DESCRIPTION

FIG. 1 is a top perspective view of a luminaire of the present invention;

FIG. 2 is a bottom perspective view of the luminaire of FIG. 1;

FIG. 3 is a left side elevational view of the luminaire of FIG. 1, the right, opposite, side of which is a mirror image thereof;

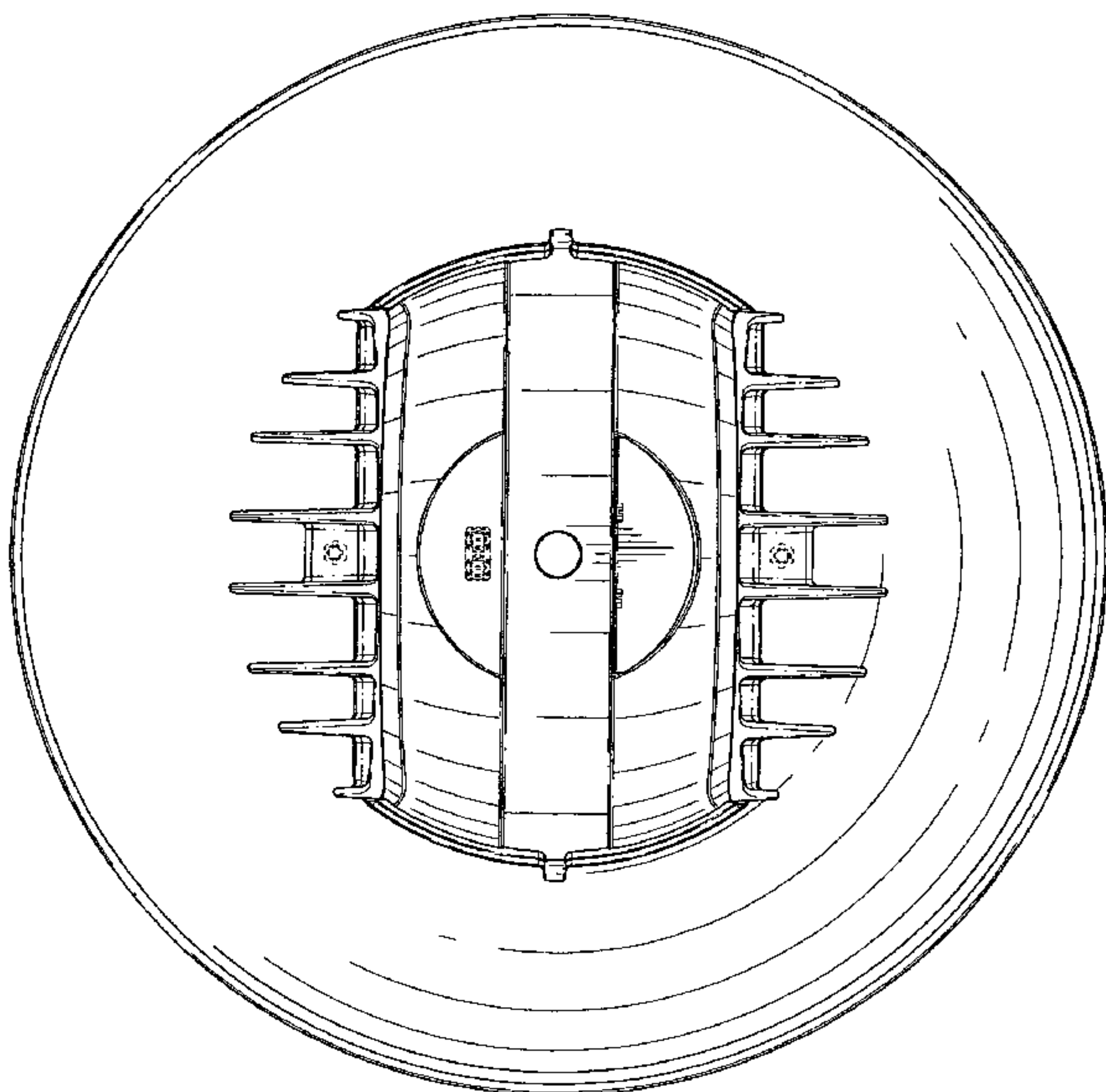
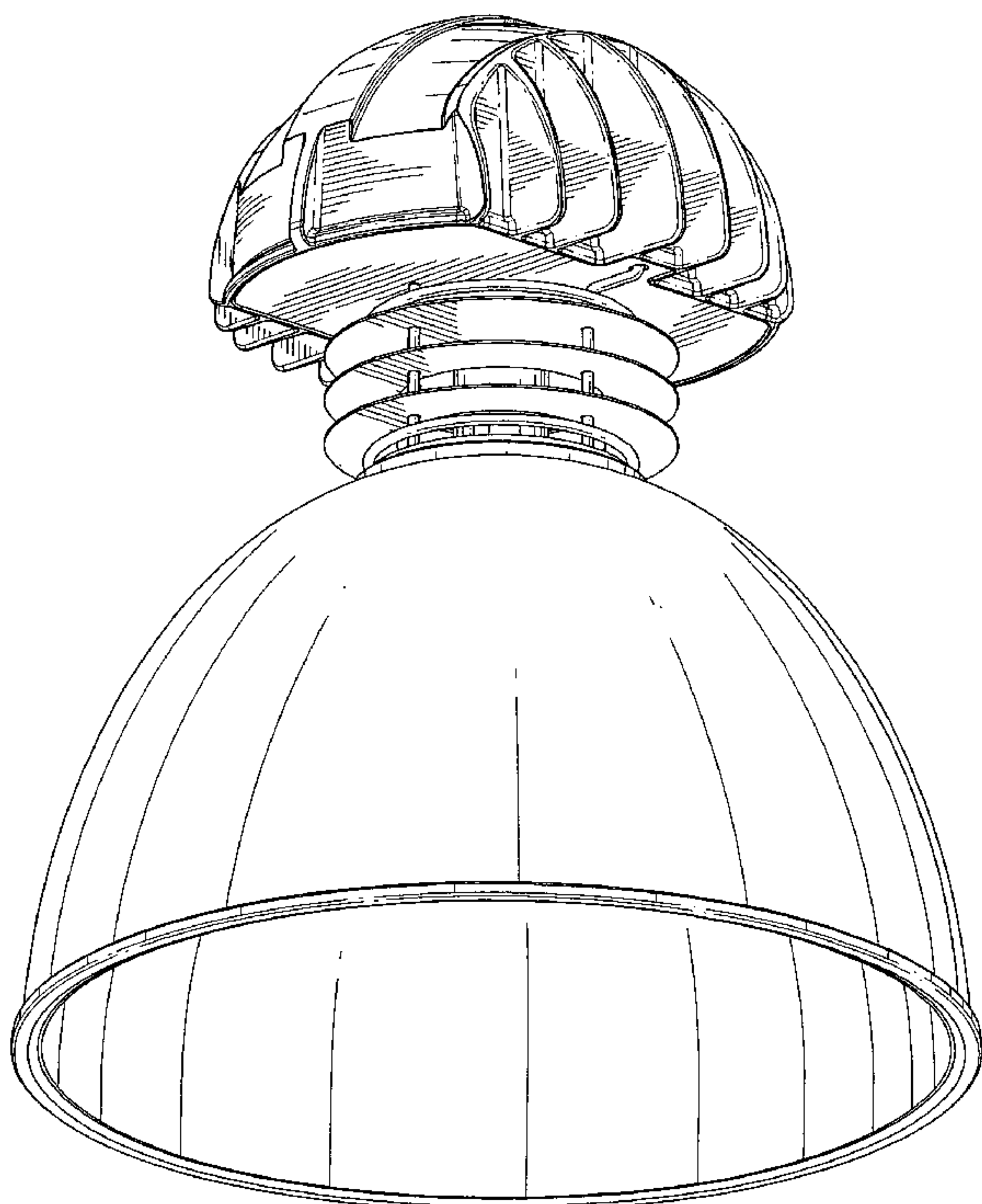
FIG. 4 is a front elevational view of the luminaire of FIG. 1, the rear, opposite, side of which is a mirror image thereof;

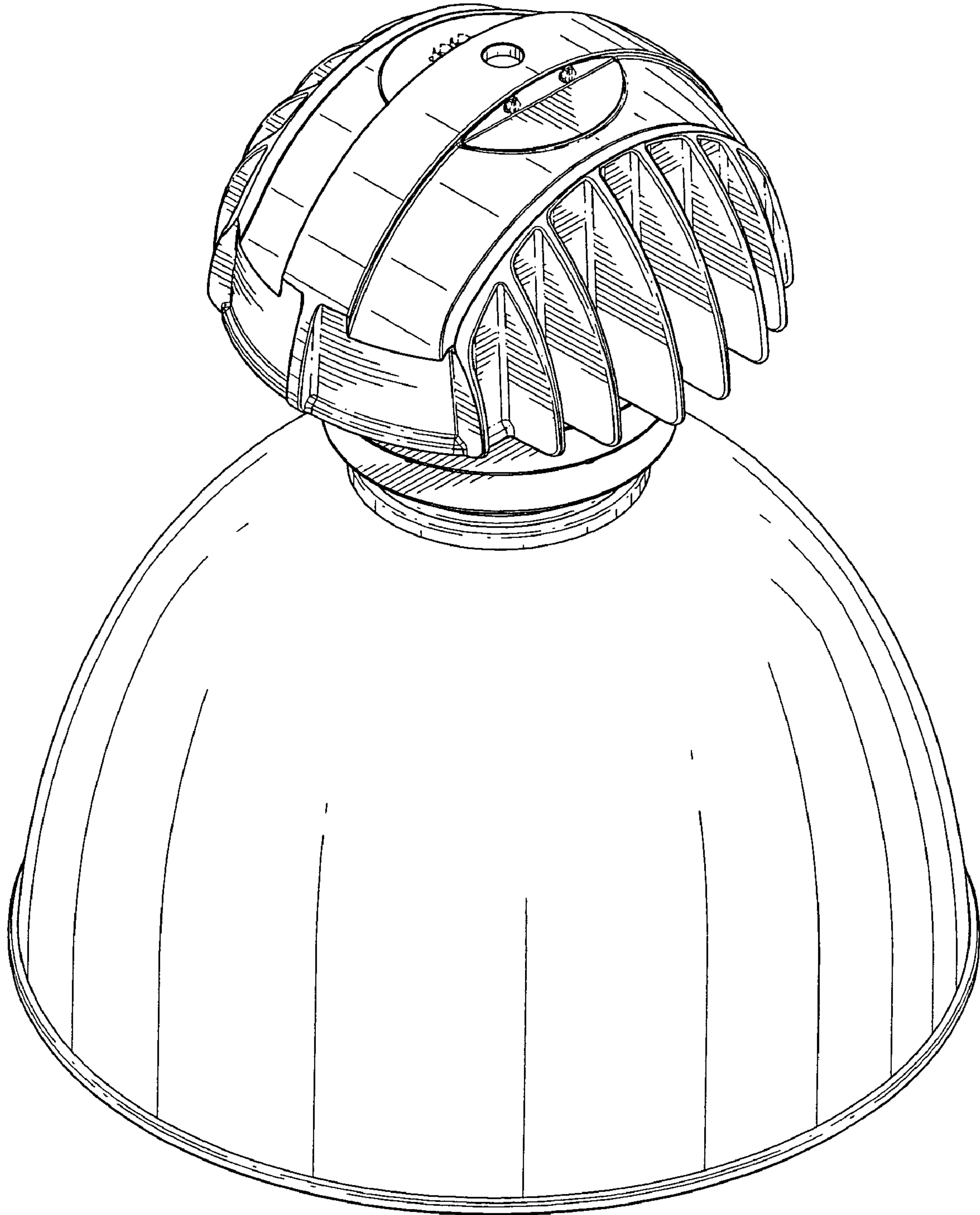

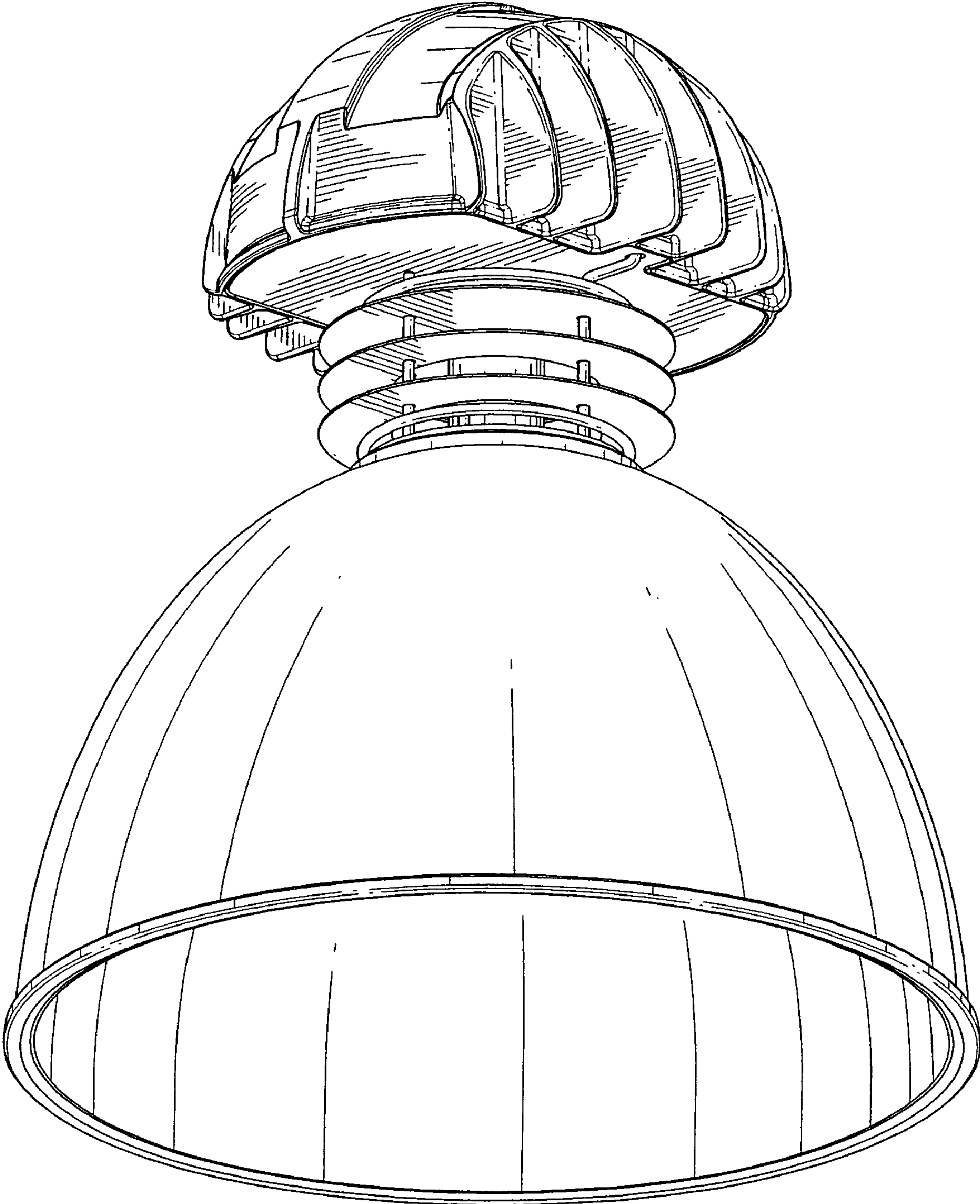

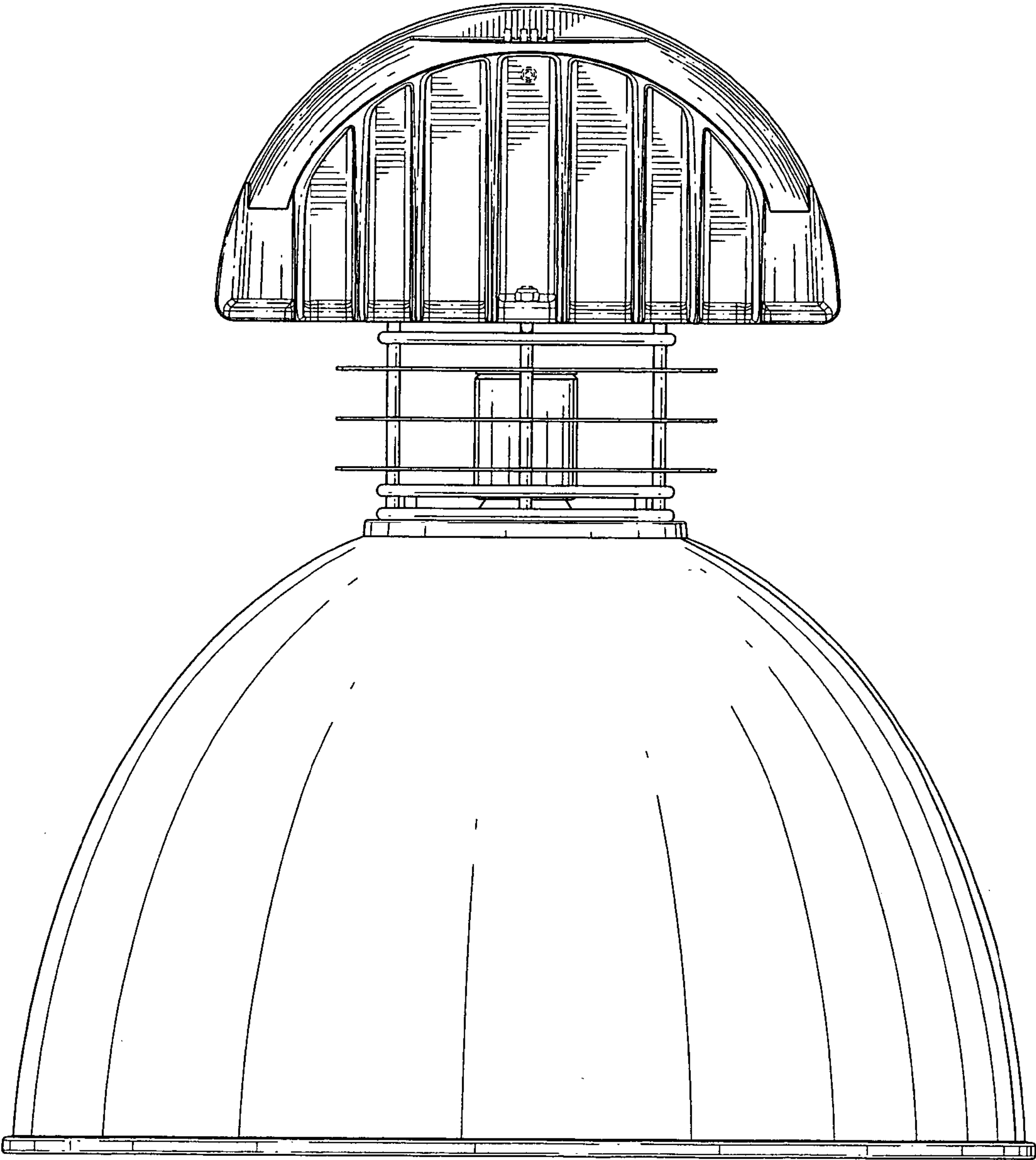

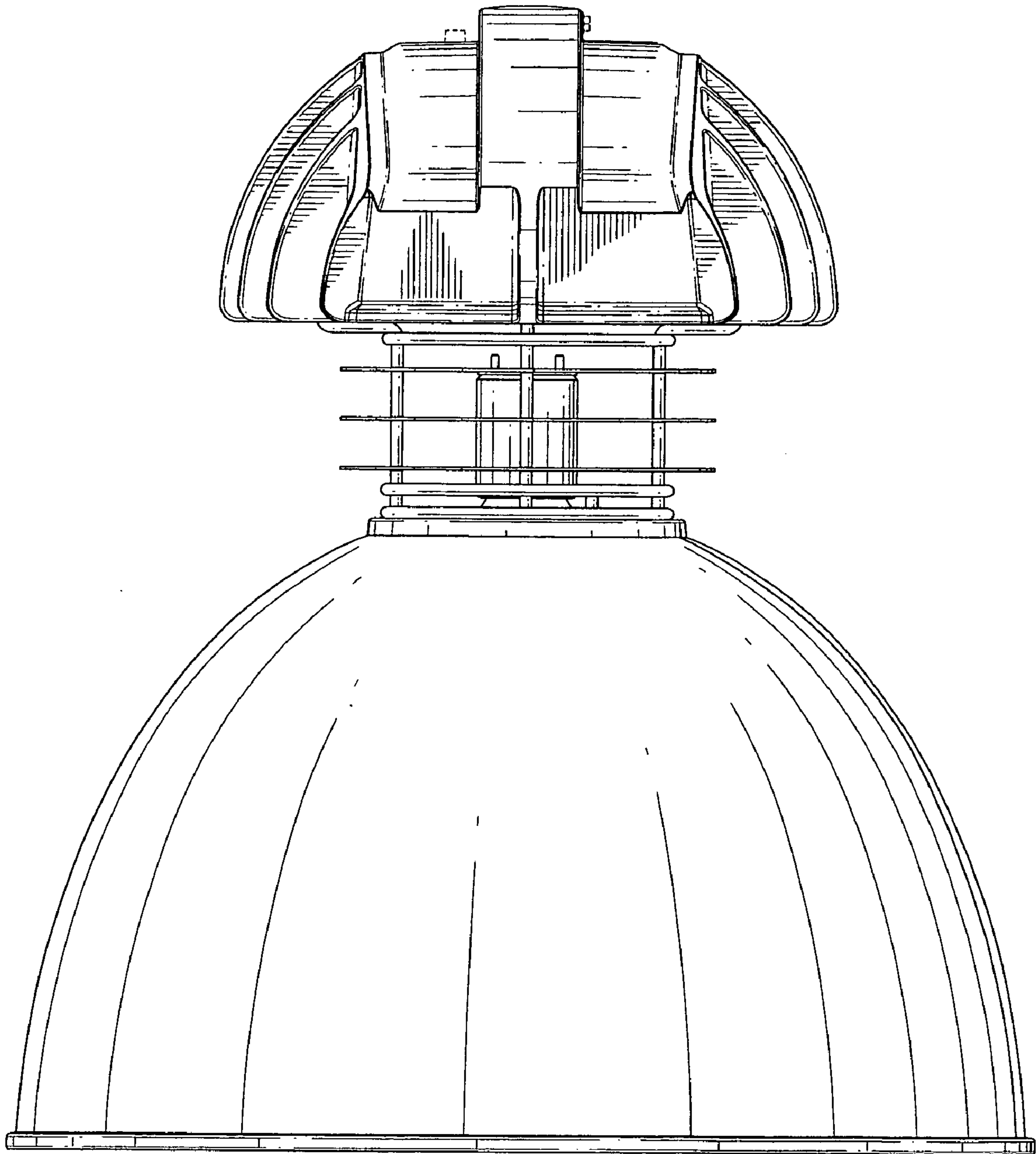

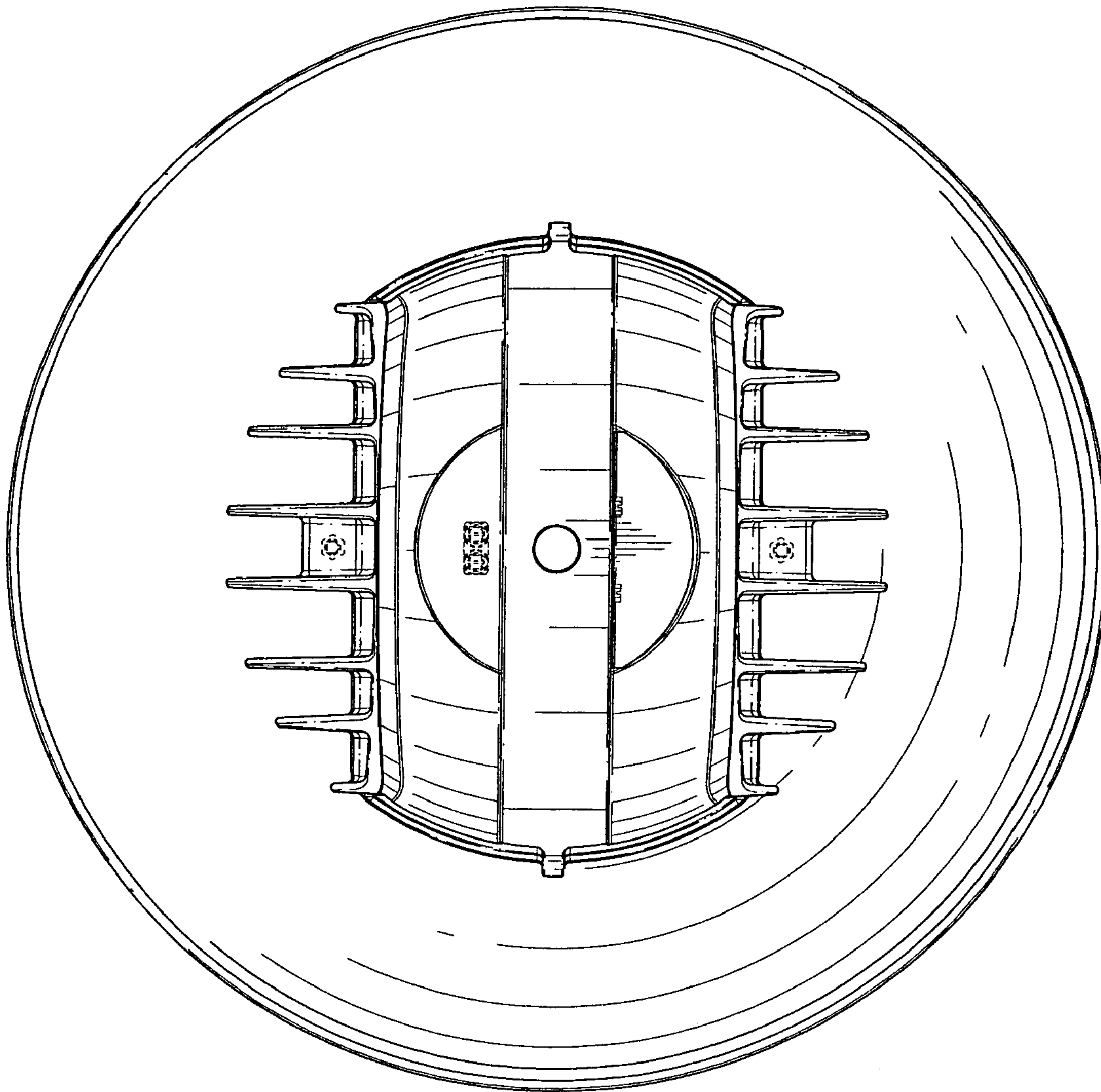

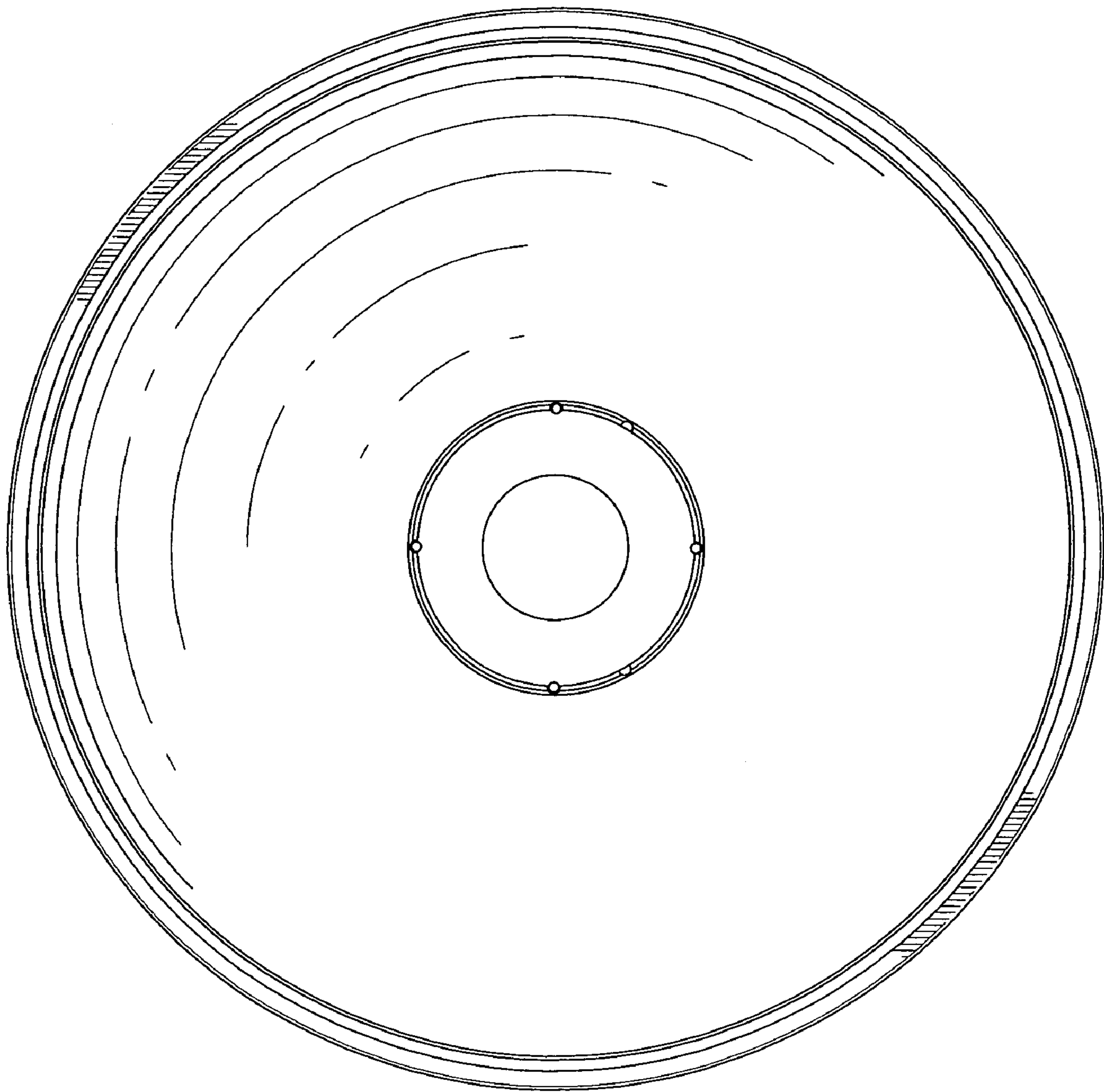
