DESCRIPTION

FIG. 1 is a perspective view of a dental floss dispenser, showing my new design;
FIG. 2 is a top plan view;

FIG. 5 is a perspective view with the lid open;

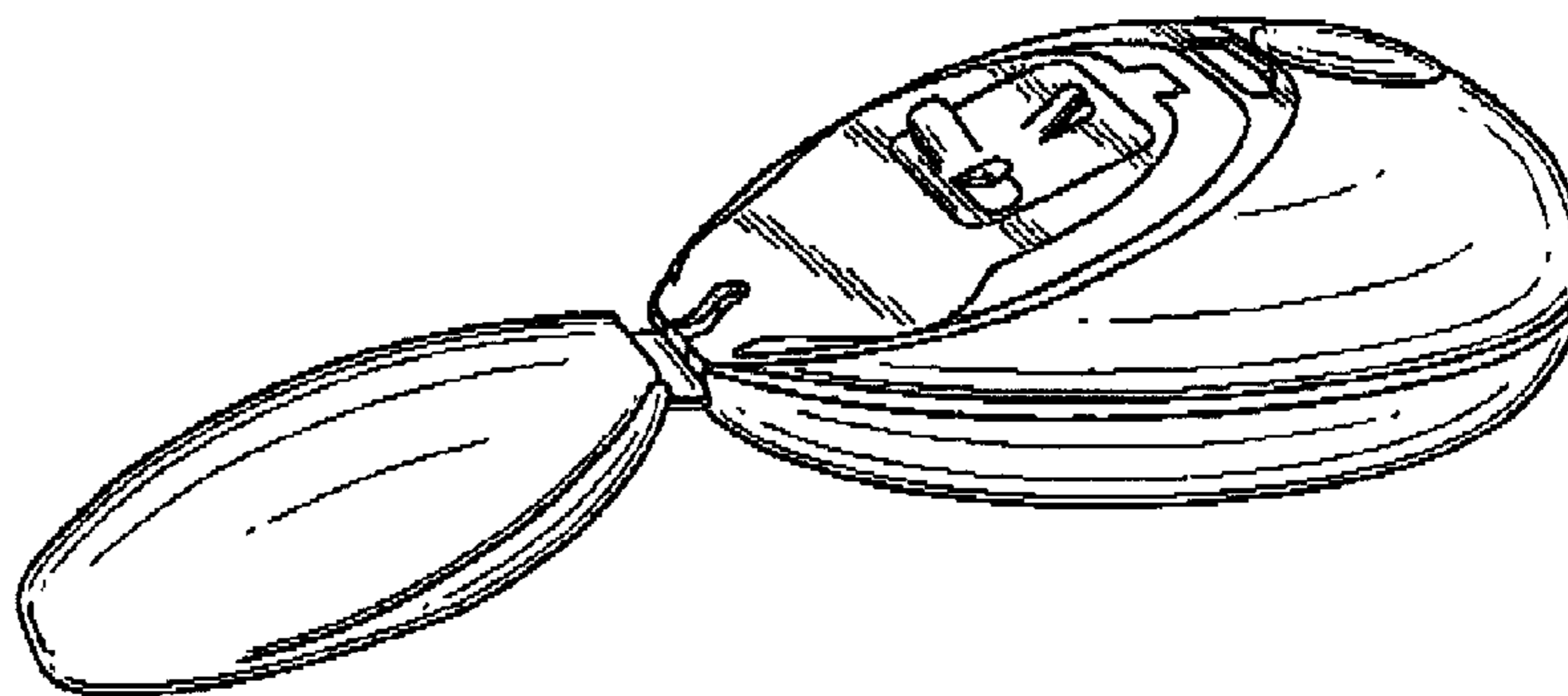
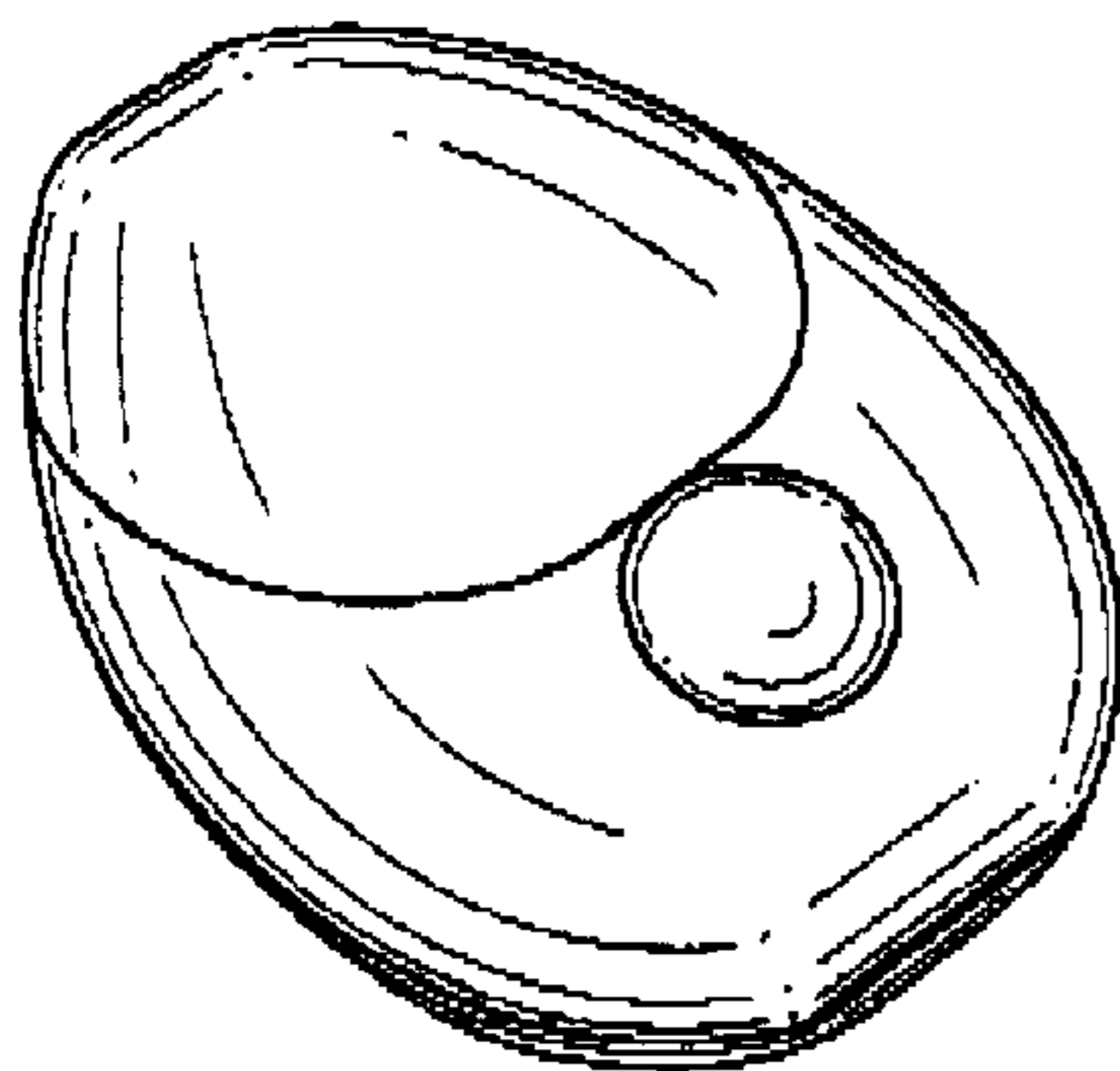

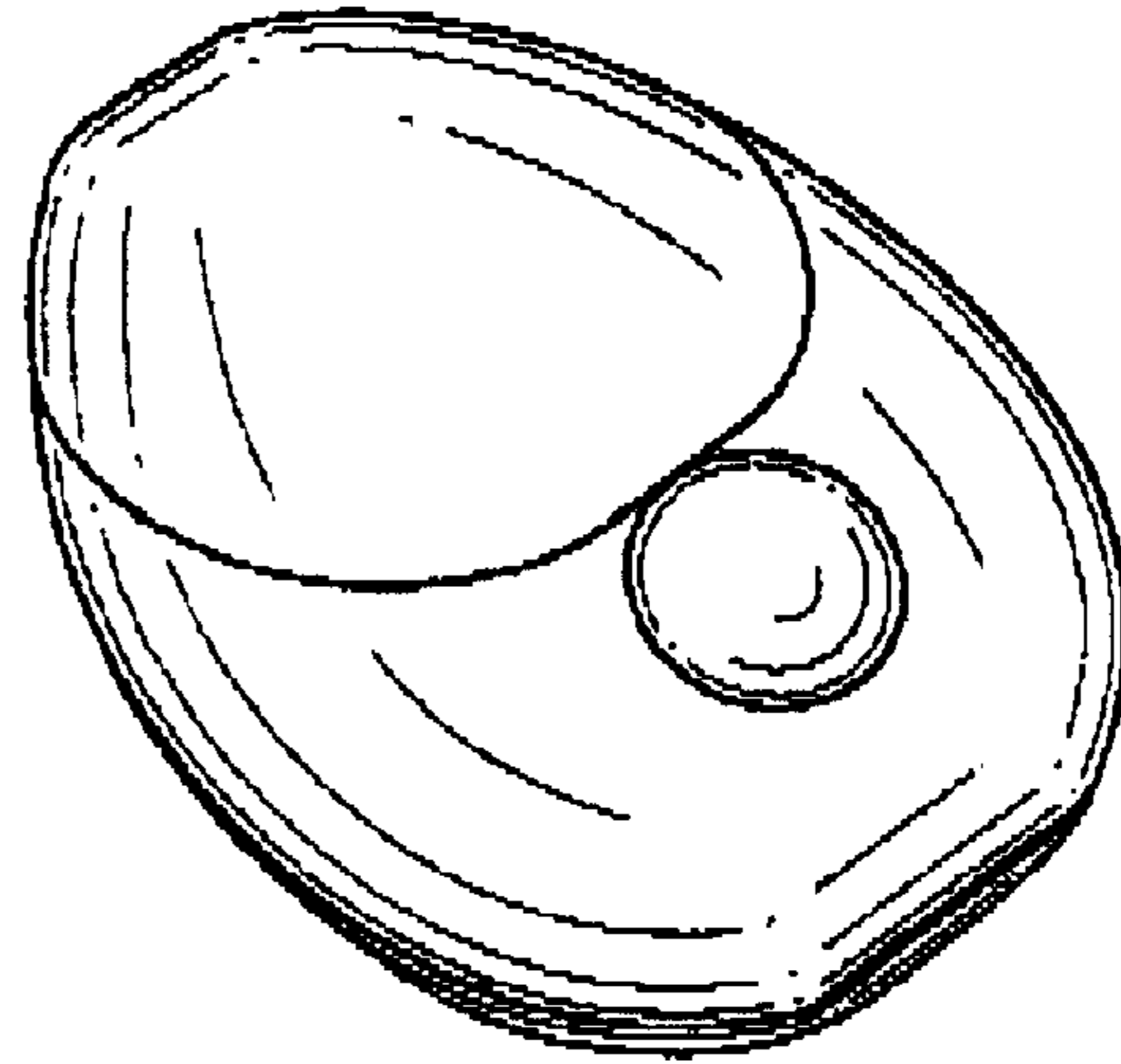

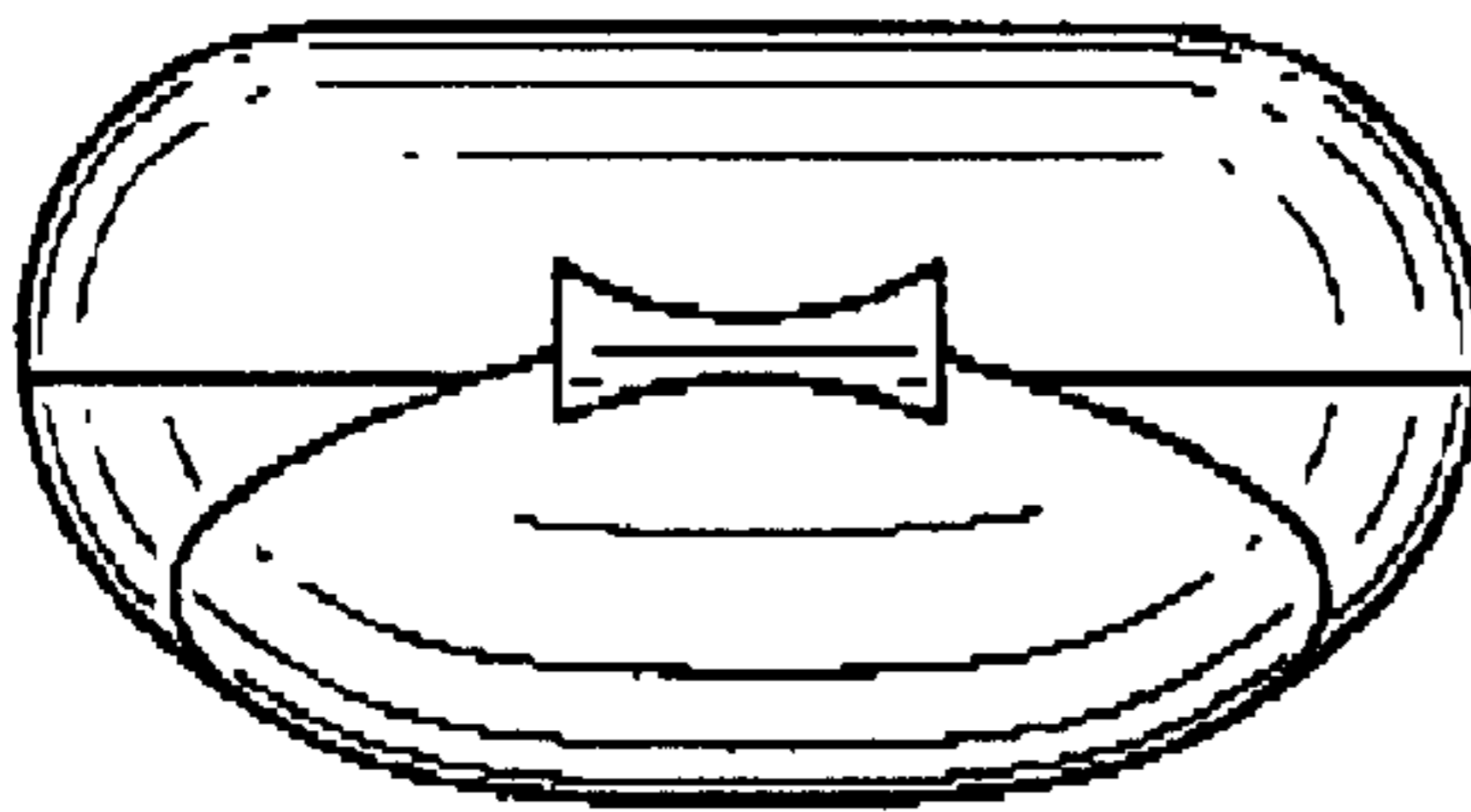

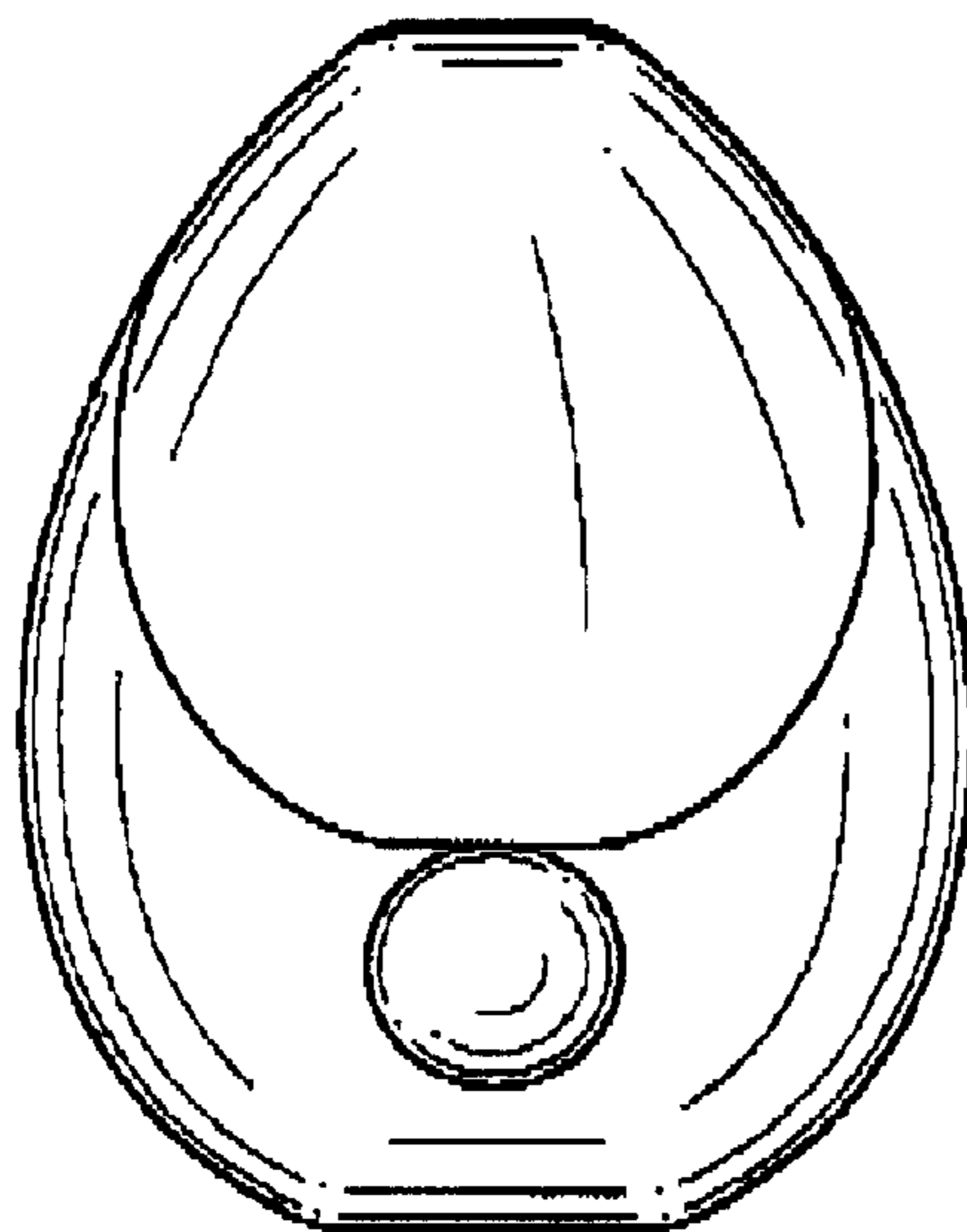

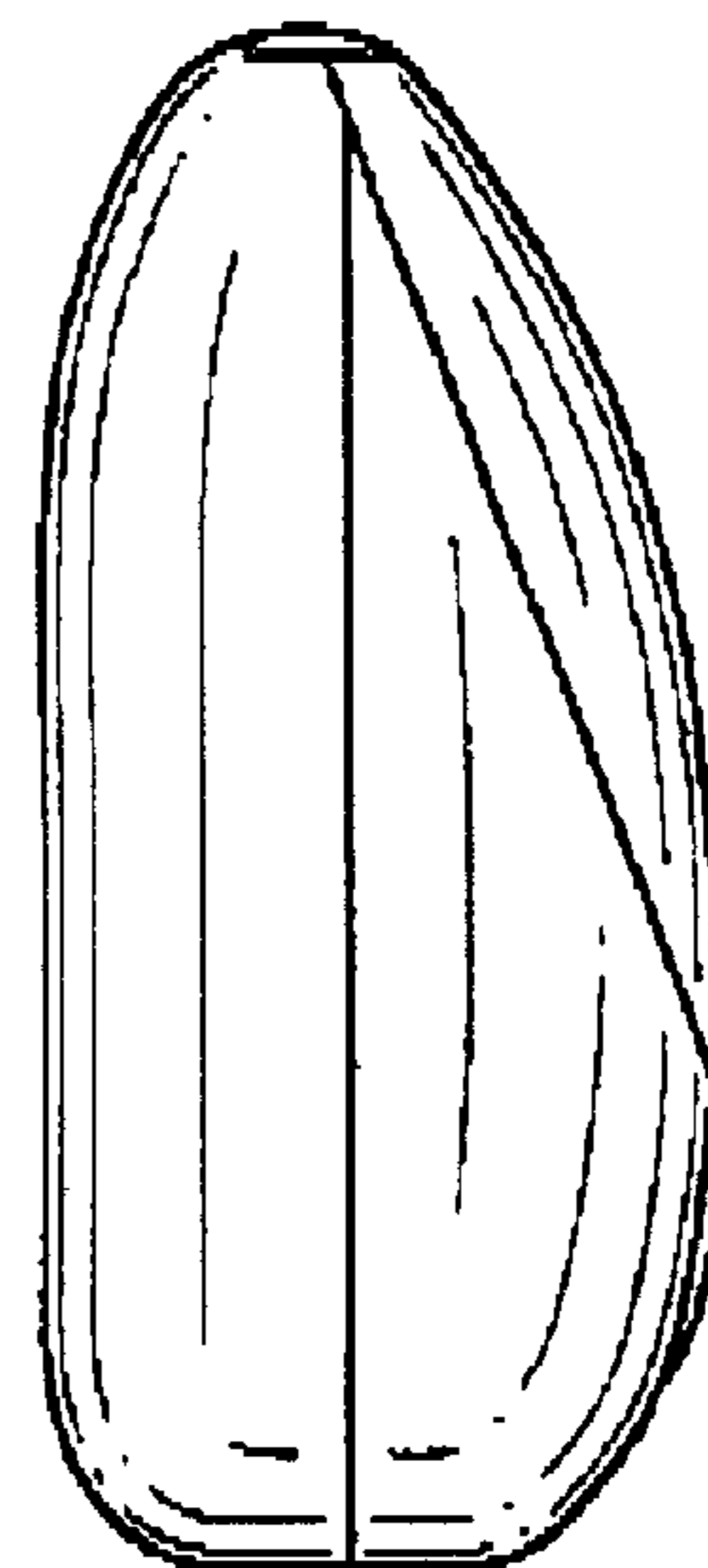

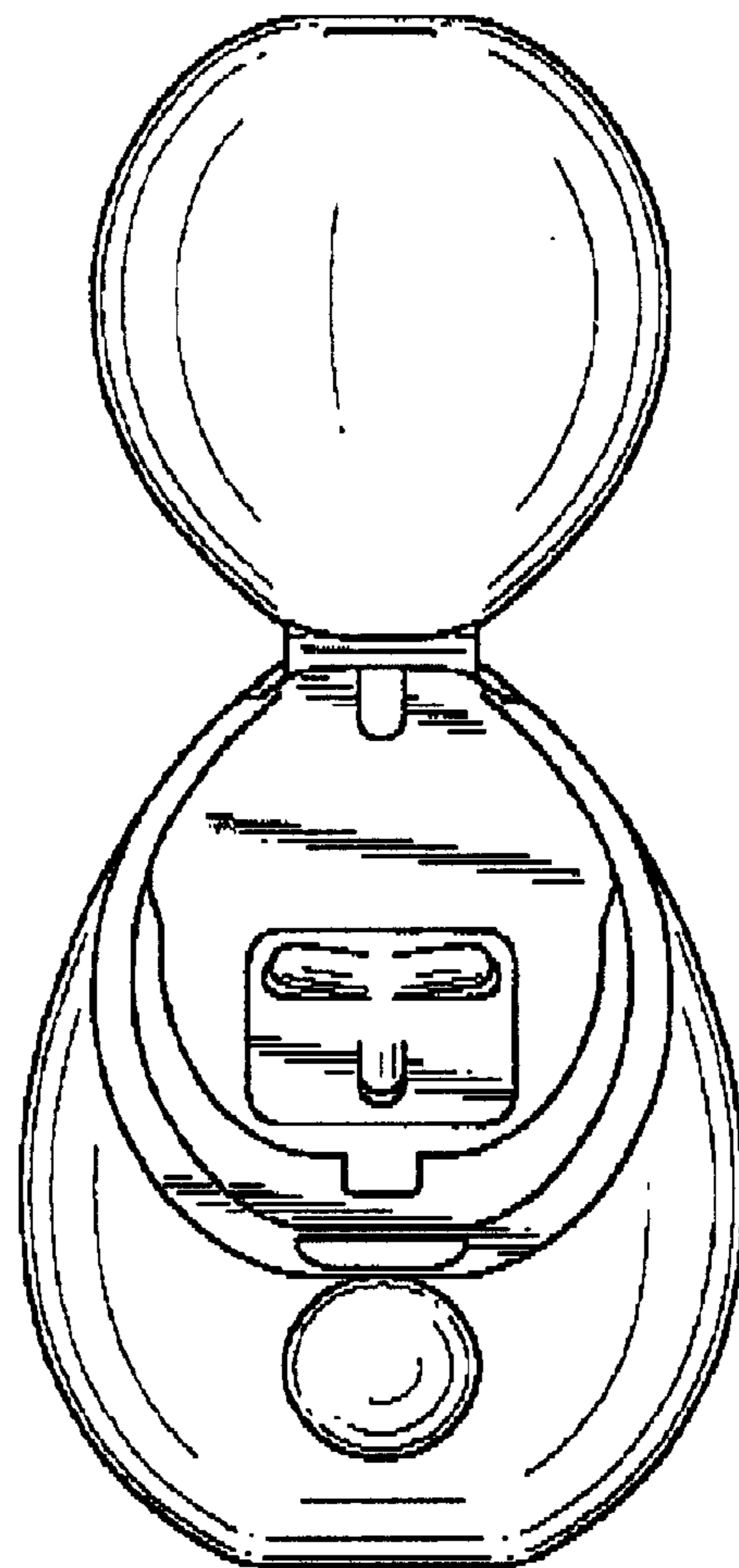
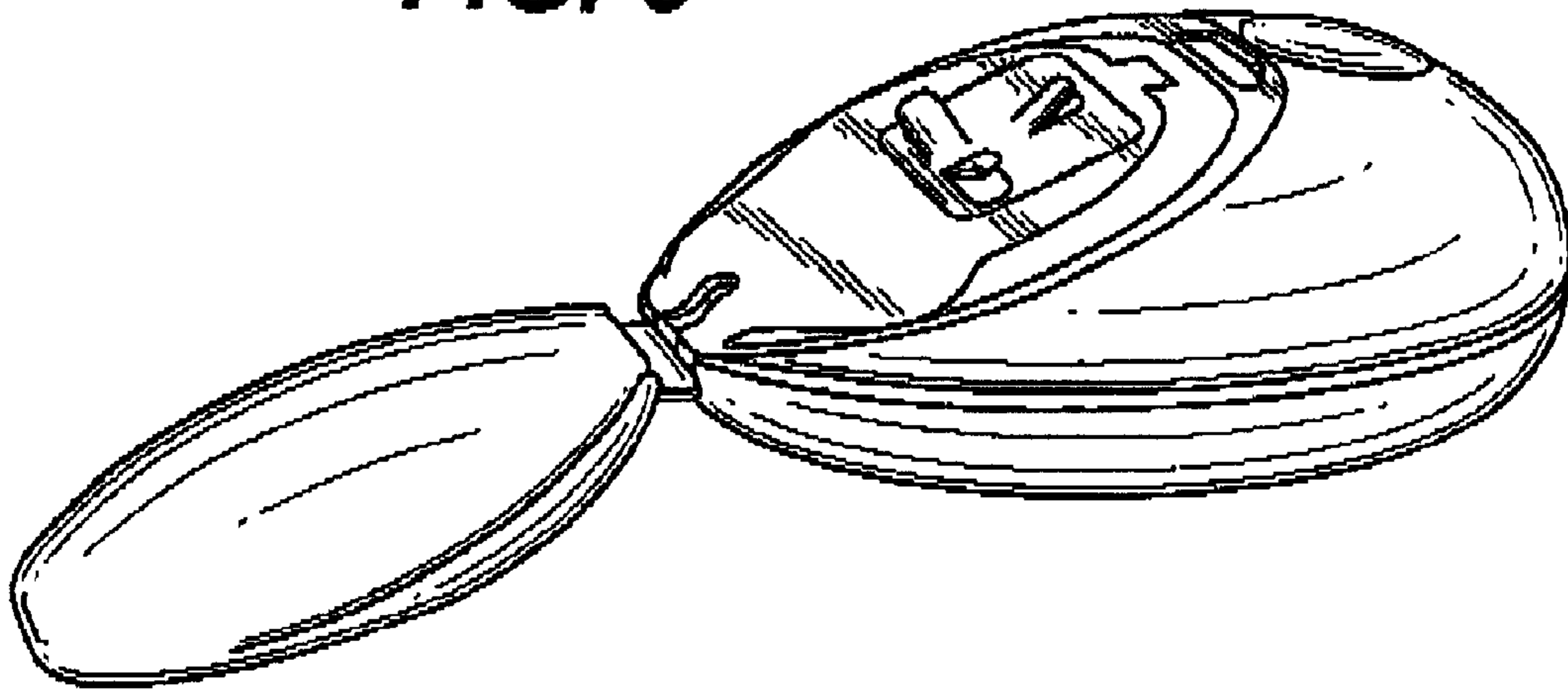

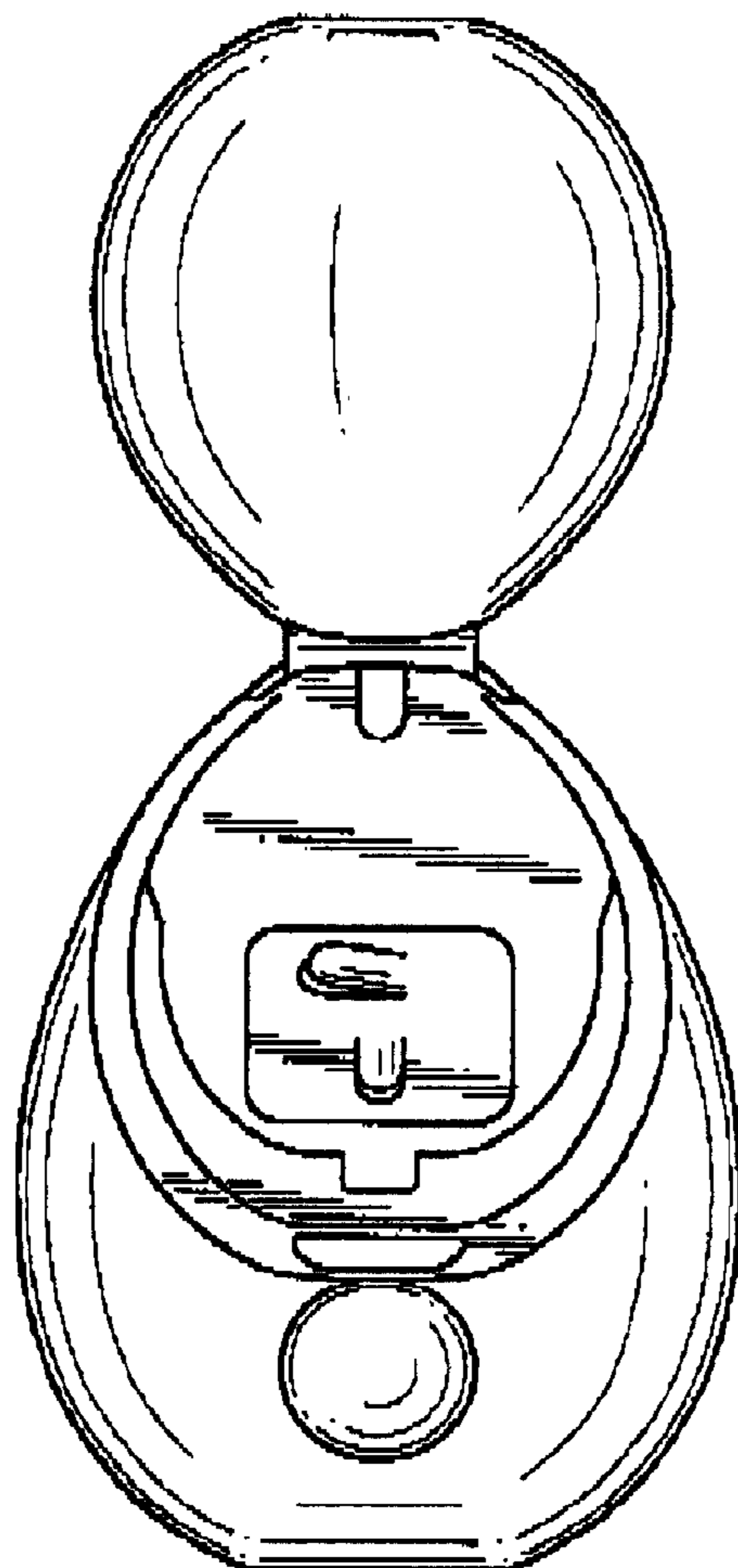
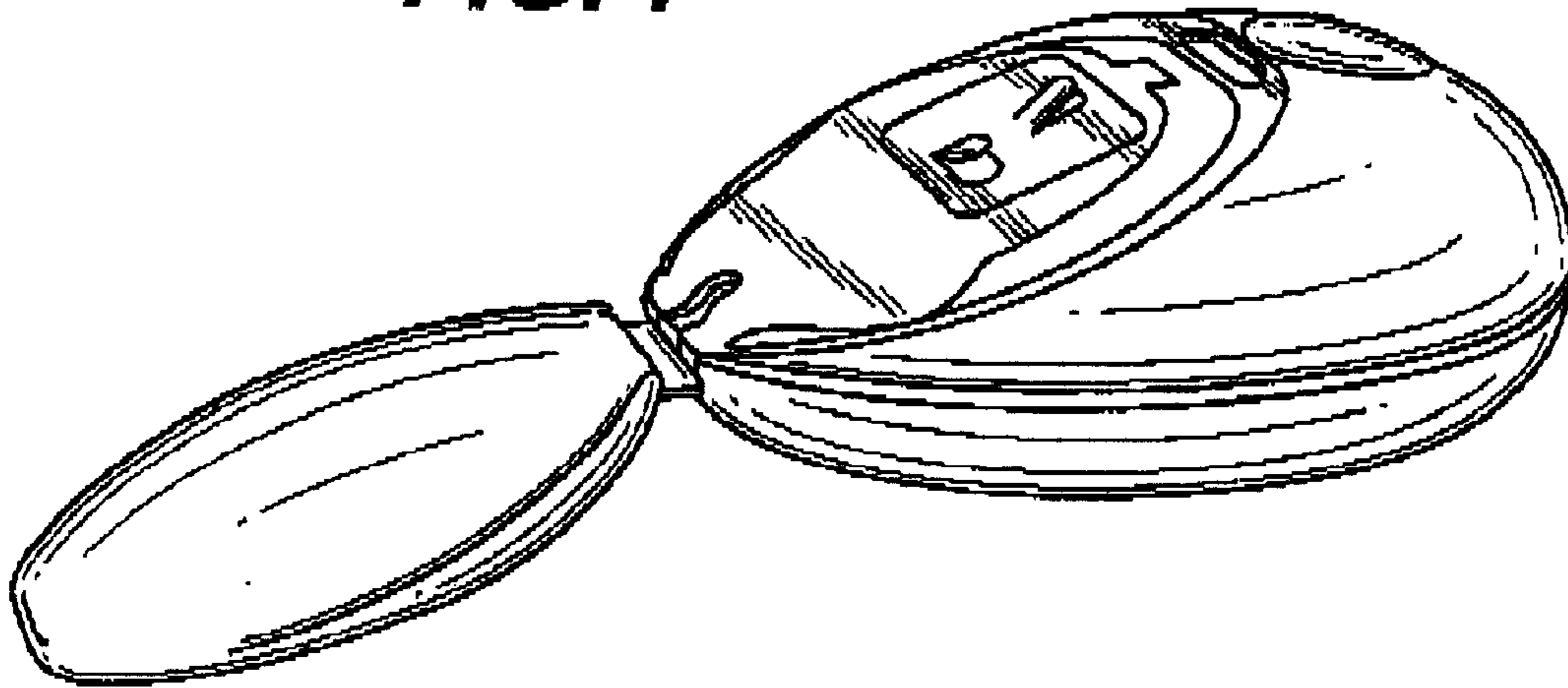
