showing a new design;

FIG. 2 is a front view of the shoe sole of FIG. 1;

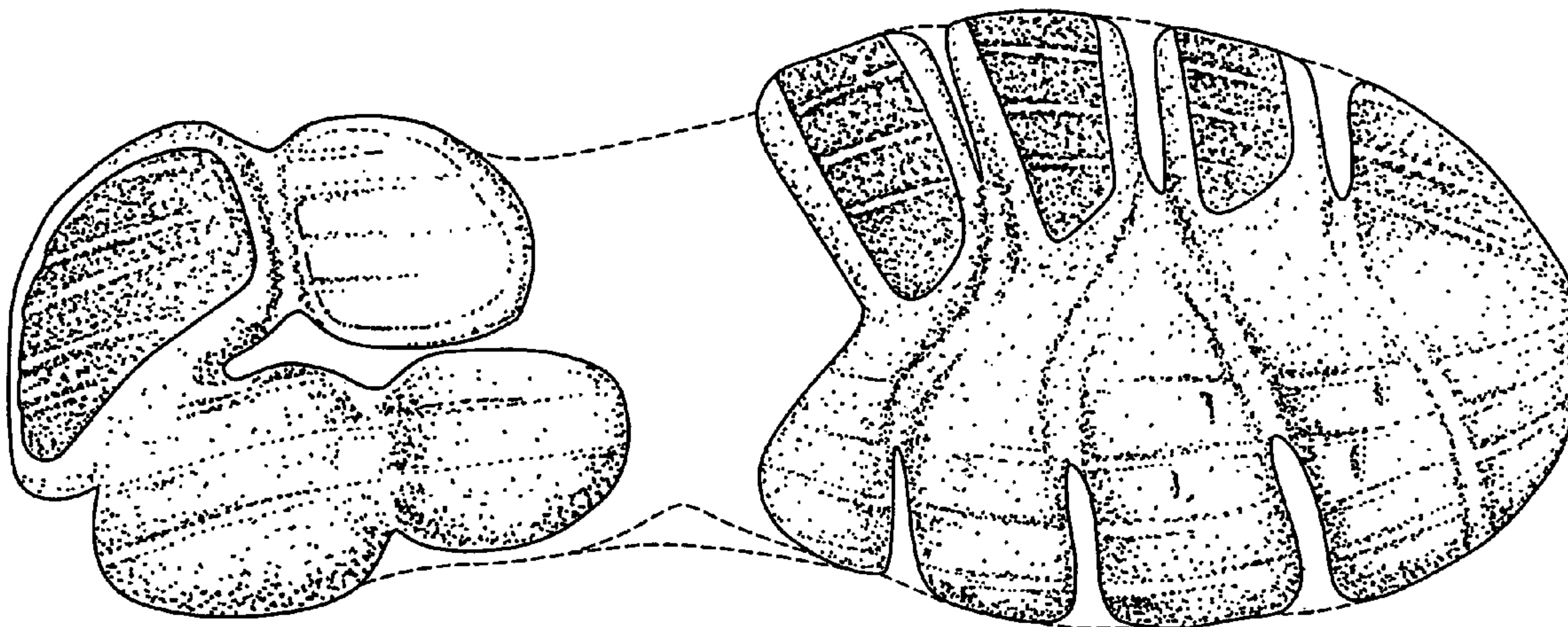
FIG. 3 is a lateral side view of the shoe sole of FIG. 1;

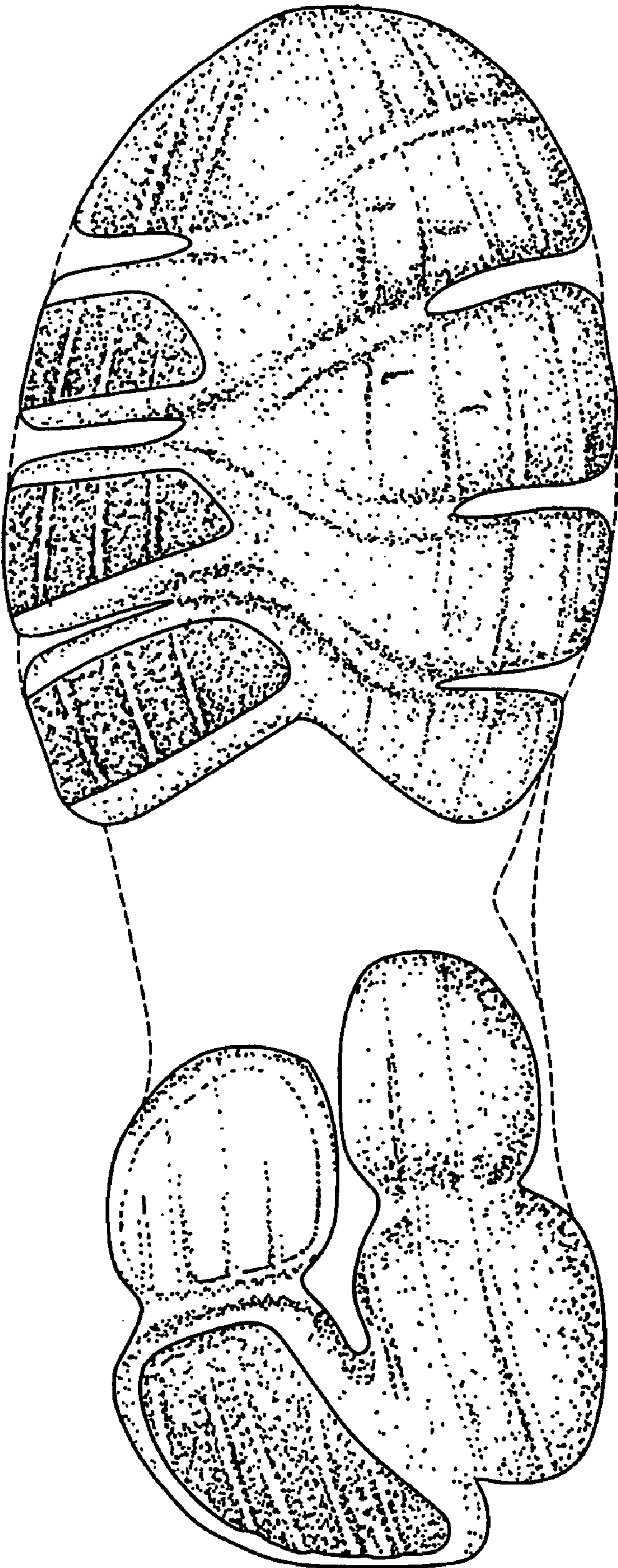

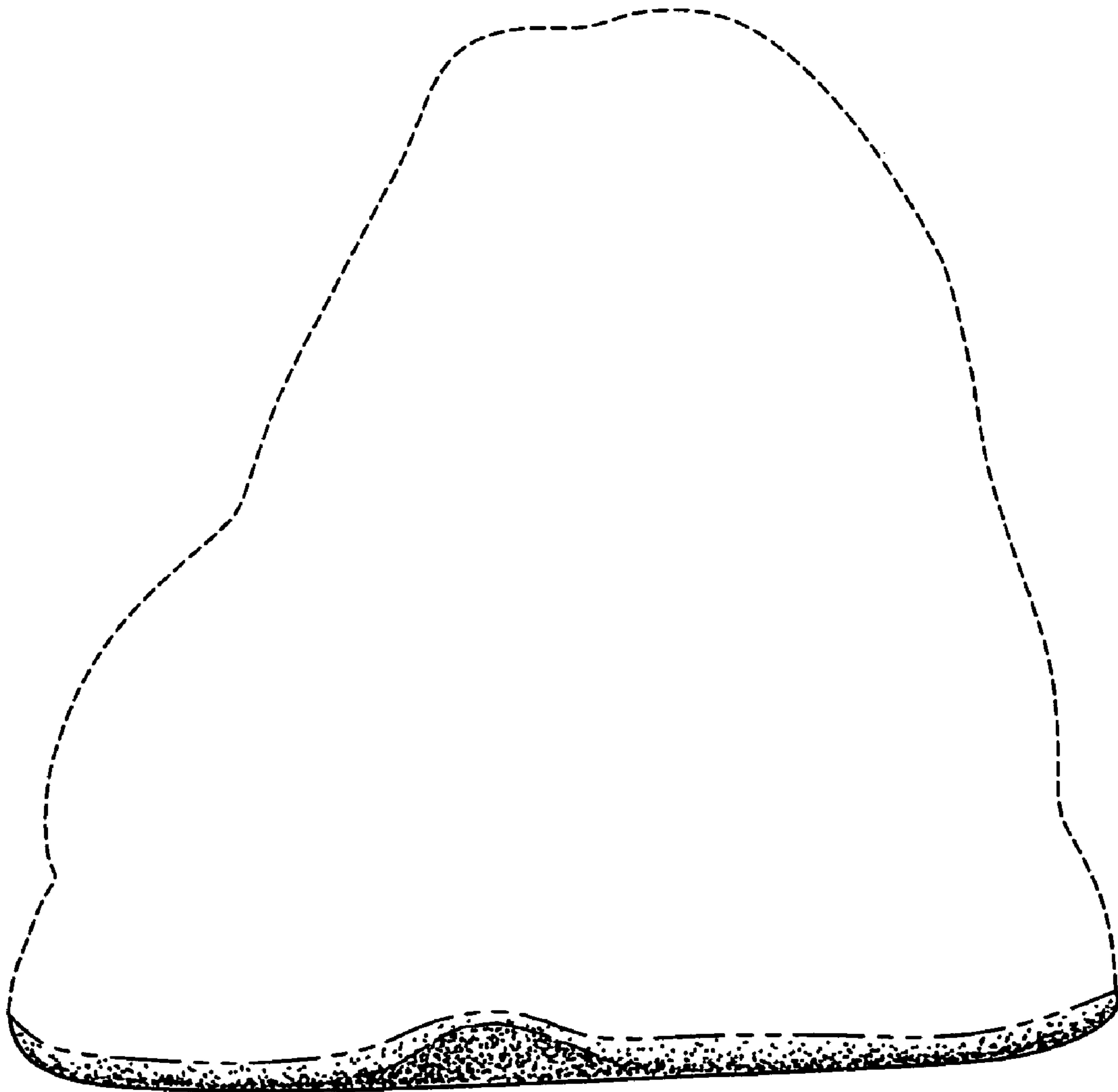

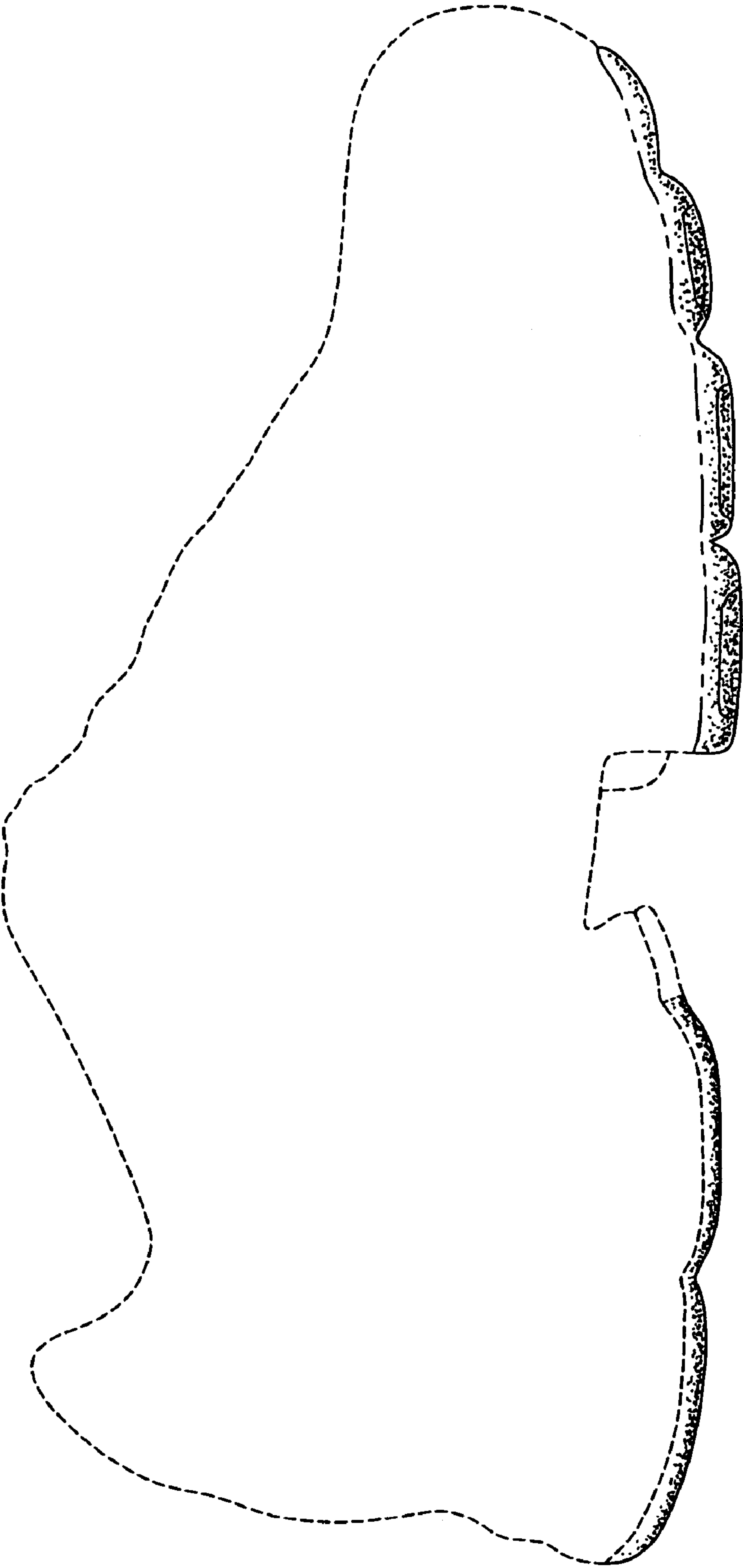

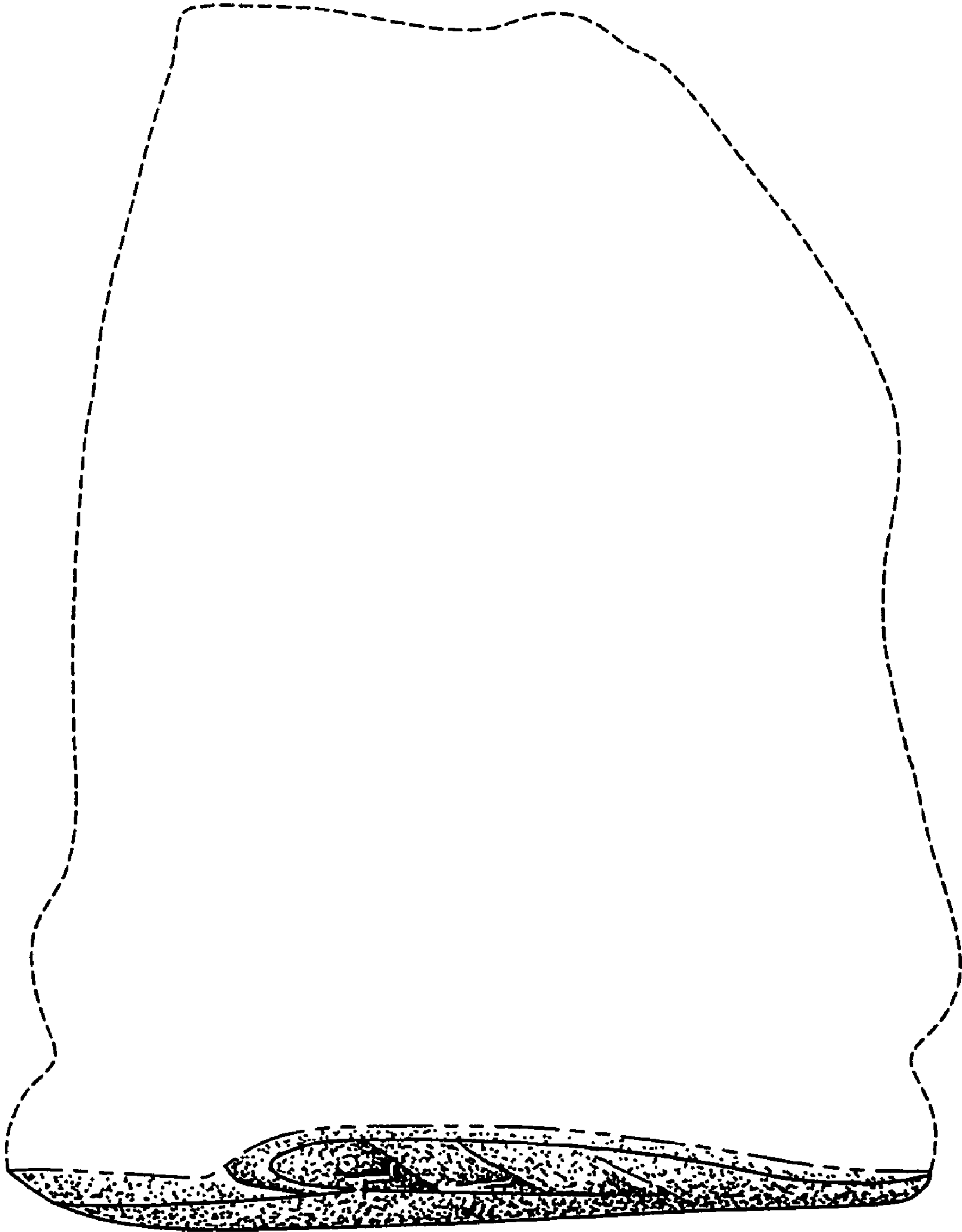

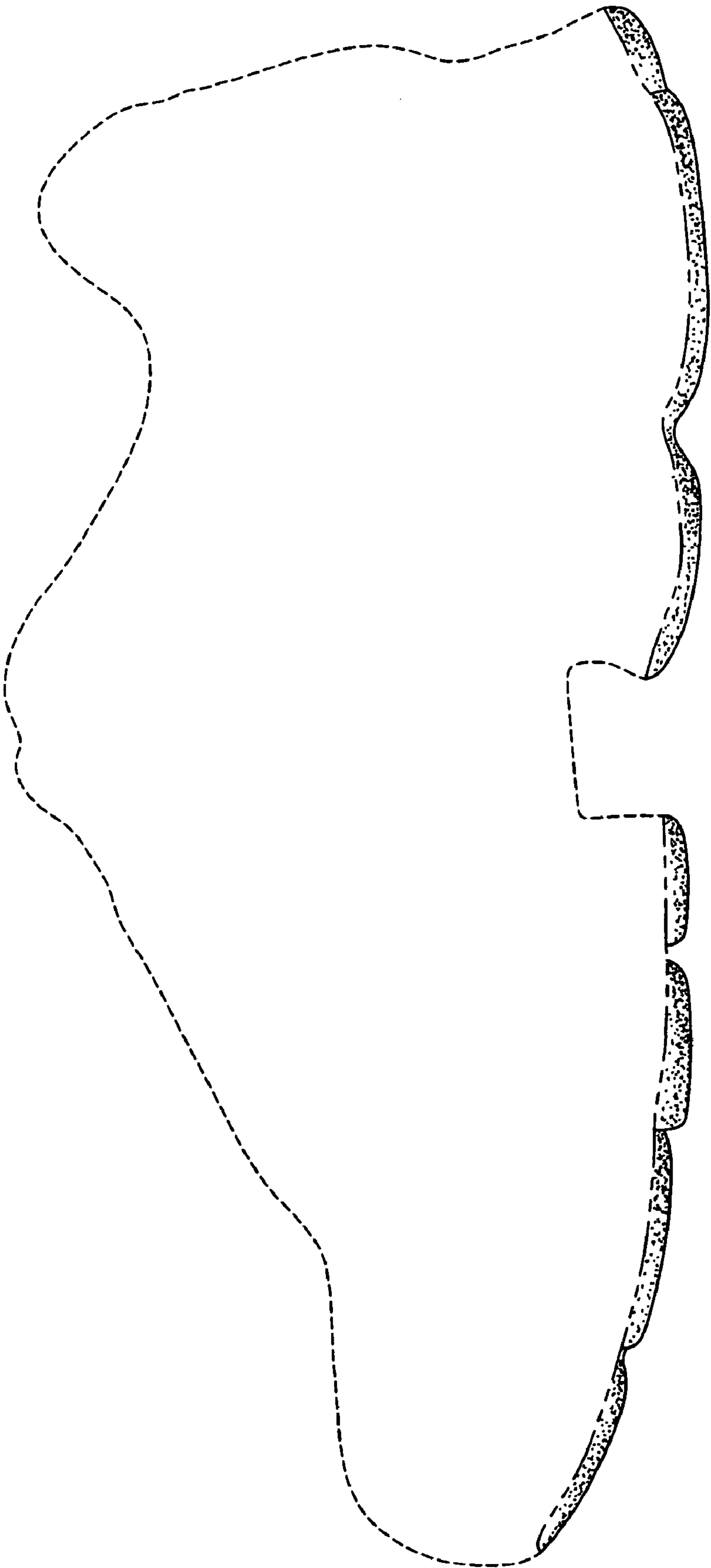
