DESCRIPTION

FIG. 7 is a left side view of the alternative embodiment of the shoe shown in FIG. 6;

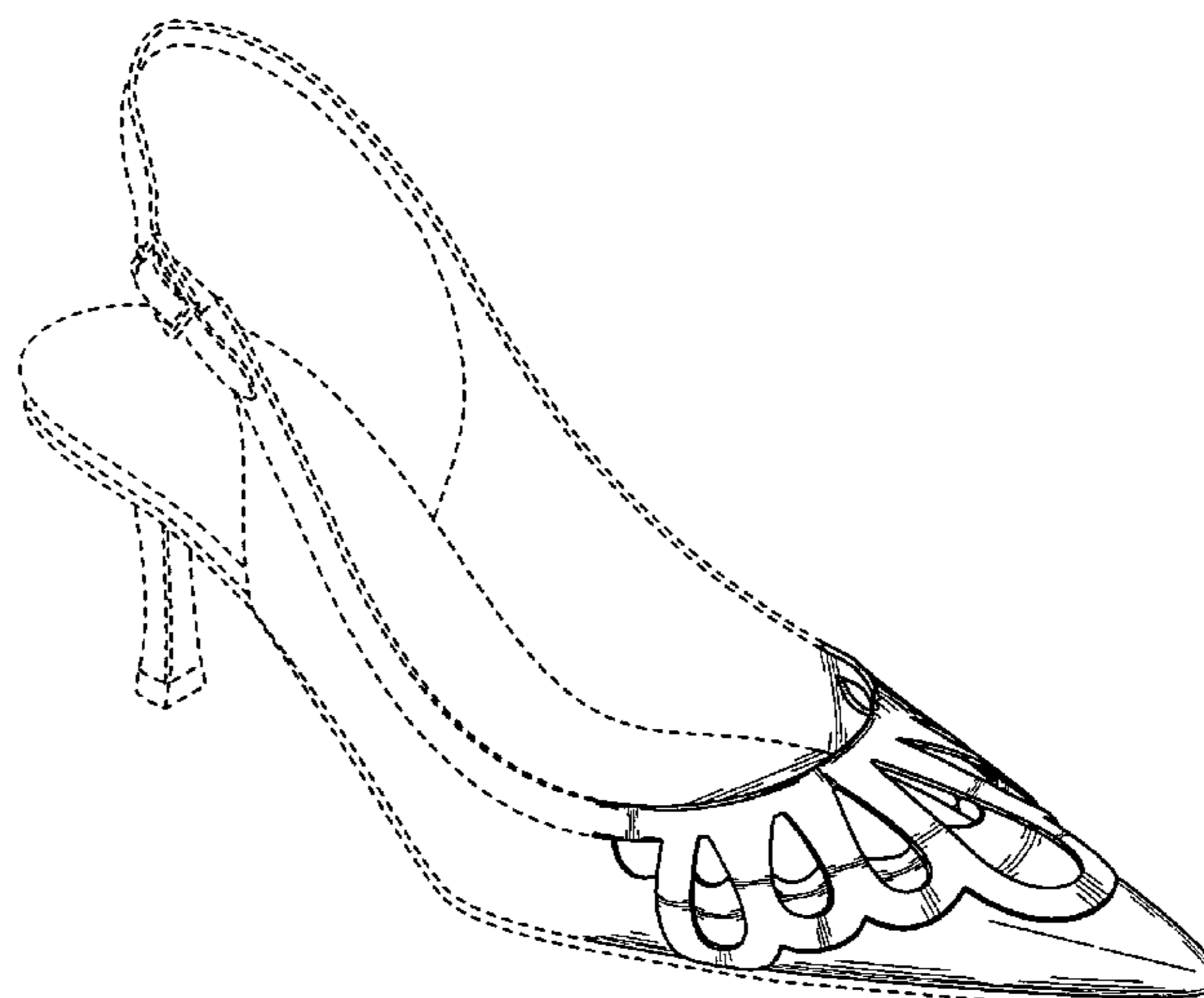
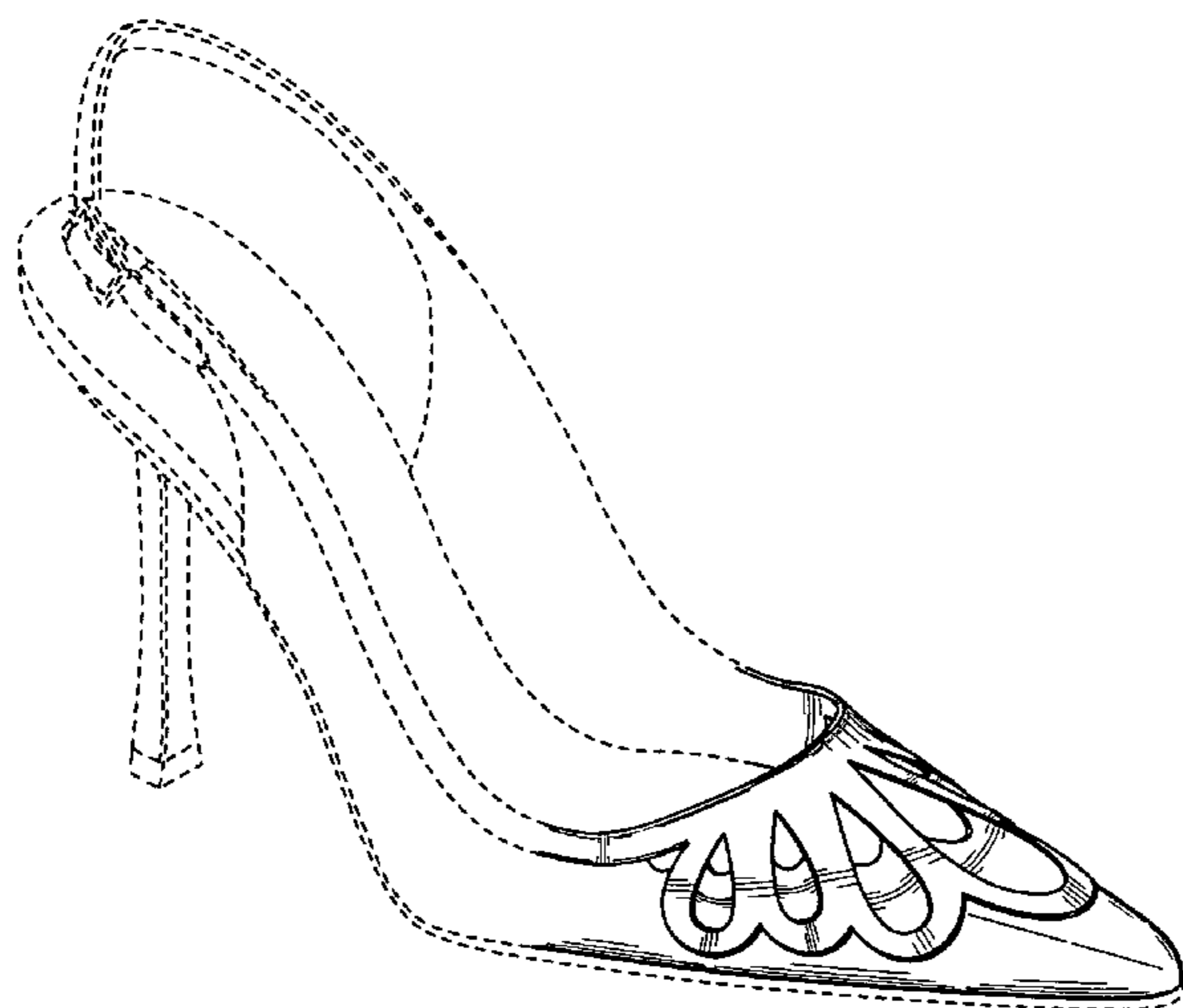
FIG. 8 is a right side view of the alternative embodiment of the shoe shown in FIG. 6;

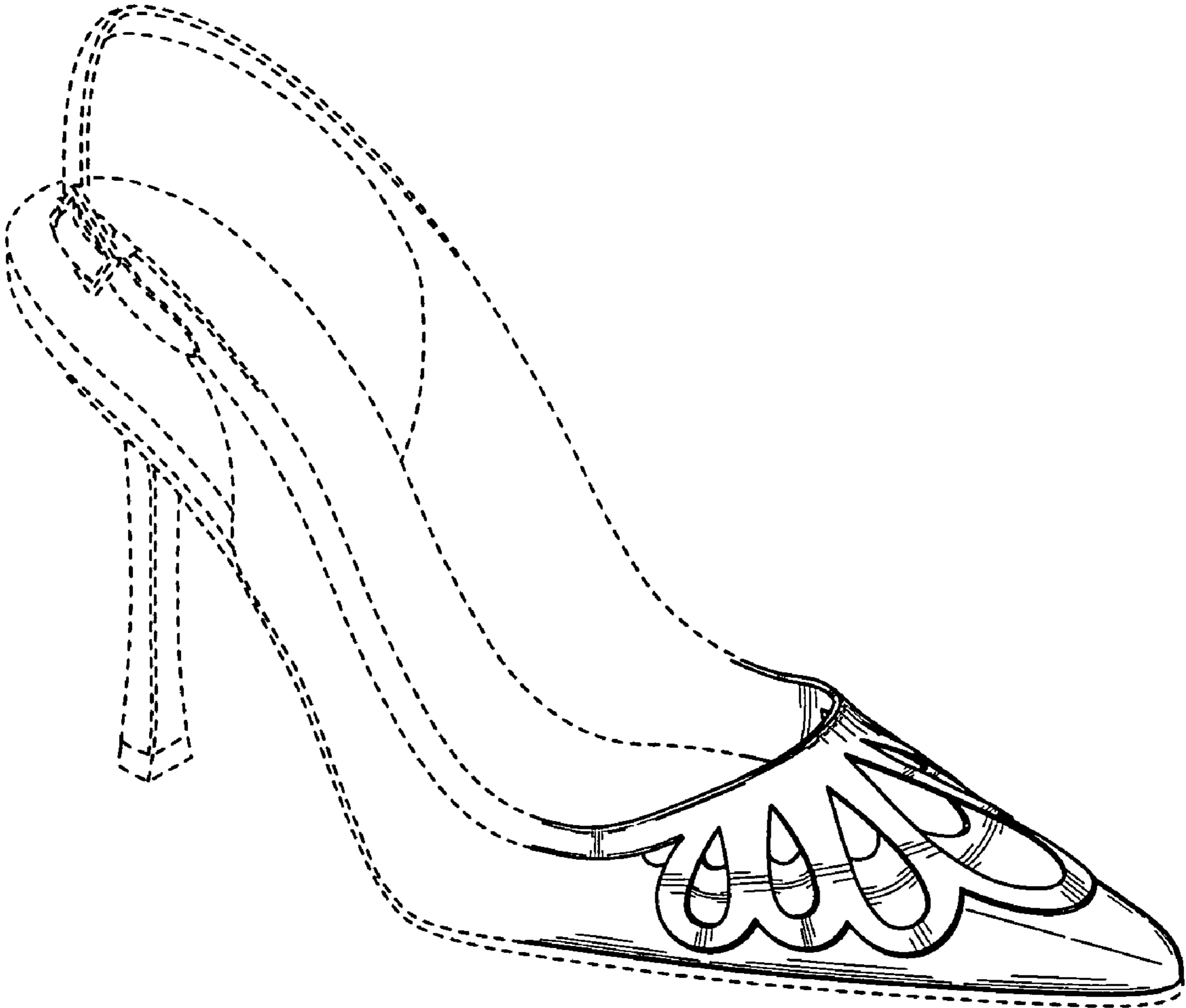

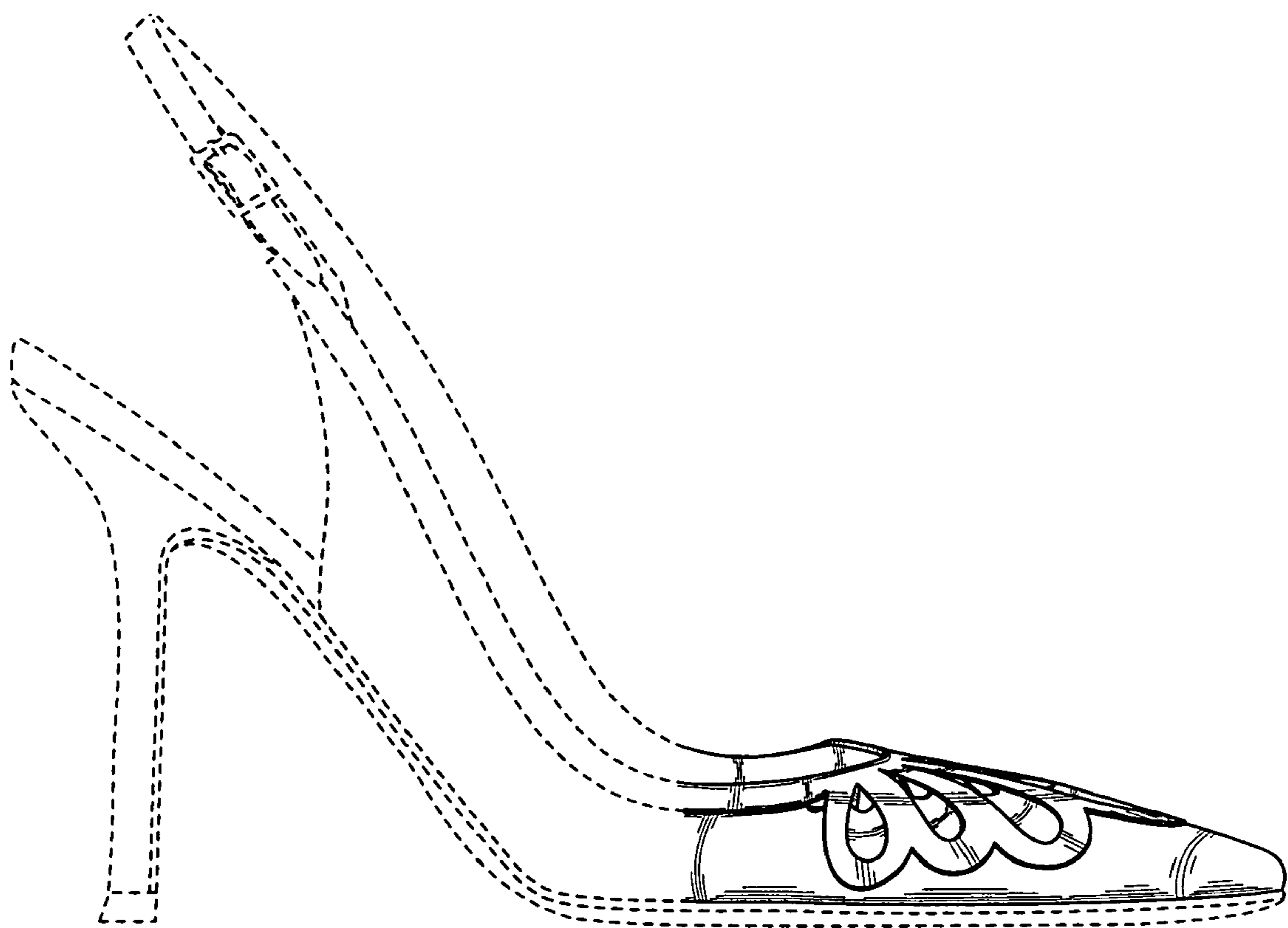

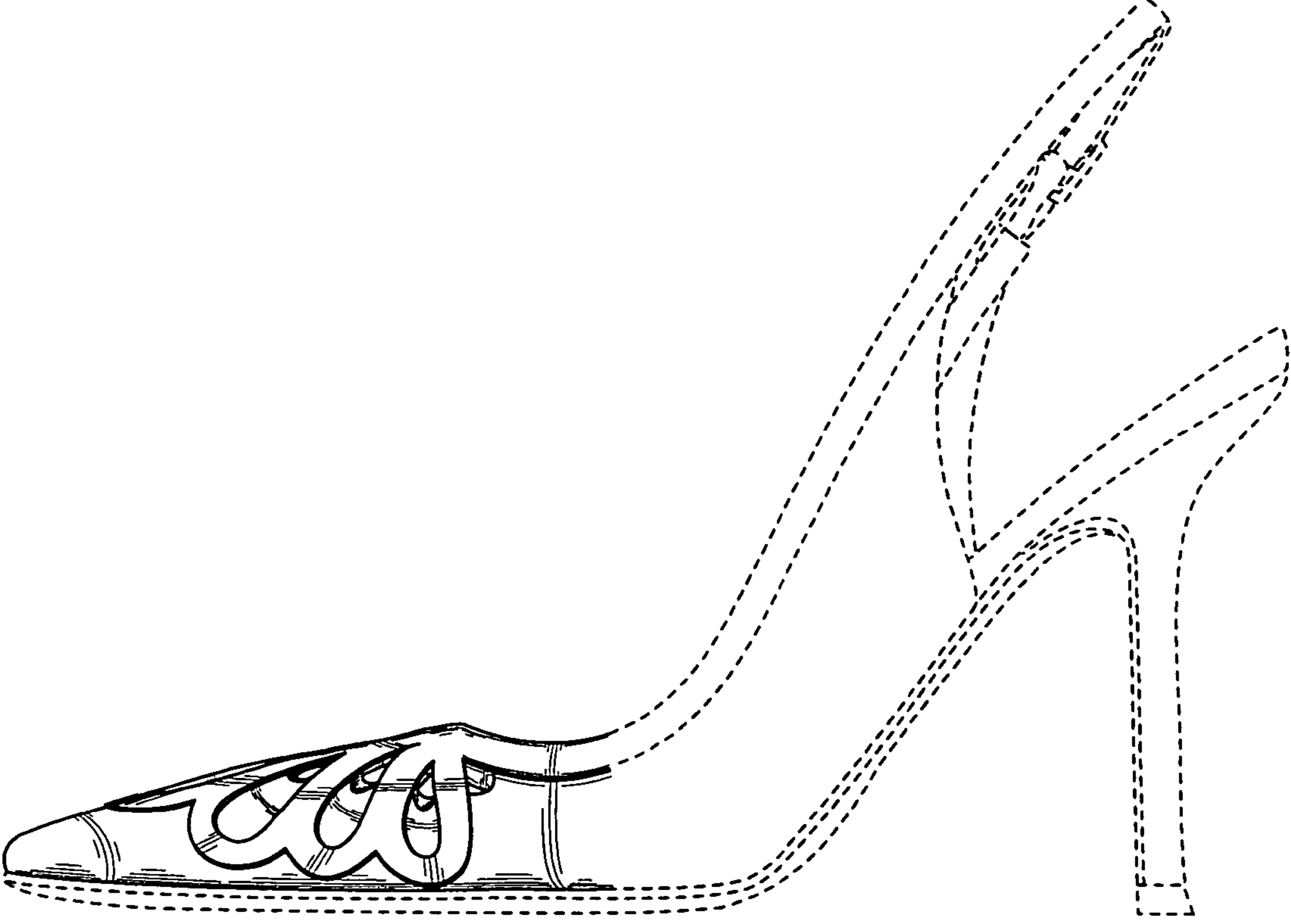

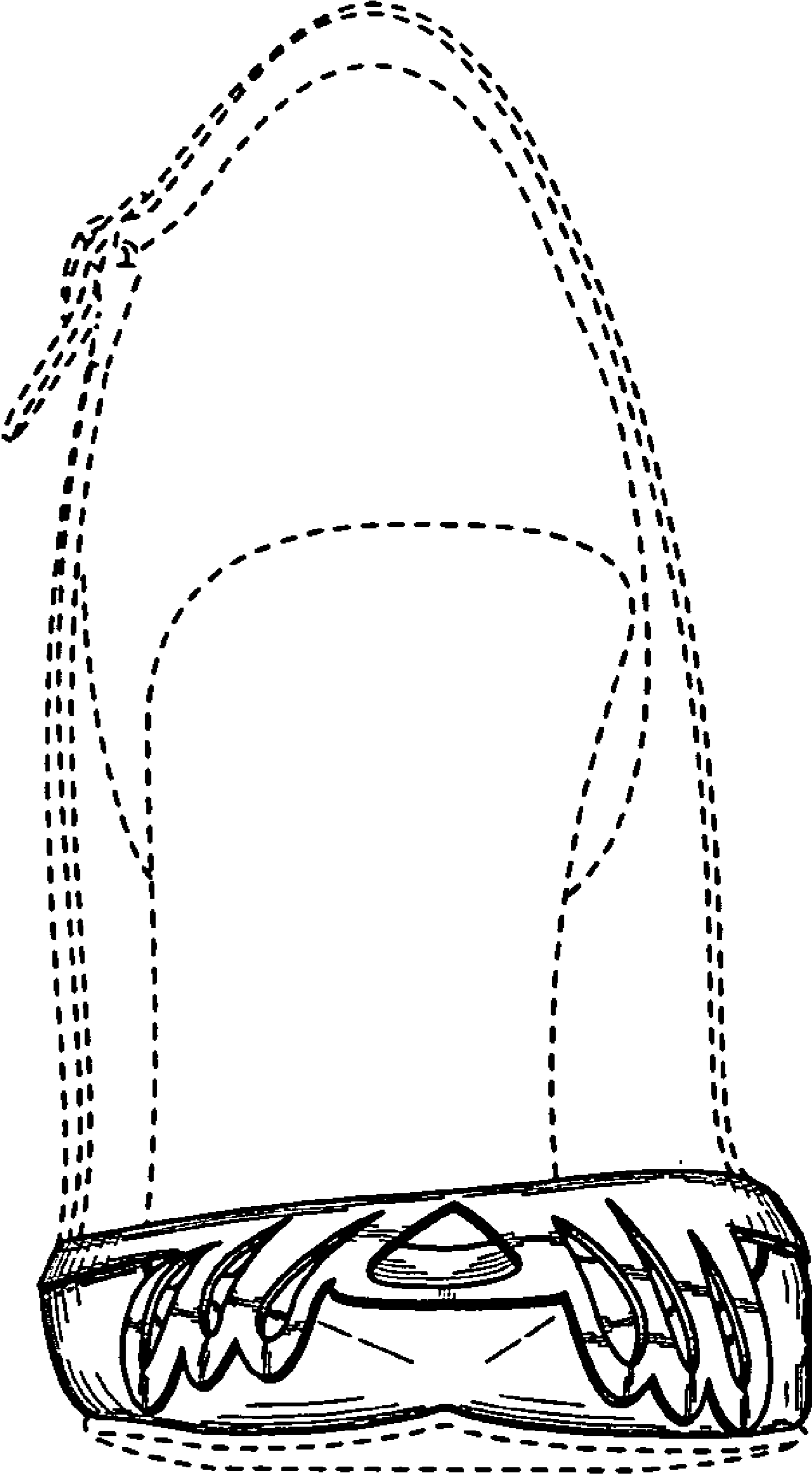

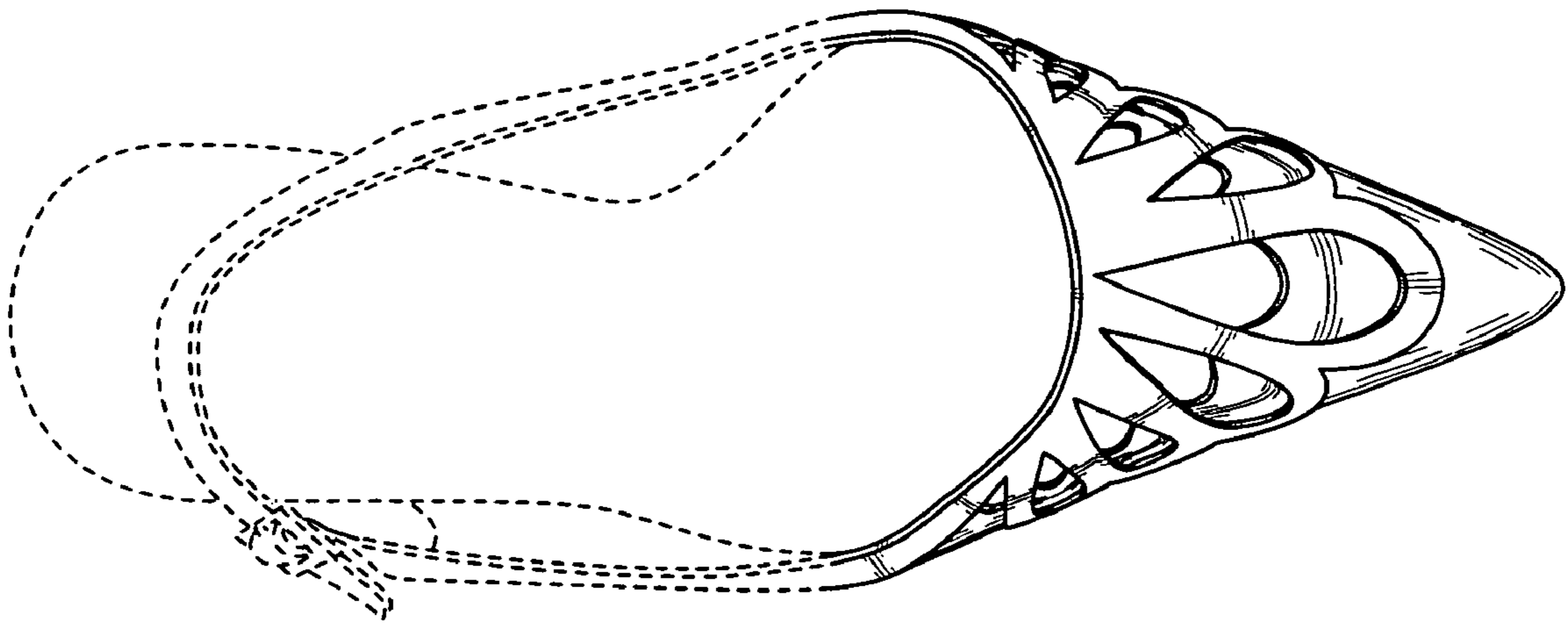

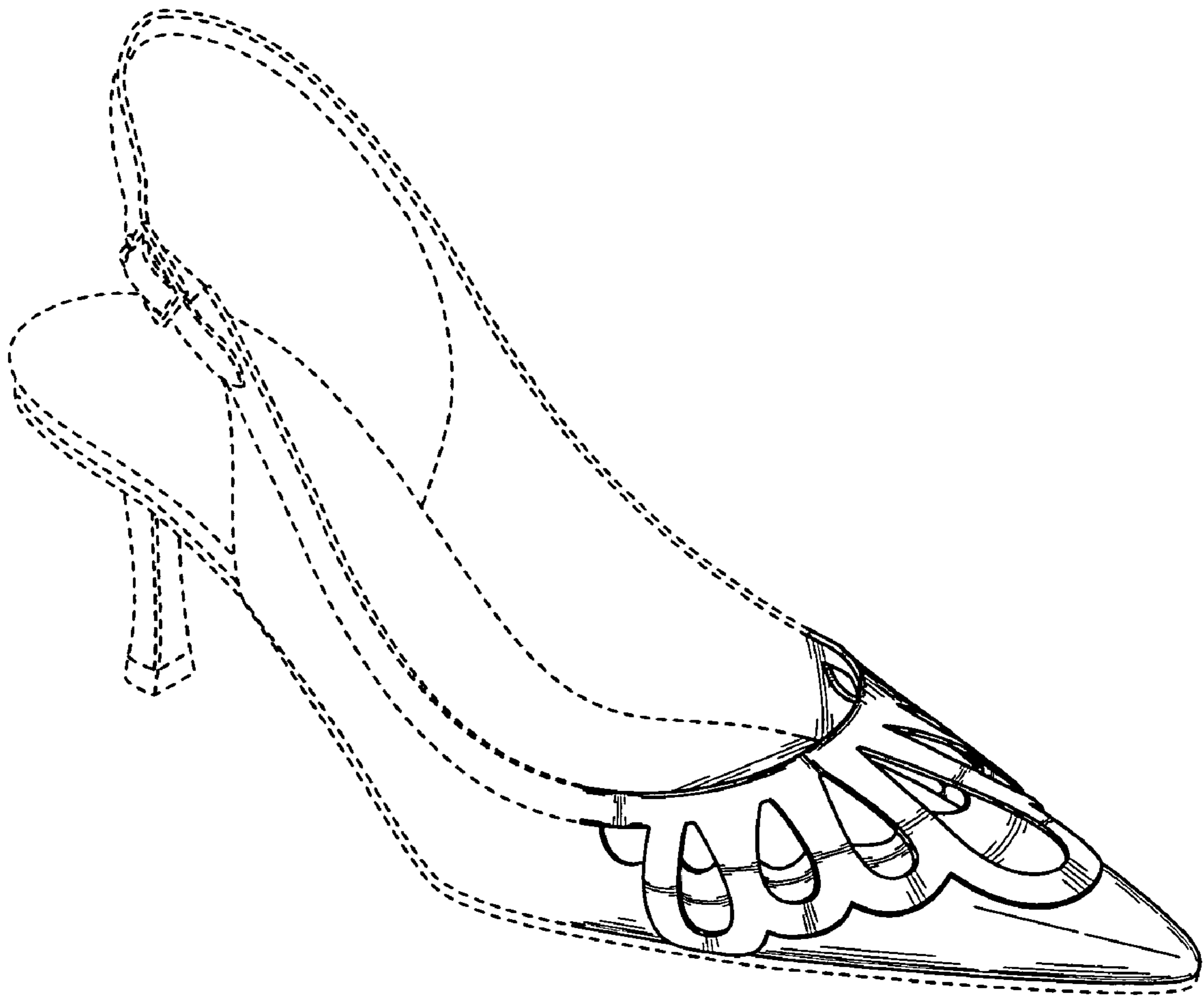

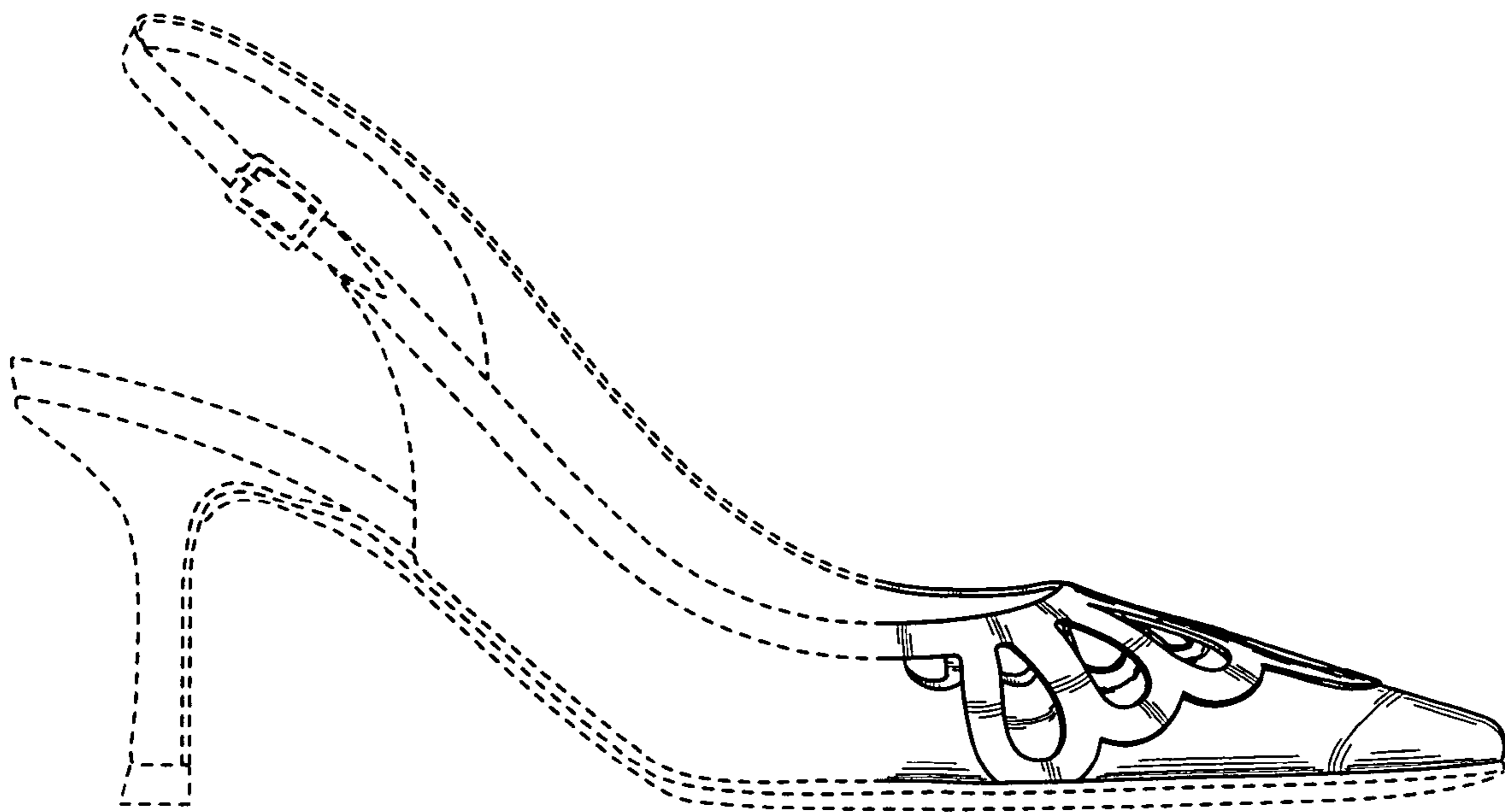

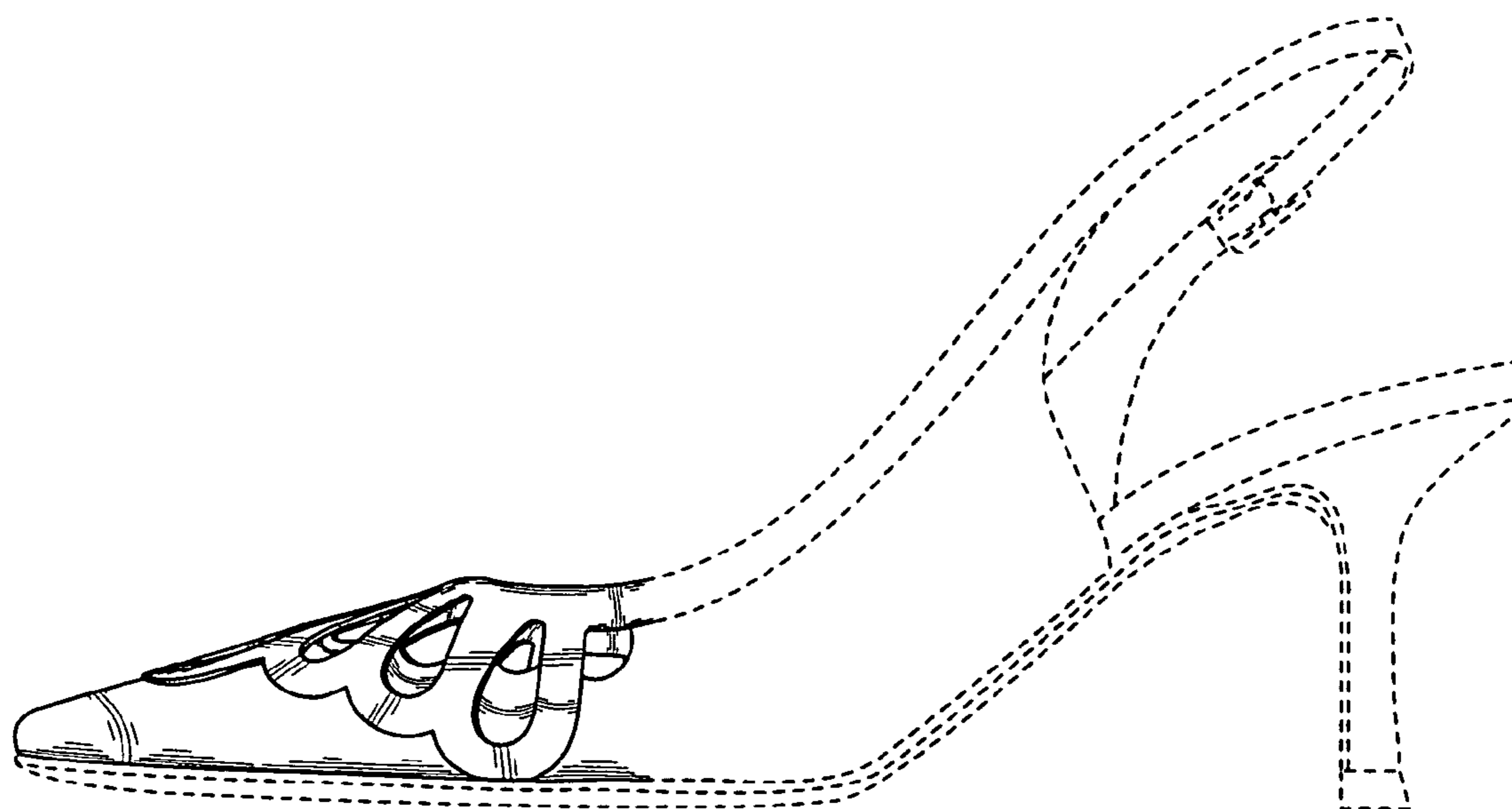

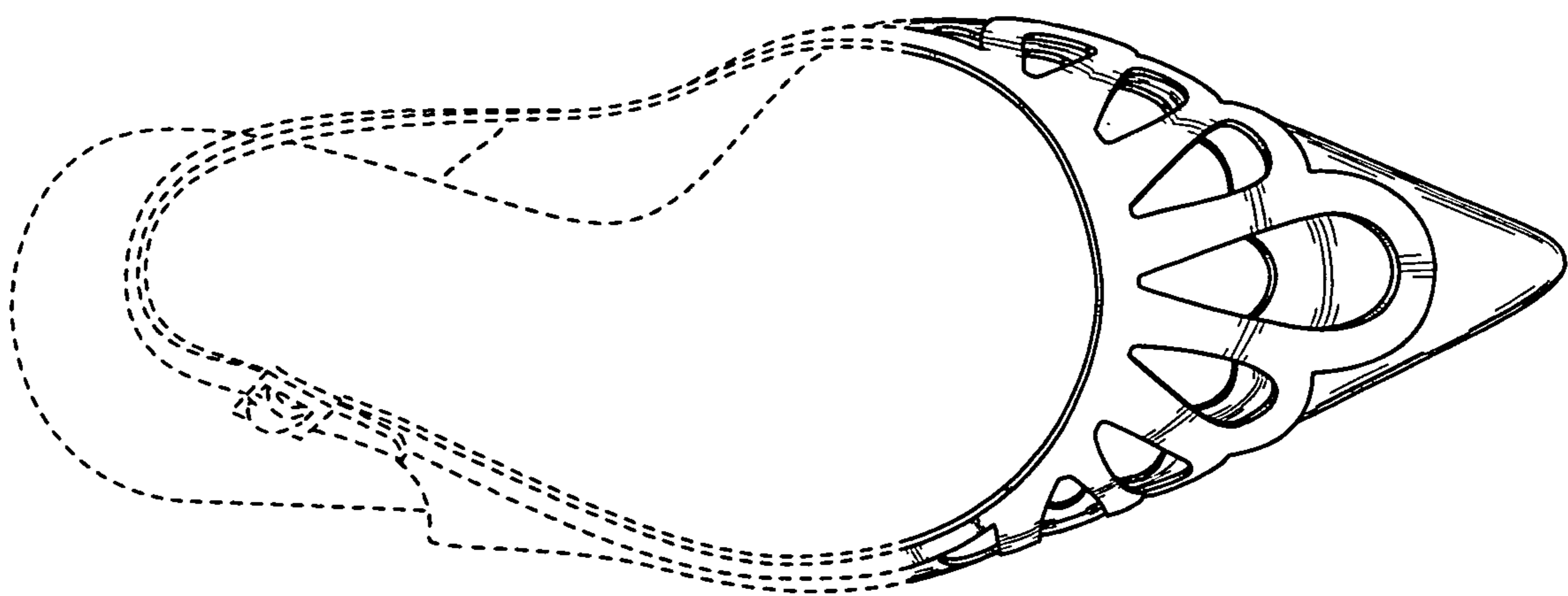

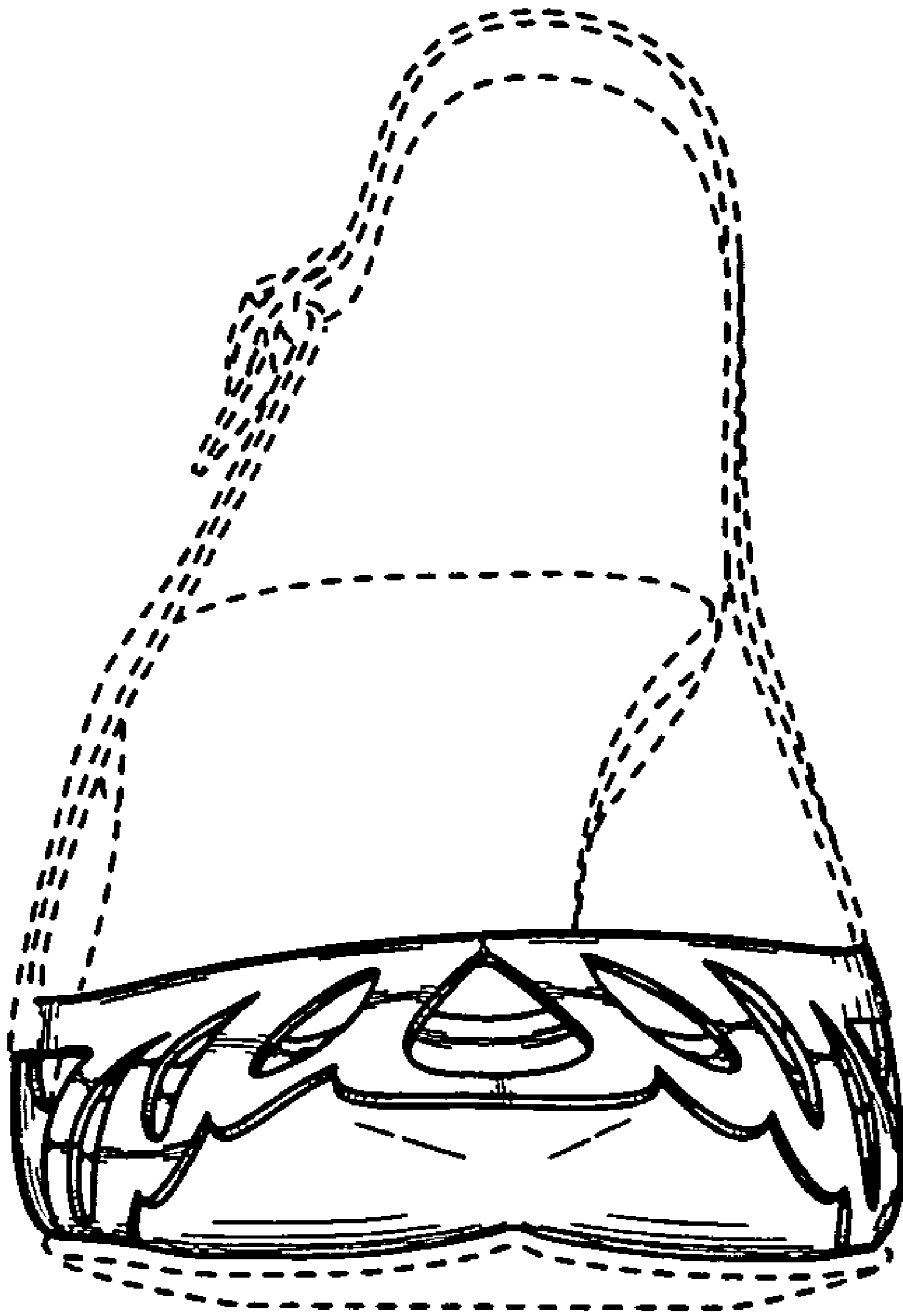
