The ornamental design for an optical case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of an Optical case showing my new design, wherein the dash-dash-dash broken line shown in FIG. 1 represents a stitching line.

FIG. 2 is a front elevational view thereof, wherein the dash-dash-dash broken line shown in FIG. 2 represents a stitching line.

FIG. 3 is a rear elevational view thereof, wherein the dash-dash-dash broken line shown in FIG. 3 represents a stitching line.

FIG. 4 is a right side elevational view thereof.

FIG. 5 is a left side elevational view thereof.

FIG. 6 is a top plan view thereof, wherein the dash-dash-dash broken line shown in FIG. 6 represents a stitching line.

FIG. 7 is a bottom plan view thereof, wherein the dash-dash-dash broken line shown in FIG. 7 represents a stitching line.


FIG. 8 is a top, front, right side perspective view of the Optical Case of FIG. 1, shown in an opened condition, wherein the dash-dash-dash broken line shown in FIG. 8 represents a stitching line; and,

FIG. 9 is a front, right perspective view of the Optical Case of FIG. 1, shown in an opened condition with a broken line showing of a sample, wherein the dash-dash-dash broken line shown in FIG. 9 represents a stitching line. The dot-dot-dash broken lines in FIG. 9 showing the sample are for illustrative purpose only and form no part of the claimed design.

The dash-dash-dash broken line shown in the drawings represents a stitching line.


















