FIG. 4 is right side view thereof;

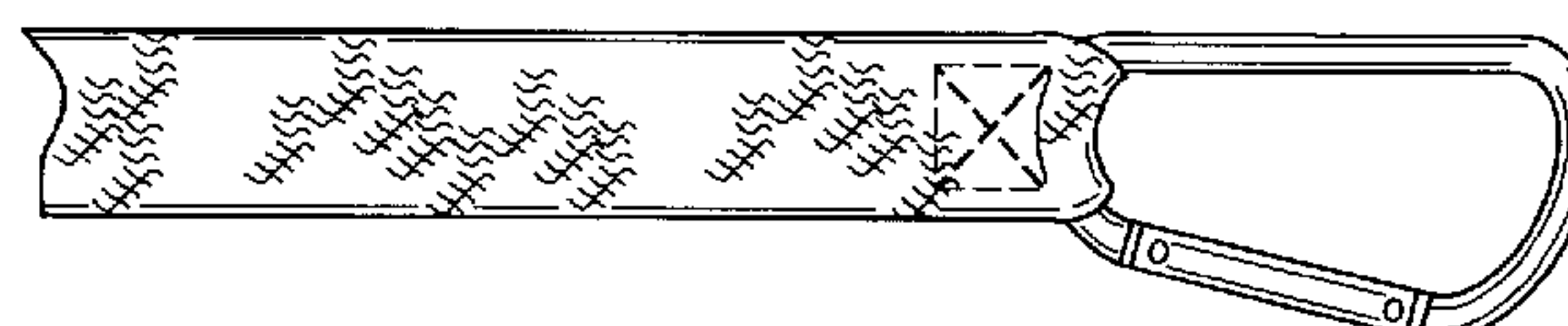
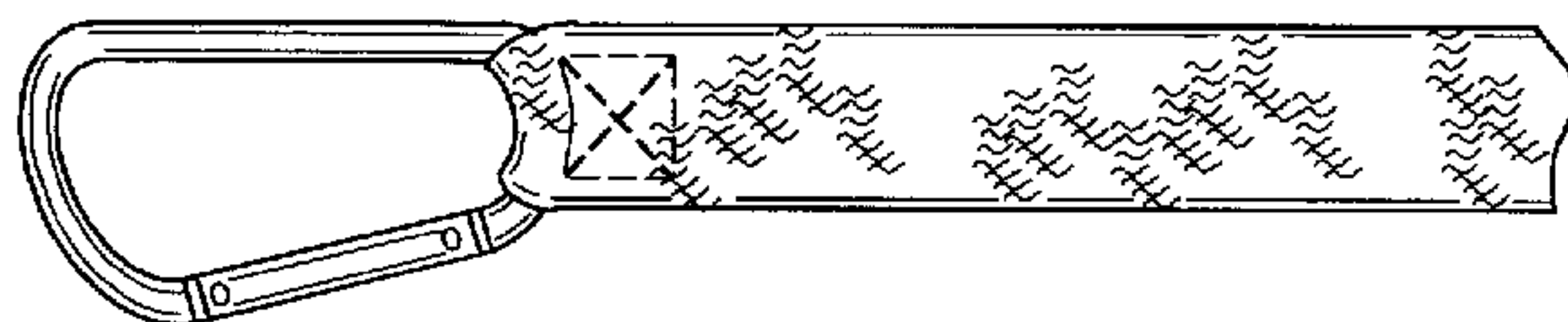
FIG. 5 is a top view thereof; and,

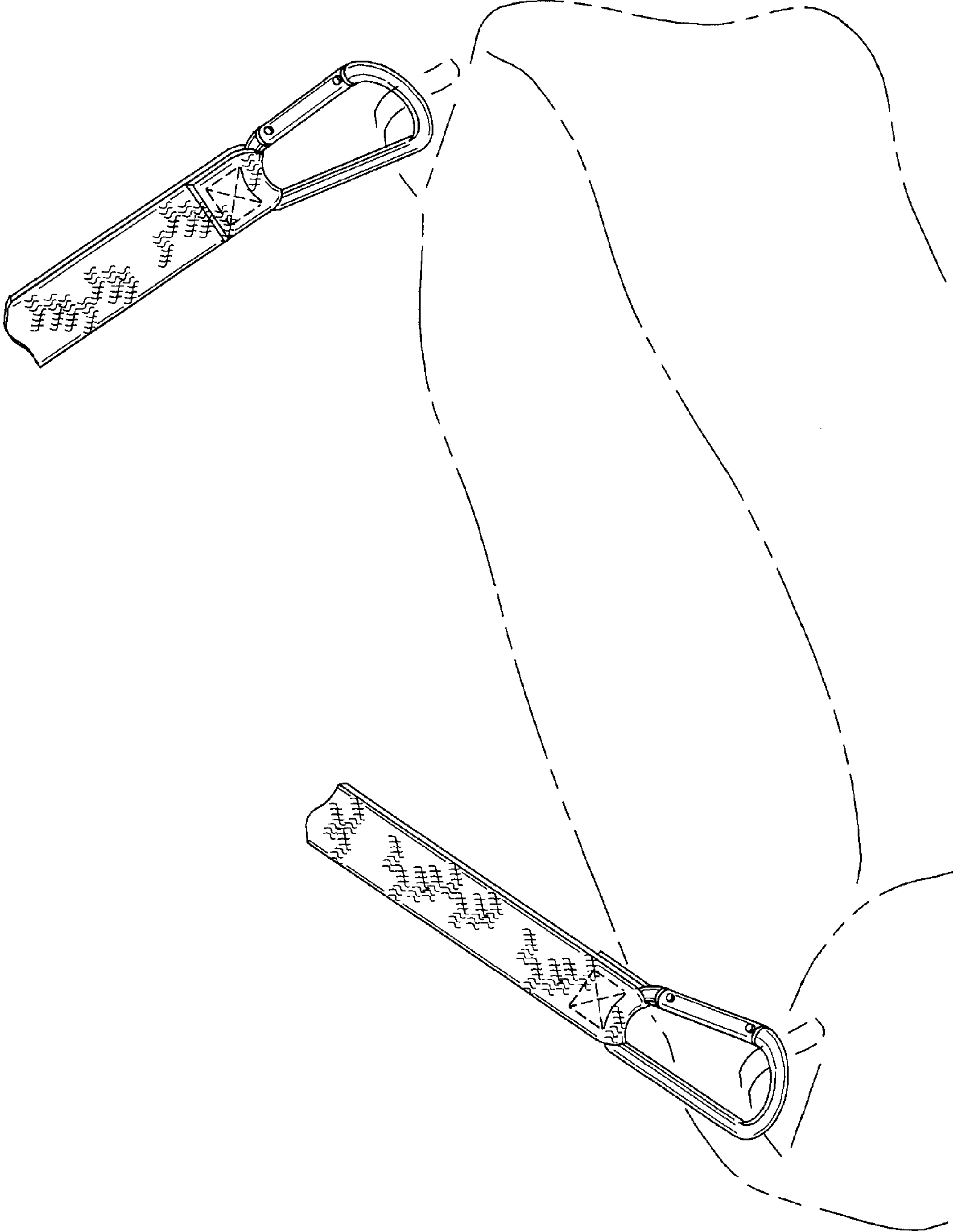

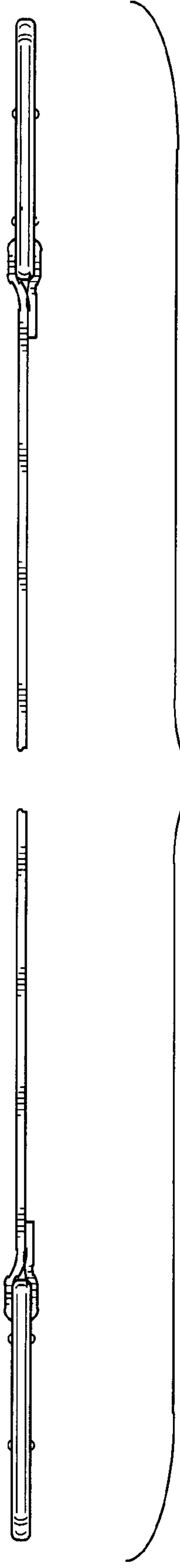

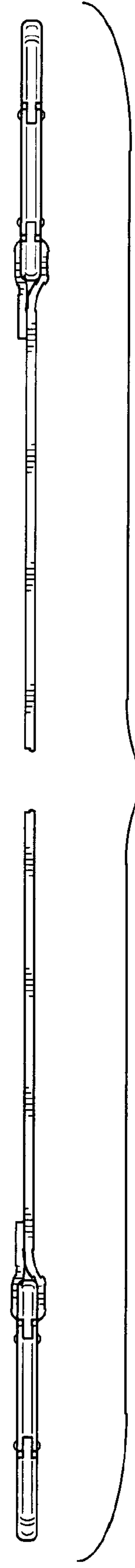

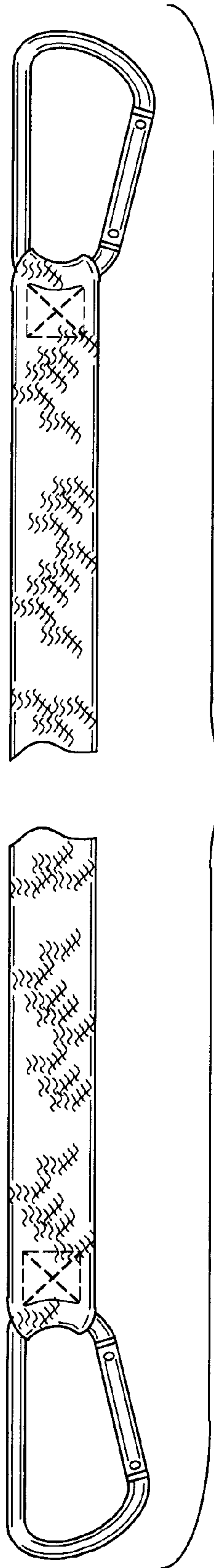

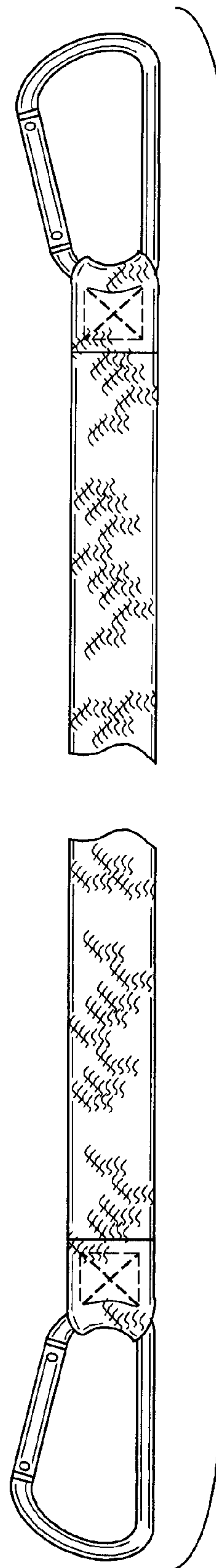
