DESCRIPTION

FIG. 1 is a front elevation view of a first embodiment of my new seat design in the form of a sofa;

FIG. 2 is a side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 11 is an opposite side elevation view thereof; and,

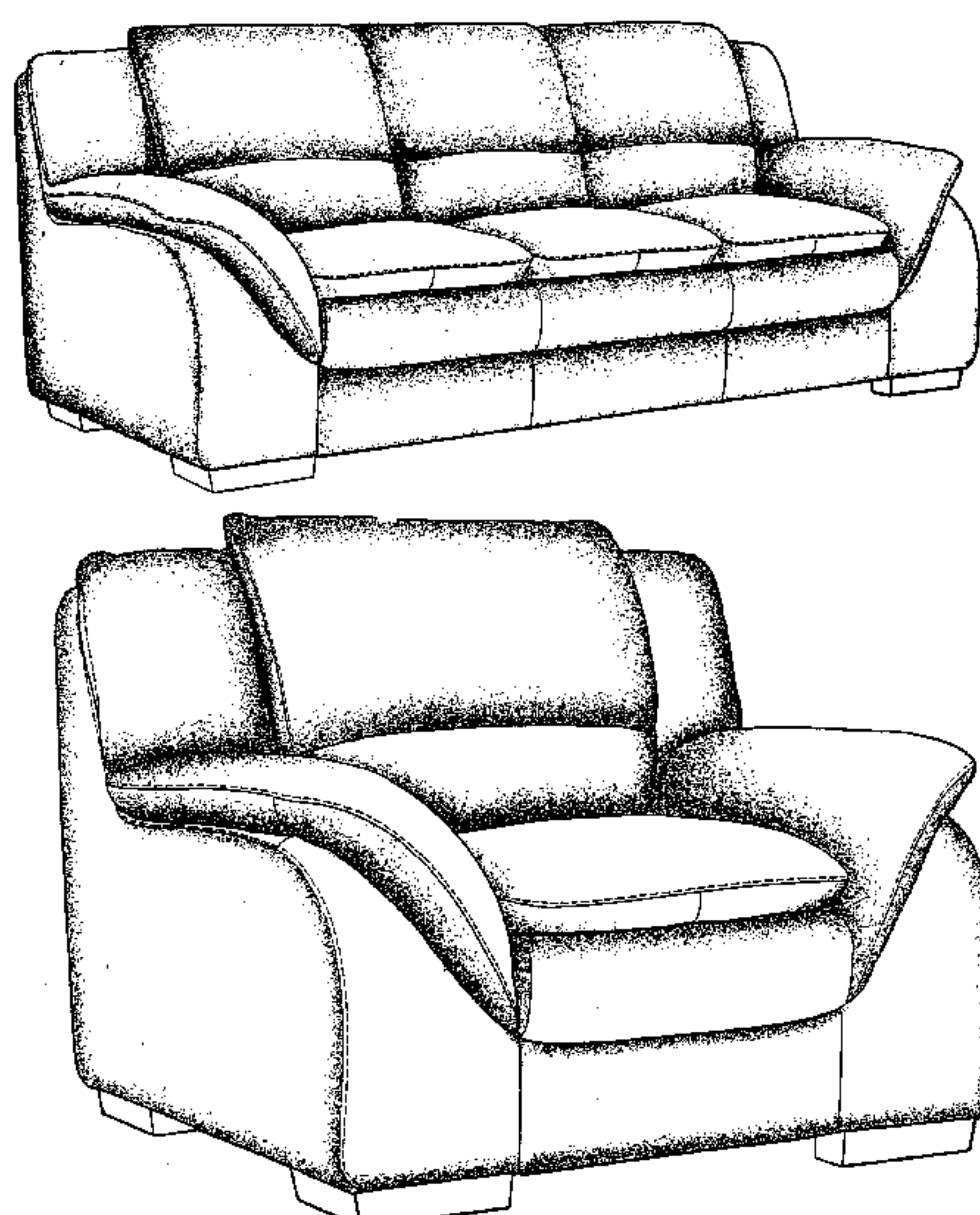
FIG. 12 is a top plan view thereof.

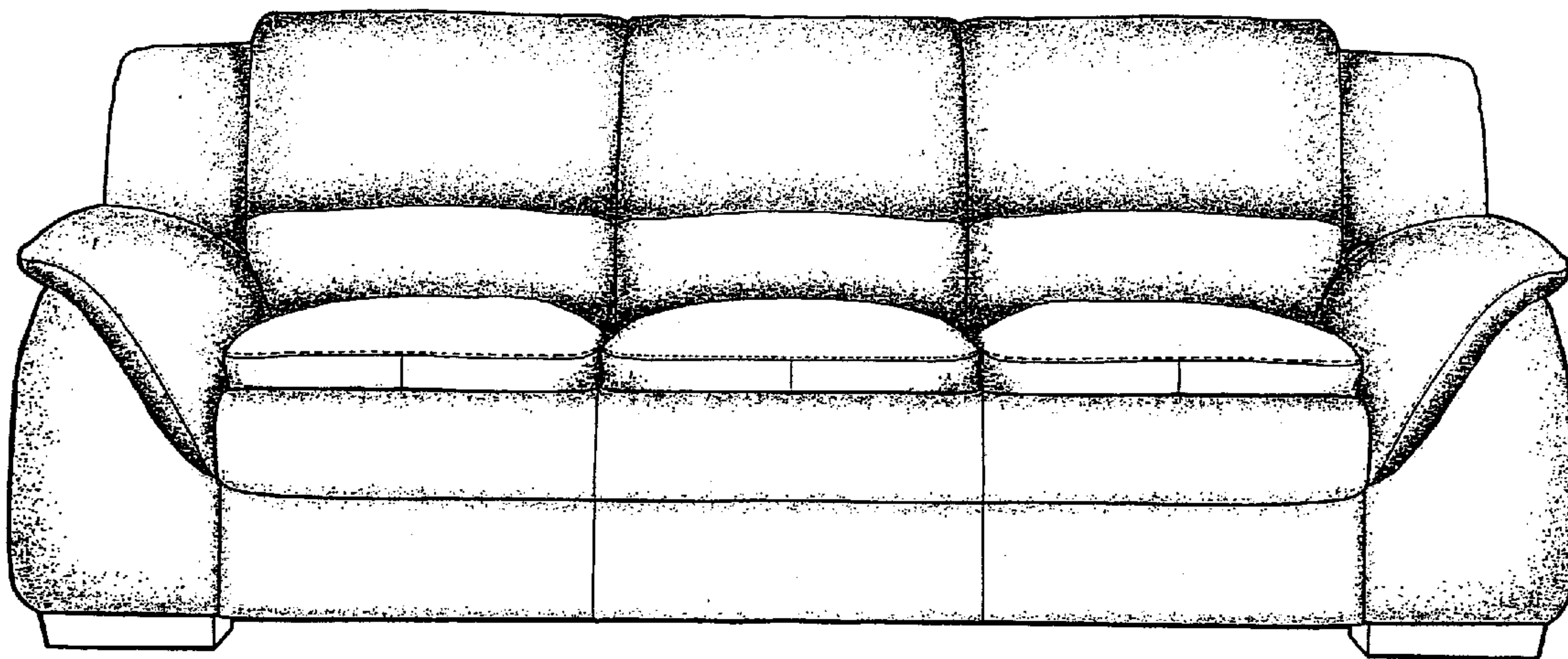

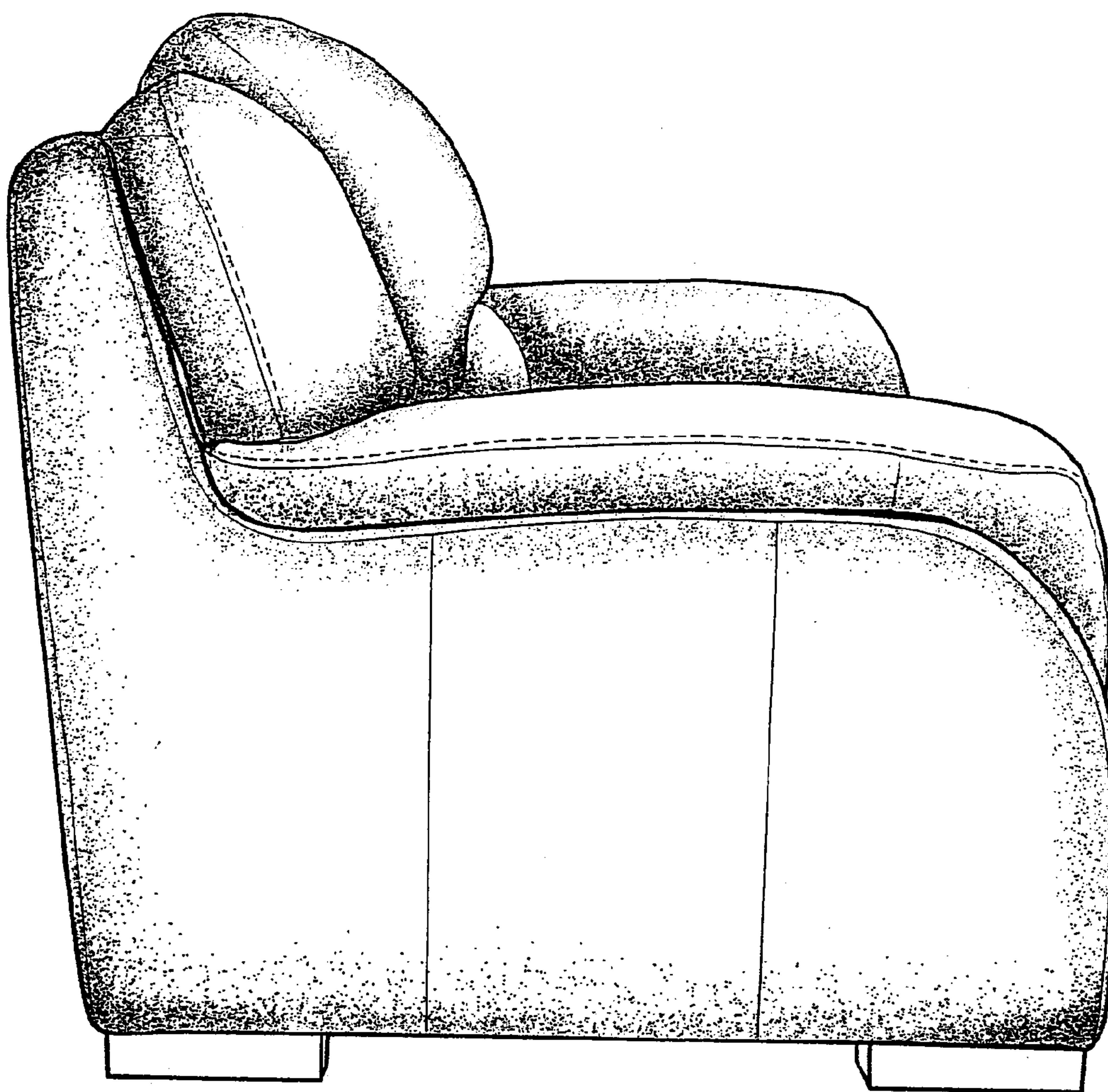

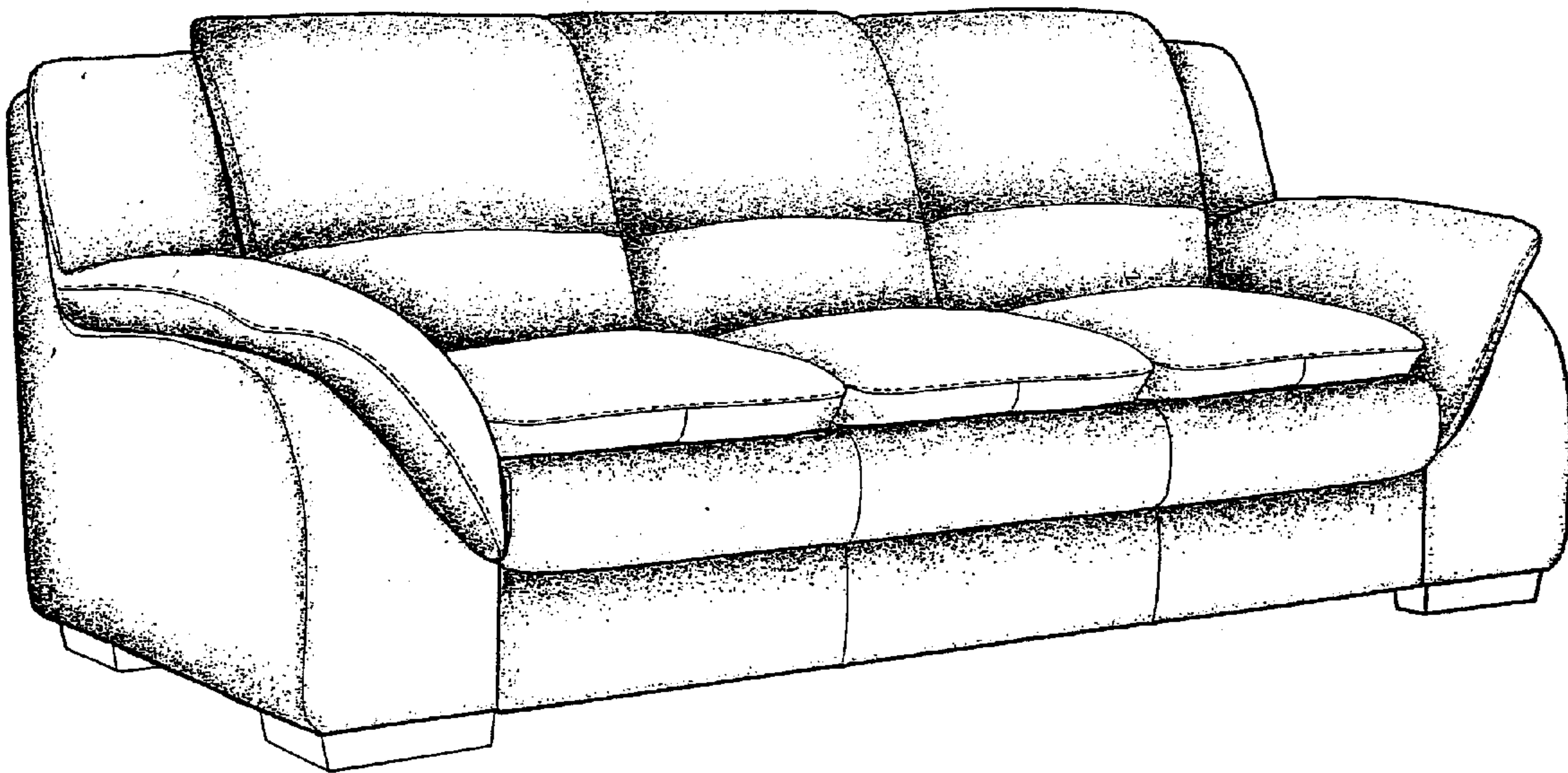

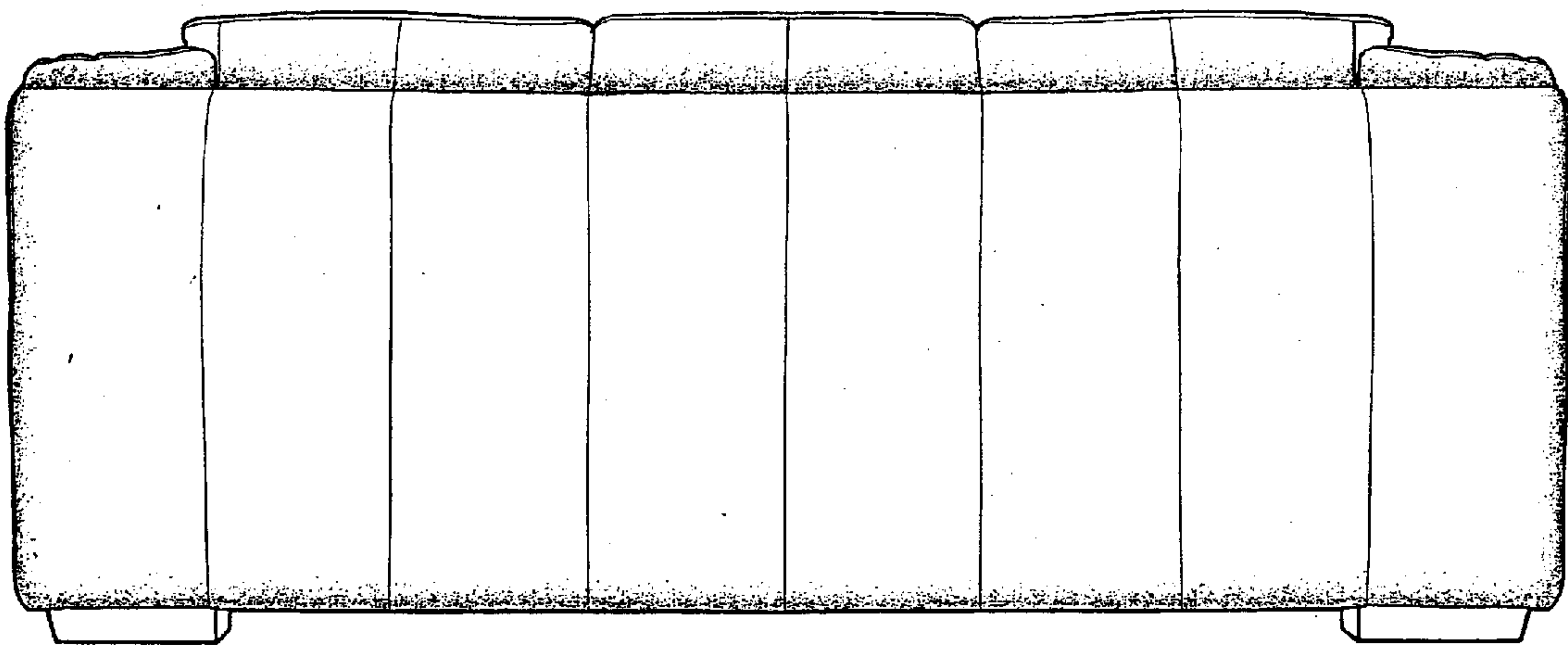

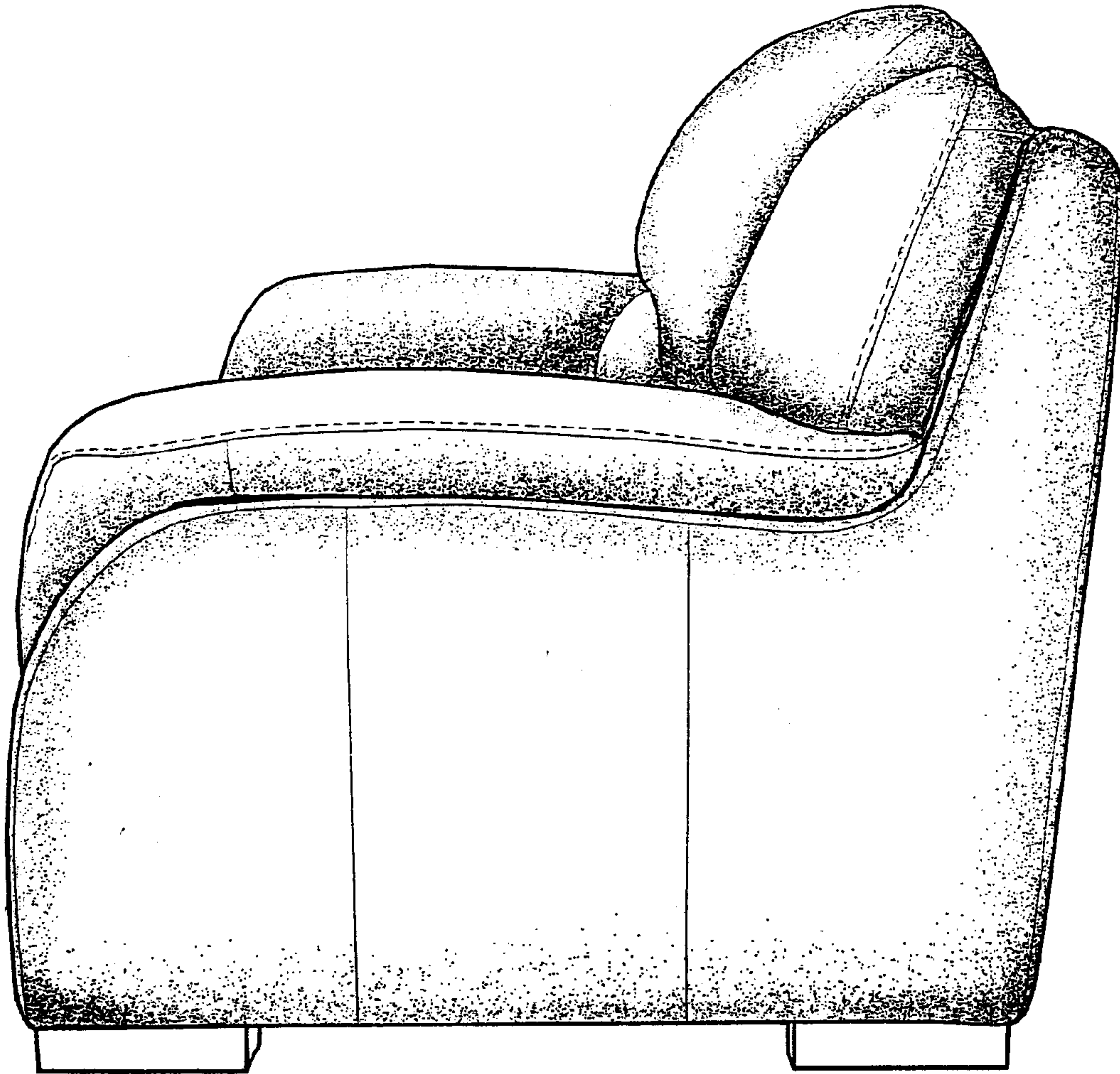

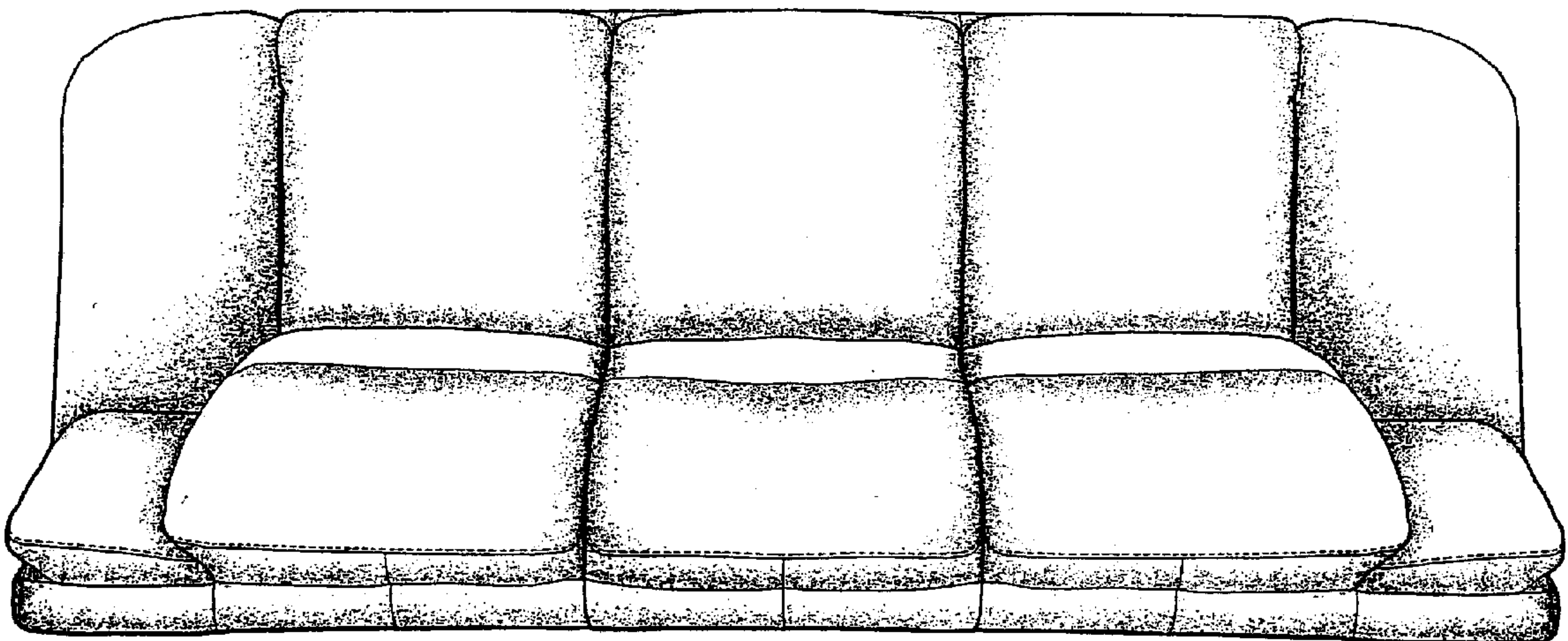

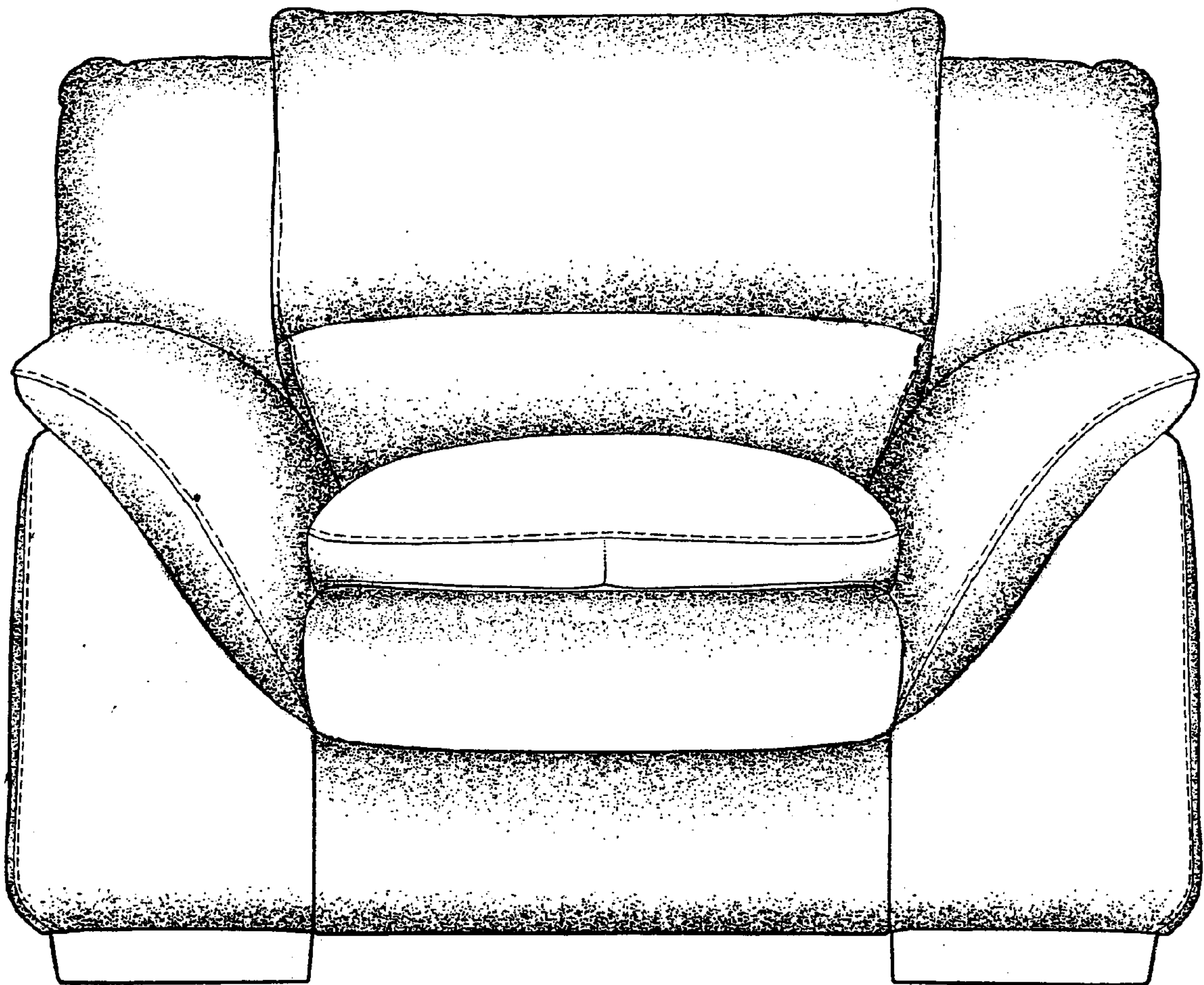

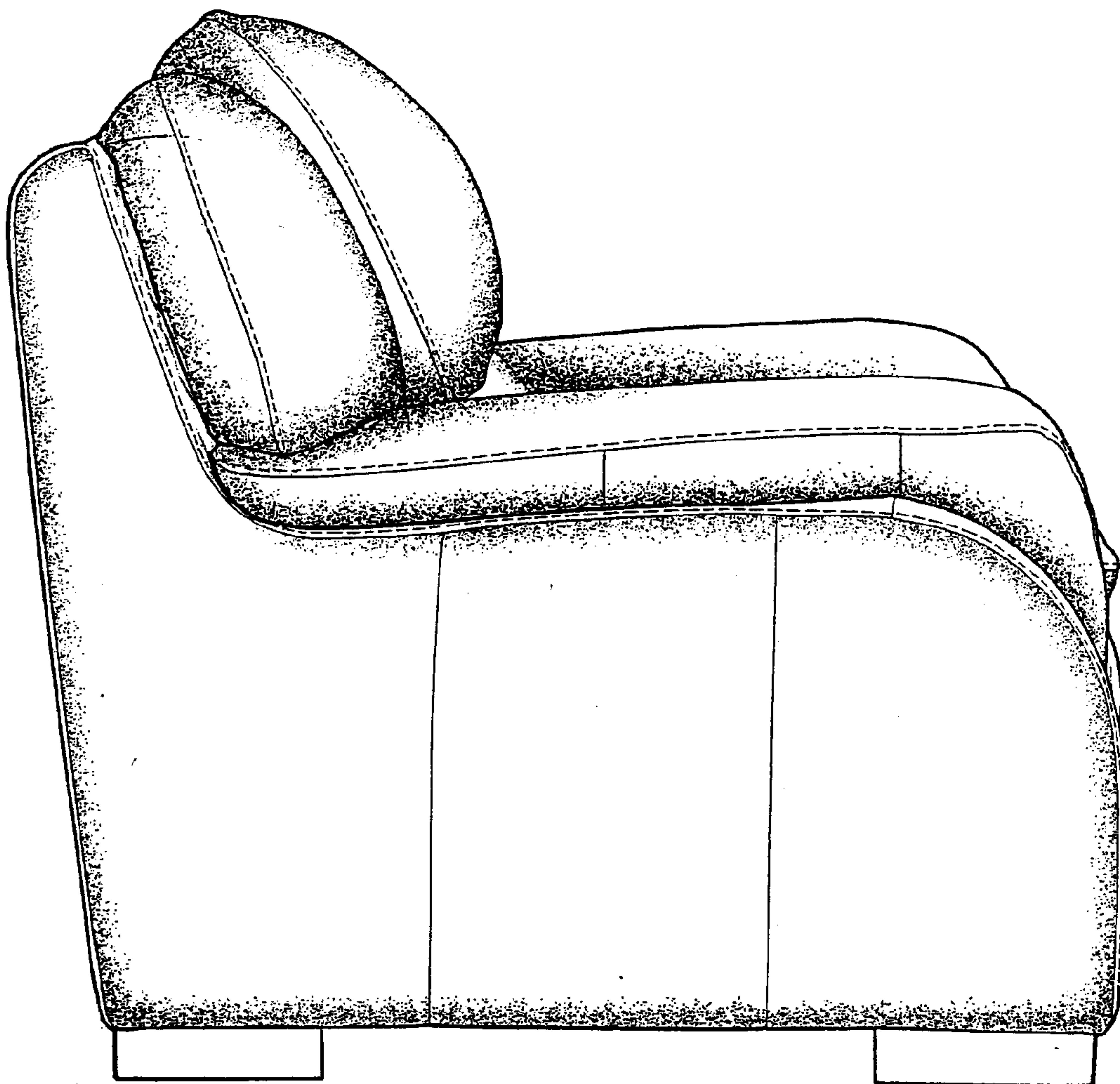

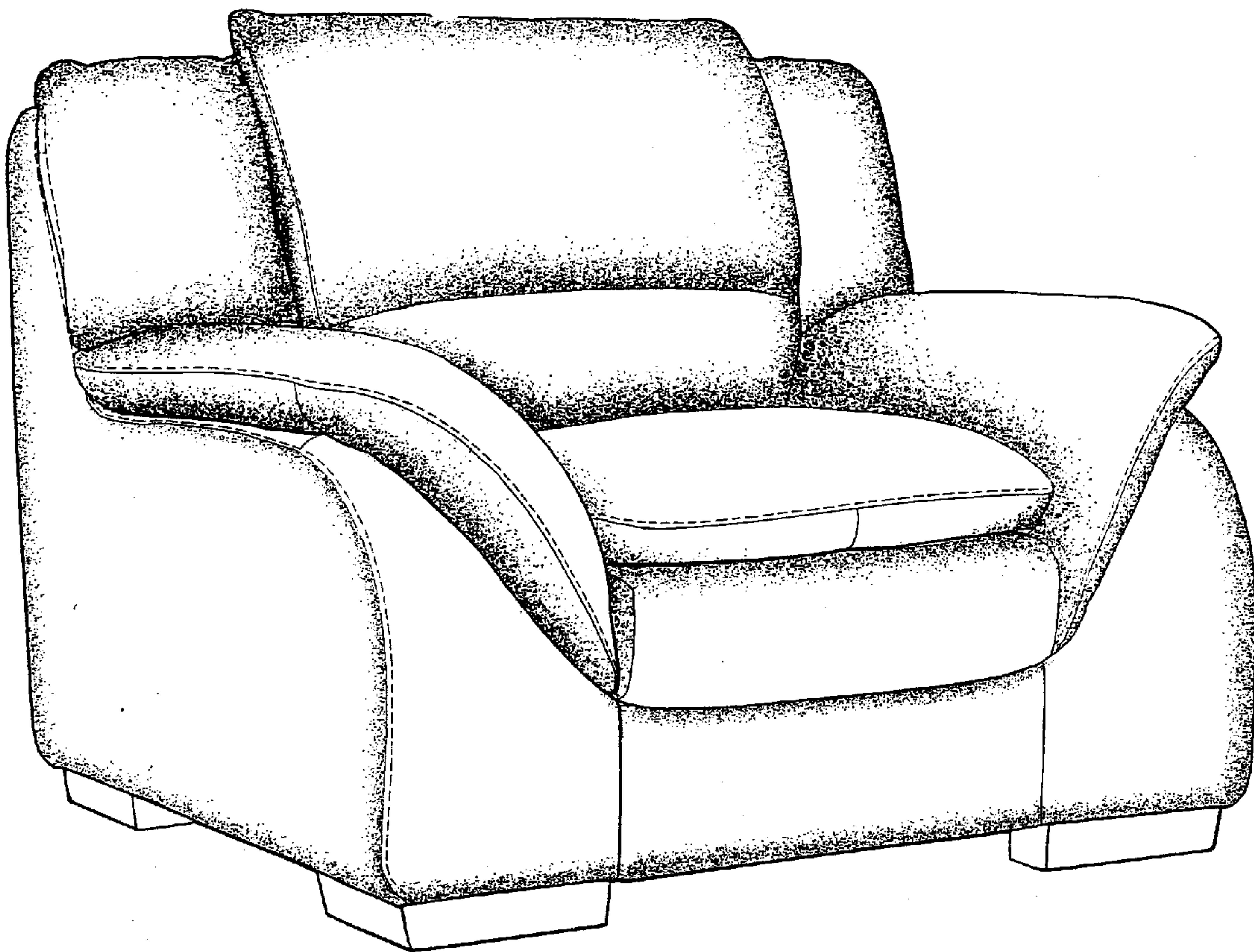

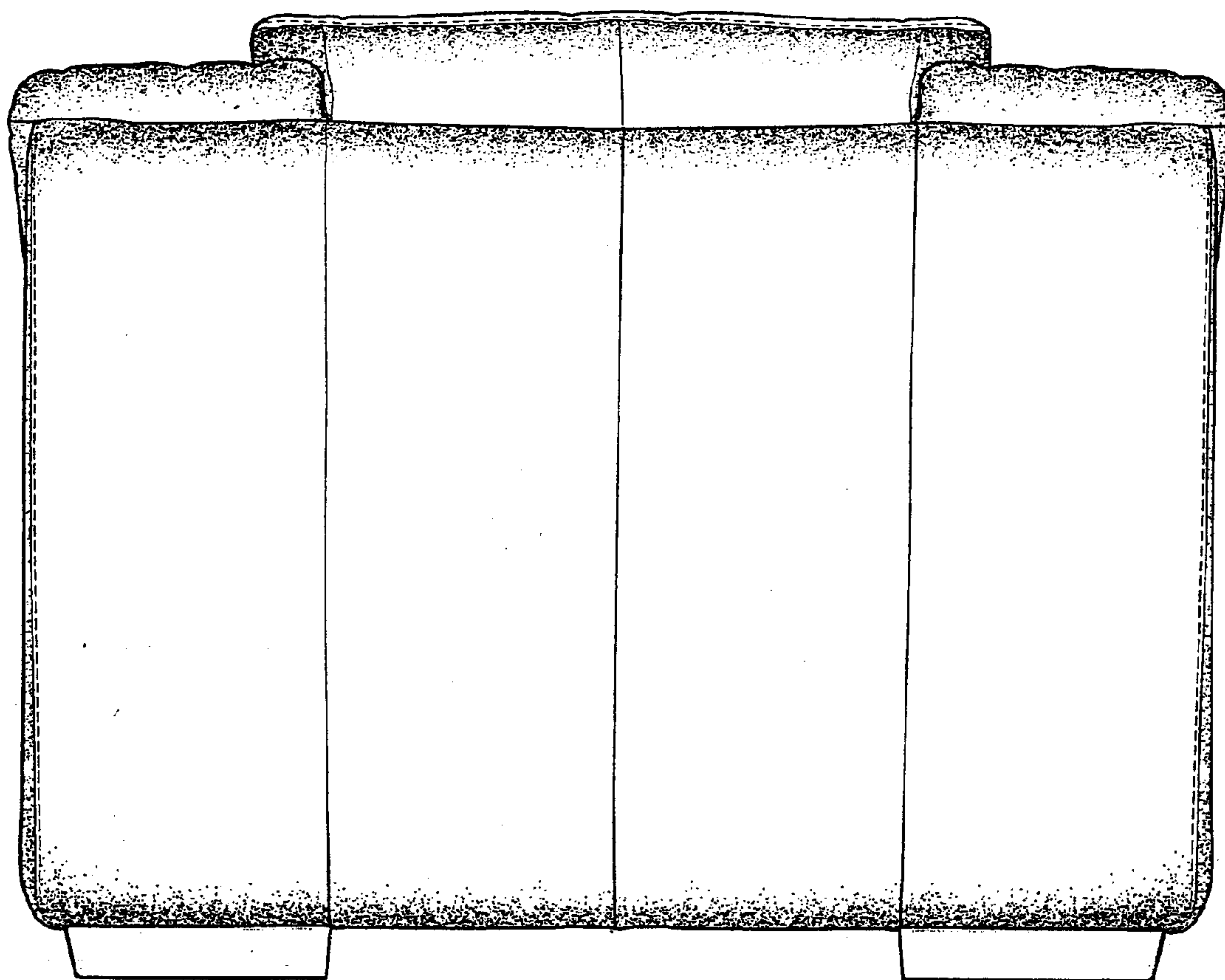

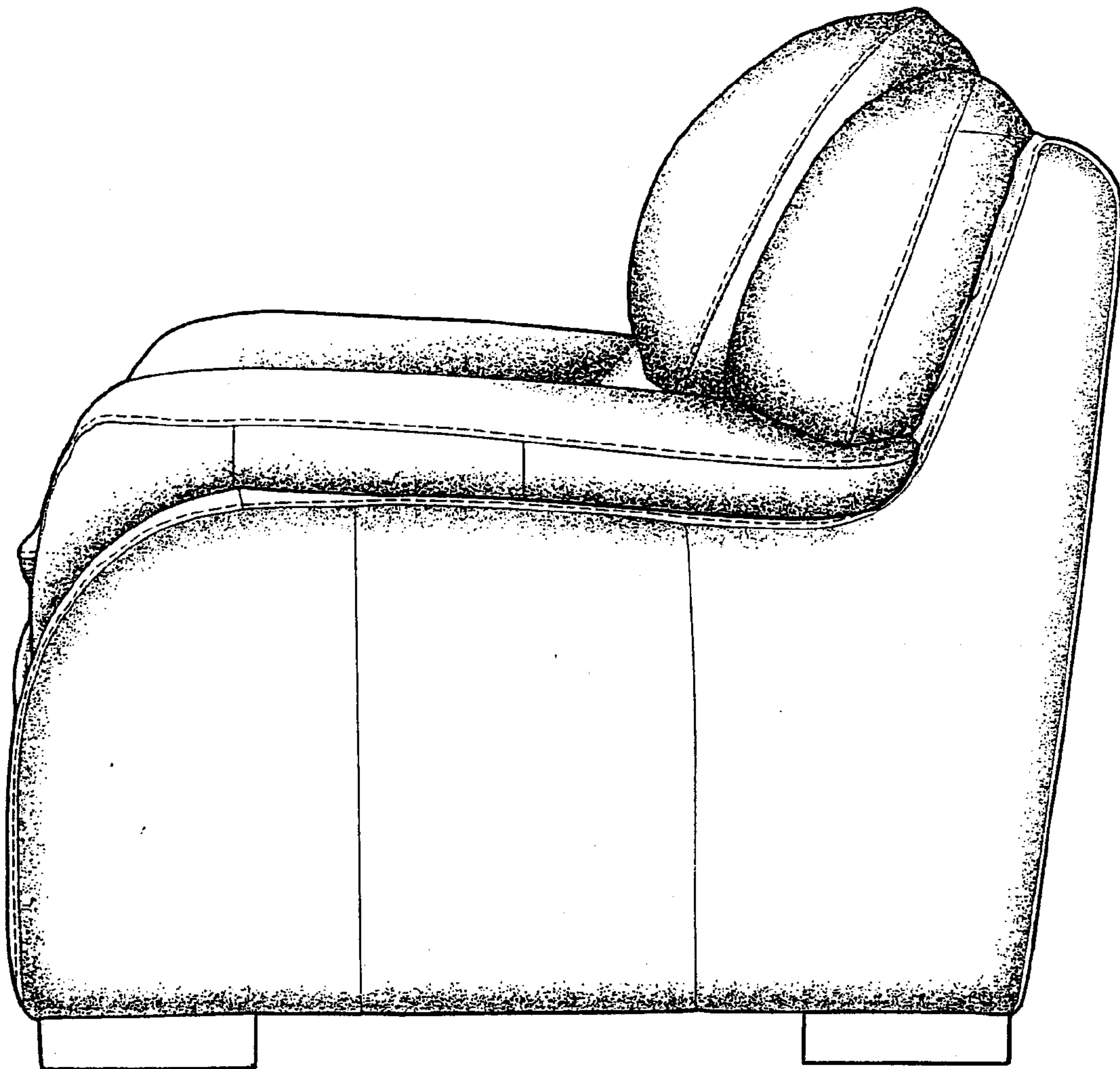

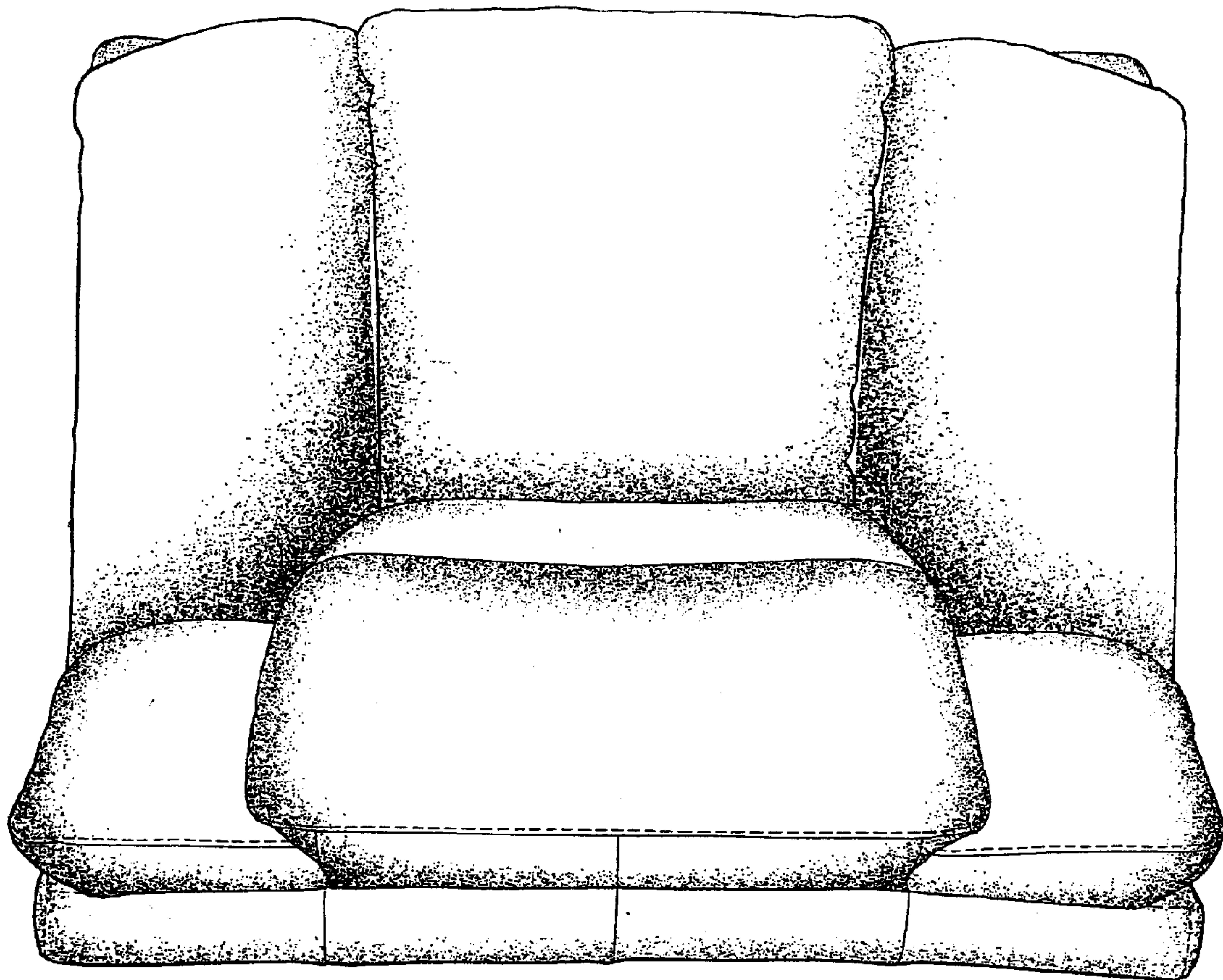
