FIG. 3 is a left side view thereof;

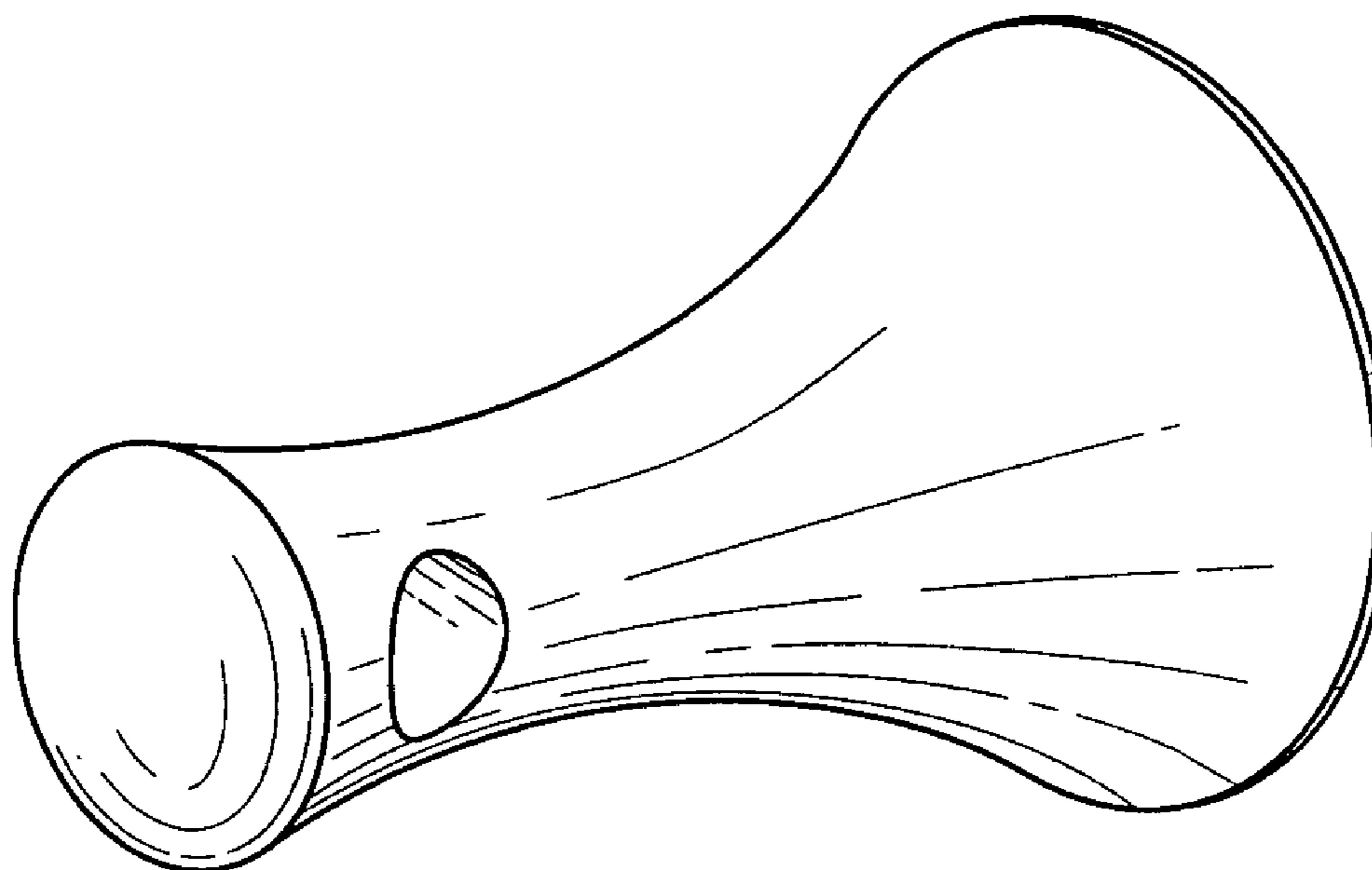
FIG. 4 is a right side view thereof;

FIG. 5 is a top plan view thereof;

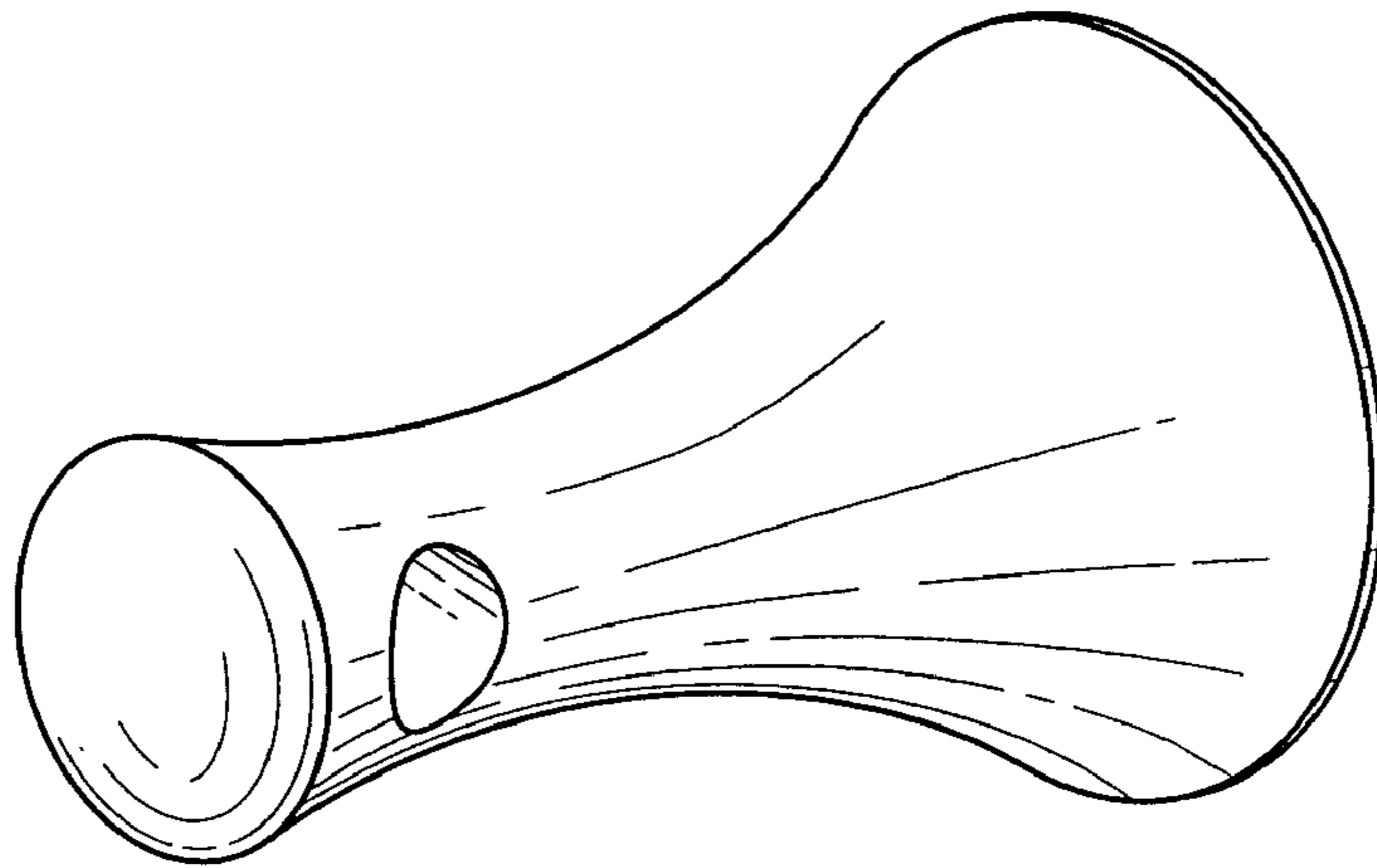
FIG. 6 is a bottom view thereof; and,

FIG. 7 is a rear view thereof.

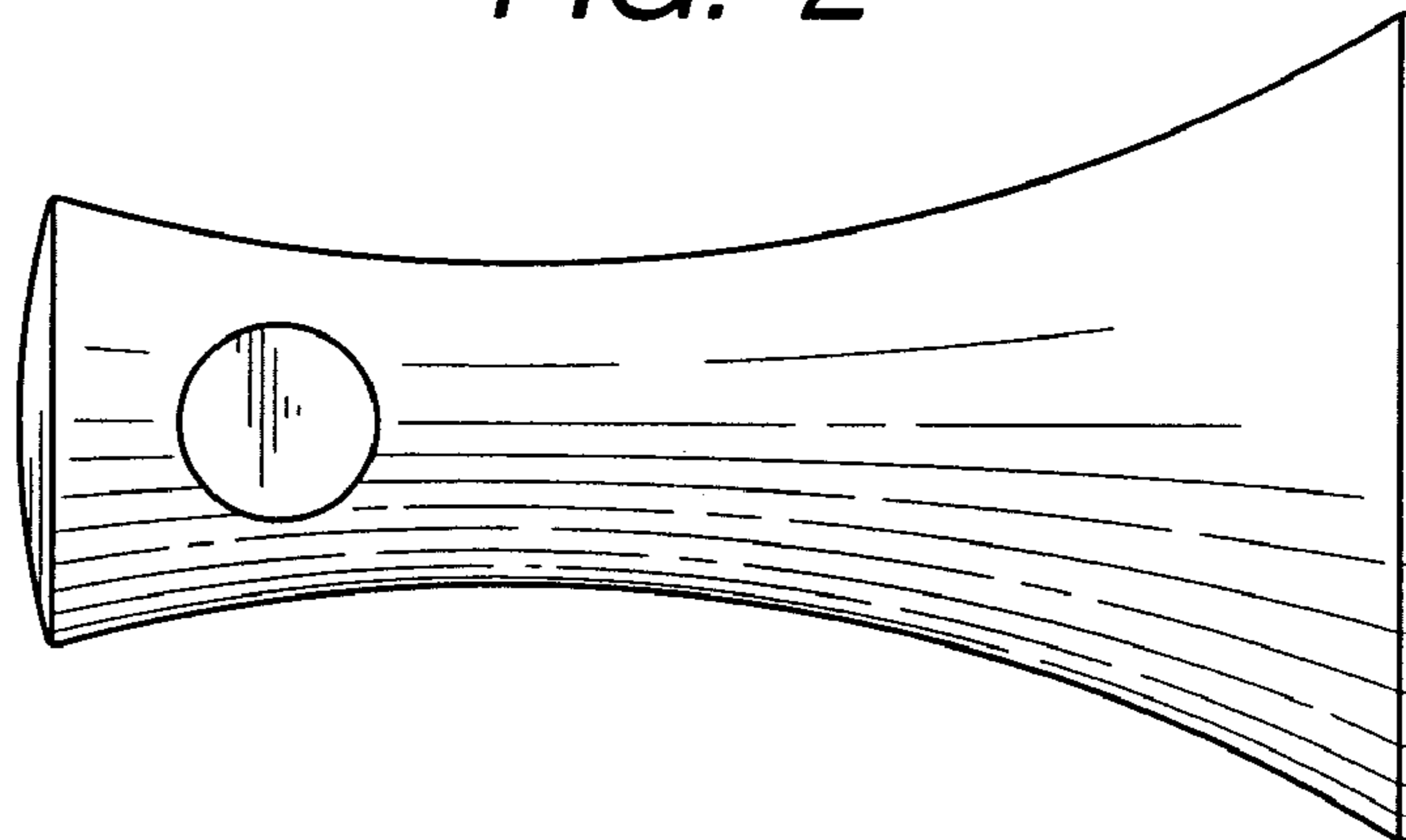

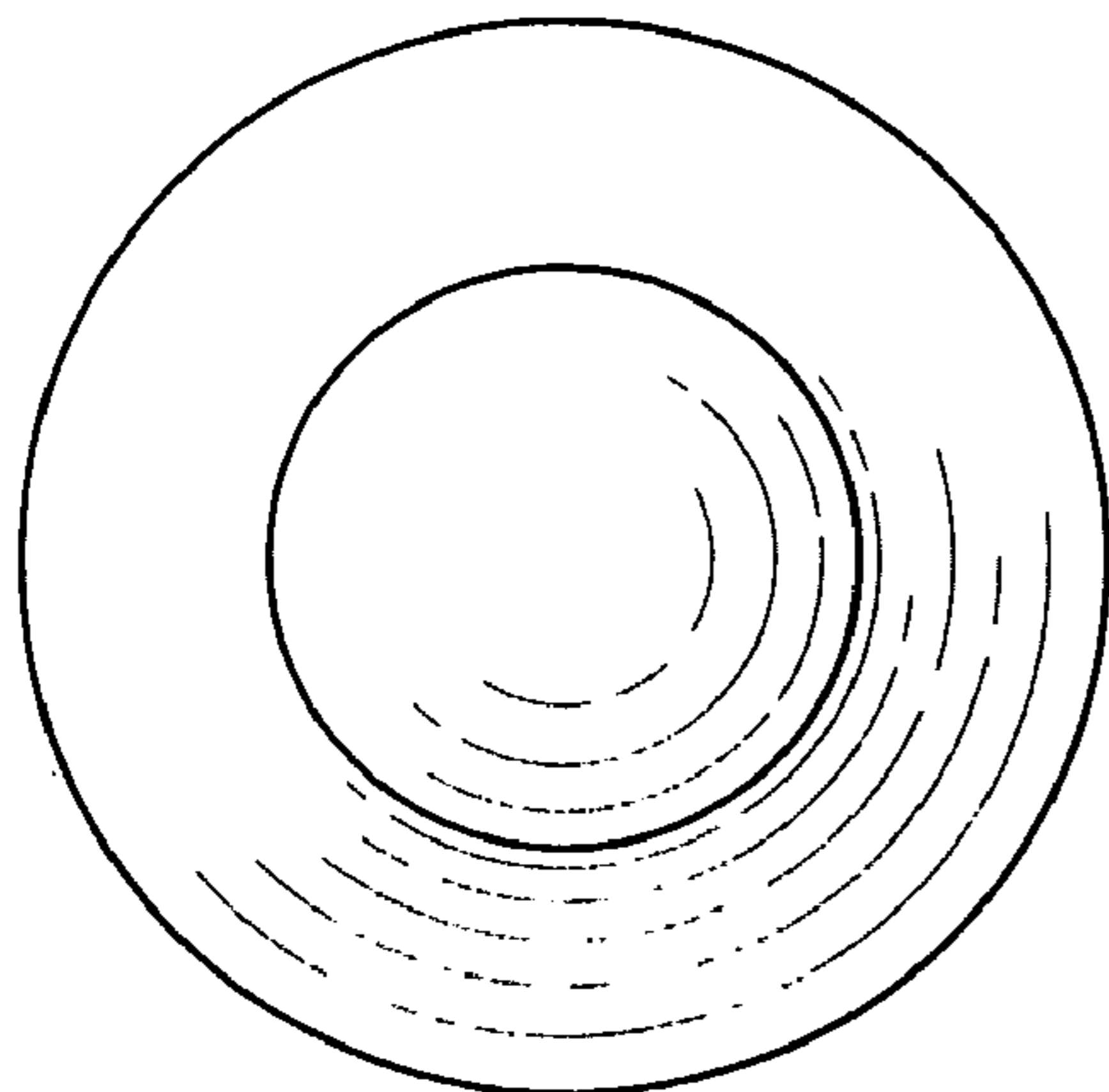

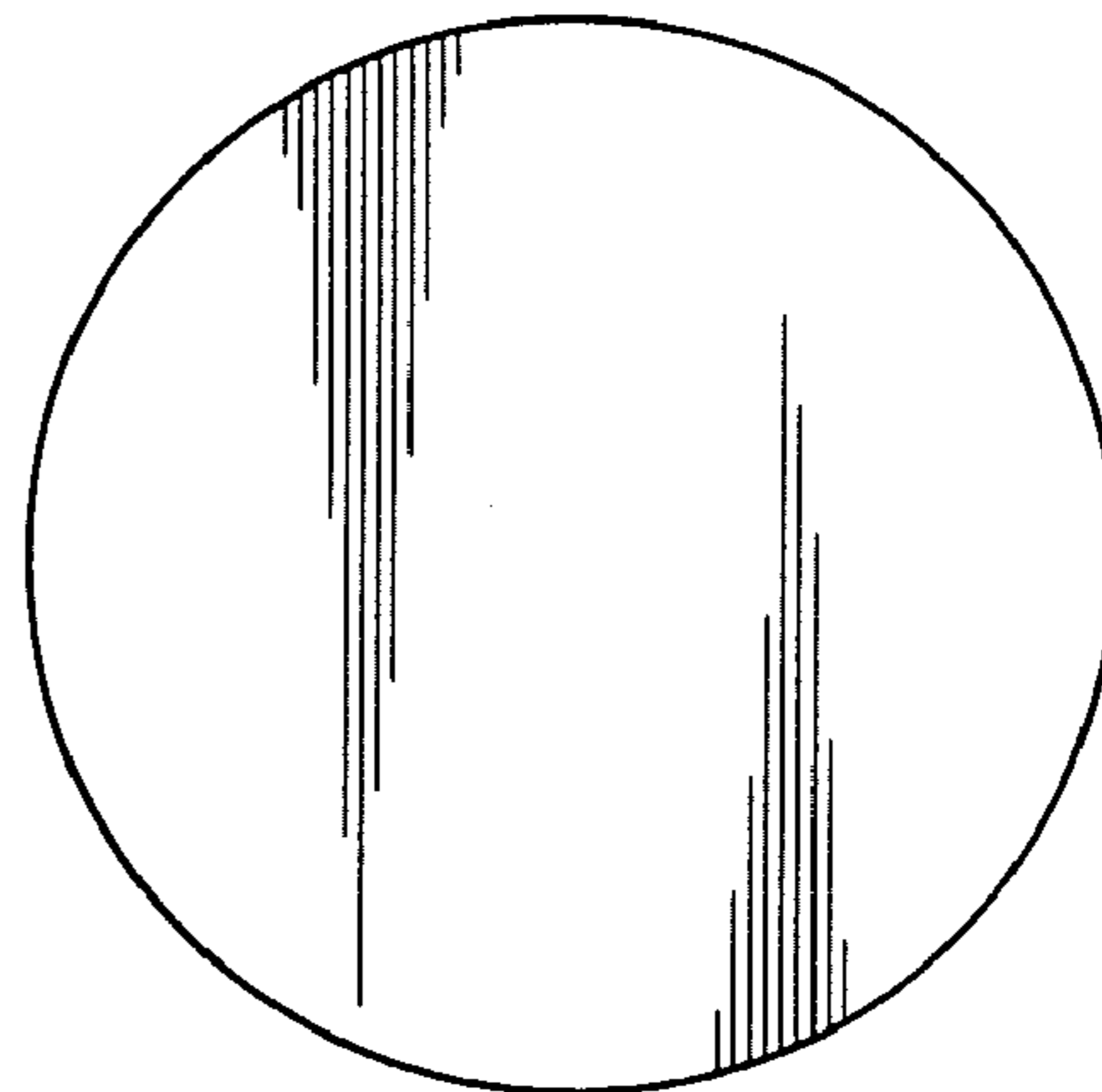

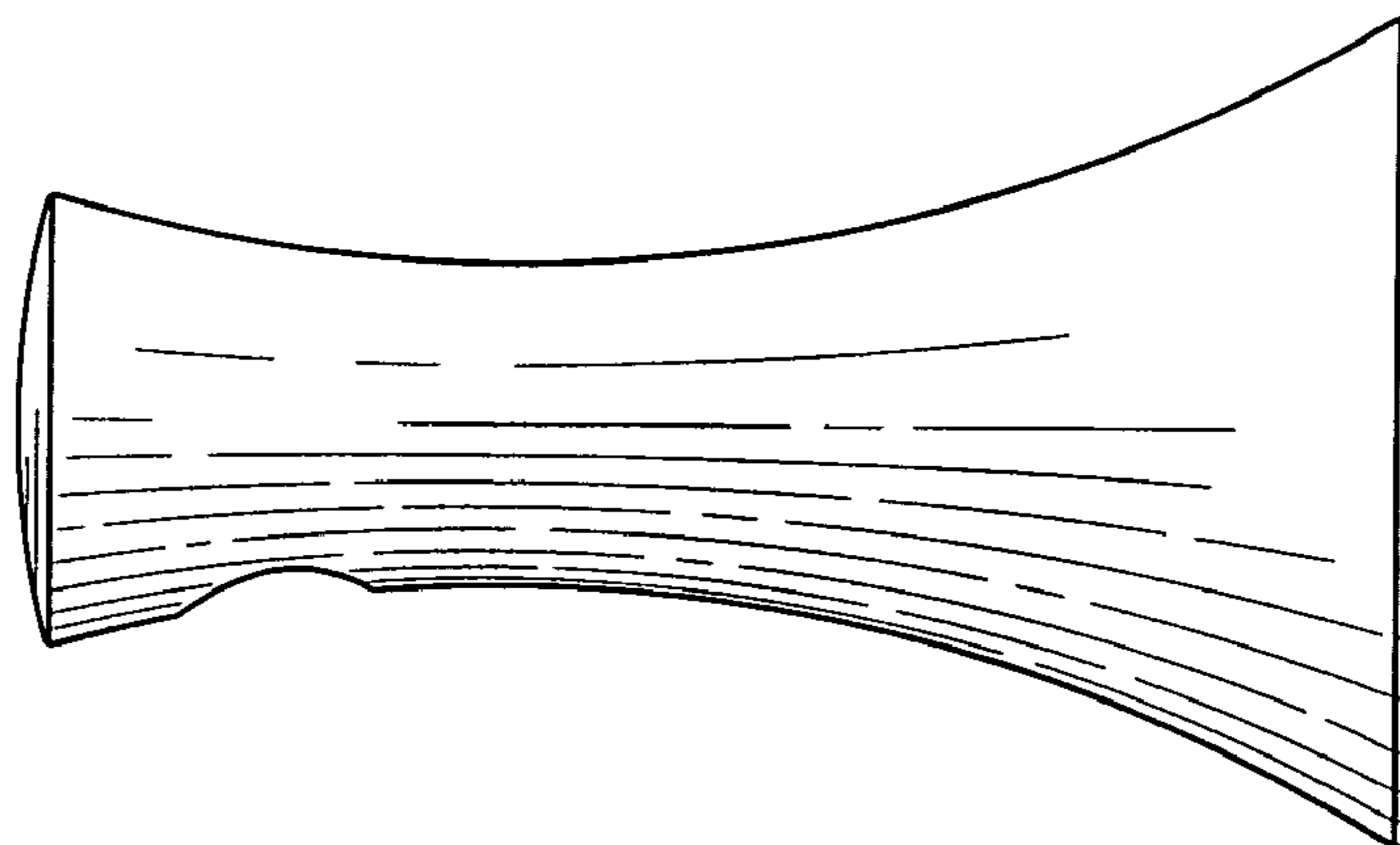

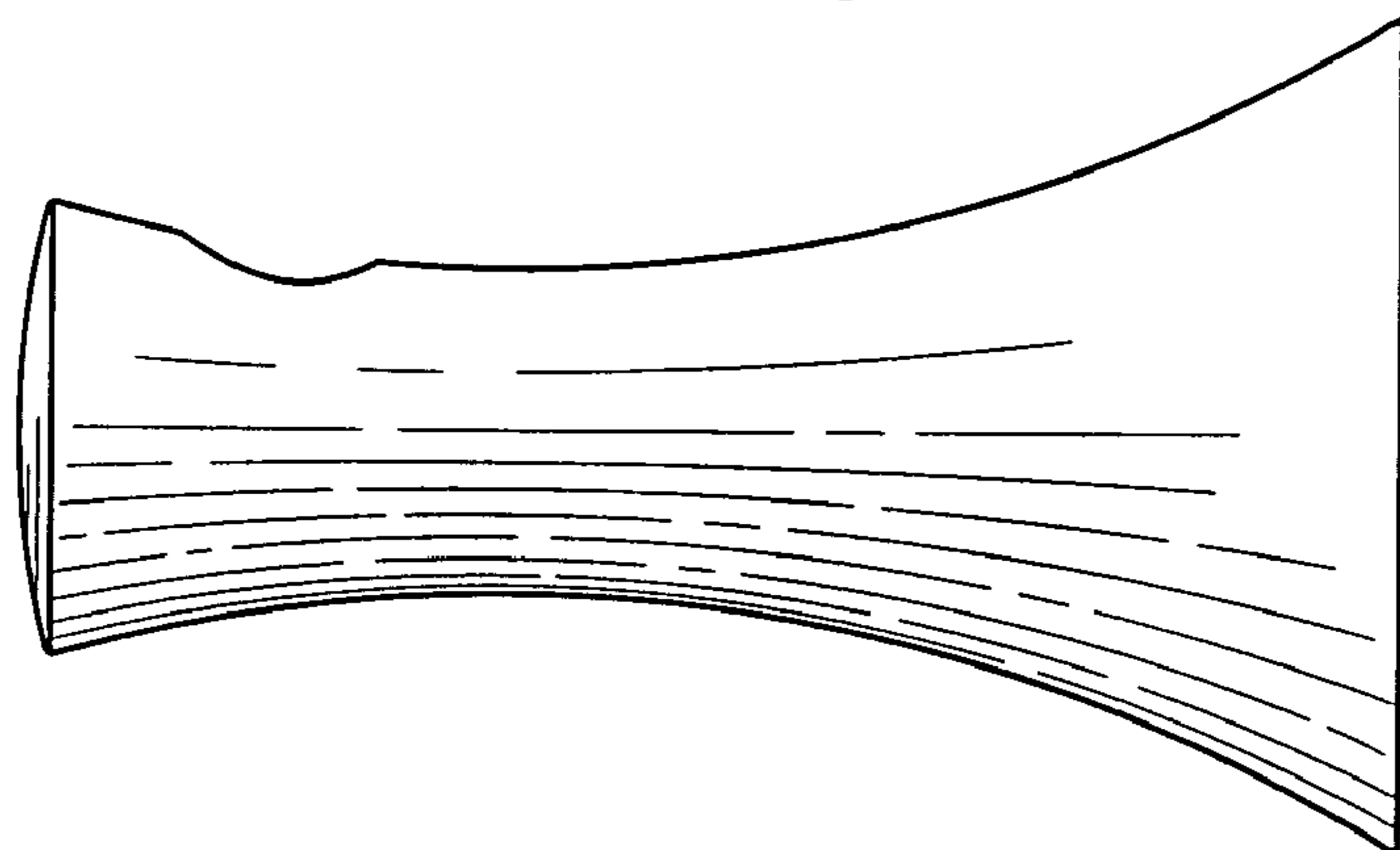
