**DESCRIPTION**

FIG. 1 is a perspective view of the dumbbell retail/storage rack according to this invention;

FIG. 2 is a rear view of the dumbbell retail/storage rack of FIG. 1;

FIG. 3 is a front view of the dumbbell retail/storage rack of FIG. 1, with a dumbbell shown in phantom (the dumbbell not being a part of the invention);

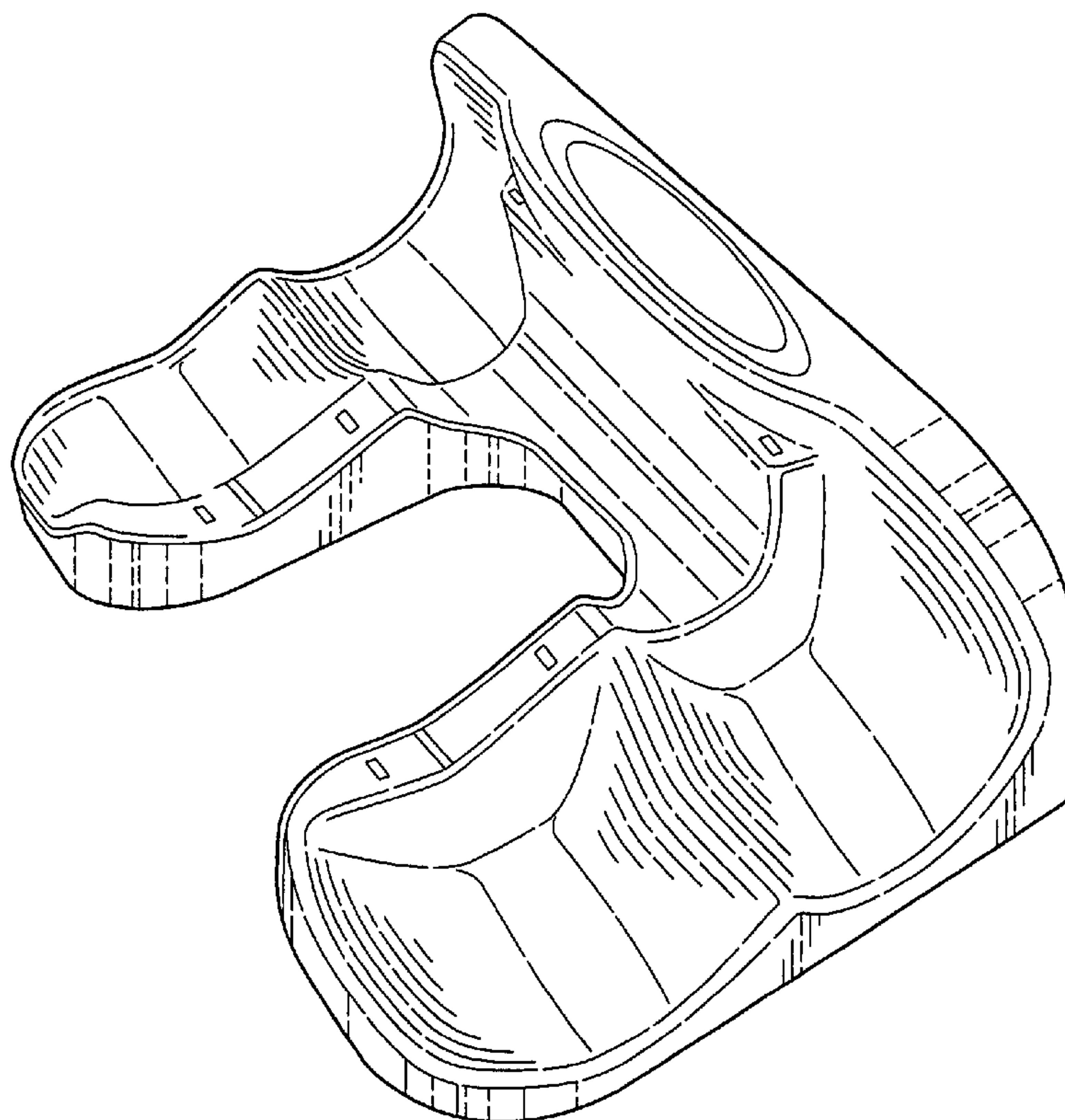
FIG. 4 is a left side view of the dumbbell retail/storage rack of FIG. 1, with two dumbbells shown in phantom (the dumbbells not being a part of the invention);

FIG. 5 is a right side view of the dumbbell retail/storage rack of FIG. 1, with two dumbbells shown in phantom (the dumbbells not being a part of the invention);

FIG. 6 is a top view of the dumbbell retail/storage rack of FIG. 1, with two dumbbells shown in phantom (the dumbbells not being a part of the invention); and,

FIG. 7 is a bottom view of the dumbbell retail/storage rack of FIG. 1, with two dumbbells shown in phantom (the dumbbells not being a part of the invention).

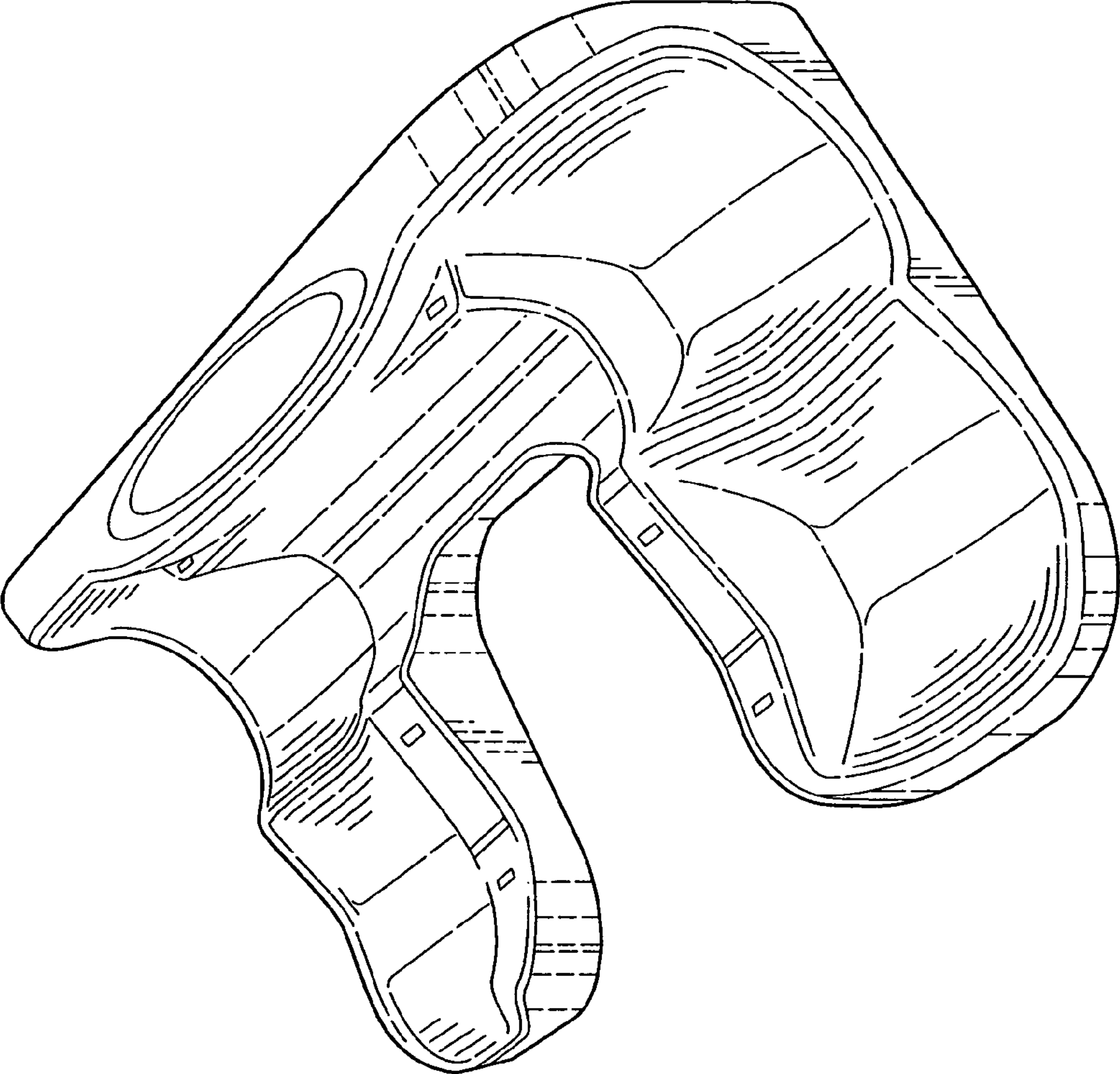

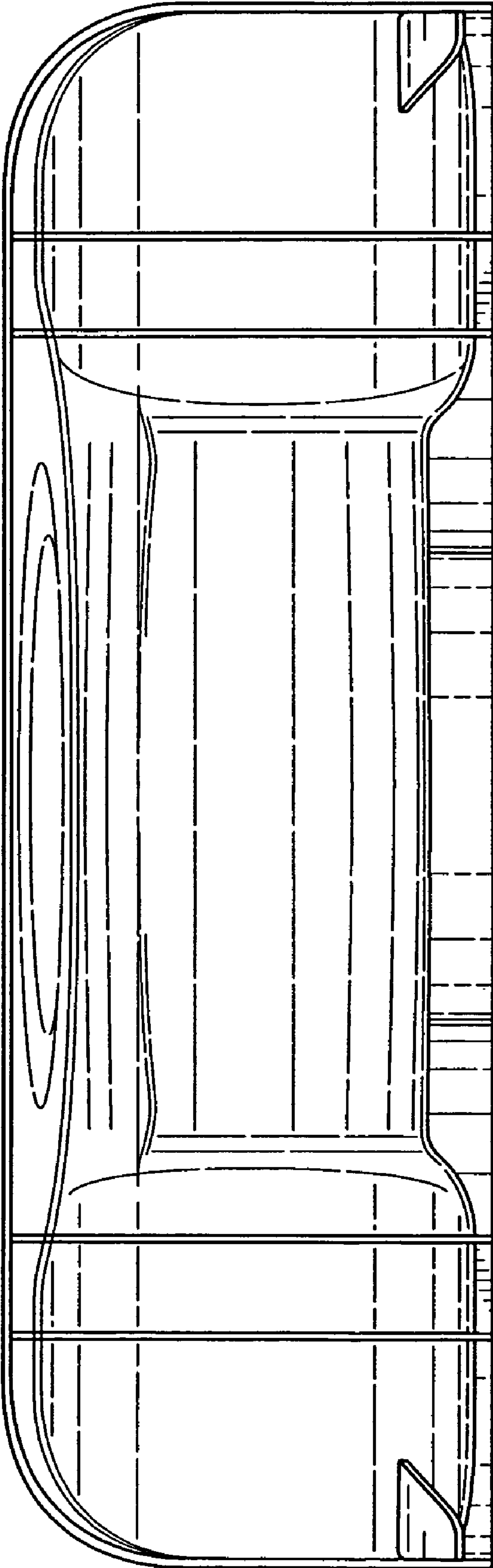

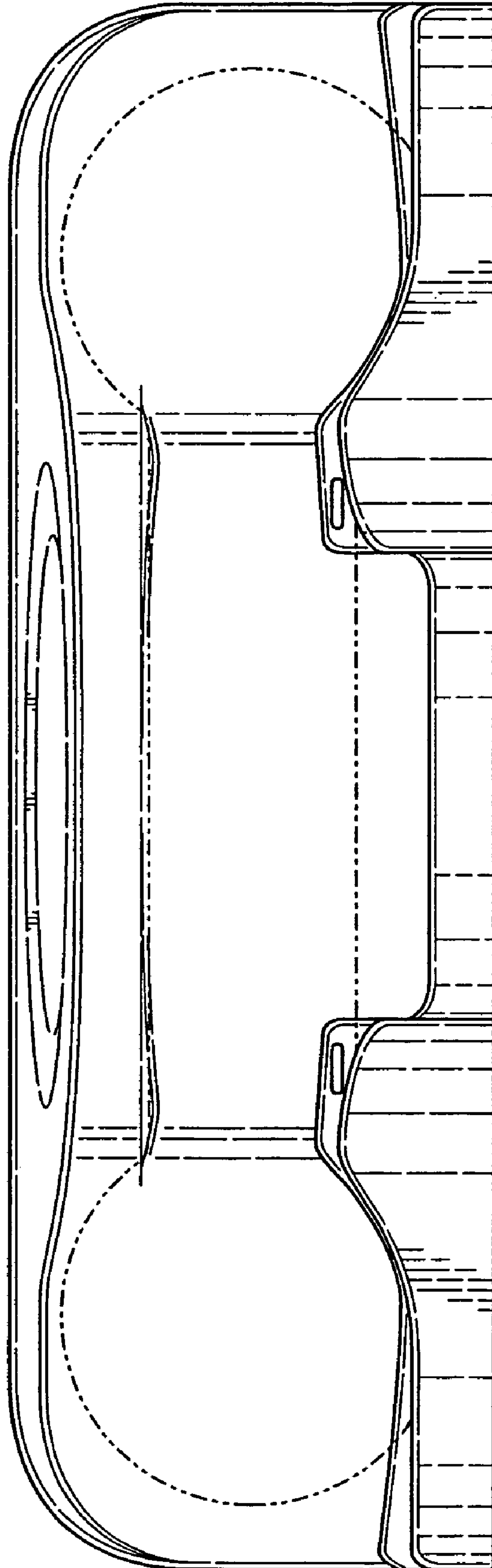

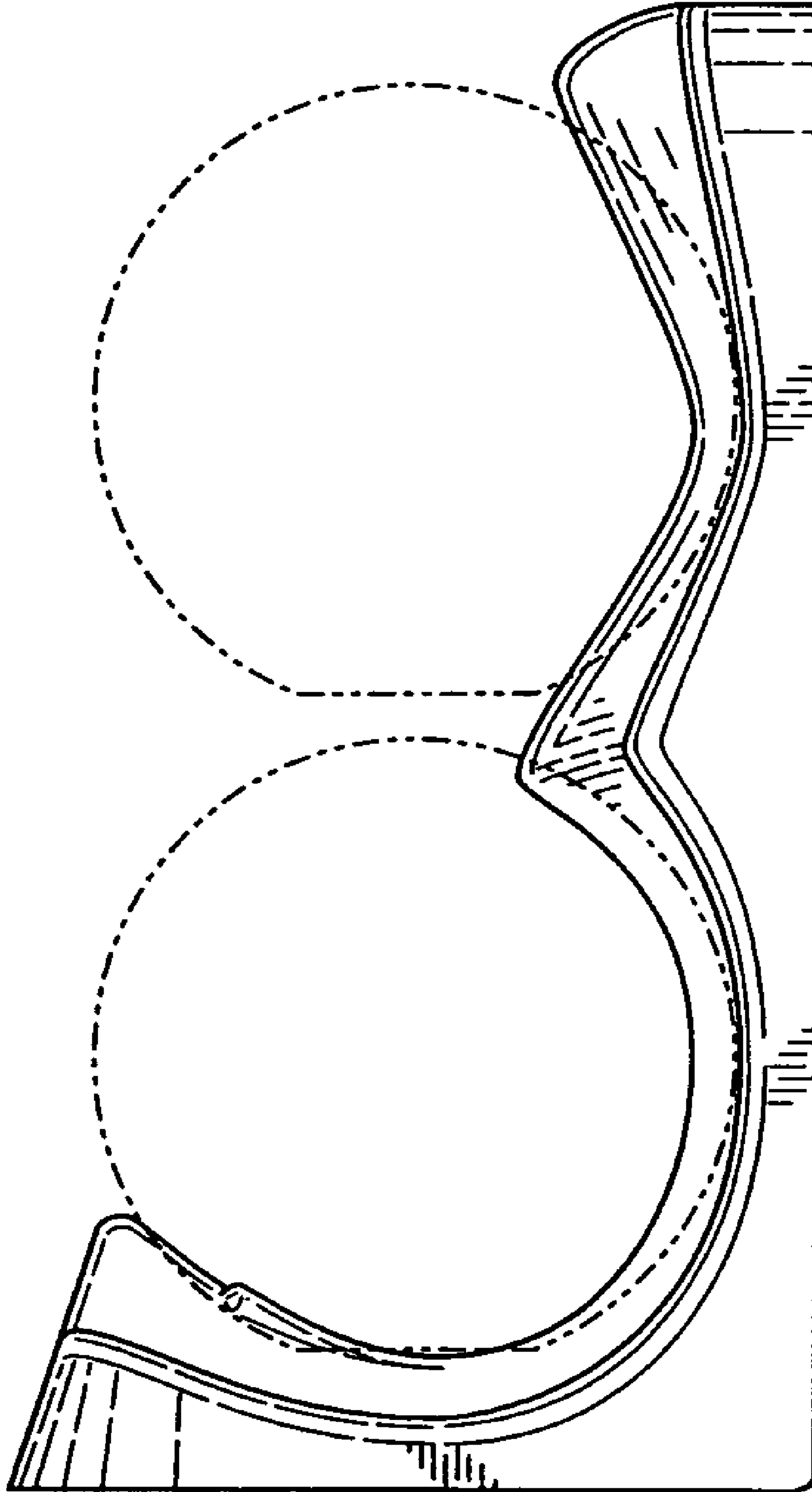

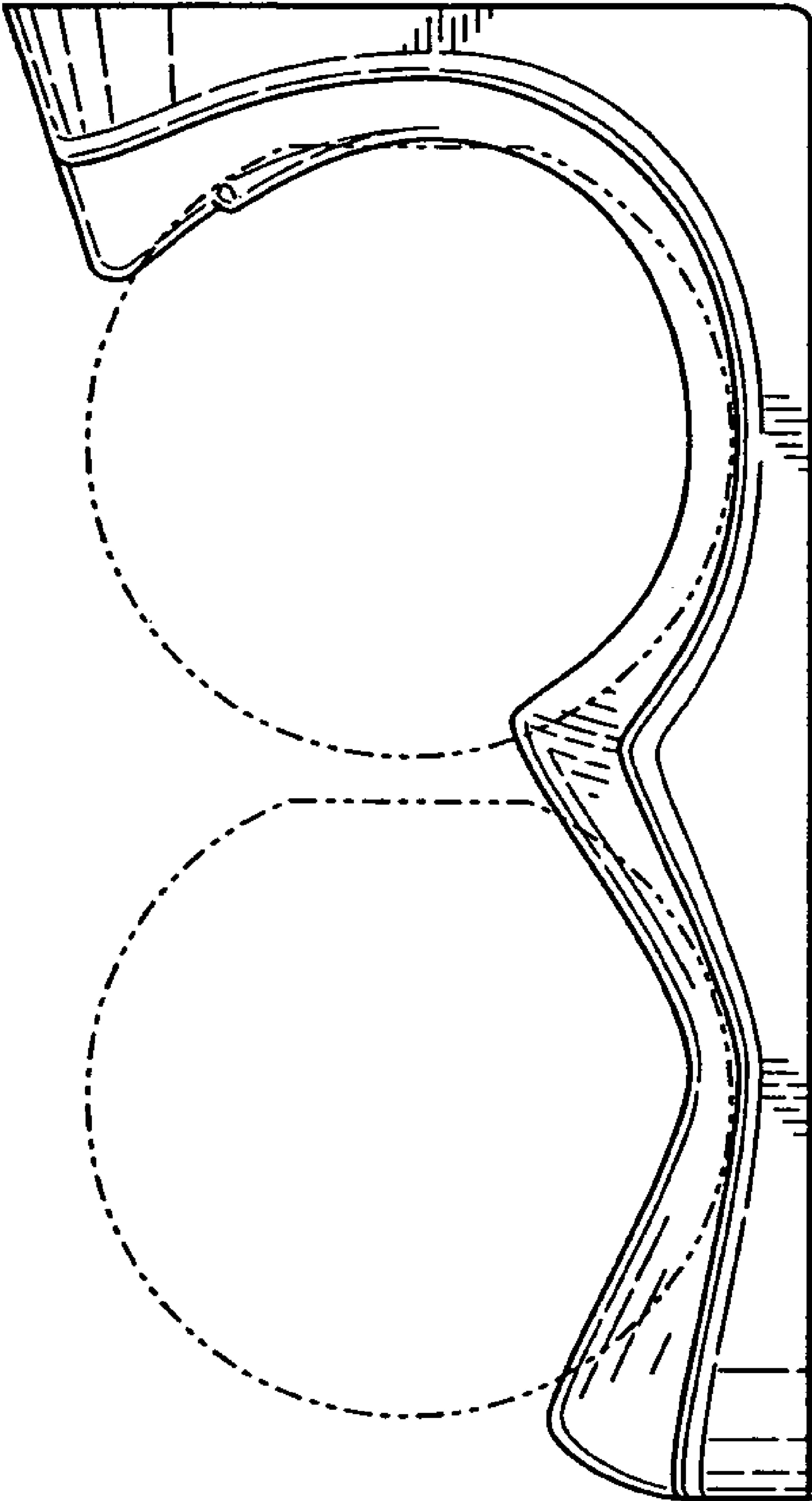

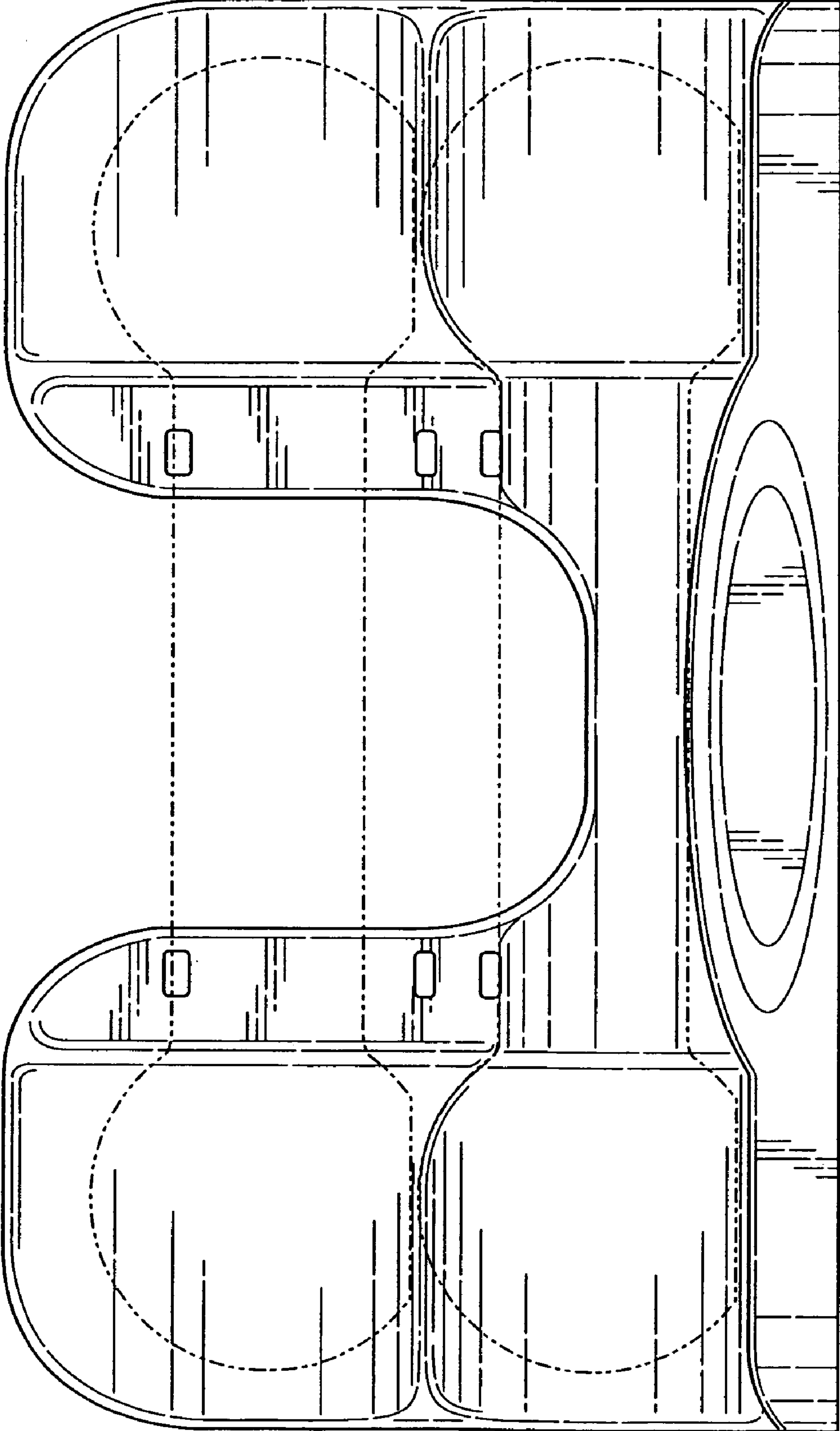

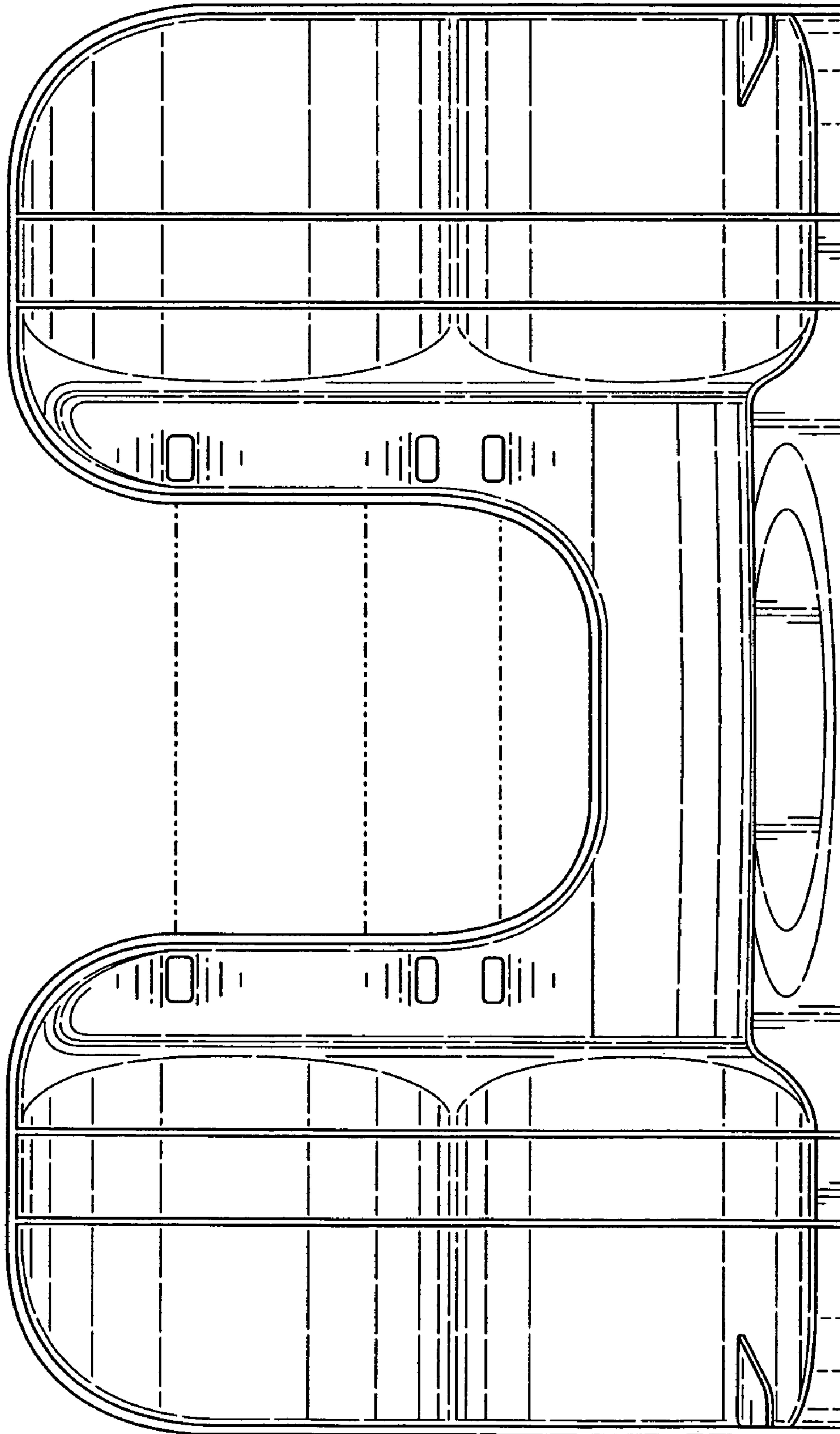
