FIG. 8 is a right side elevational view thereof.

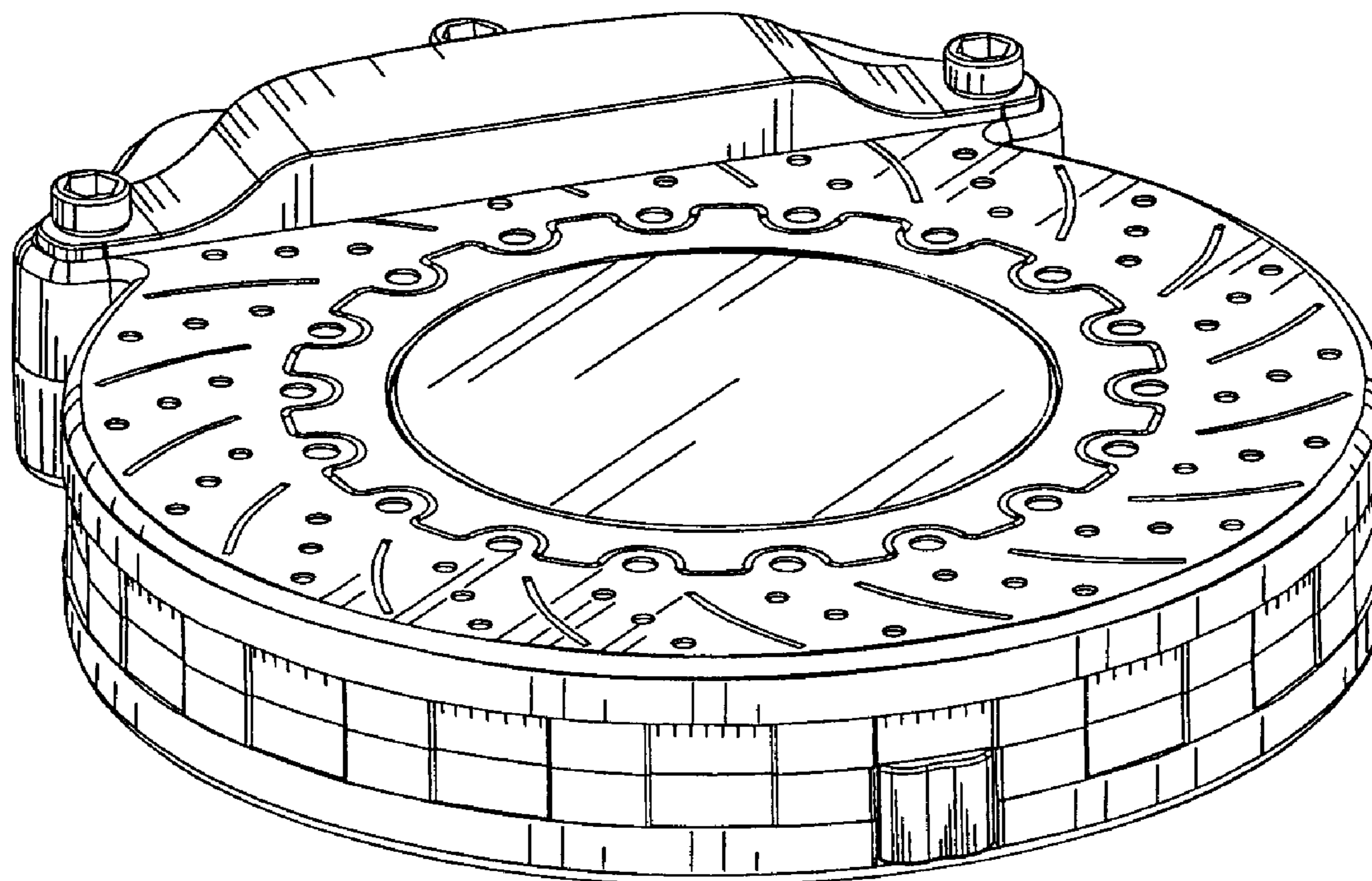

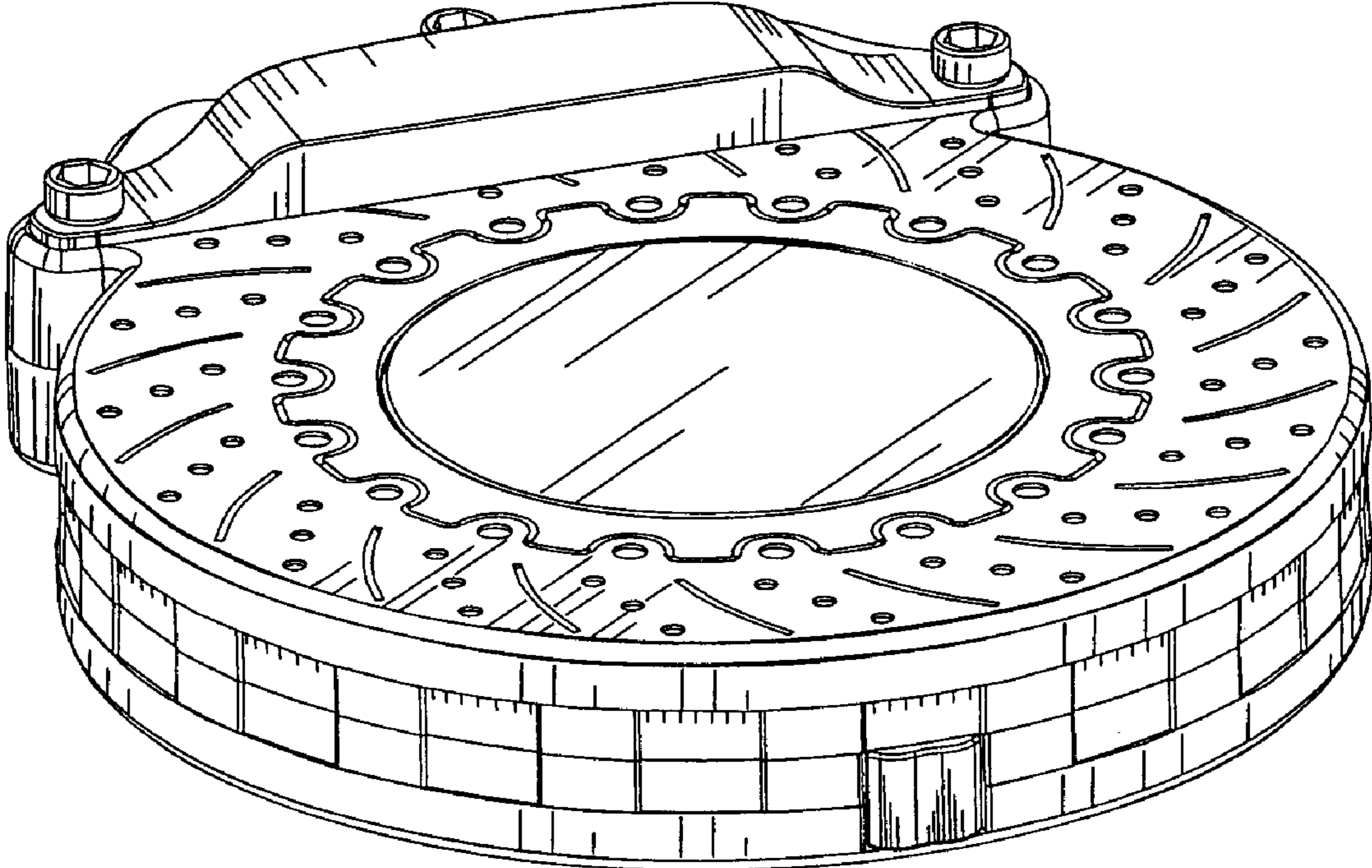

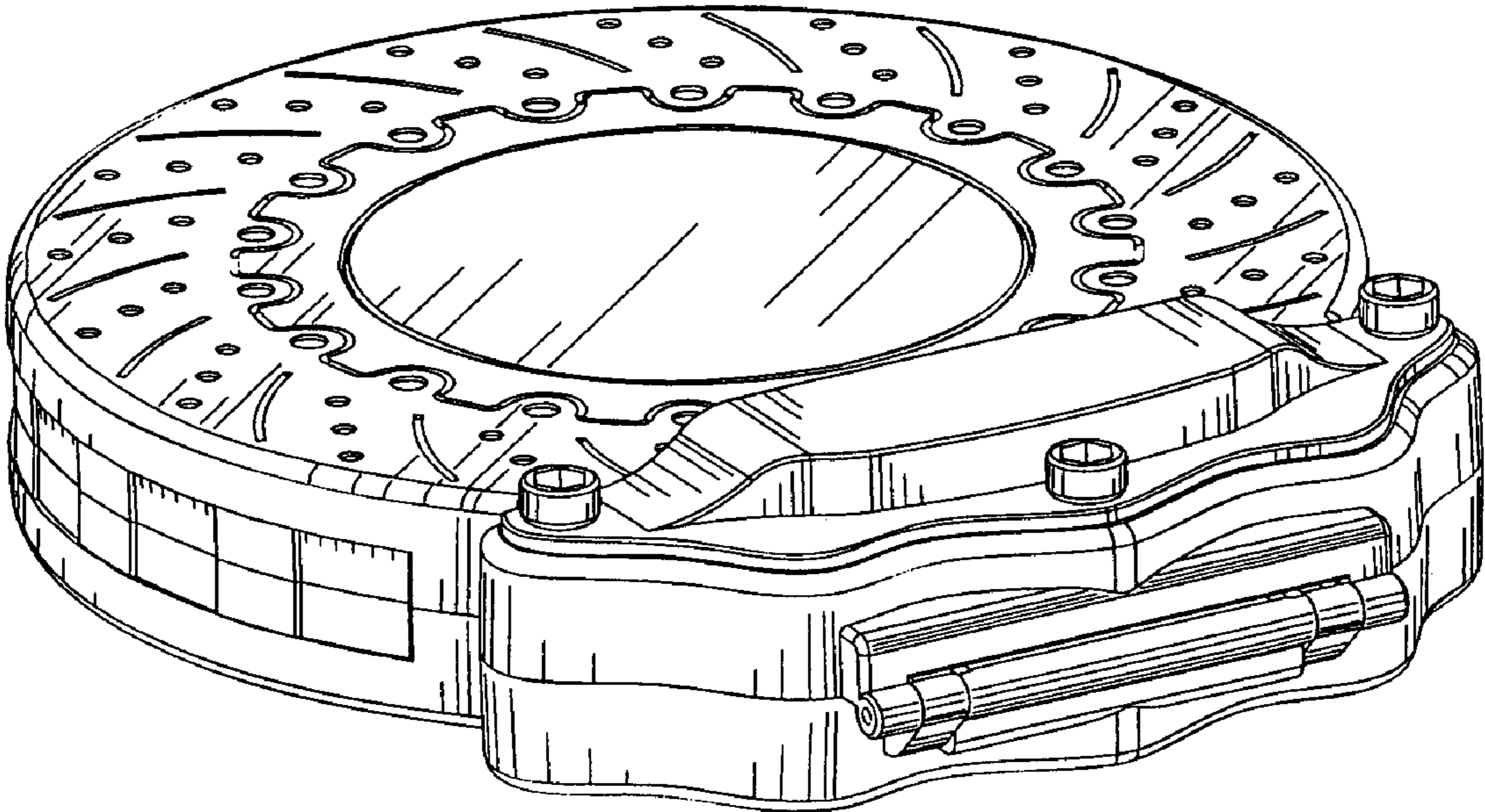

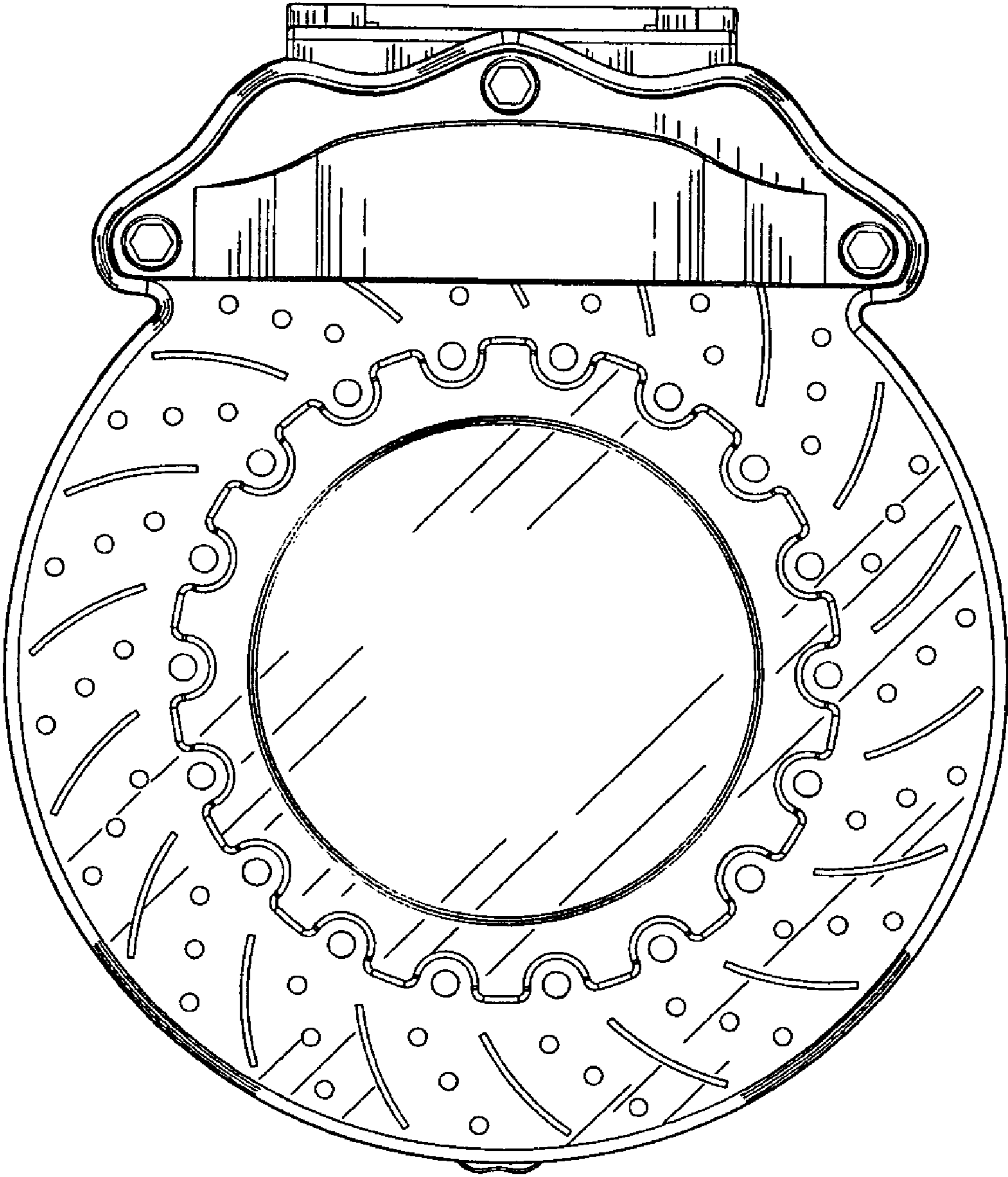

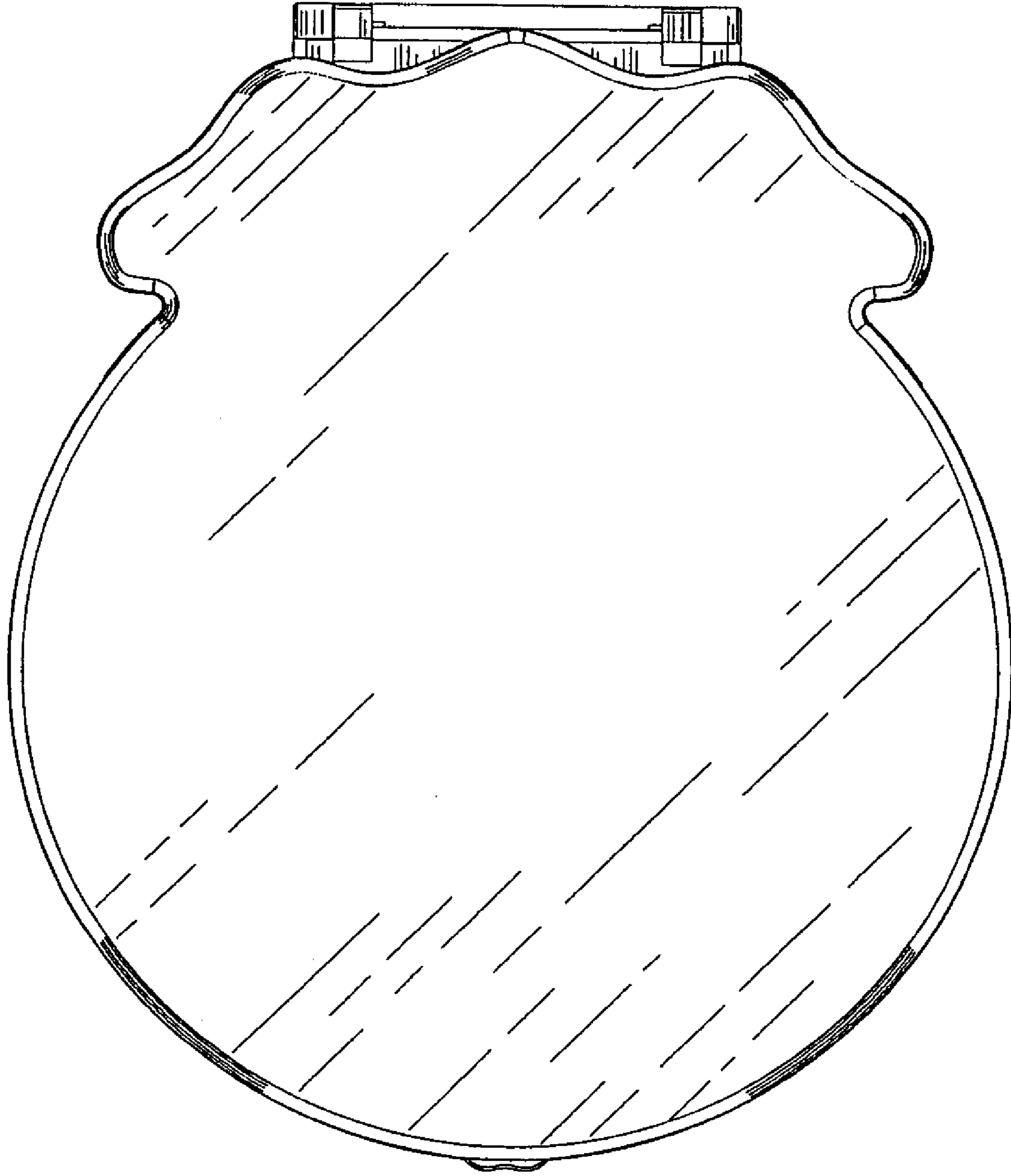

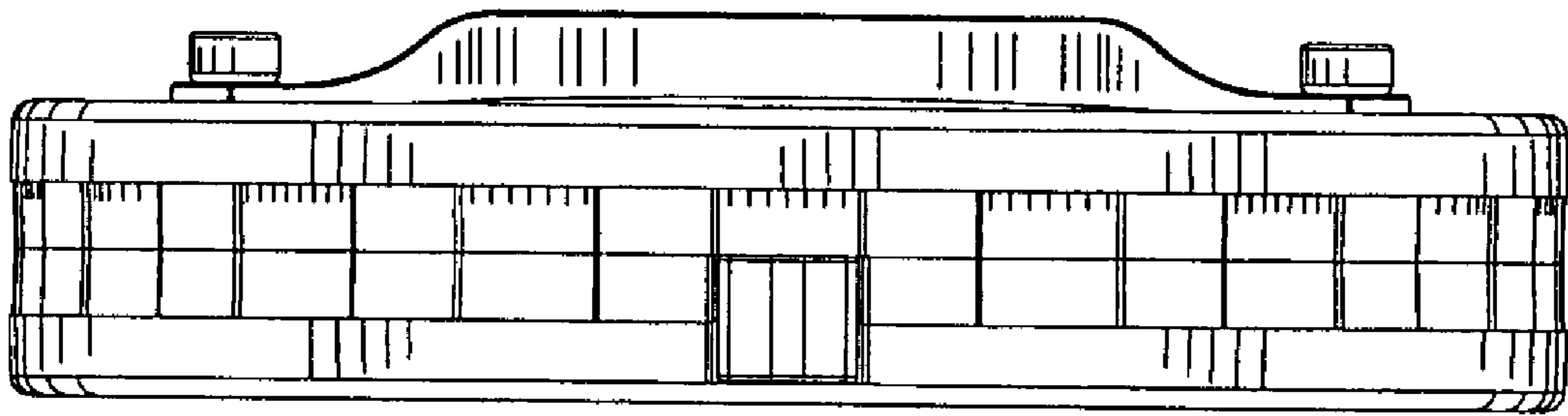

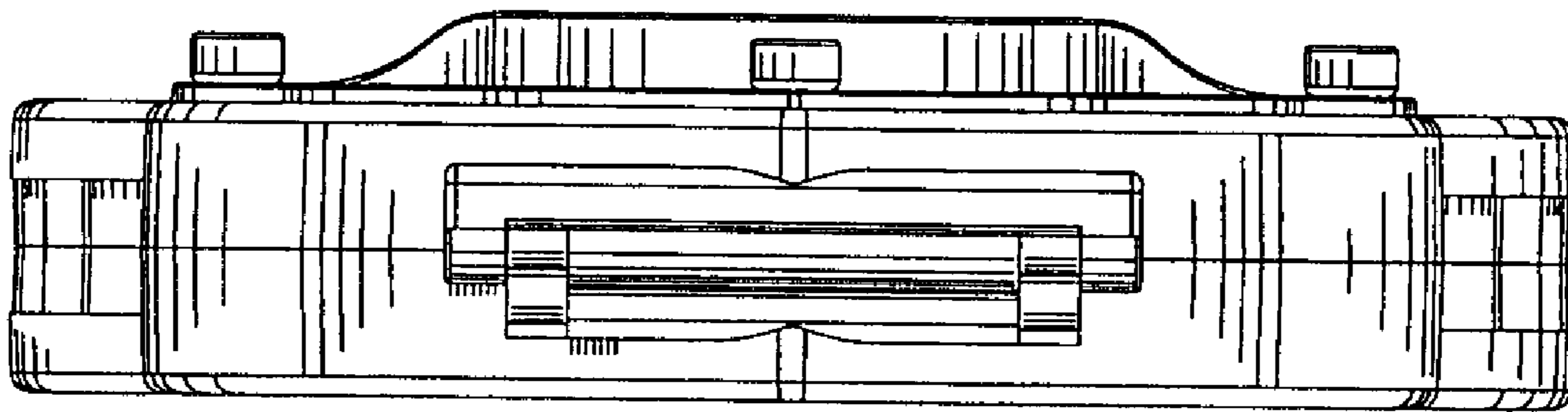

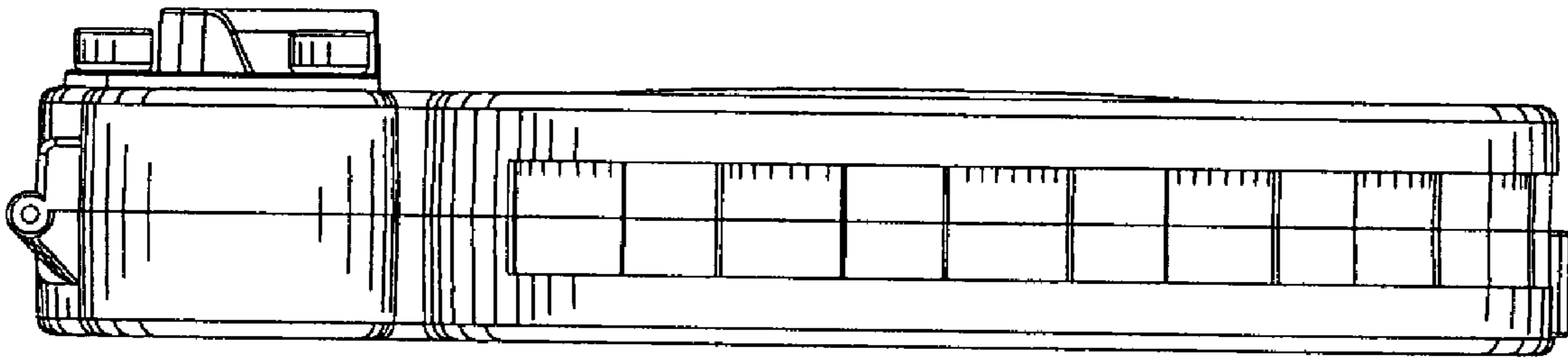

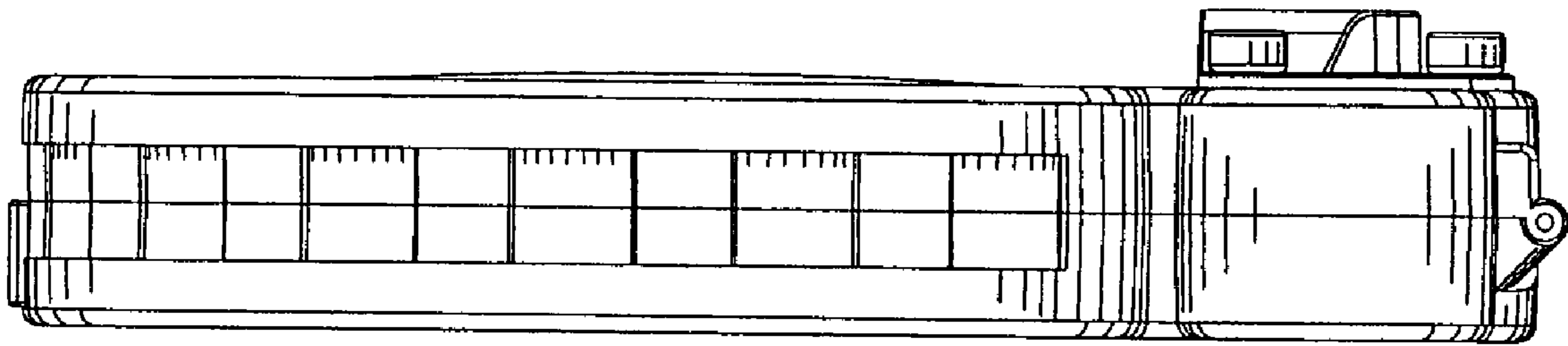
