FIG. 4 is a bottom view of the design first embodiment shown in FIG. 1;

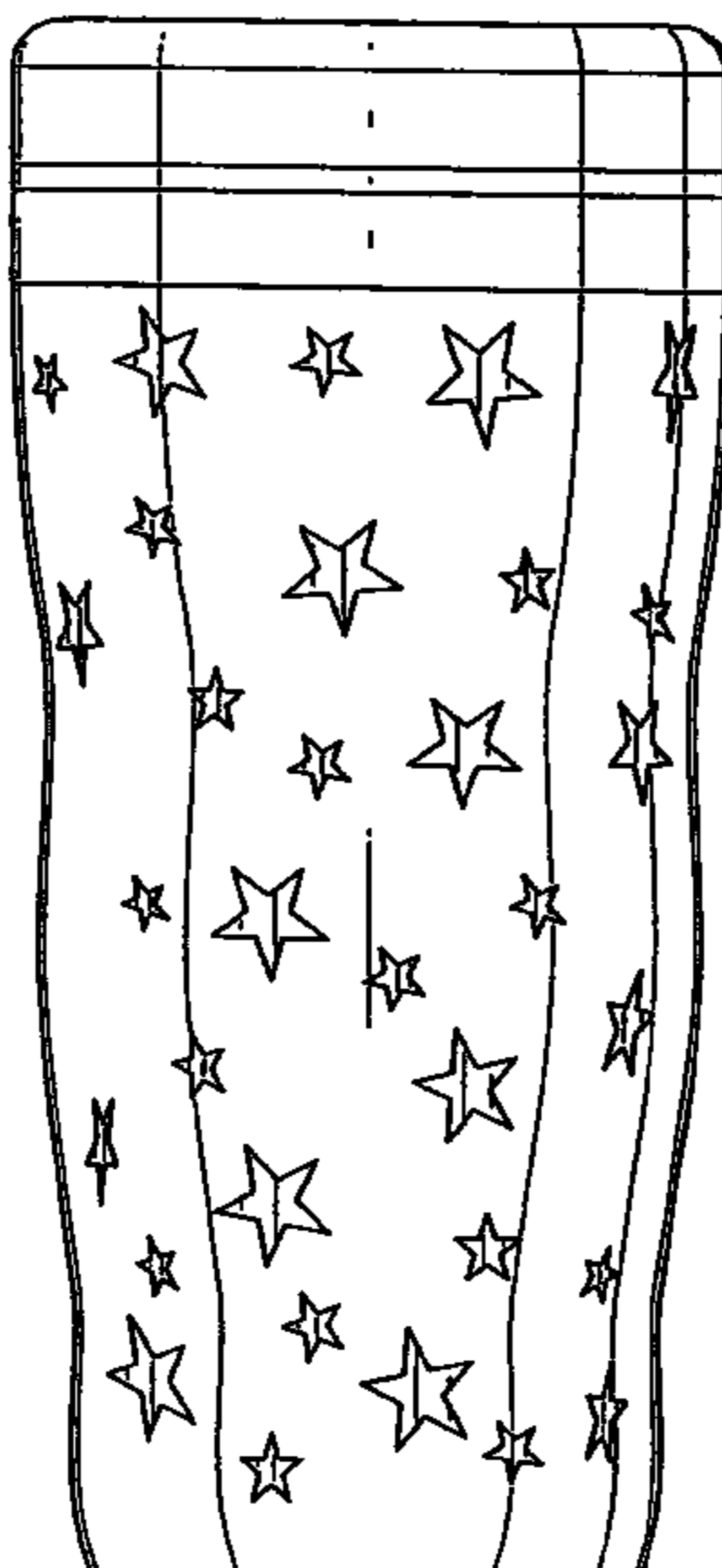
FIG. 5 is a perspective view of the second embodiment of the travel mug with star apertures; and,

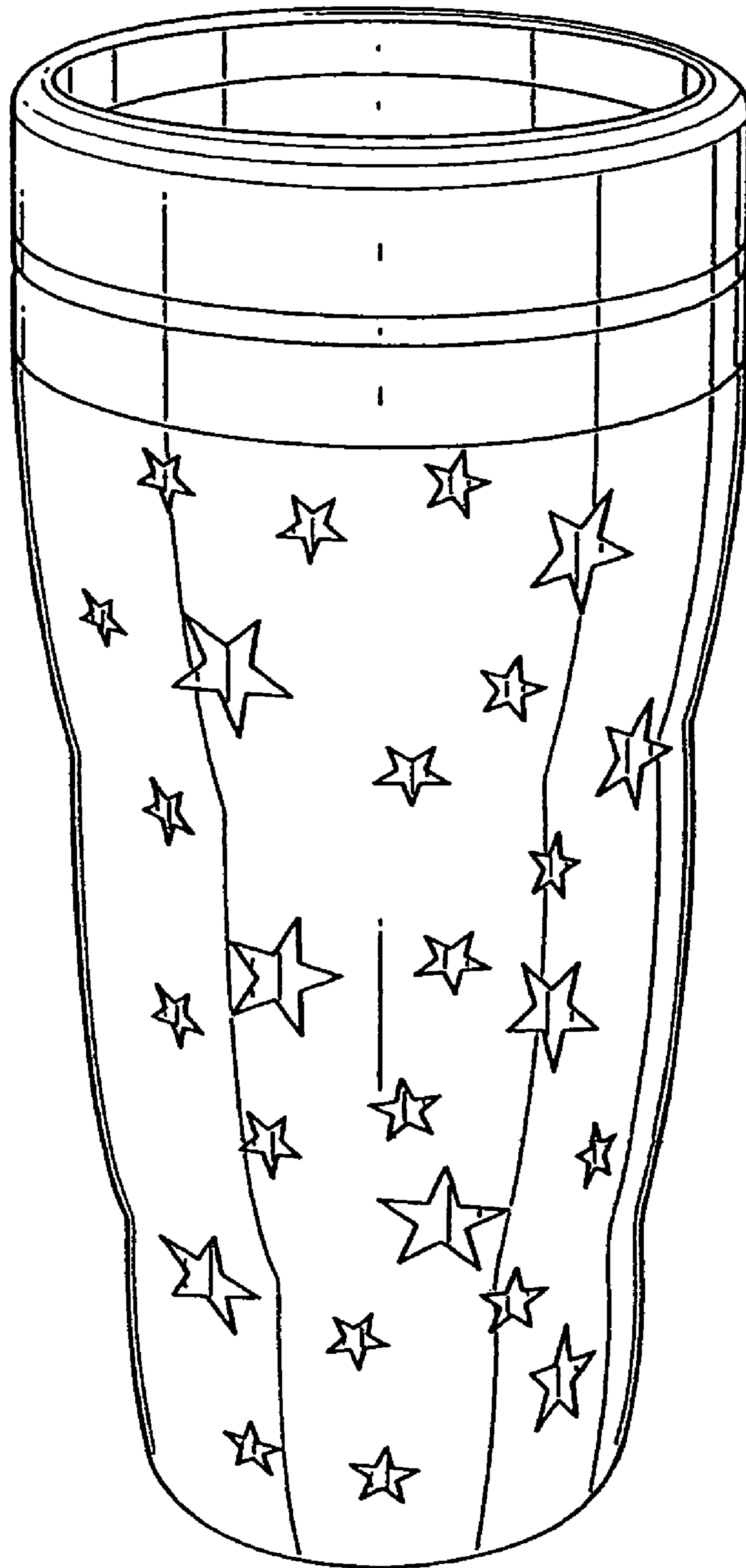

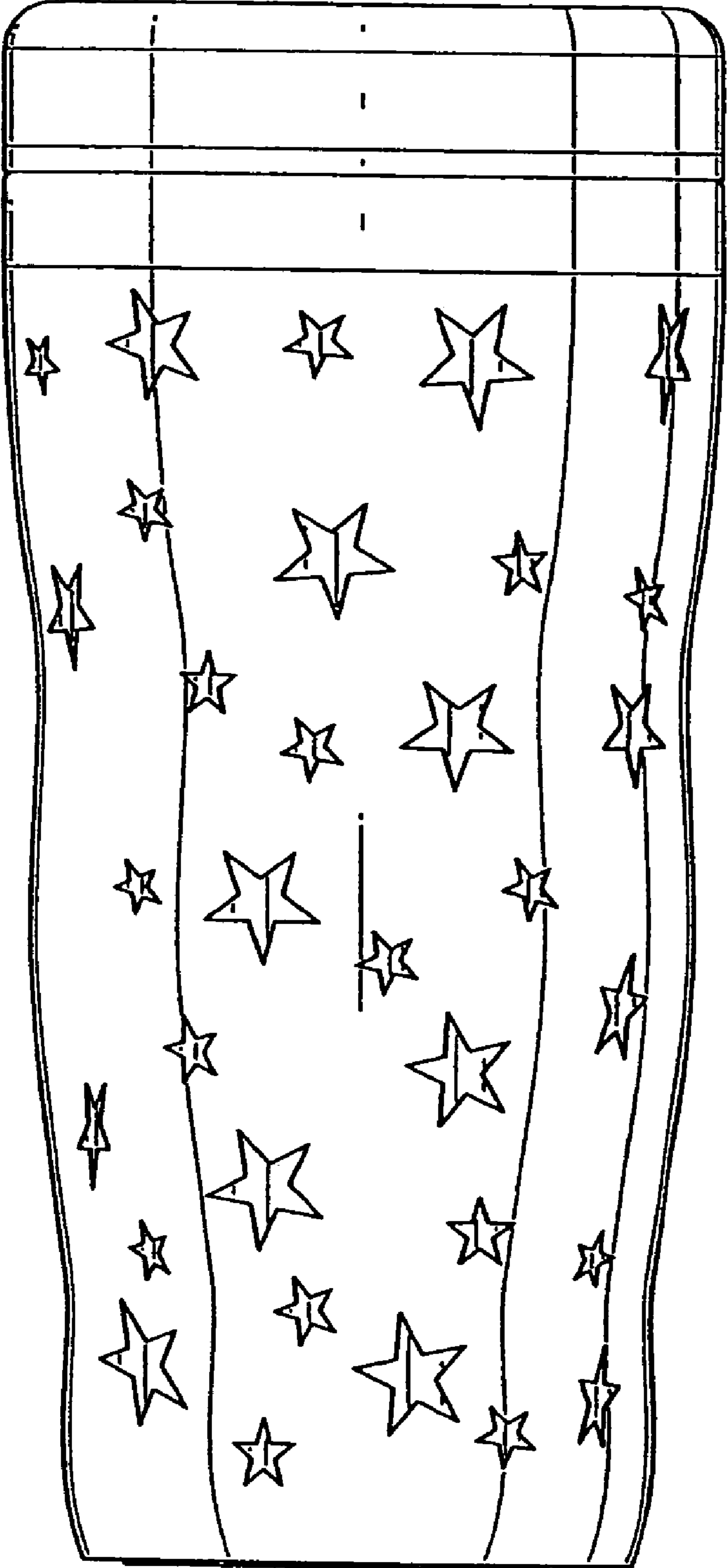

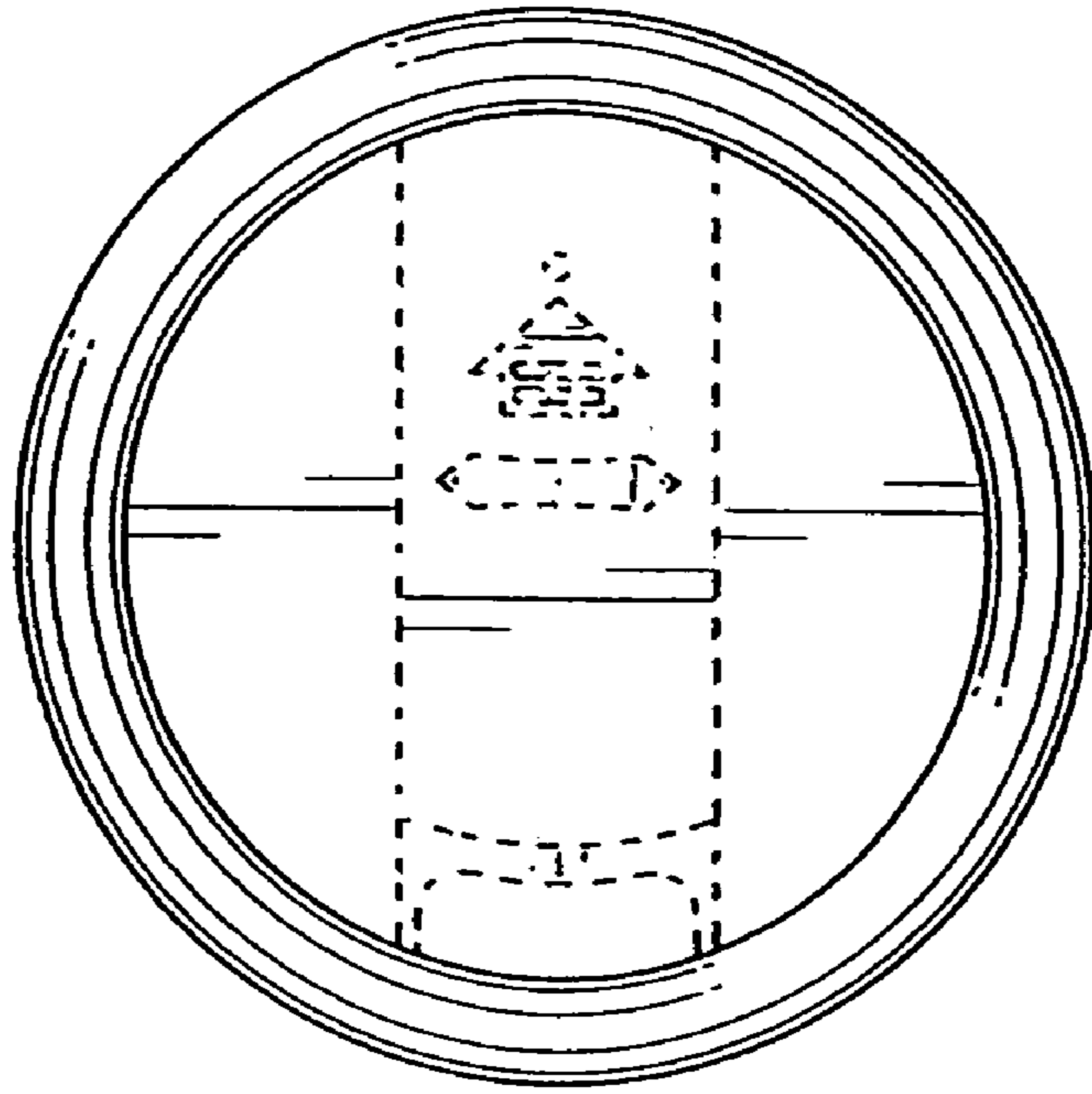

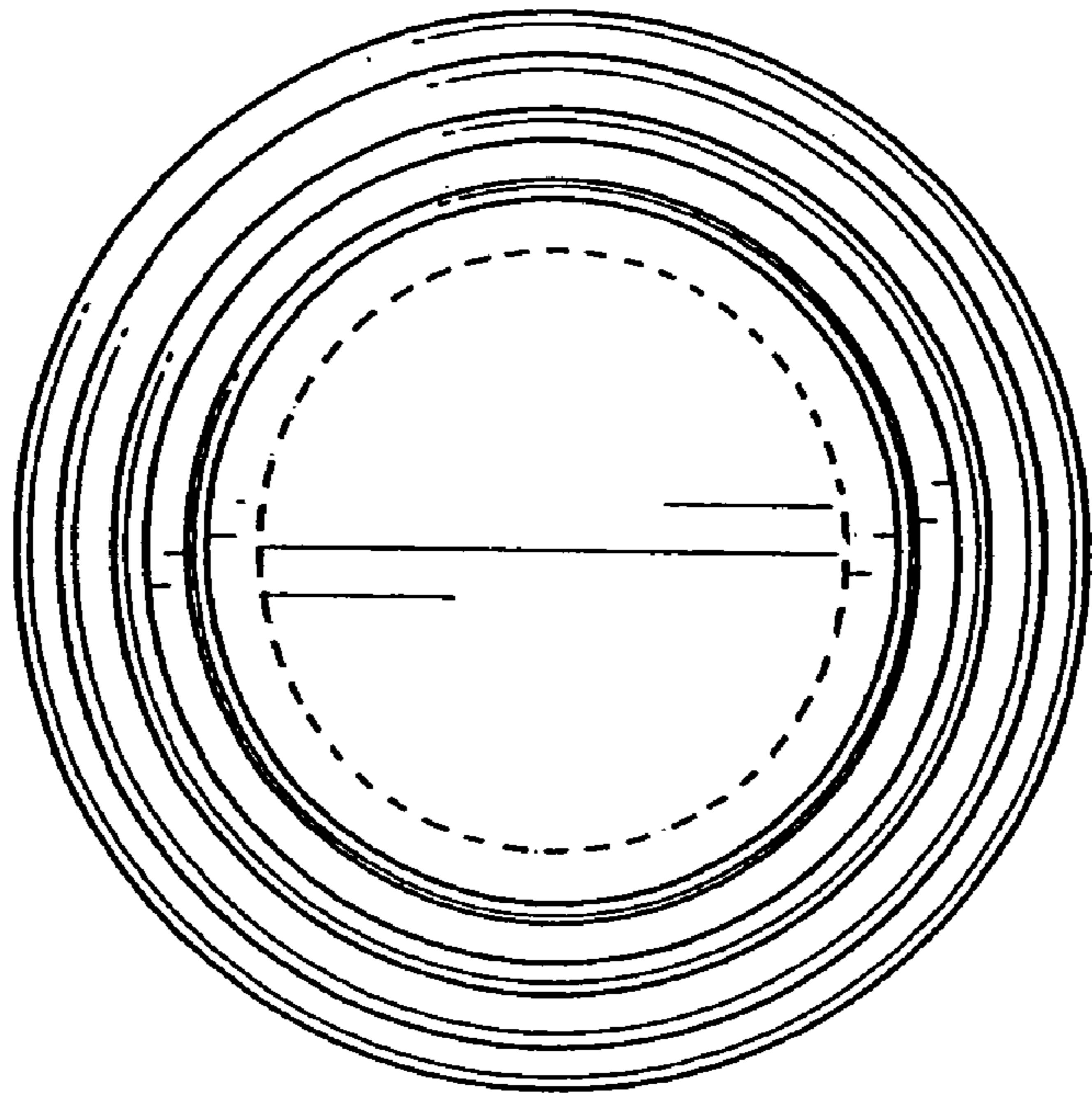

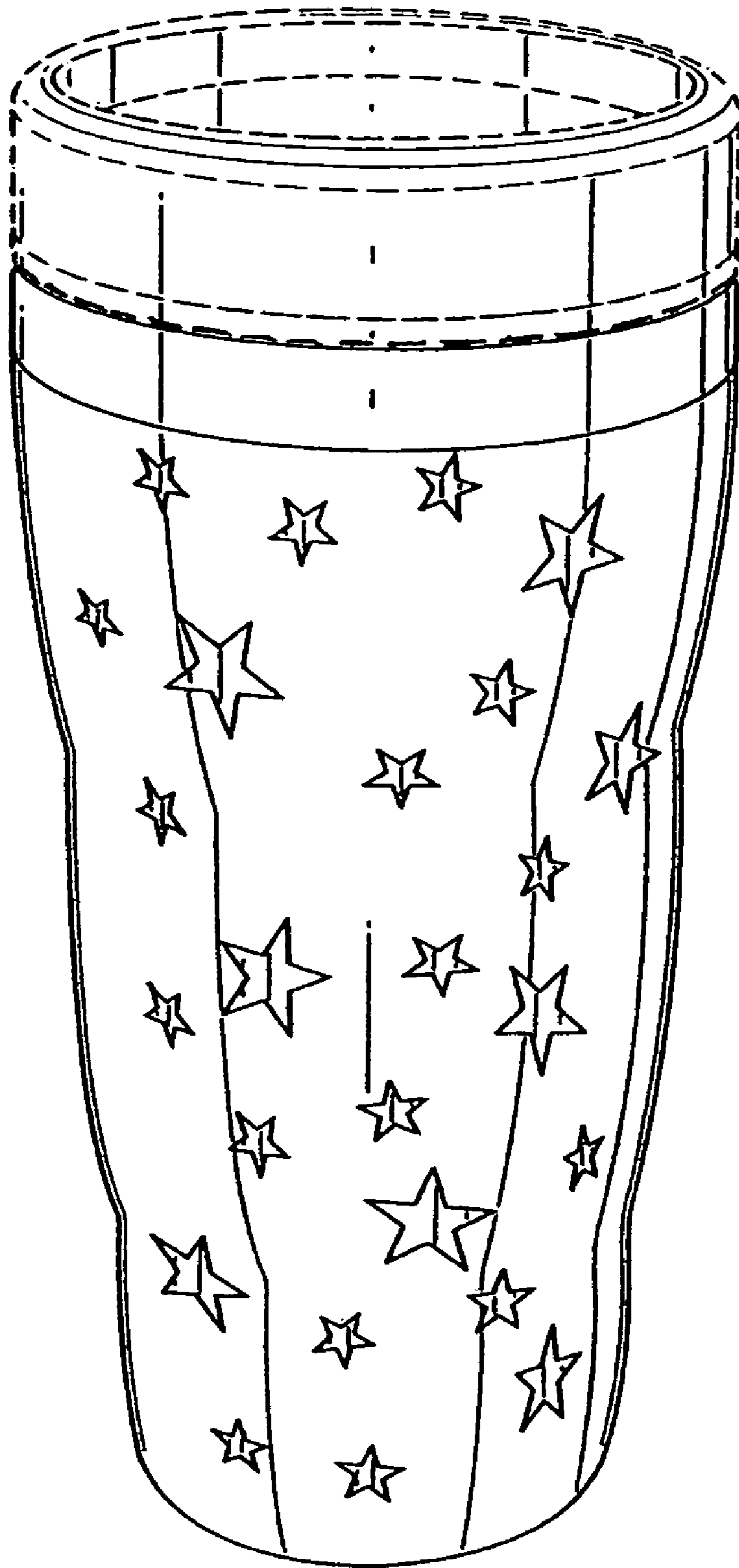

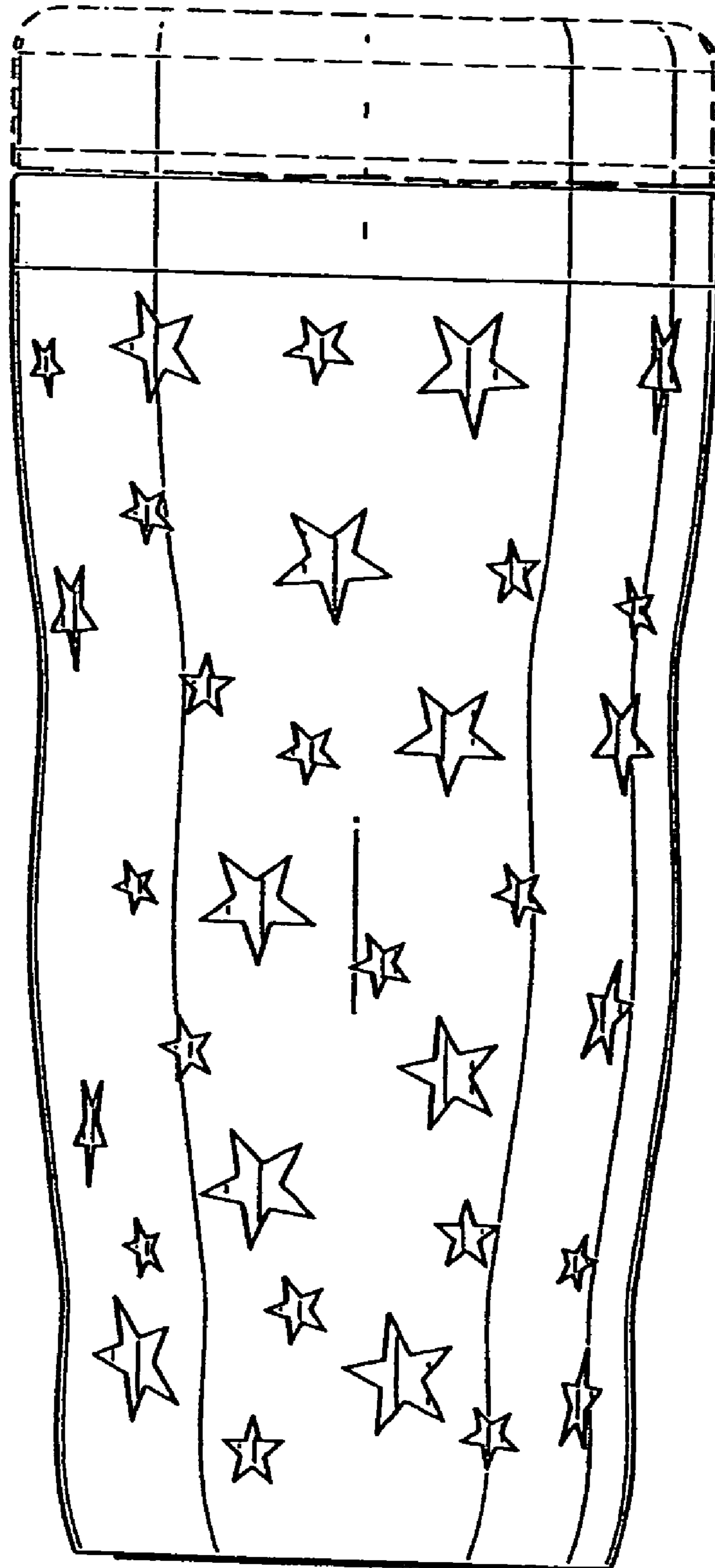
