FIG. 2 is a back view of the invention;

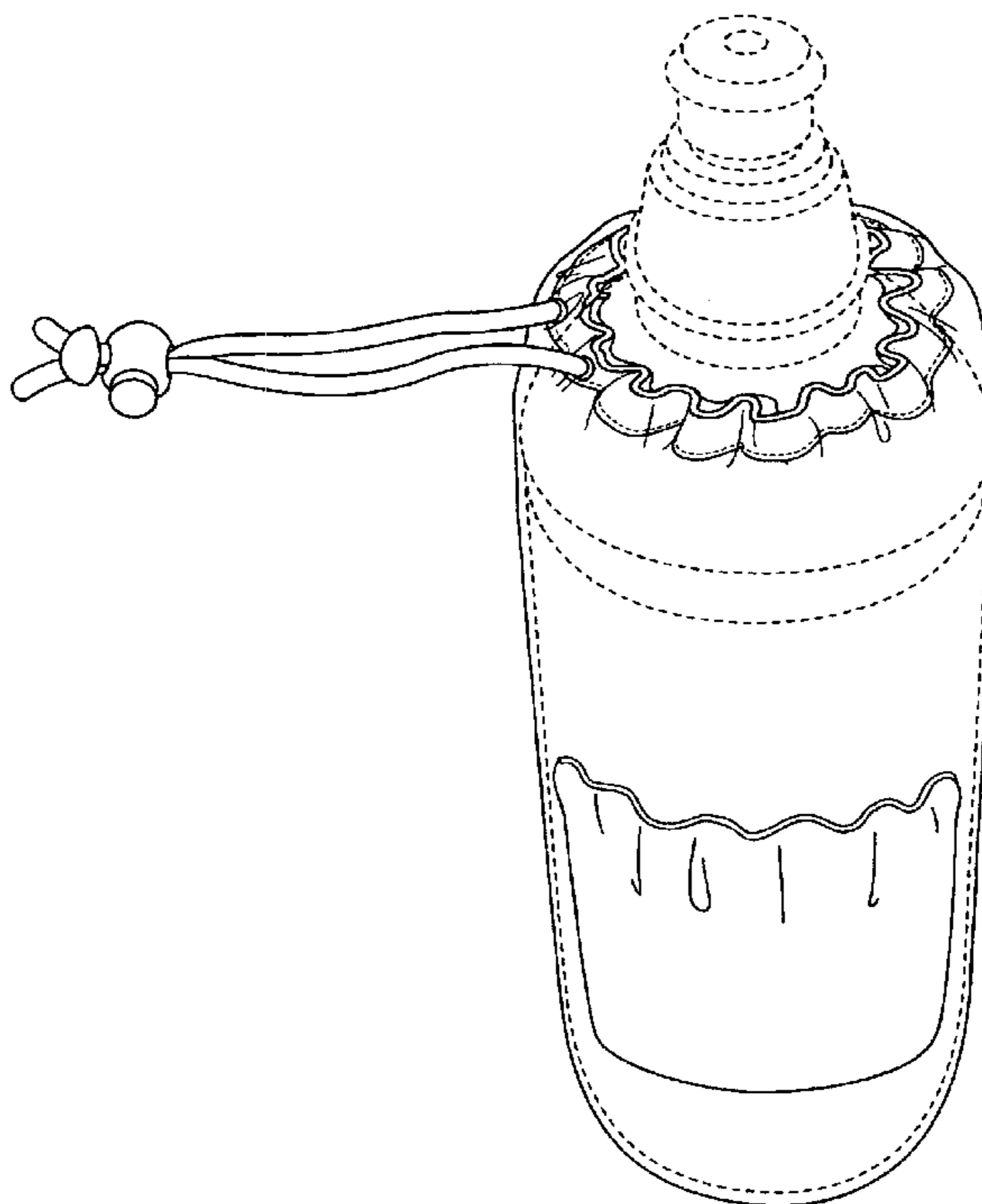
FIG. 3 is a front view of the invention;

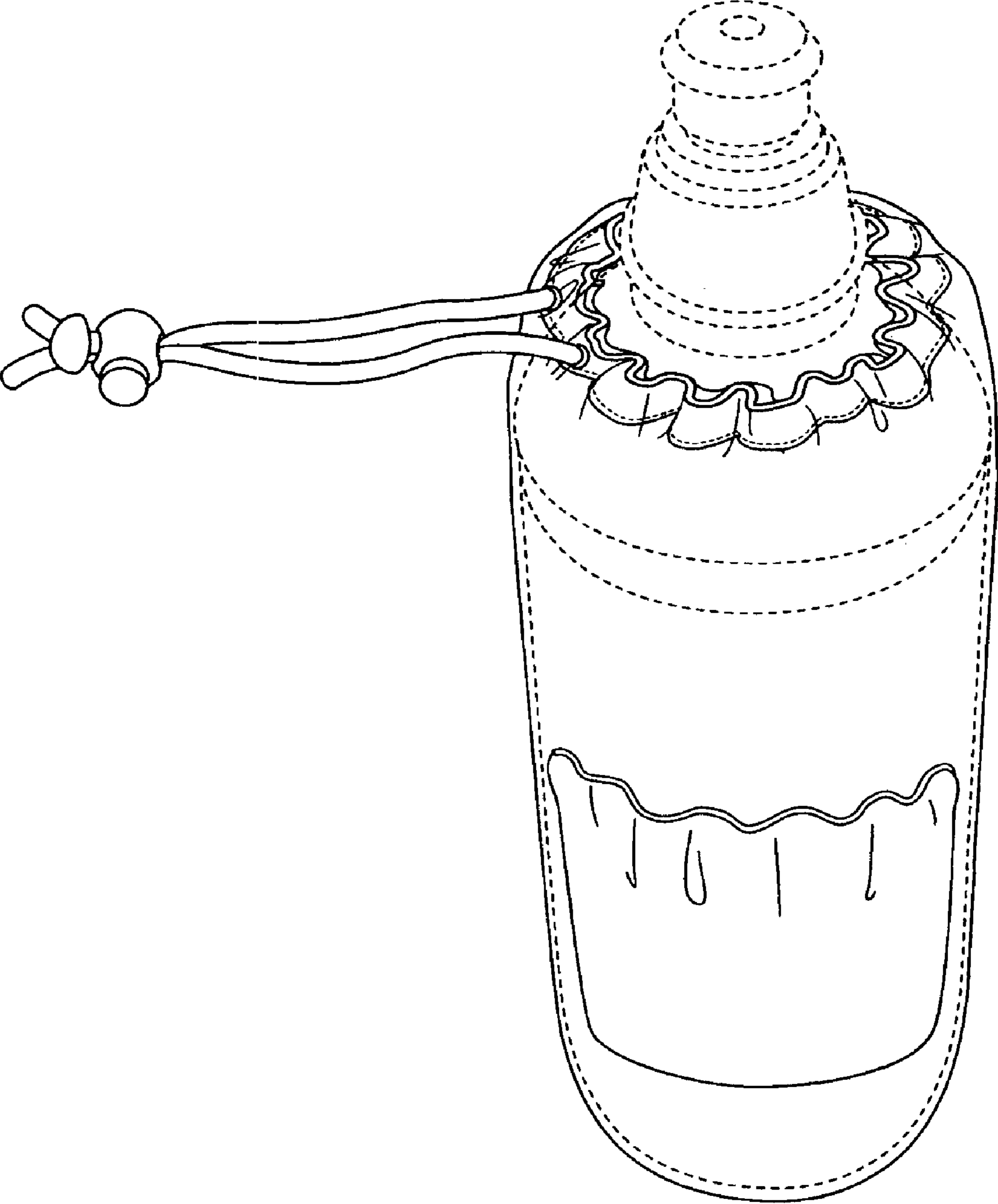

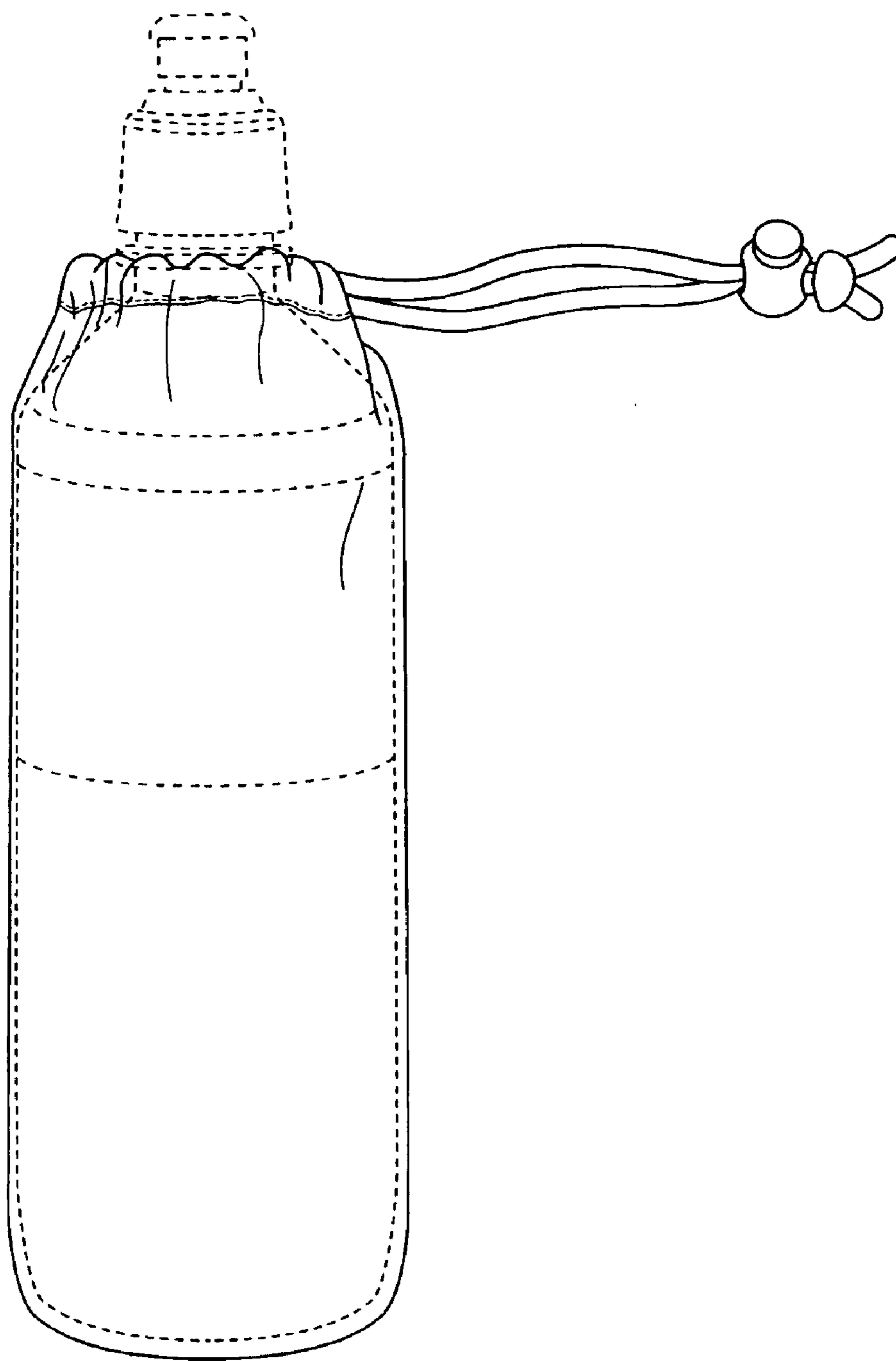

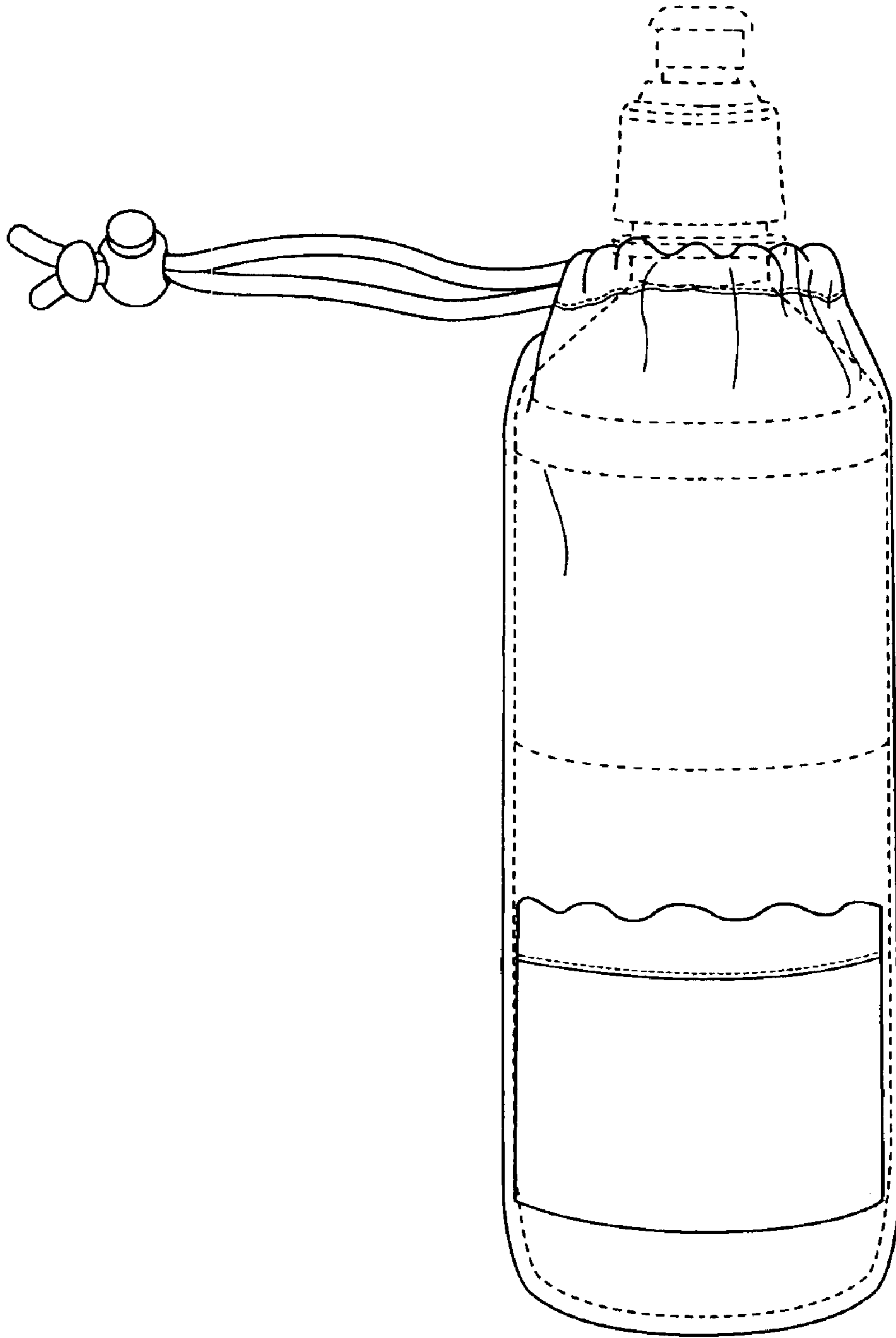

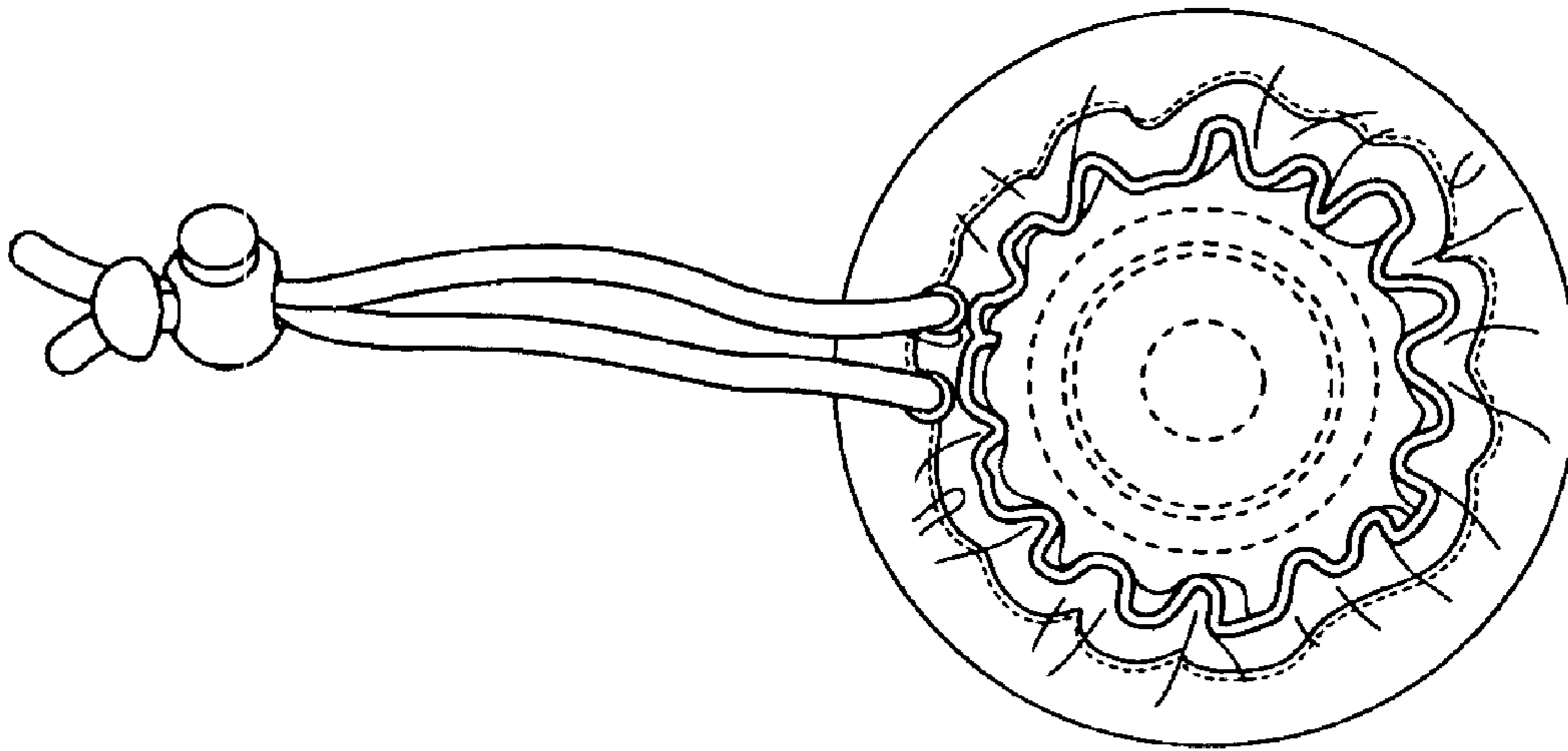

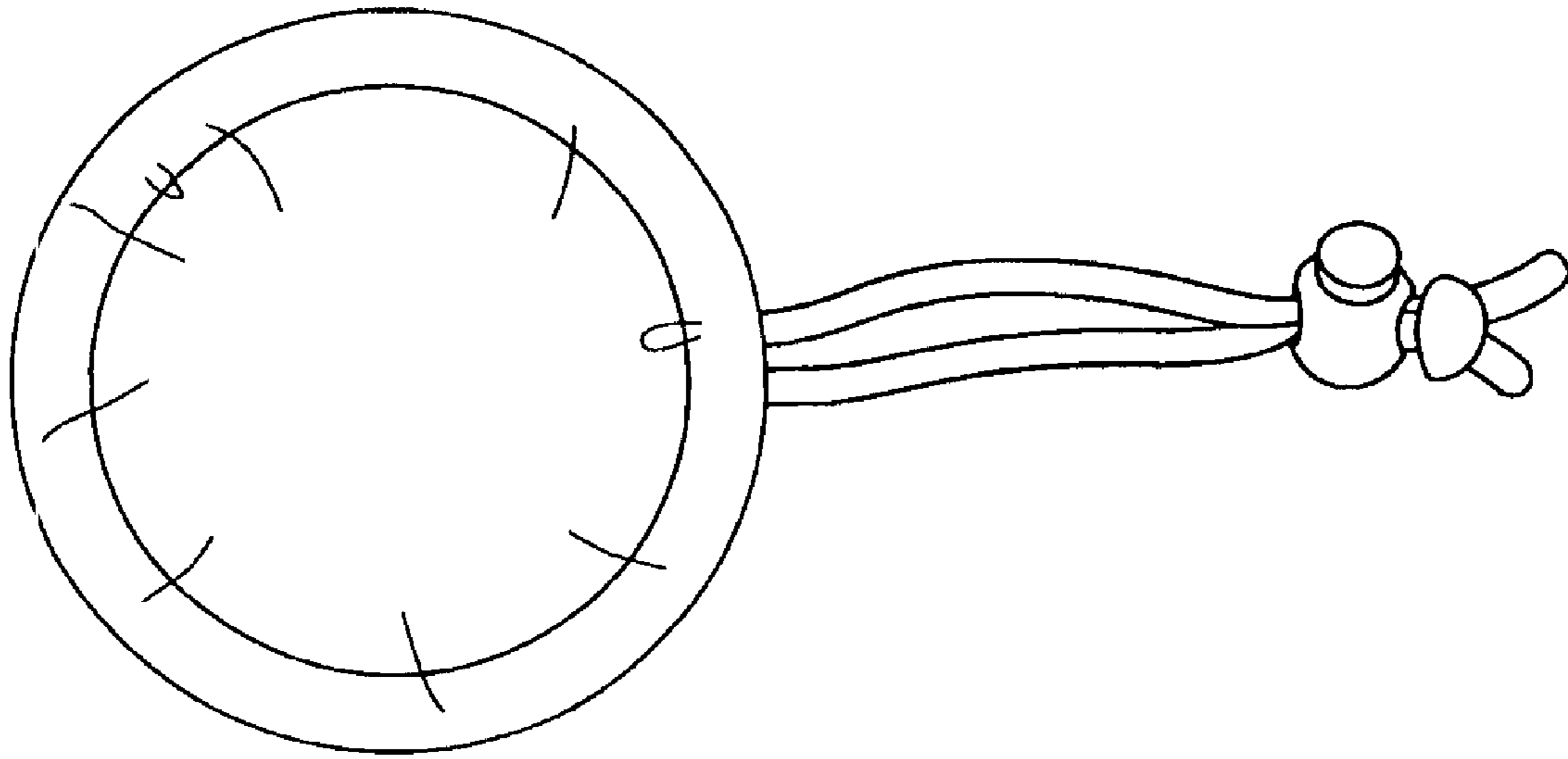
