**DESCRIPTION**

FIG. 1 is a top perspective view of a container embodying the new design;

FIG. 4 is a left side elevational view, the right side being a mirror image thereof;

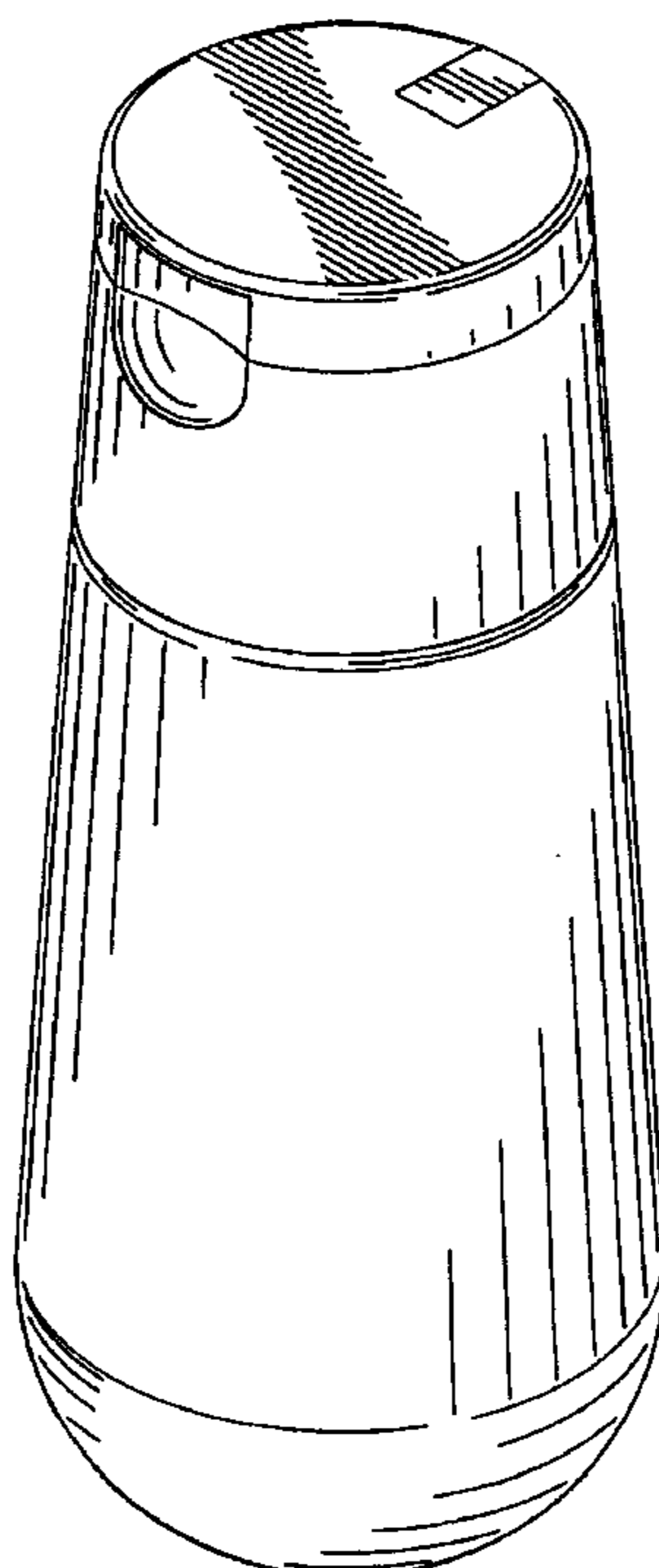
FIG. 5 is a rear elevational view thereof;

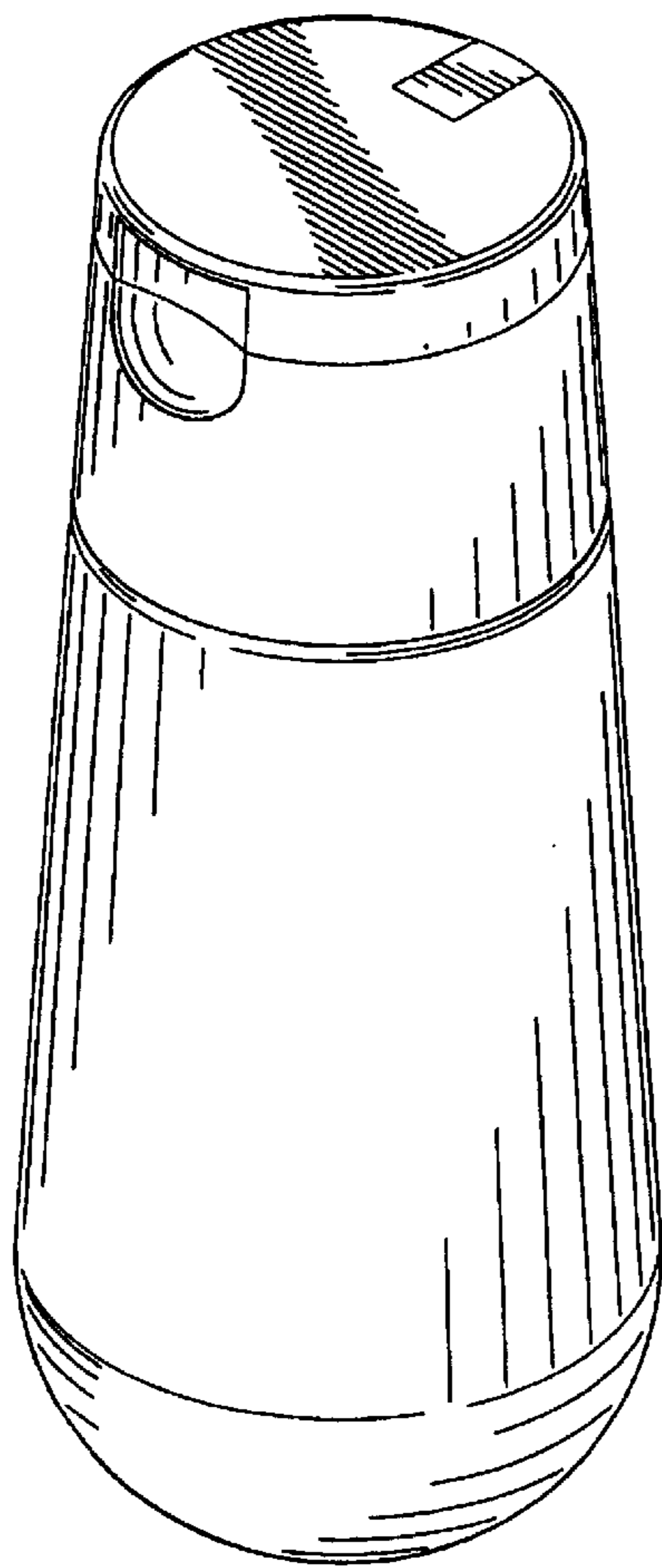

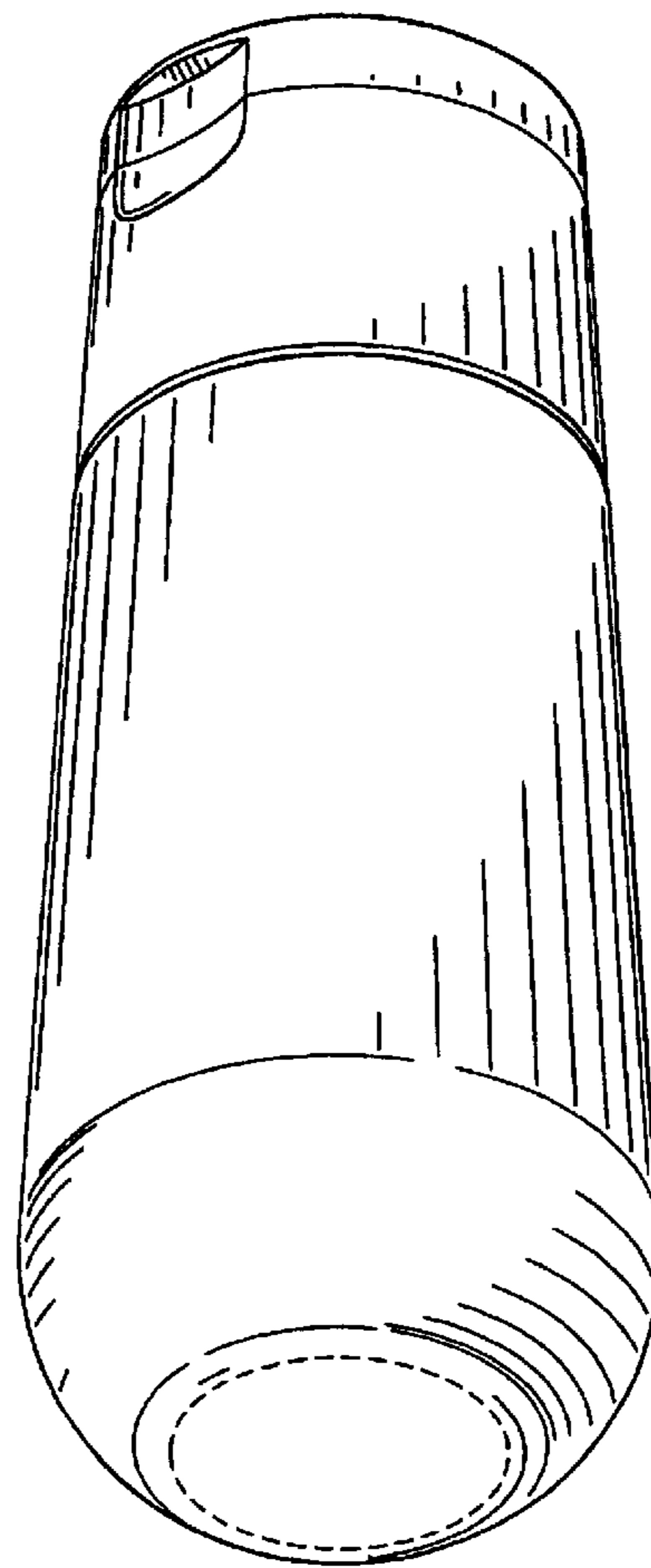

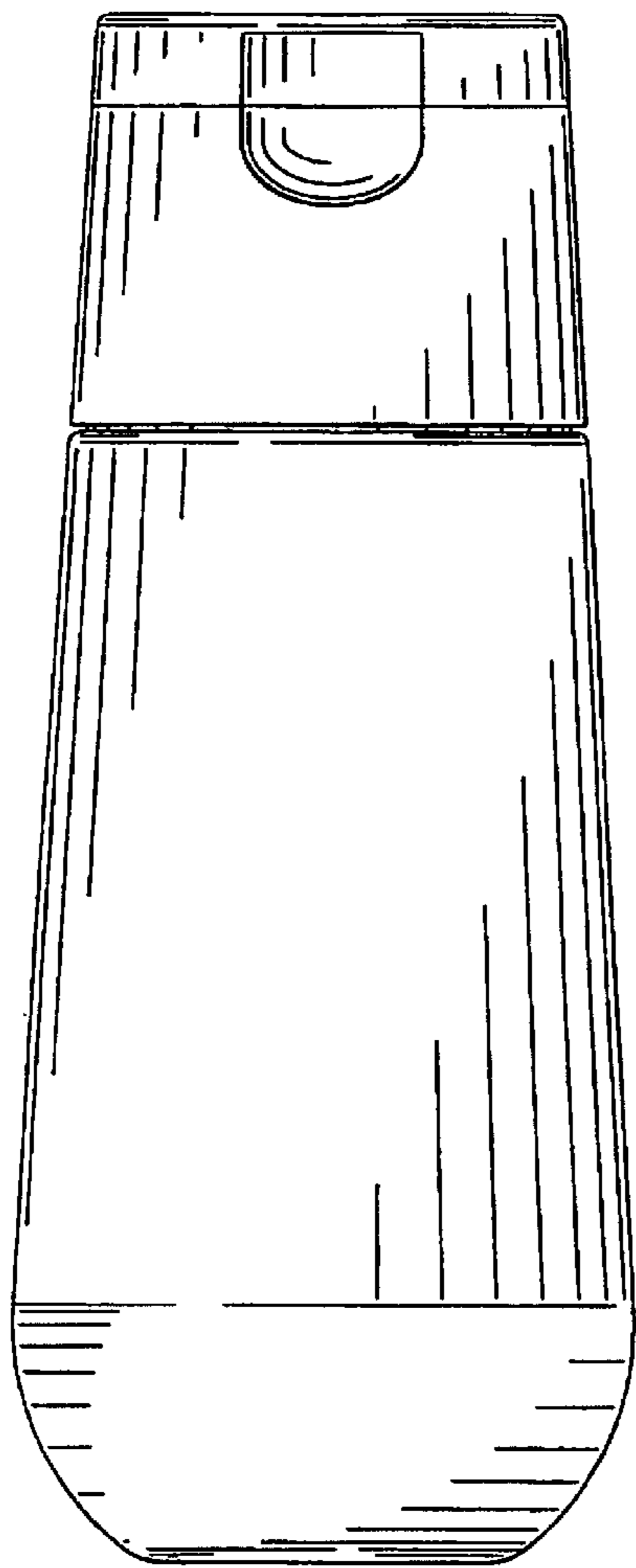

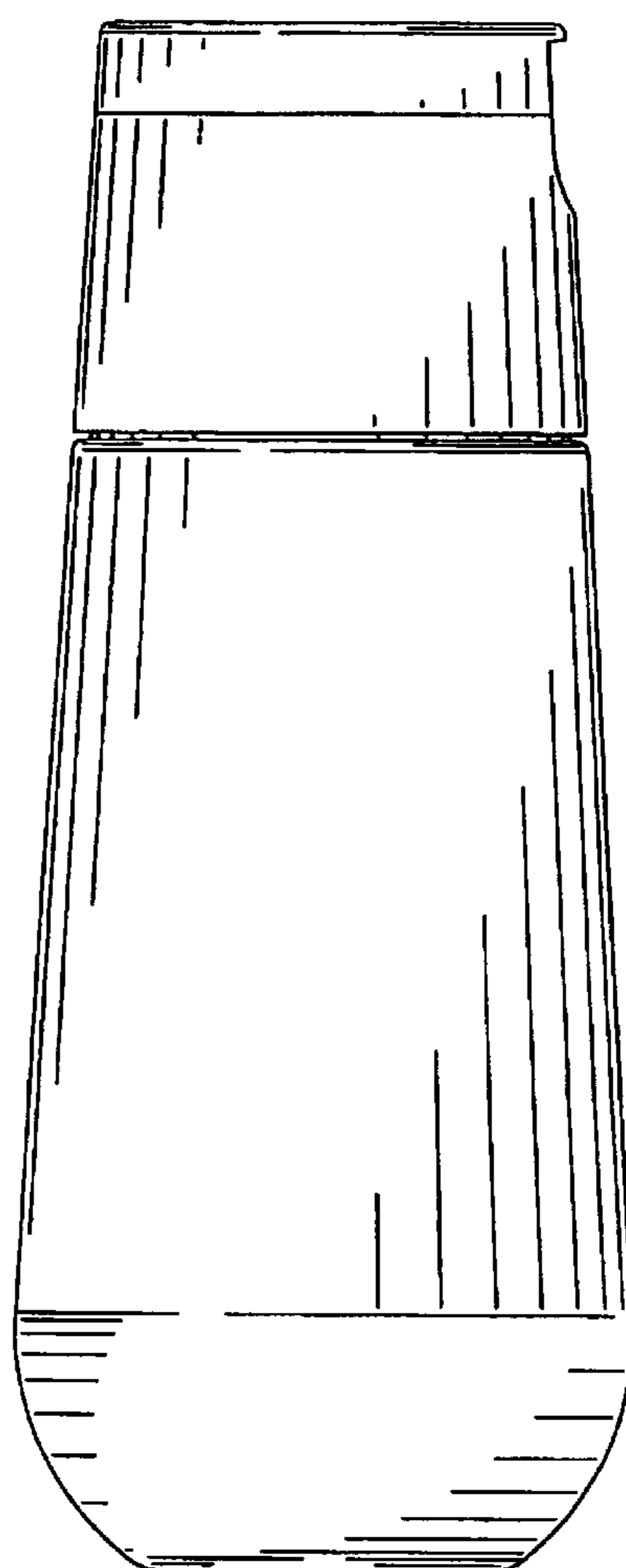

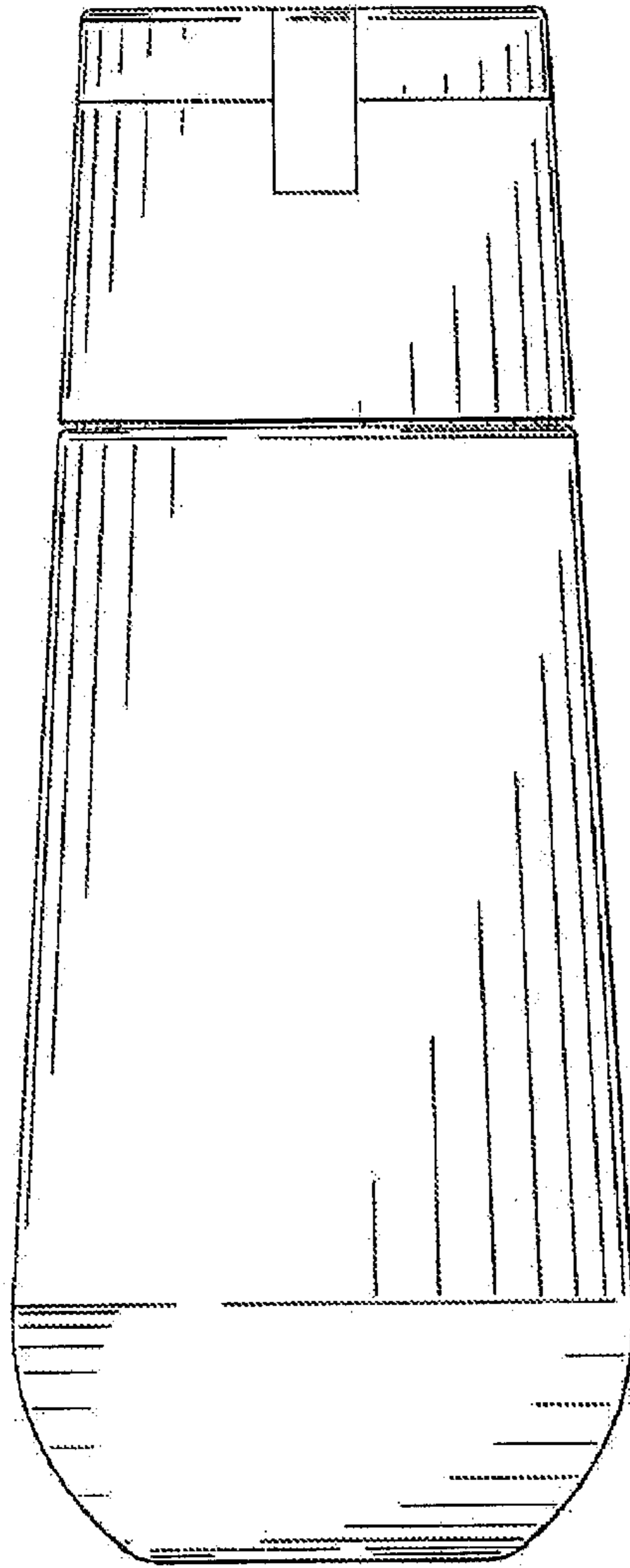

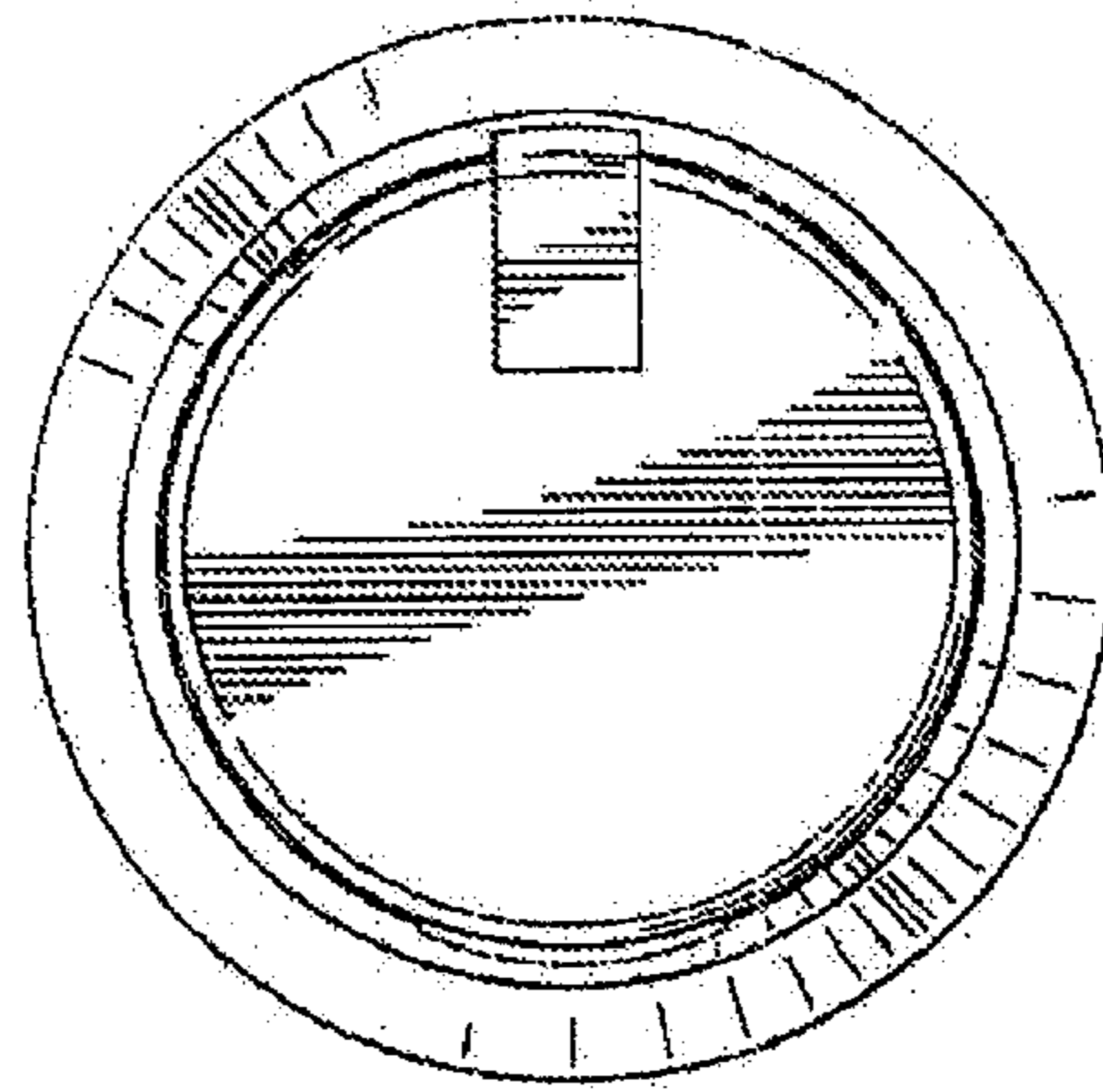

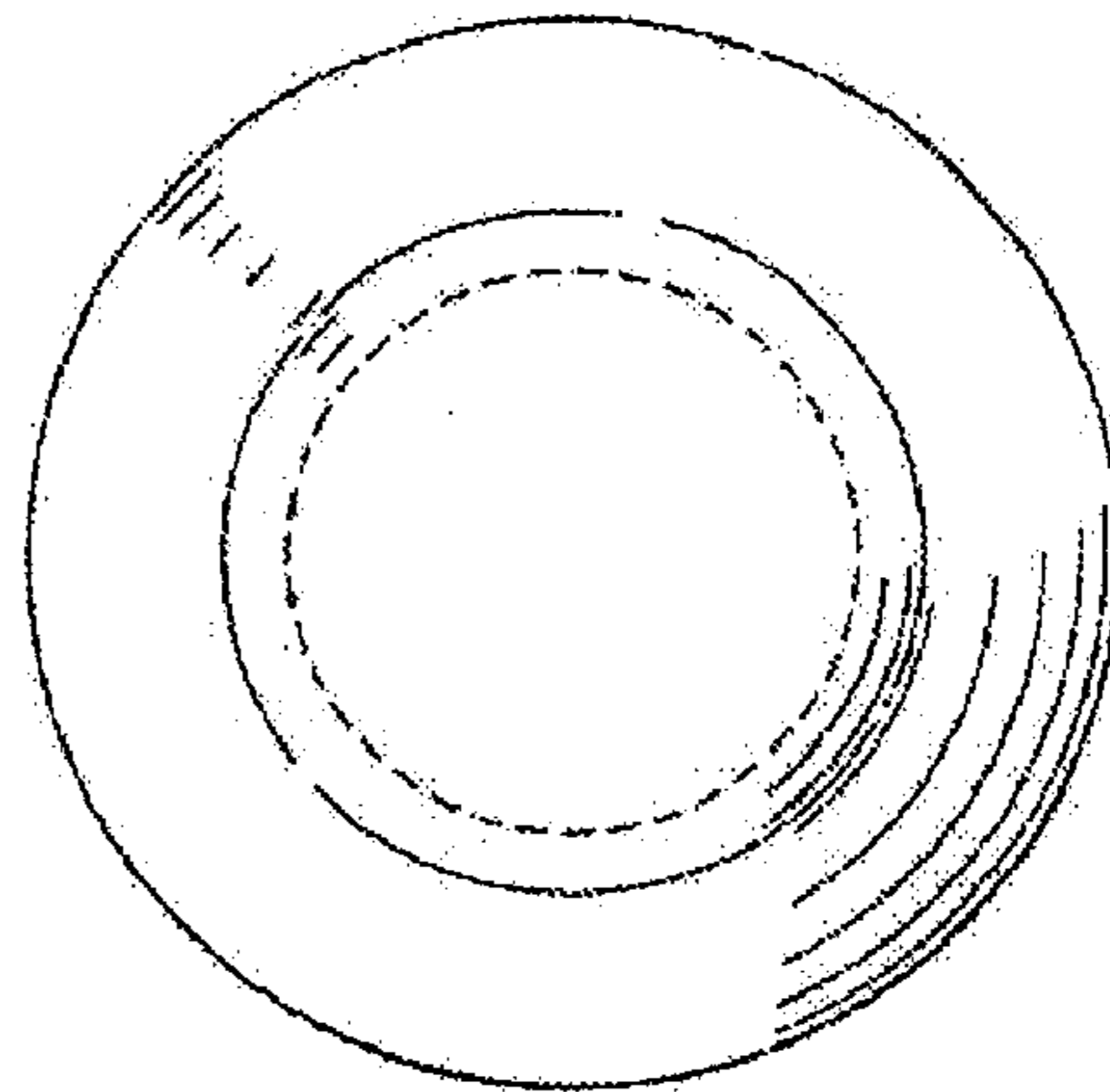
