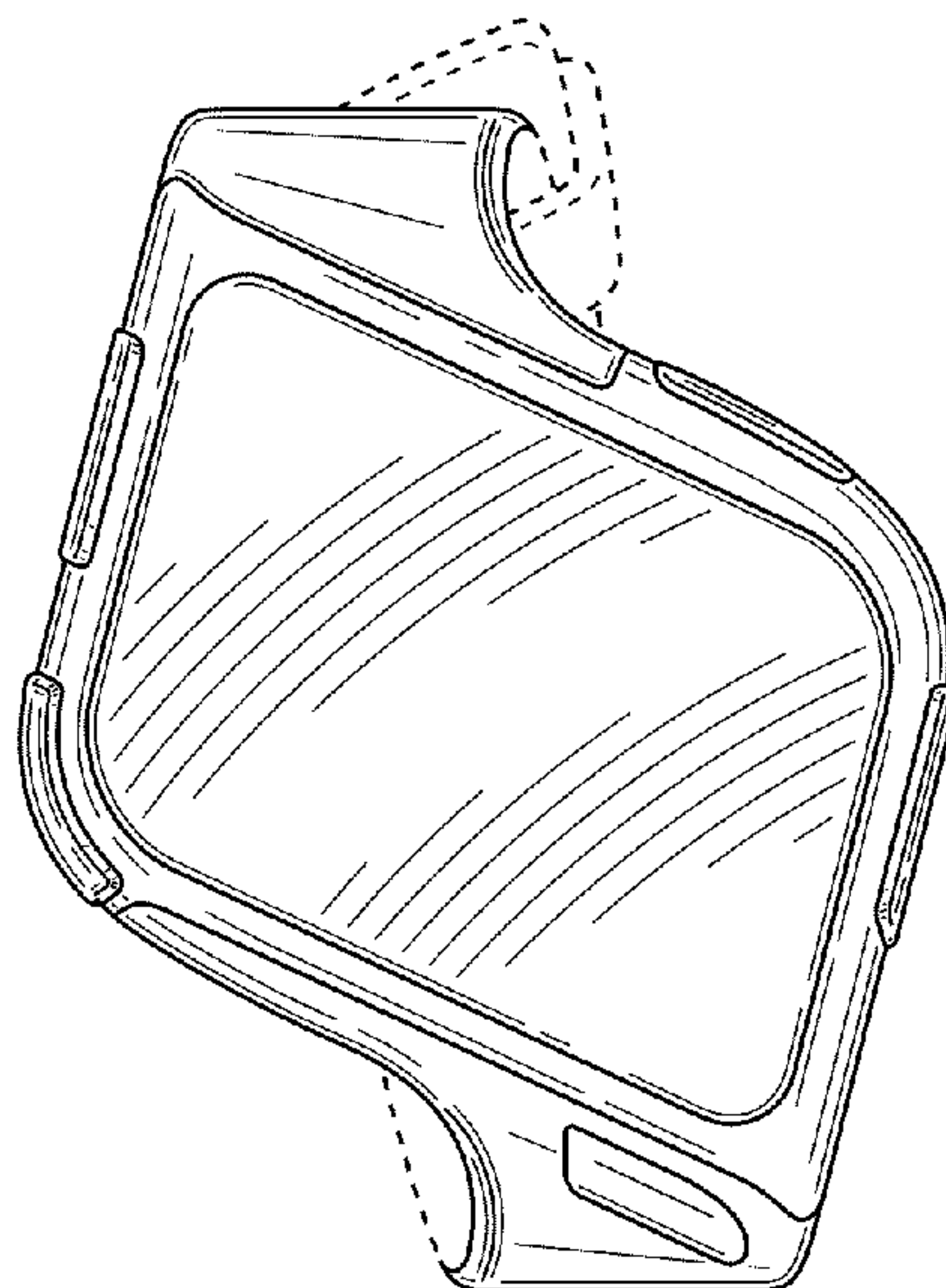
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front right perspective view of a portion of a watch showing my new design;
FIG. 2 is a front view thereof;

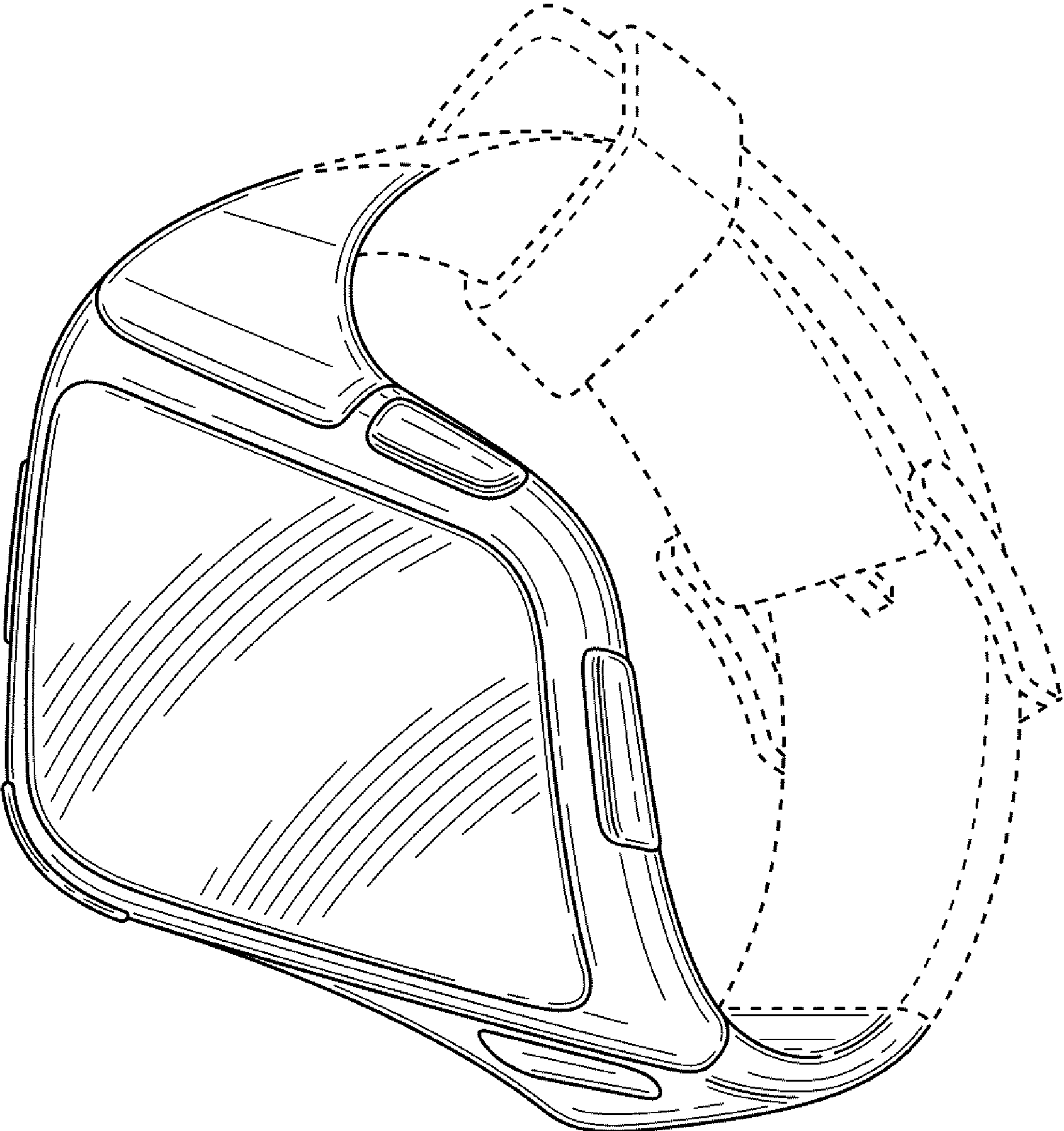

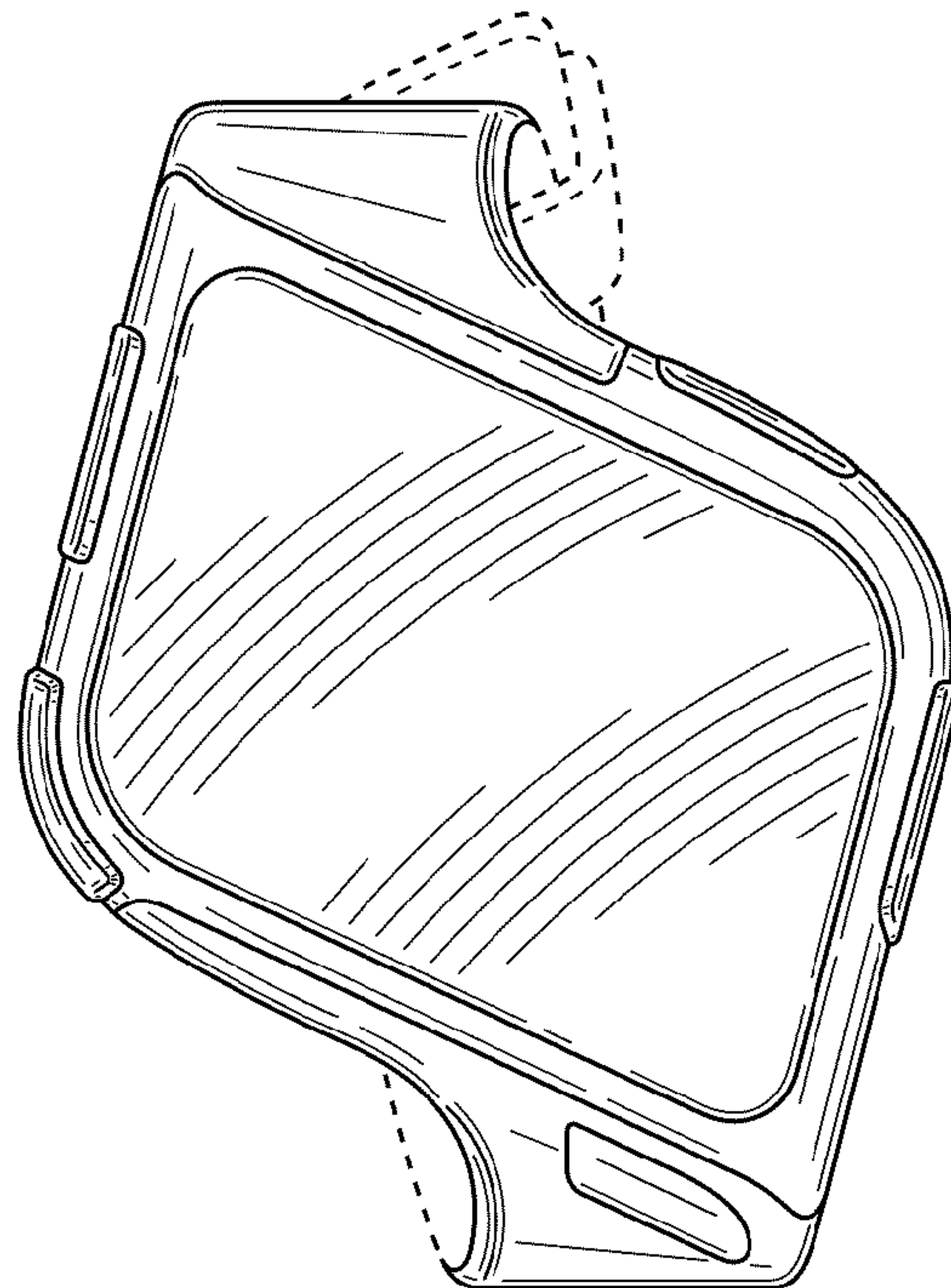

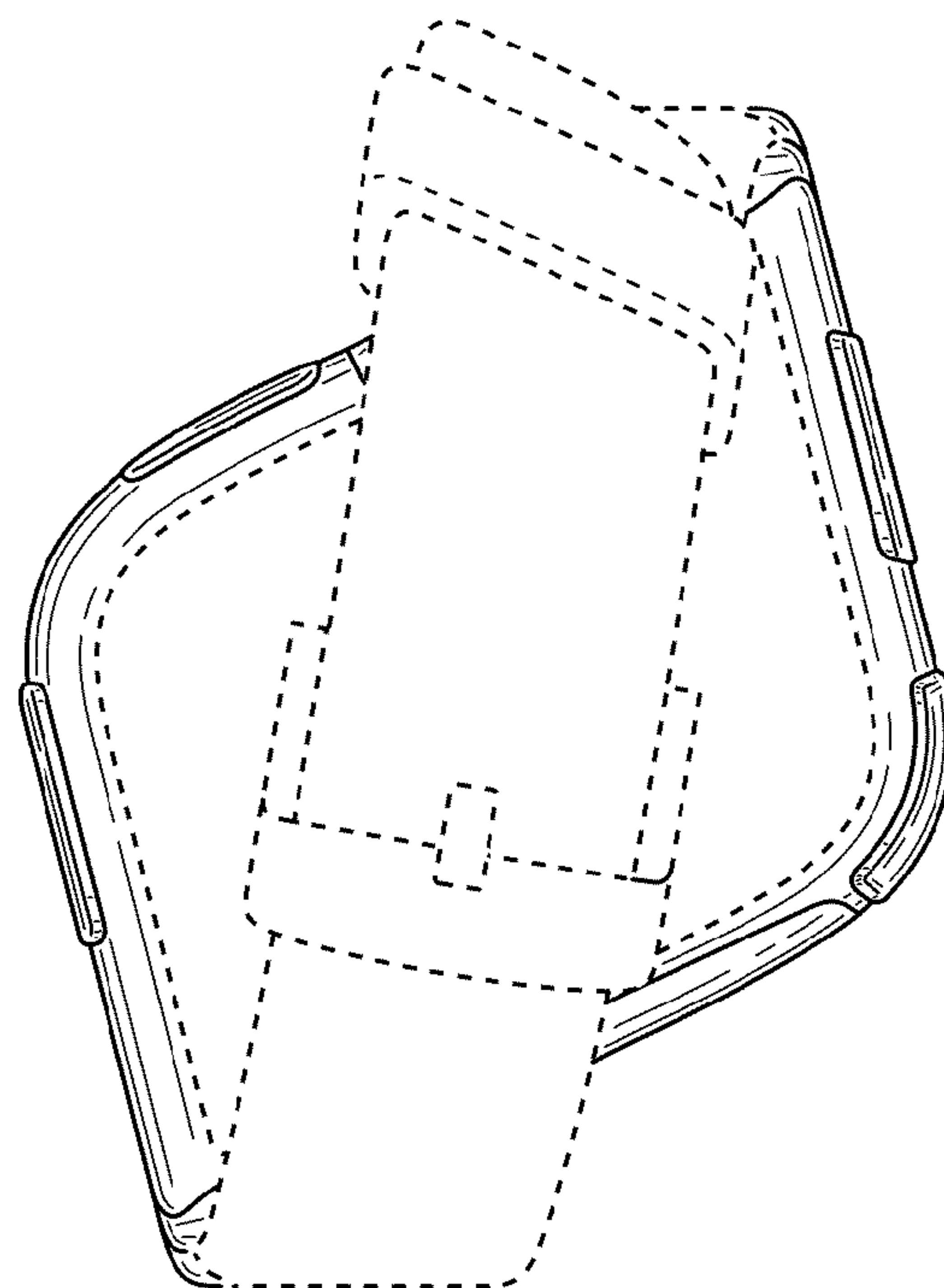

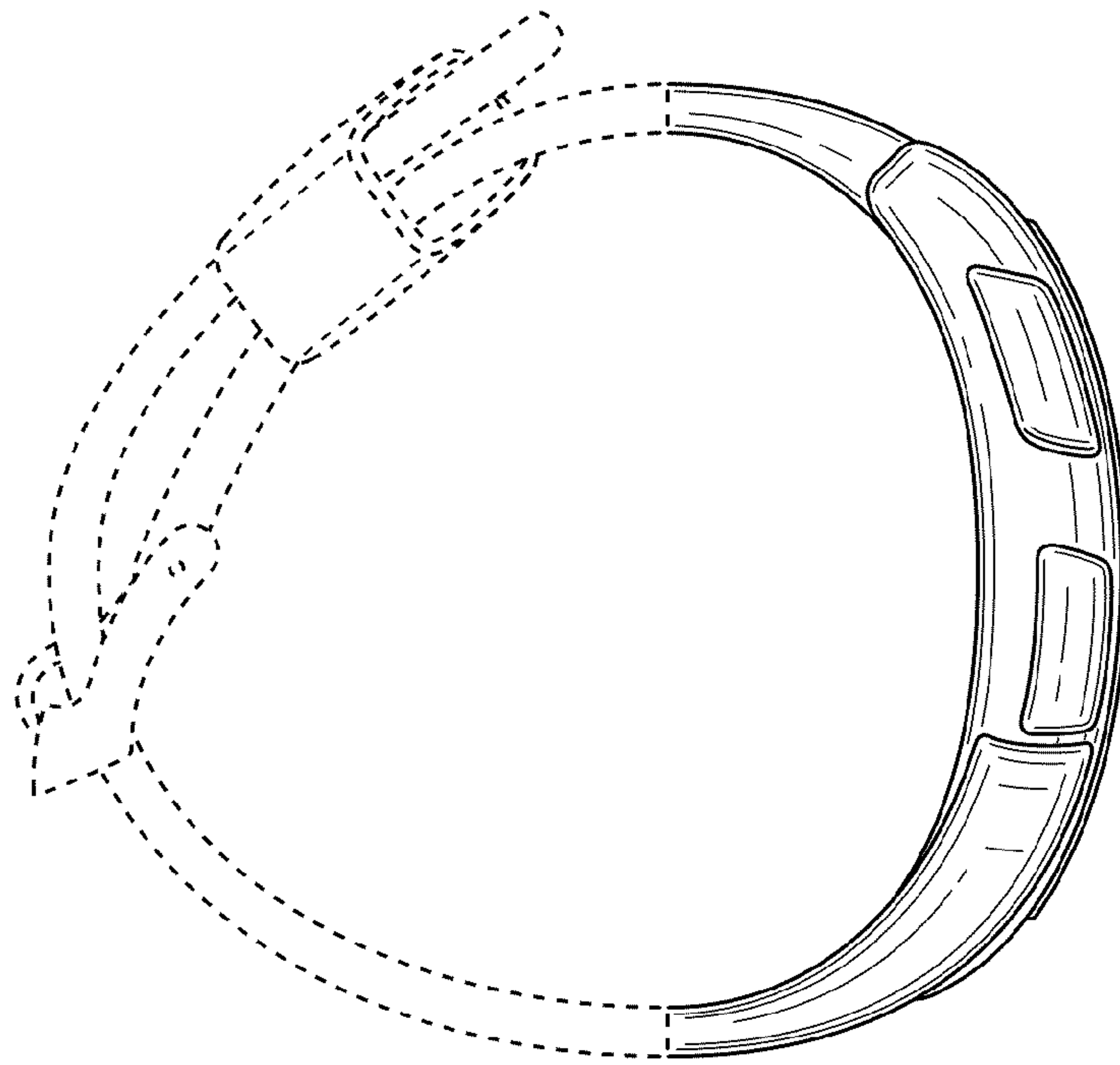

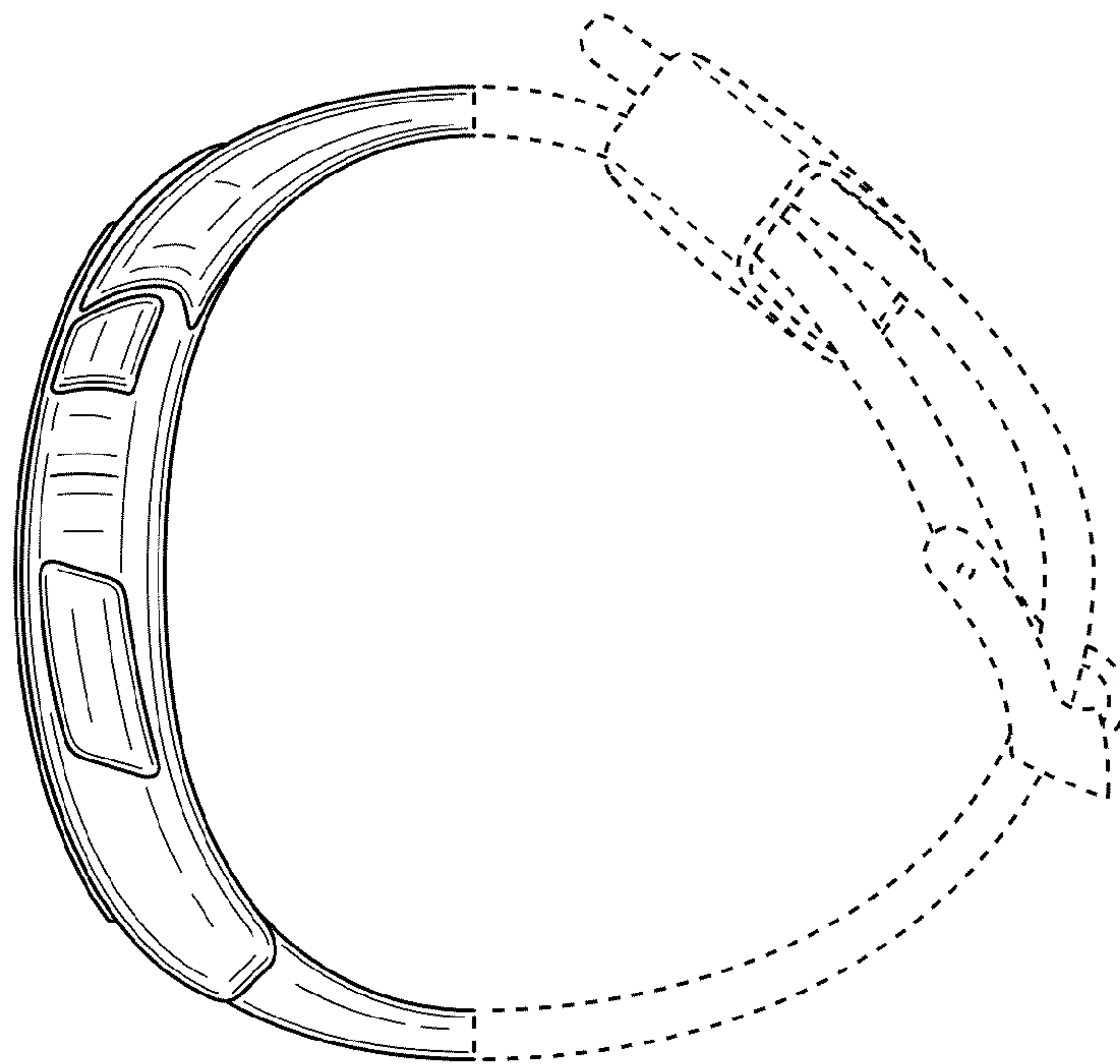

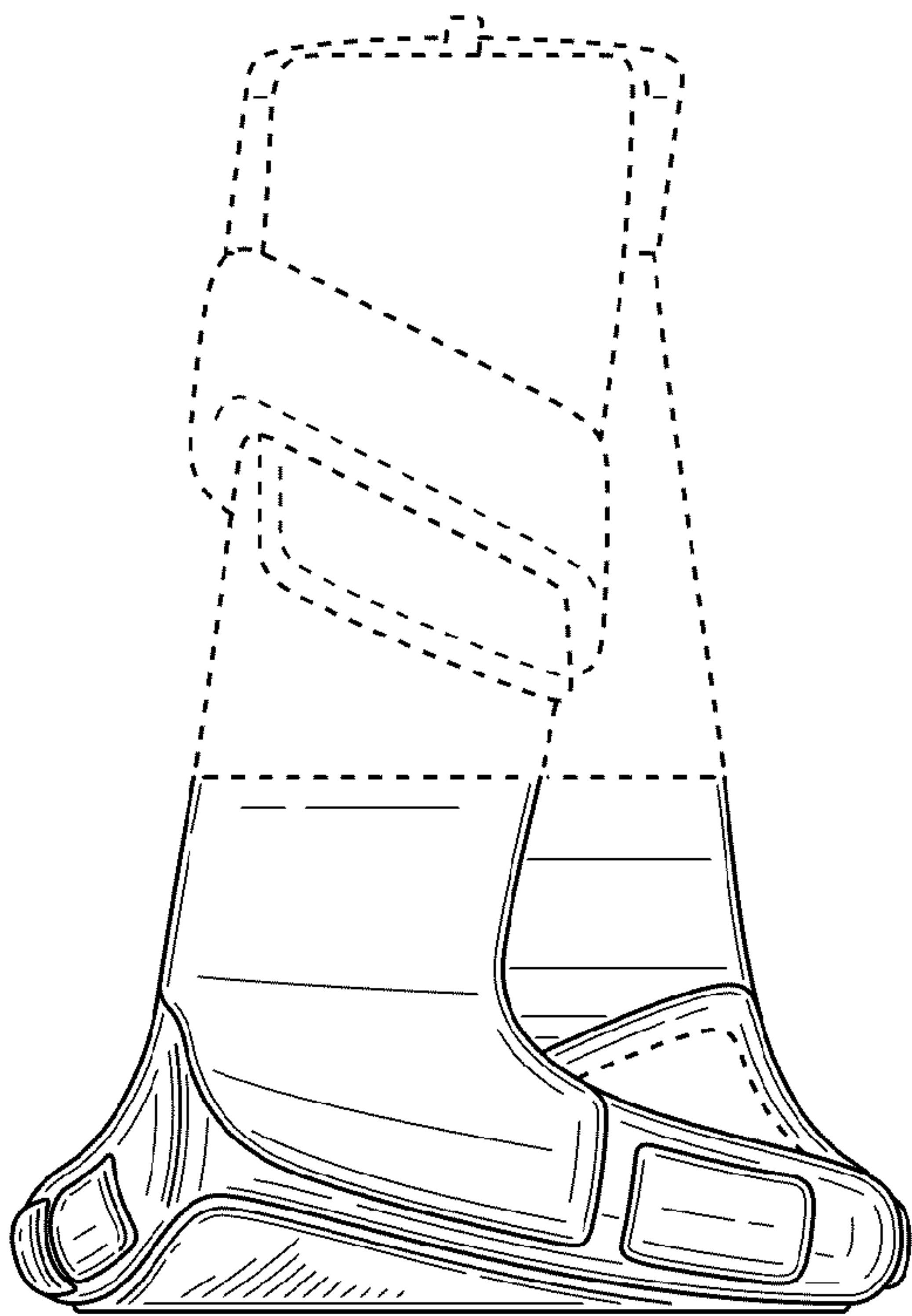

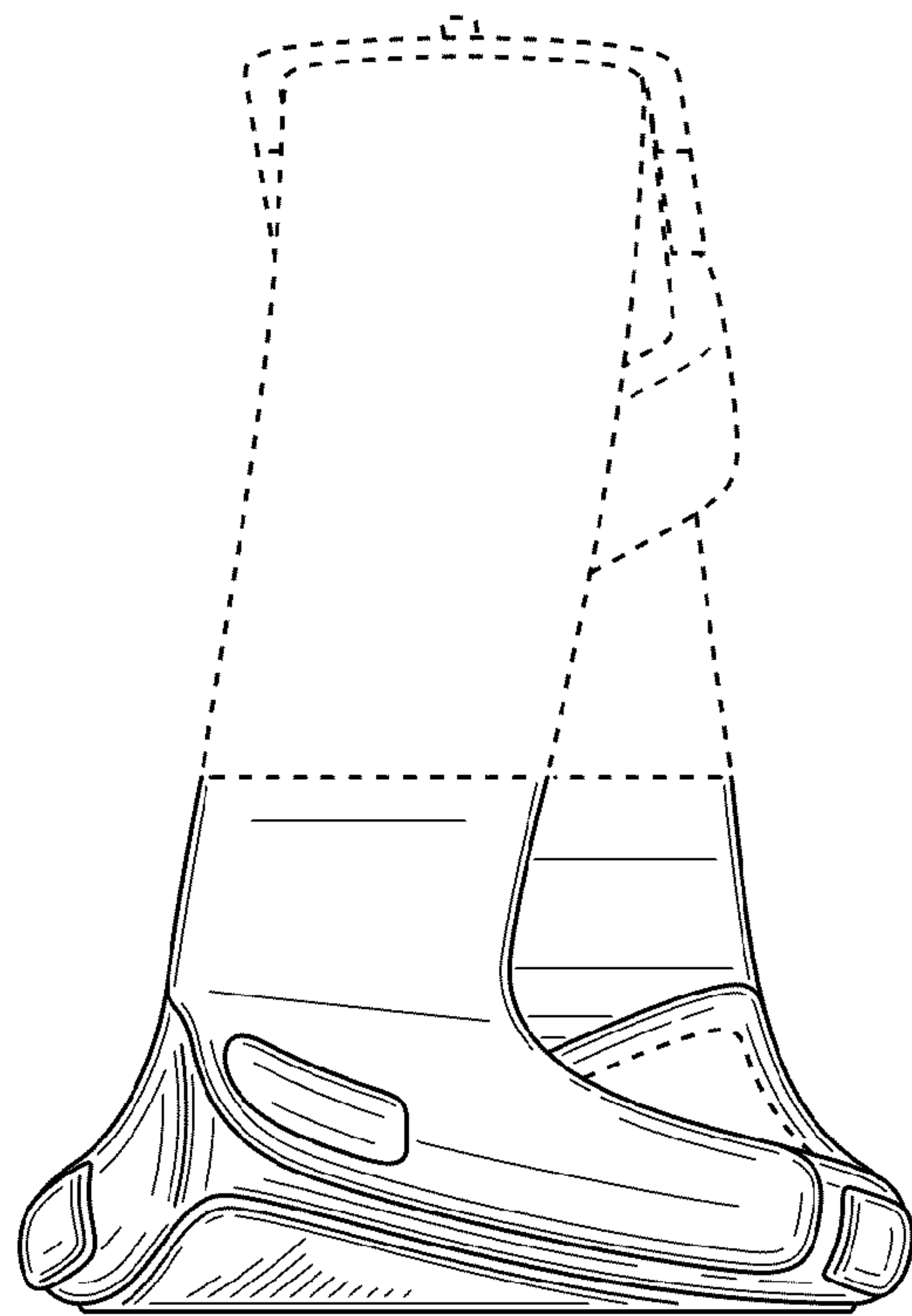
