The ornamental design for an engine intake cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an engine intake cover.

FIG. 2 is a top view of the engine intake cover.

FIG. 3 is a left side elevation view of the engine intake cover.

FIG. 4 is a right side elevation view of the engine intake cover.

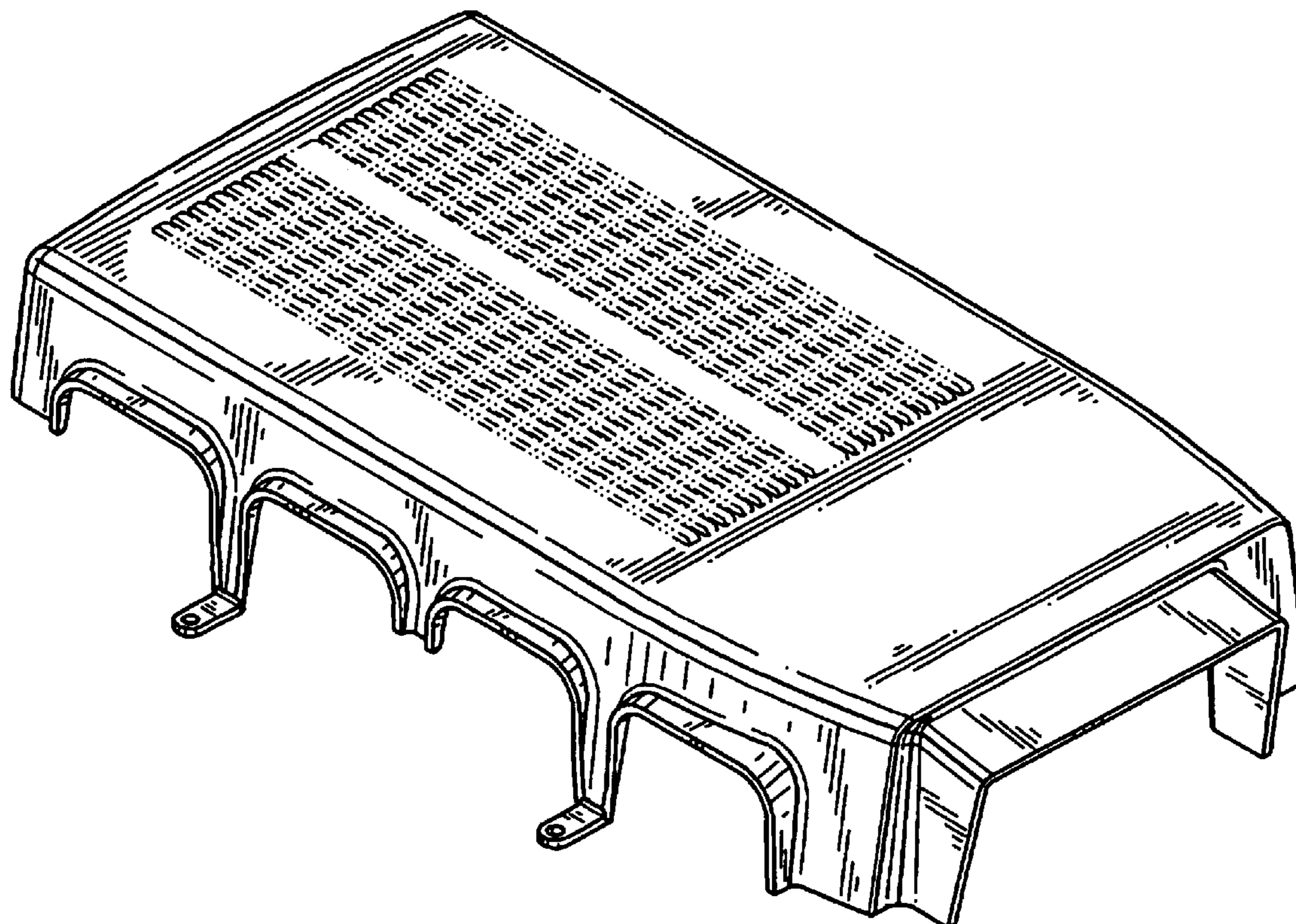
FIG. 5 is a front elevation view of the engine intake cover.

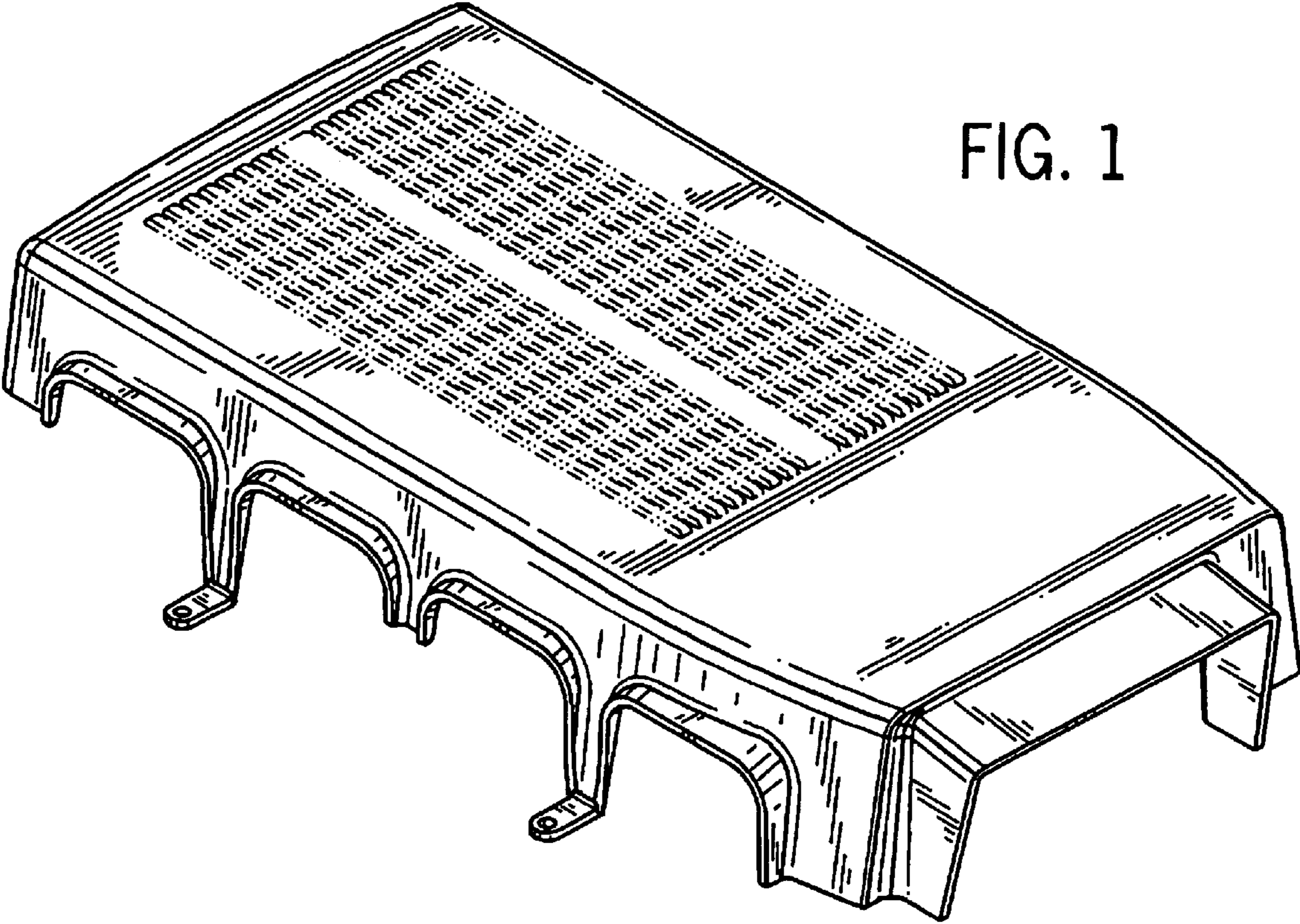
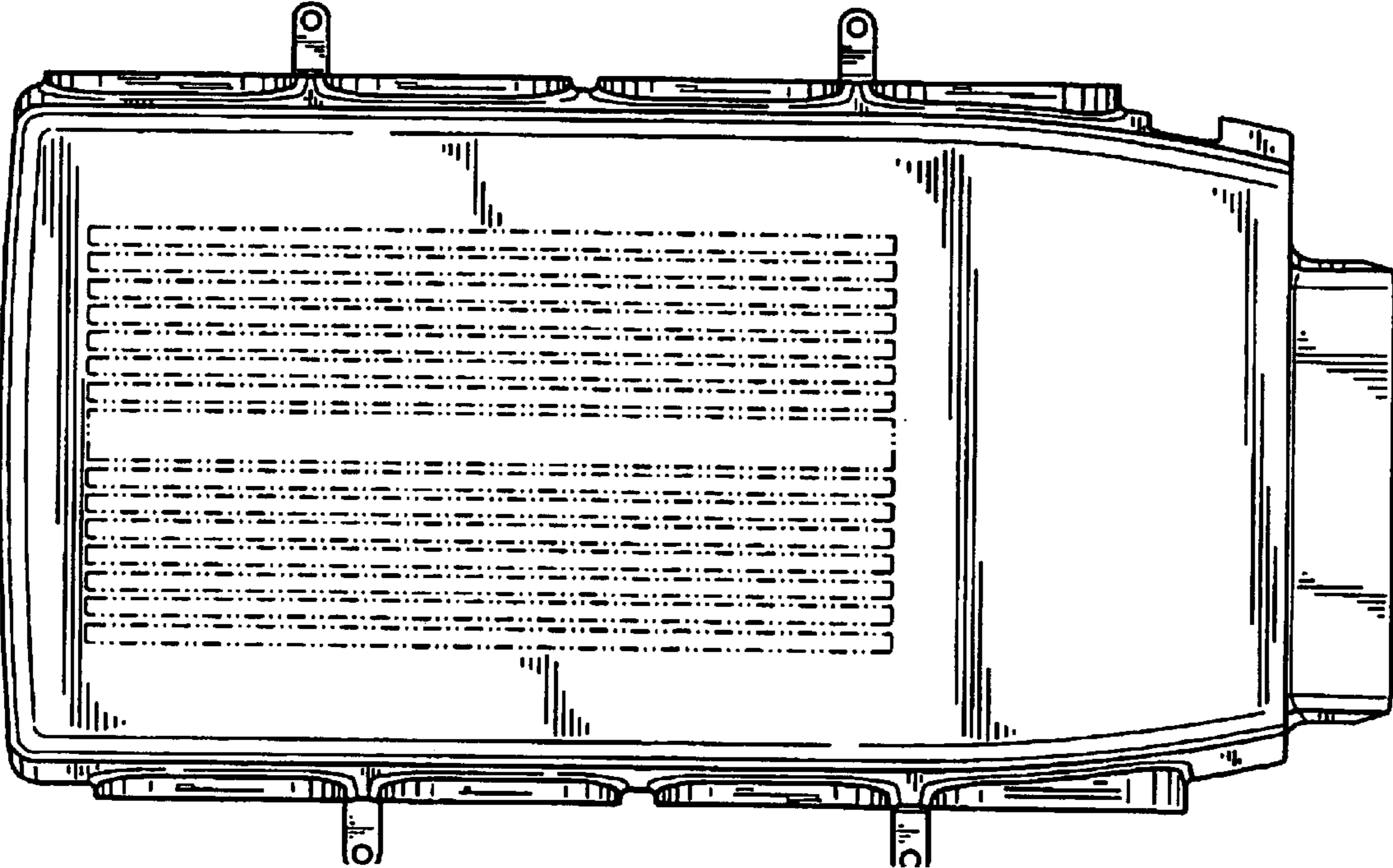

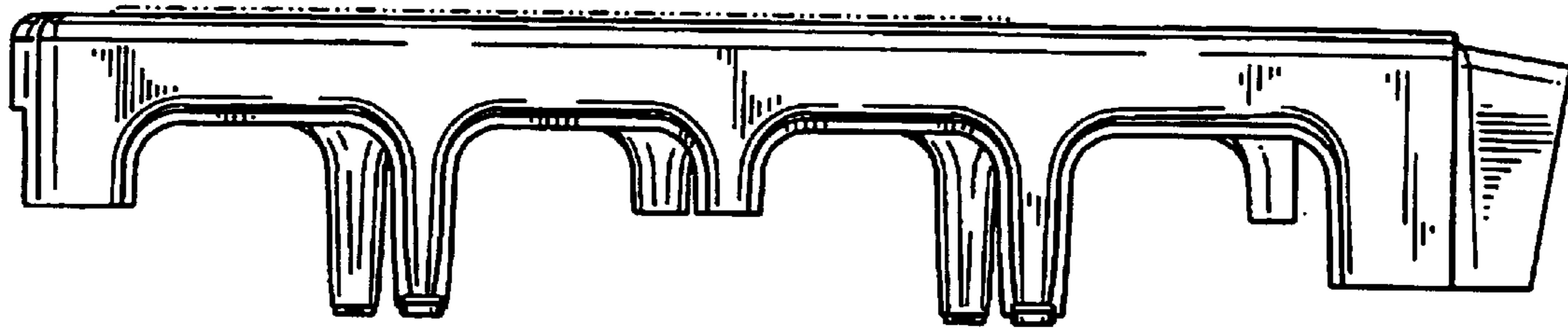

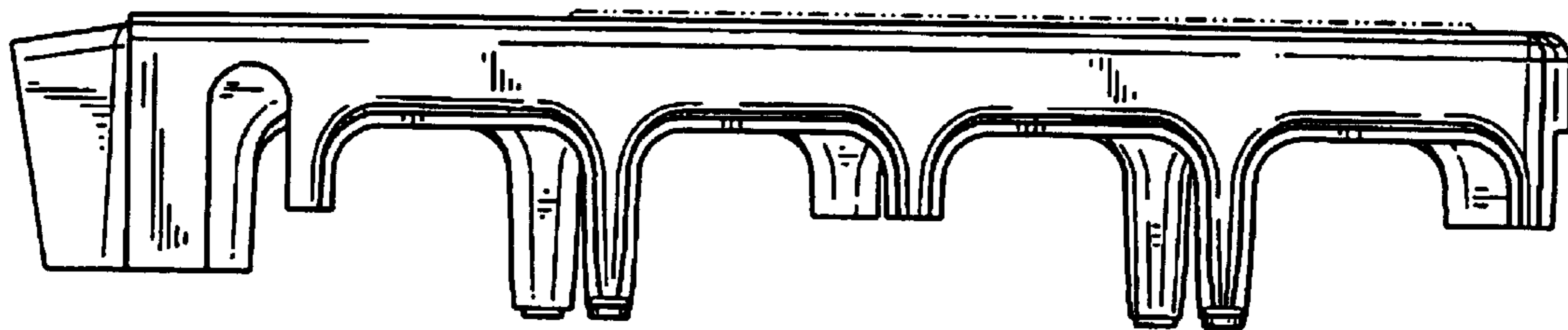

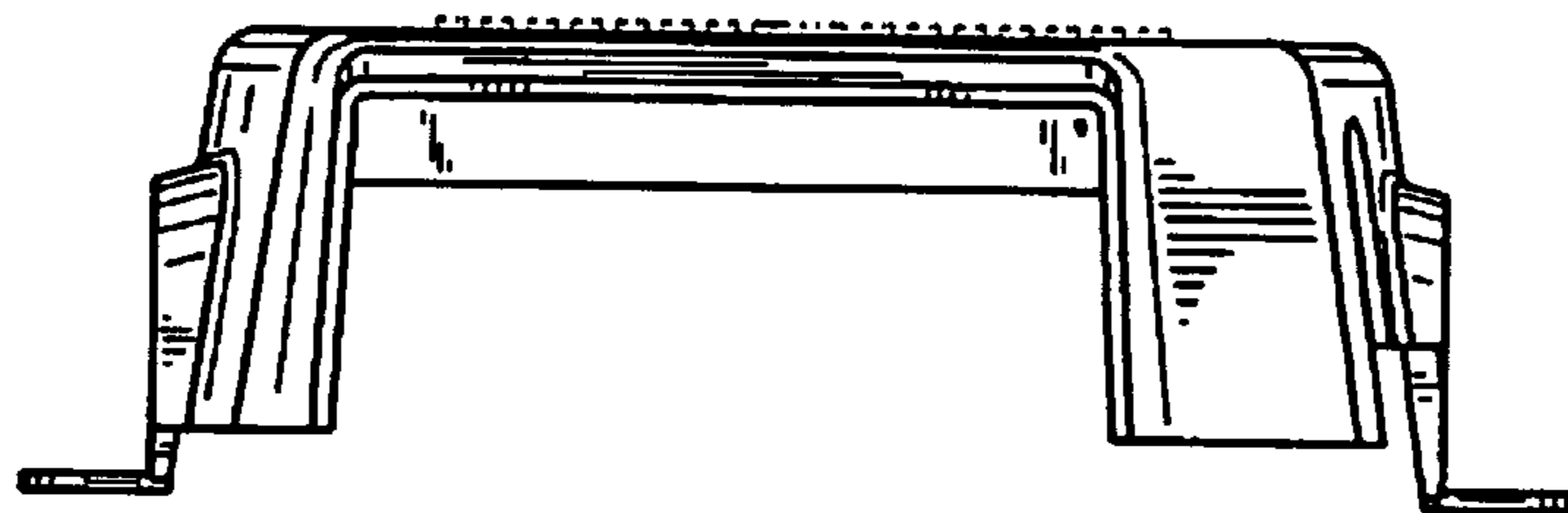

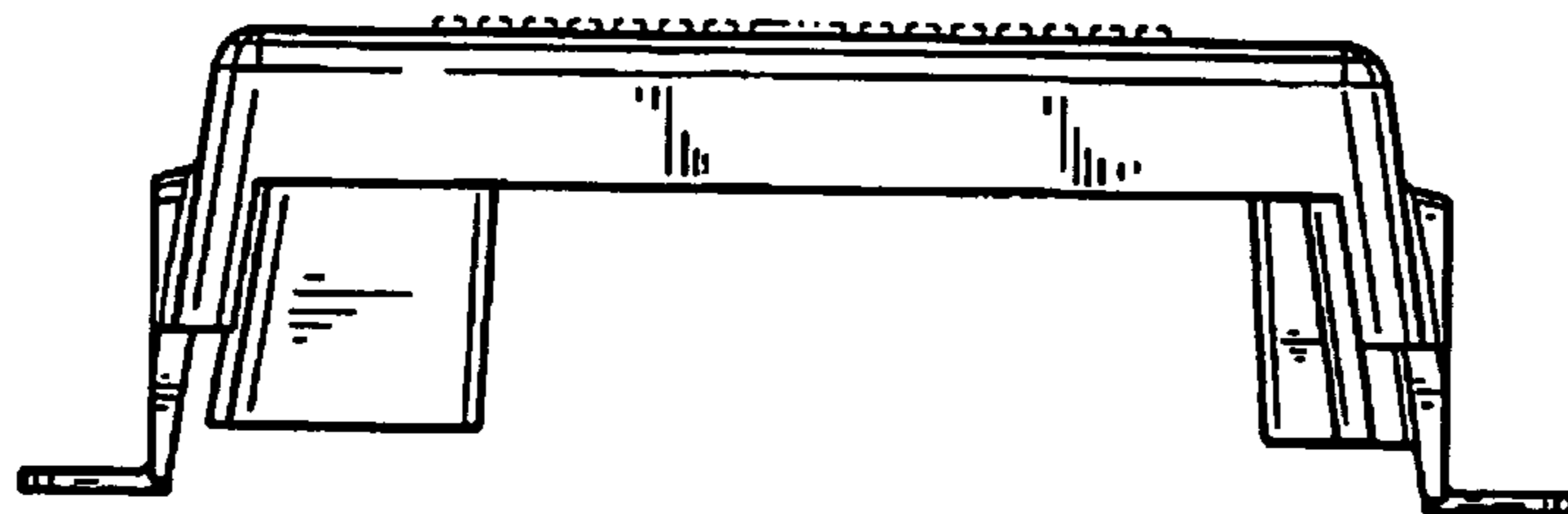

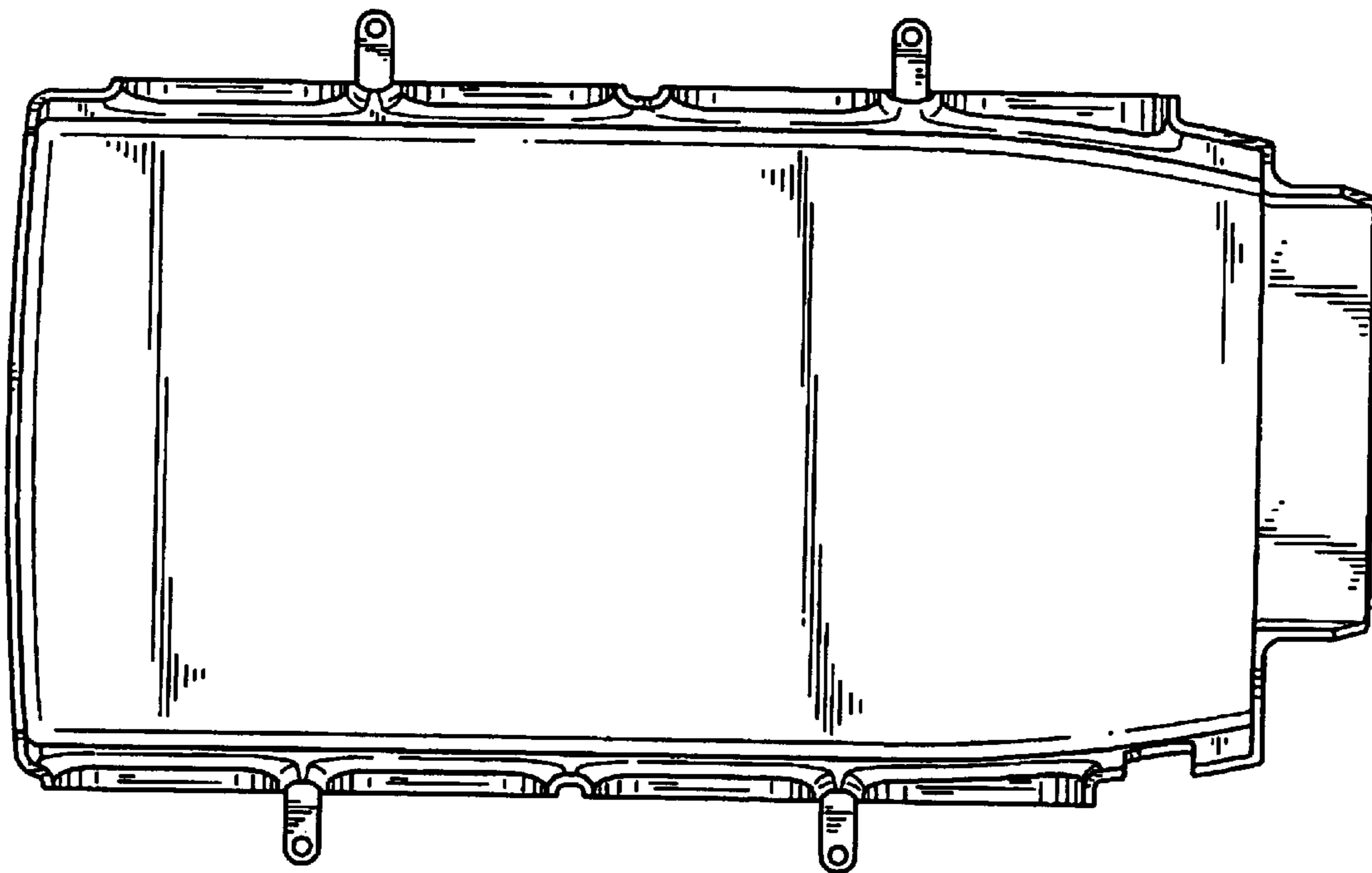
