The ornamental design for a paper tray, as shown and described.

DESCRIPTION

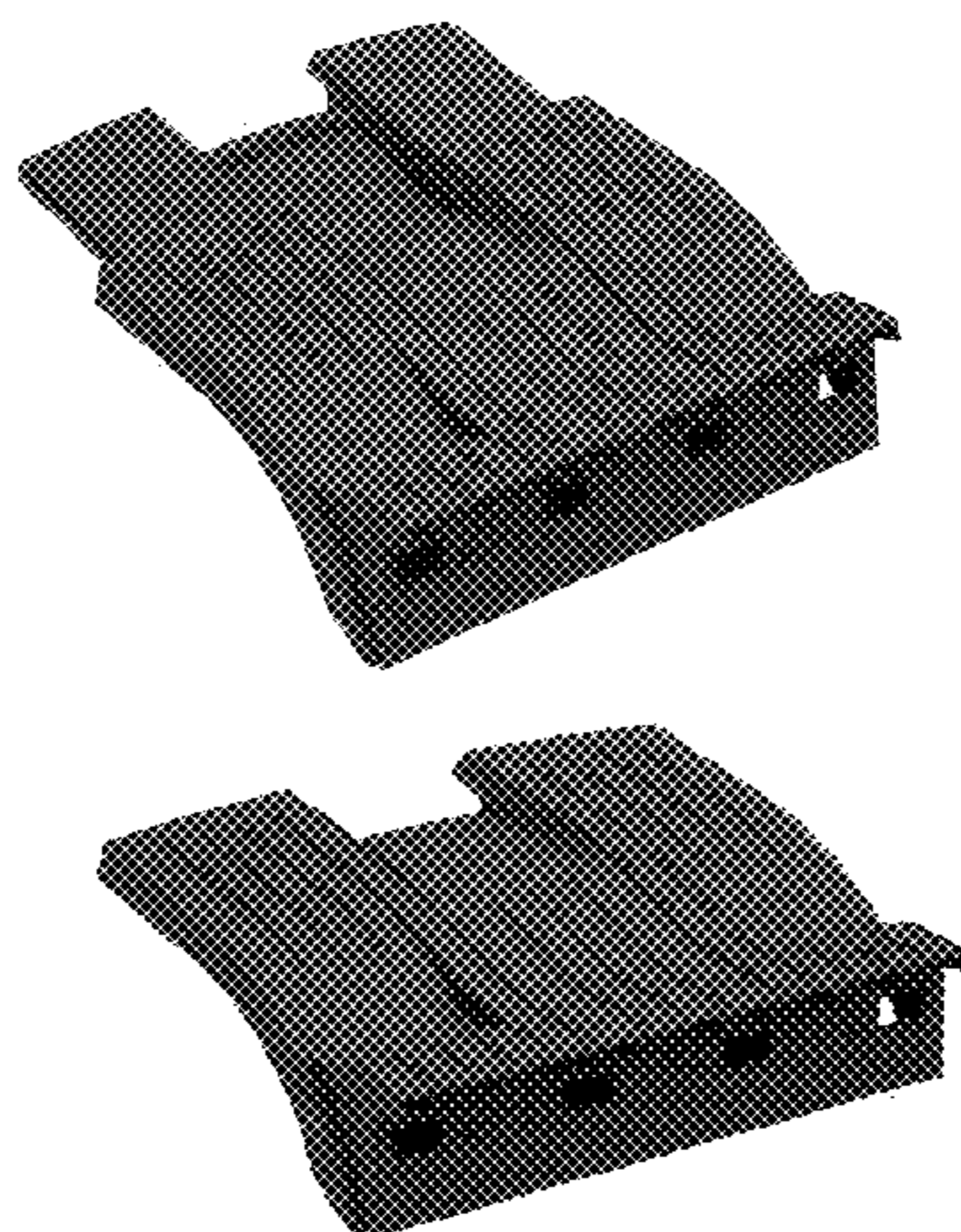

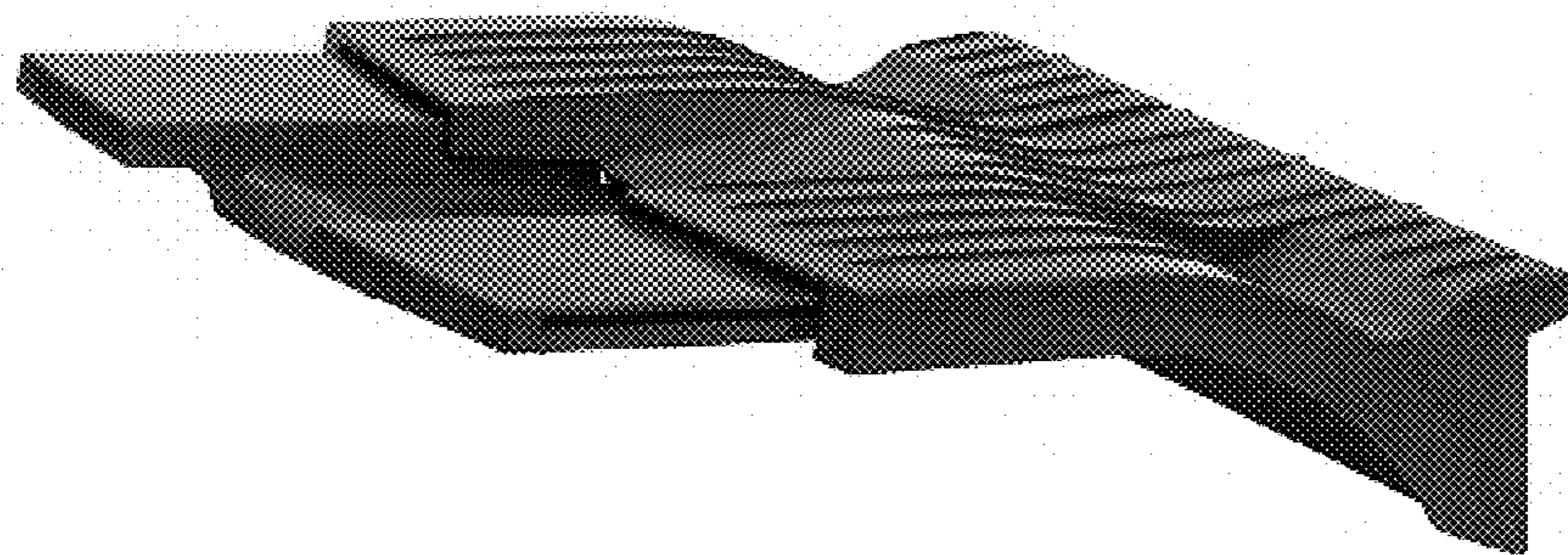

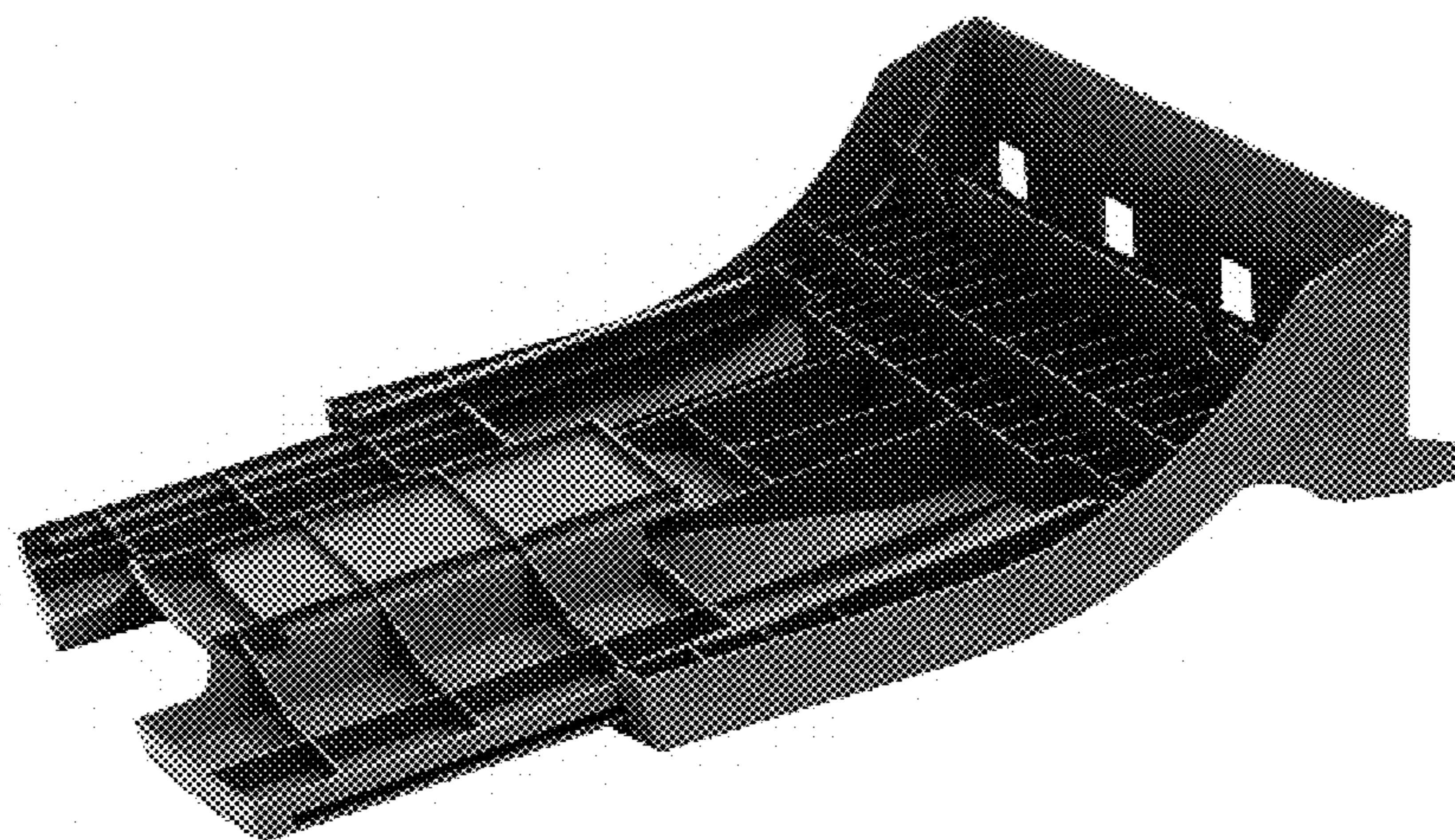

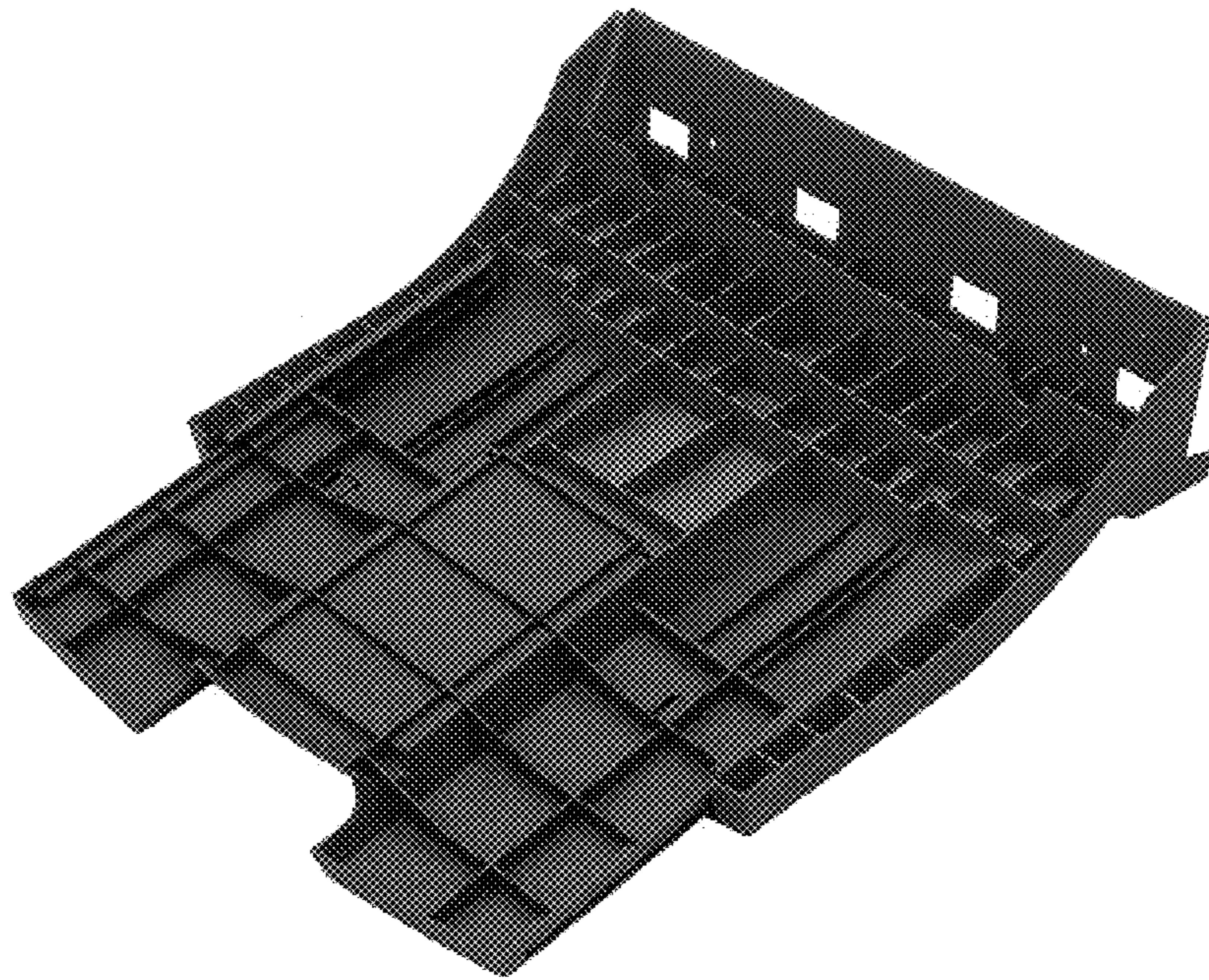

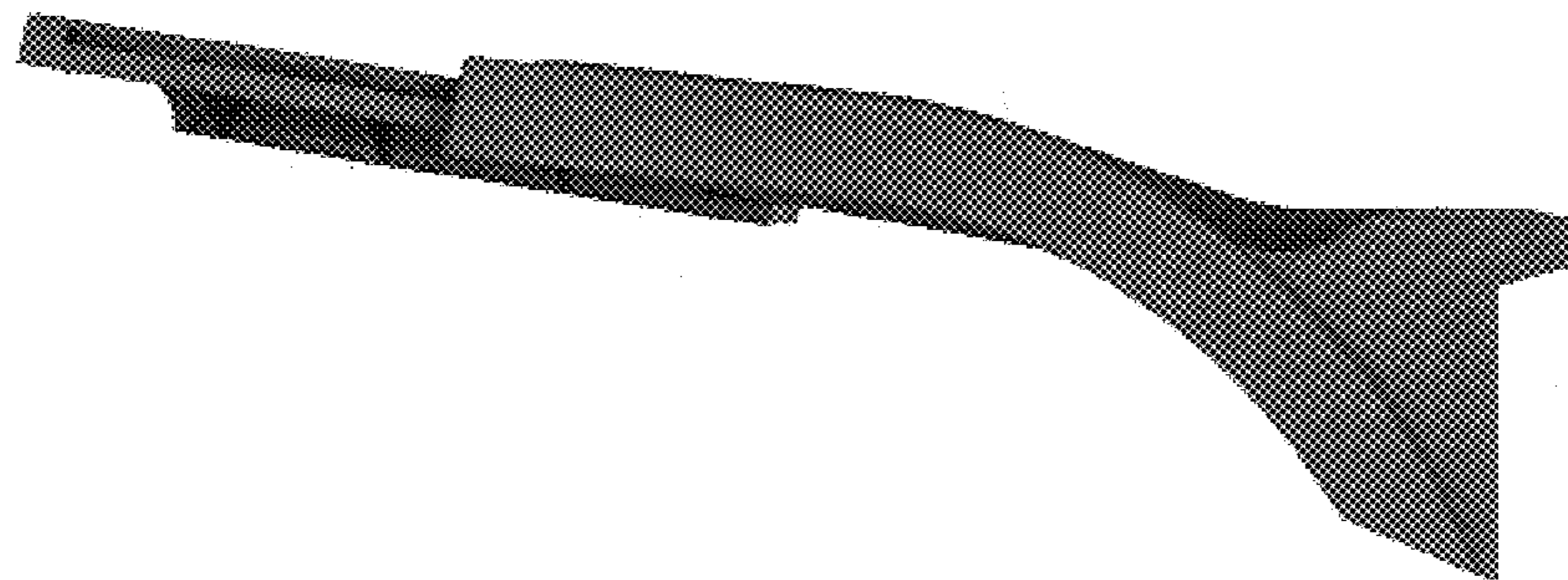

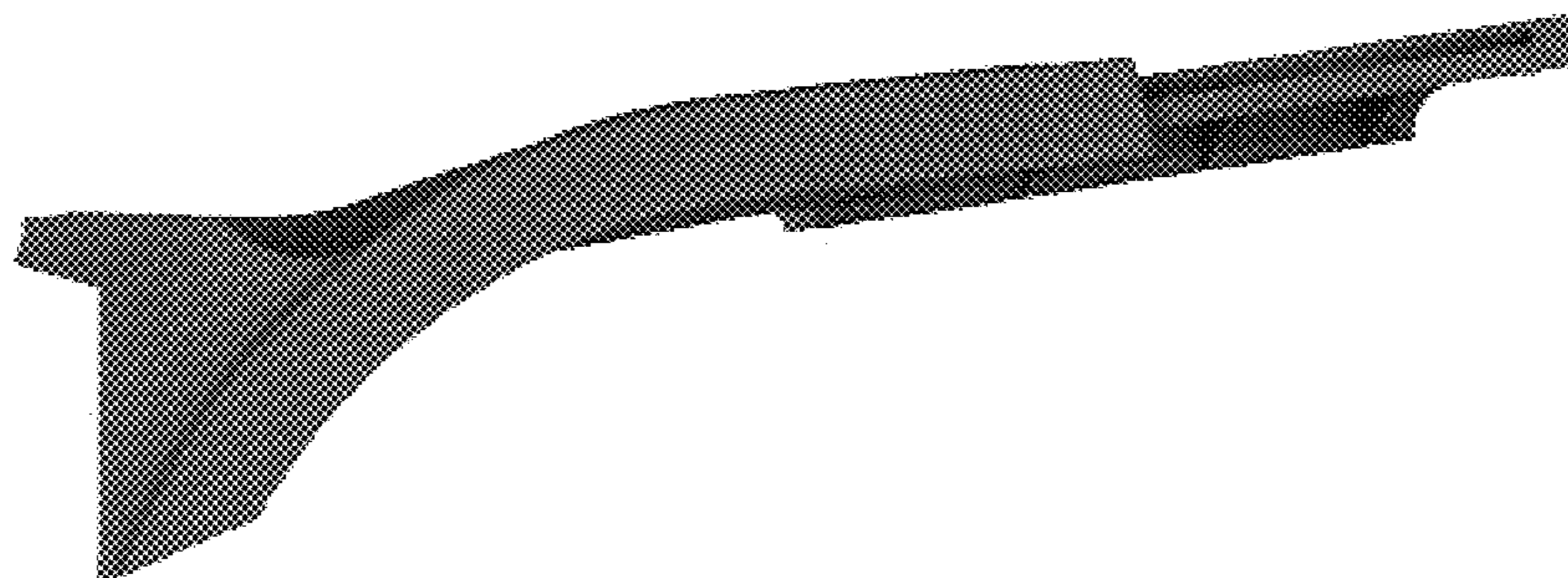

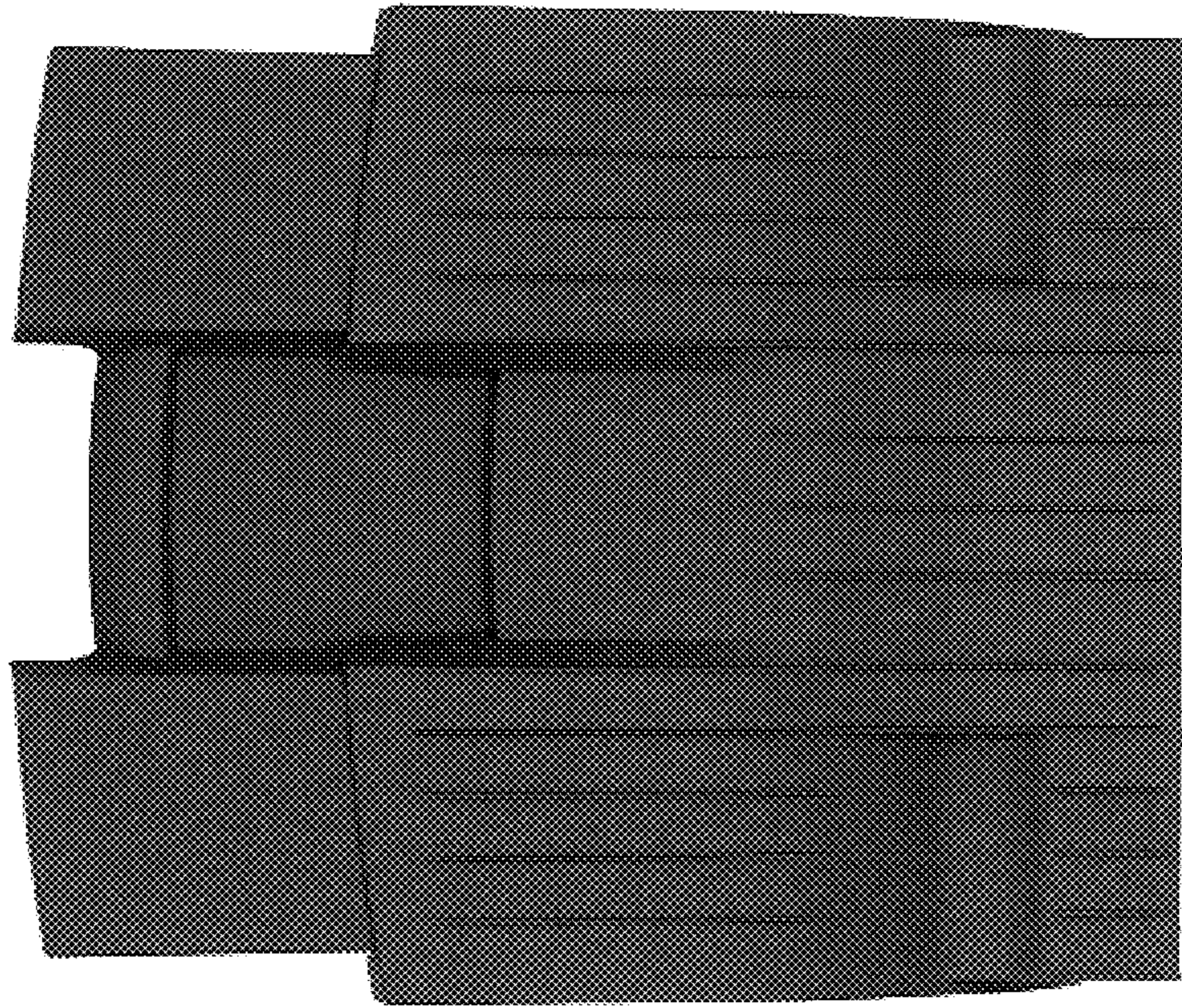

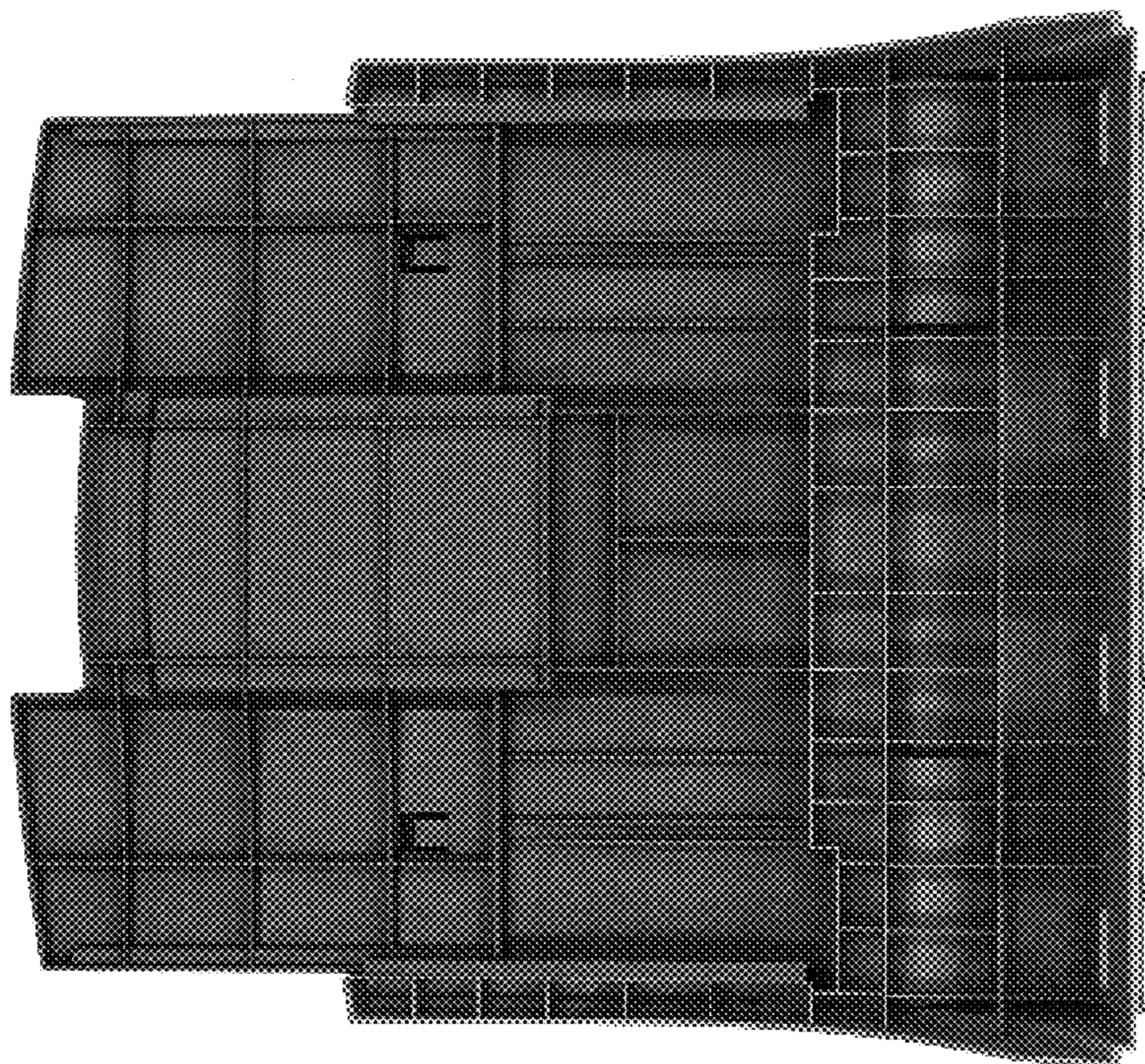

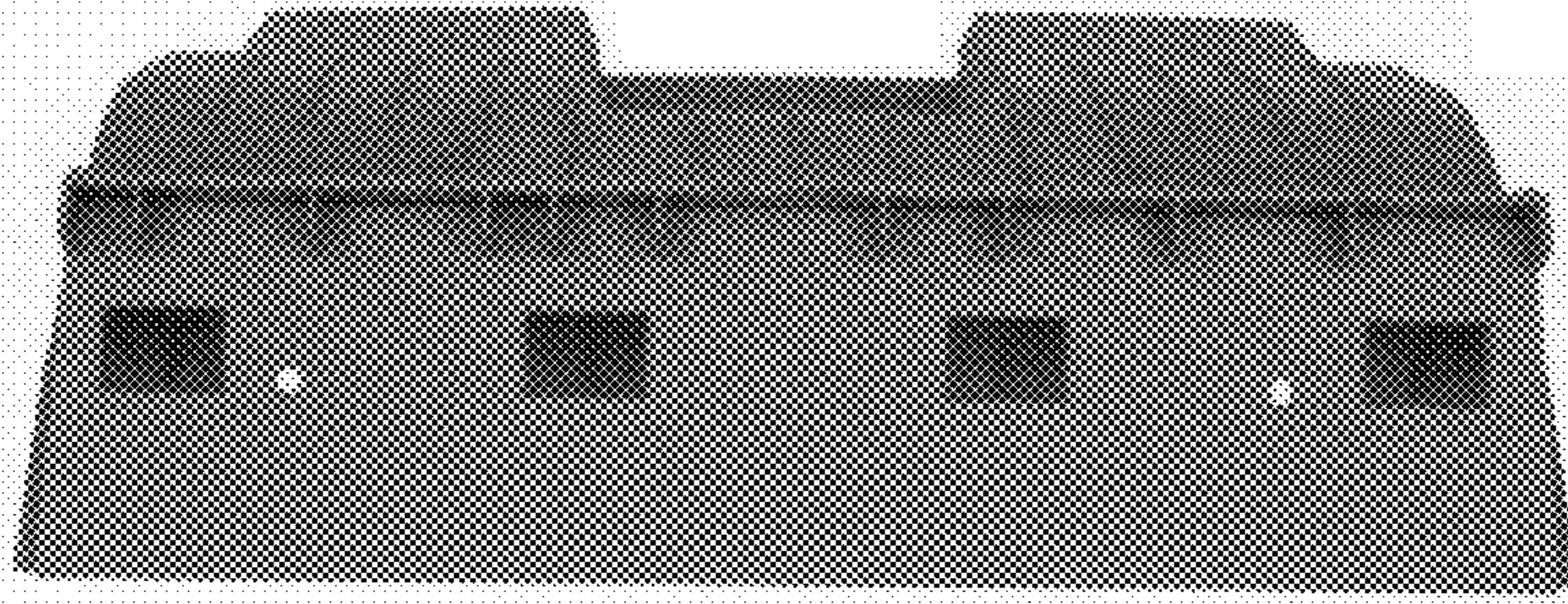

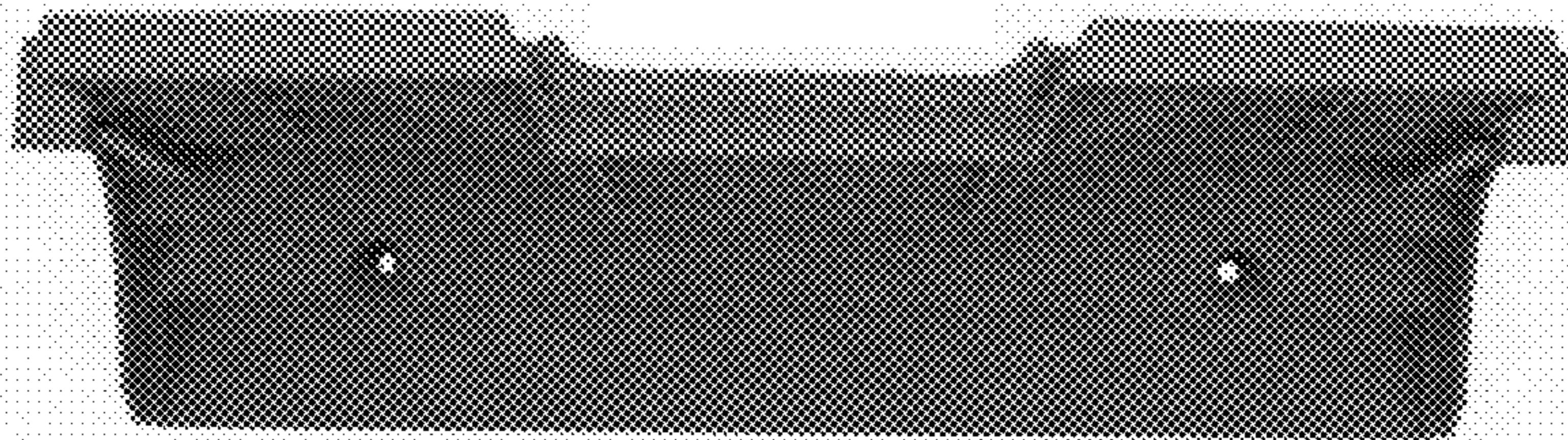

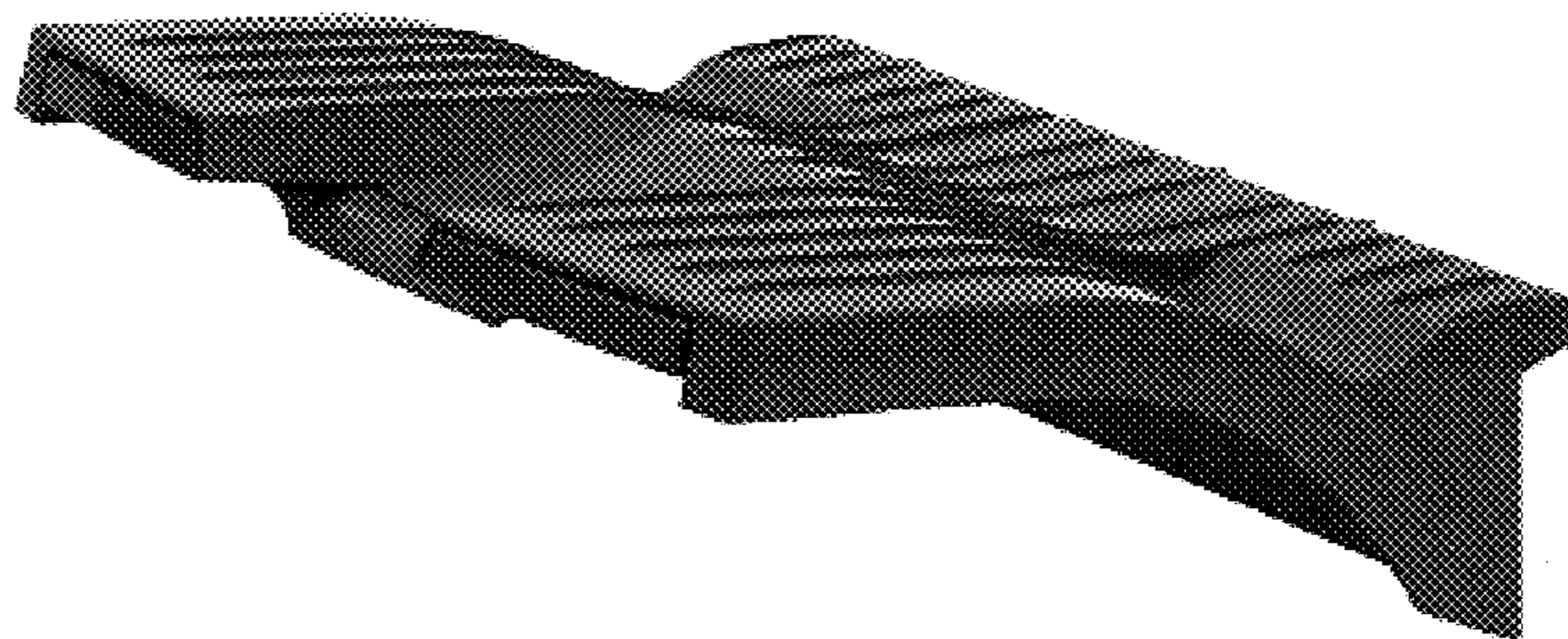

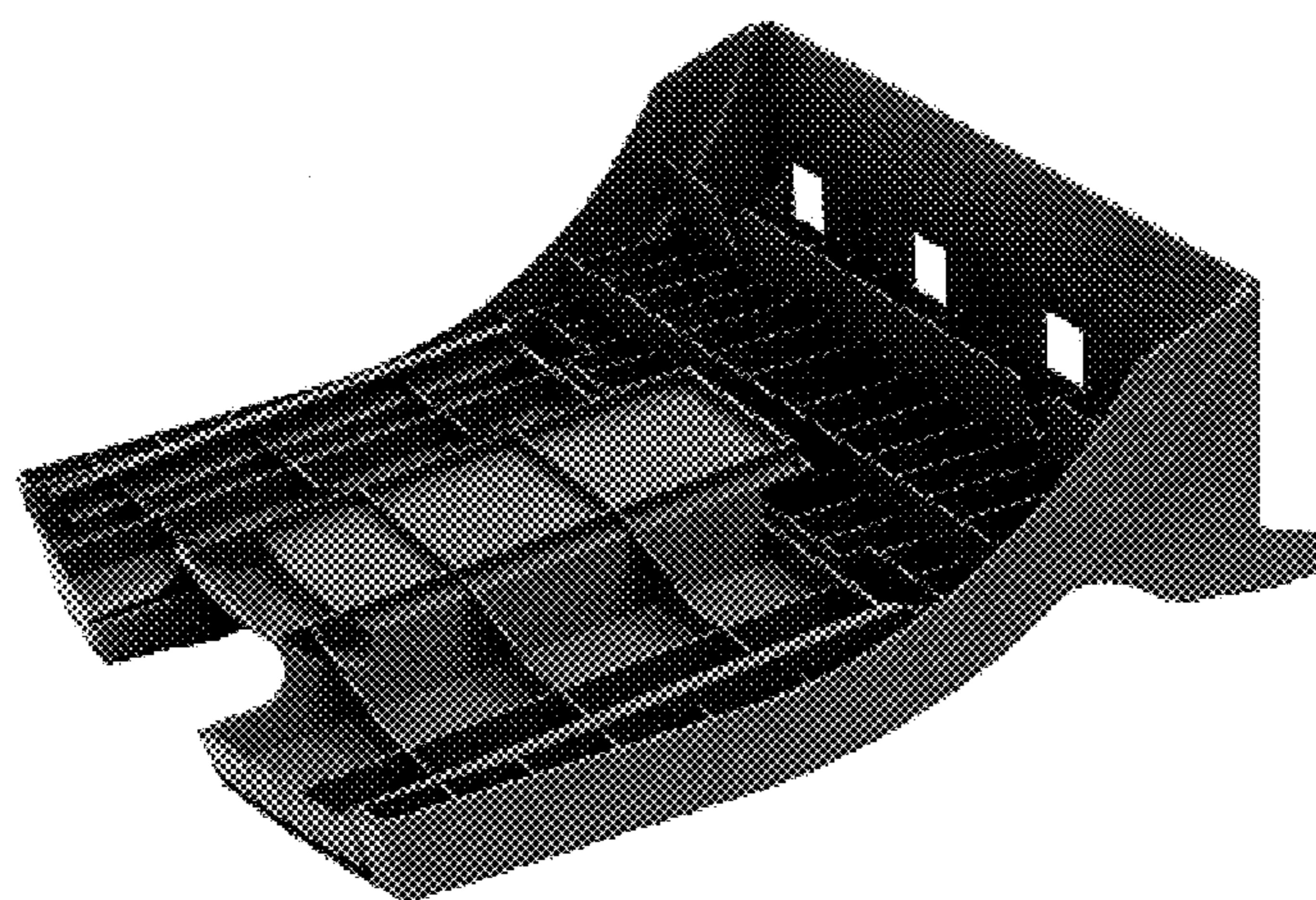

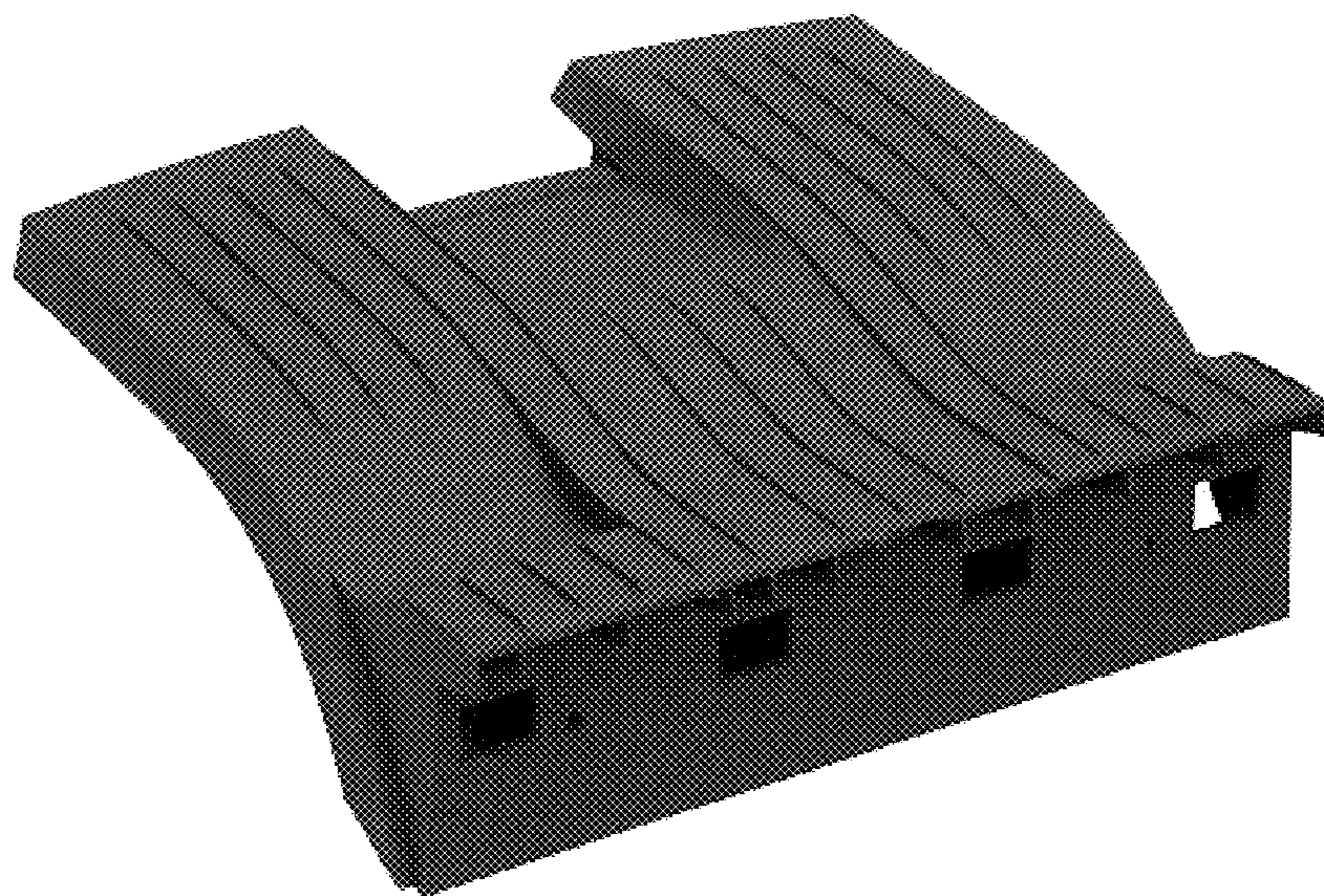

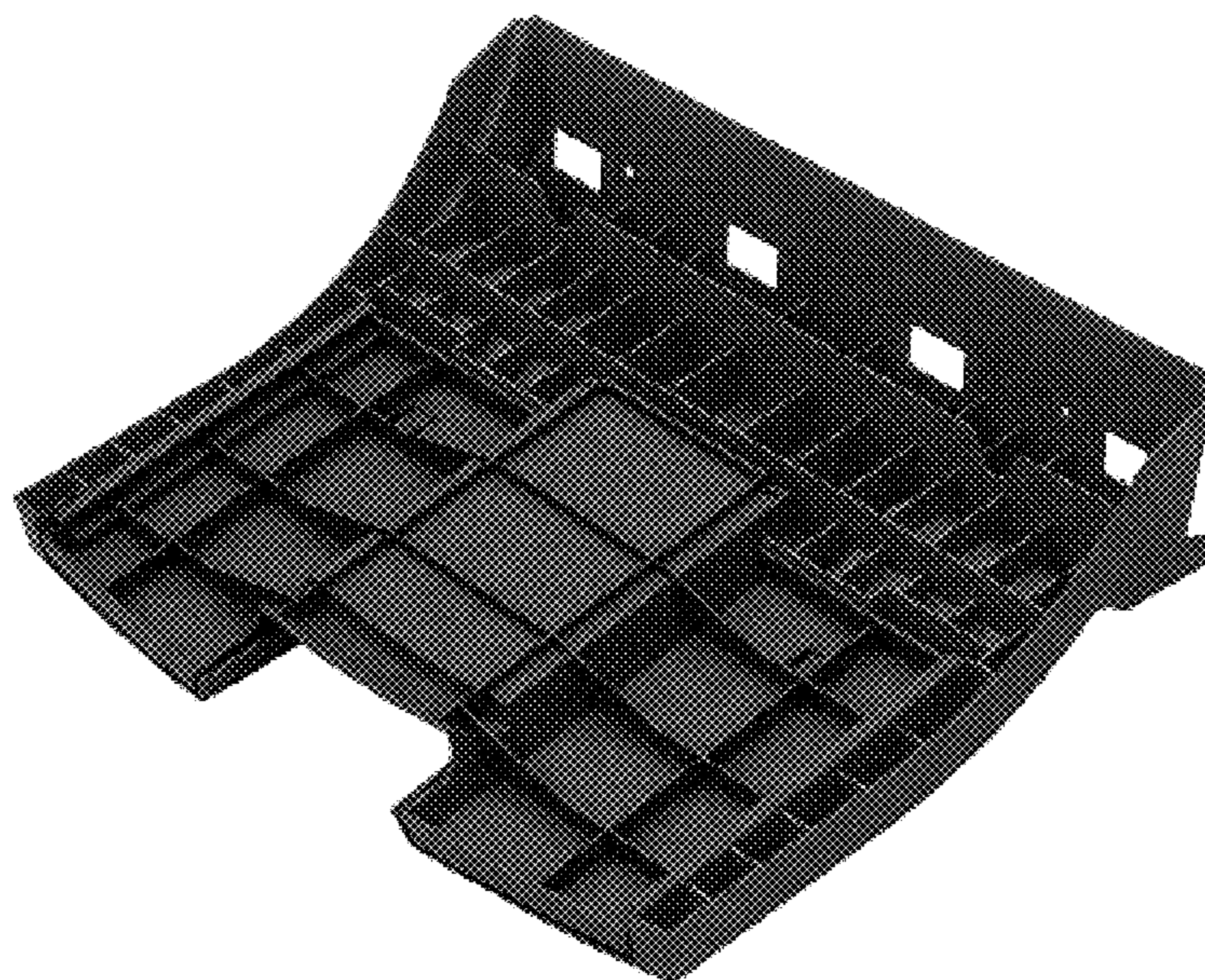

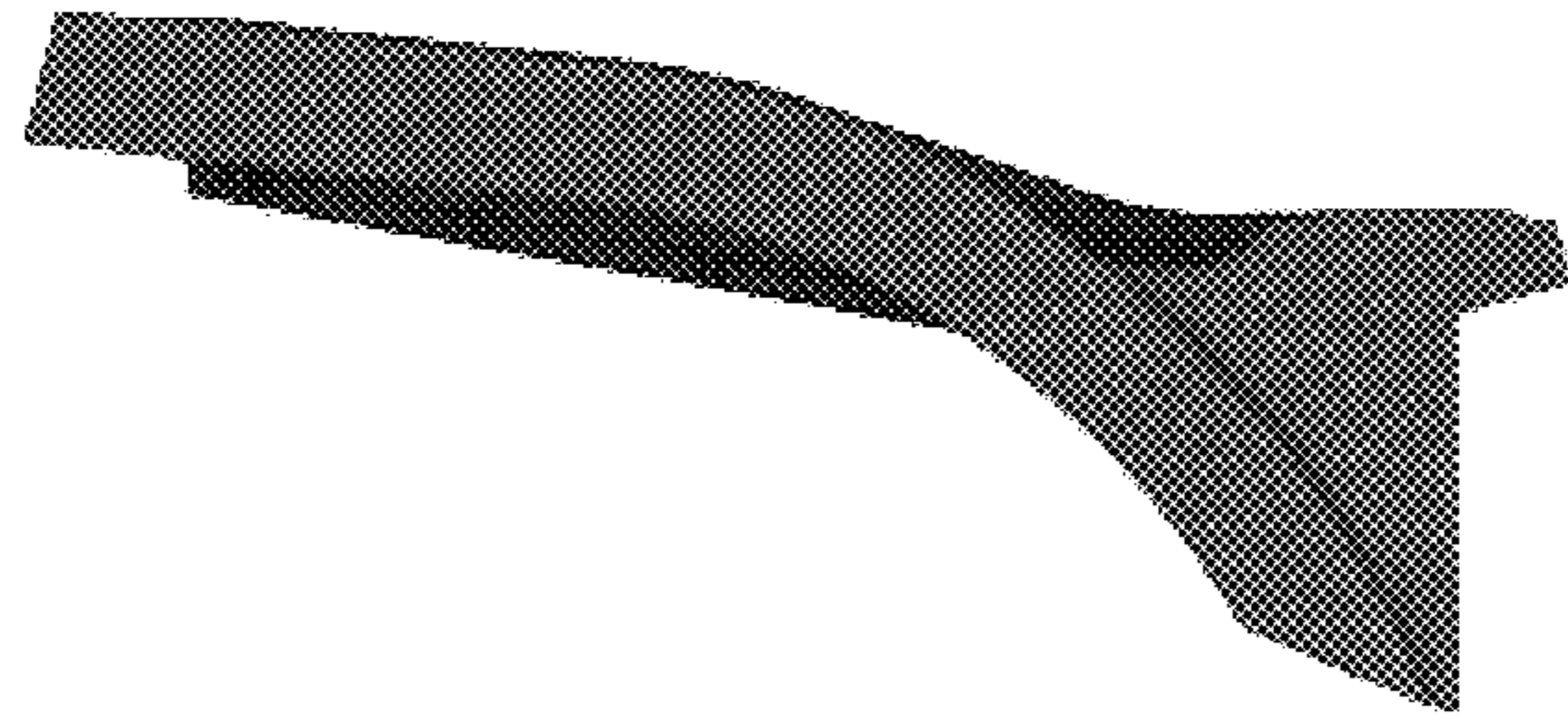

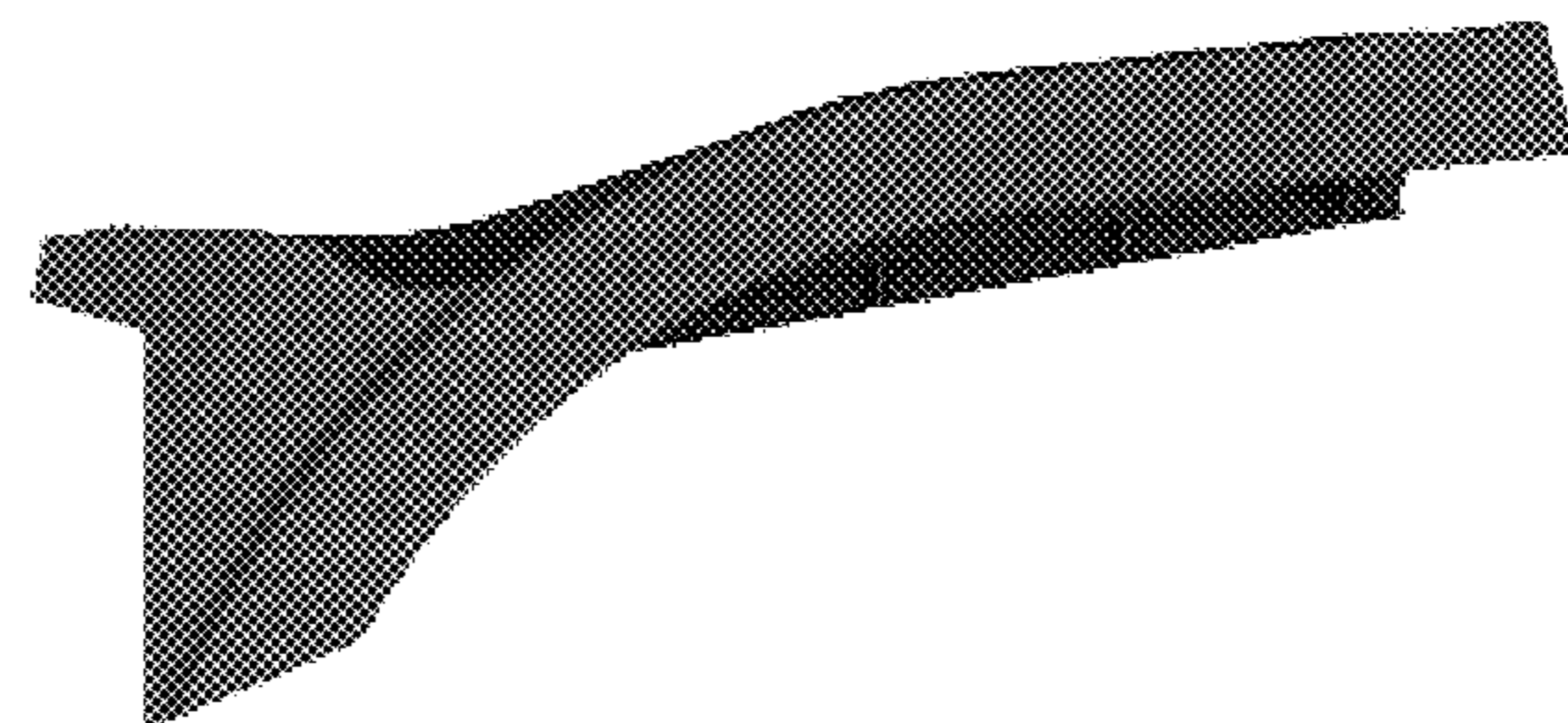

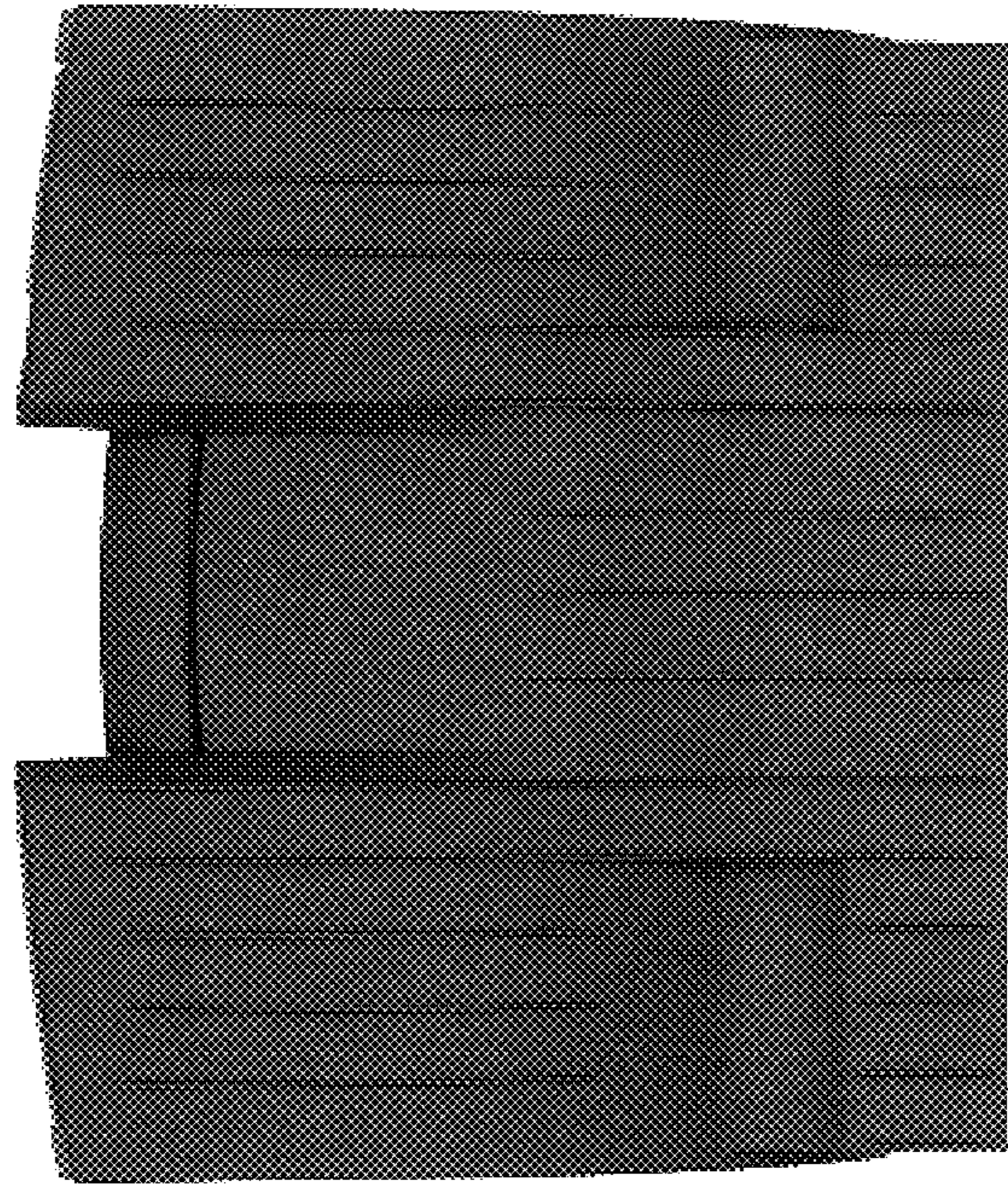

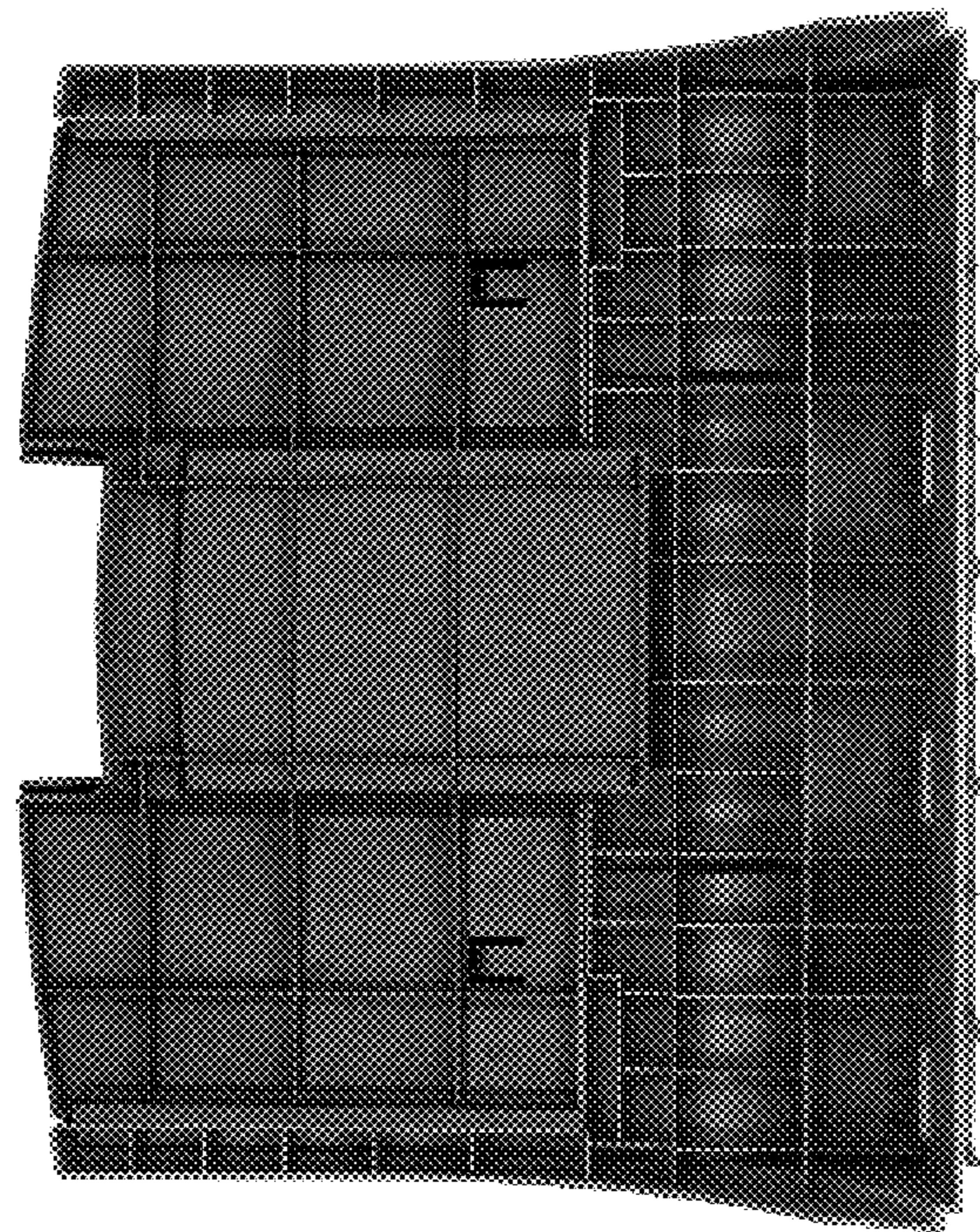

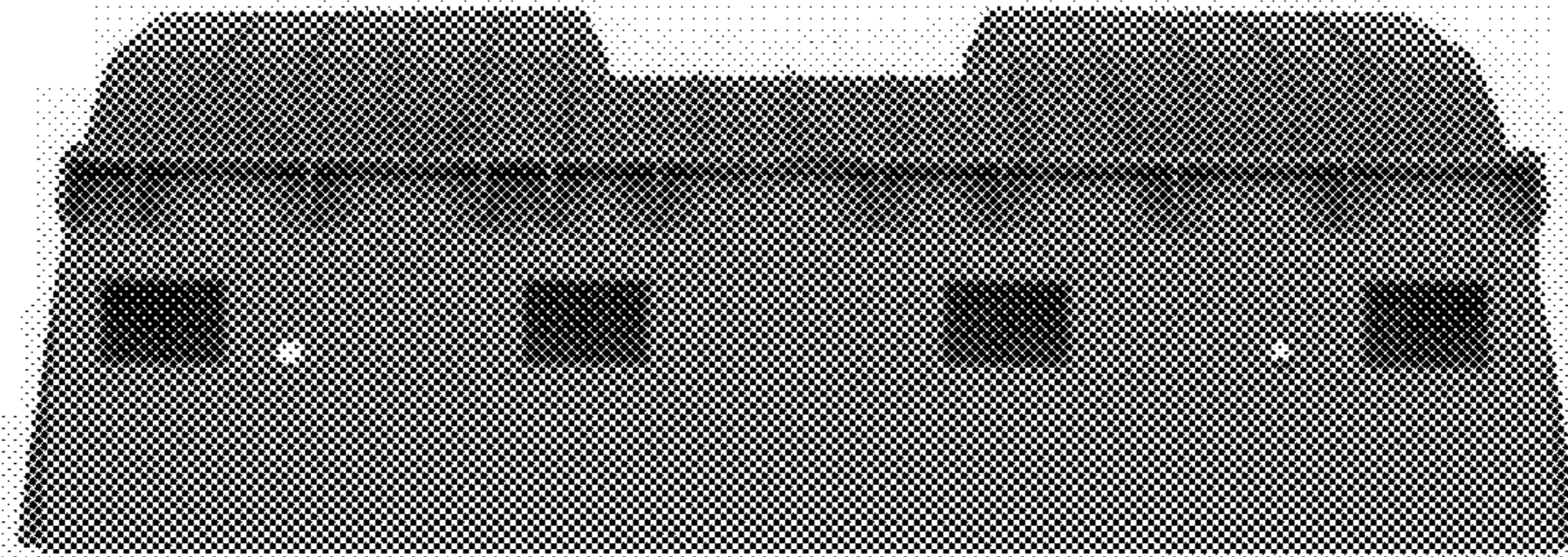
