FIG. 5 is a left side view of the exercise tube.

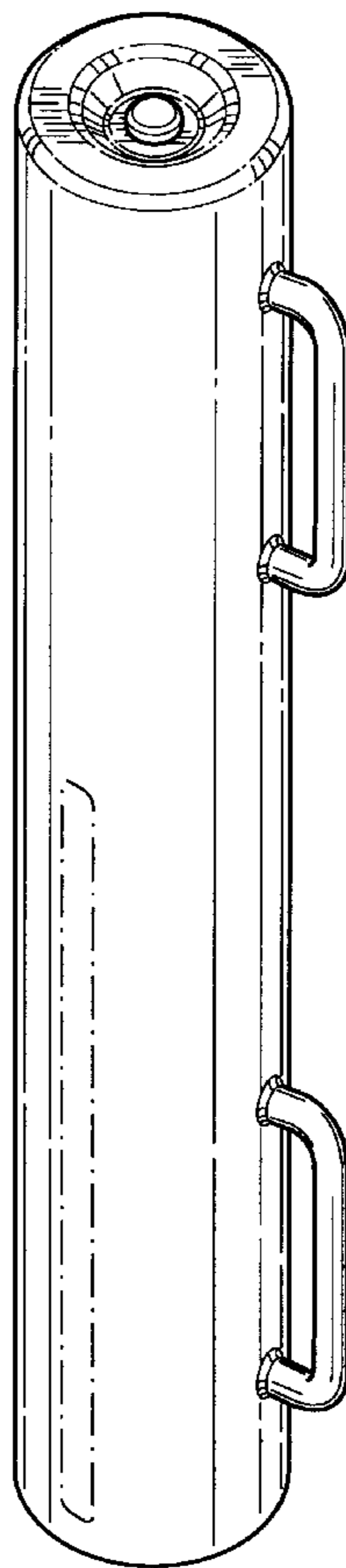
FIG. 6 is a back elevation view of the exercise tube.

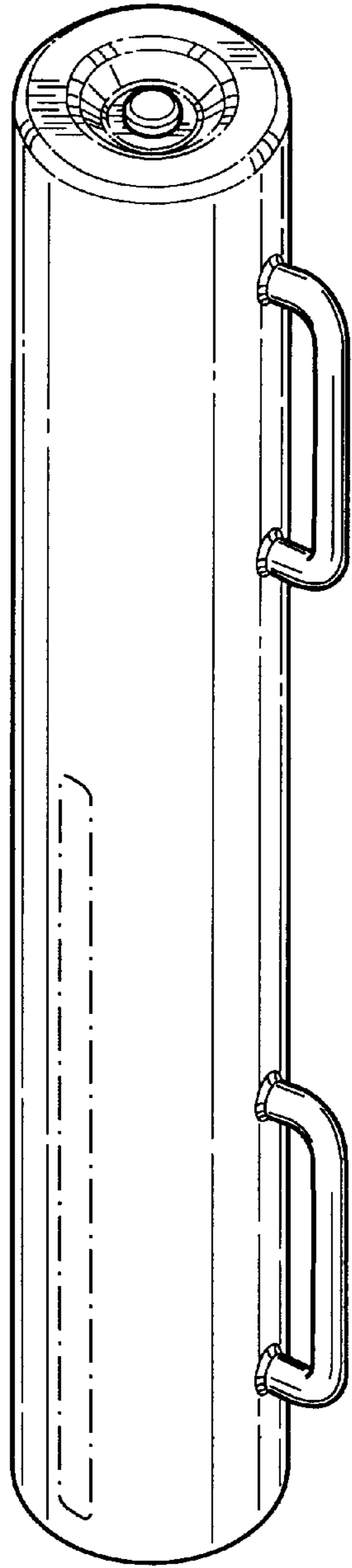

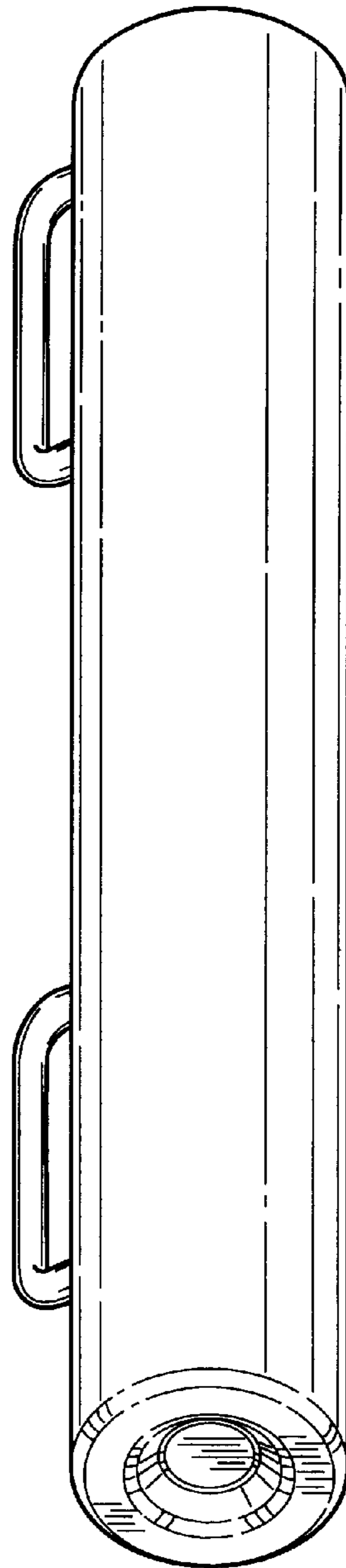

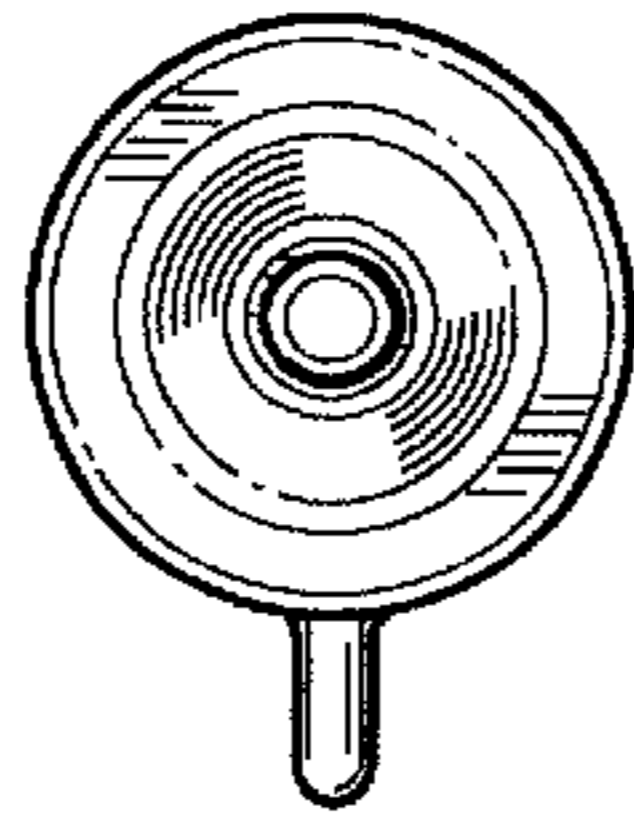

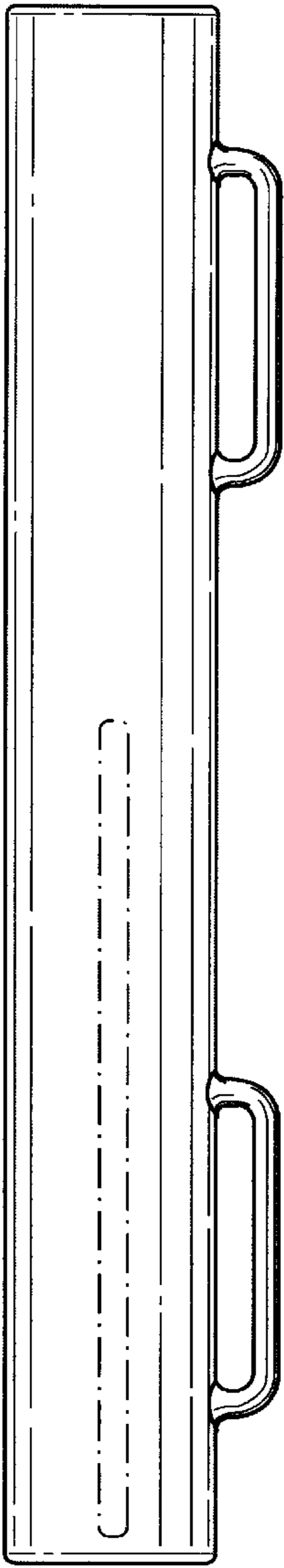

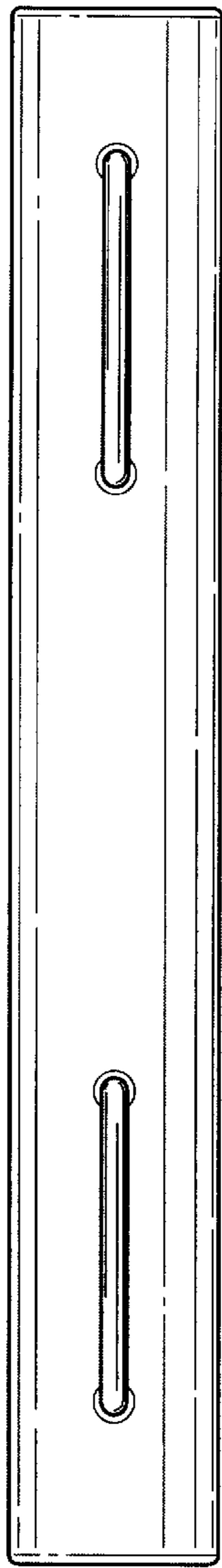

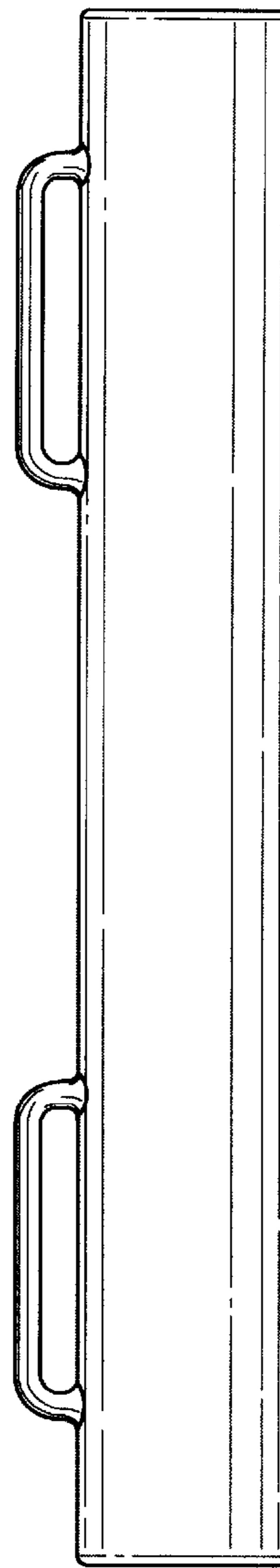

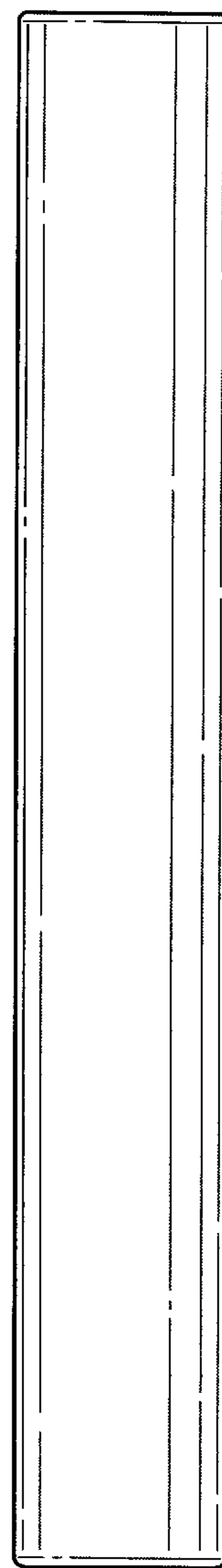

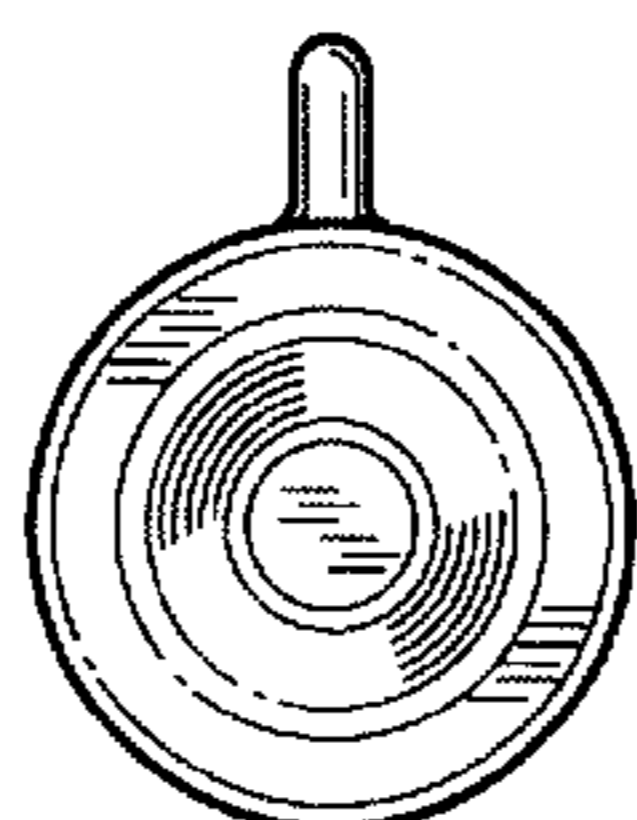
