FIG. 5 is a top side view of the four lamp capacity low profile light fixture as shown in FIG. 1; and,

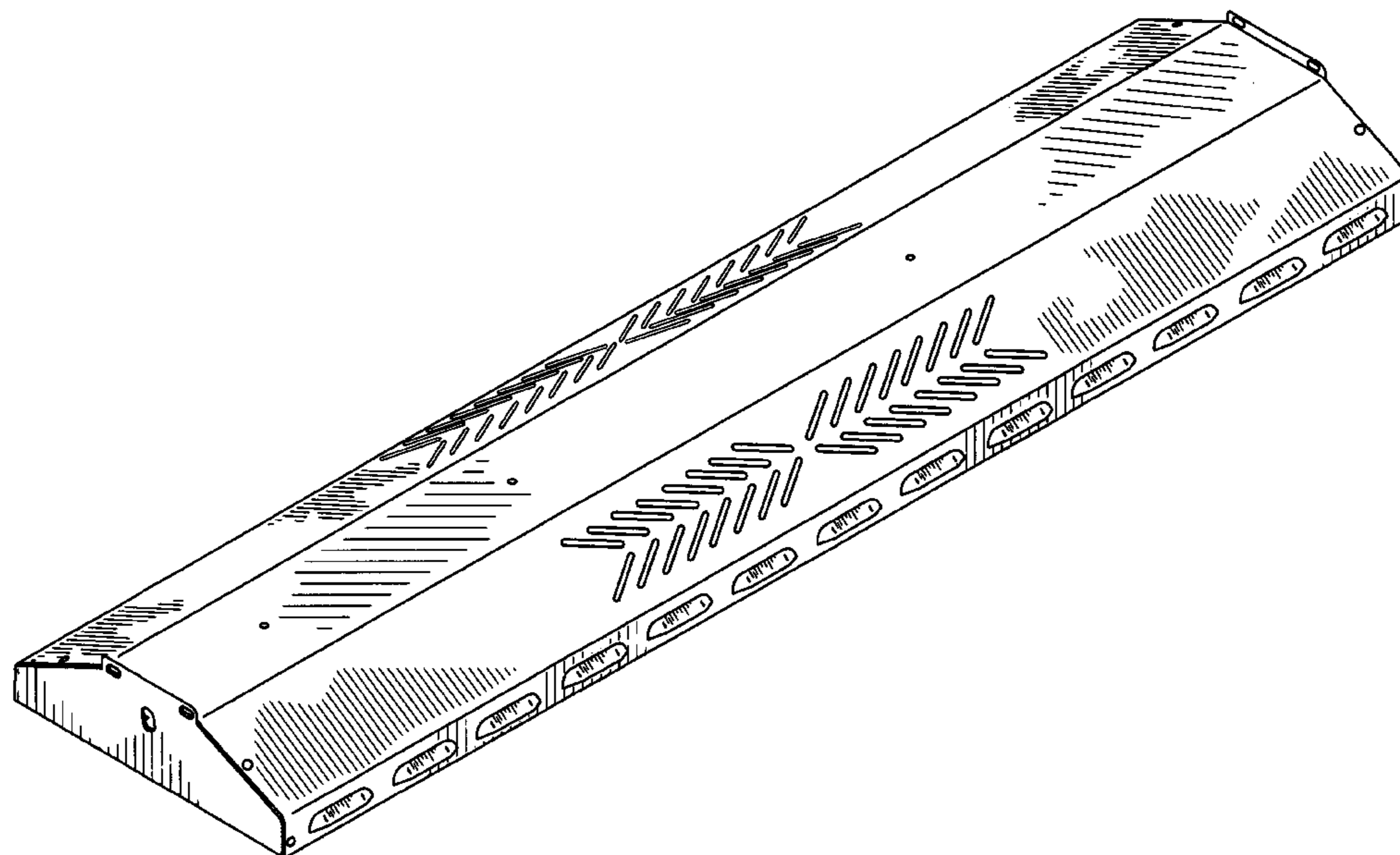
FIG. 6 is a bottom side view of the four lamp capacity low profile light fixture as shown in FIG. 1 further showing the new design.

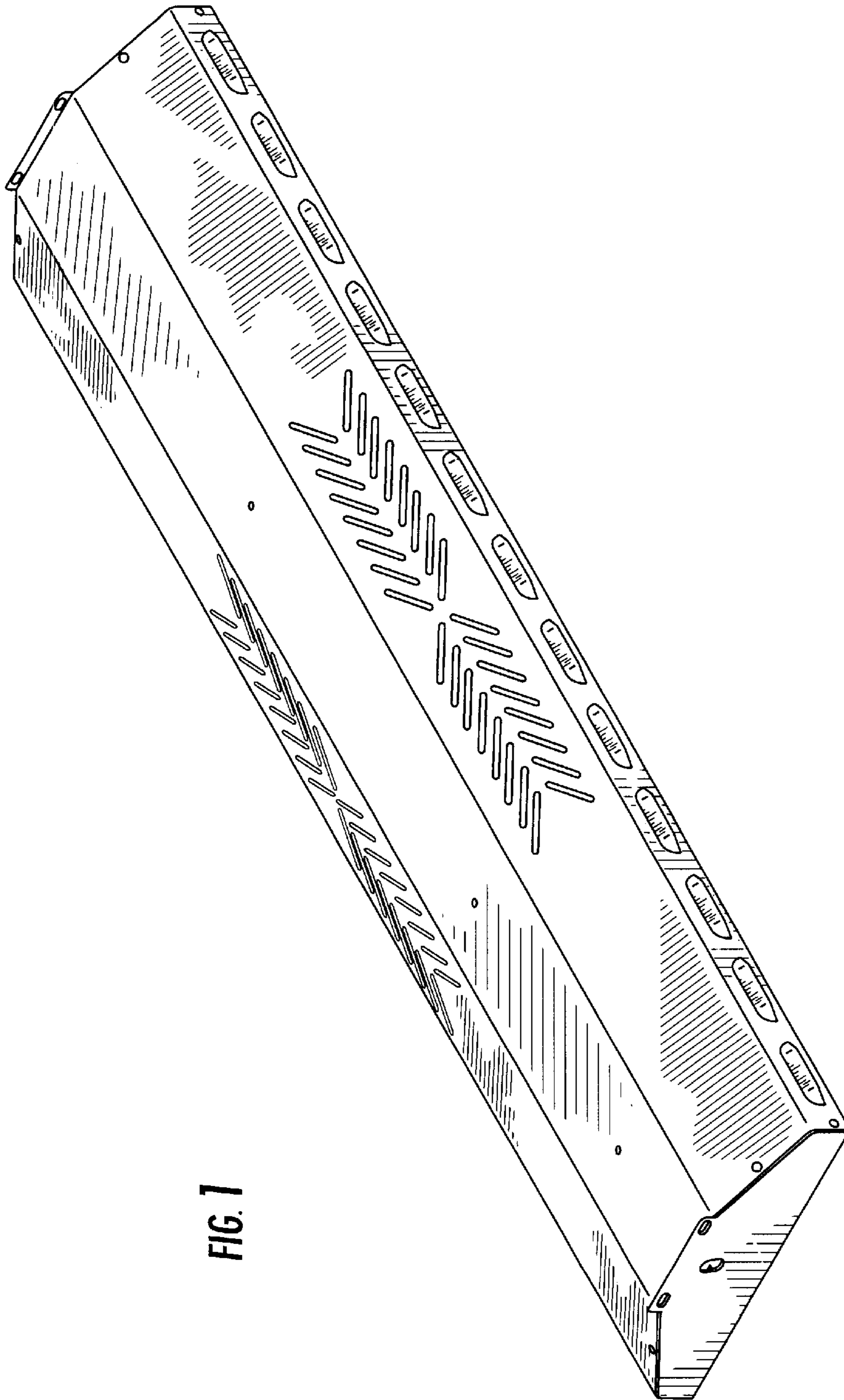

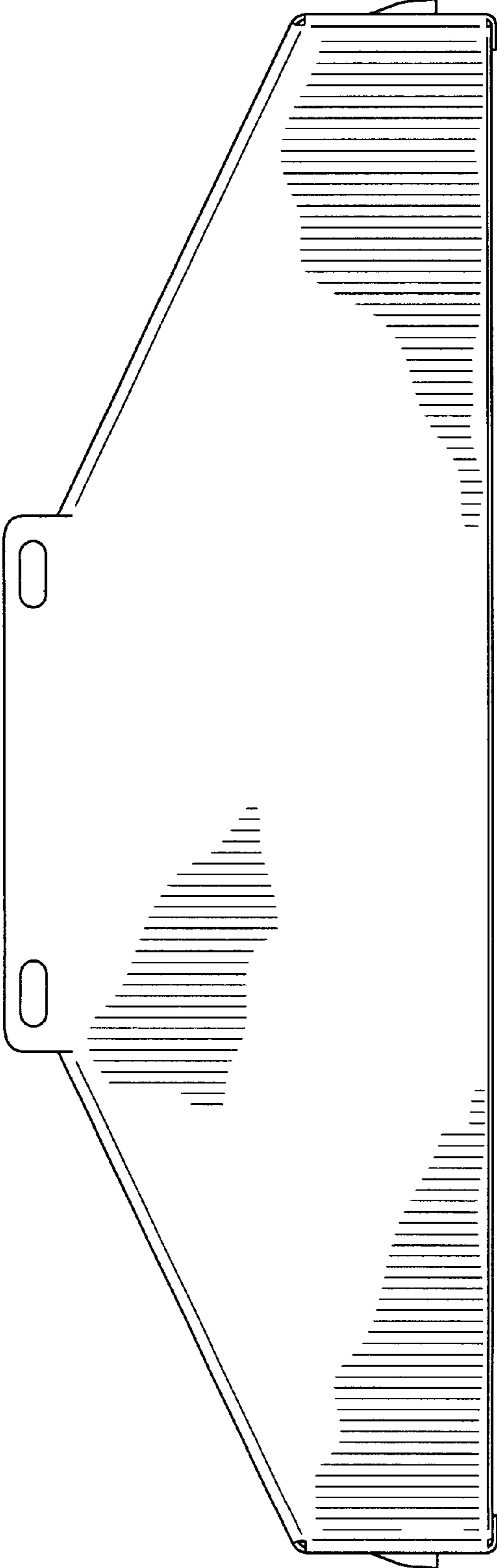

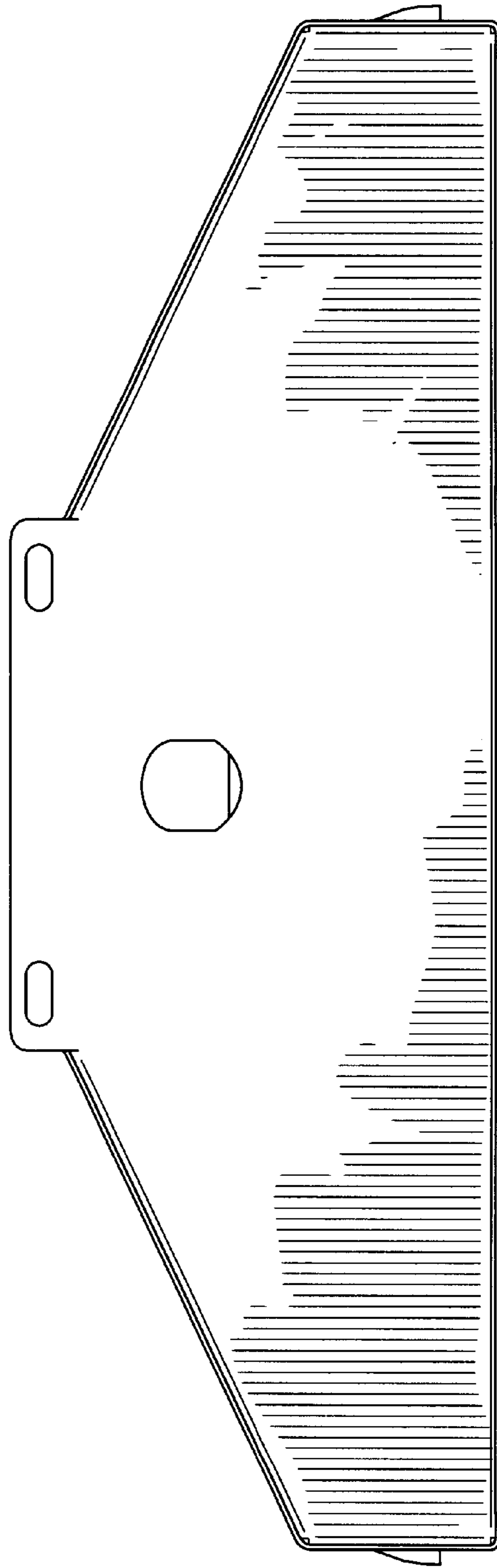

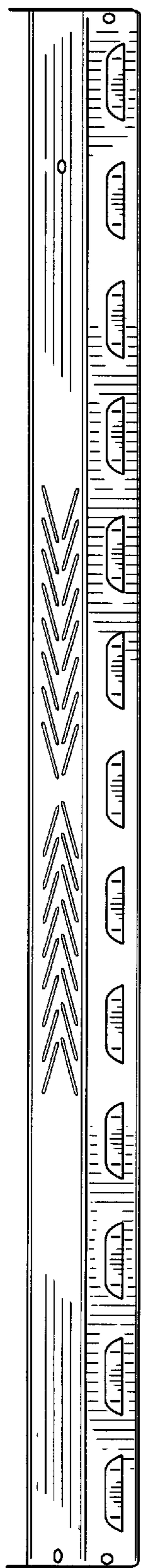

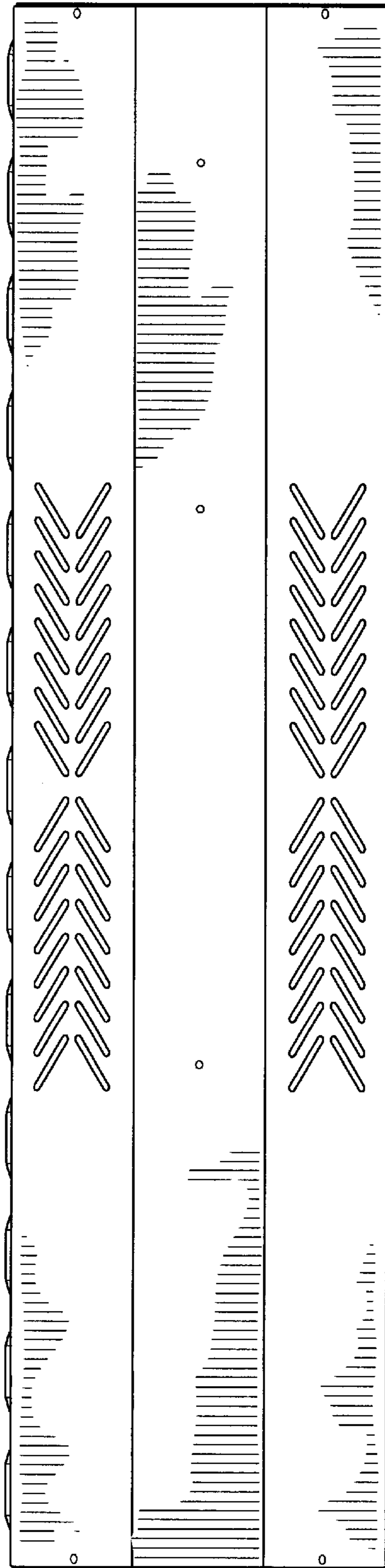

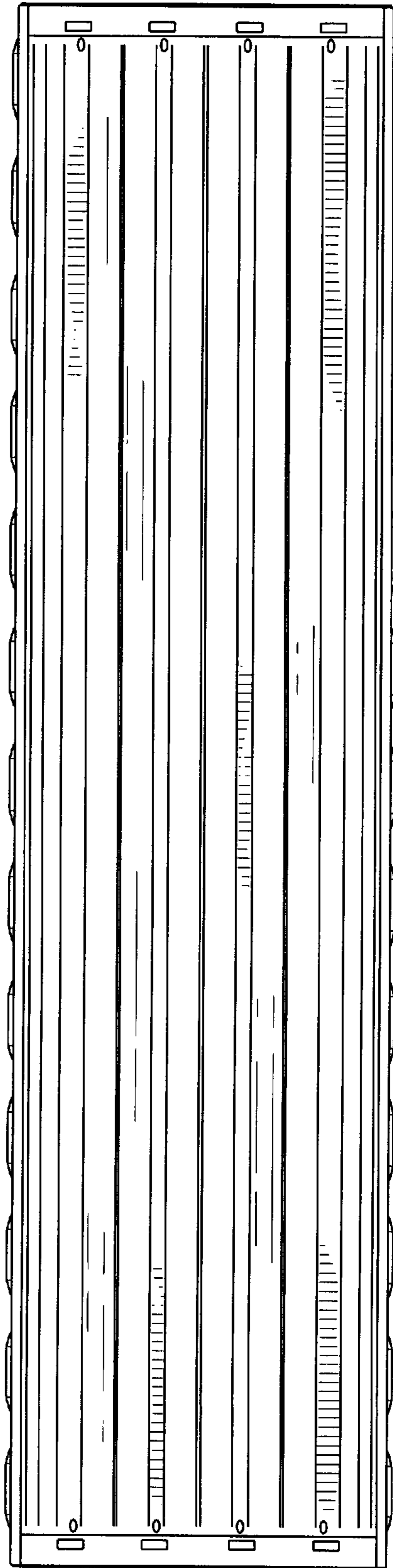
