DESCRIPTION

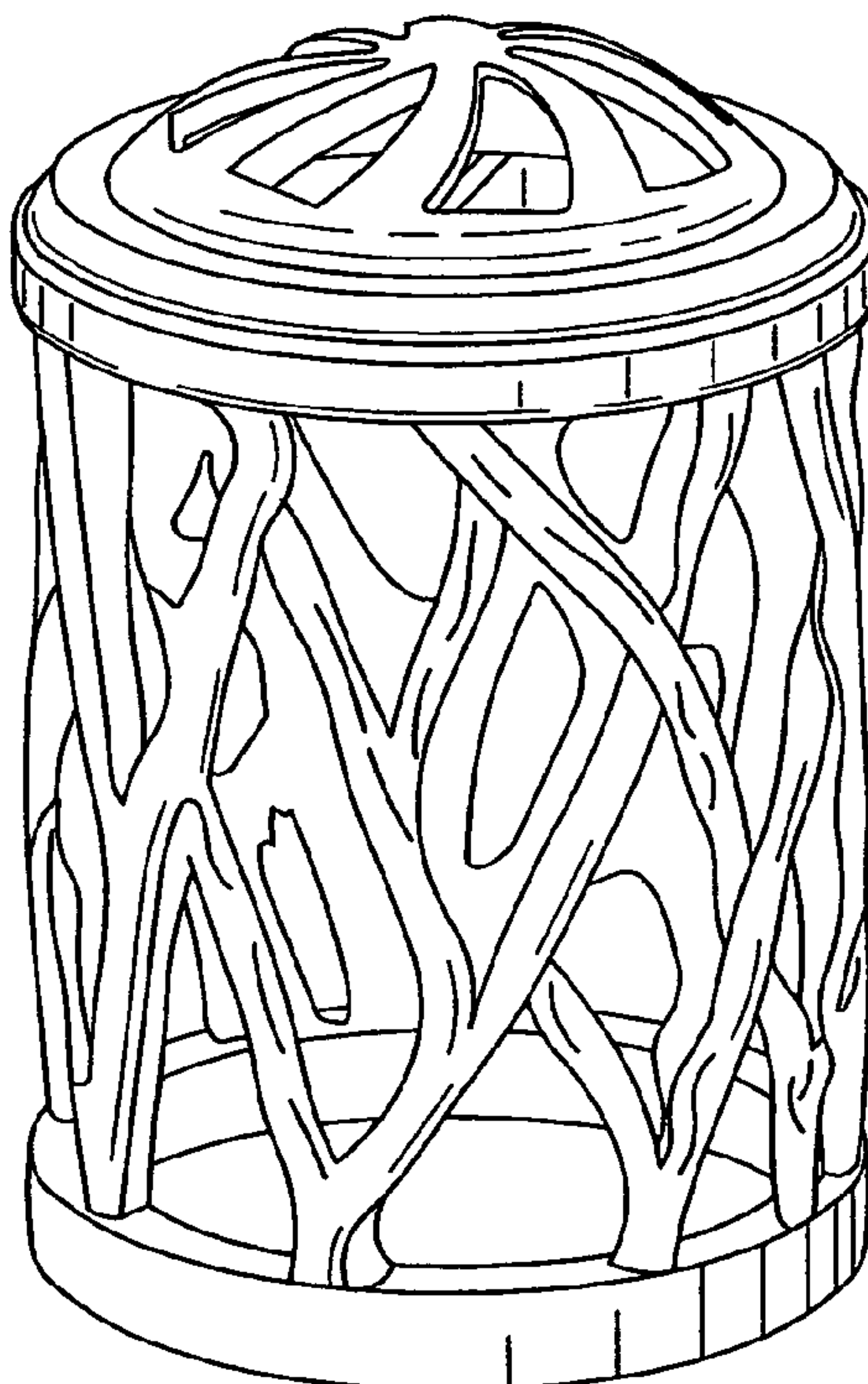
FIG. 1 is a perspective view of effusion lamp topper showing

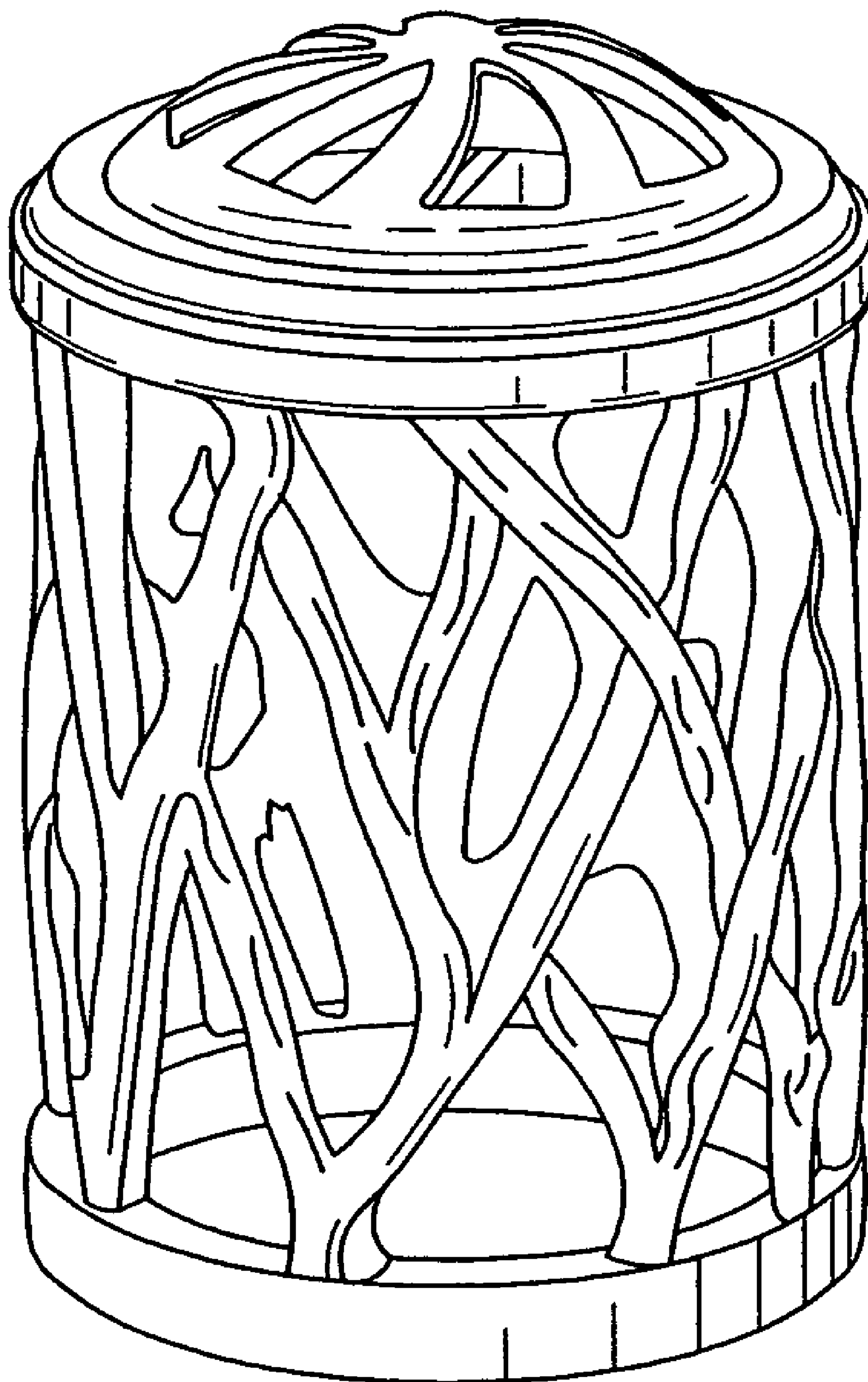

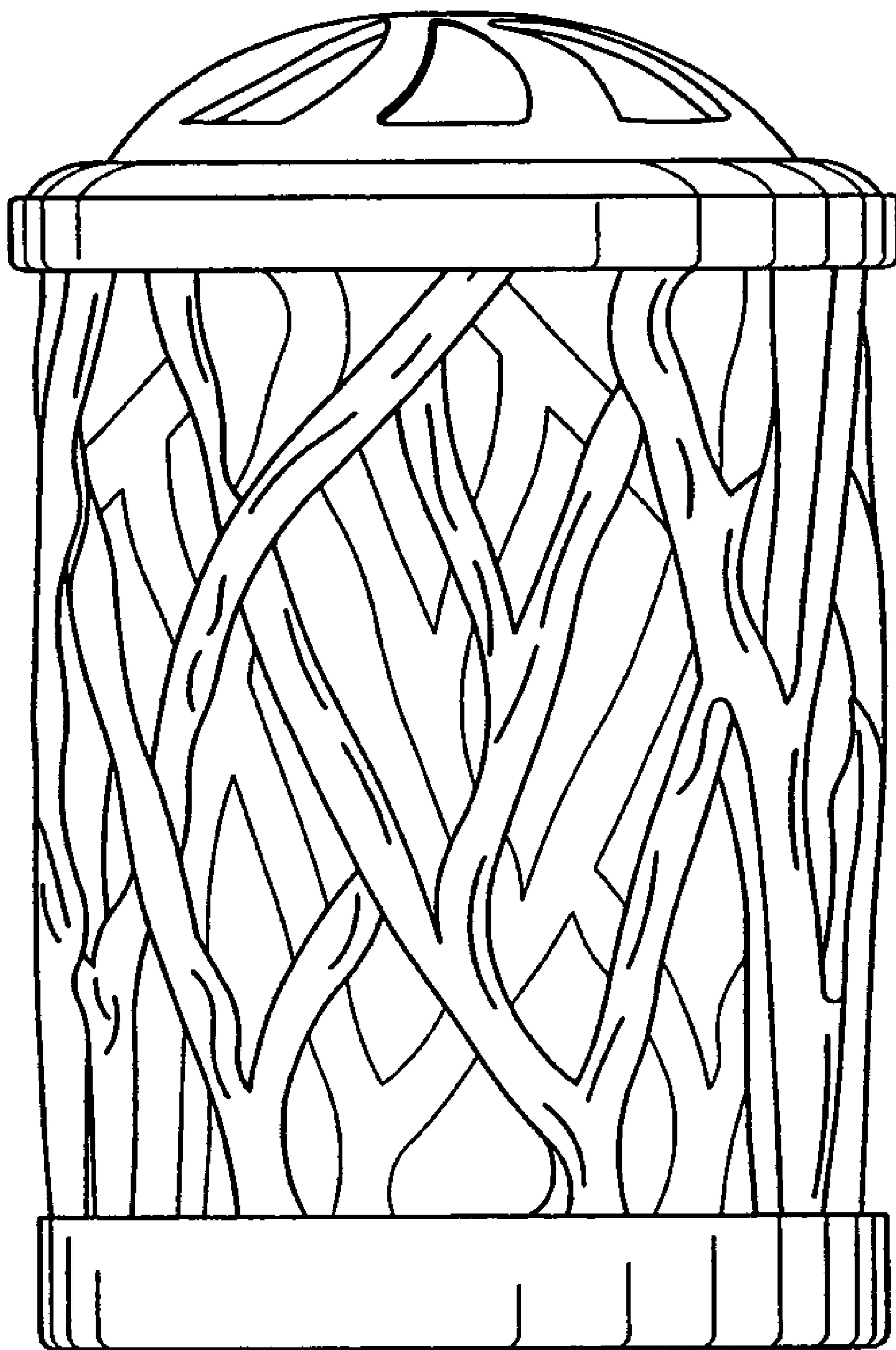

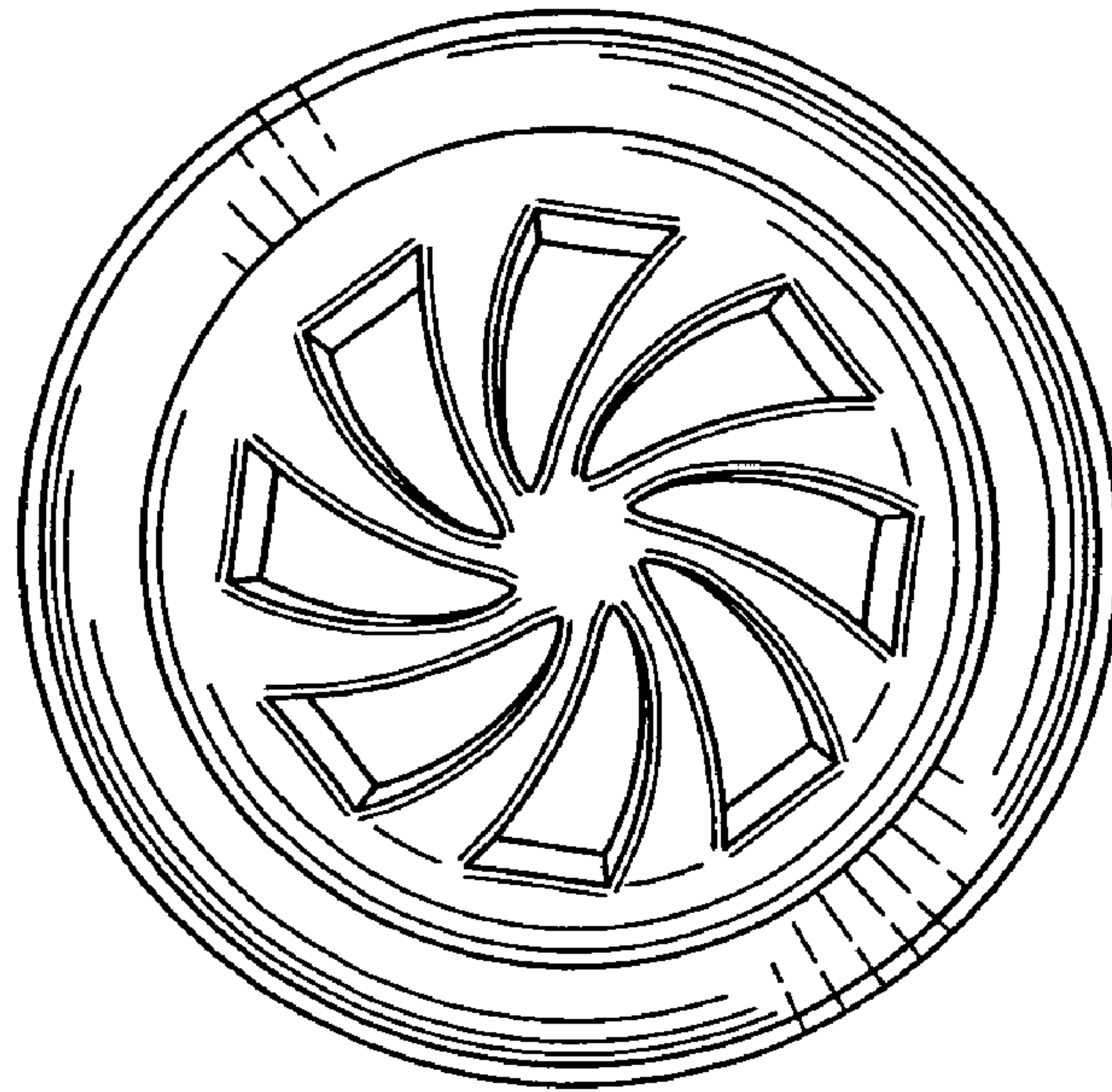

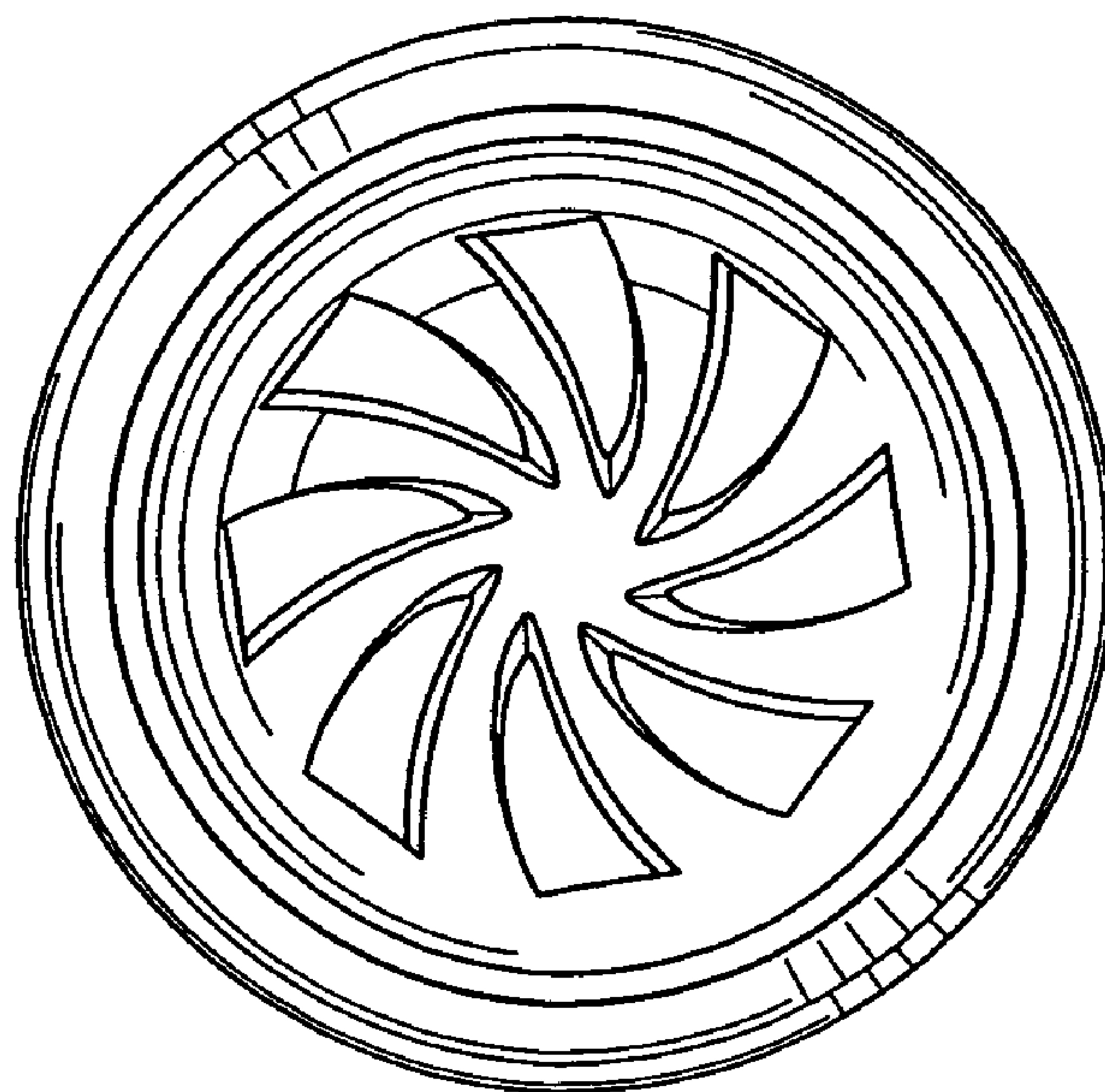
