The ornamental design for a floor cleaning device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a floor cleaning device showing the new design;

FIG. 2 is a left side view thereof, the right side view thereof being a mirror image of the left side view shown view thereof;

FIG. 3 is a top view thereof;

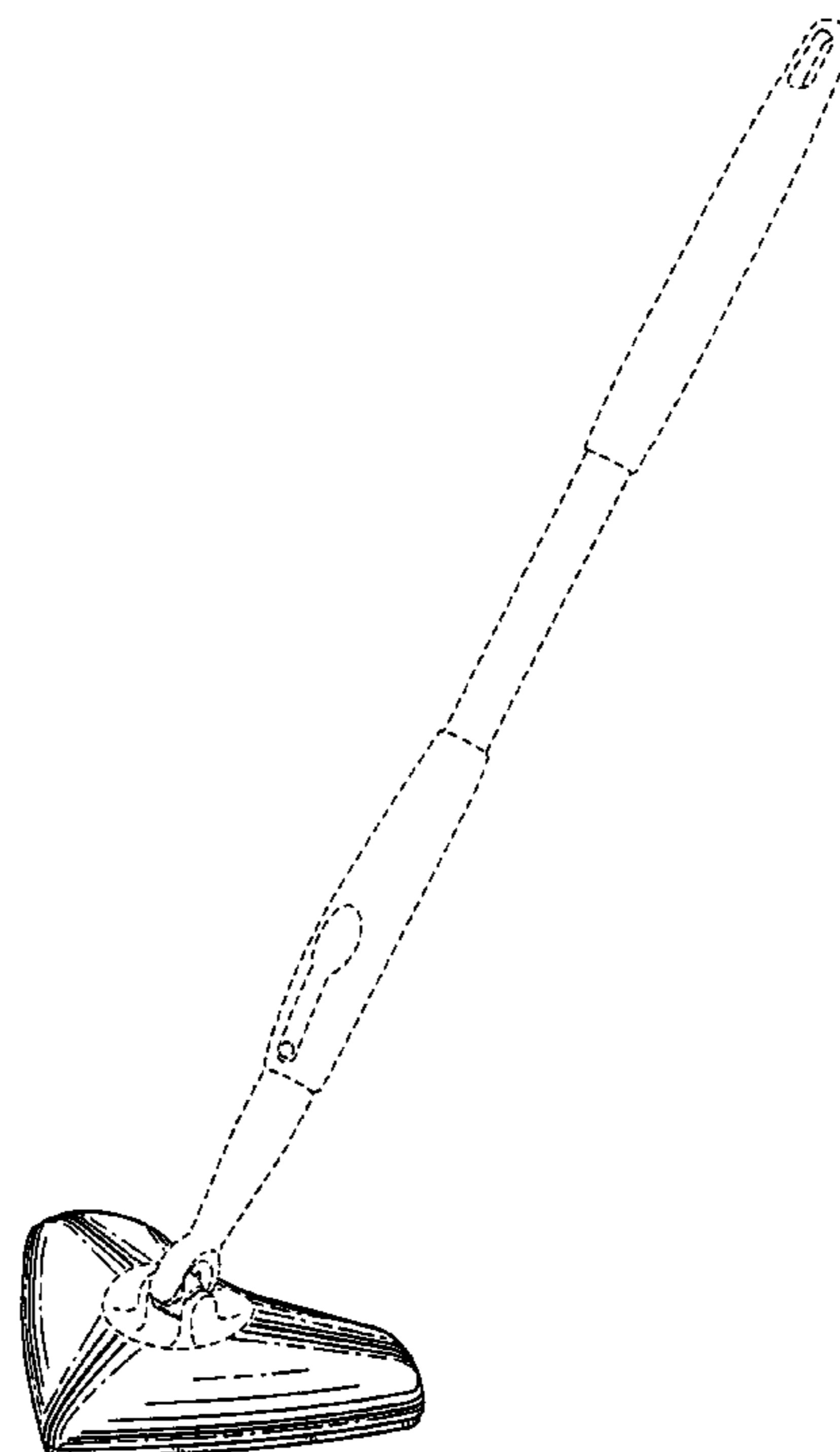
FIG. 4 is a bottom view thereof;

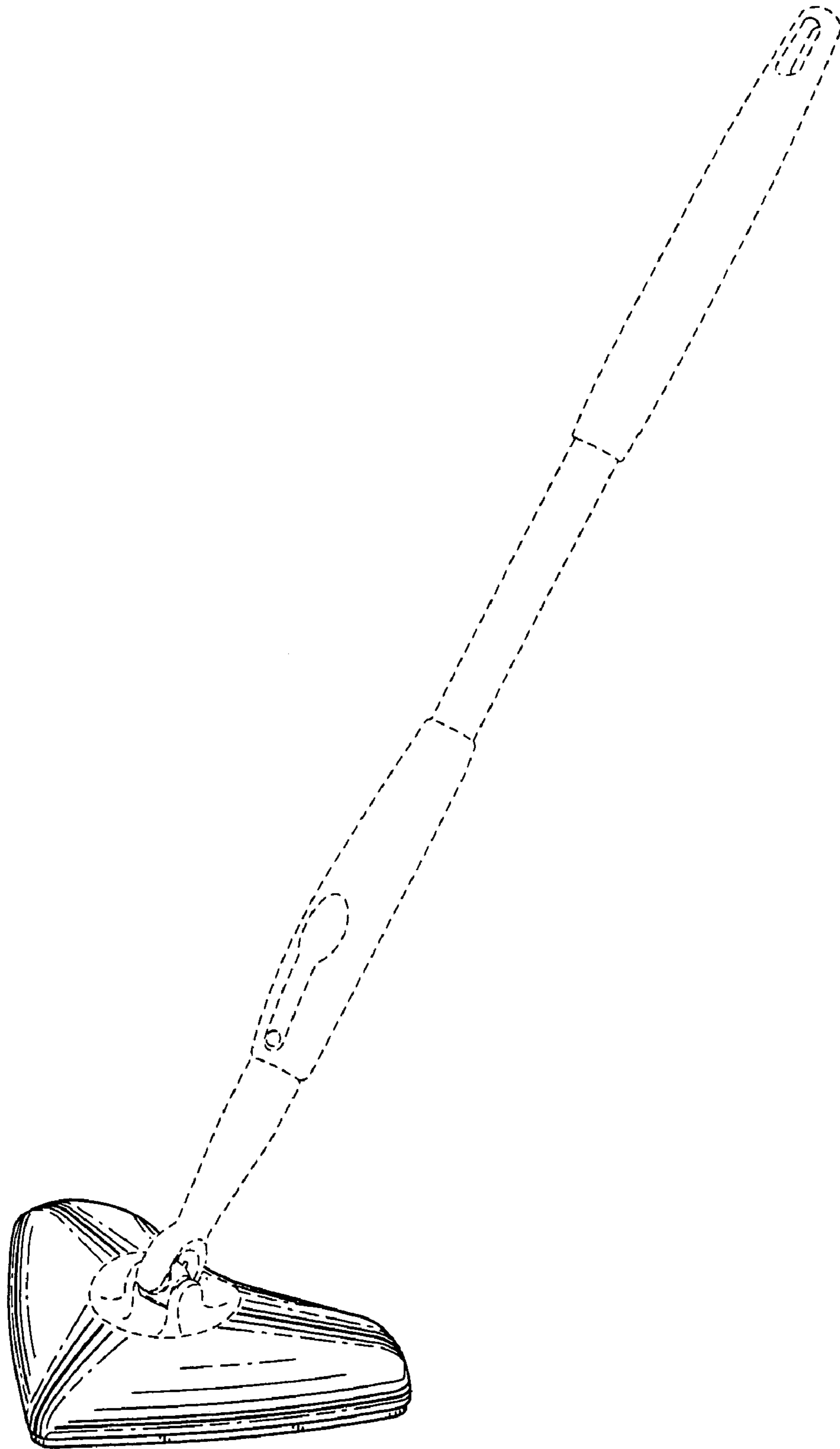

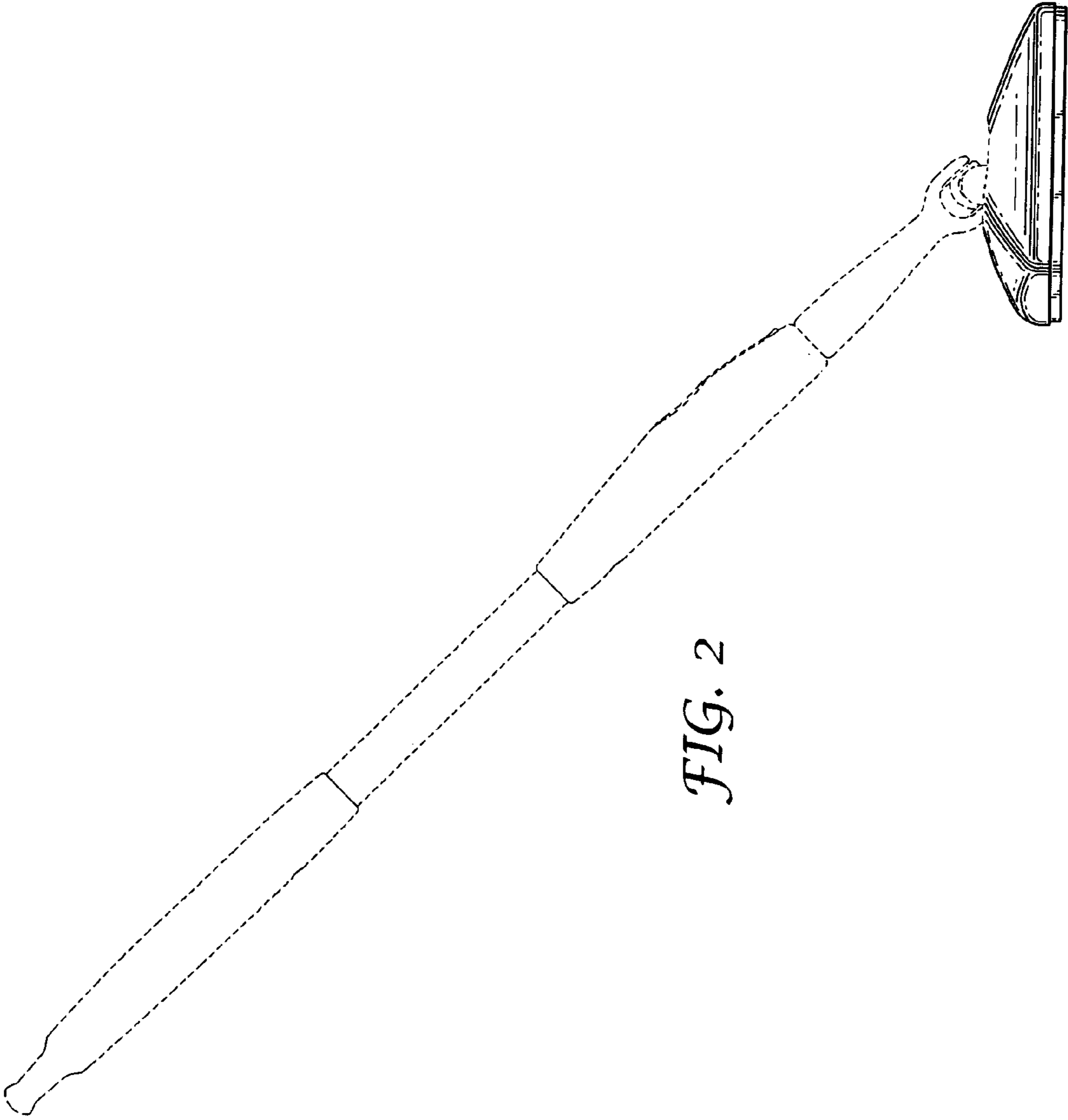

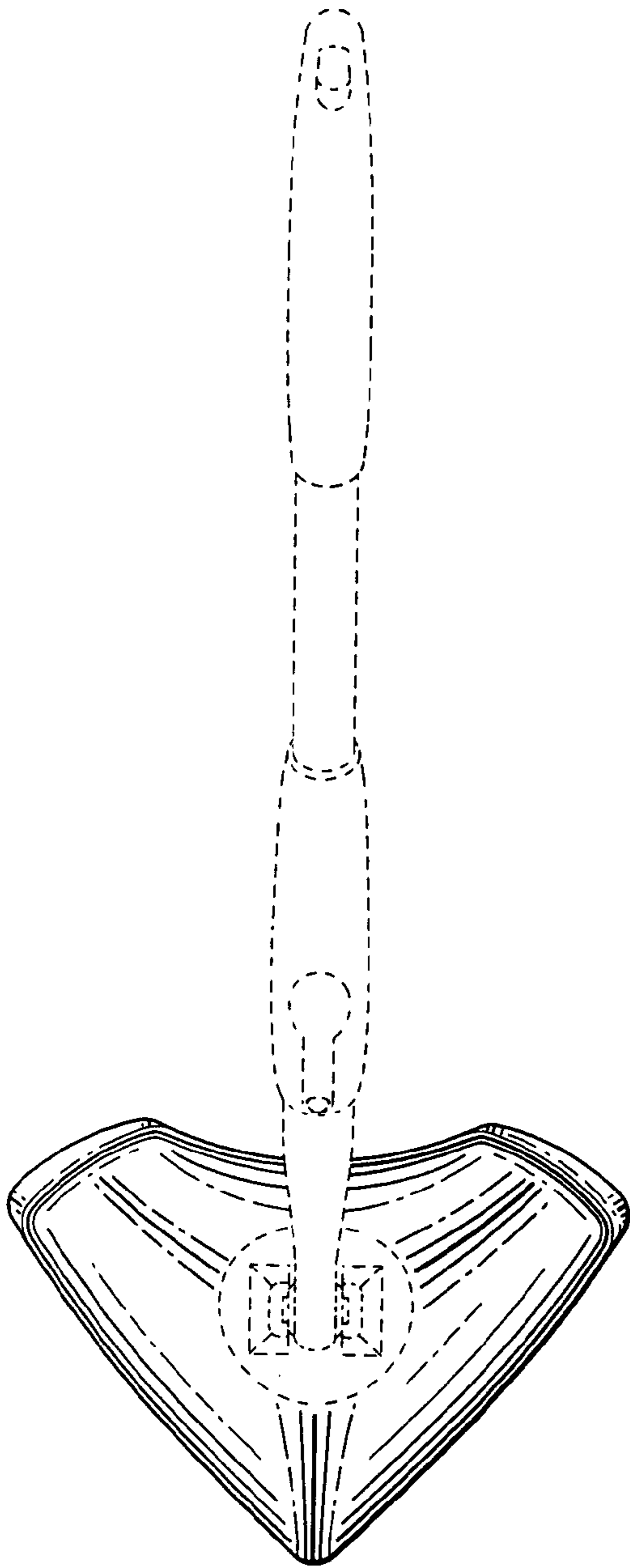

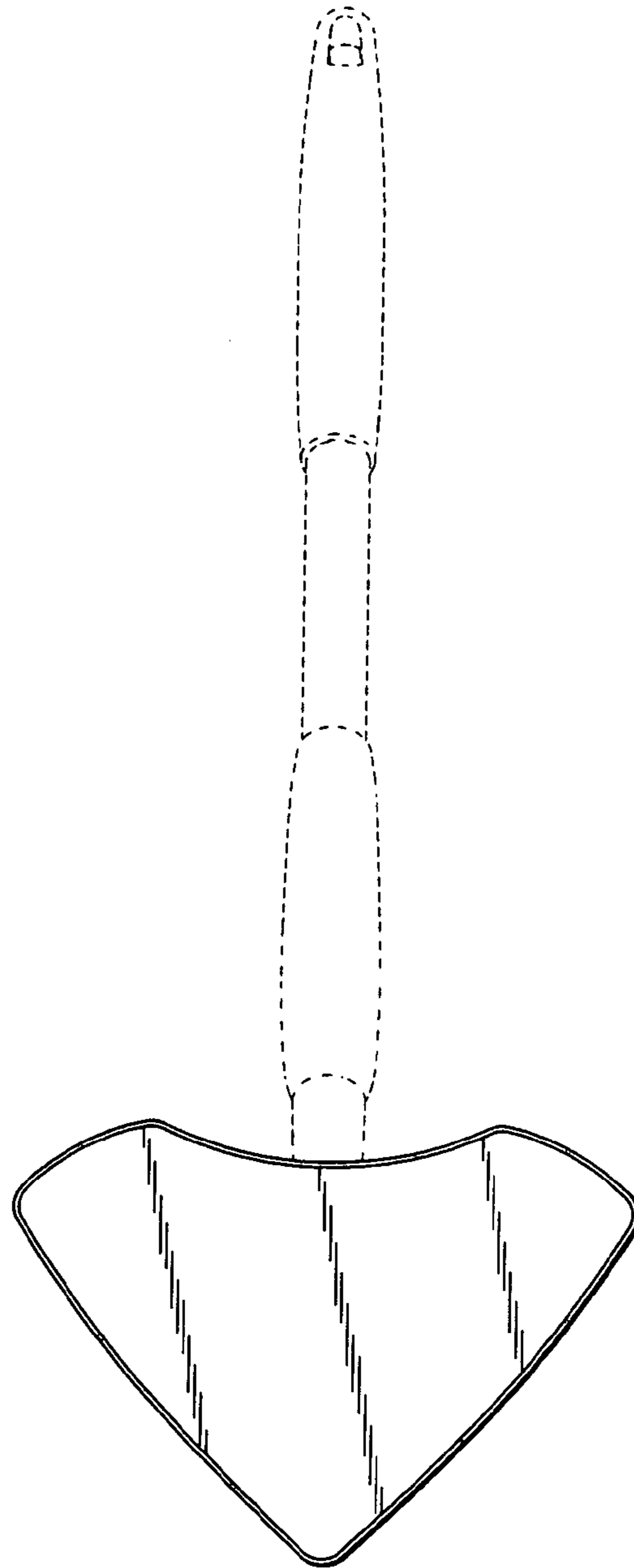

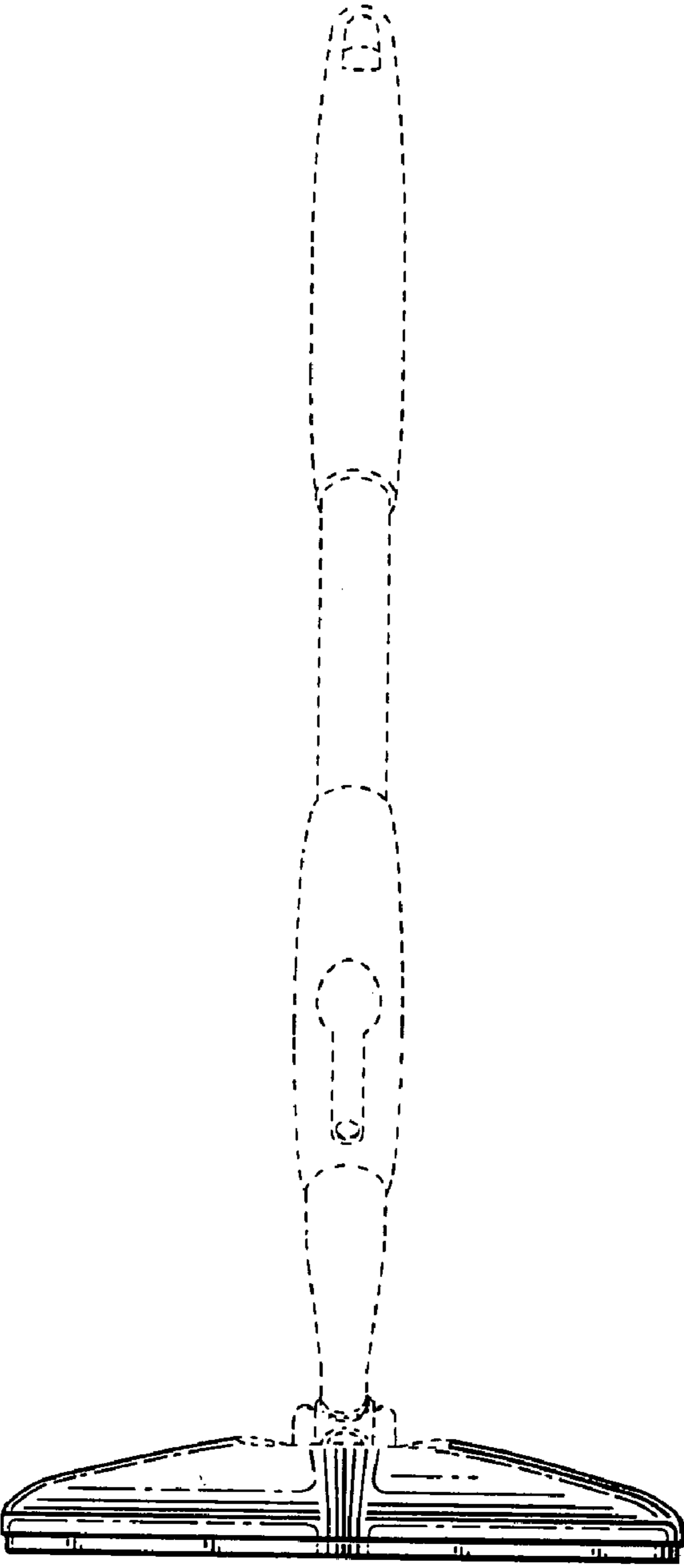

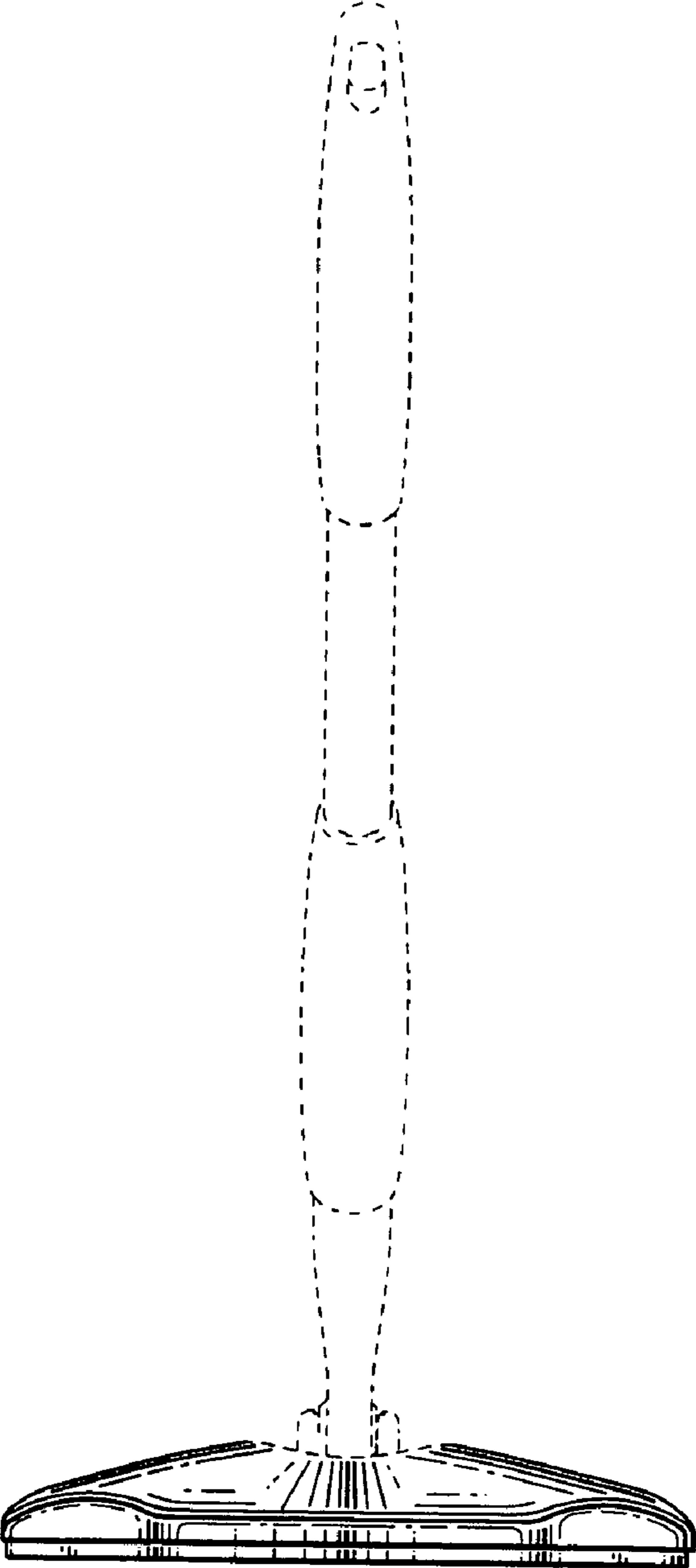
