(57) **CLAIM**

The ornamental design for a swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a swimsuit.

FIG. 2 is top view of the swimsuit of FIG. 1.

FIG. 3 is a front view of the swimsuit of FIG. 1.

FIG. 4 is a right side view of the swimsuit of FIG. 1.

FIG. 5 is a rear view of the swimsuit of FIG. 1.

FIG. 6 is a perspective view of the swimsuit of FIG. 1 with a front flap raised.

FIG. 7 is a perspective view of the swimsuit of FIG. 1 with a front flap raised and side tabs opened; and,

FIG. 8 is a perspective view of the swimsuit of FIG. 1 with a front flap raised and tabs in an alternate position.

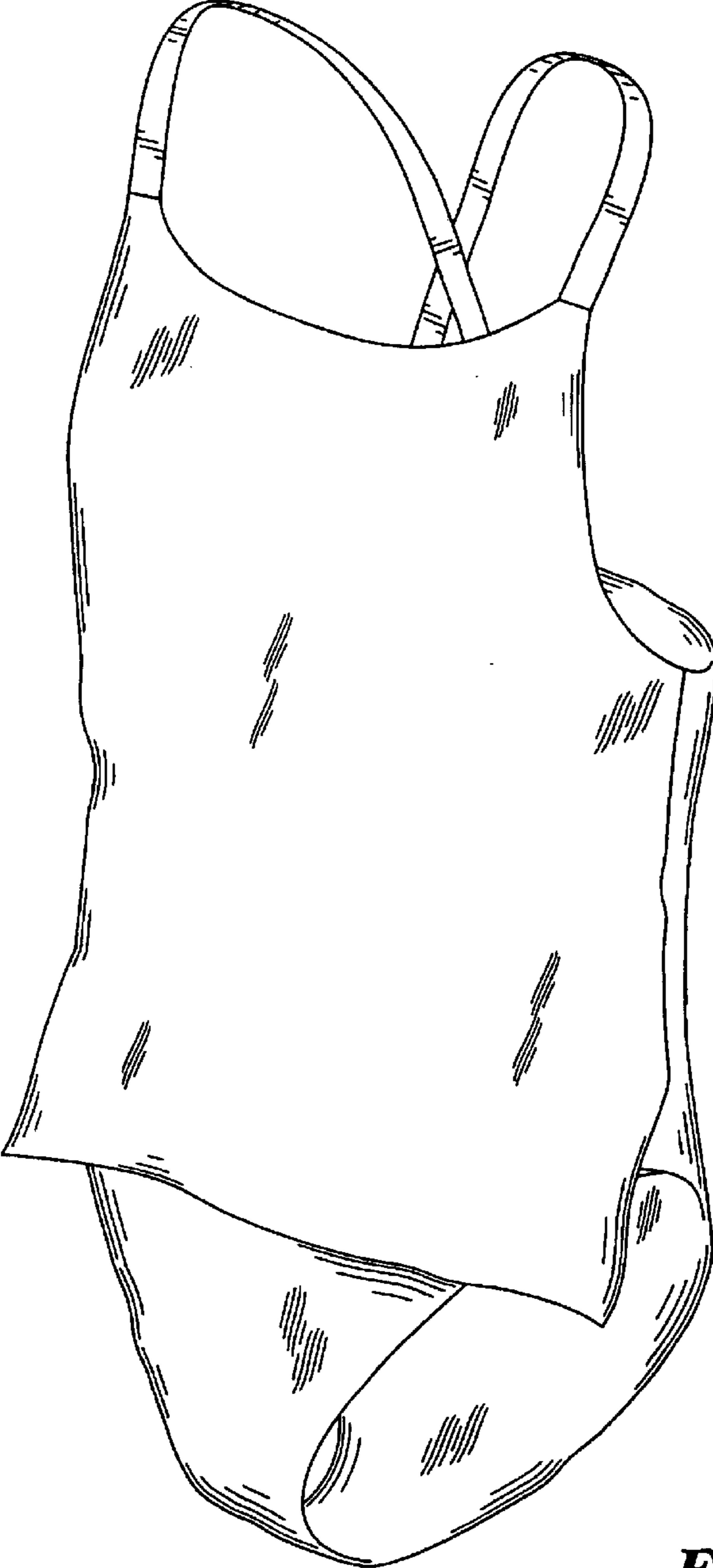

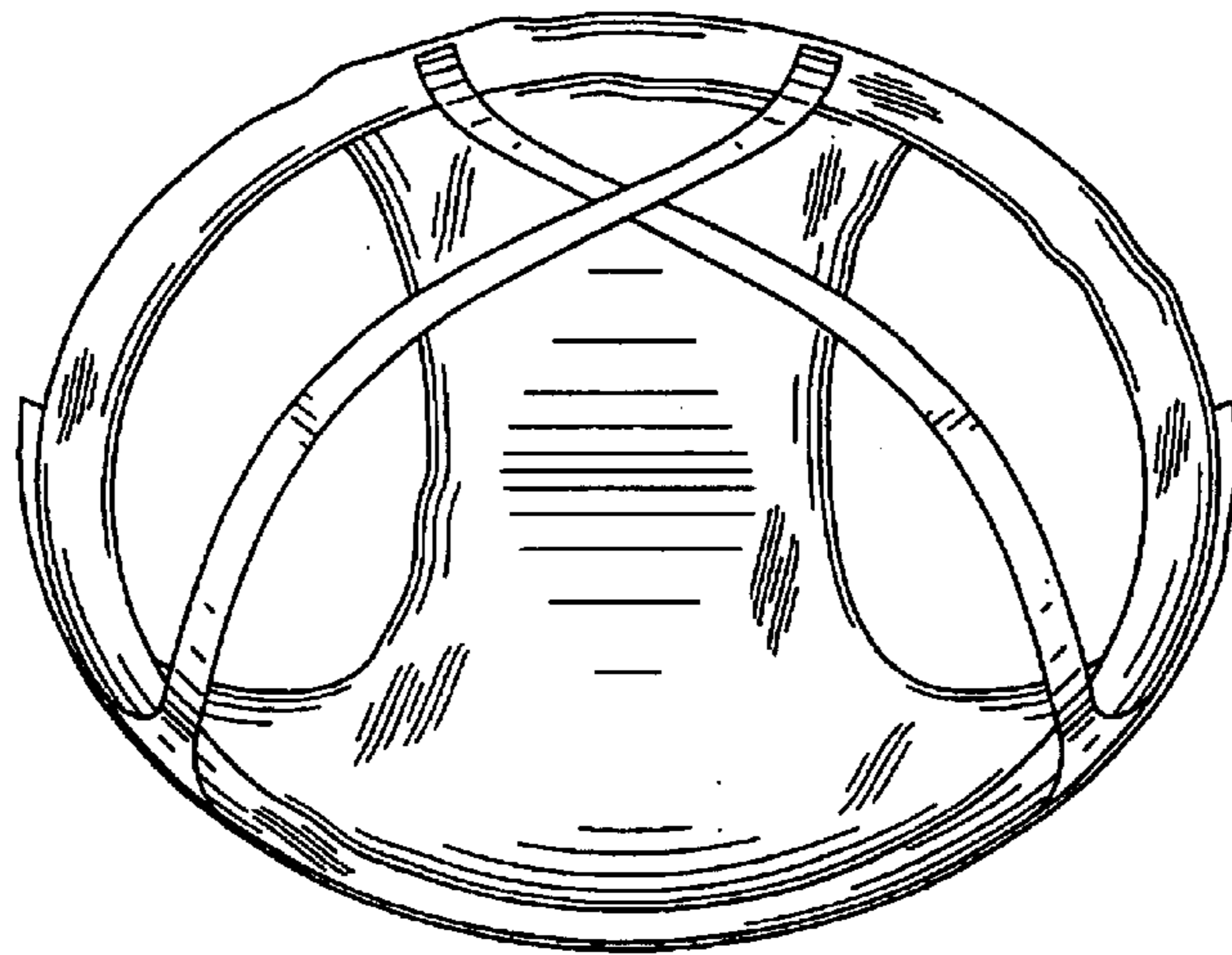

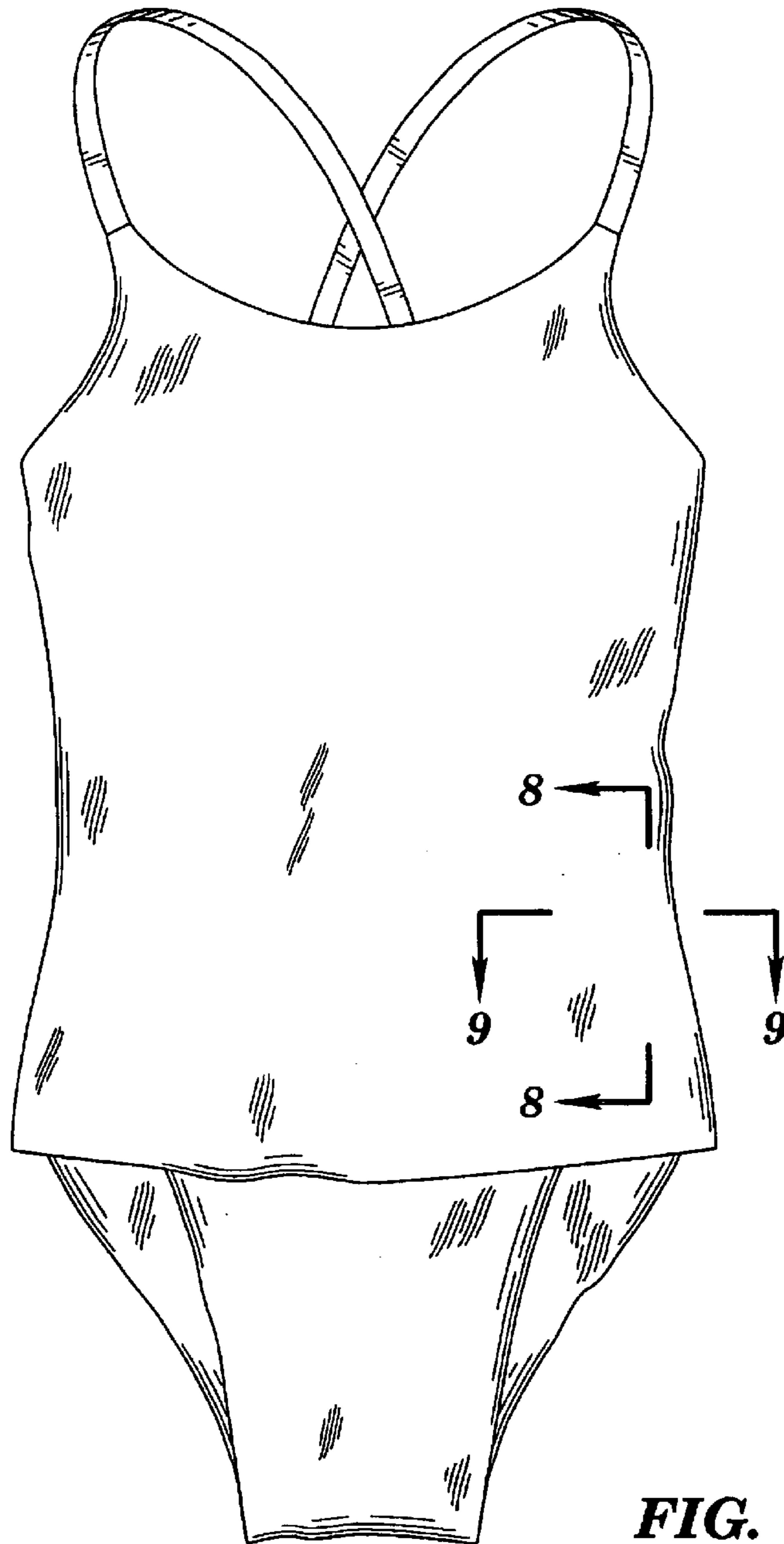

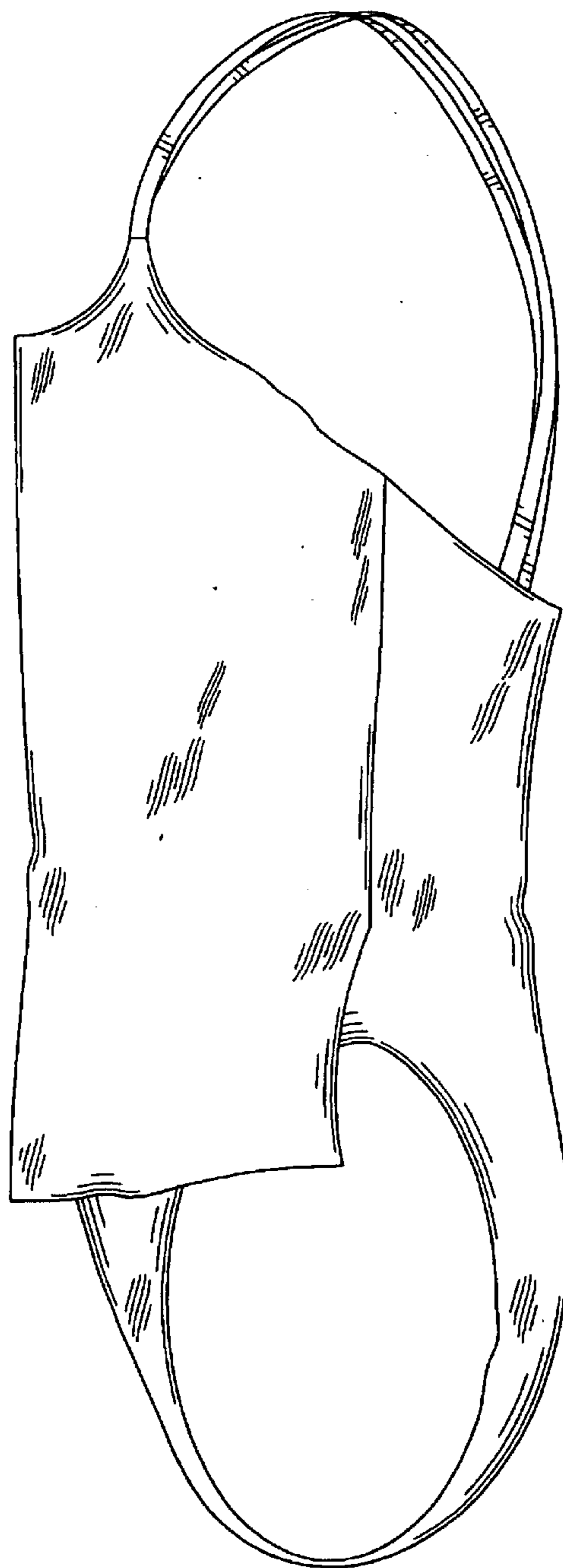

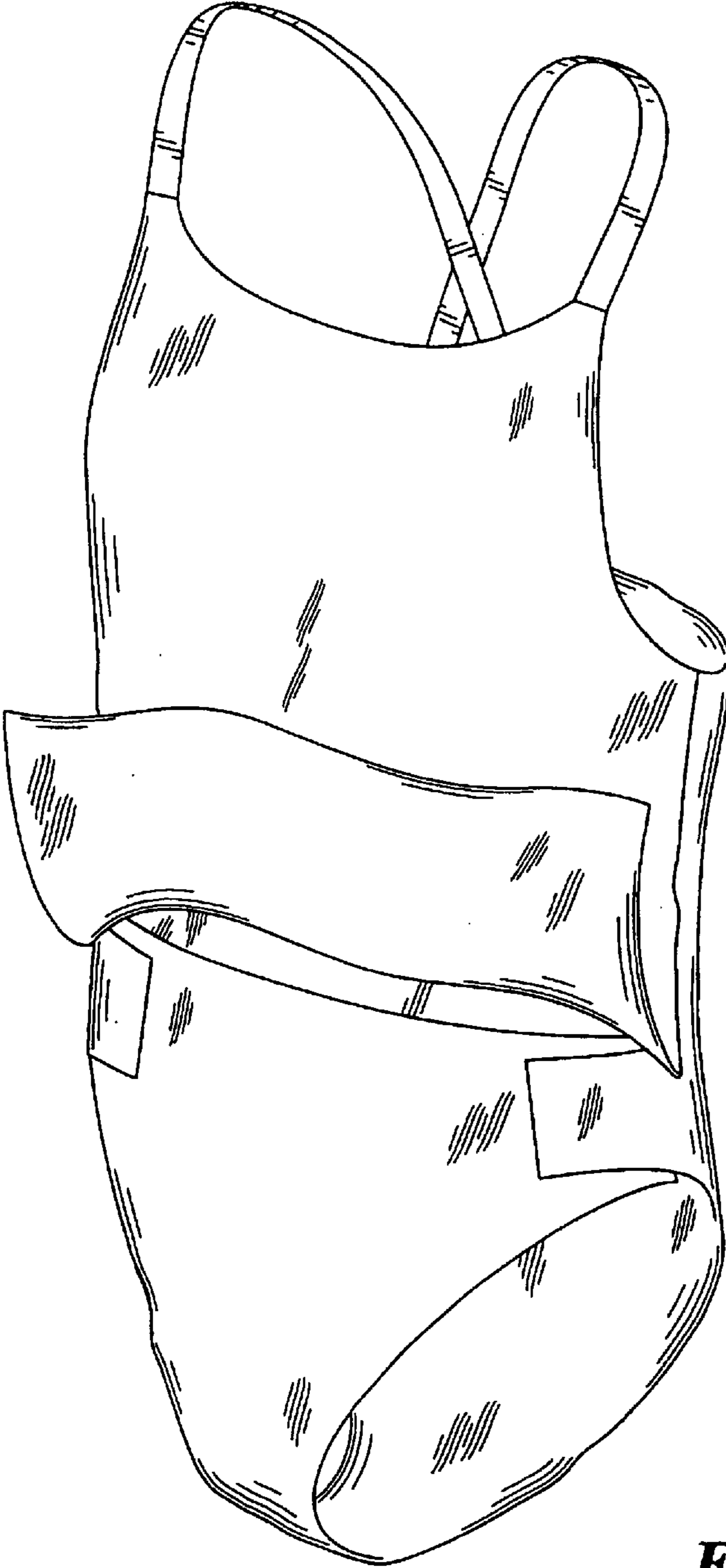

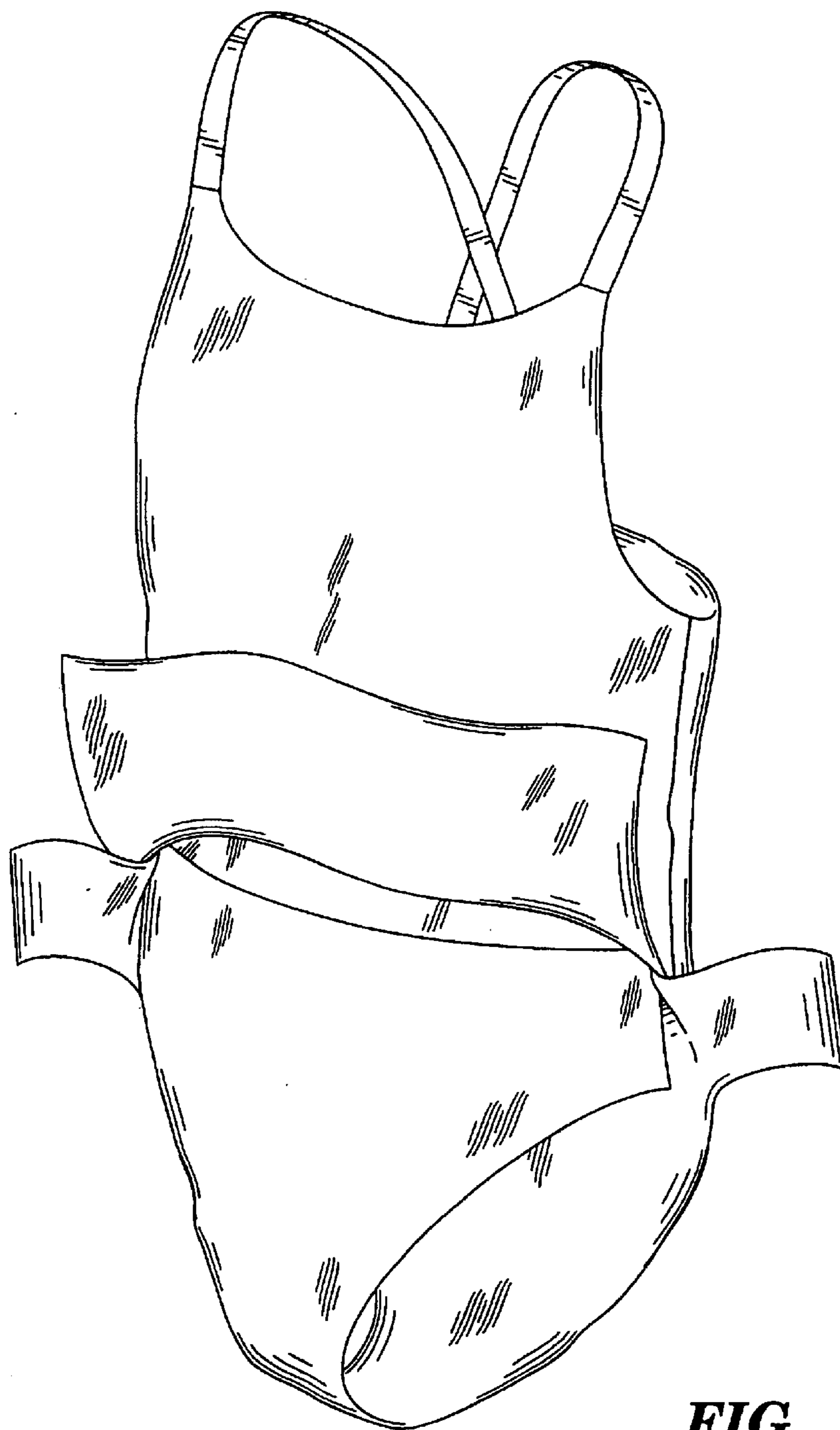

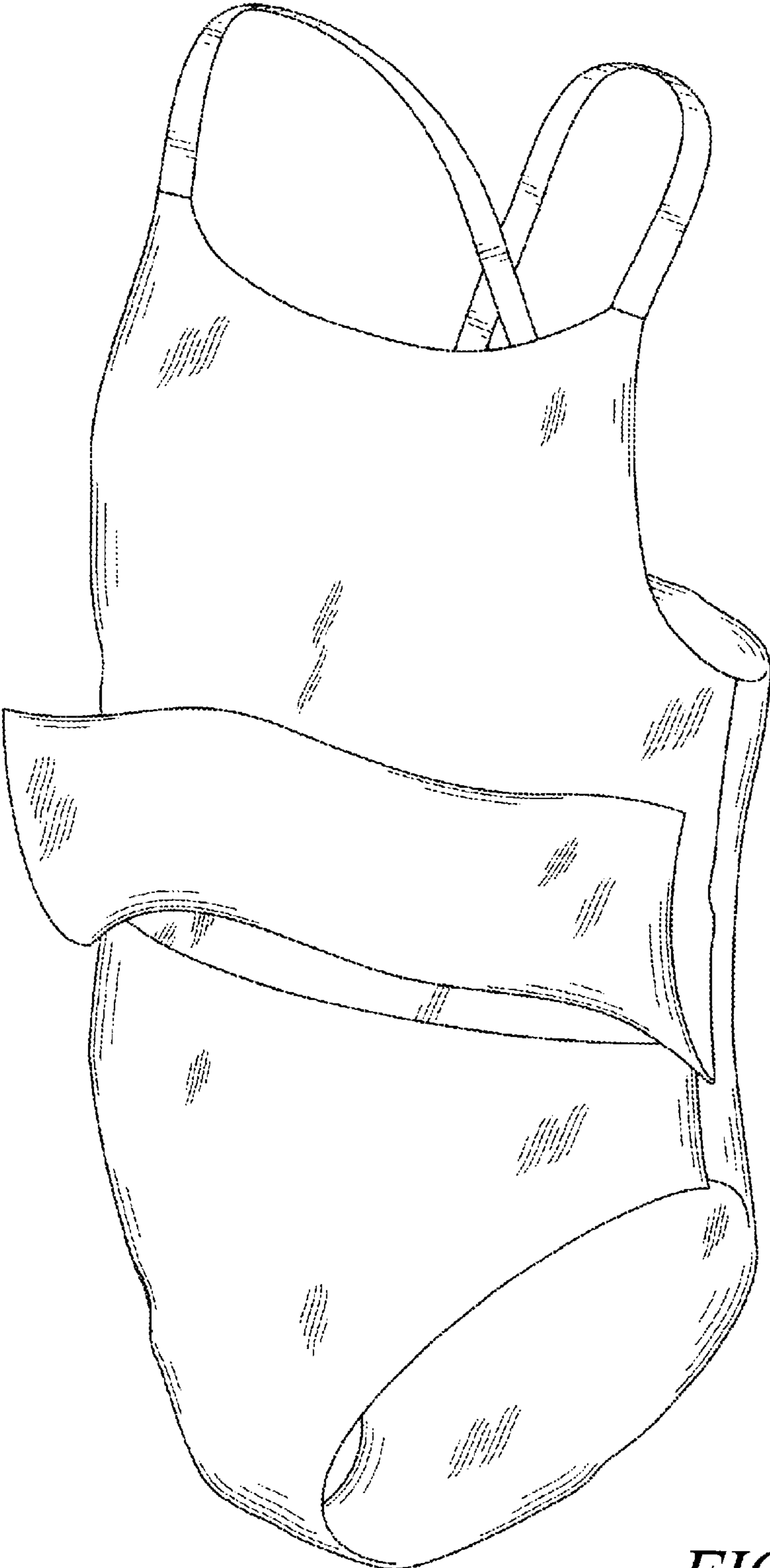
