FIG. 3 is a right elevational view thereof;

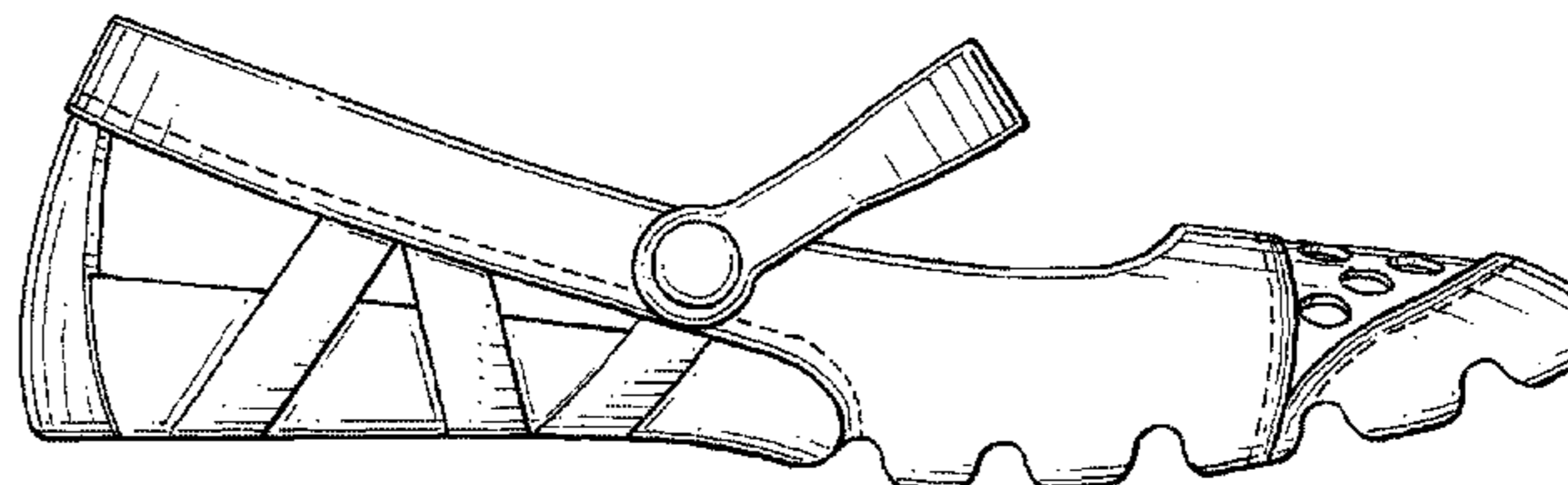
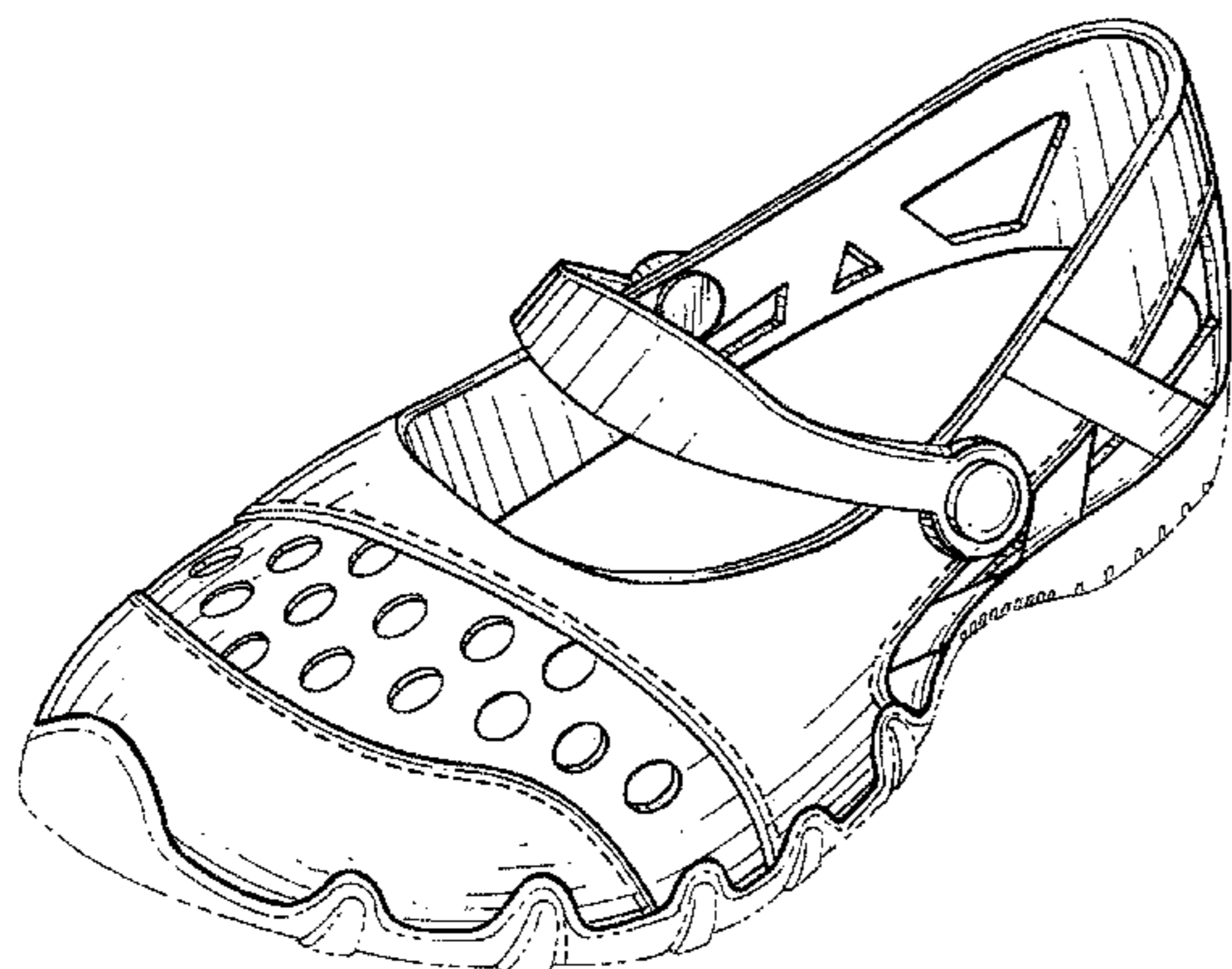
FIG. 4 is a left elevational view thereof;

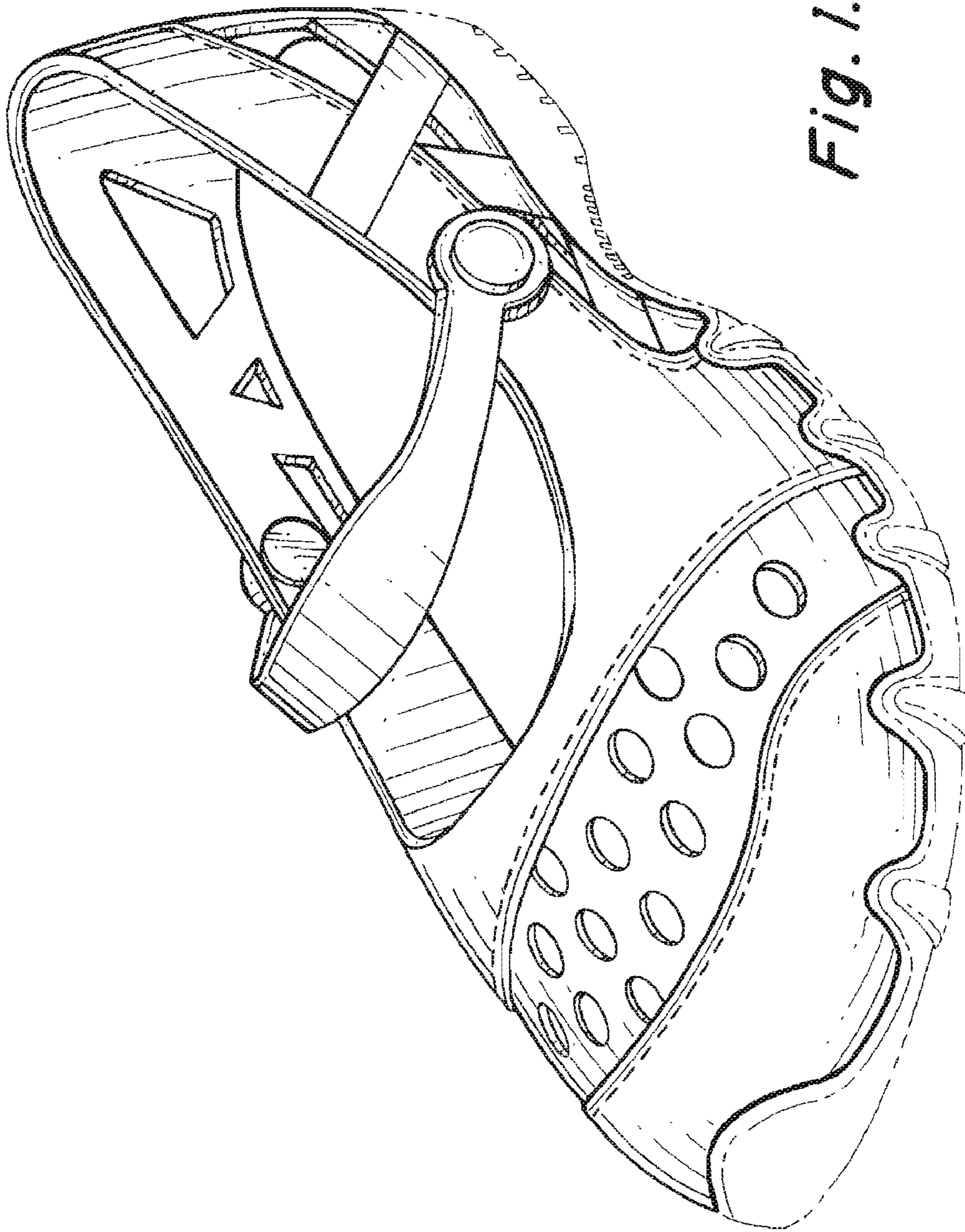
FIG. 5 is a front elevational view thereof; and,

FIG. 6 is a rear elevational view thereof.

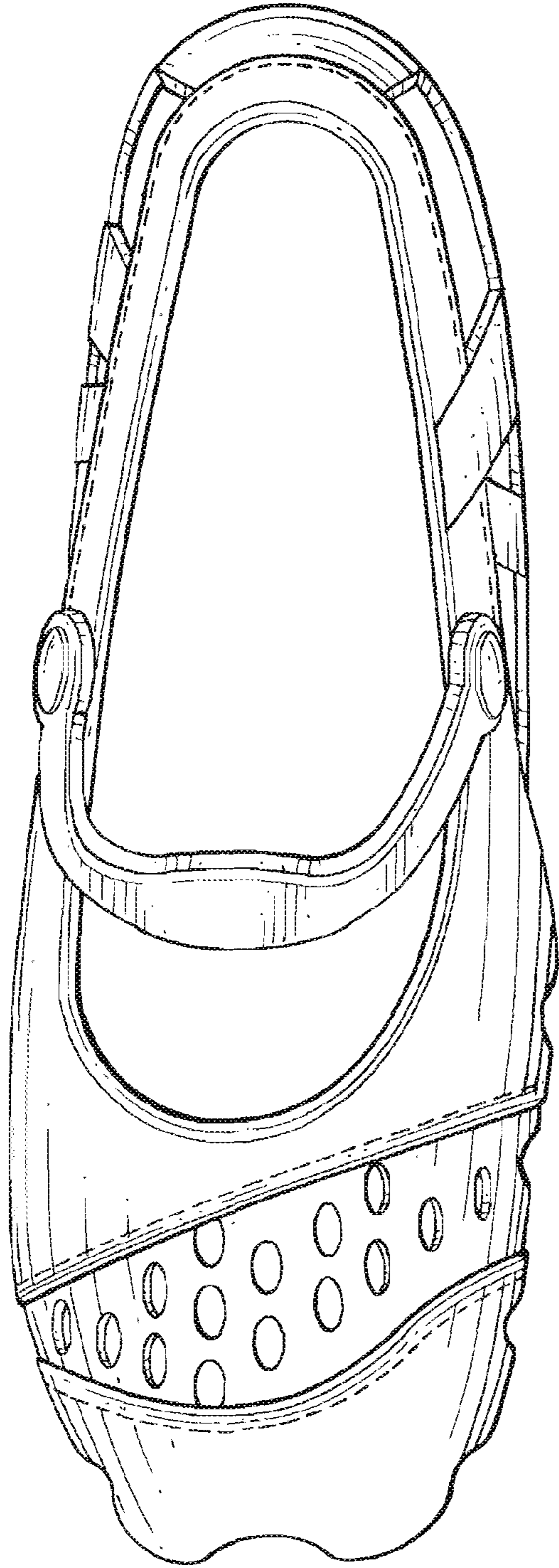

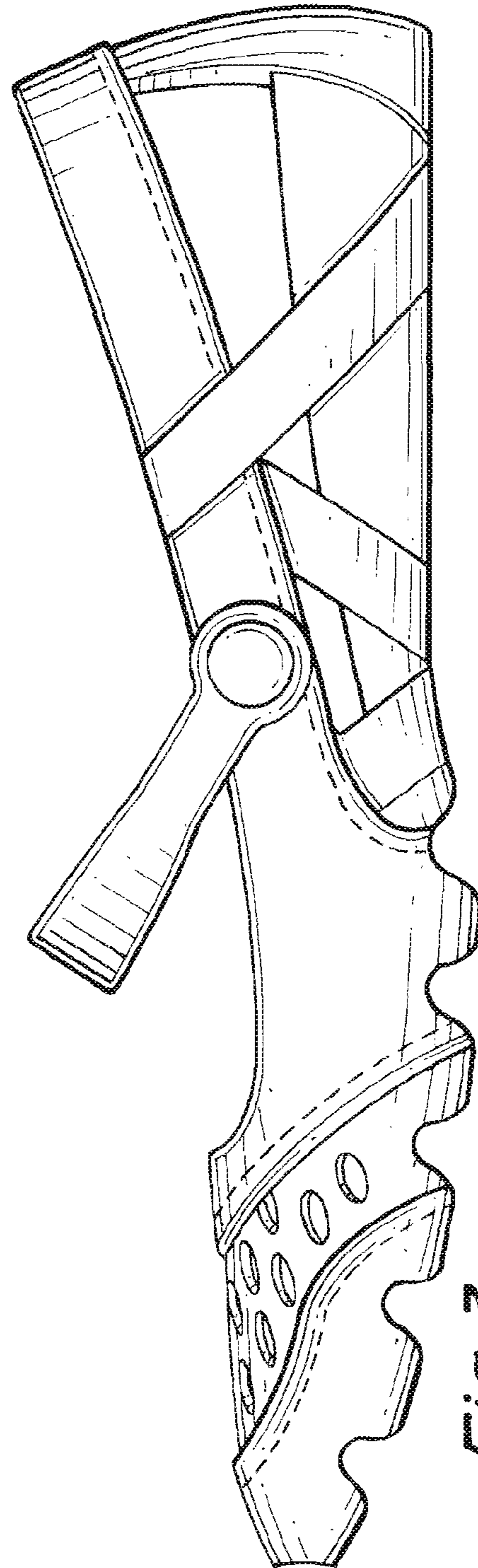




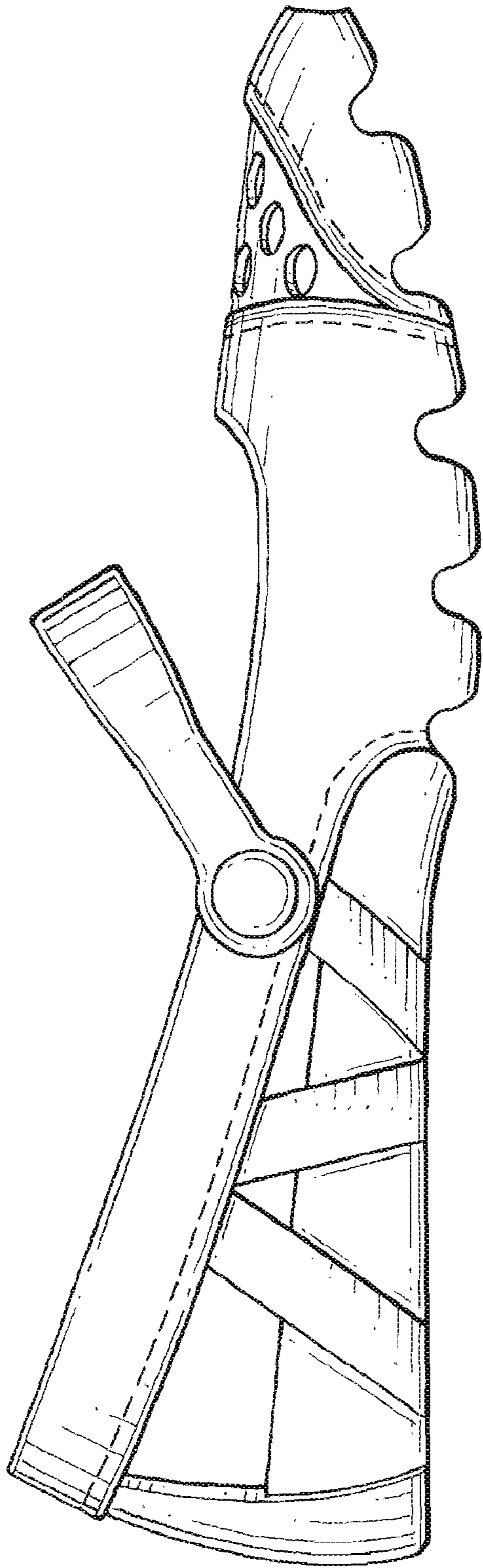

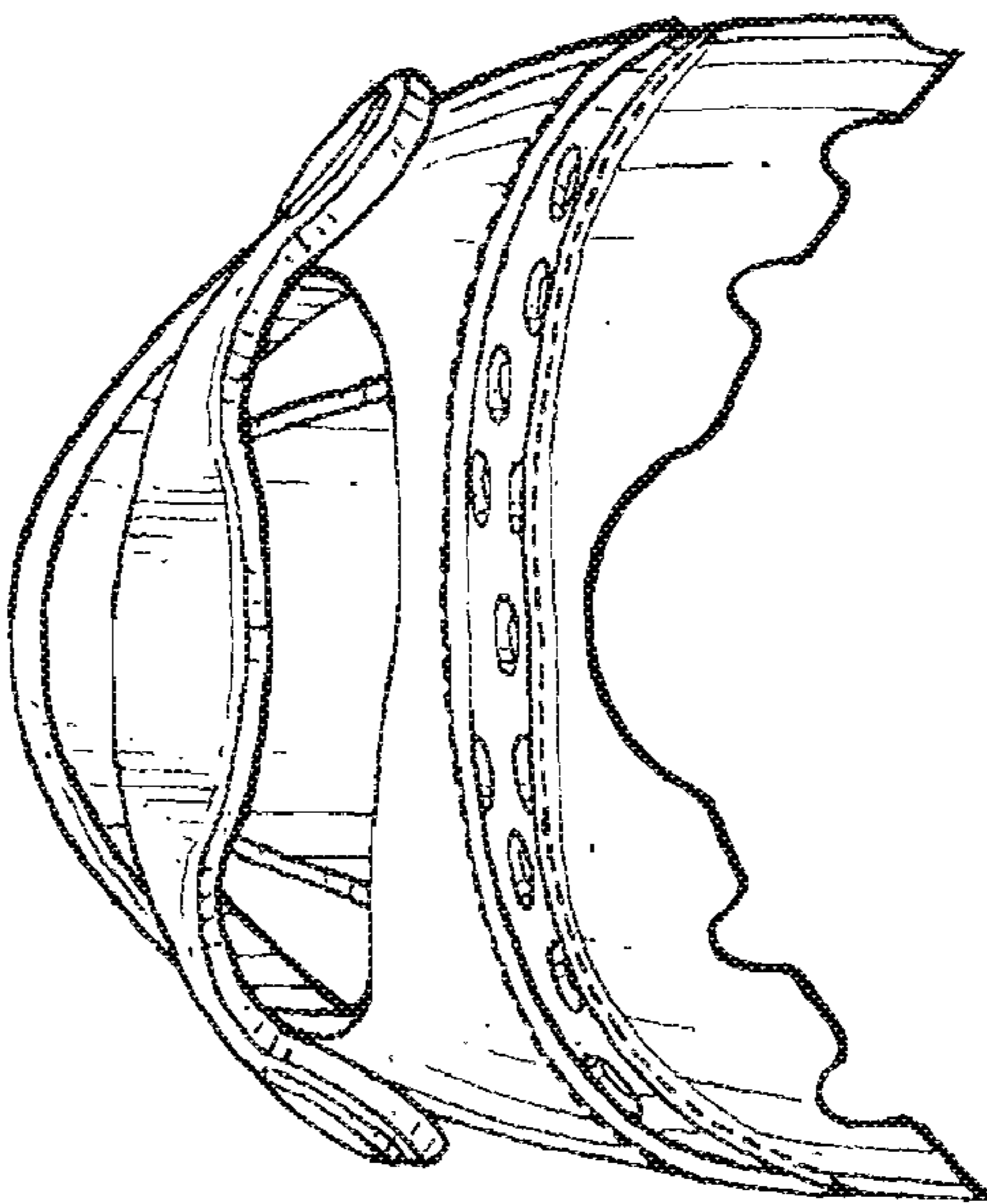

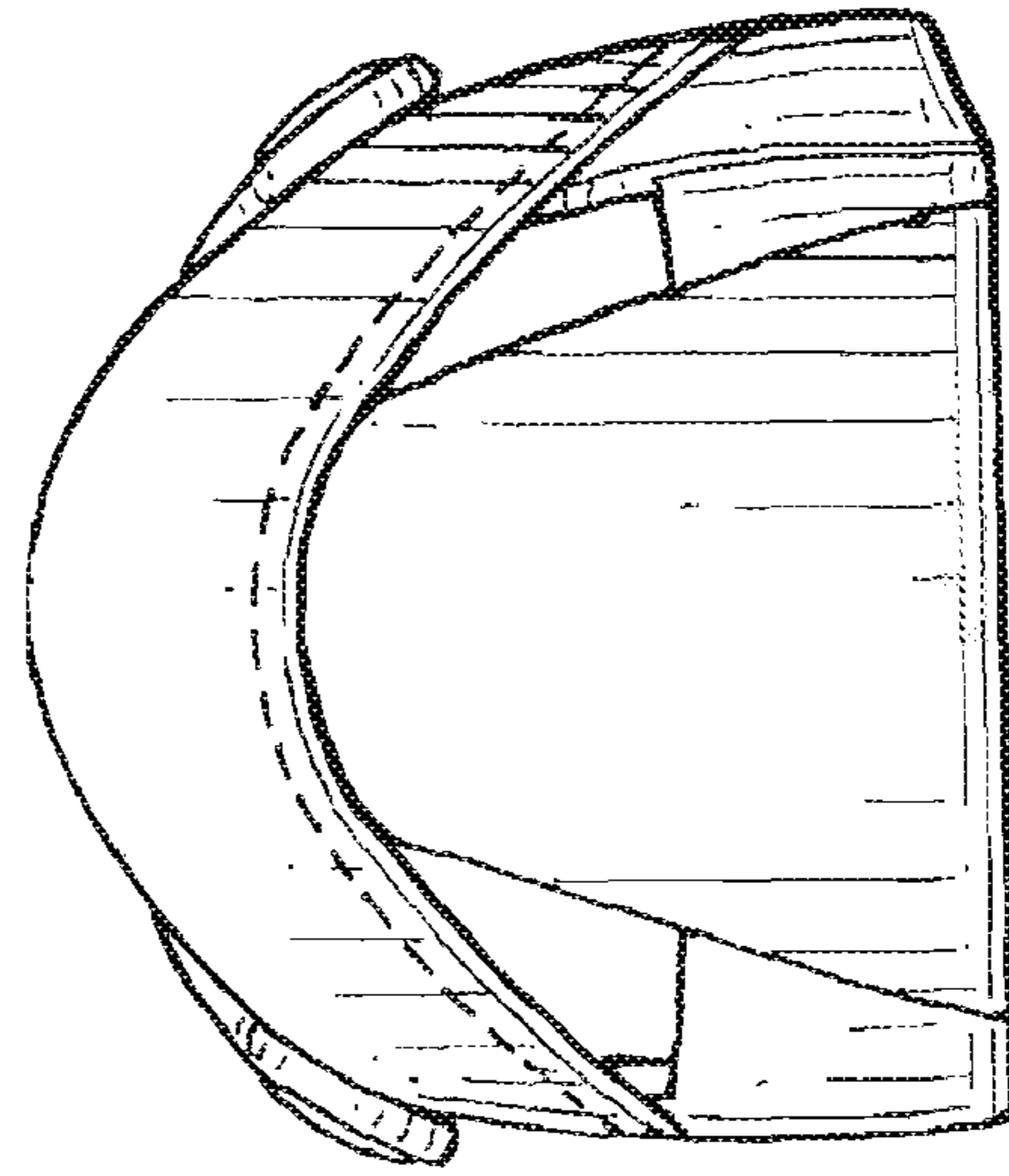
