DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;

FIG. 9 is a right side view of the alternative embodiment of the shoe shown in FIG. 7;

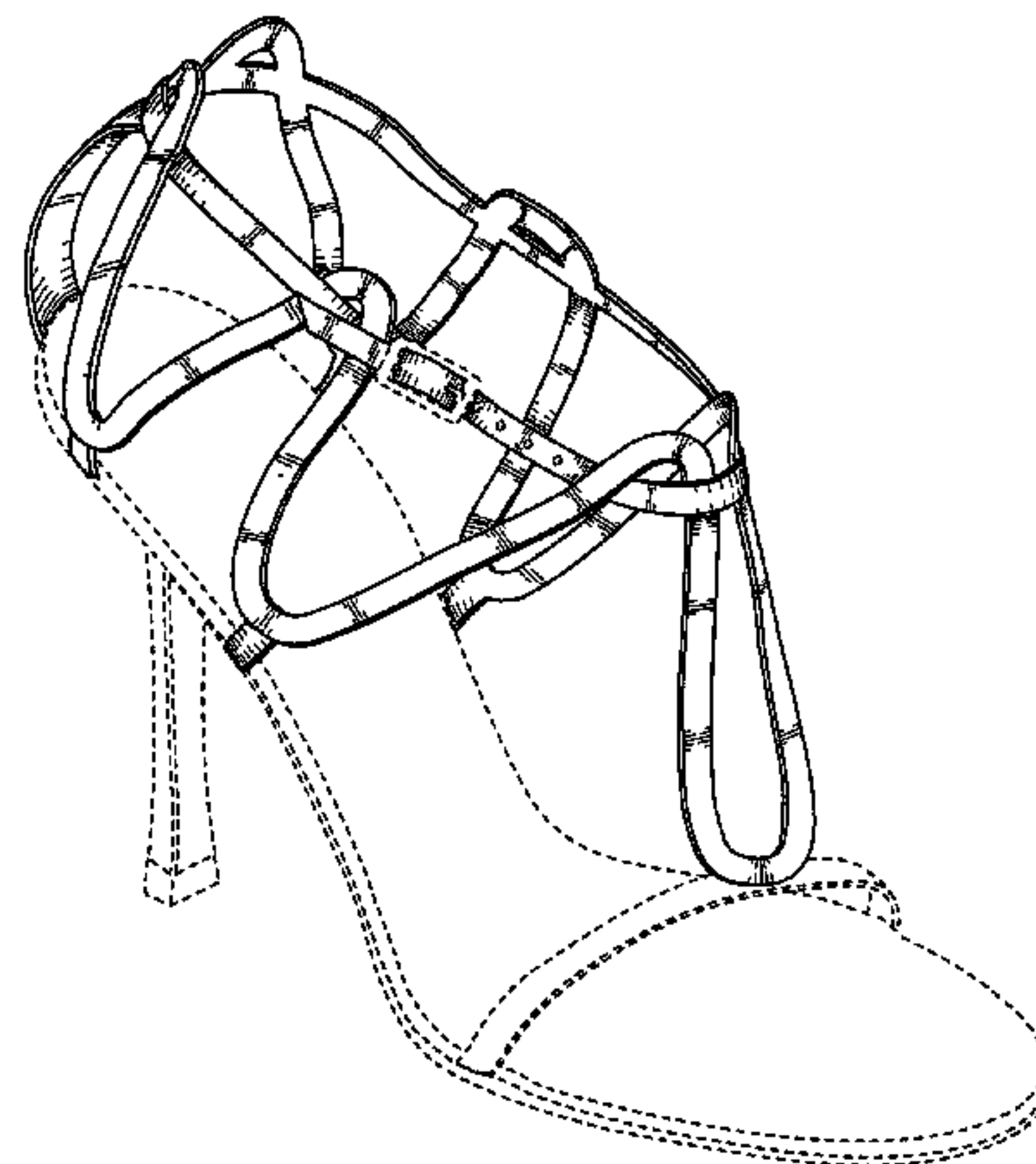
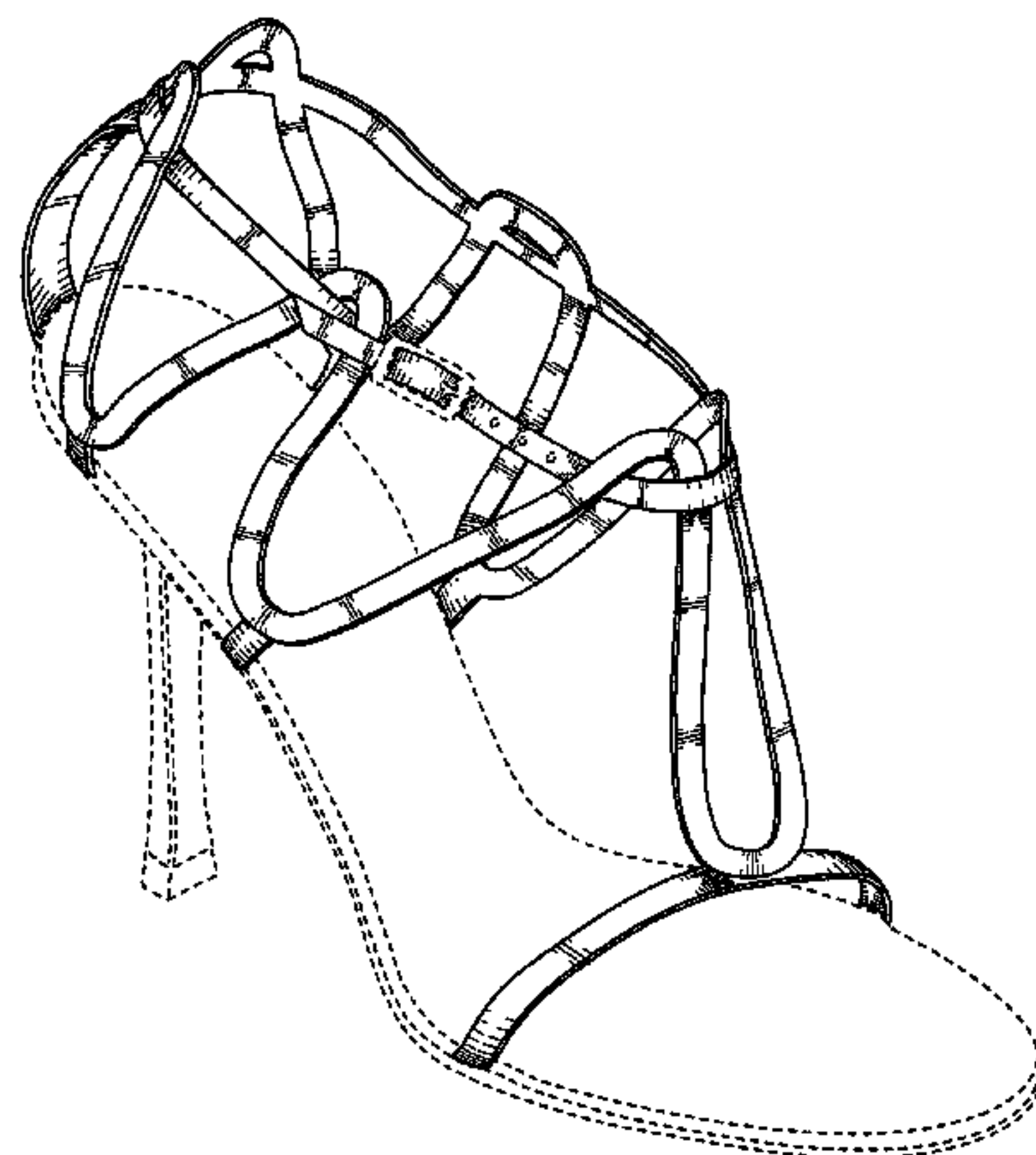
FIG. 10 is a front view of the alternative embodiment of the shoe shown in FIG. 7;

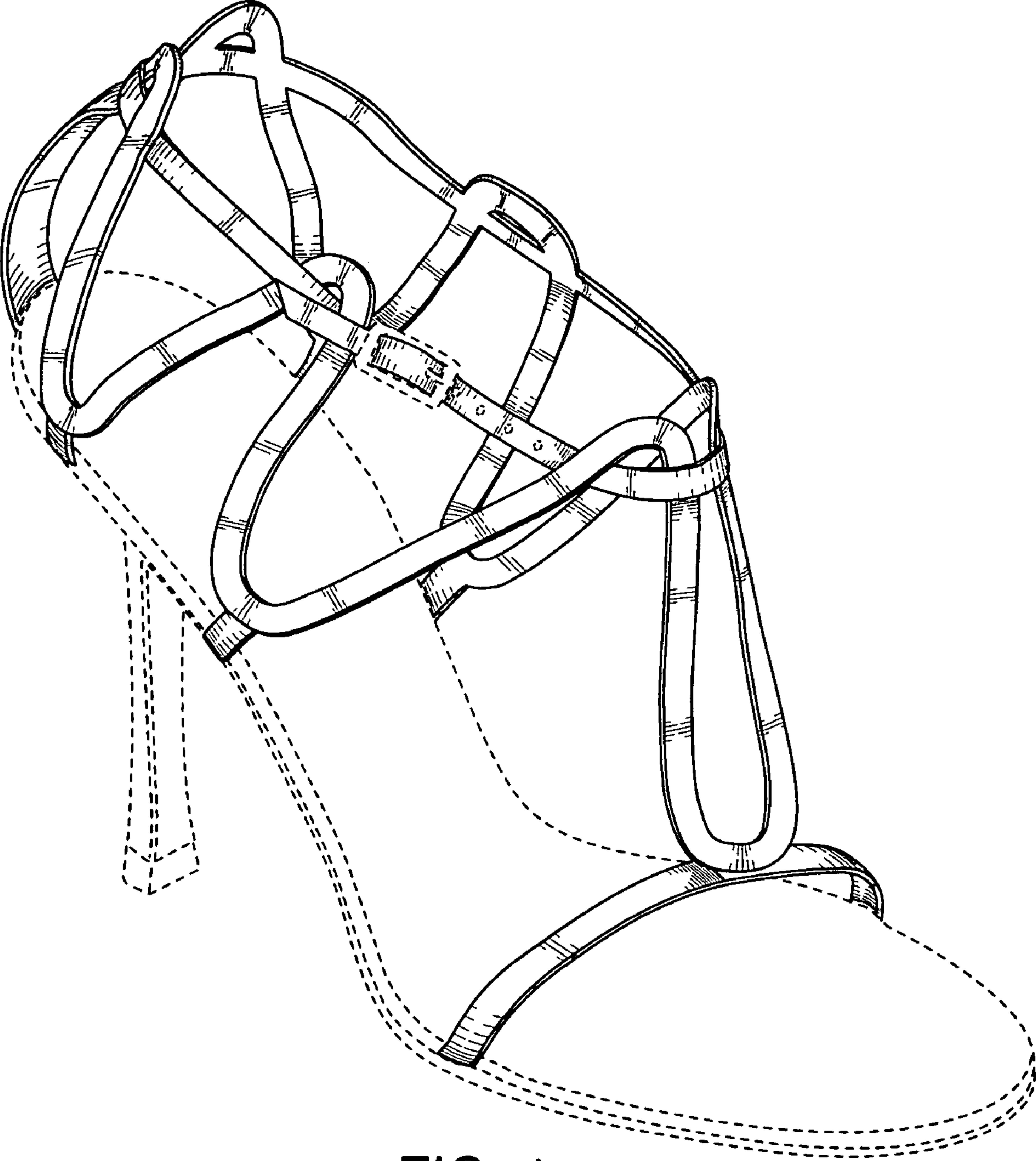

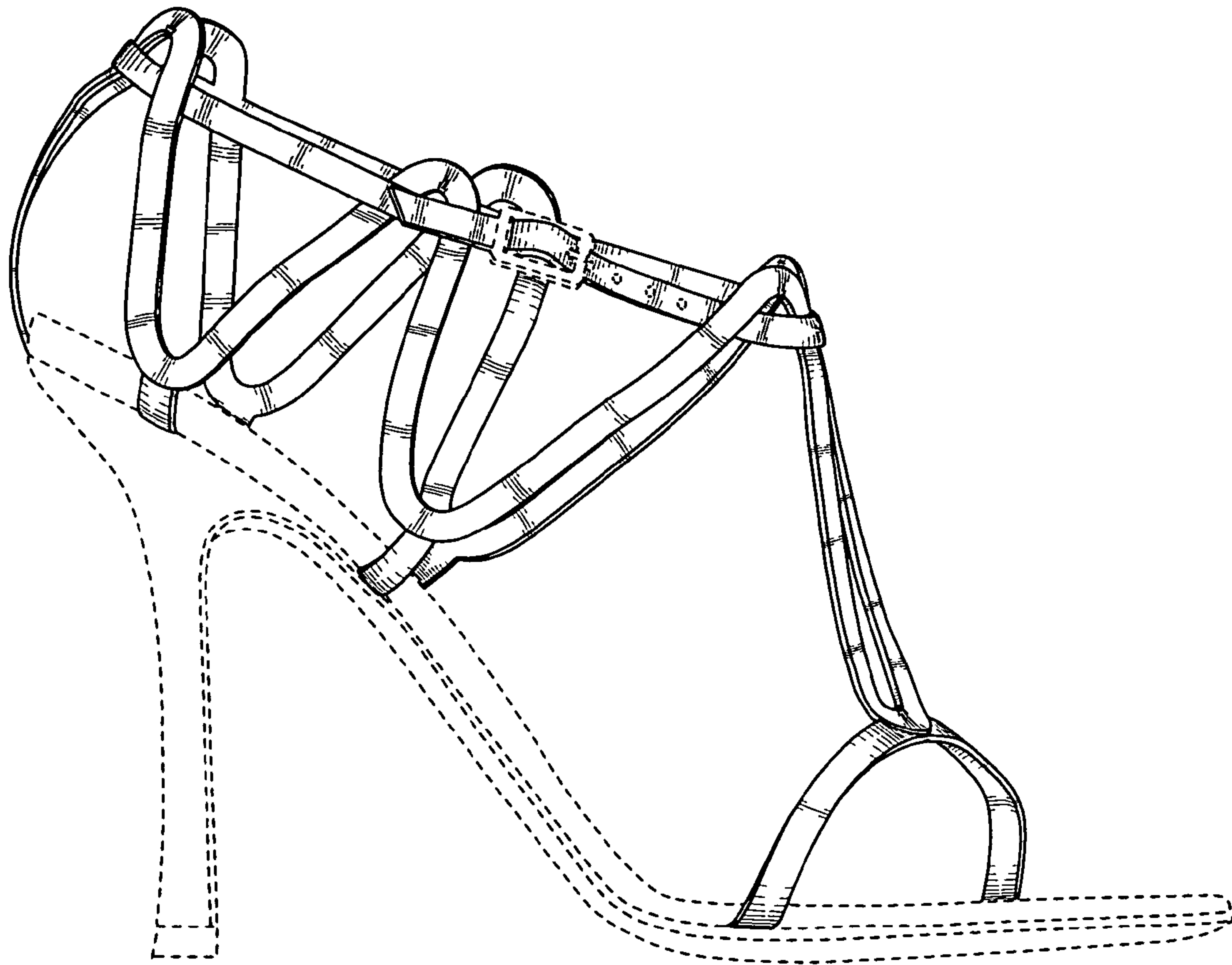

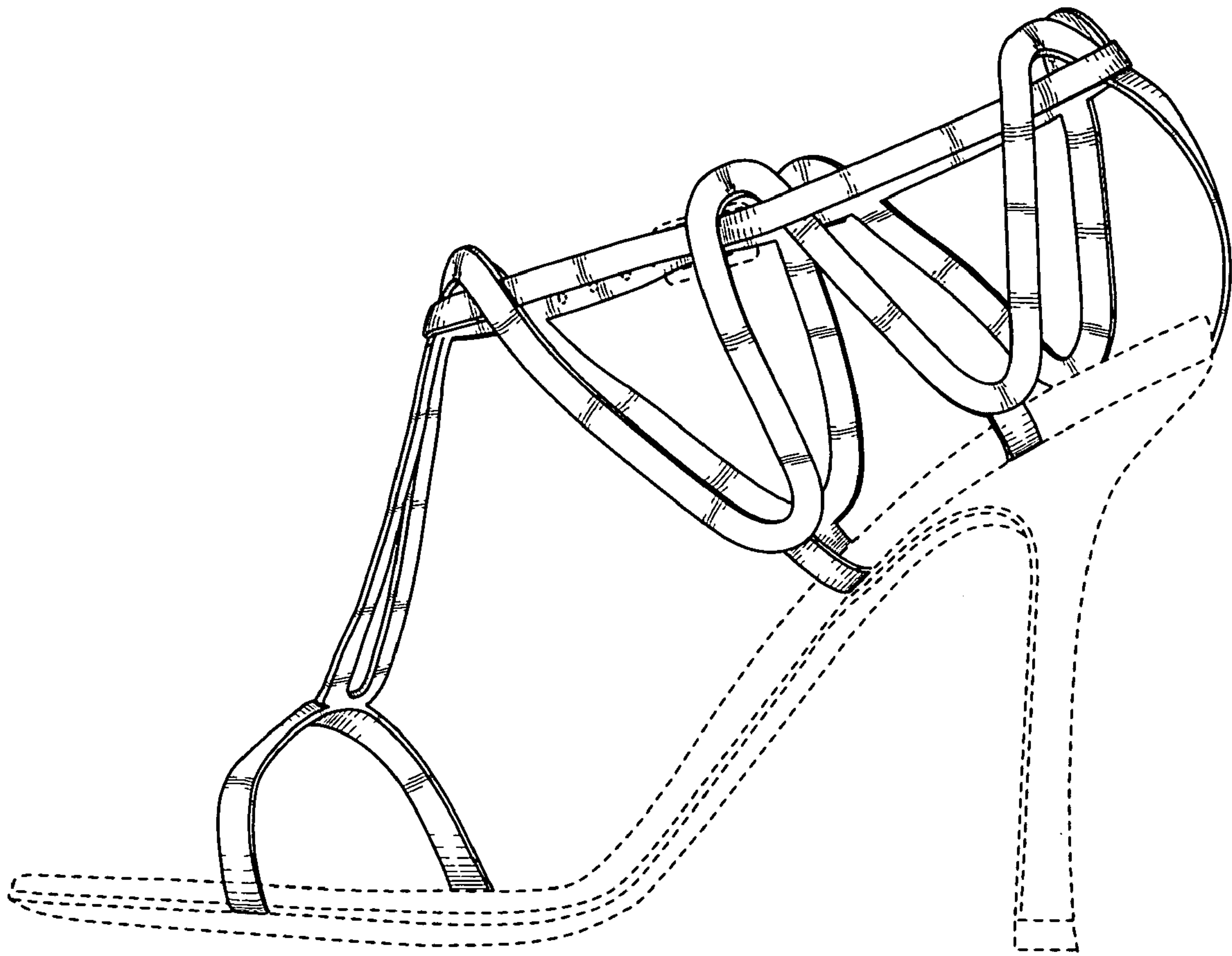

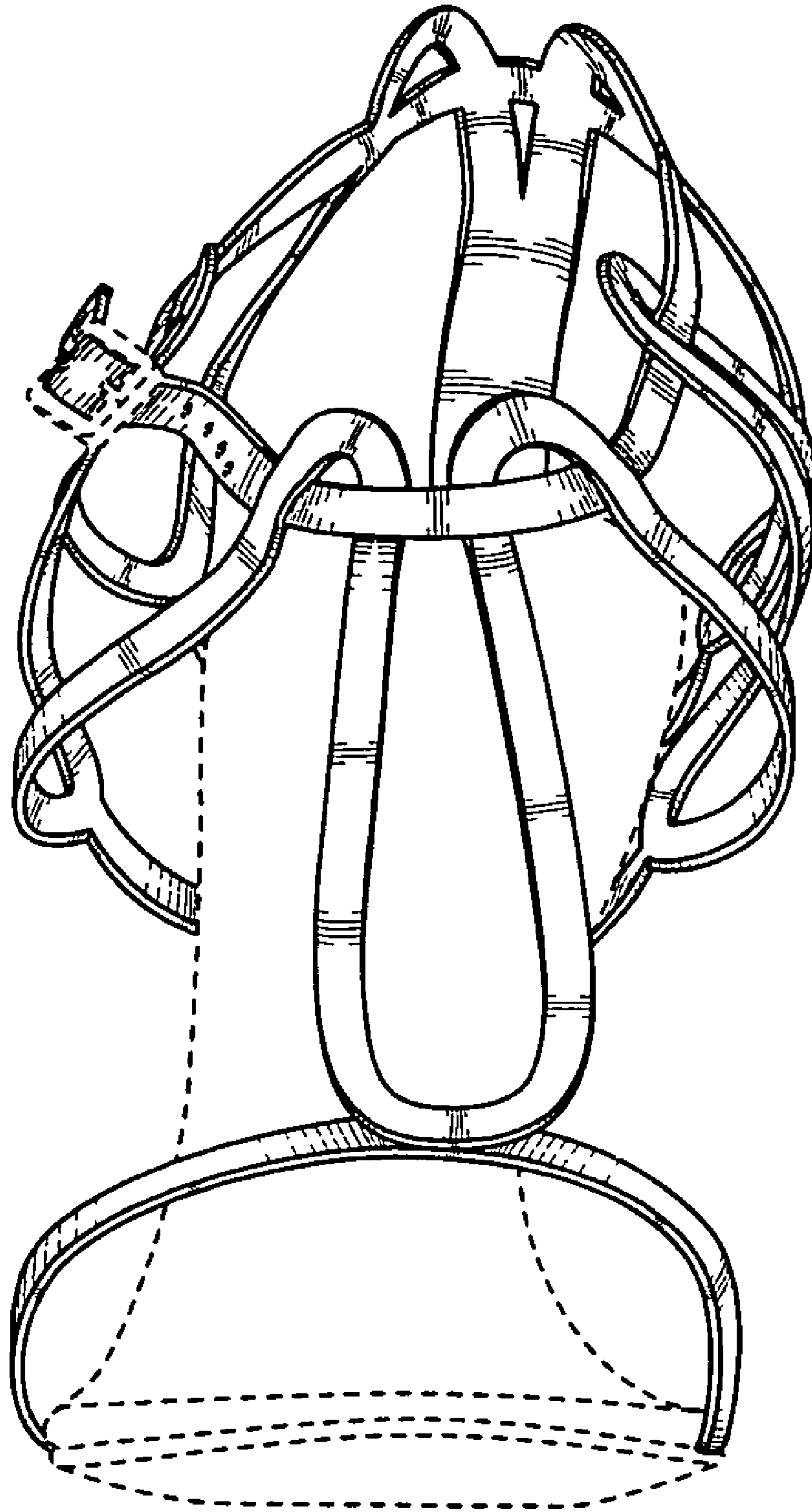

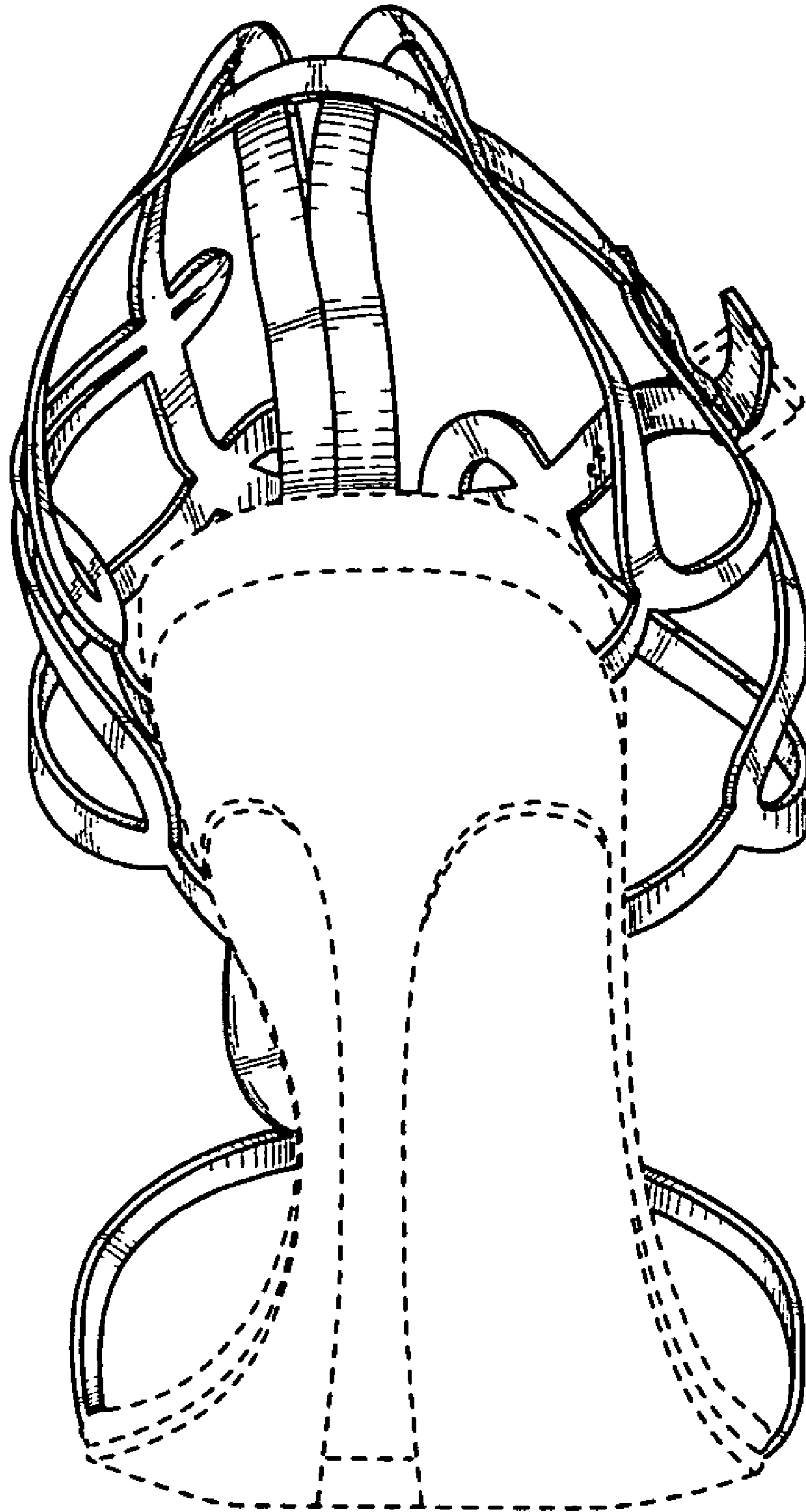

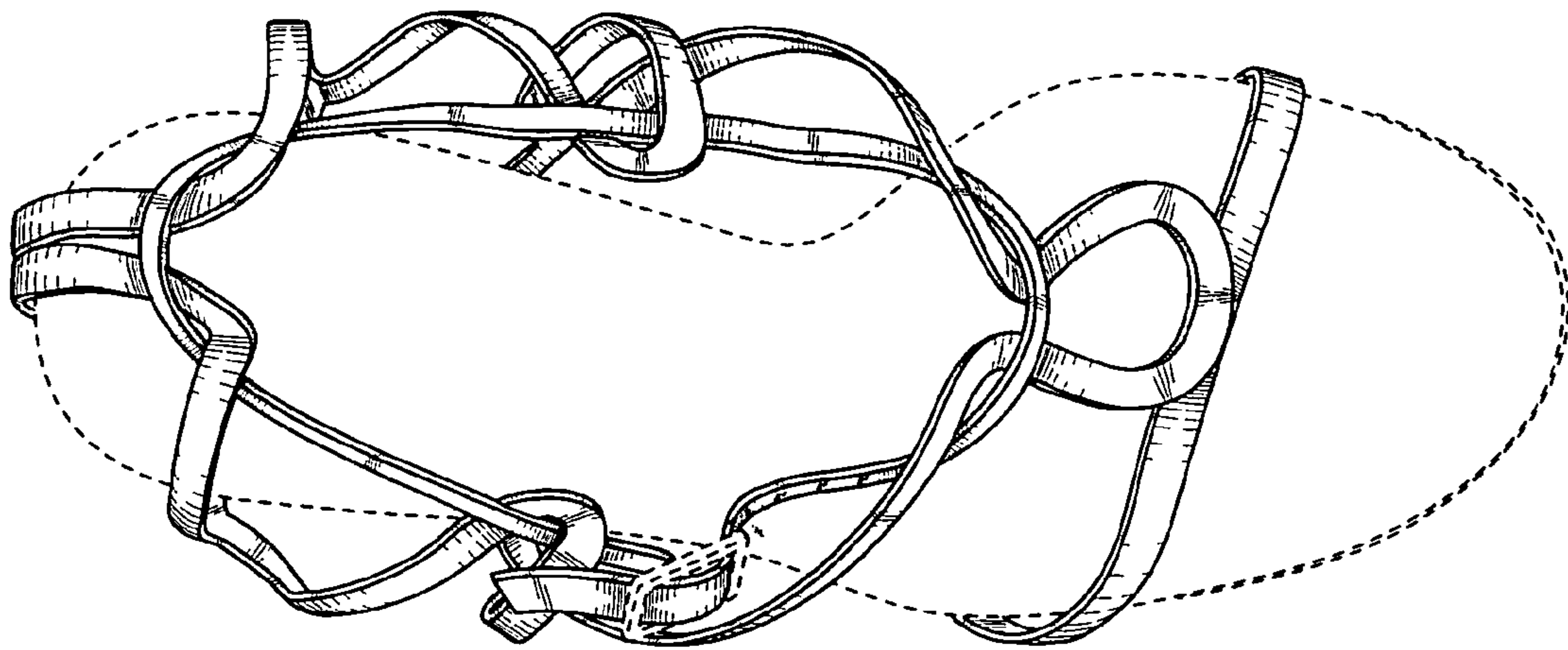

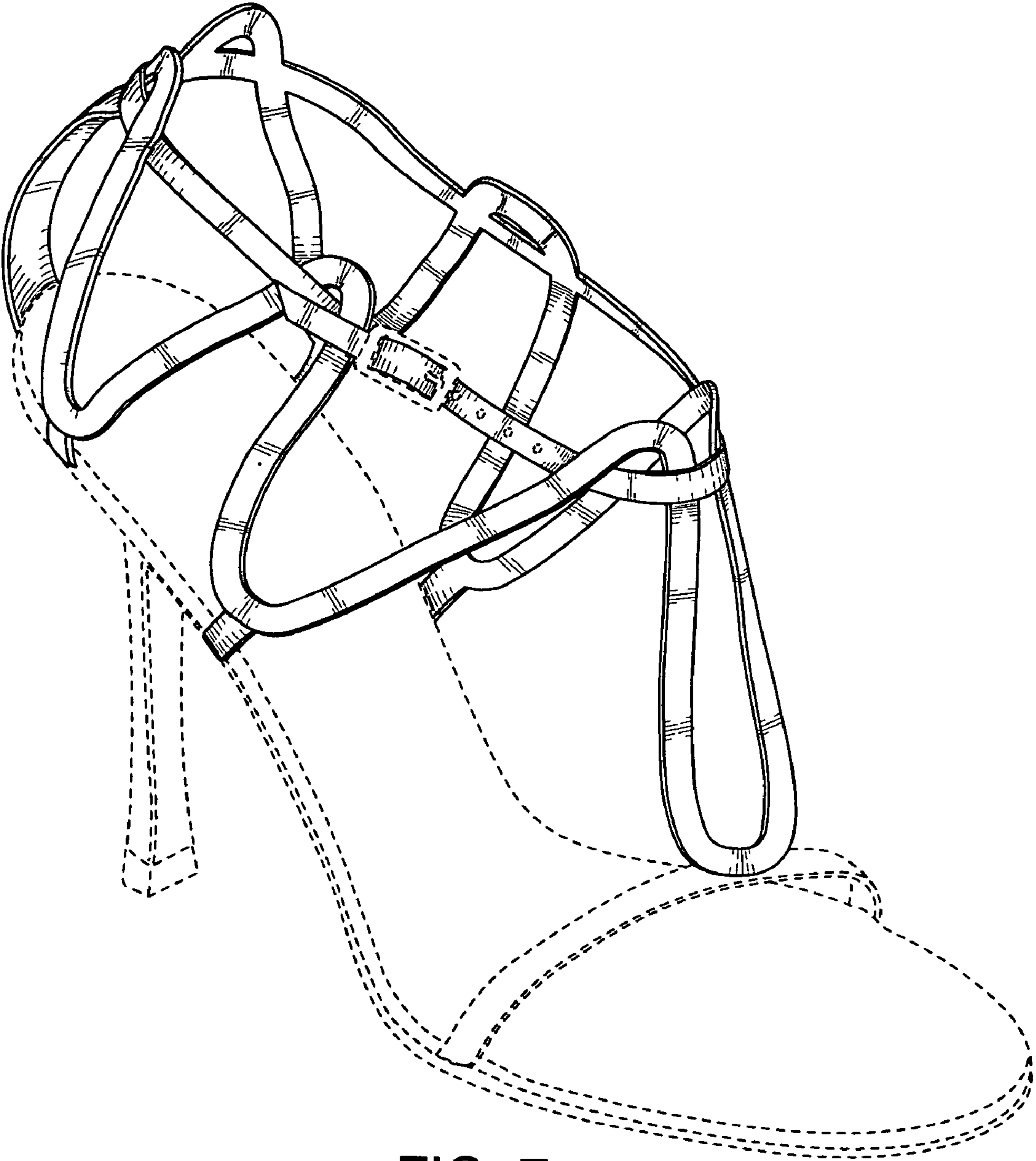

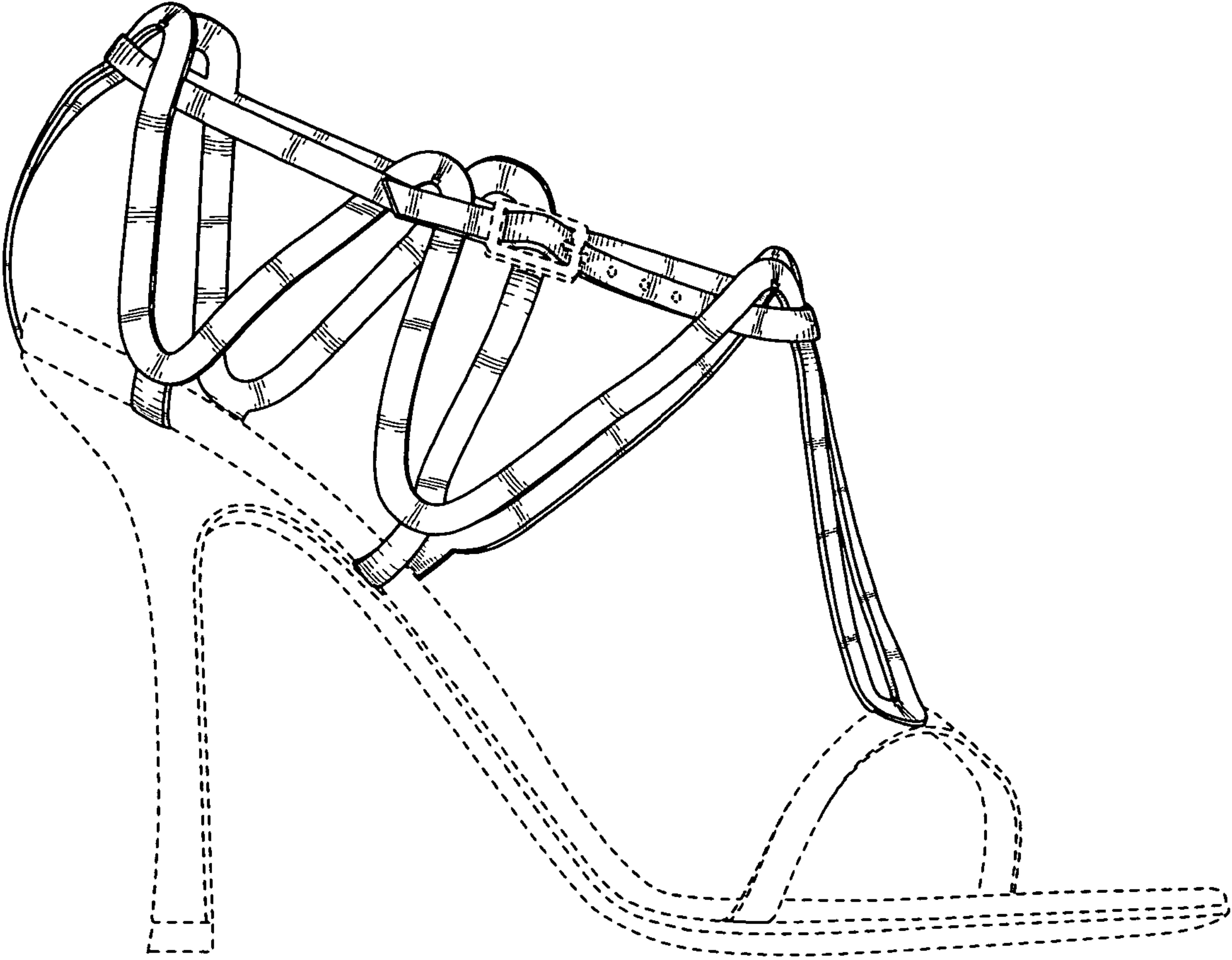

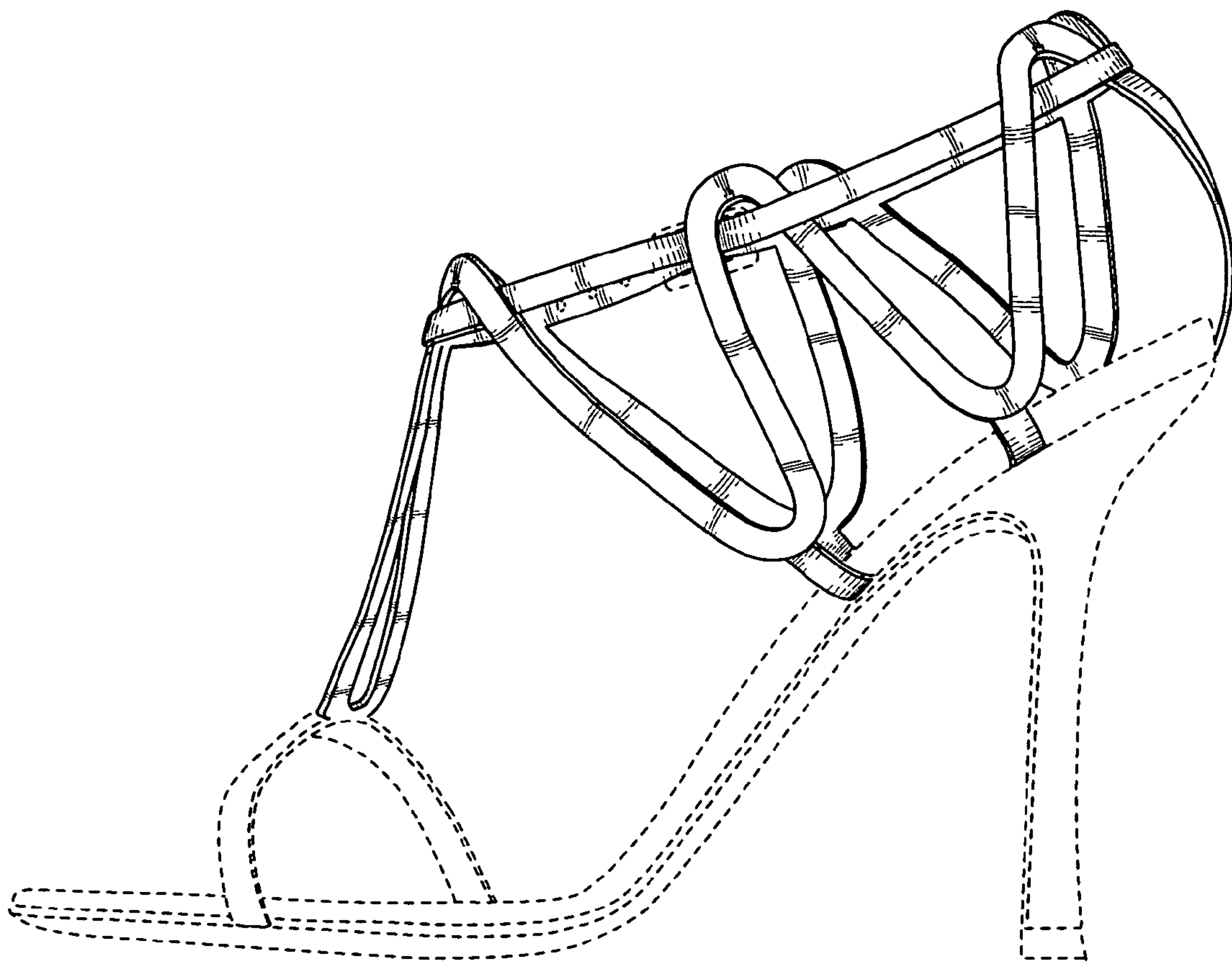

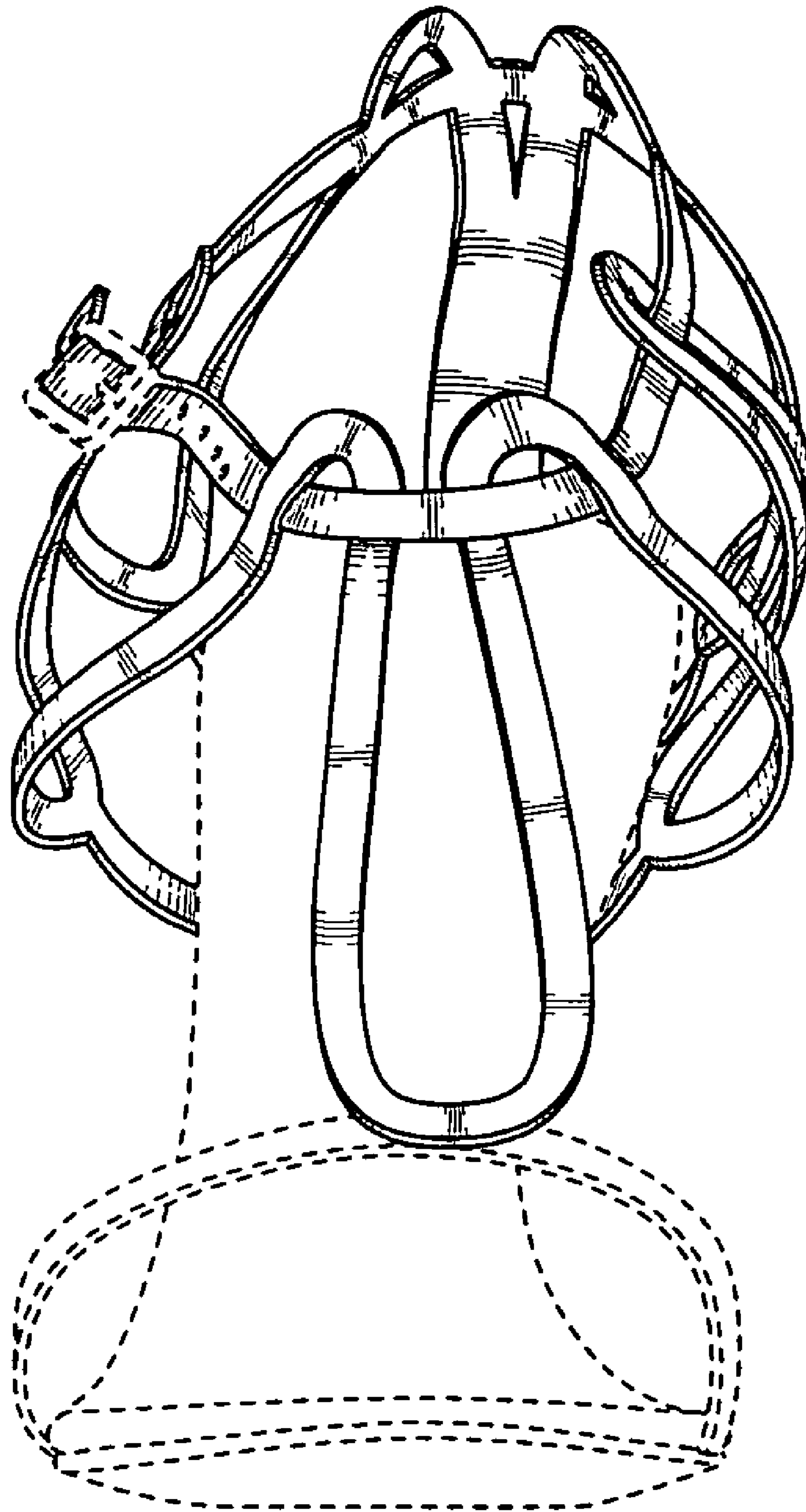

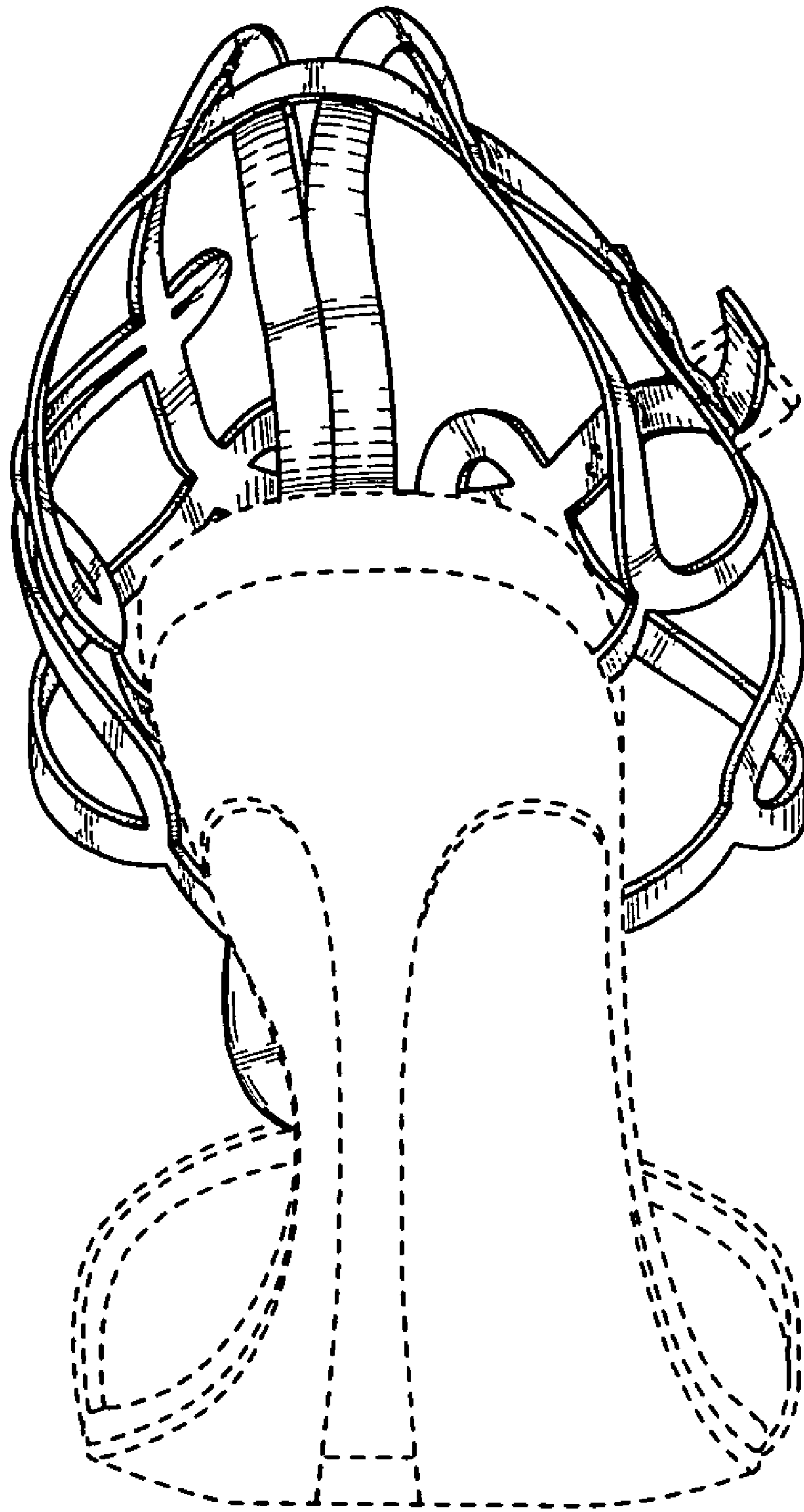

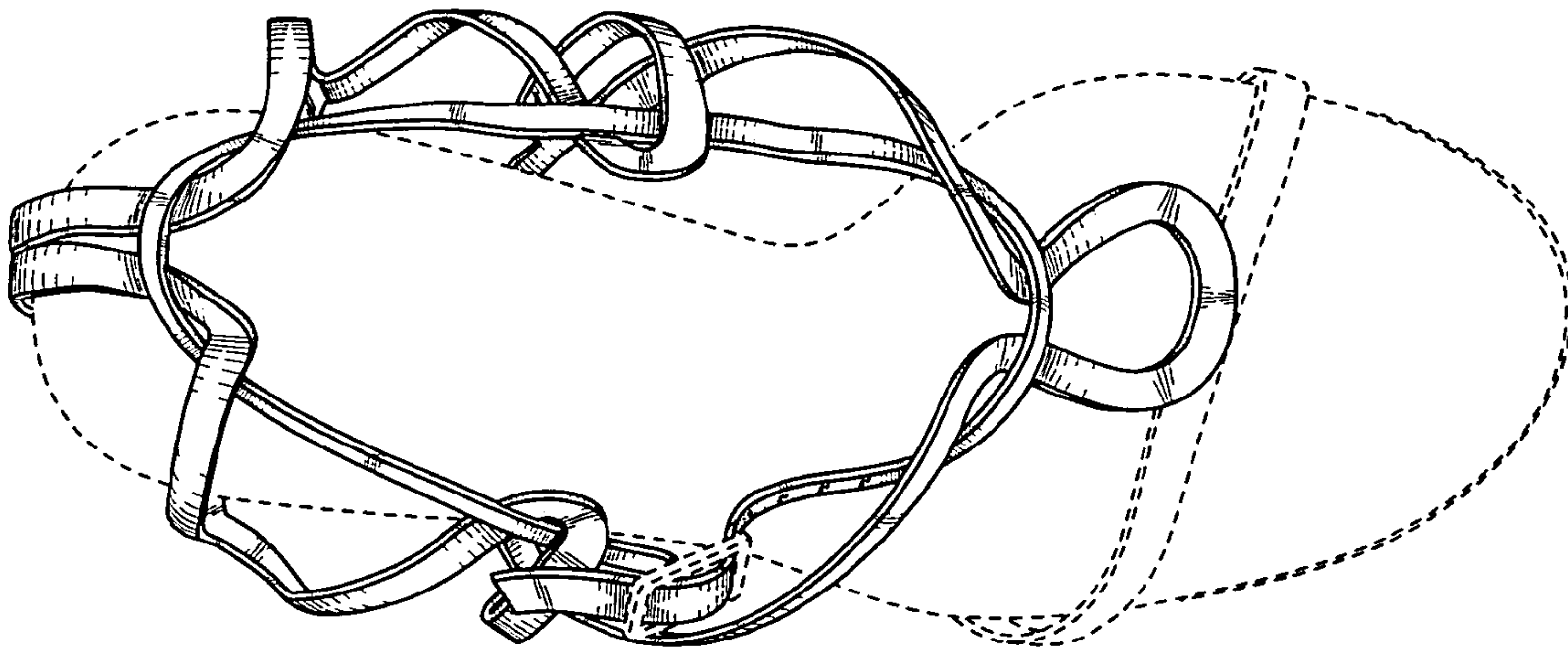
