DESCRIPTION

FIG. 1 is a right front perspective view of a handbag showing my new design in an open position;

FIG. 2 is a front elevation view thereof, the rear being a mirror image thereof;

FIG. 3 is a right side view thereof, the left side being a mirror image thereof;

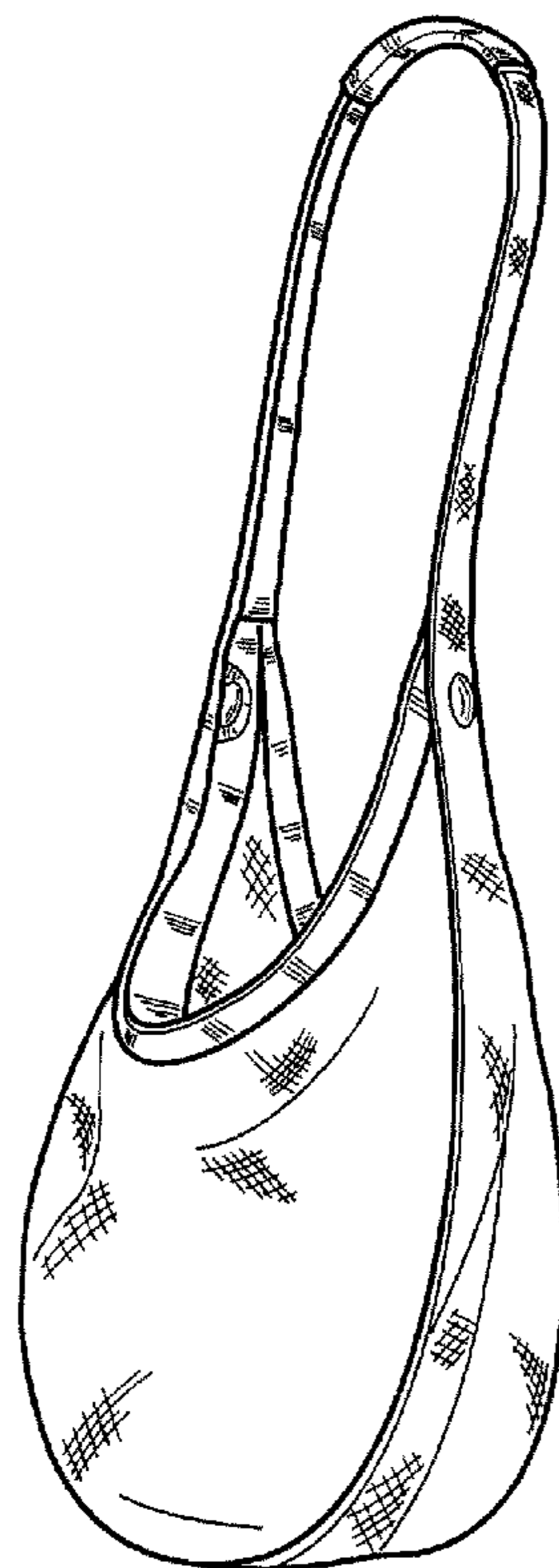
FIG. 4 is a top plan view;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front right side perspective view thereof showing the handbag in a closed position, the left side being a mirror image thereof; and,

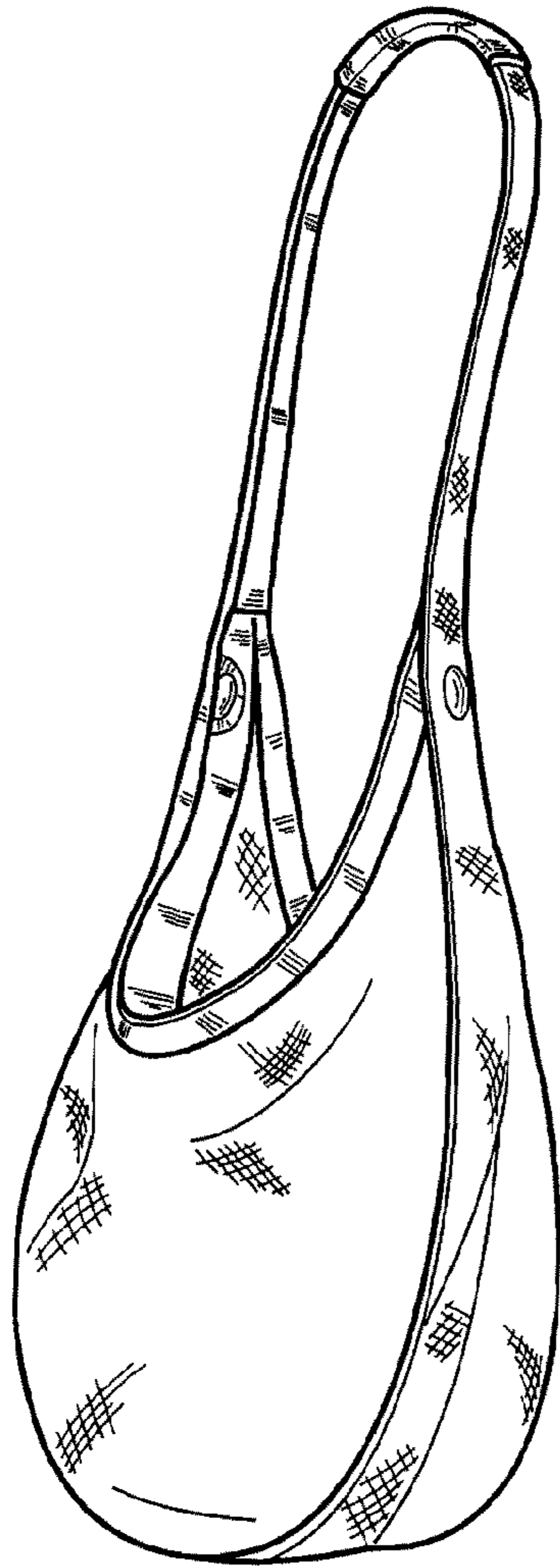

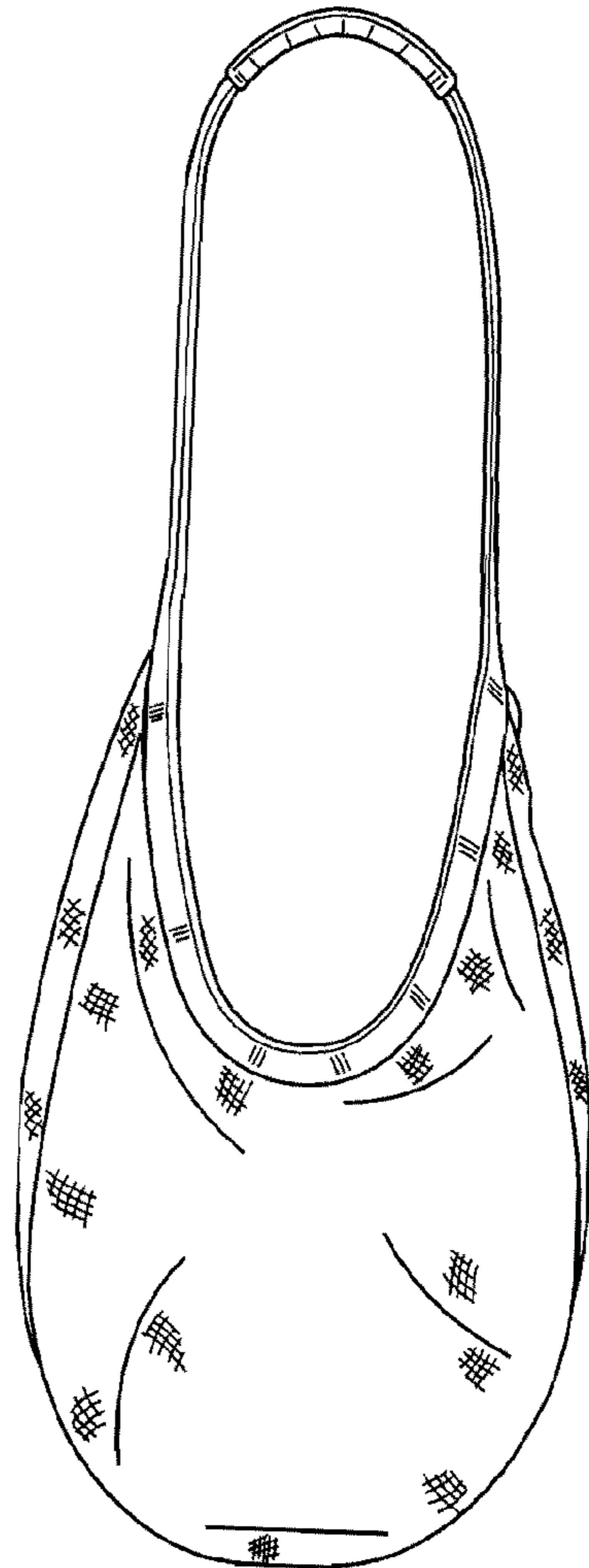

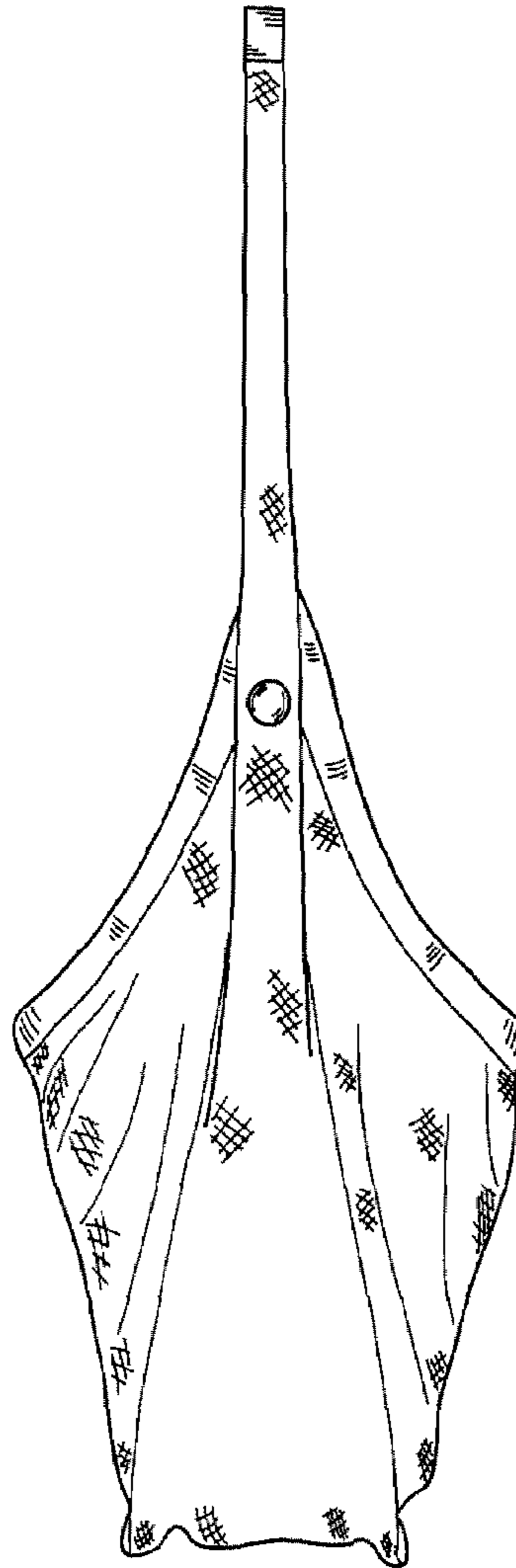
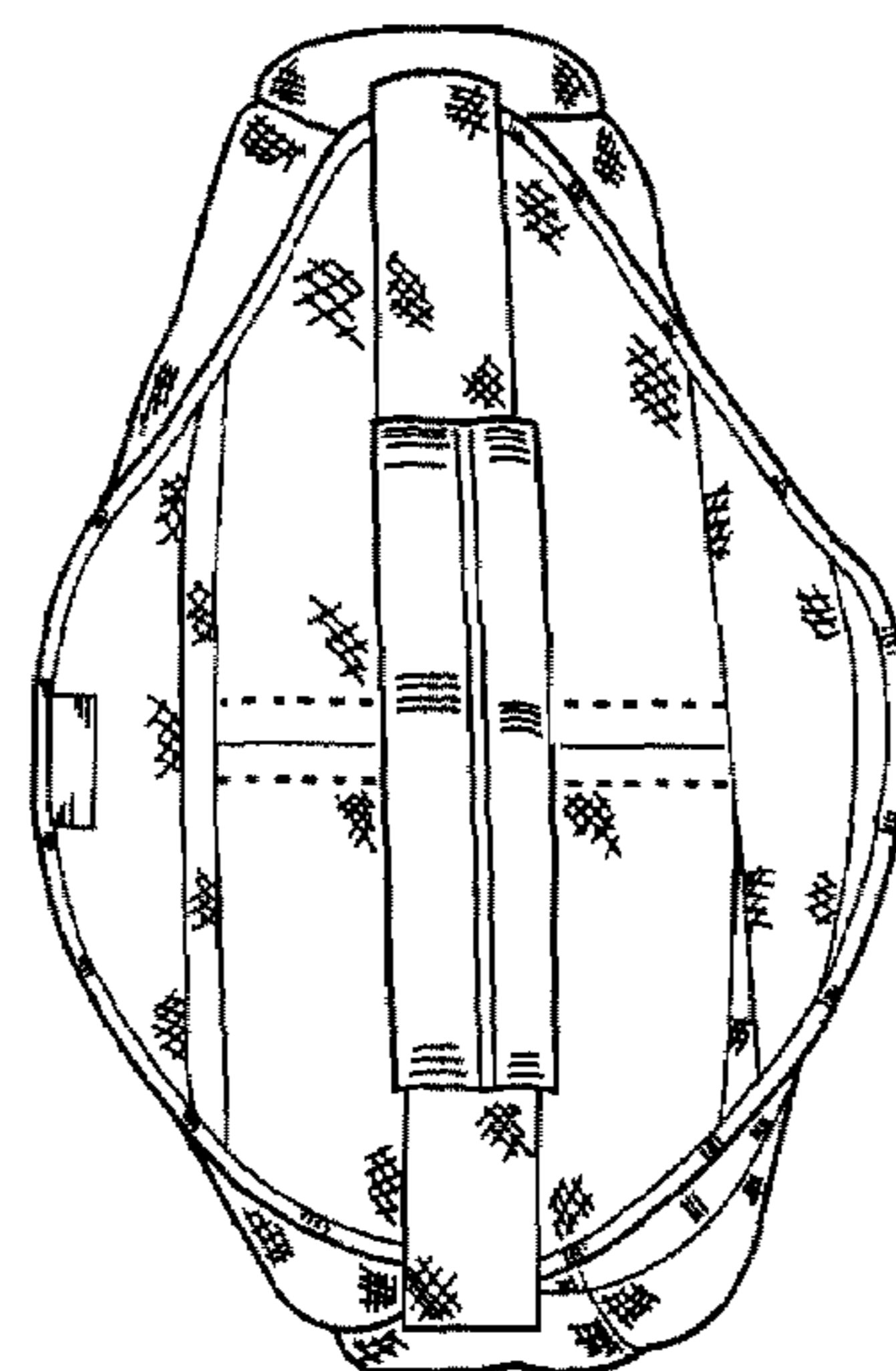

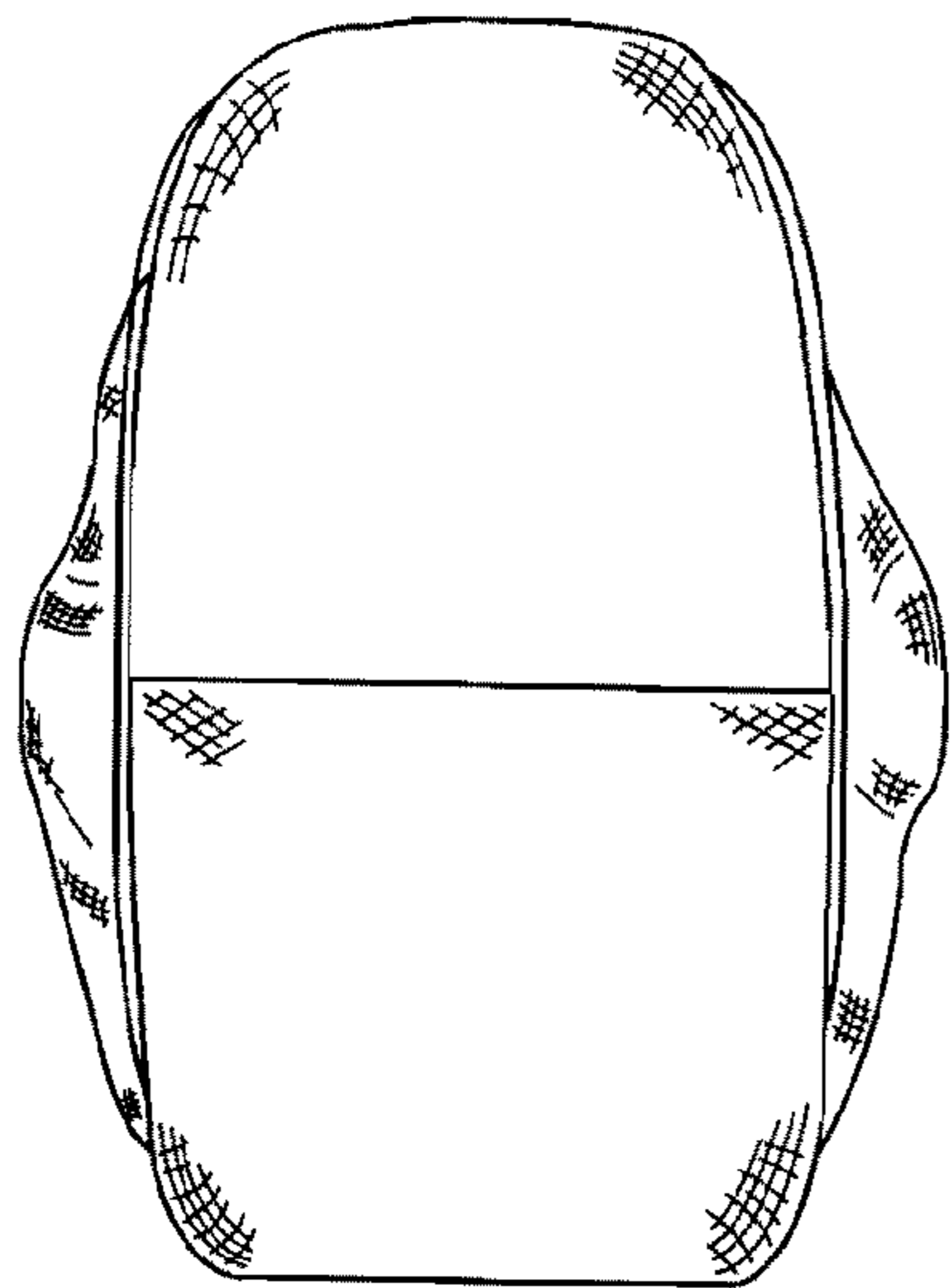

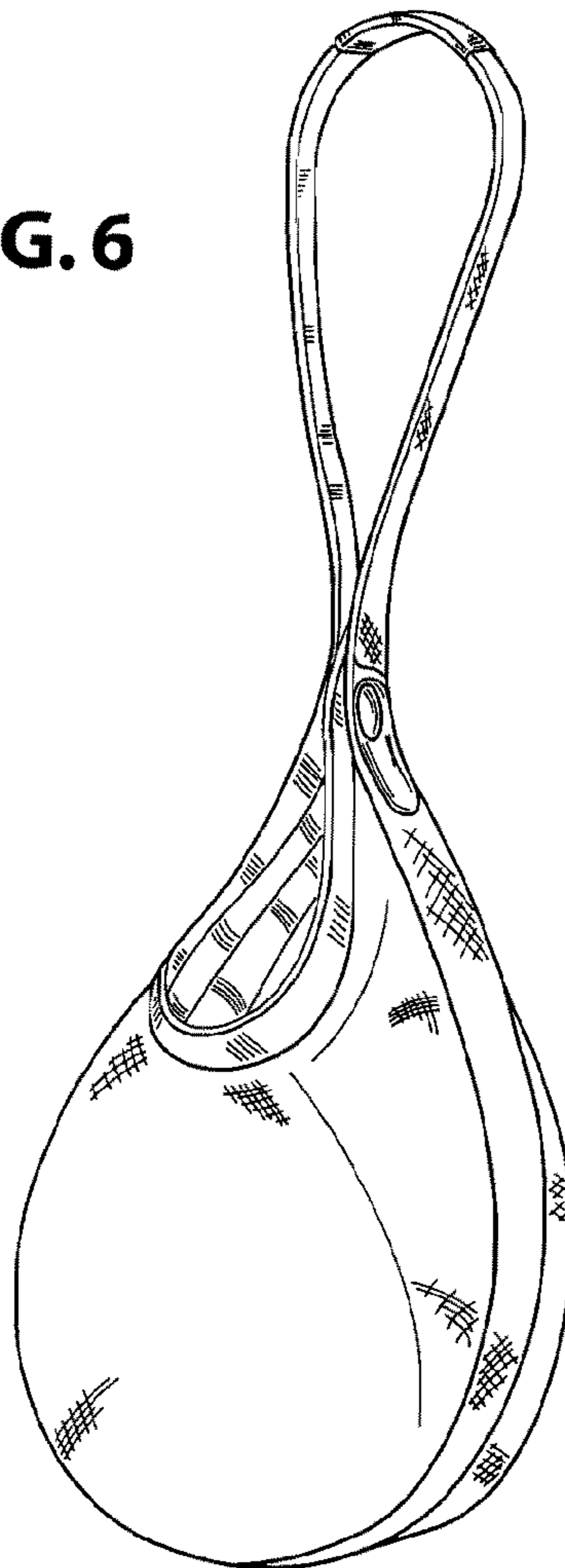
