FIG. 1 is a top perspective view of a disc holder showing my new design;

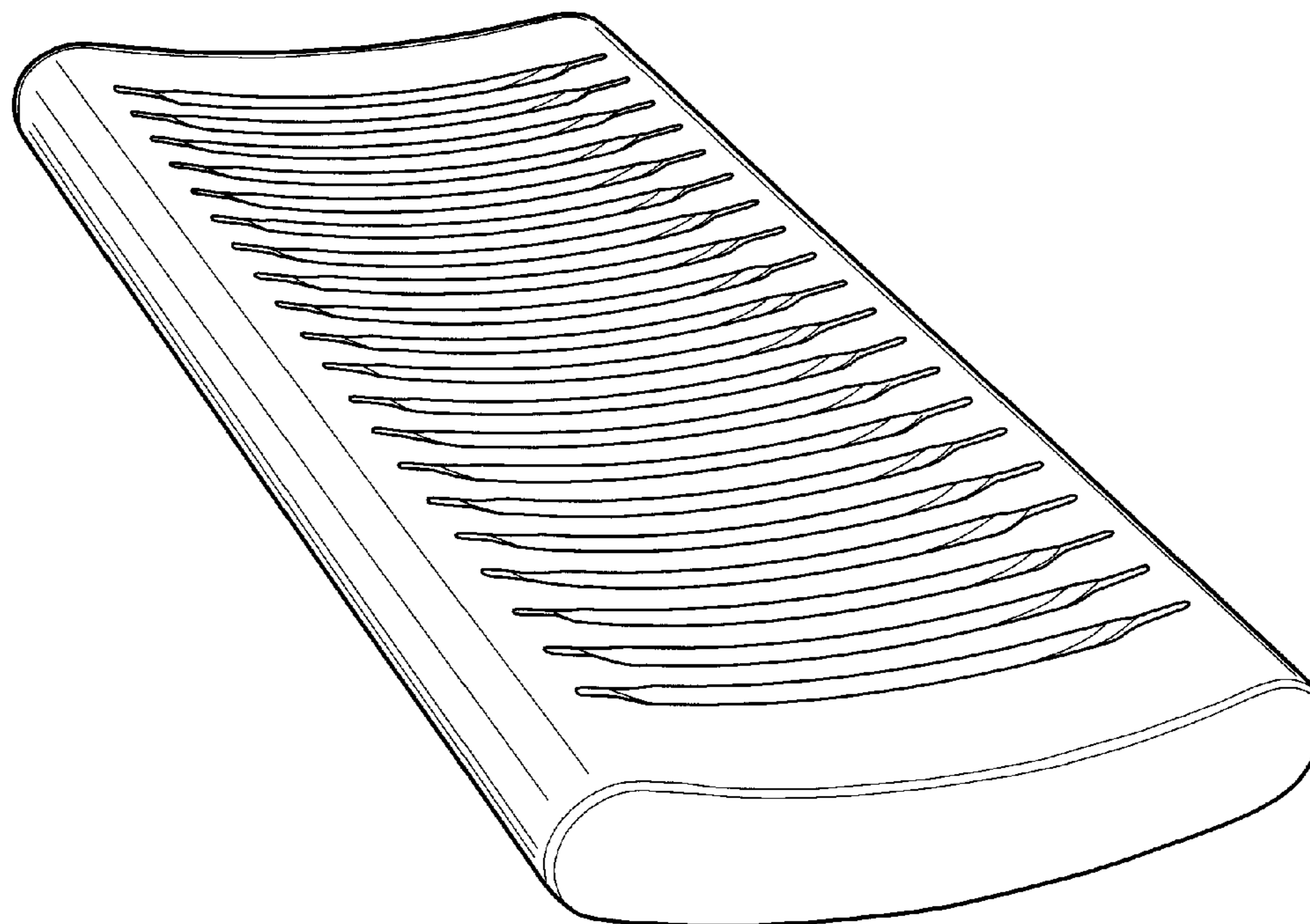
FIG. 2 is a plan view thereof;

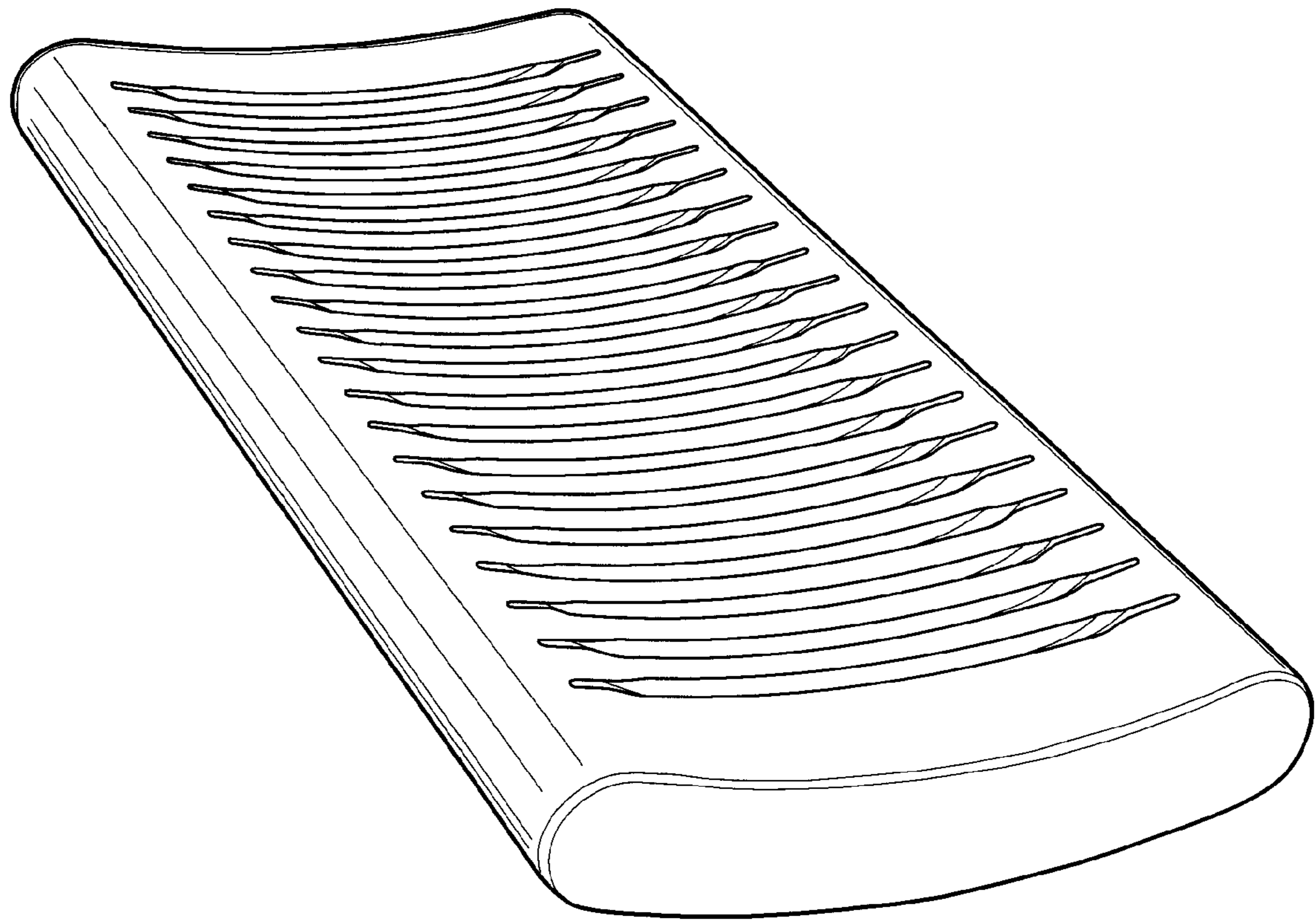

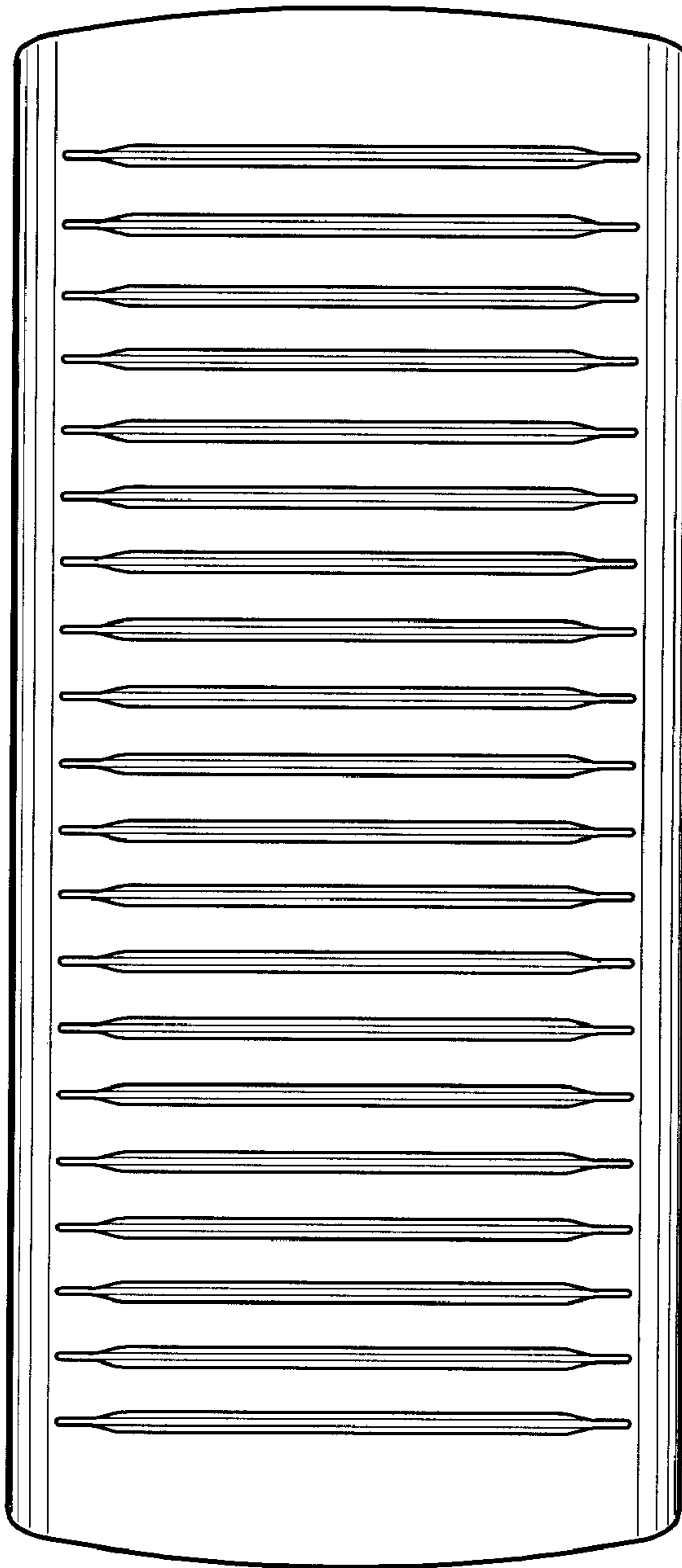

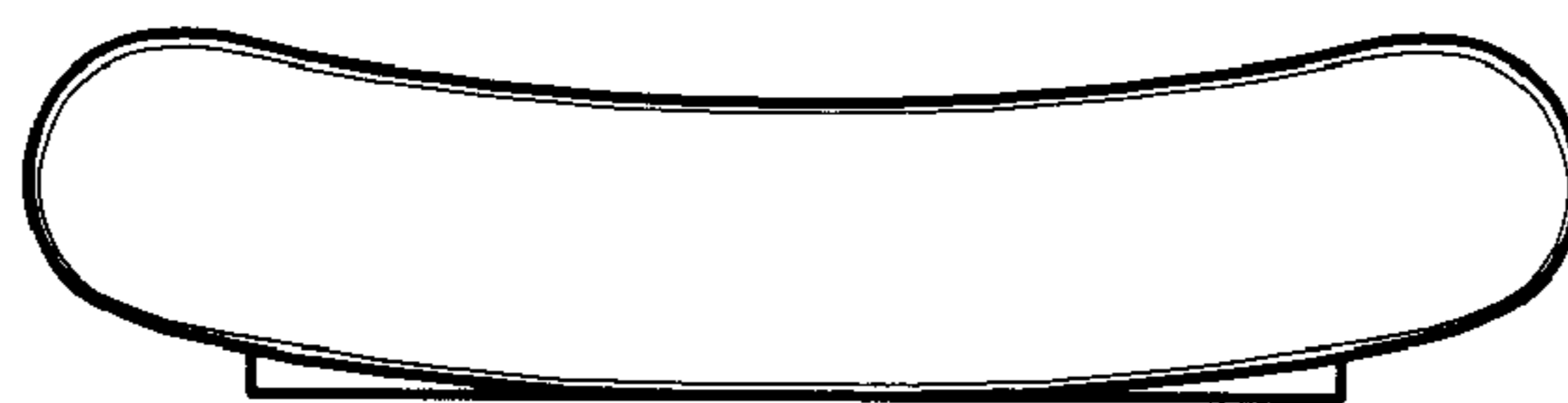

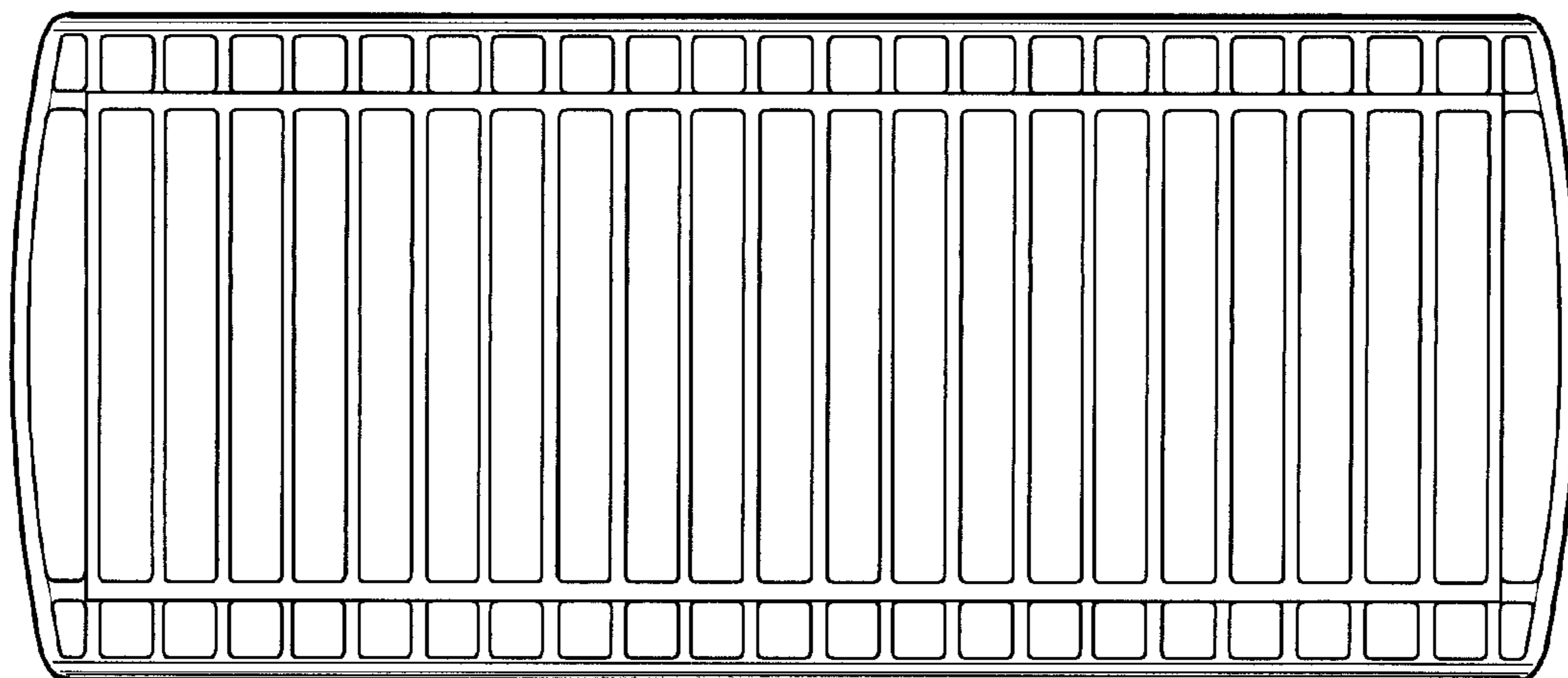

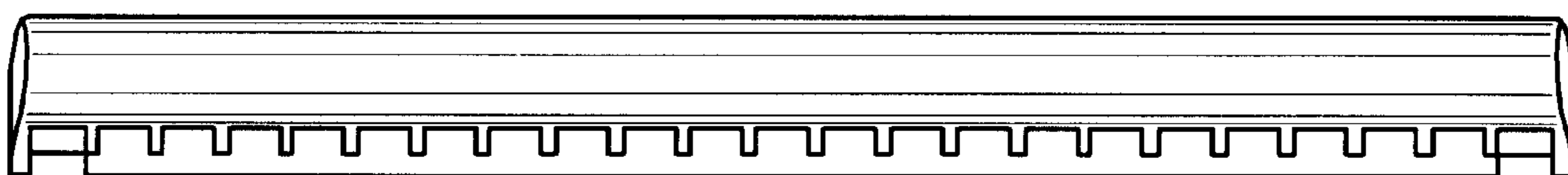
