The ornamental design for a campfire cooking griddle, as shown and described.

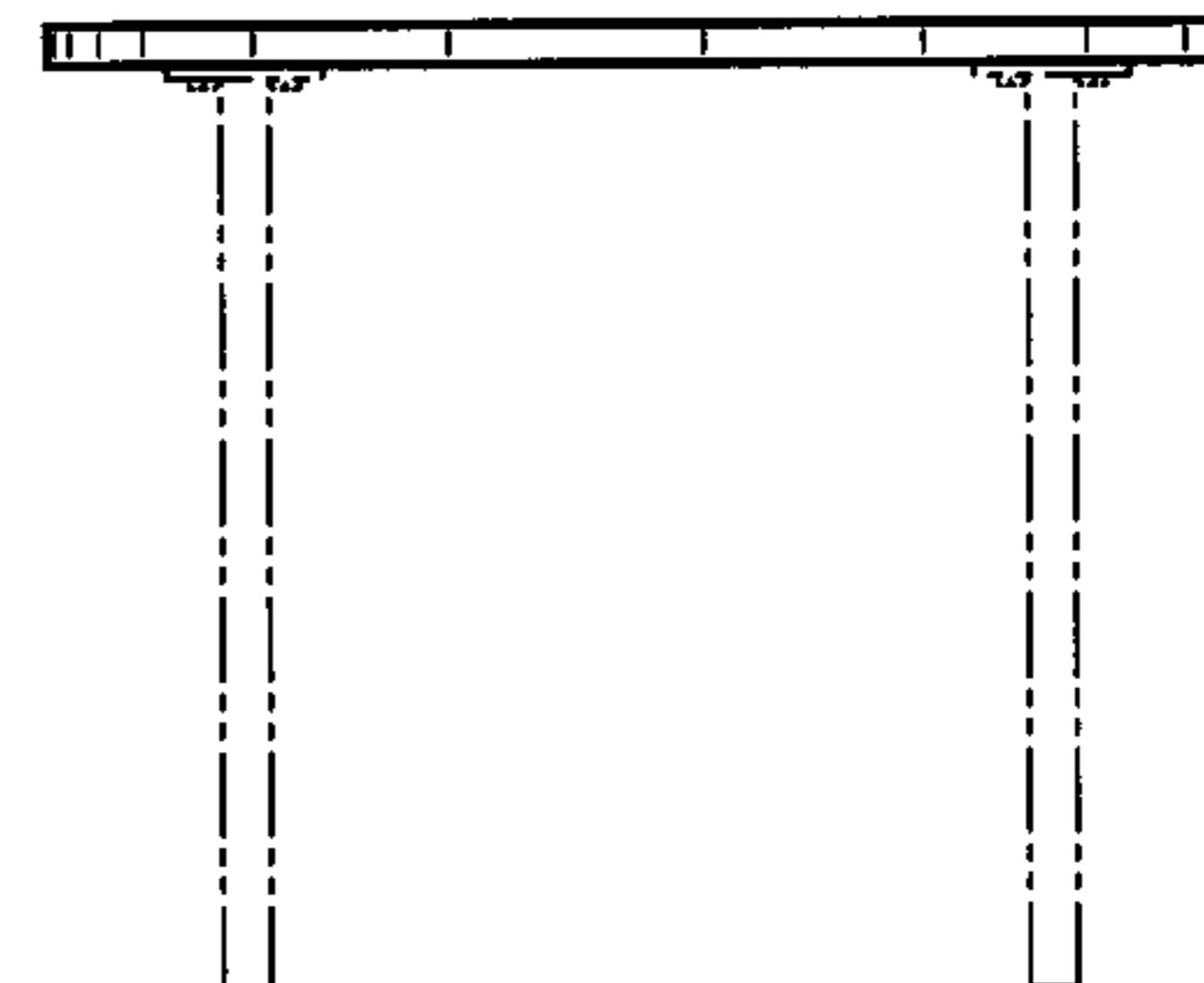
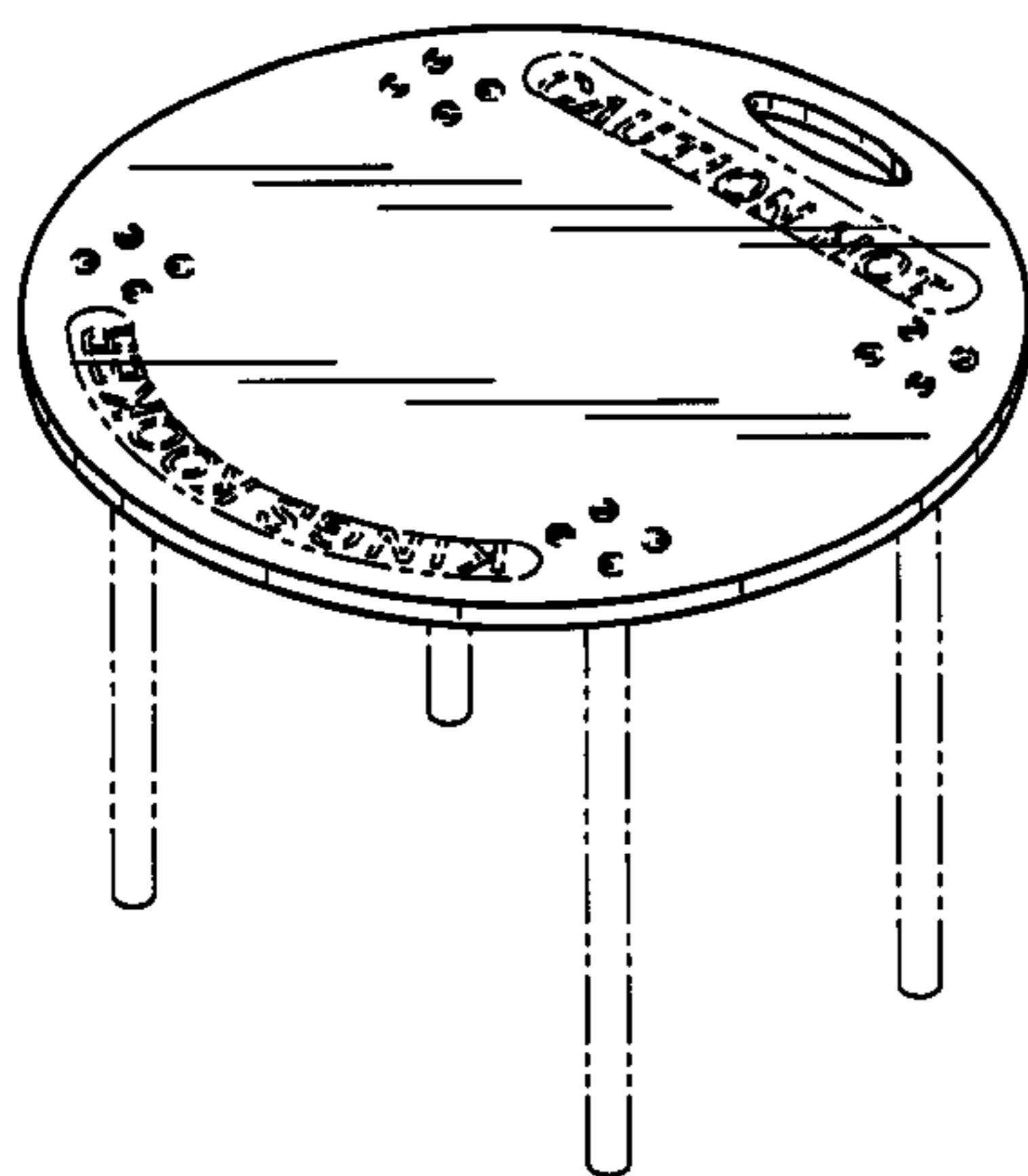
**DESCRIPTION**

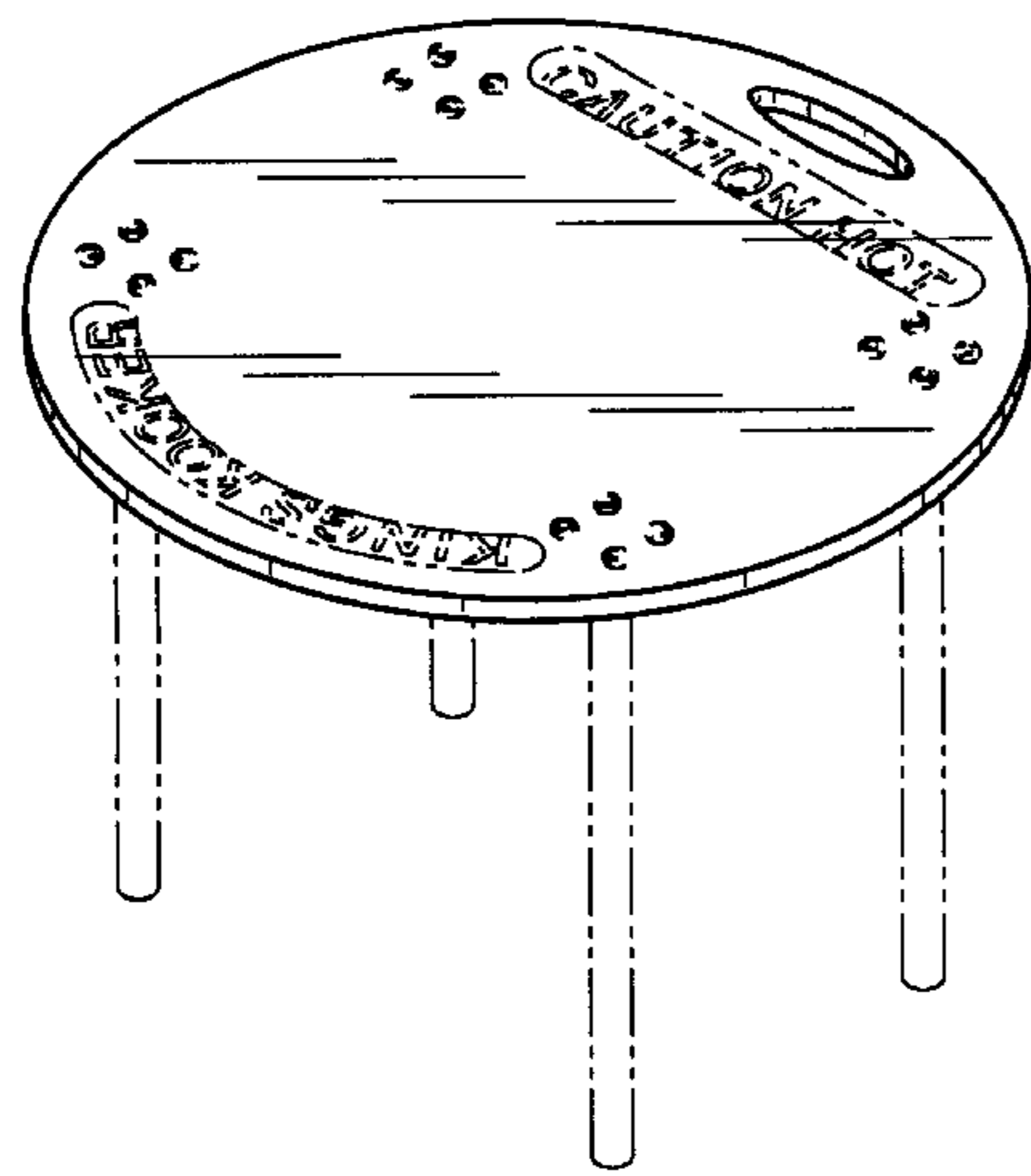

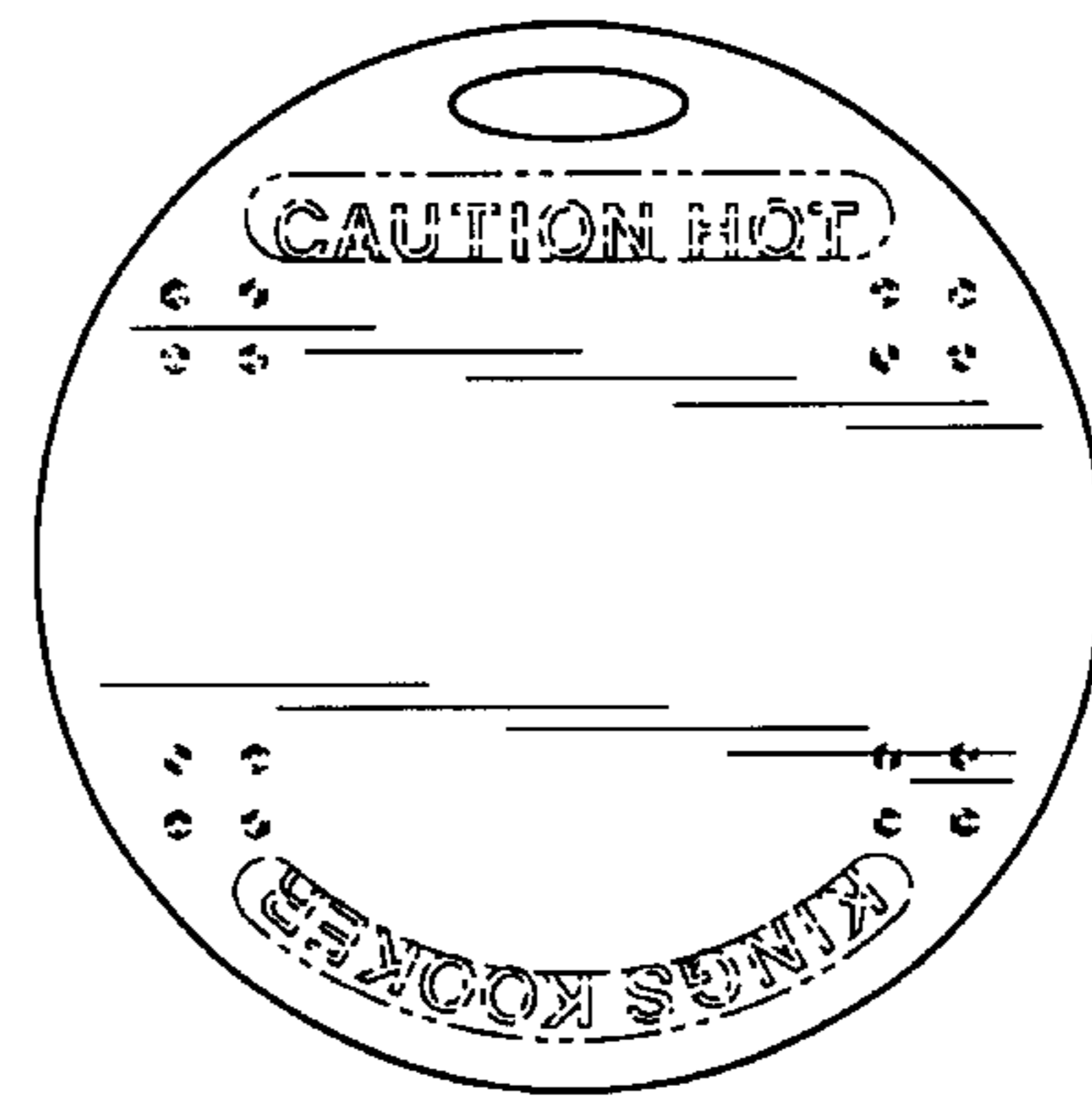

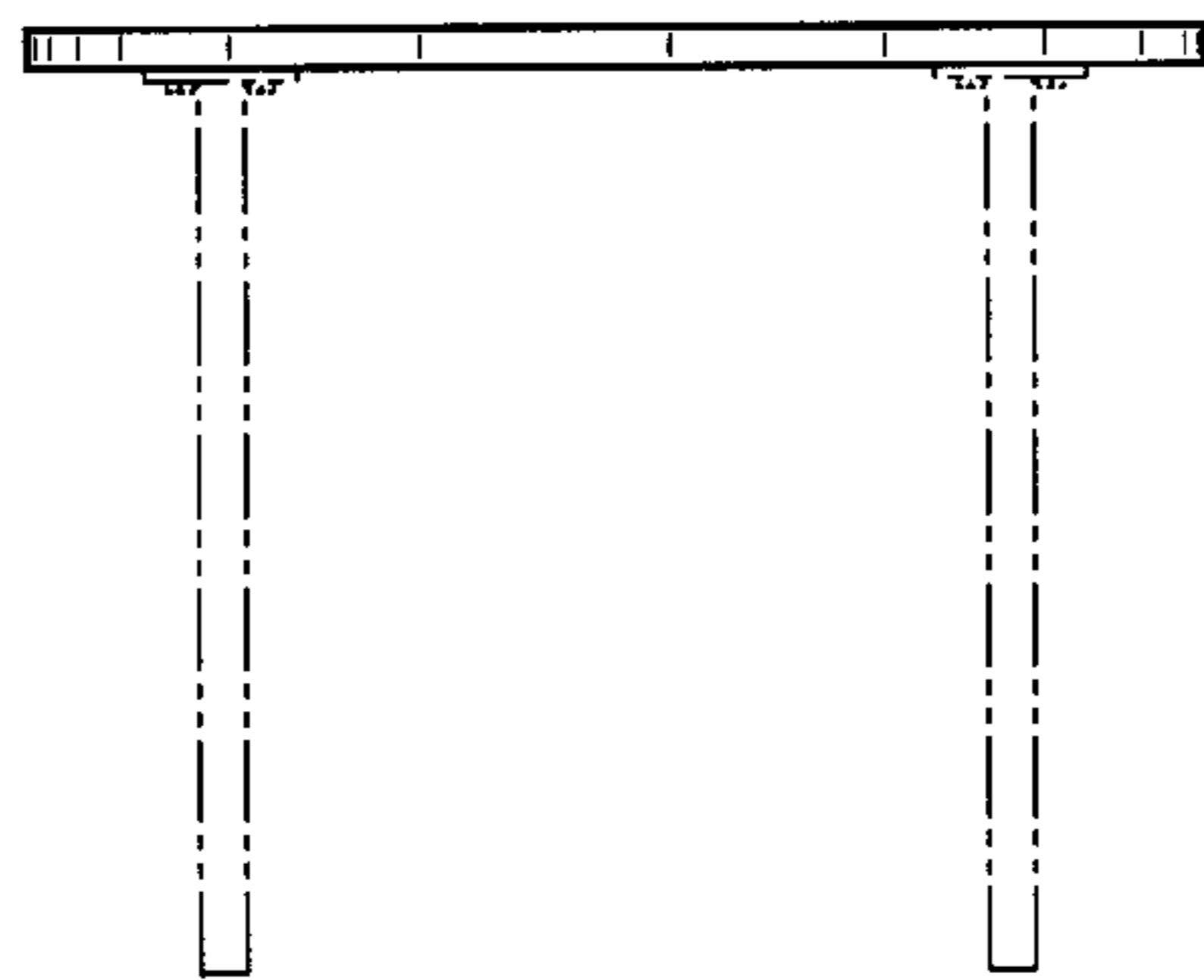
