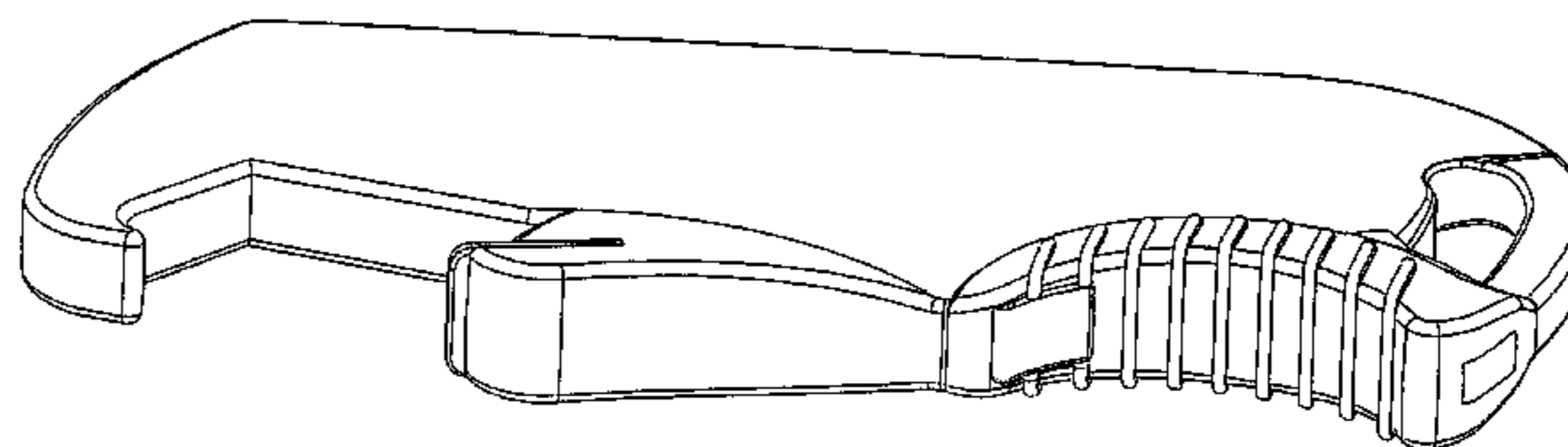
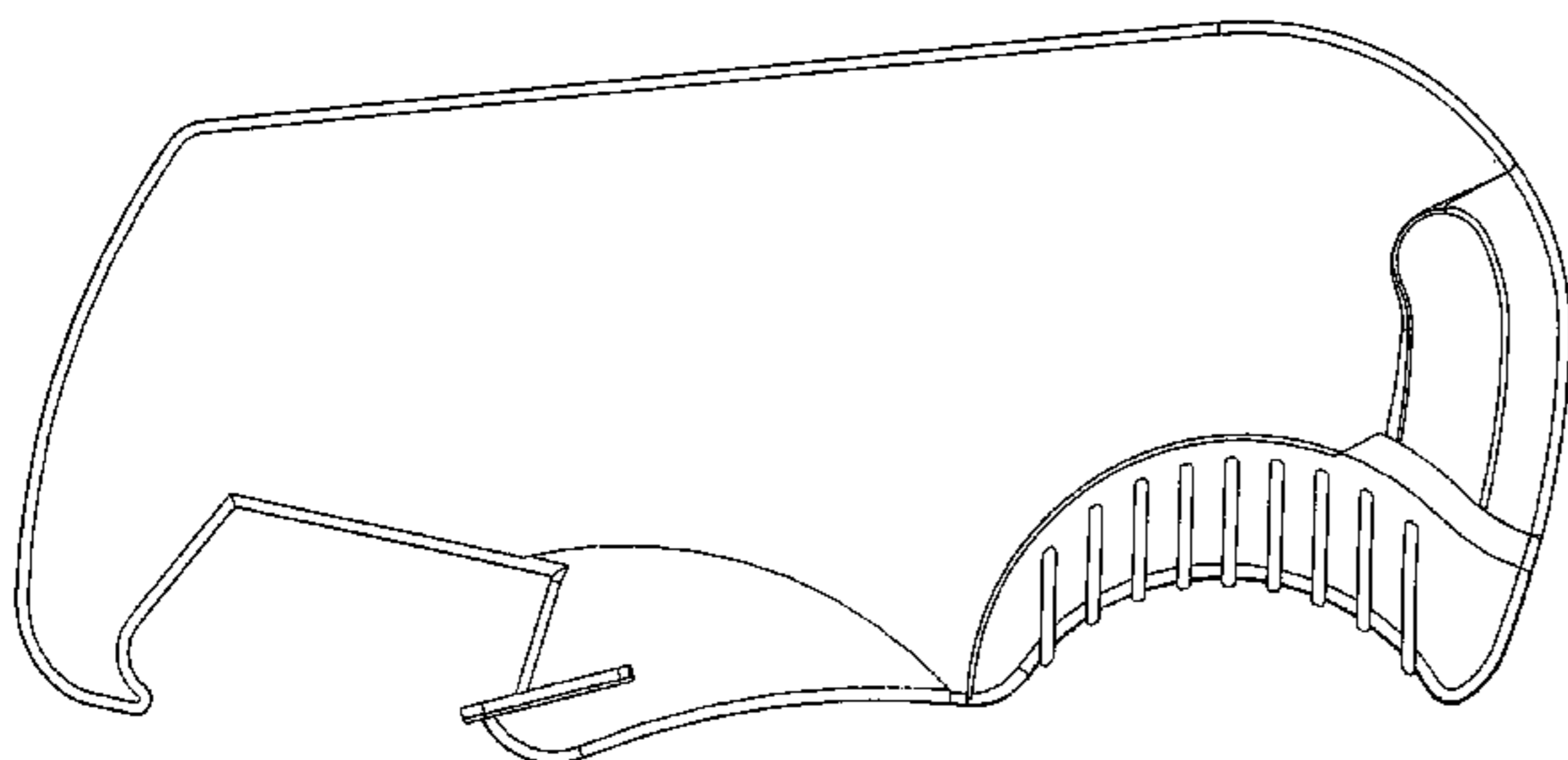
(57) **CLAIM**

The ornamental design for a bottle opener, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a bottle opener showing my new design;
FIG. 2 is a left side elevational view thereof;

FIG. 4 is a rear perspective view thereof;
FIG. 5 is a bottom, right side perspective view thereof;

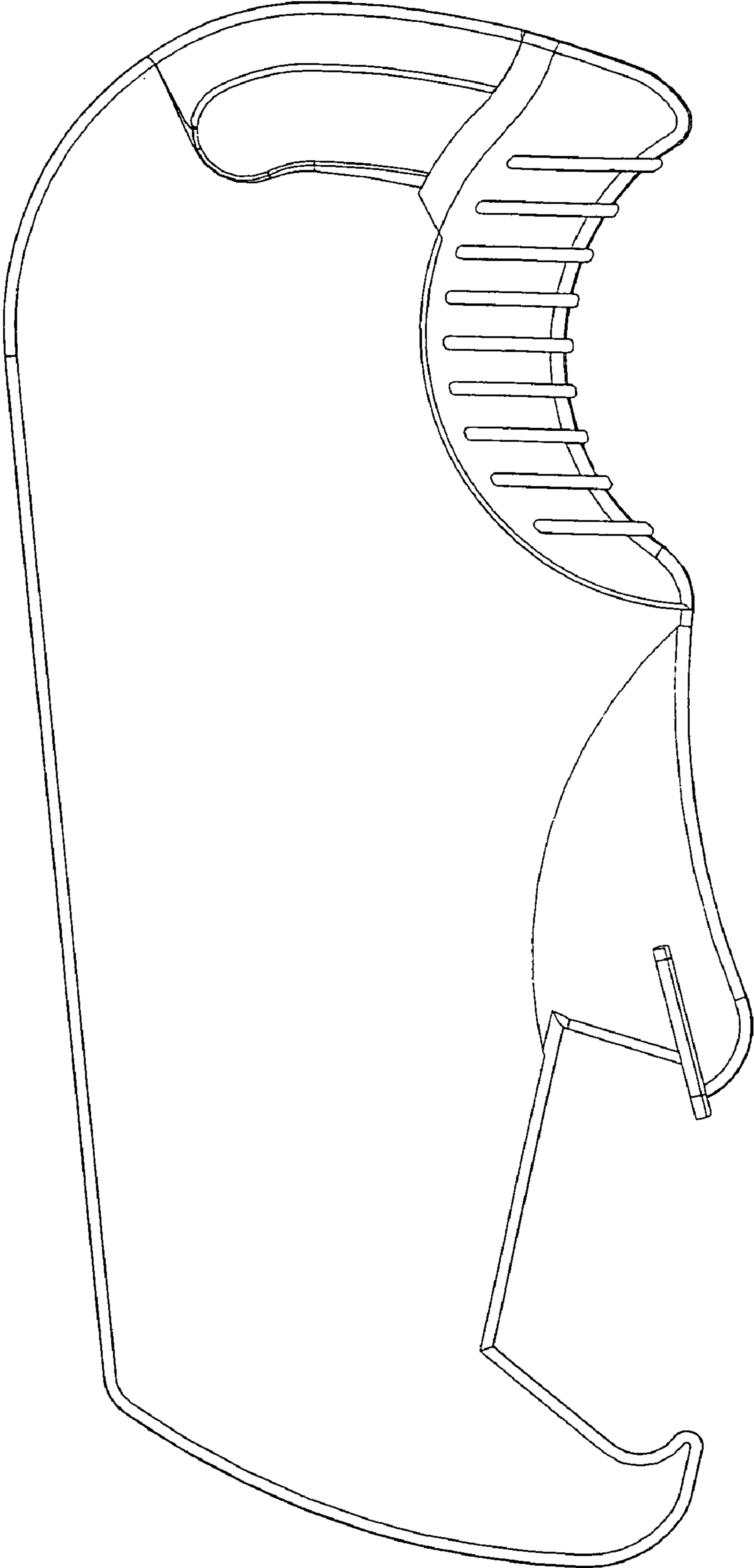

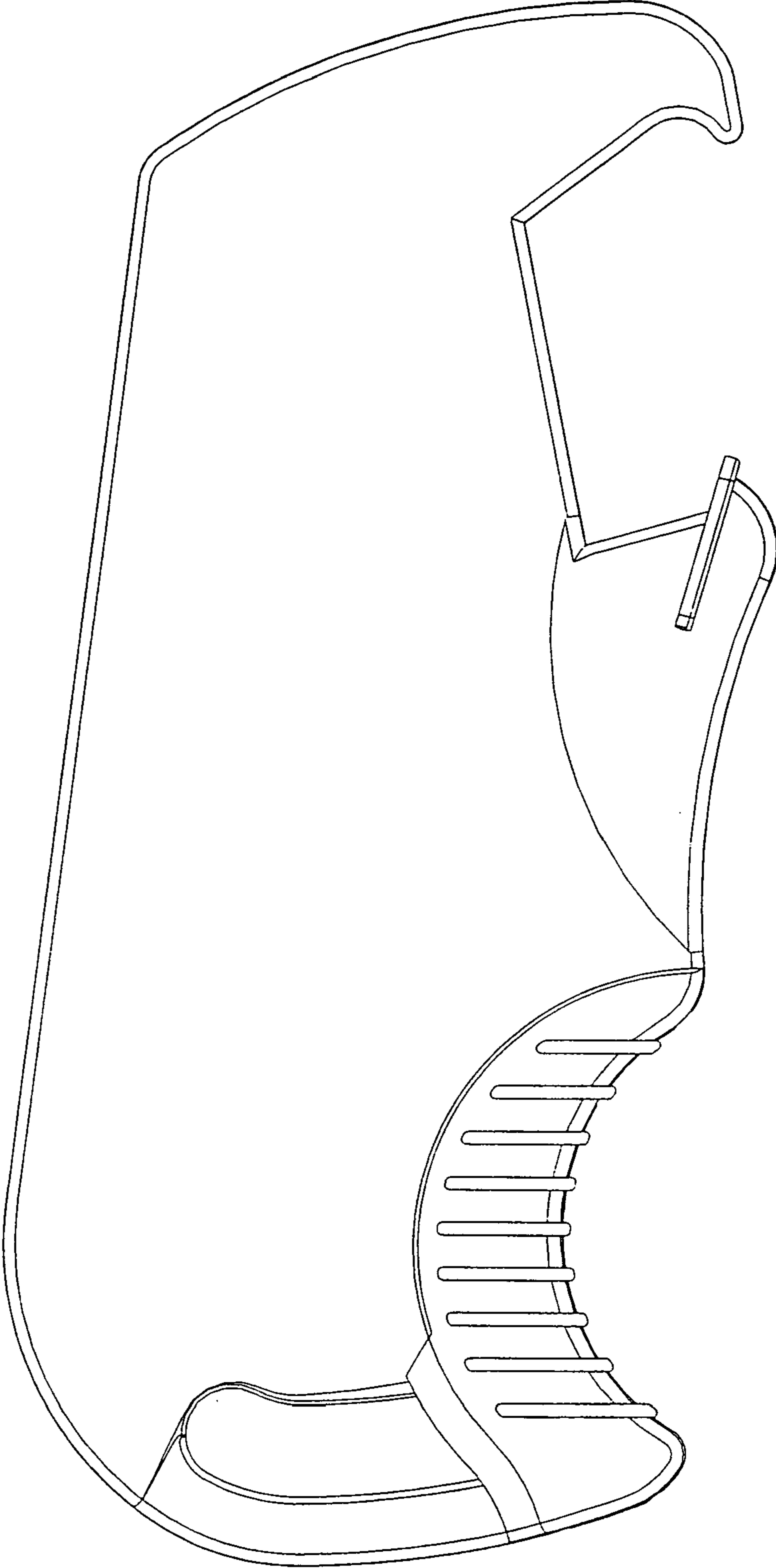
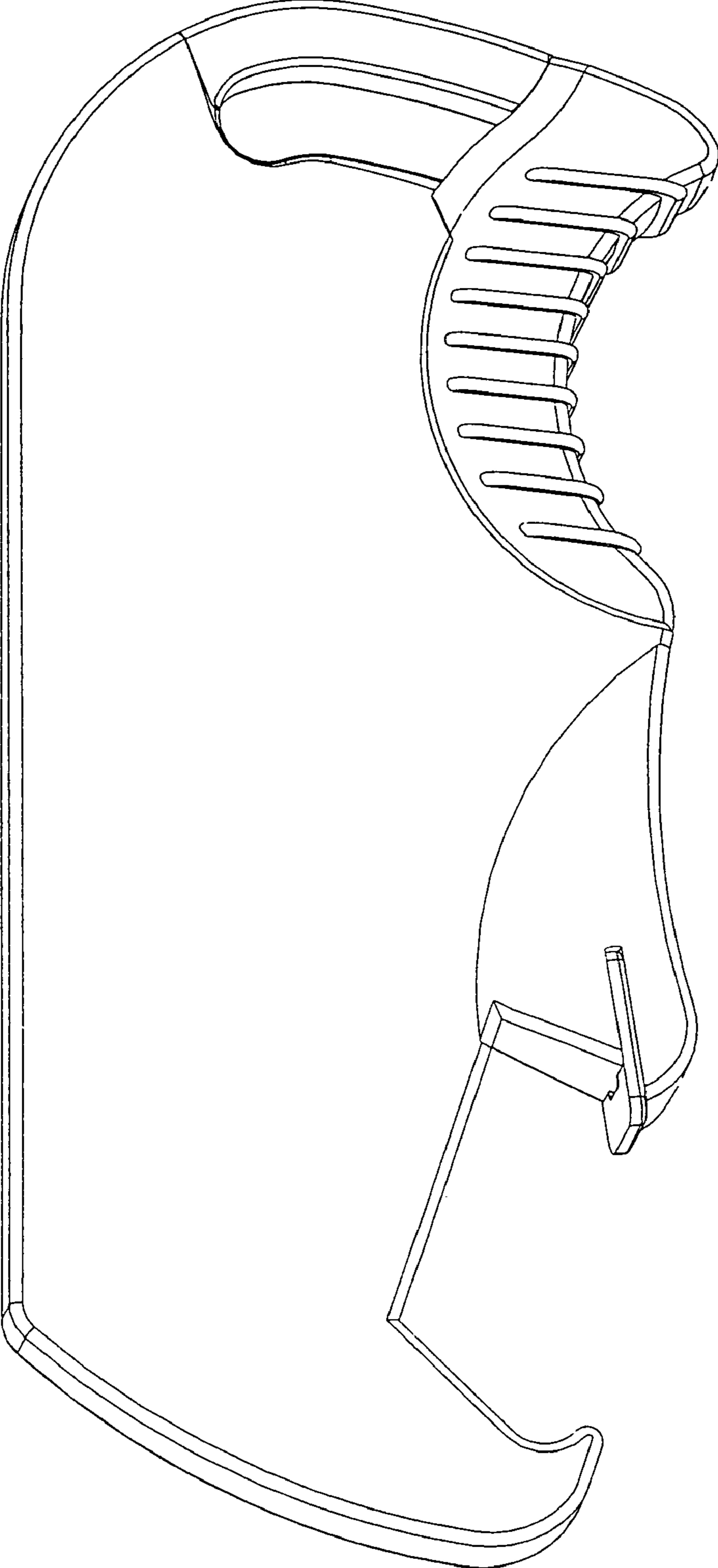

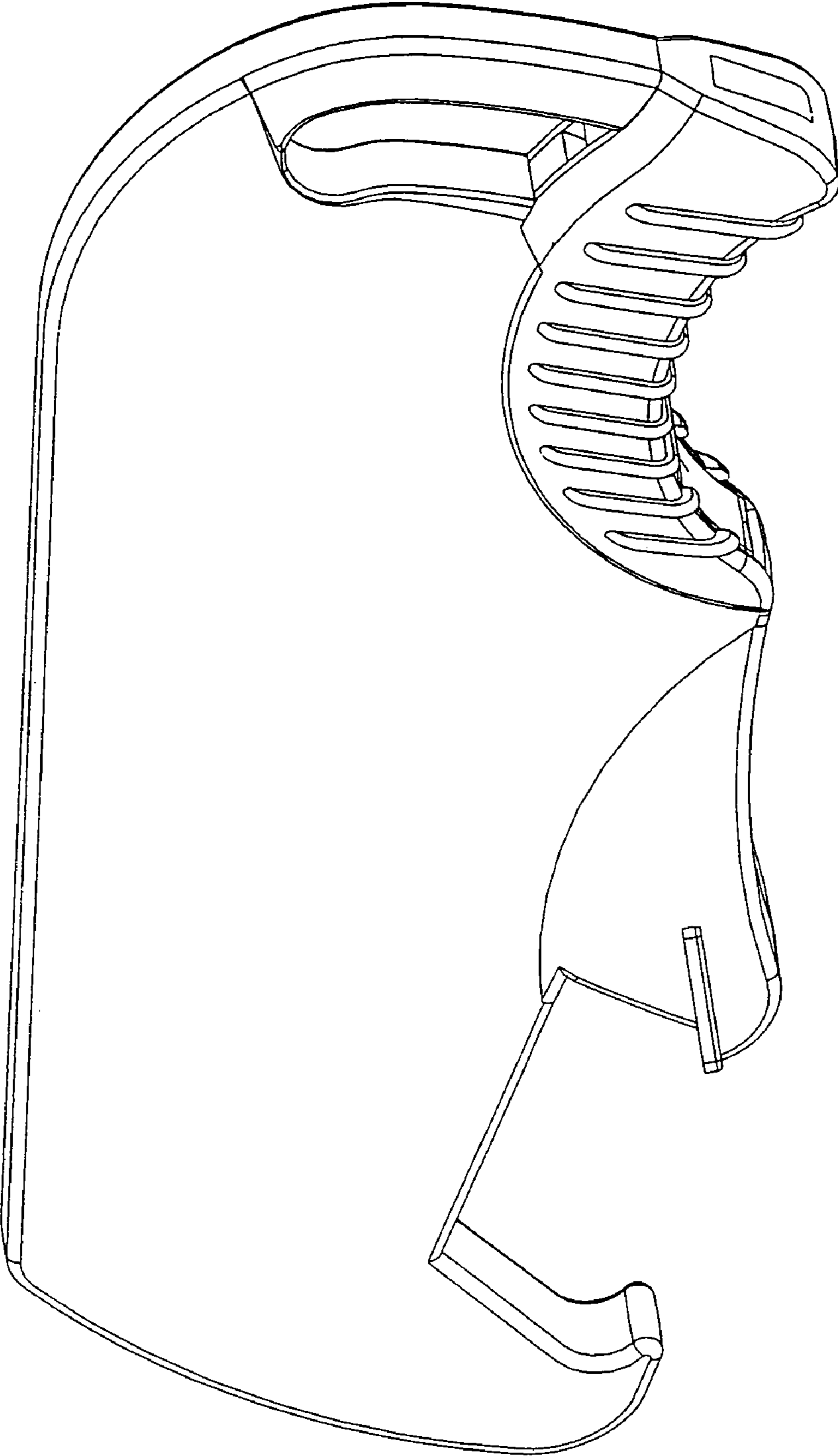

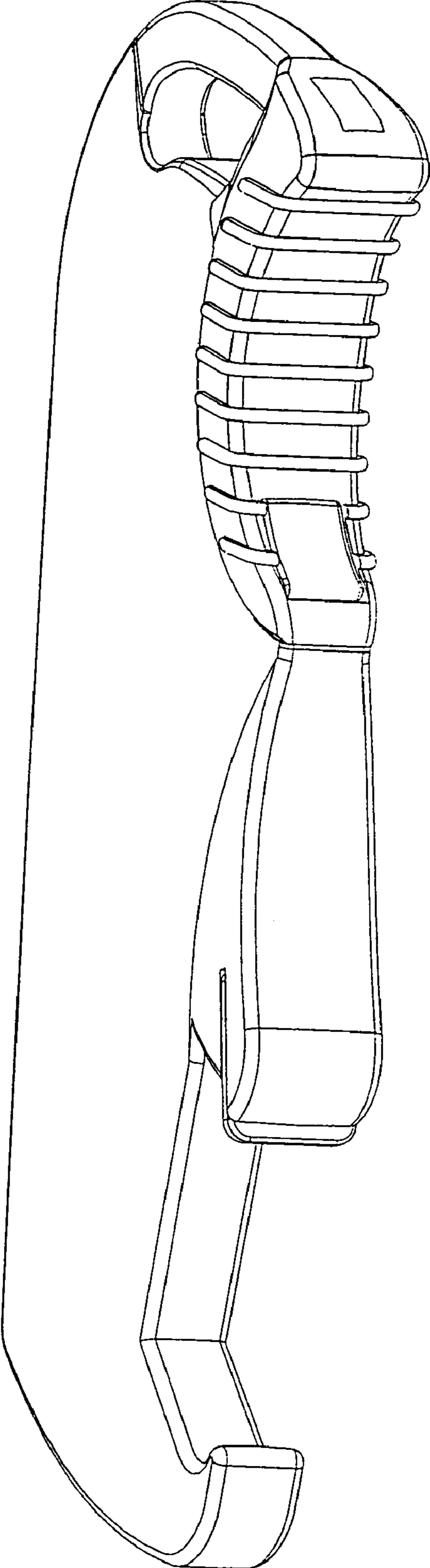

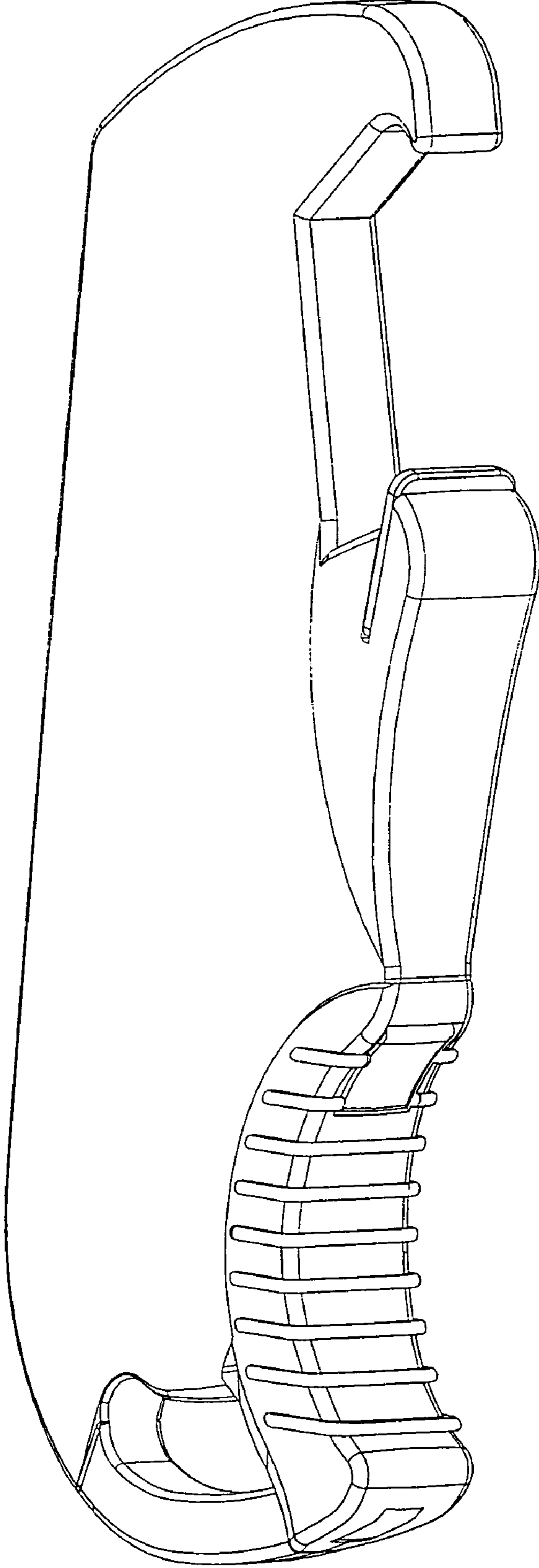

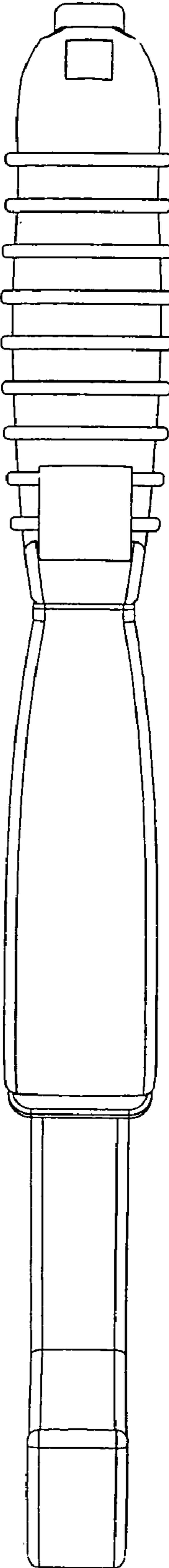
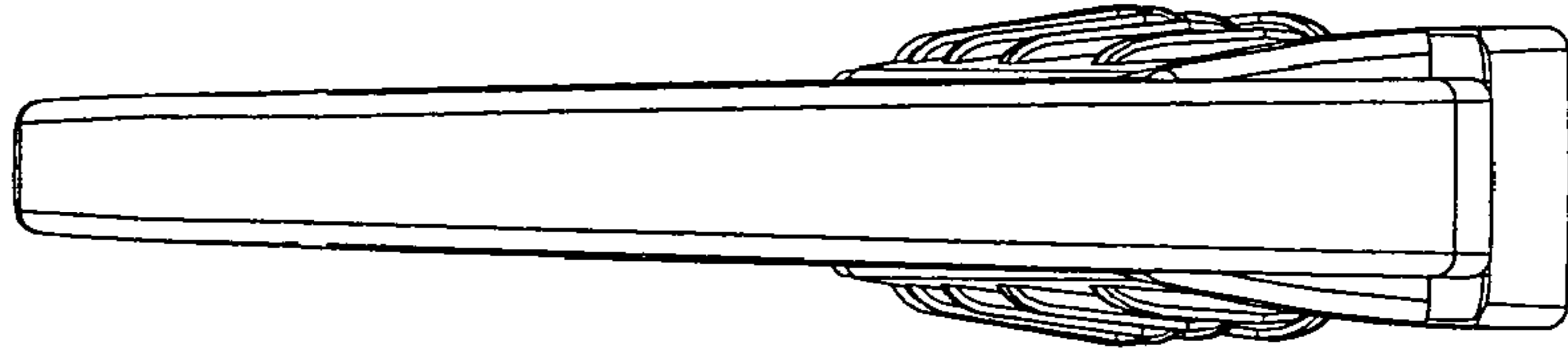

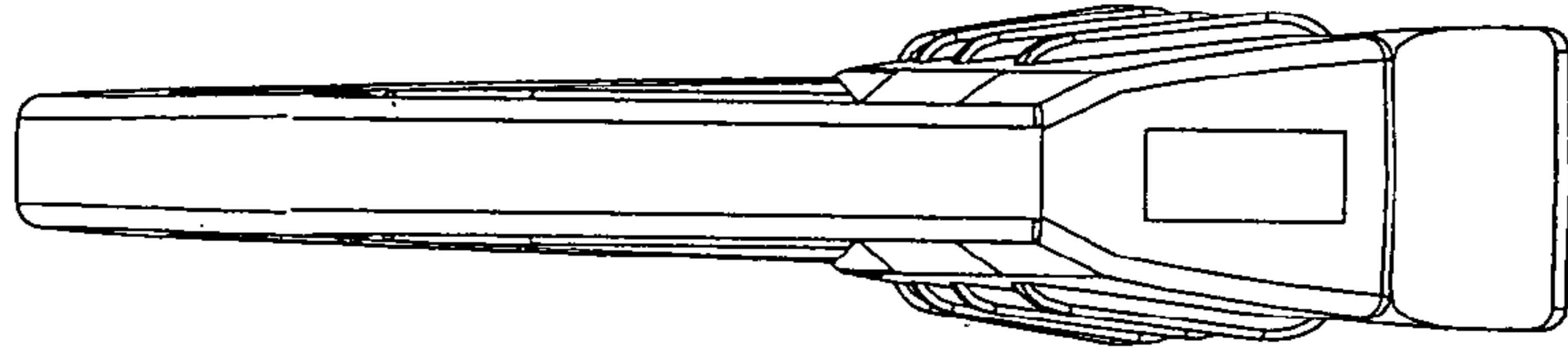
