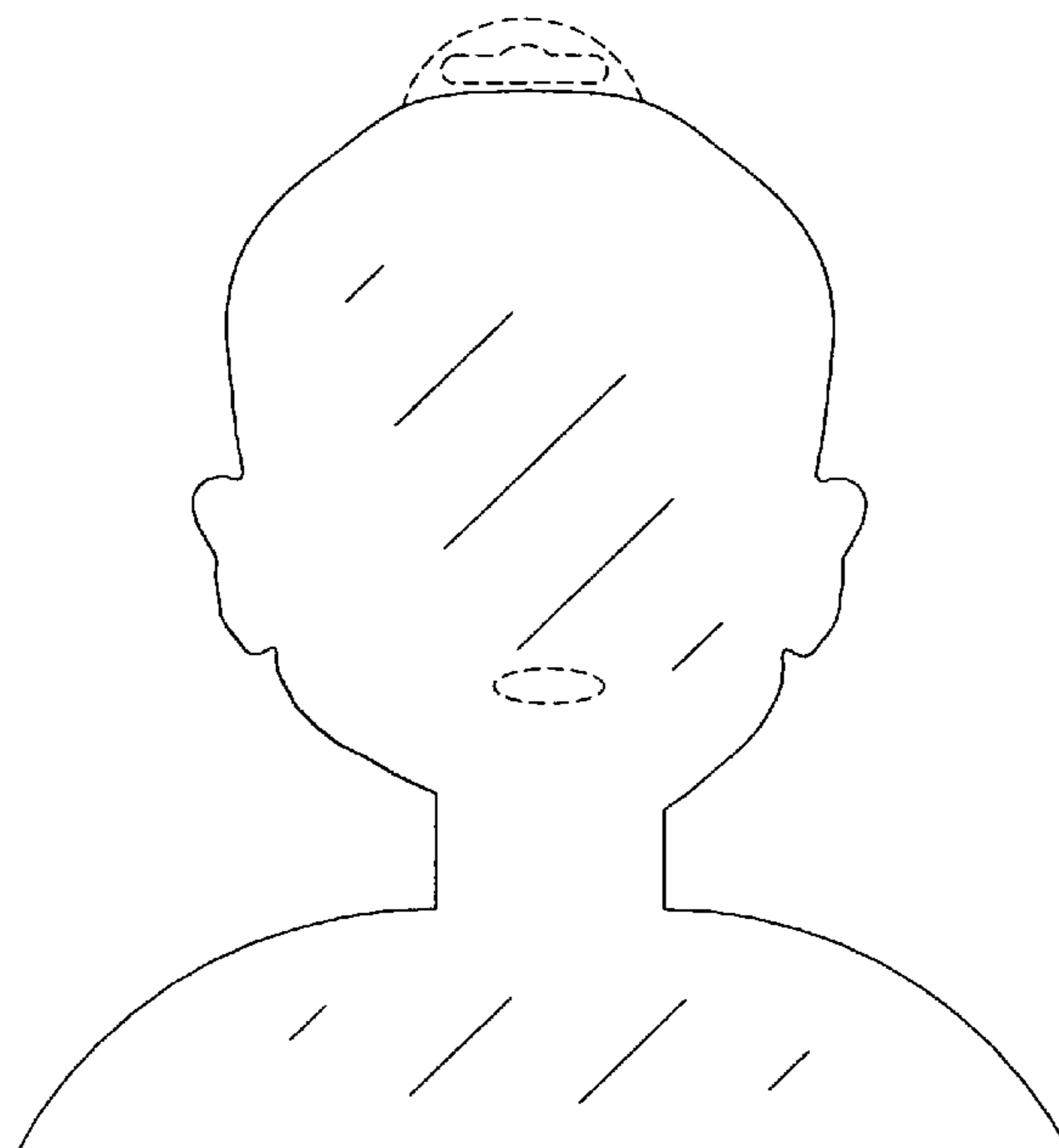
FIG. 1 is a front elevation view of the packaging for pacifier and clothing, showing my new design; and

FIG. 2 is an exploded perspective view of the packaging for pacifier and clothing shown in FIG. 1 and illustrates an exemplary use thereof as a point-of-purchase packaging display for an item of clothing and a pacifier with blister-packaging; and,

FIG. 3 is a perspective view of the packaging for pacifier and clothing shown in FIG. 1 being used, by way of example only, as a point-of-purchase packaging display for the exemplary clothing item and pacifier with blister-packaging shown in FIG. 2.

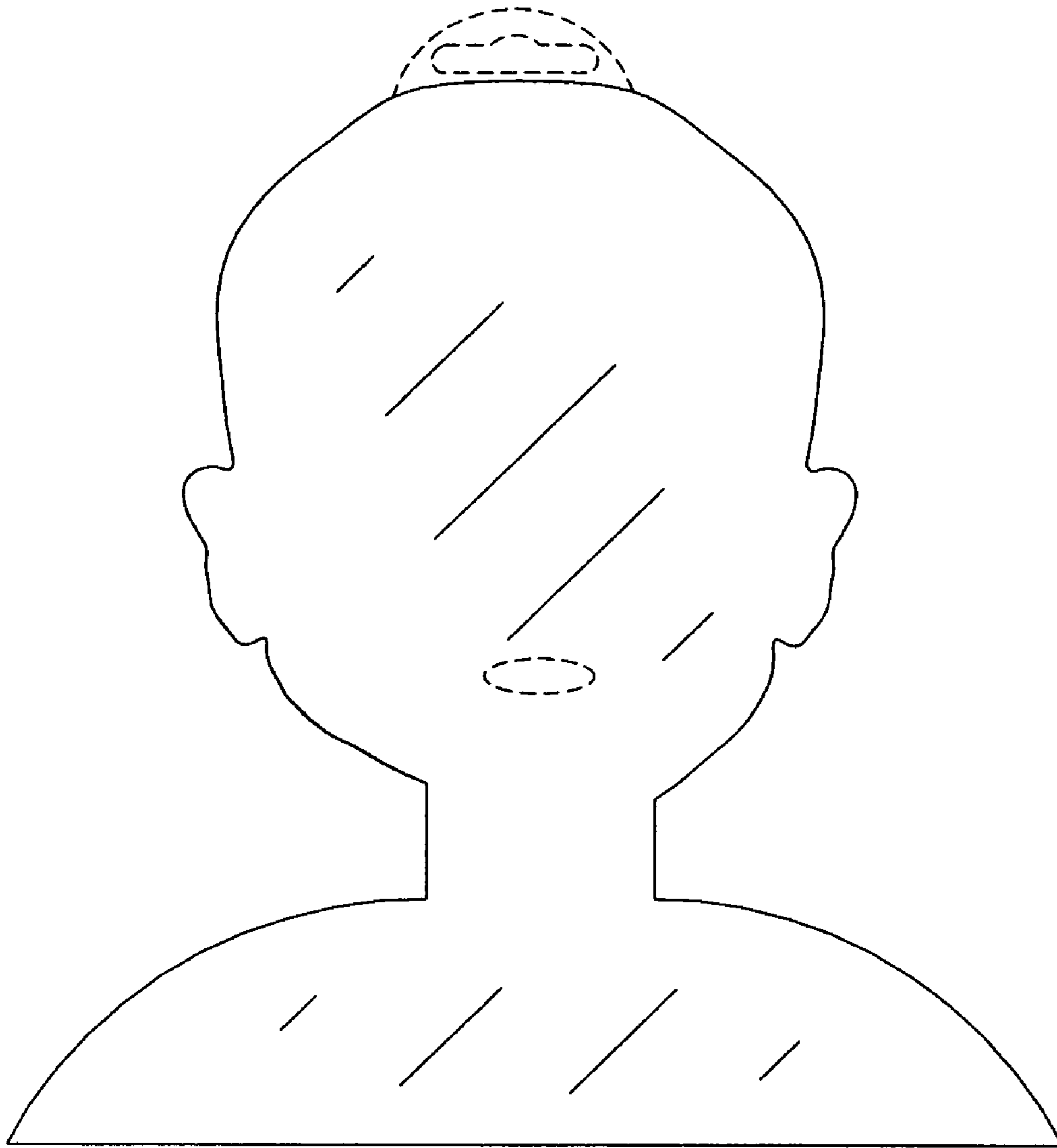

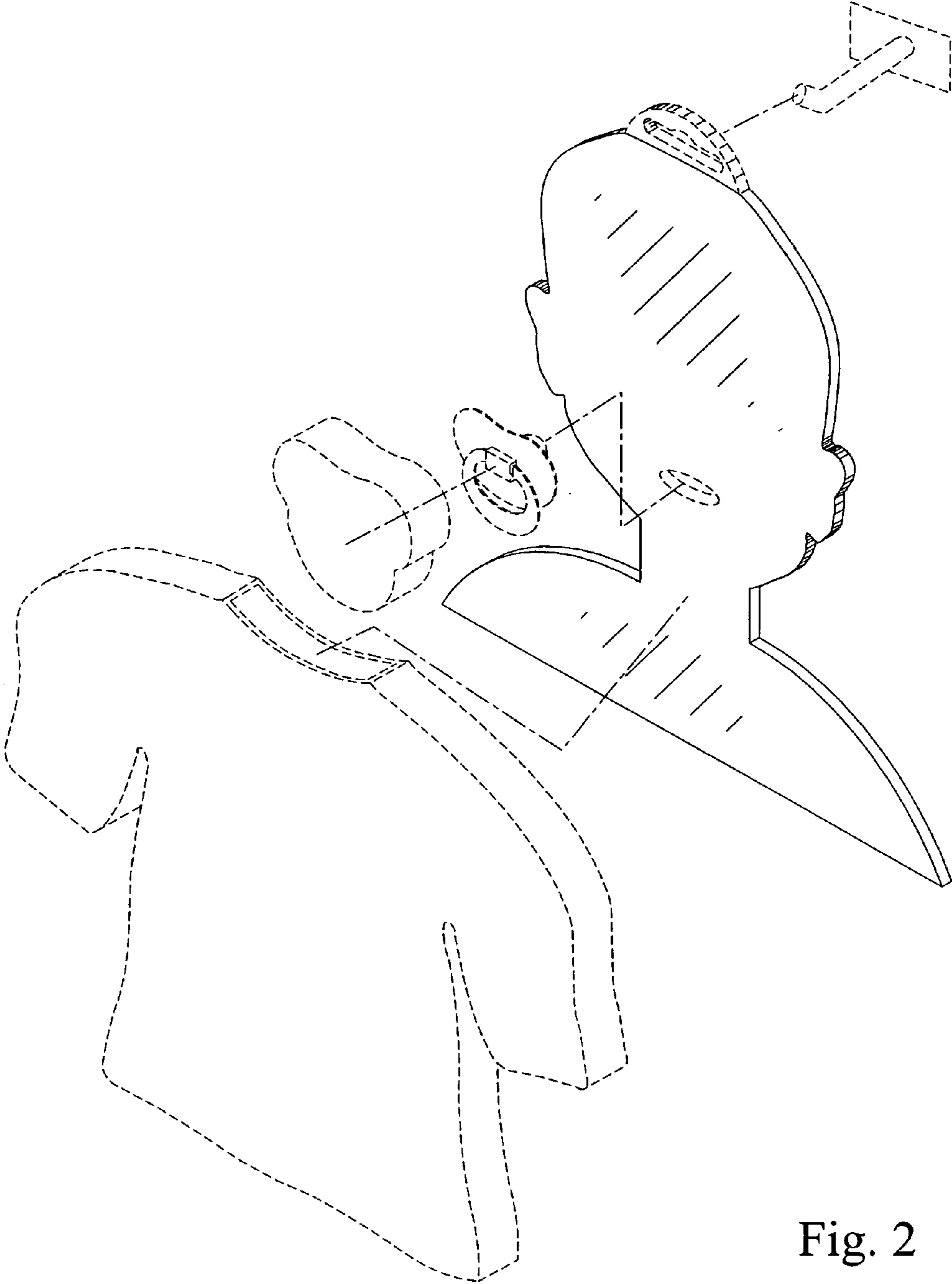

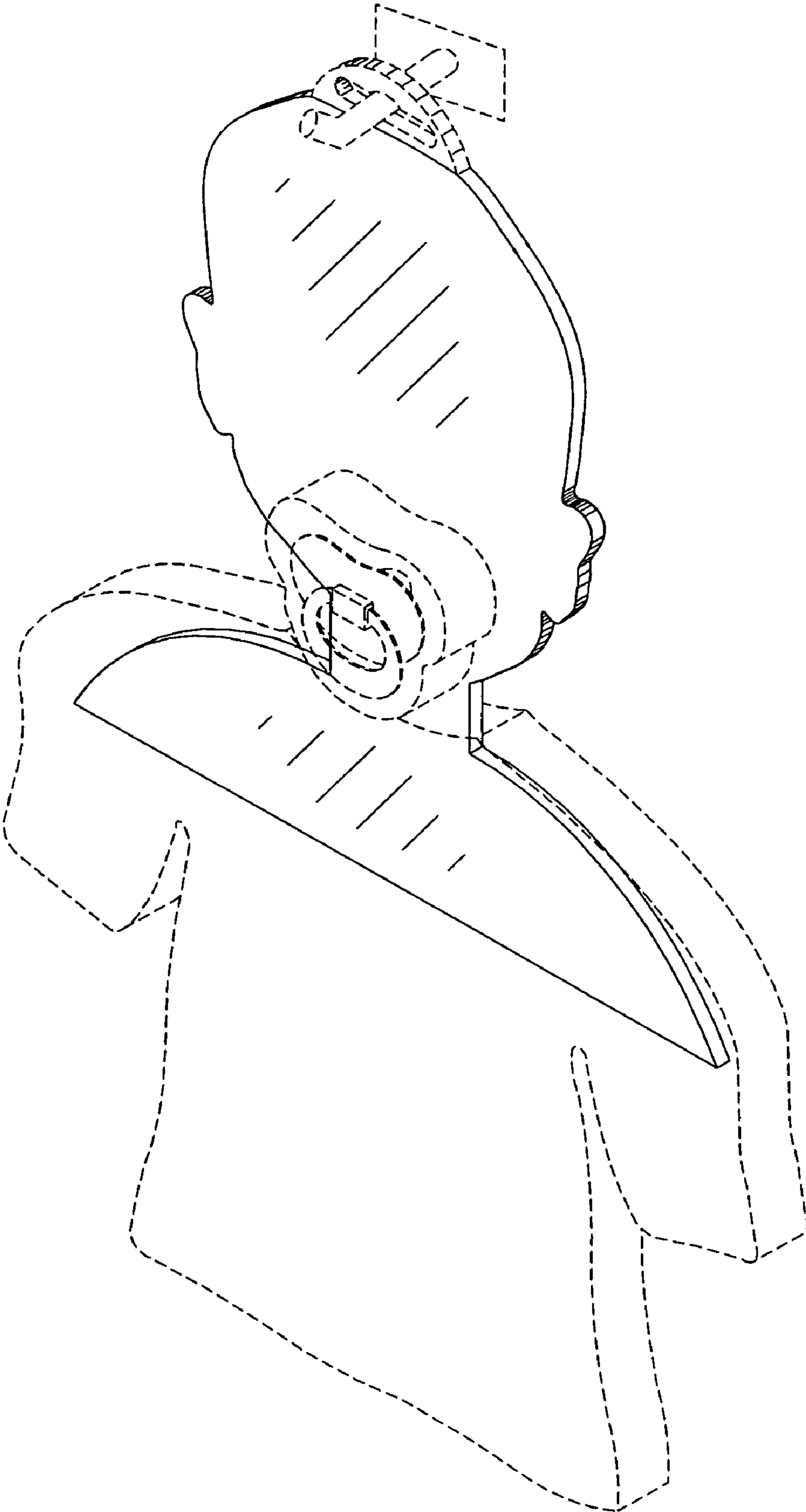
