I claim the ornamental design for a liquid container with cap, as shown and described.

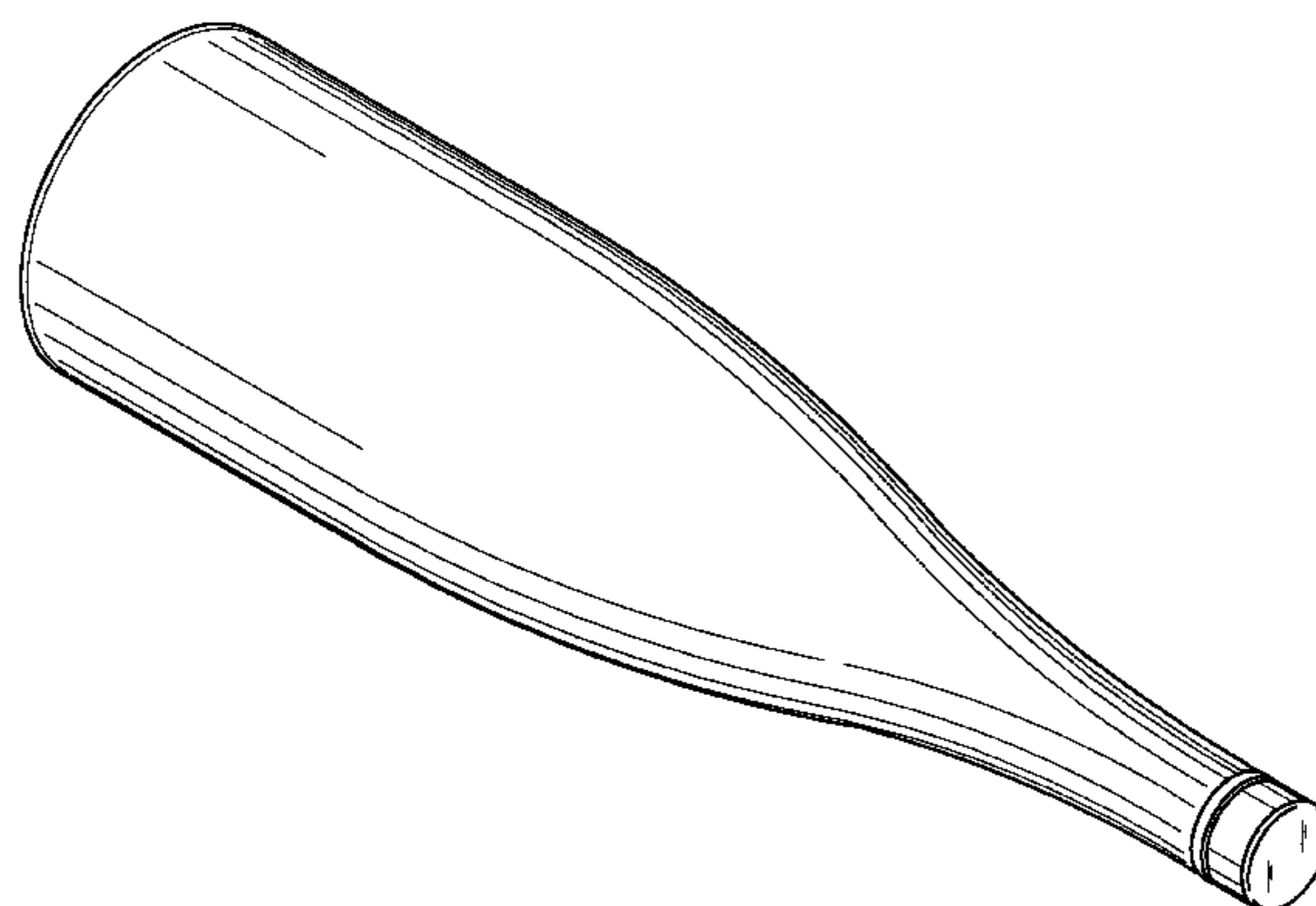
**DESCRIPTION**

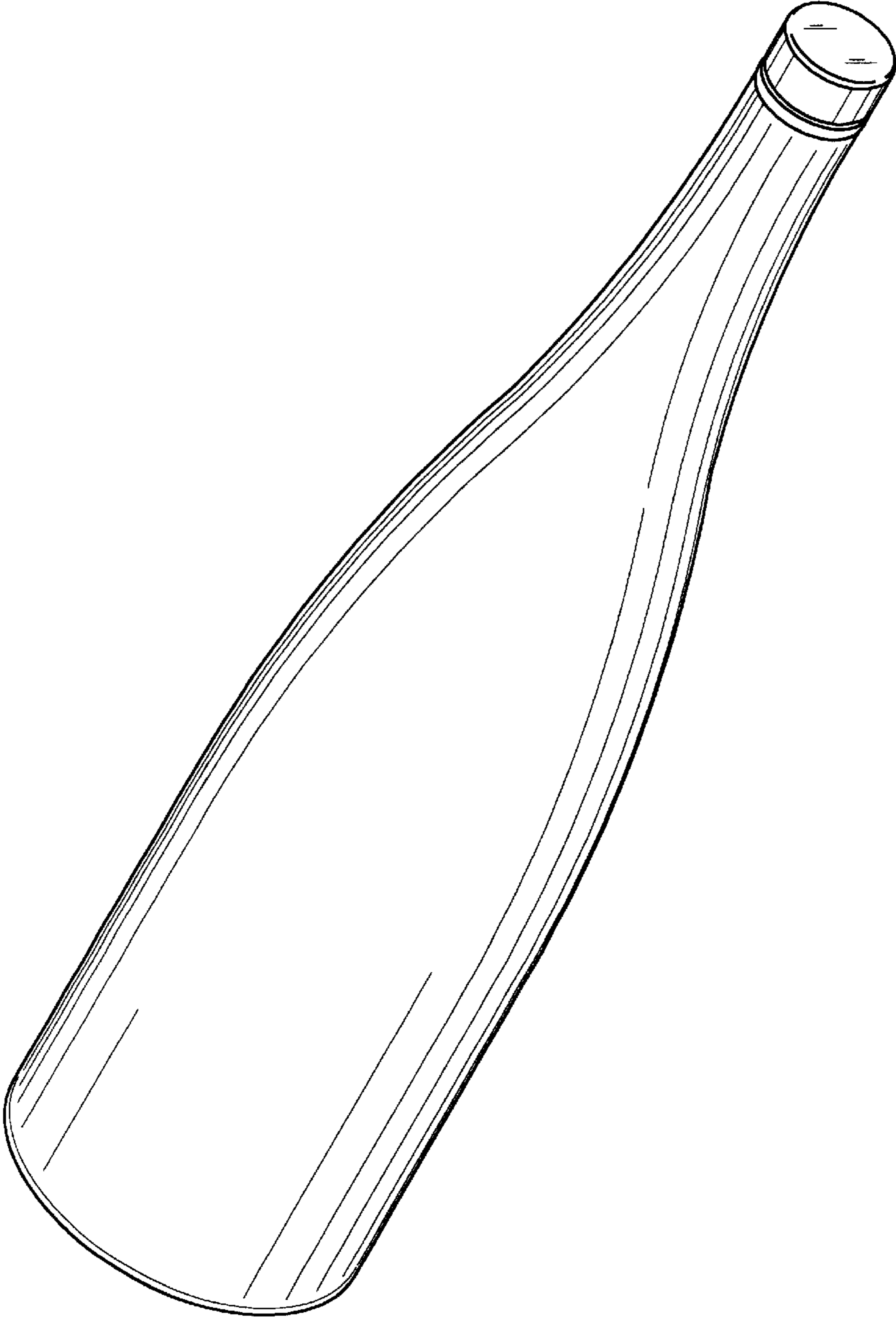

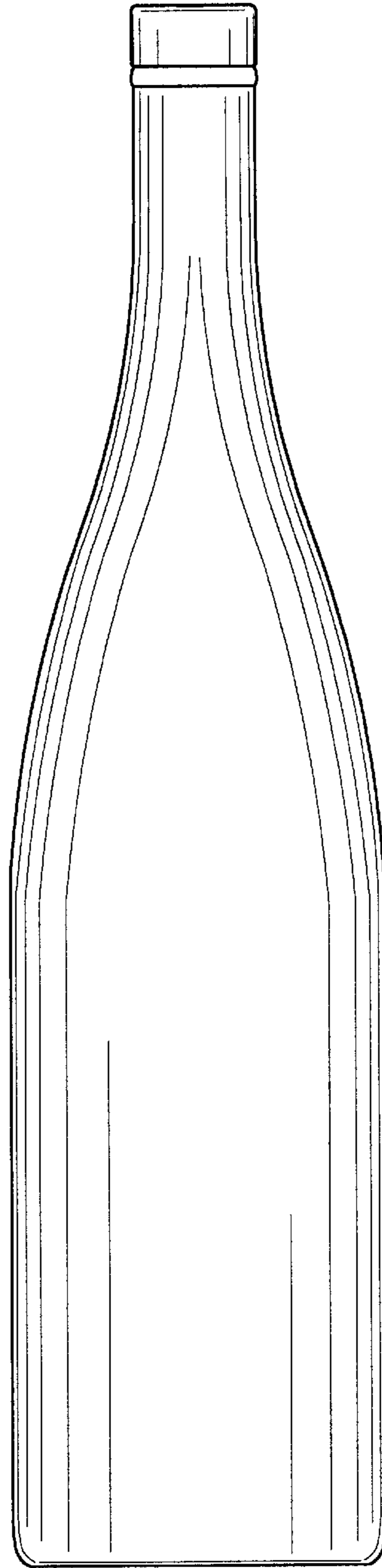

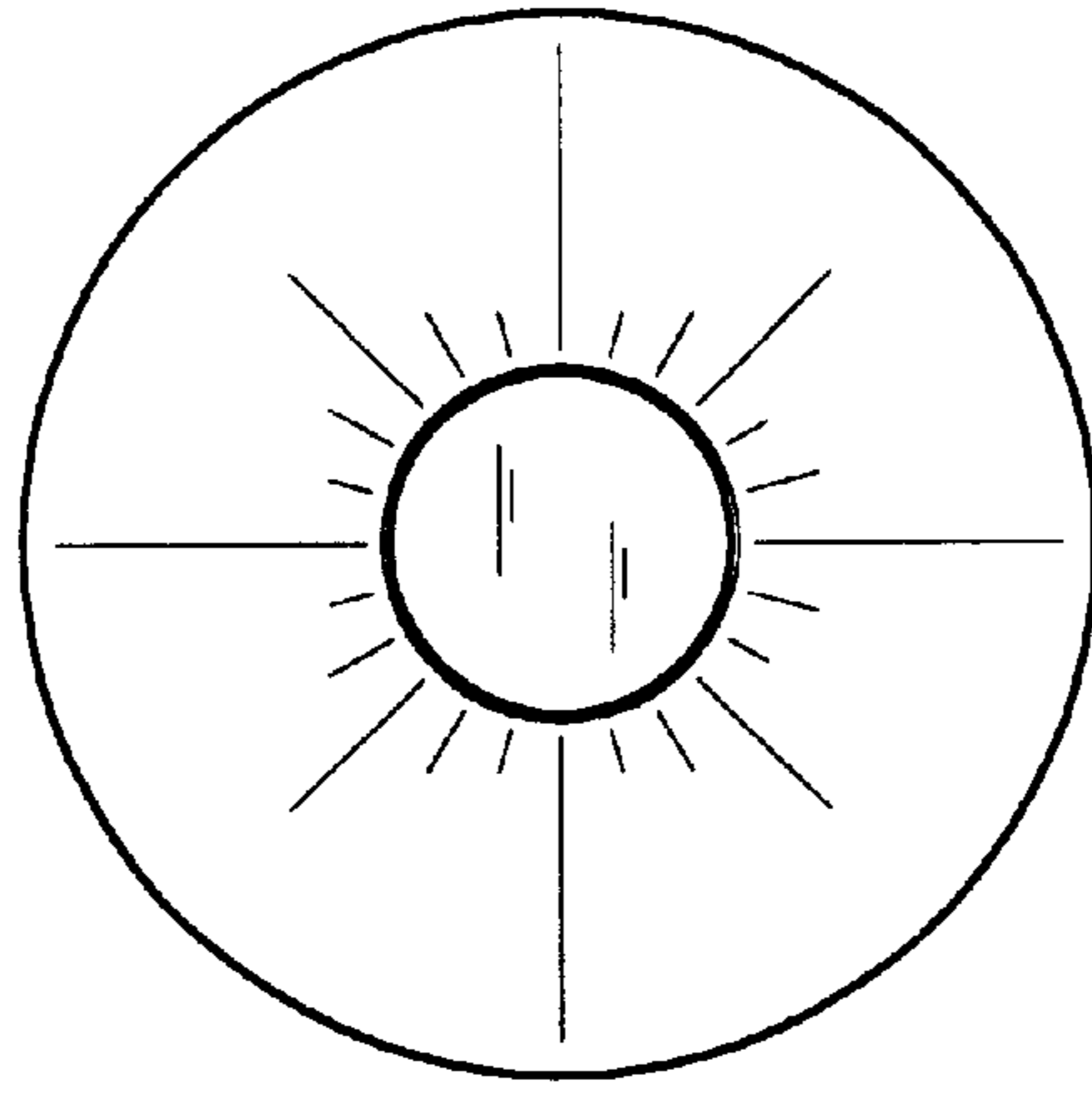
