DESCRIPTION

FIG. 1 is a perspective view of the direct current power supply;

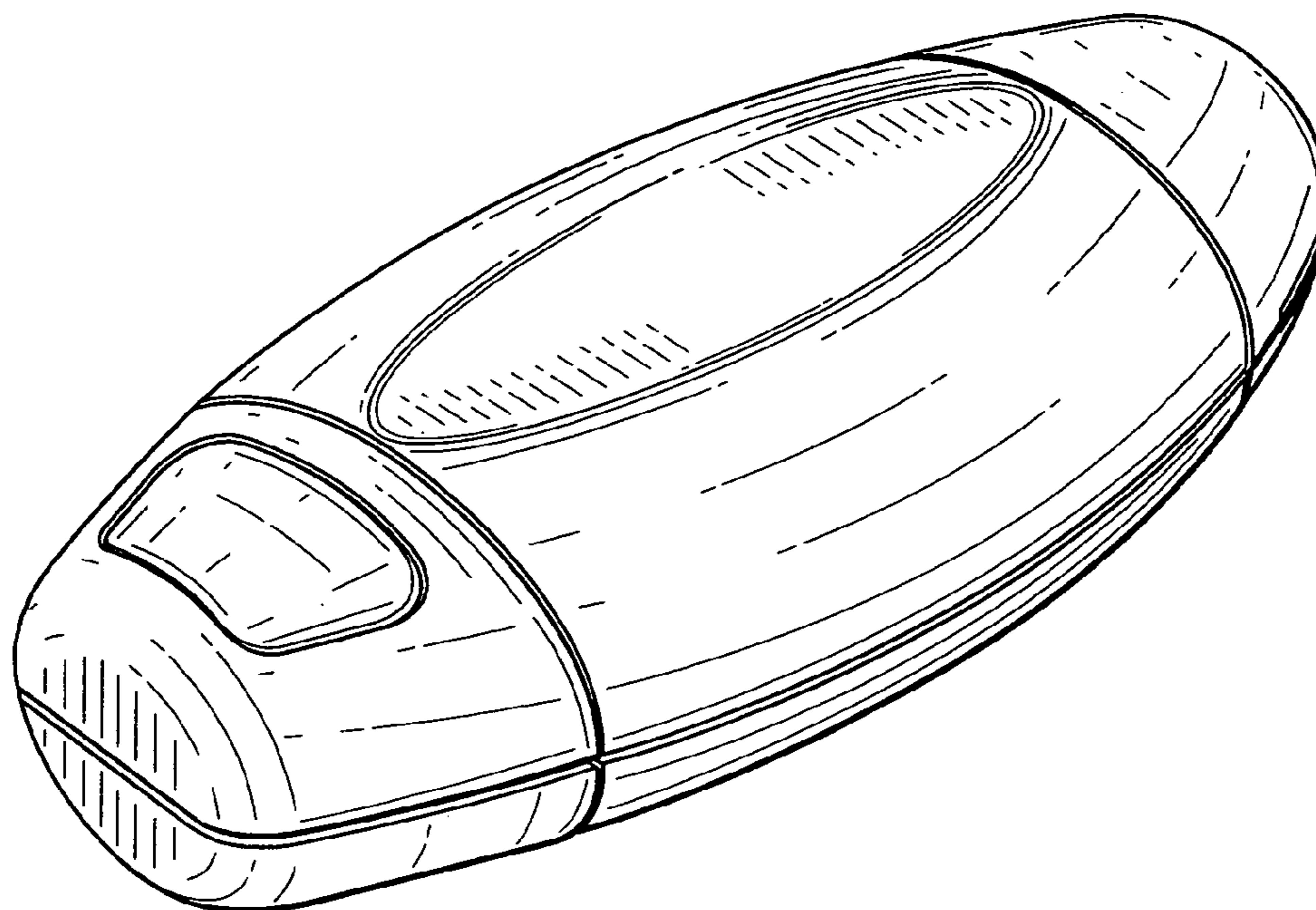
FIG. 2 is a front view of the direct current power supply, the back view being a mirror image the front view;

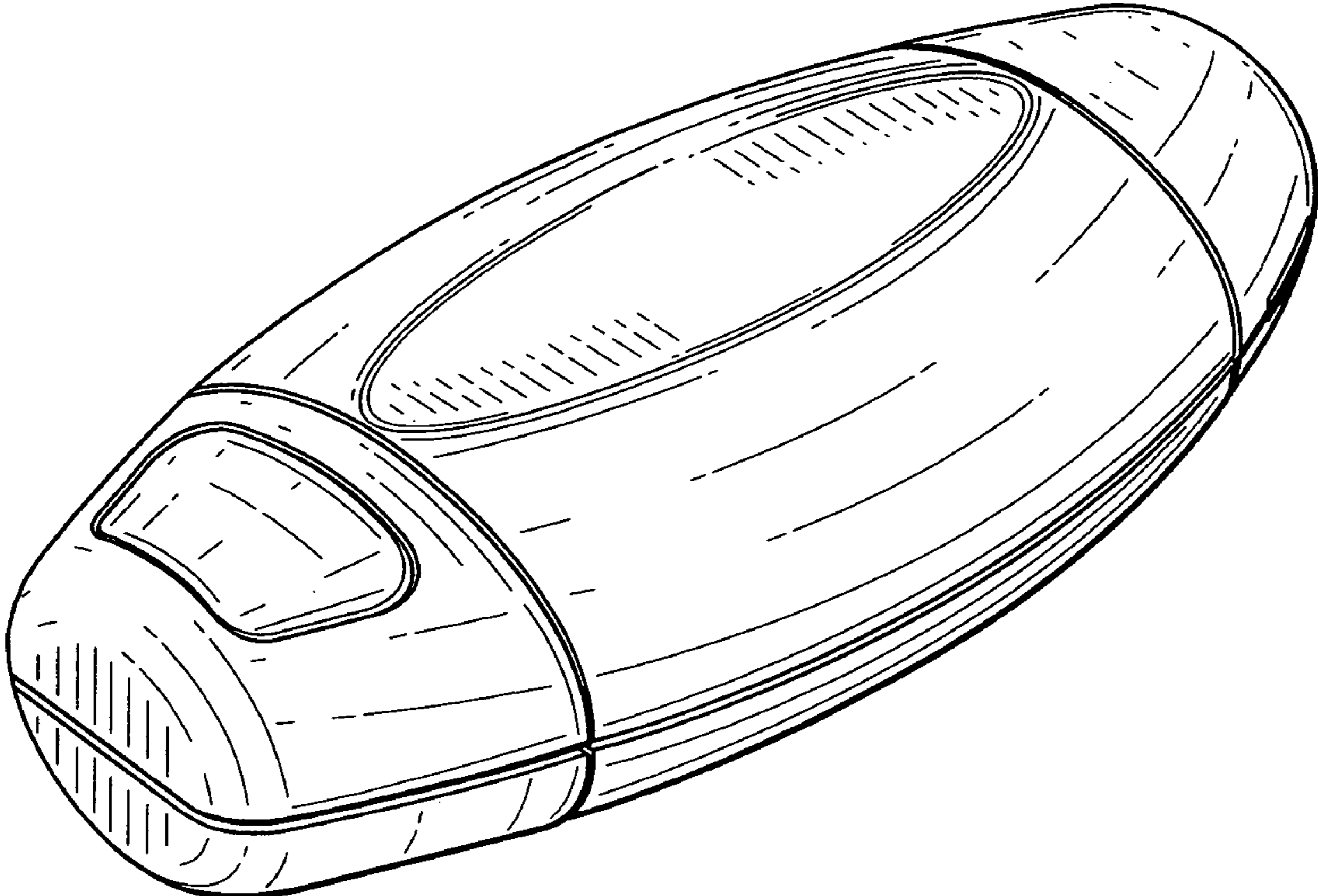

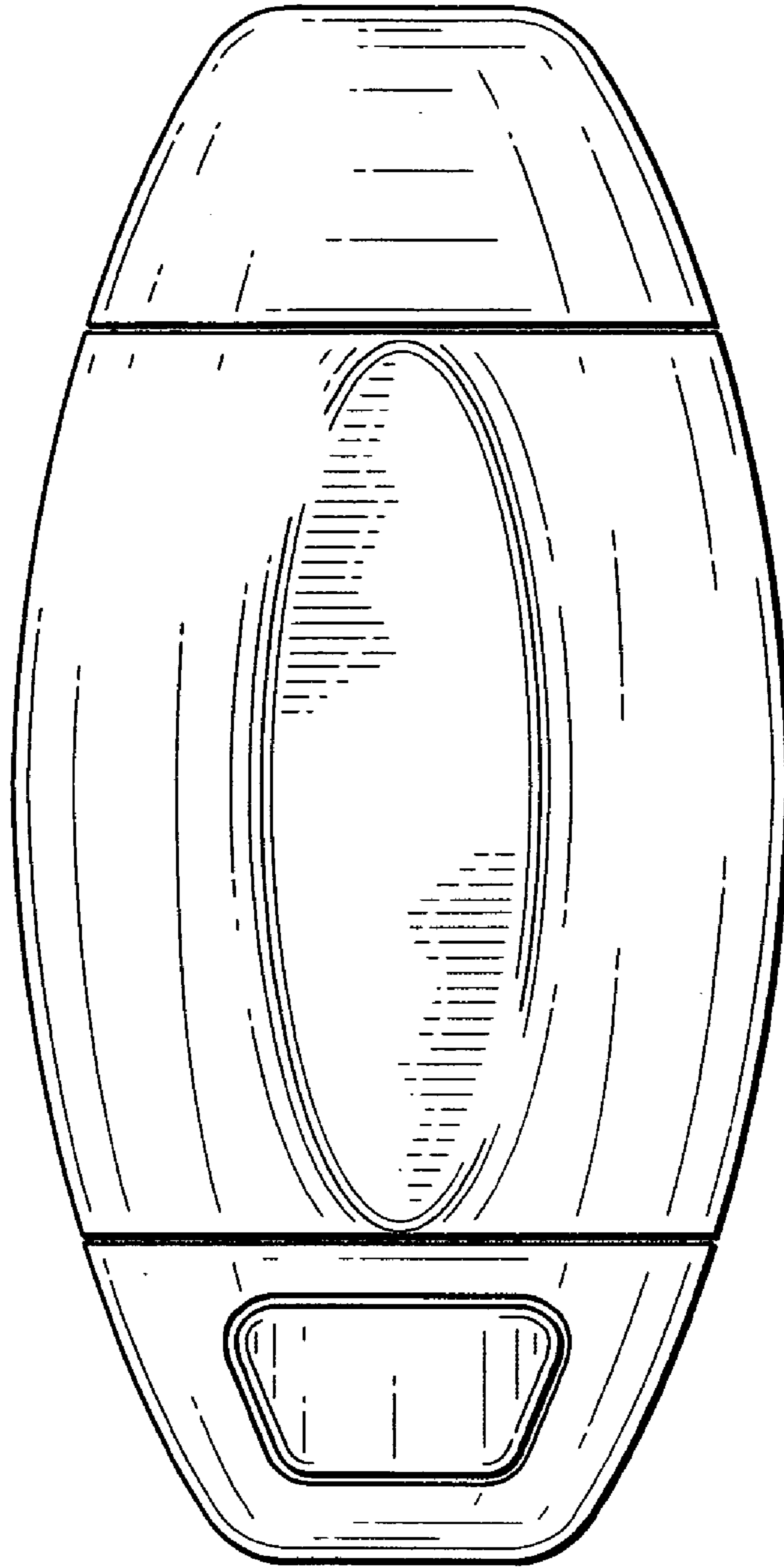

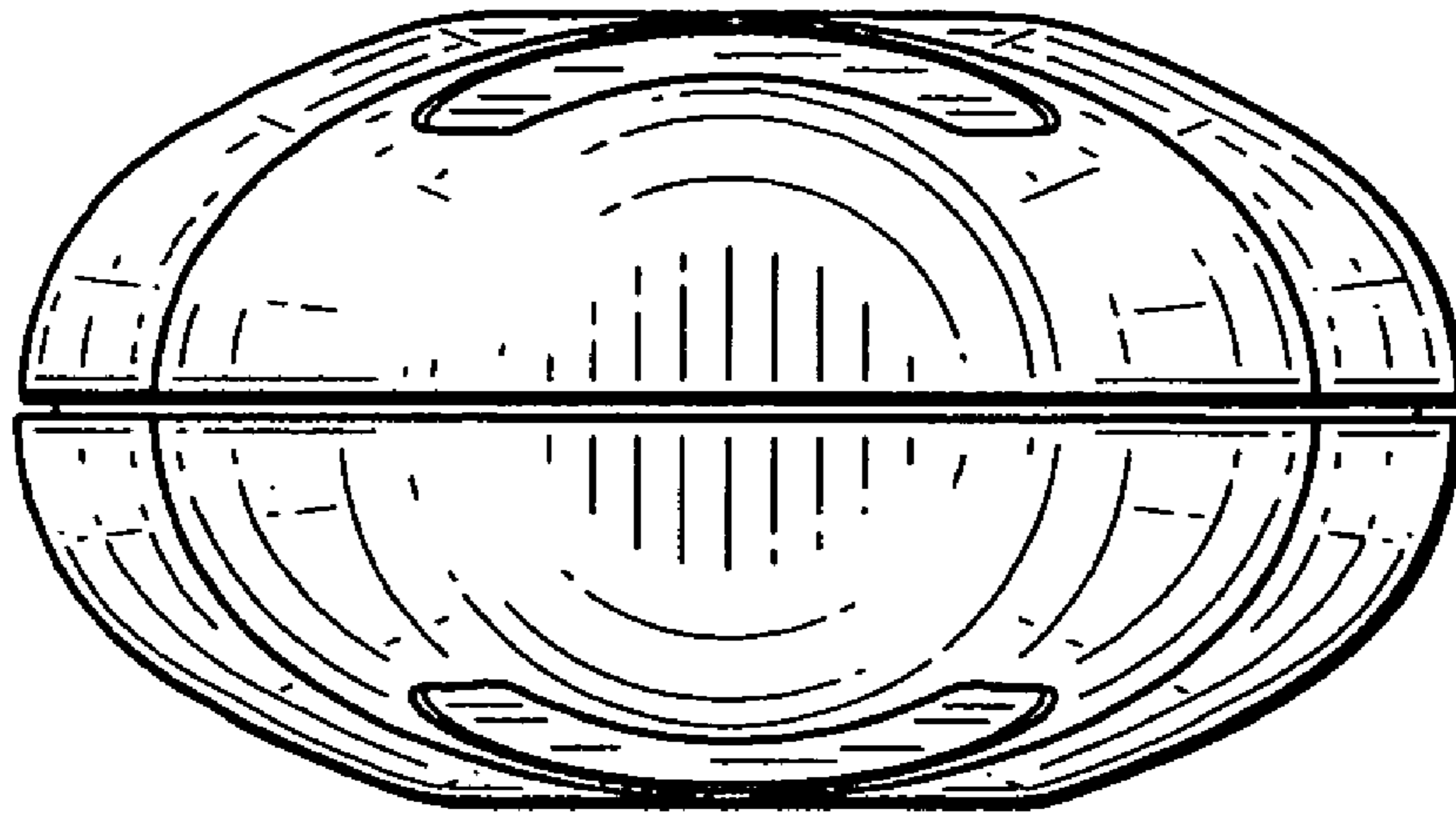

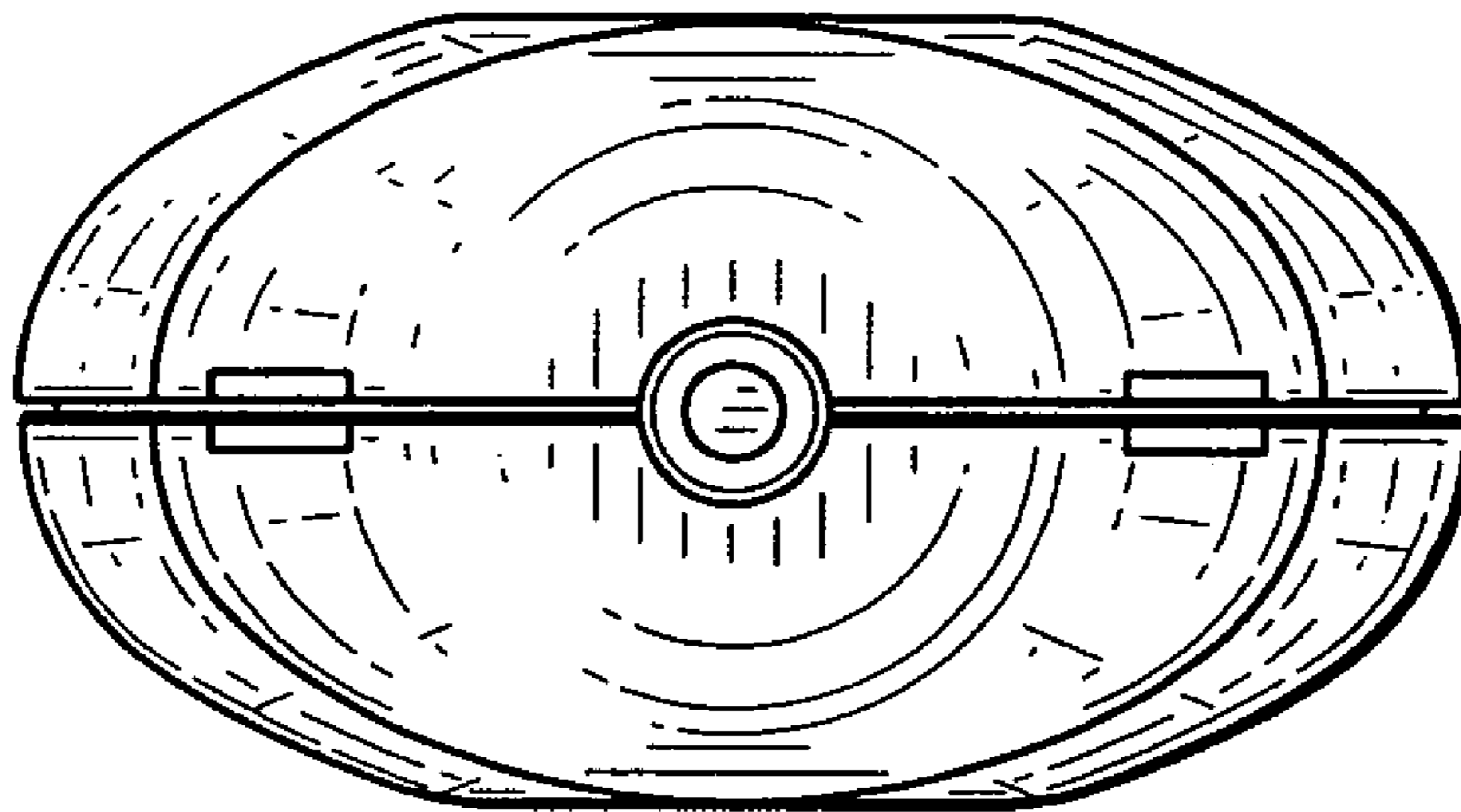

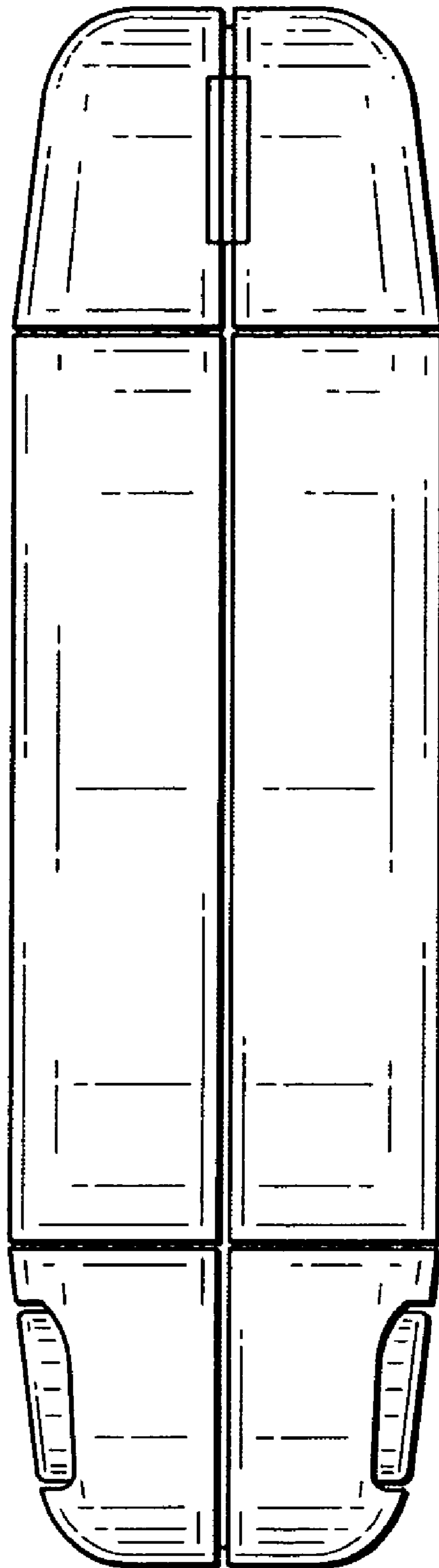
