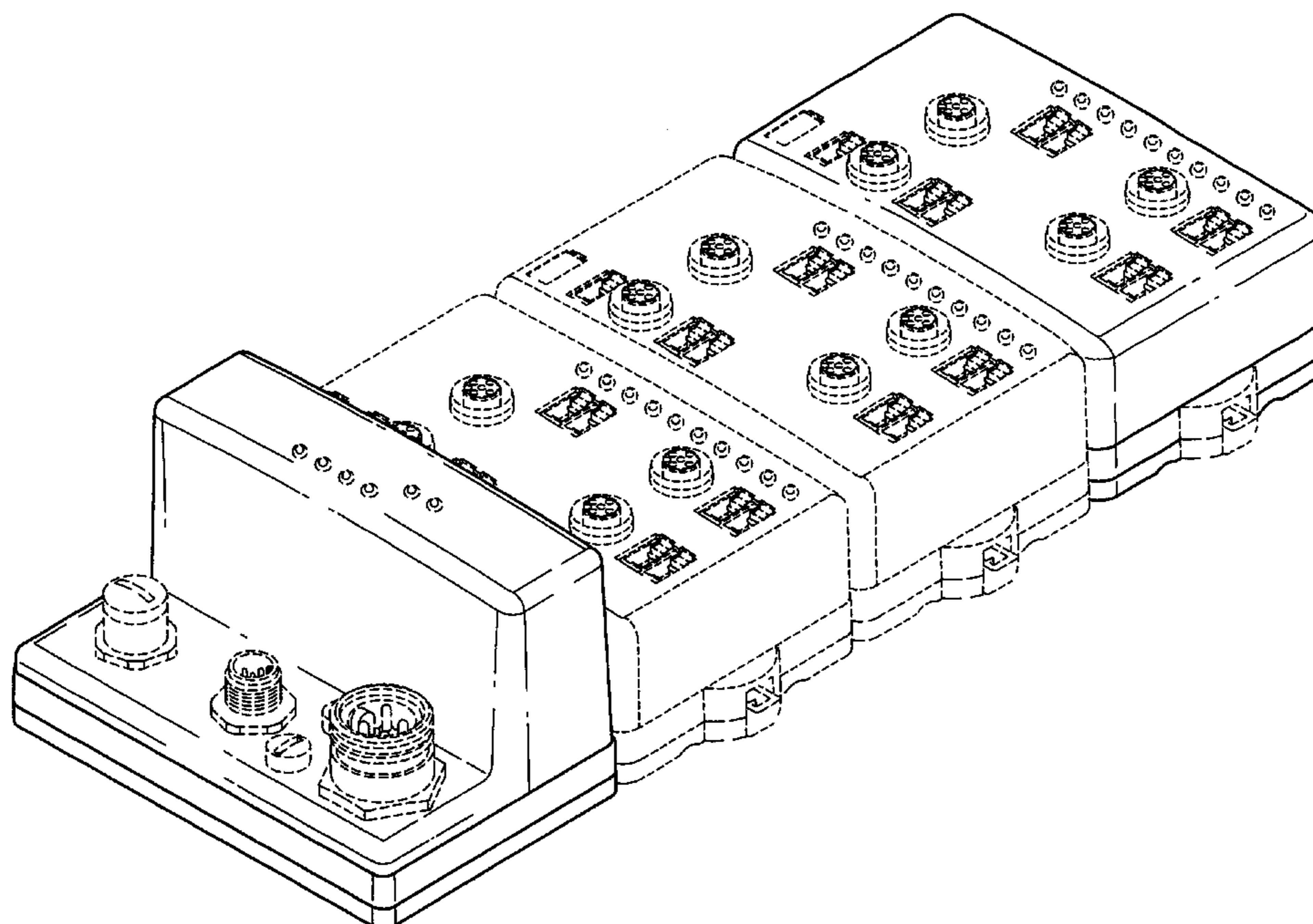
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a  
modular electrical device, showing our new design;  
FIG. 2 is a rear elevation view thereof;

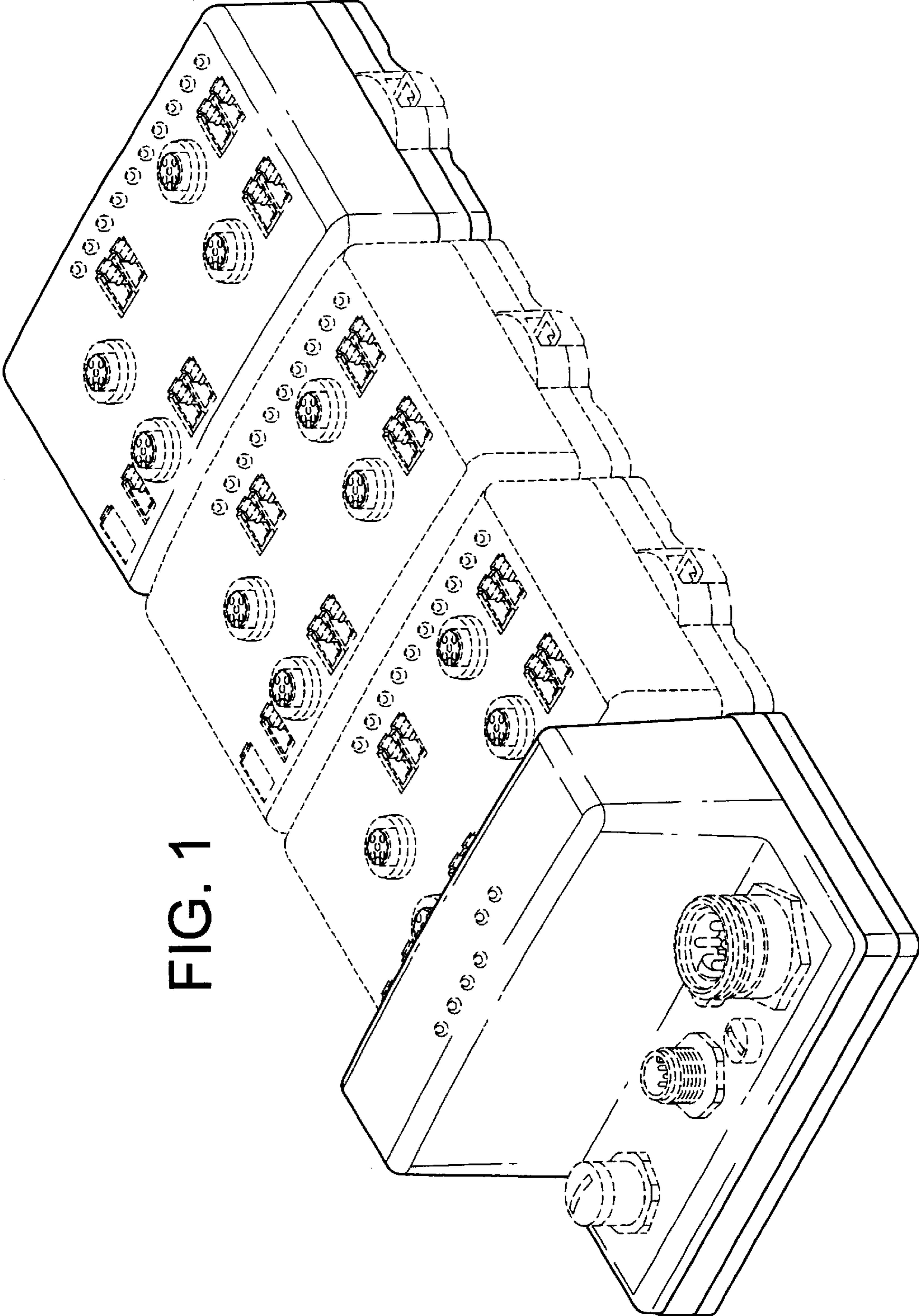

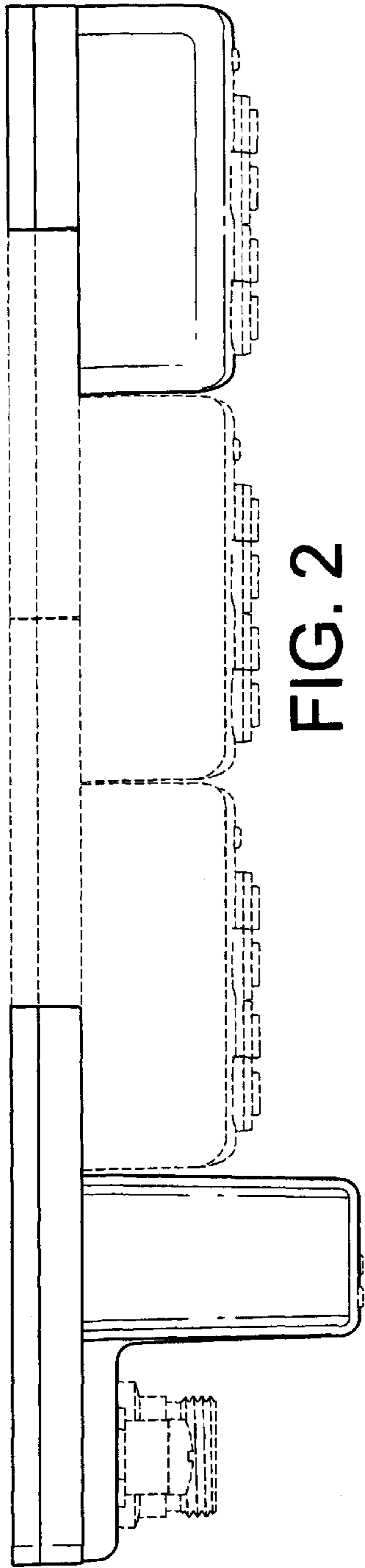

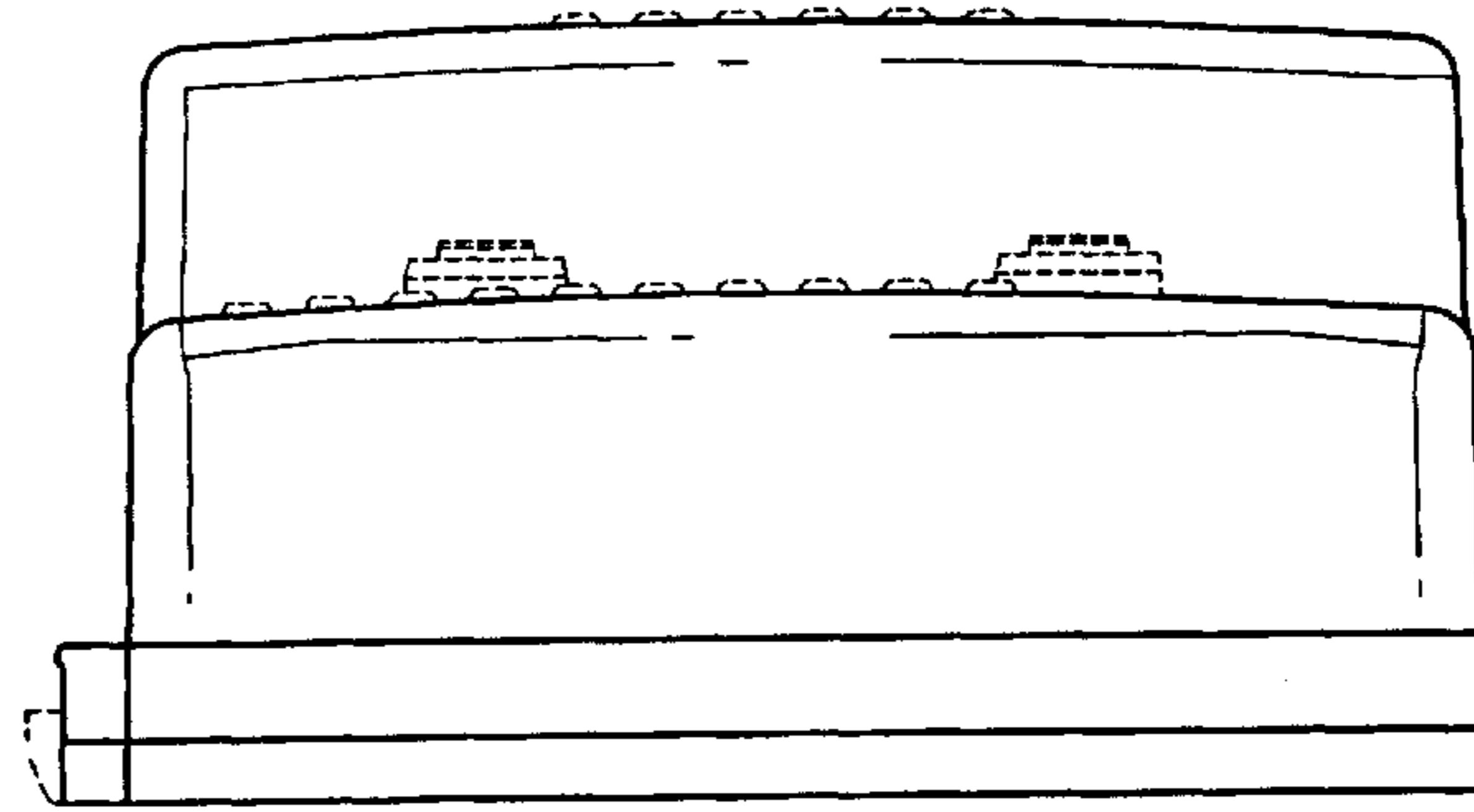

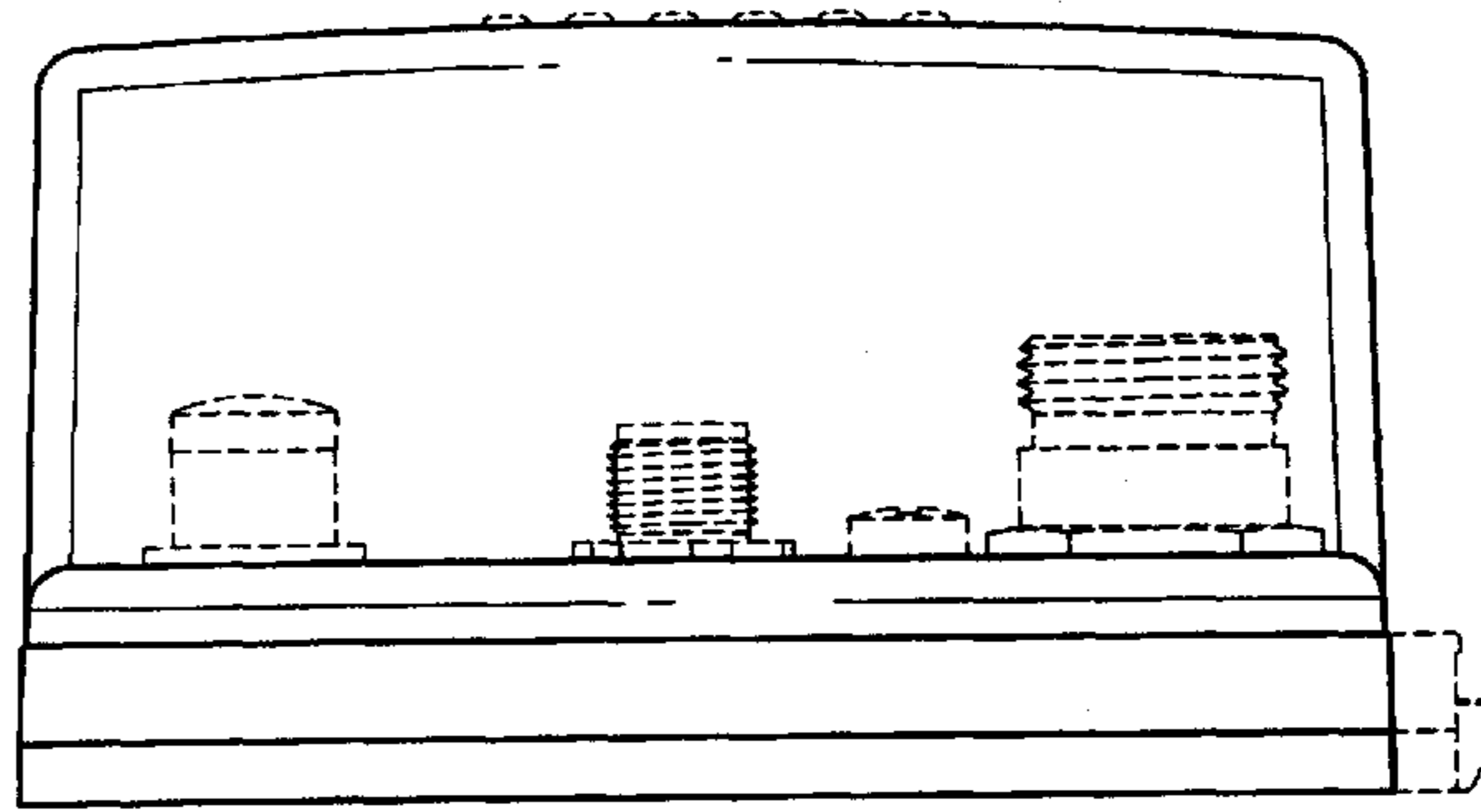

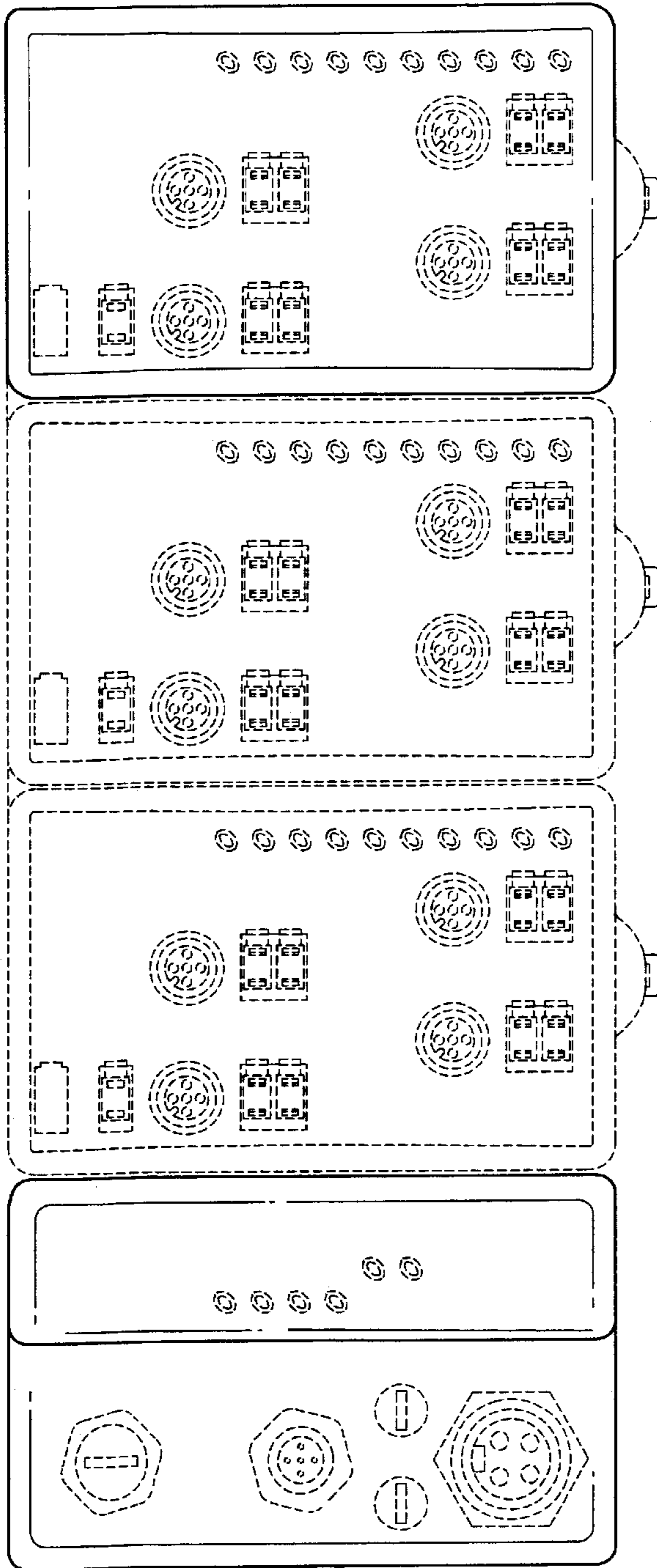

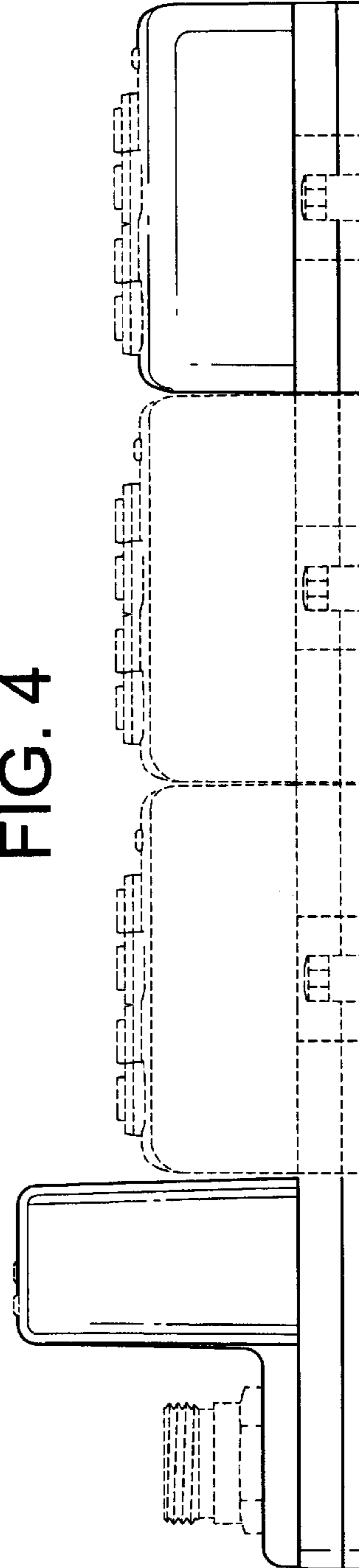

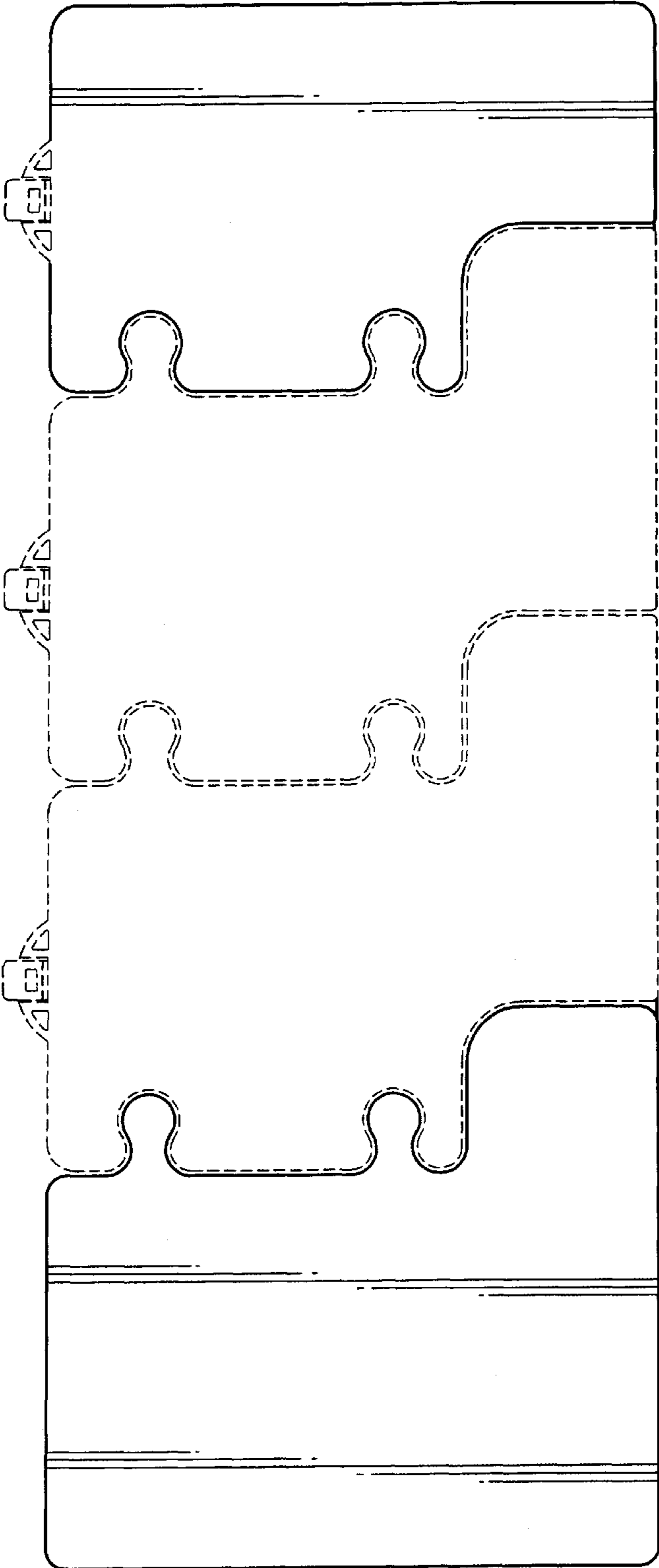
