FIG. 1 is a perspective view of a remote control unit incorporating our new design;

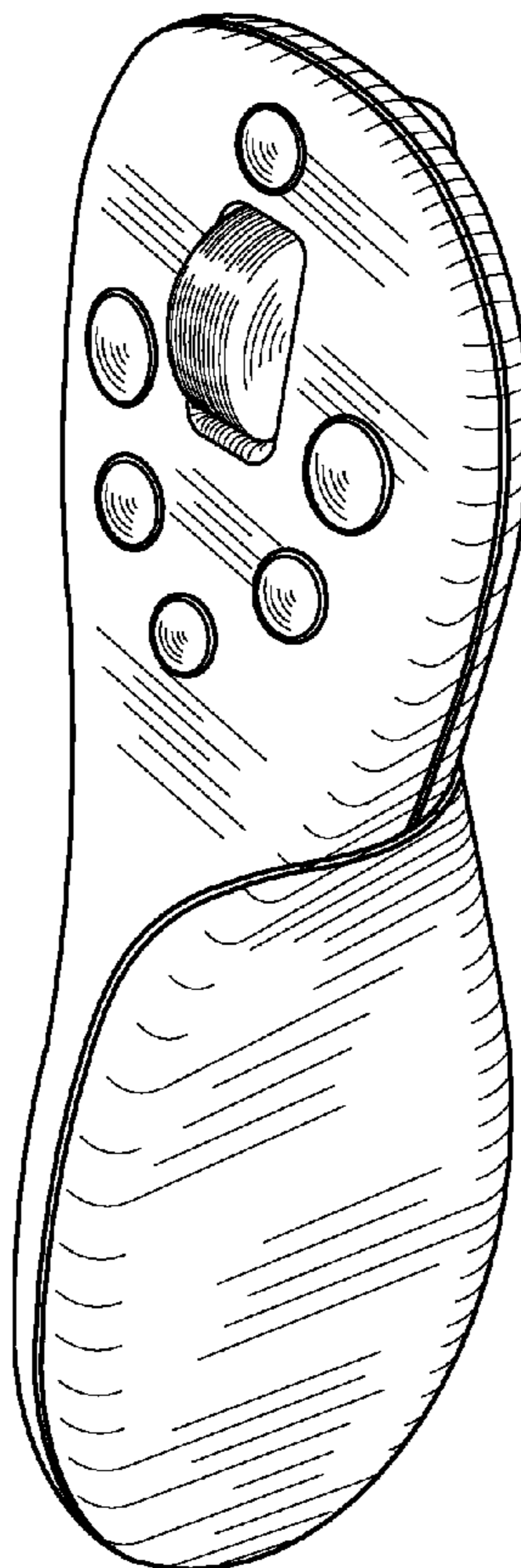
FIG. 2 is a top or front view thereof;

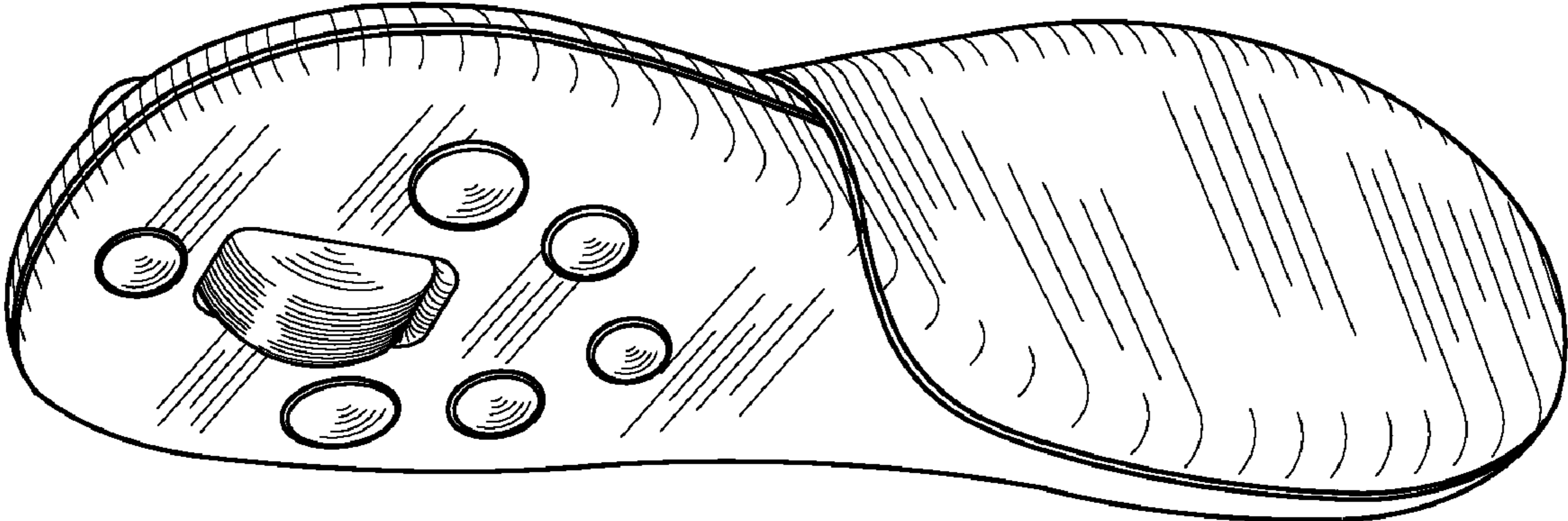

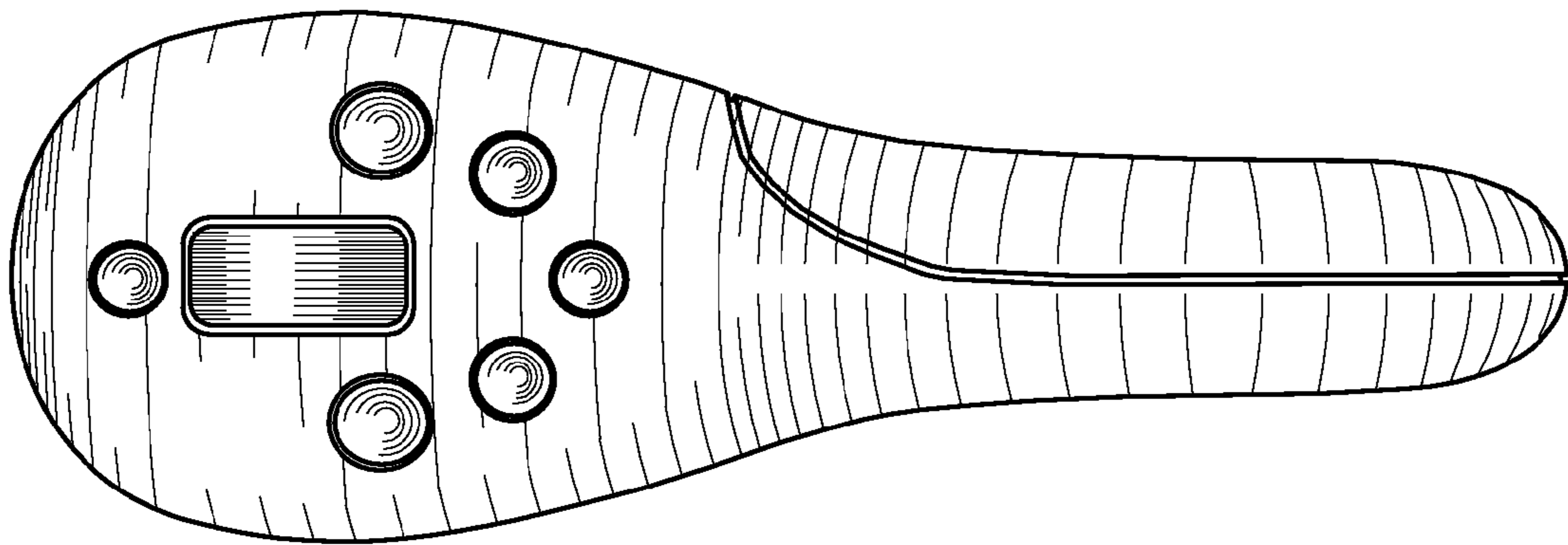

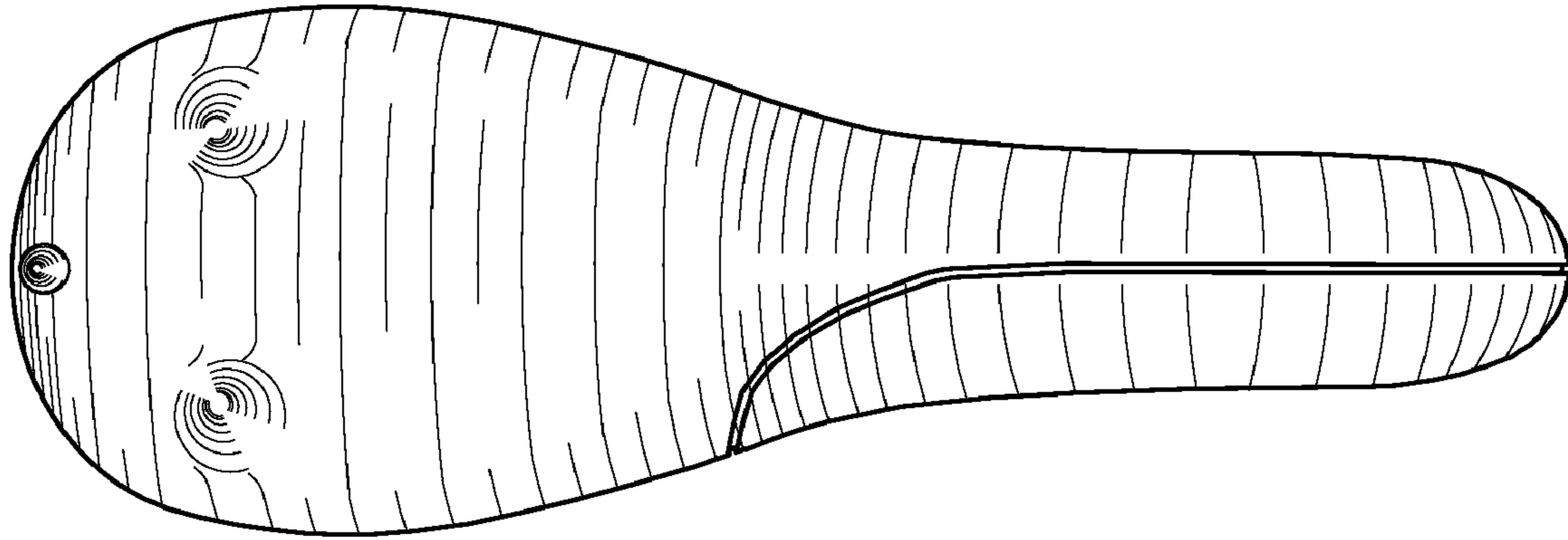

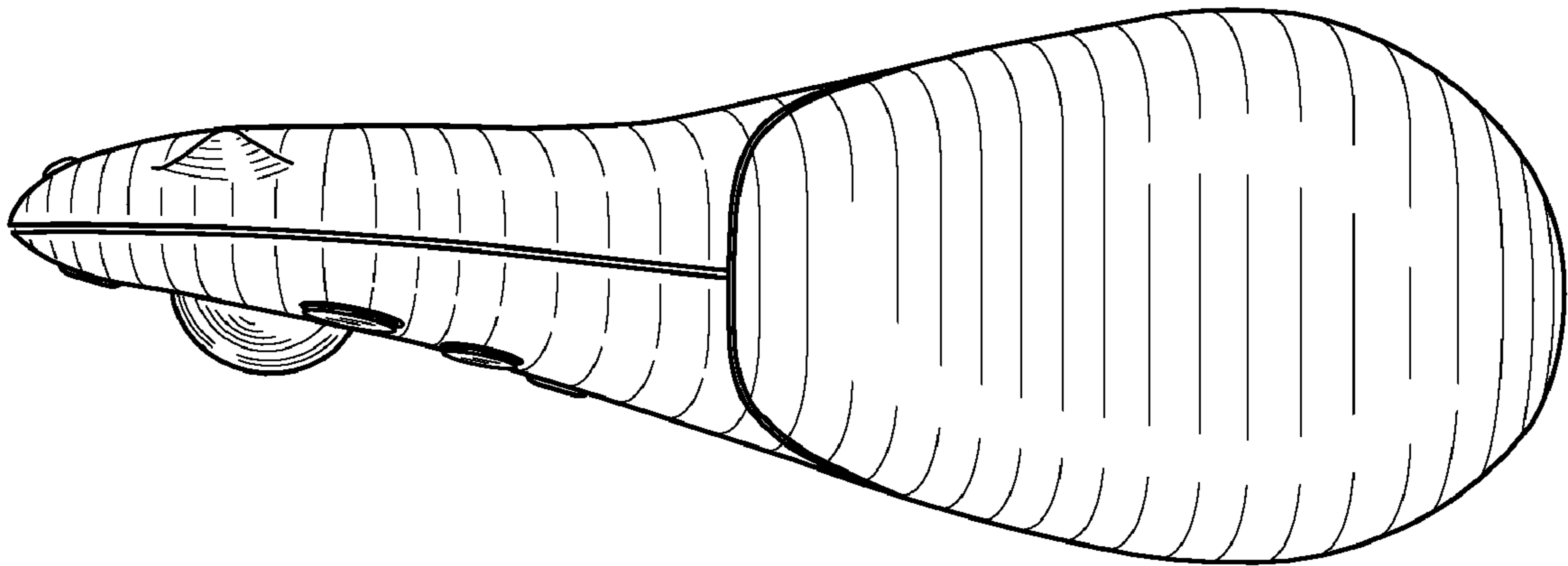

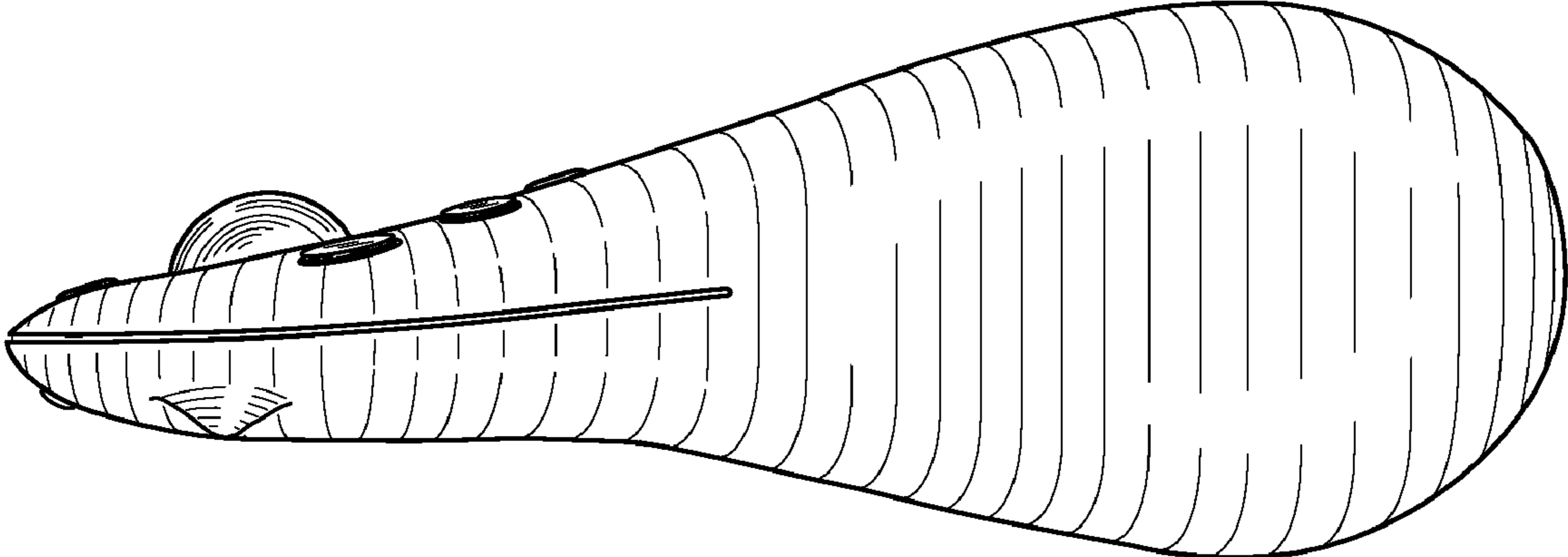
