(57) **CLAIM**

The ornamental design for a fender, as substantially shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a fender showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a right side view thereof; and,

FIG. 5 is a left side view thereof.

The right side fender is a mirror image of the design shown in FIGS. 1-5.

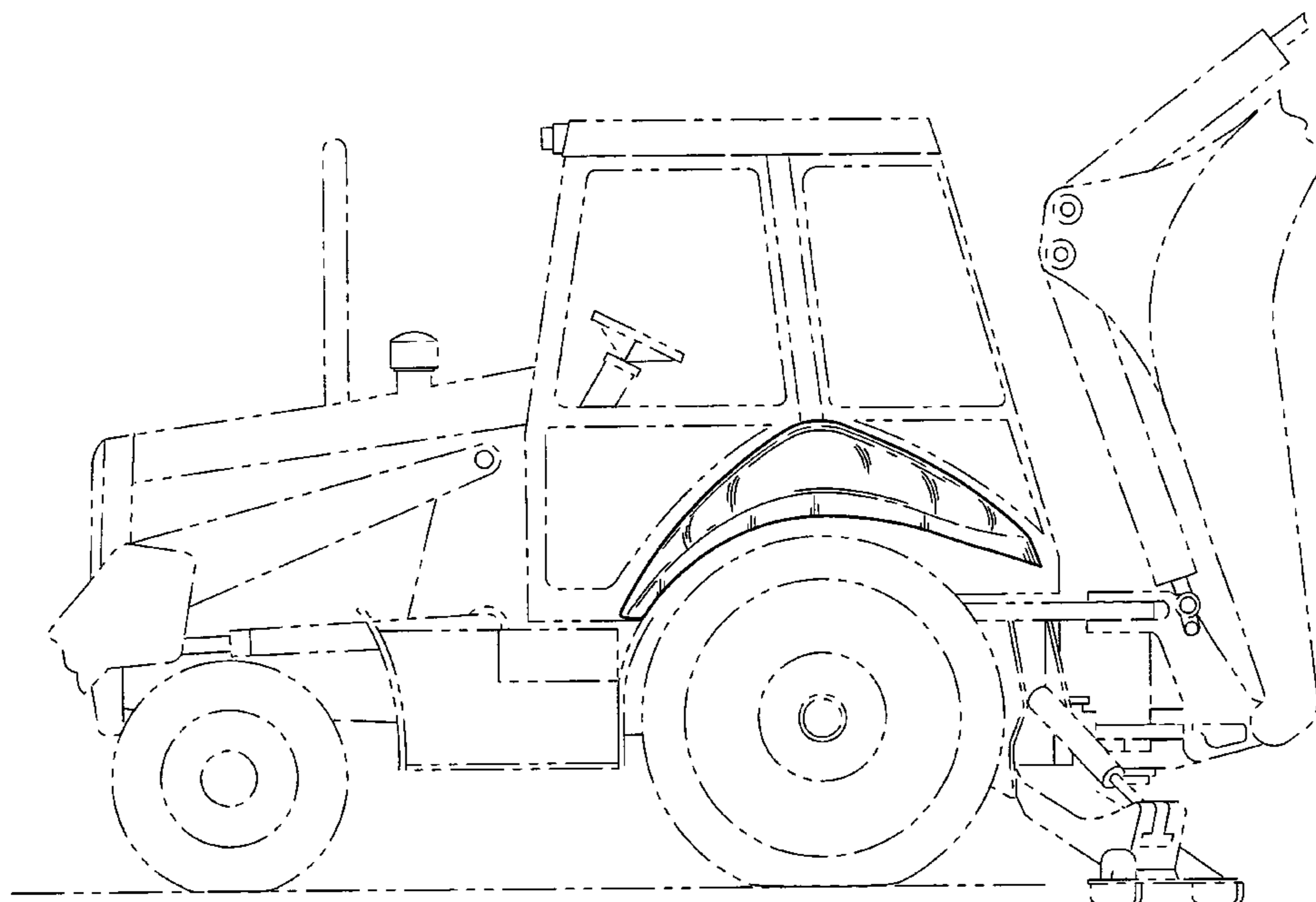
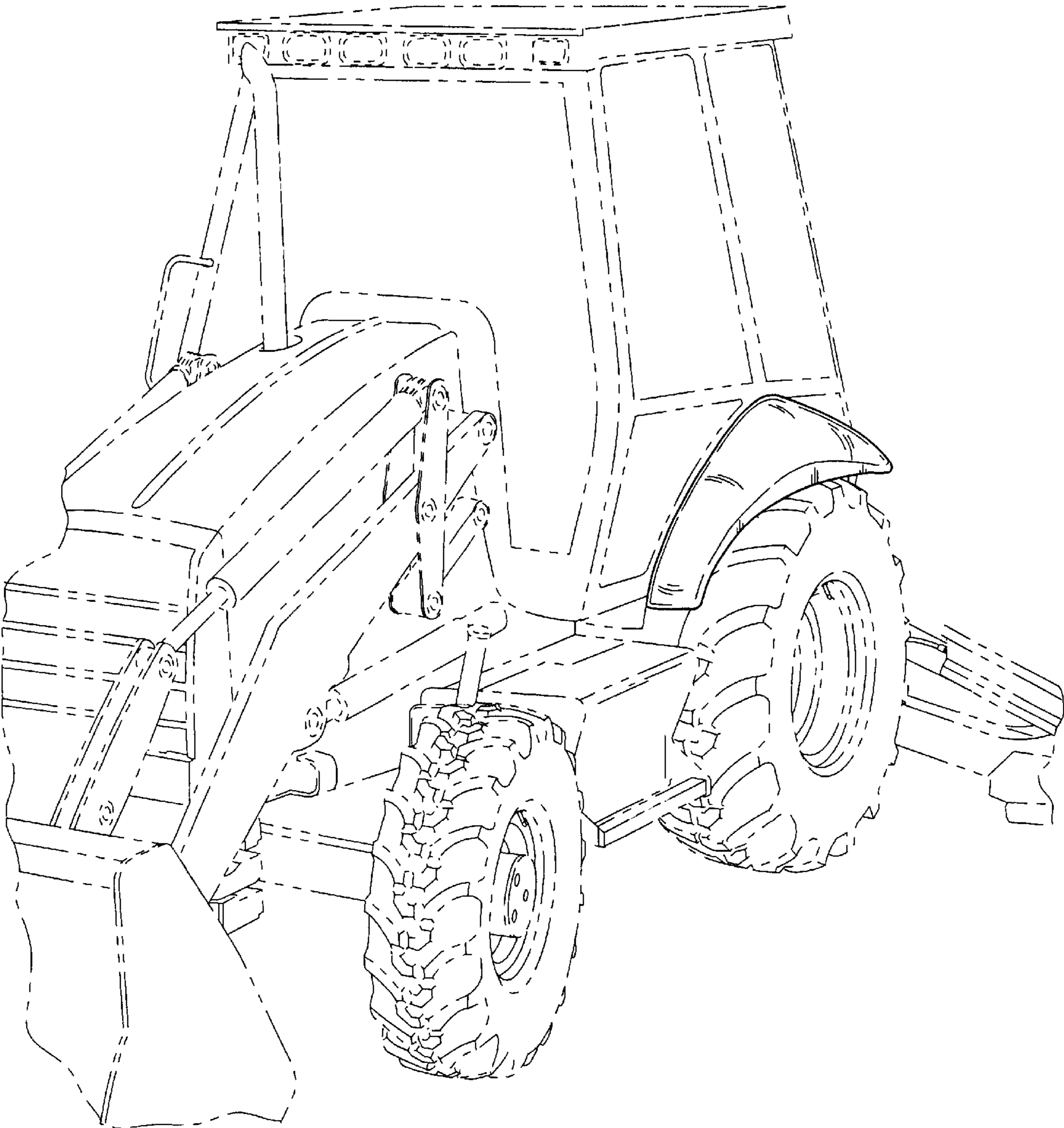
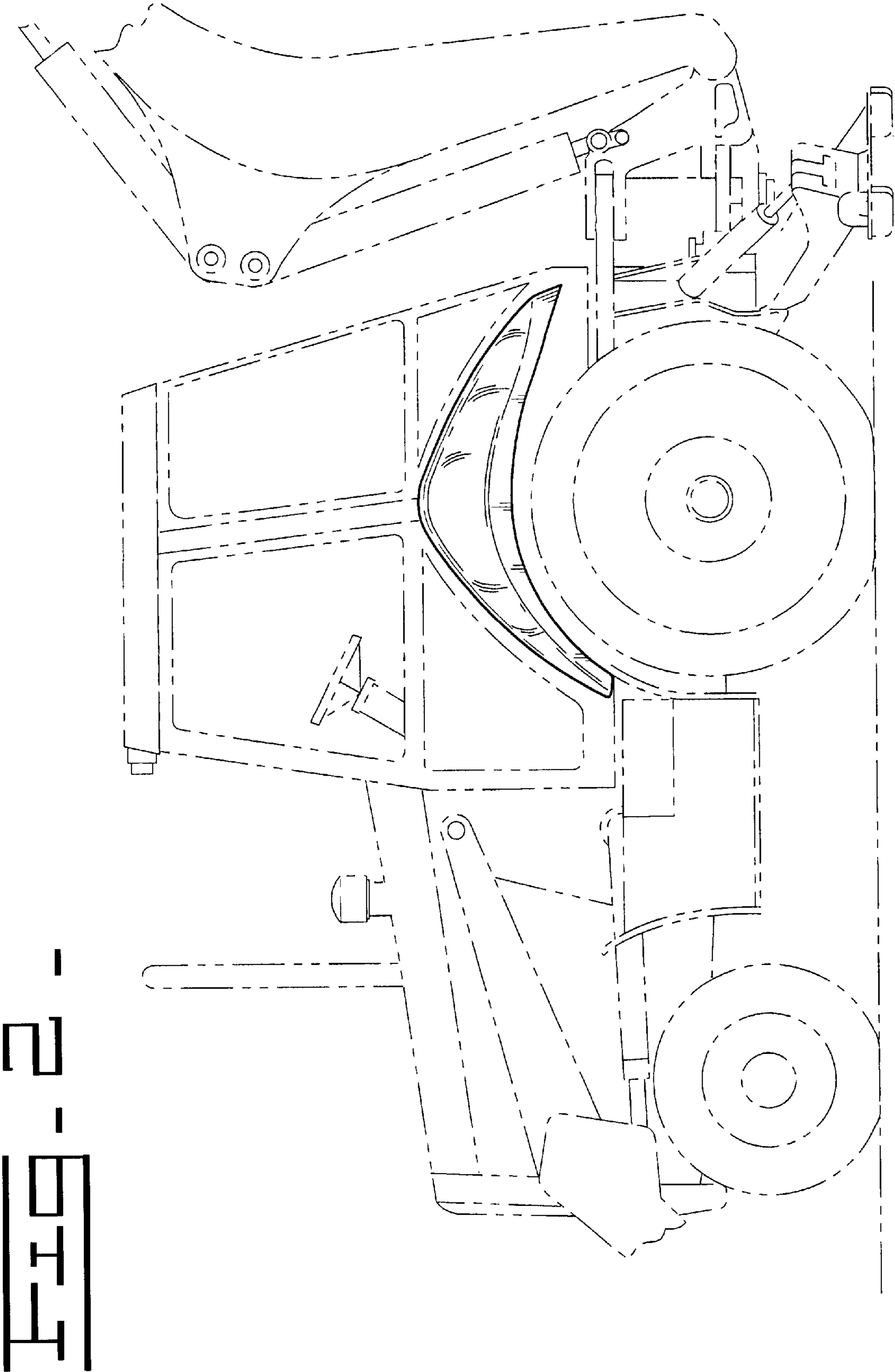

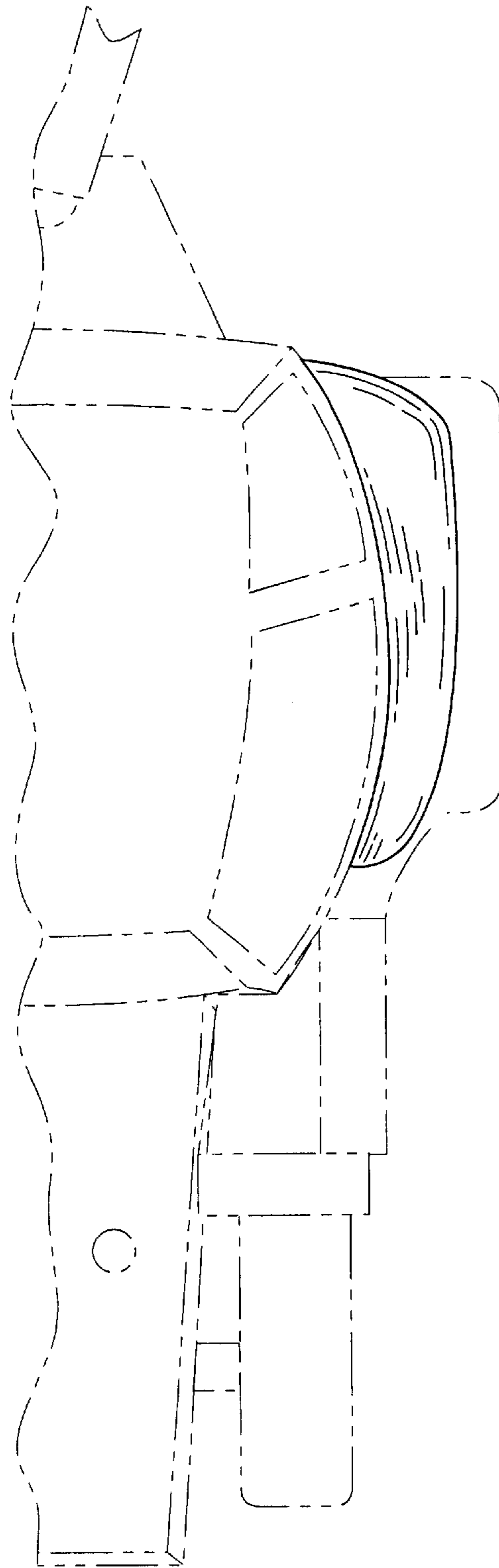

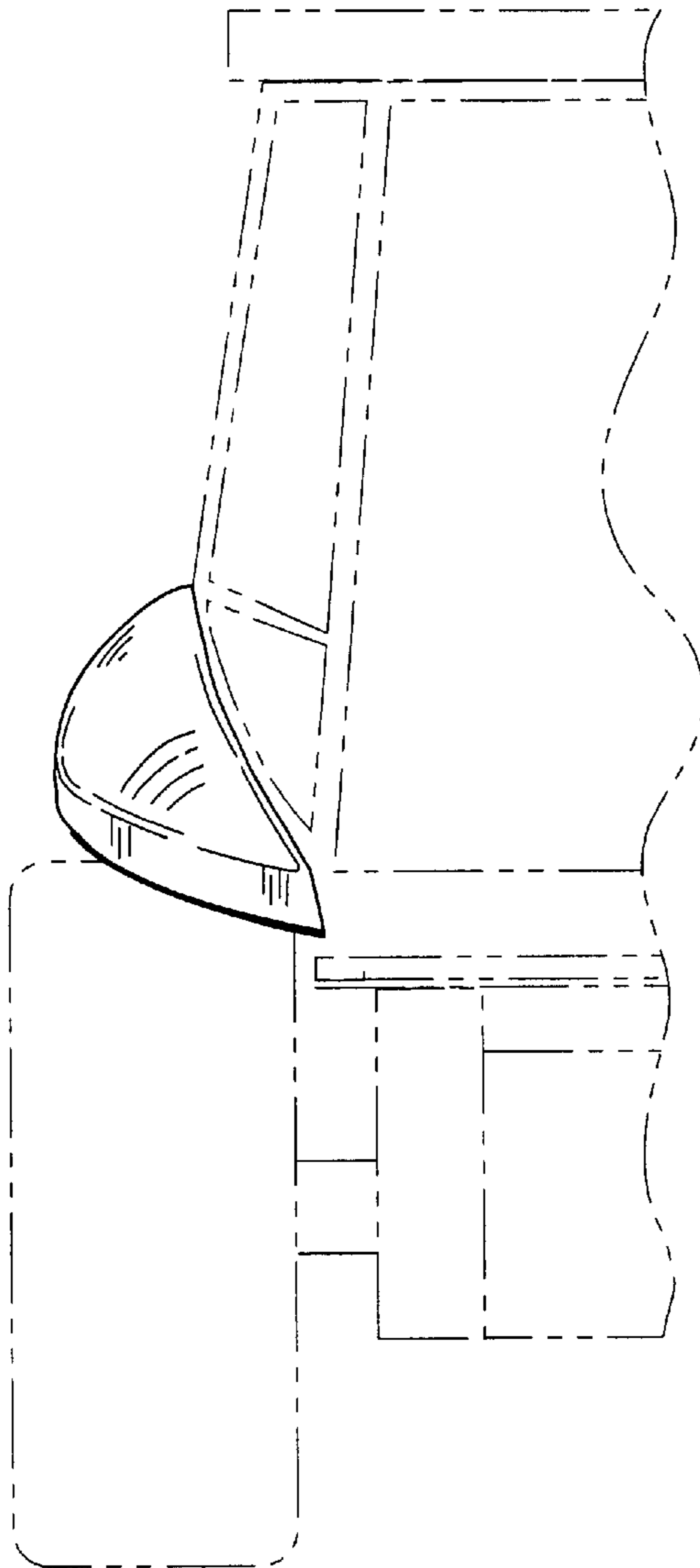
