(57) **CLAIM**

The ornamental design for a portion of a golf club head, as shown and described.

**DESCRIPTION**

The sole FIGURE is a front view of a portion of a golf club head.

The broken lines represent the bounds of the claimed design and environmental elements only; the broken lines form no part of the claimed design.
