The ornamental design for a medical device tip, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a medical device tip showing our new design.

FIG. 2 is a front elevational view thereof;

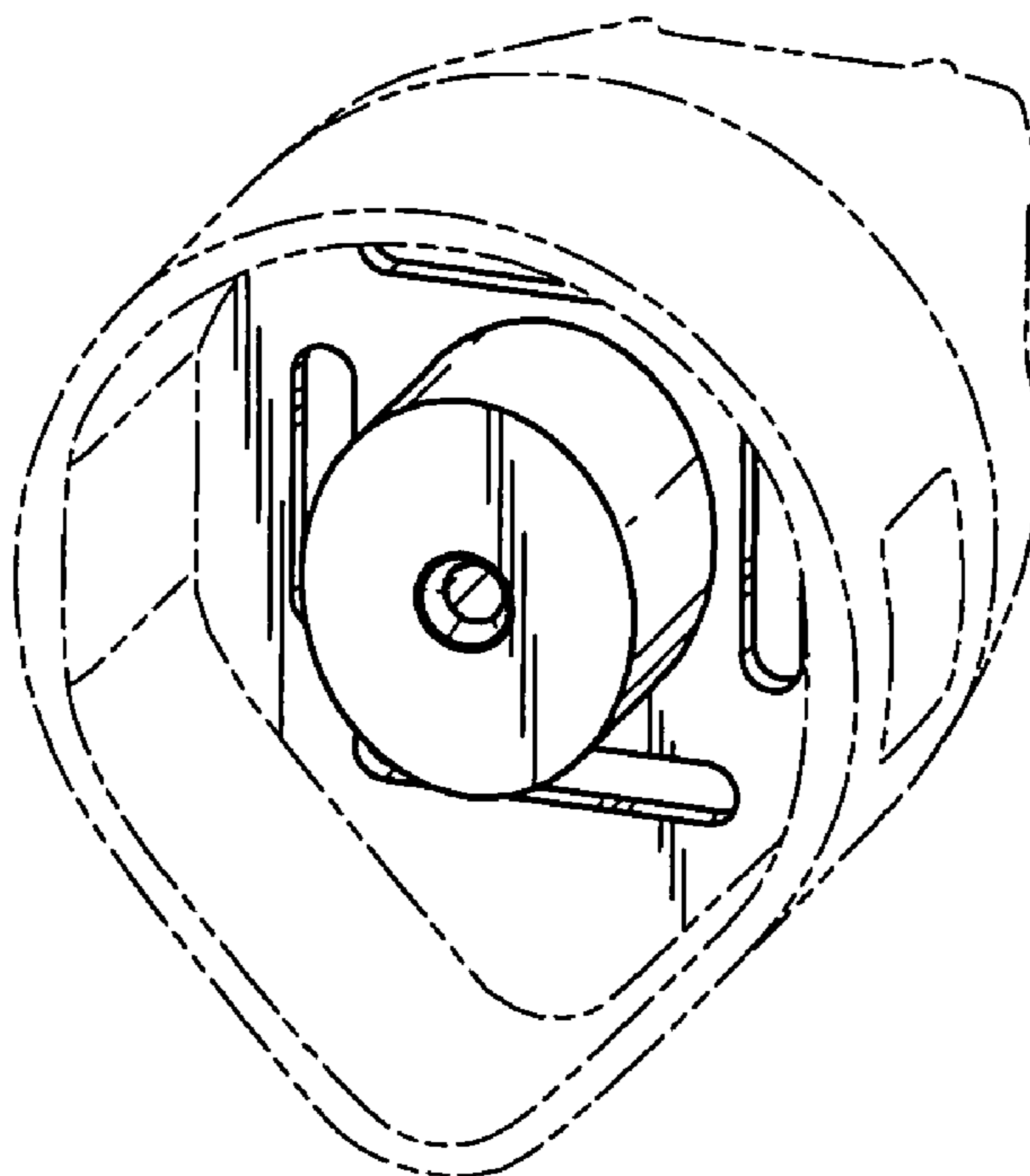
FIG. 3 is a side elevational view thereof;

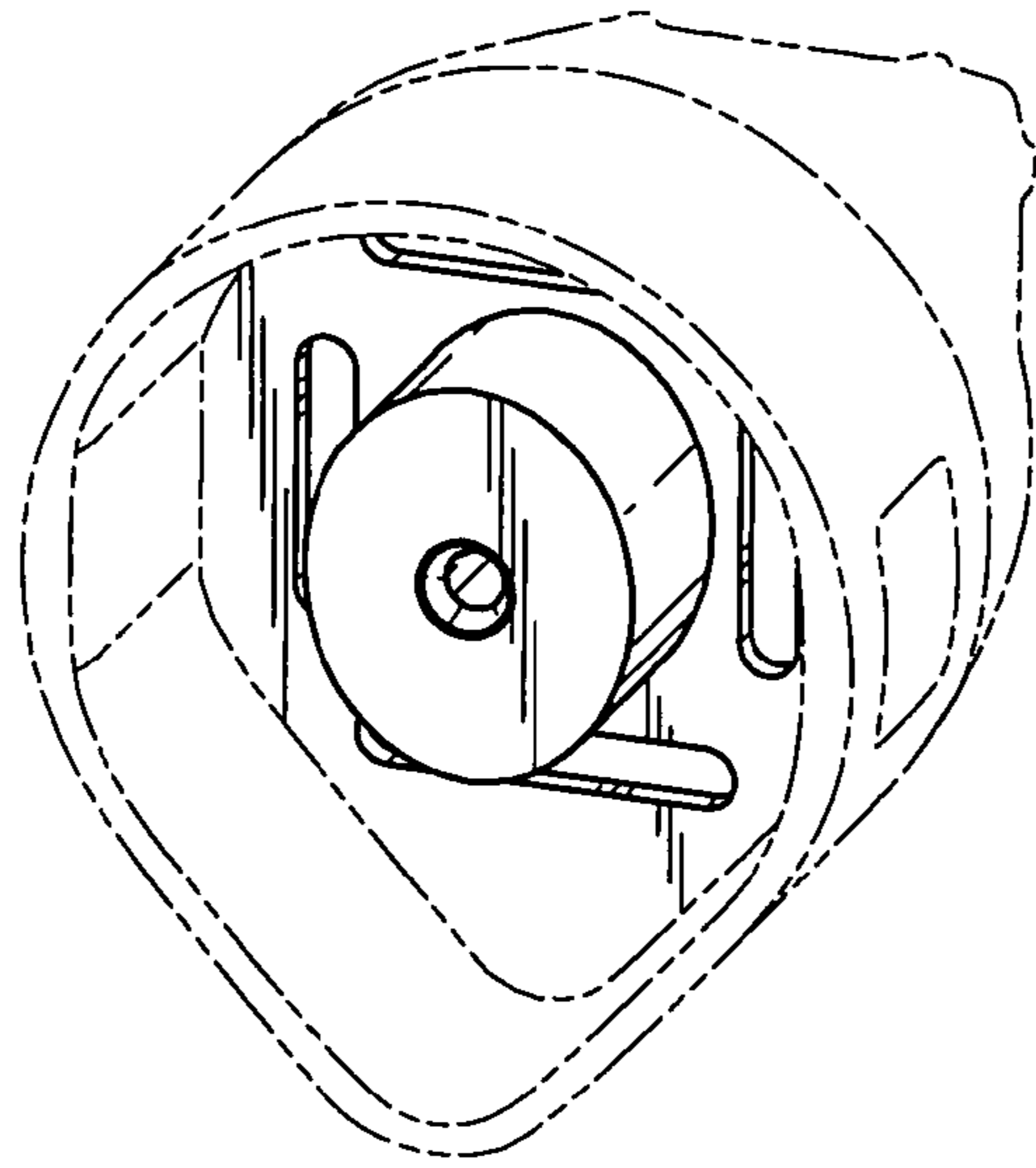

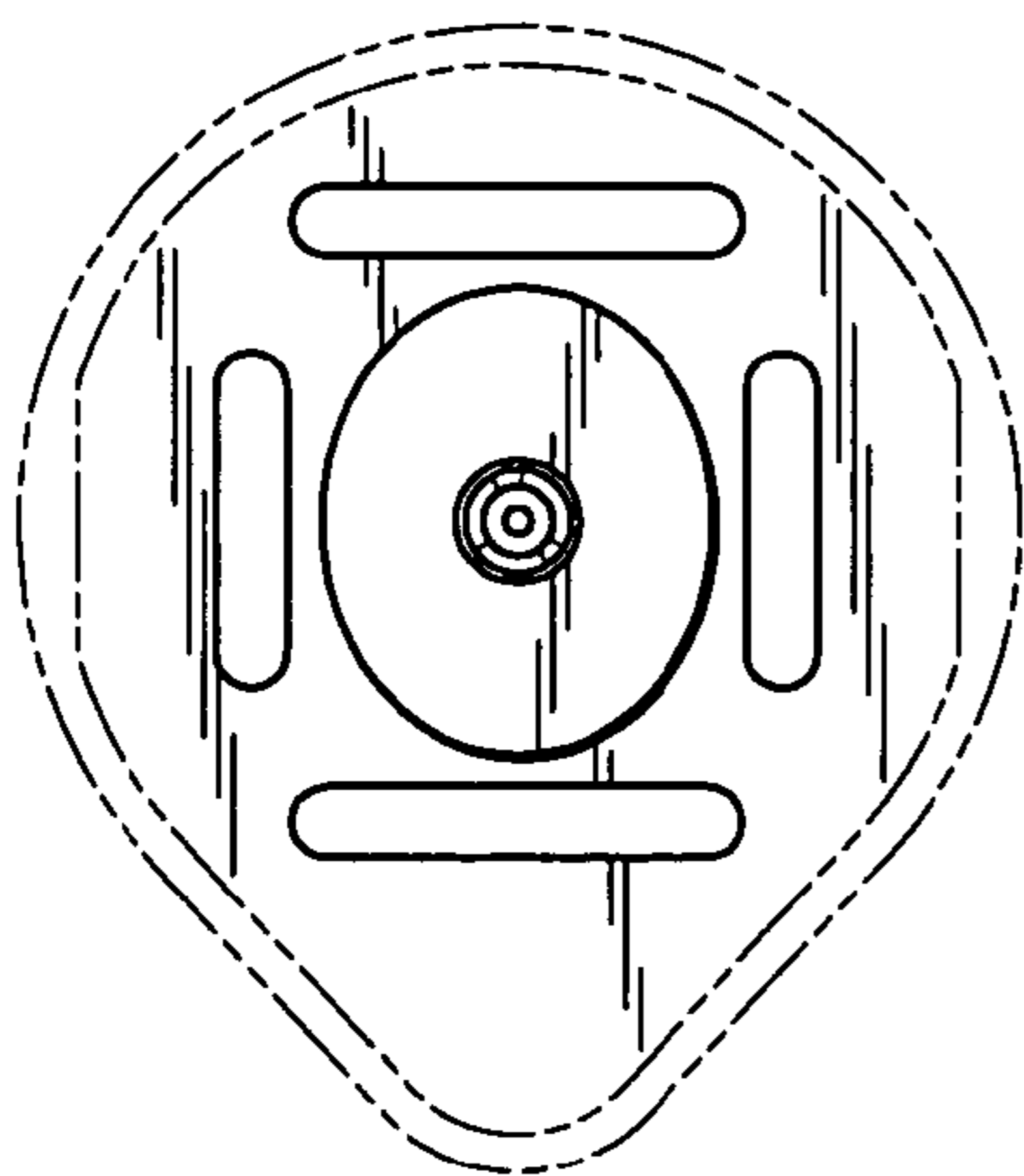

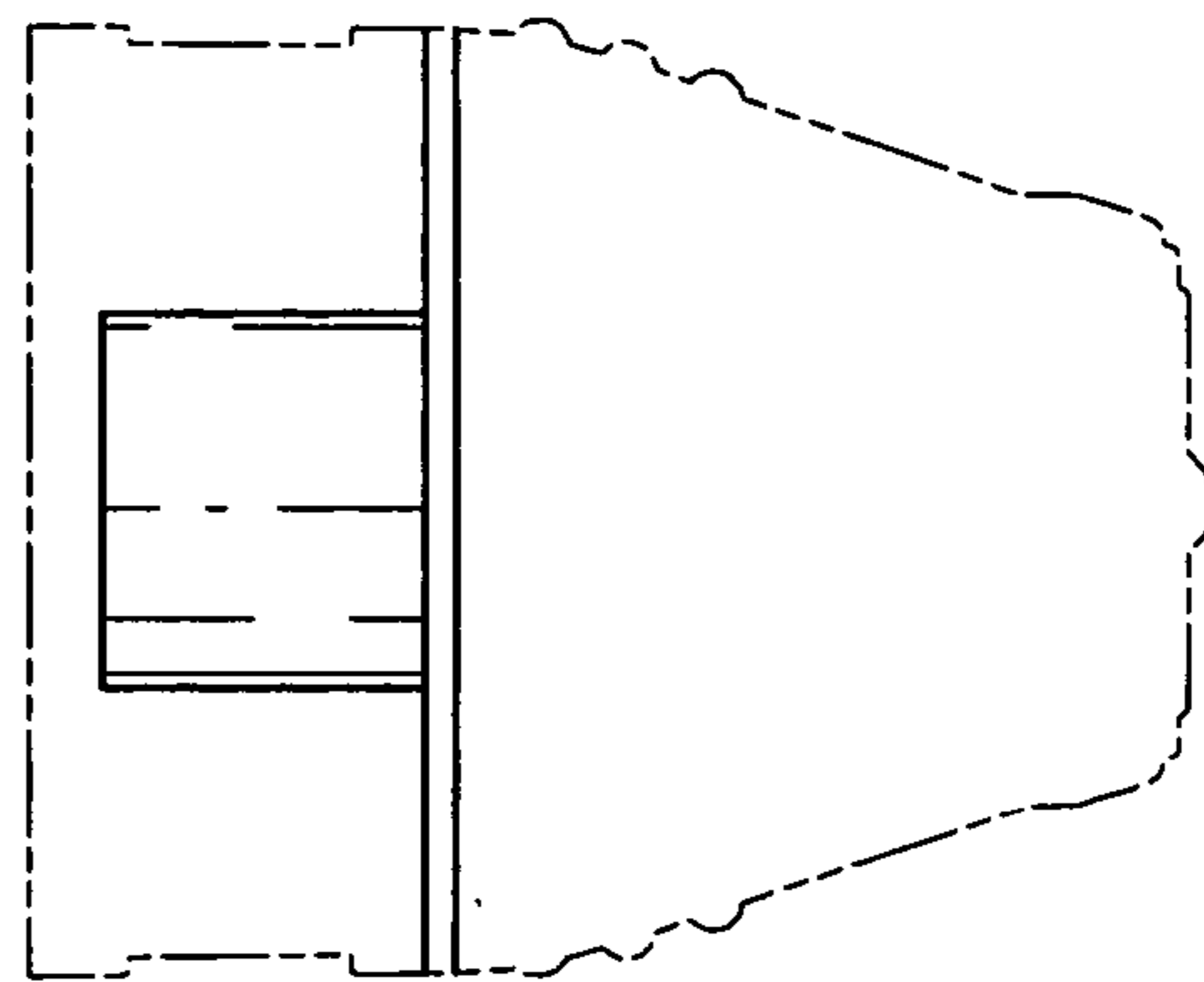

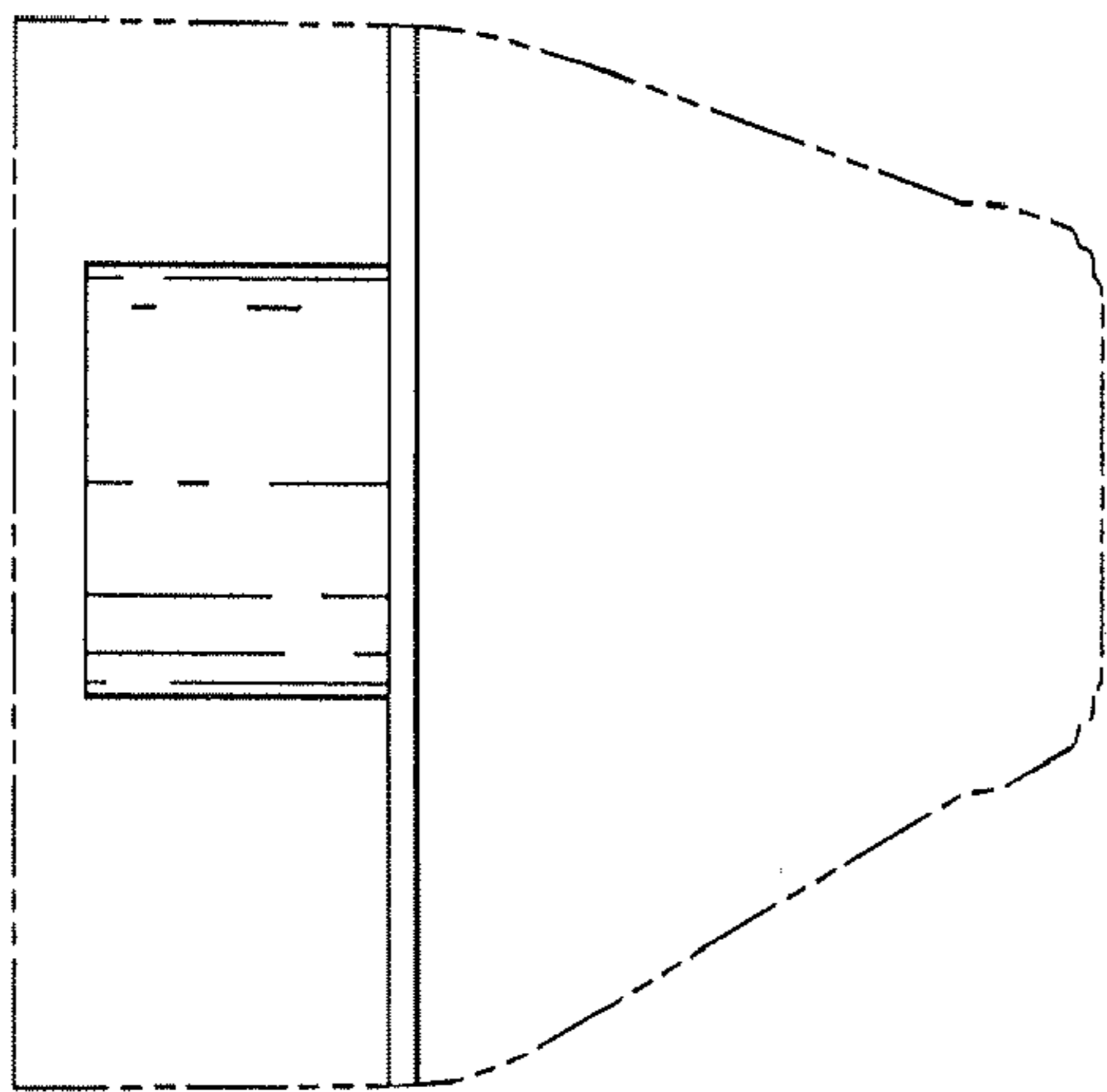

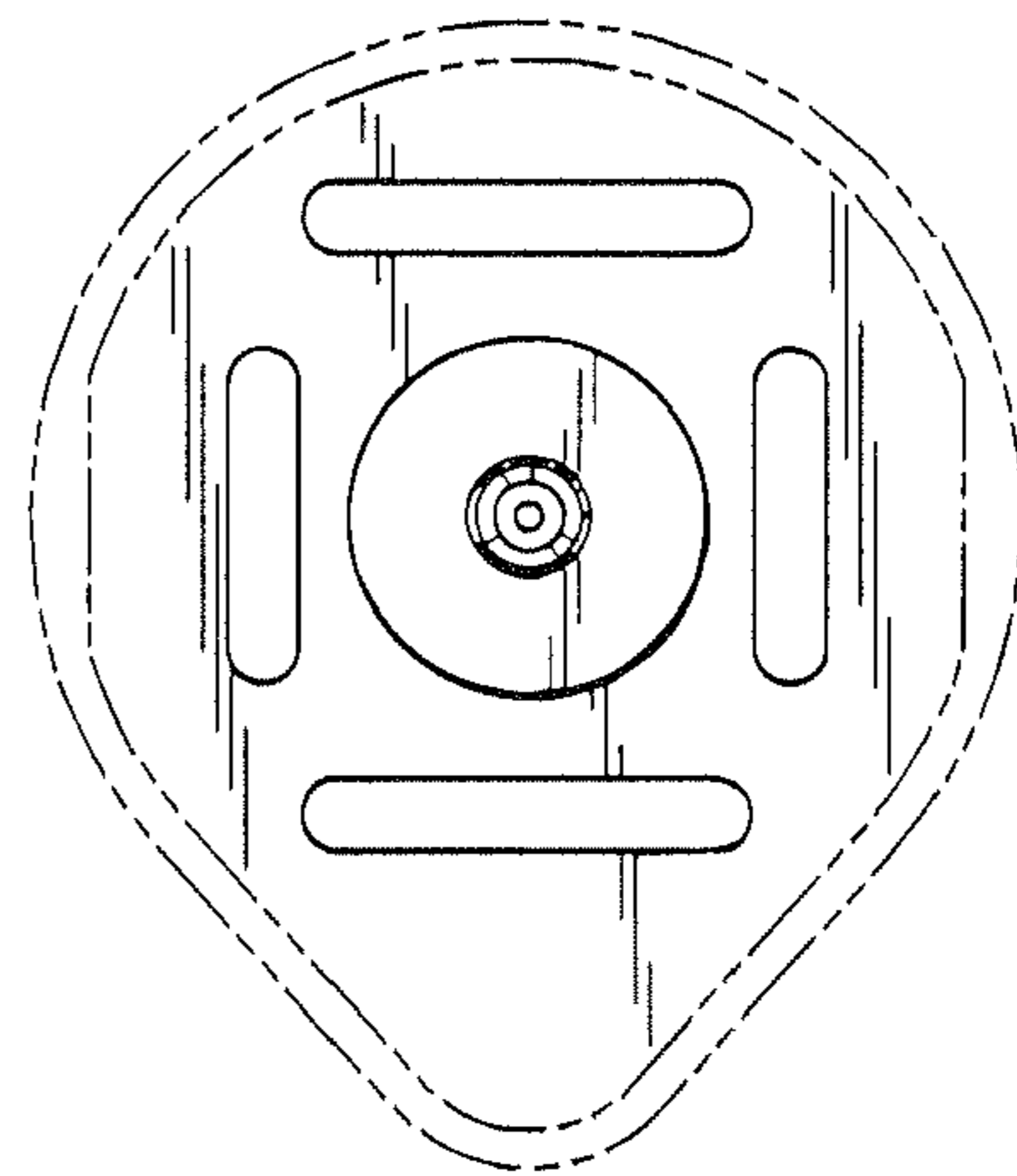
