(57) **CLAIM**

The ornamental design for a dual handle electric hair dryer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the dual handle electric hair dryer of my new design;

FIG. 2 is a side elevational view of the dual handle electric hair dryer of FIG. 1, the opposite side being a mirror image of the side shown;

FIG. 3 is a top plan view of the dual handle electric hair dryer of FIG. 1;

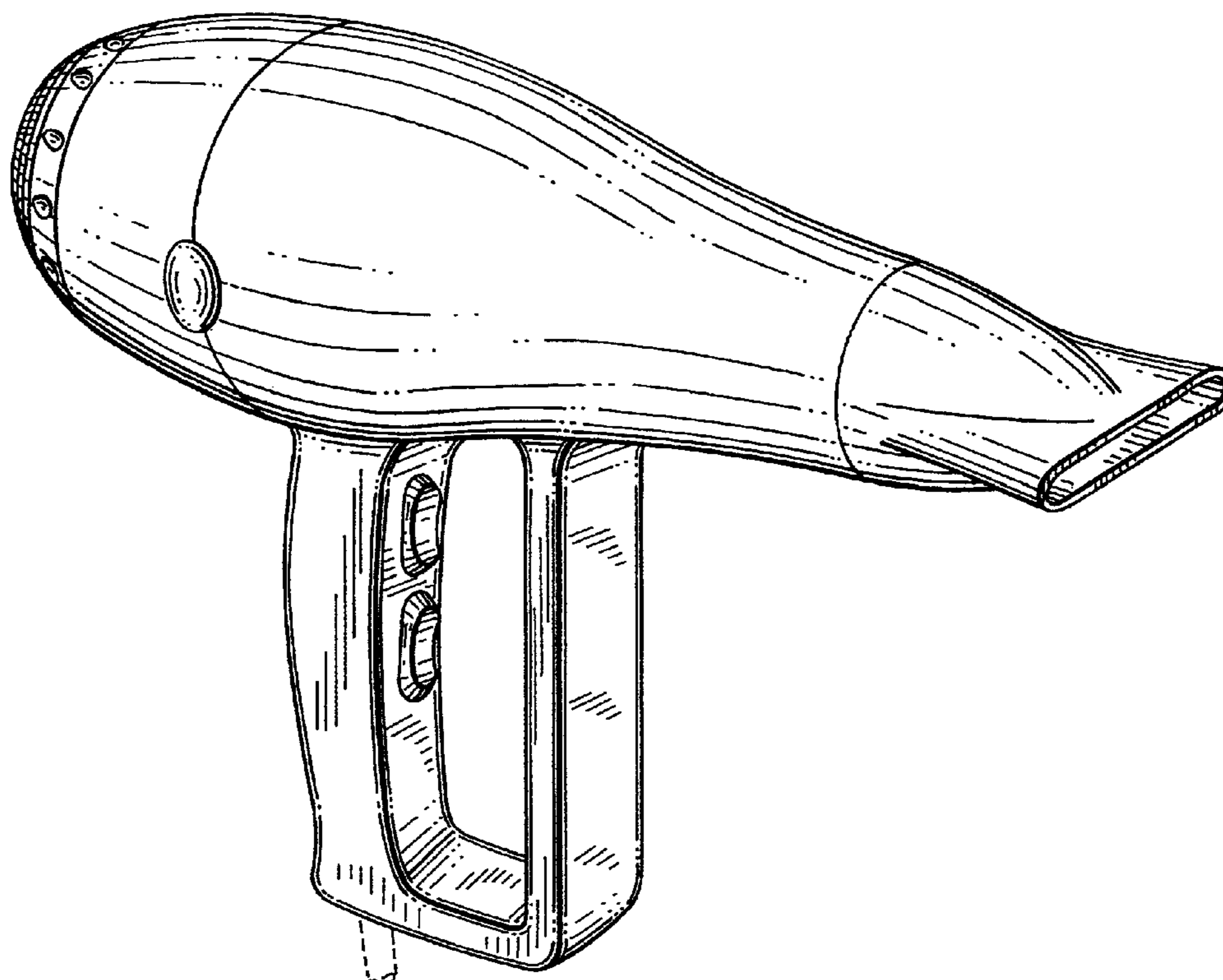
FIG. 4 is a front elevational view of the dual handle electric hair dryer of FIG. 1;

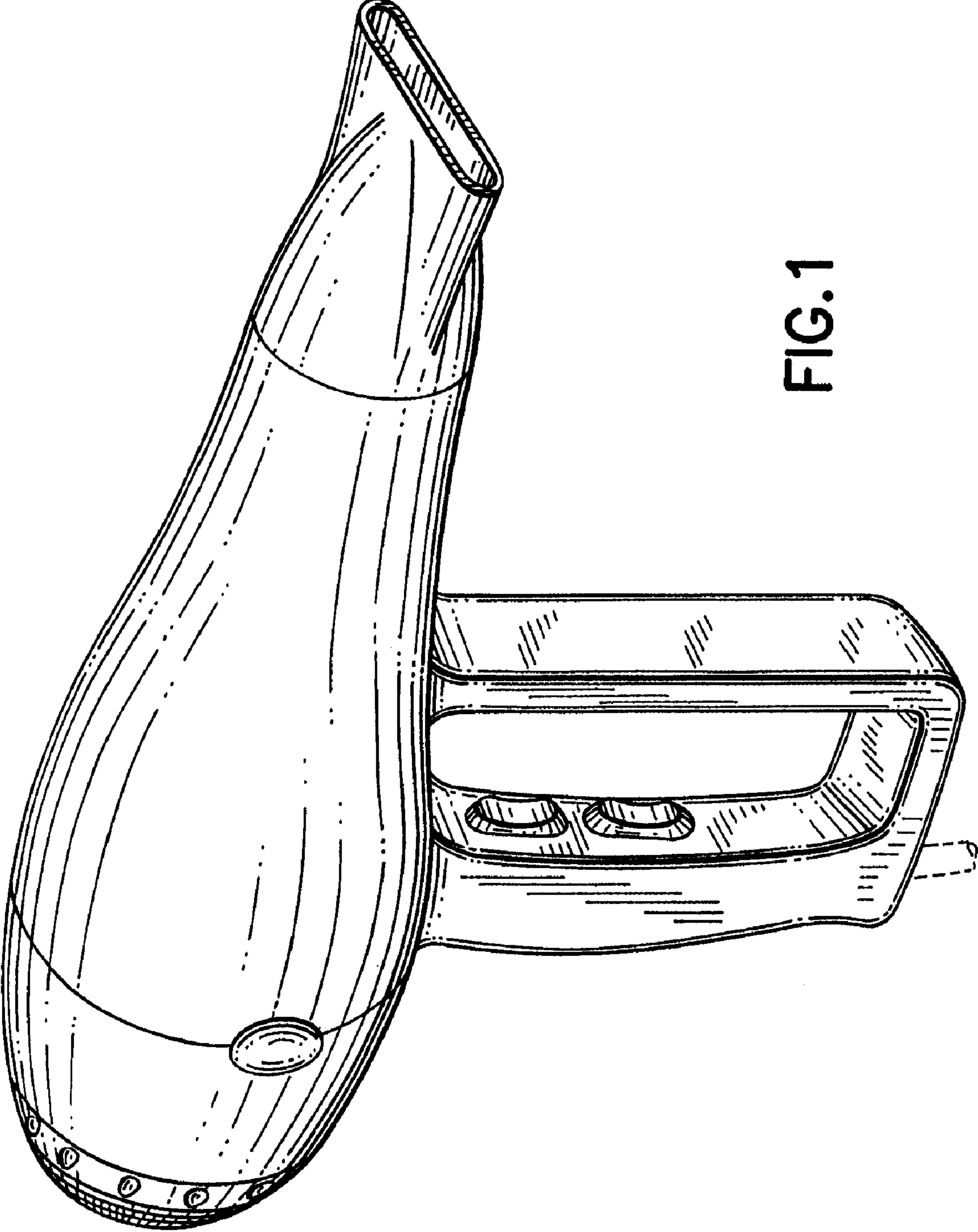

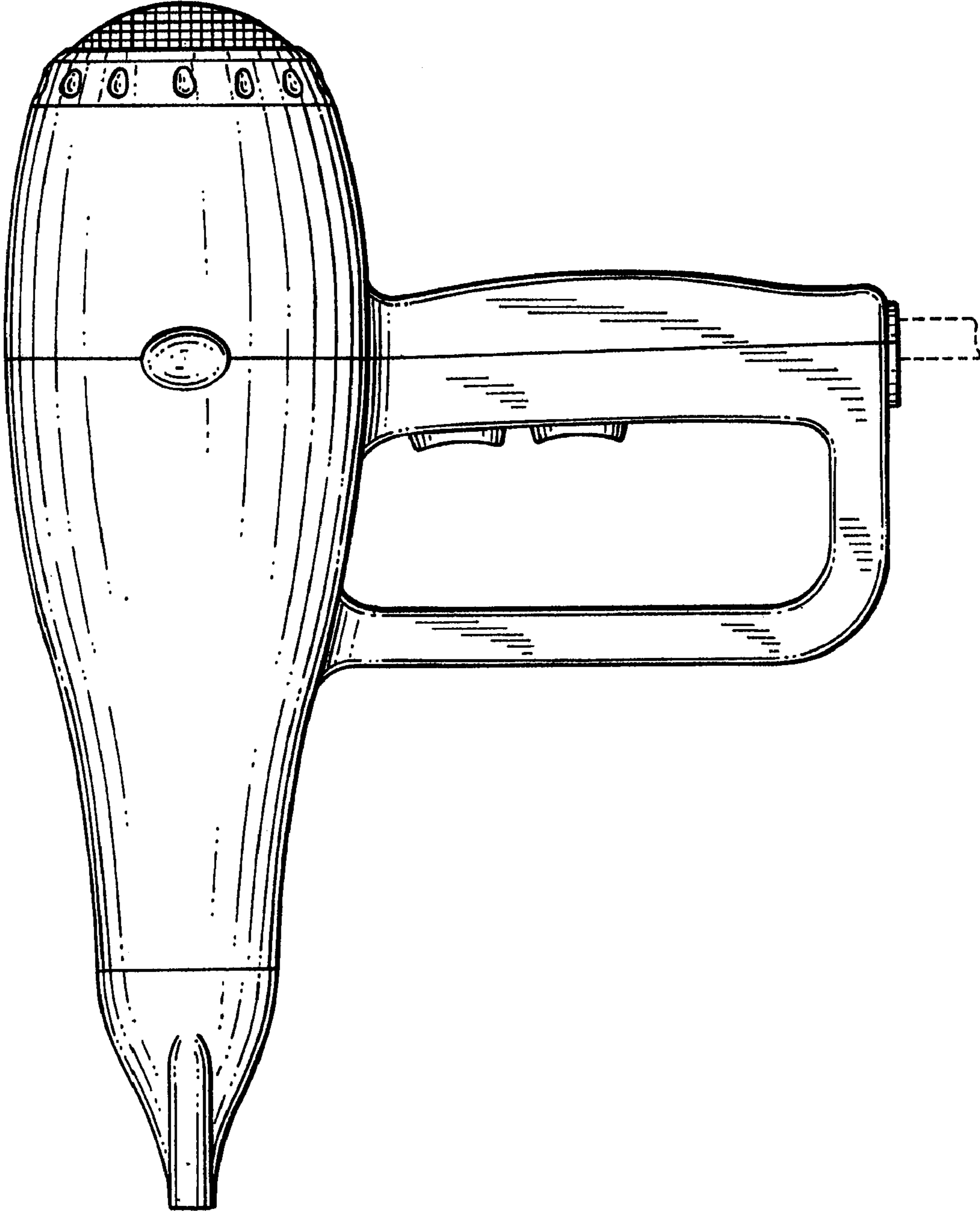

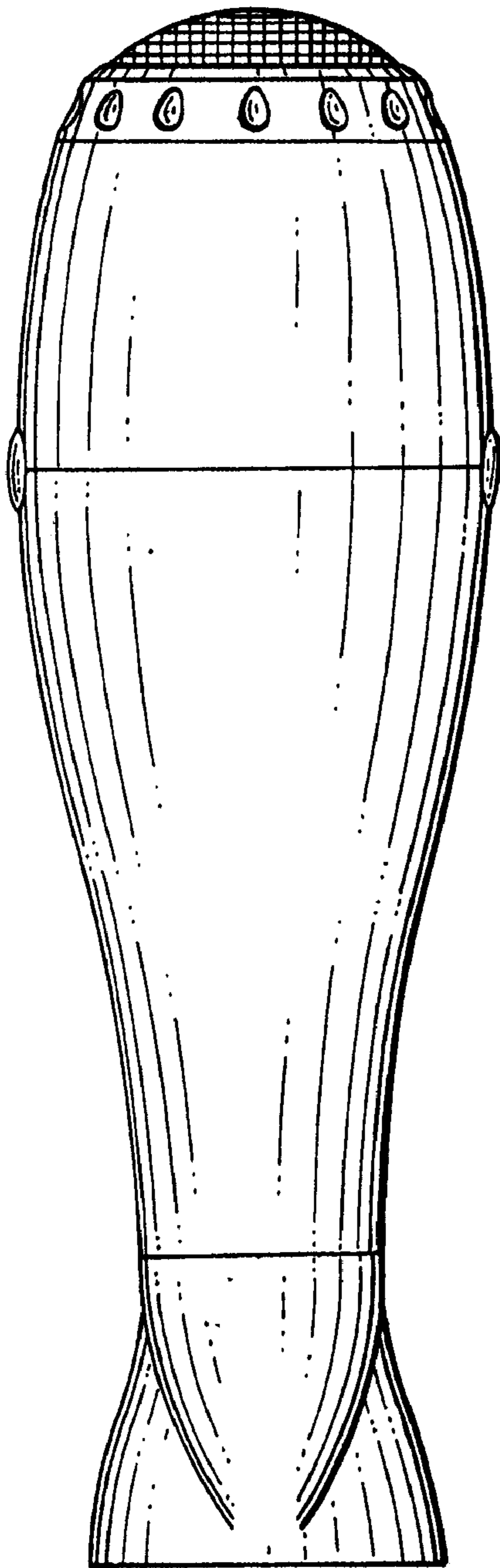
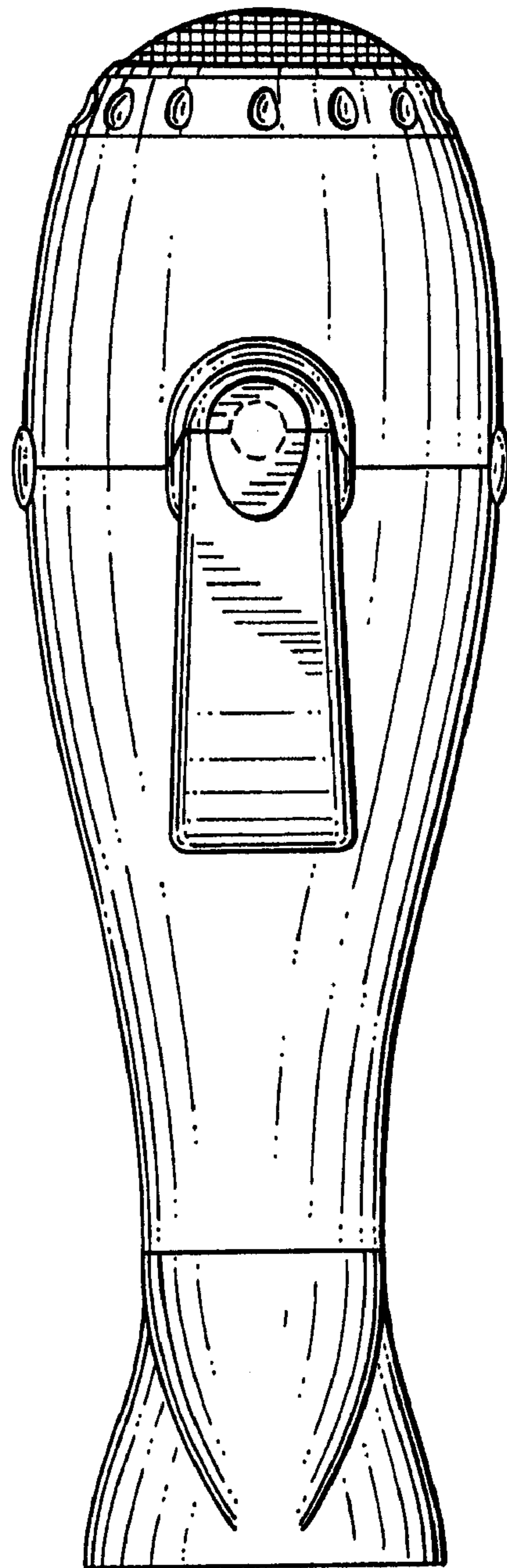

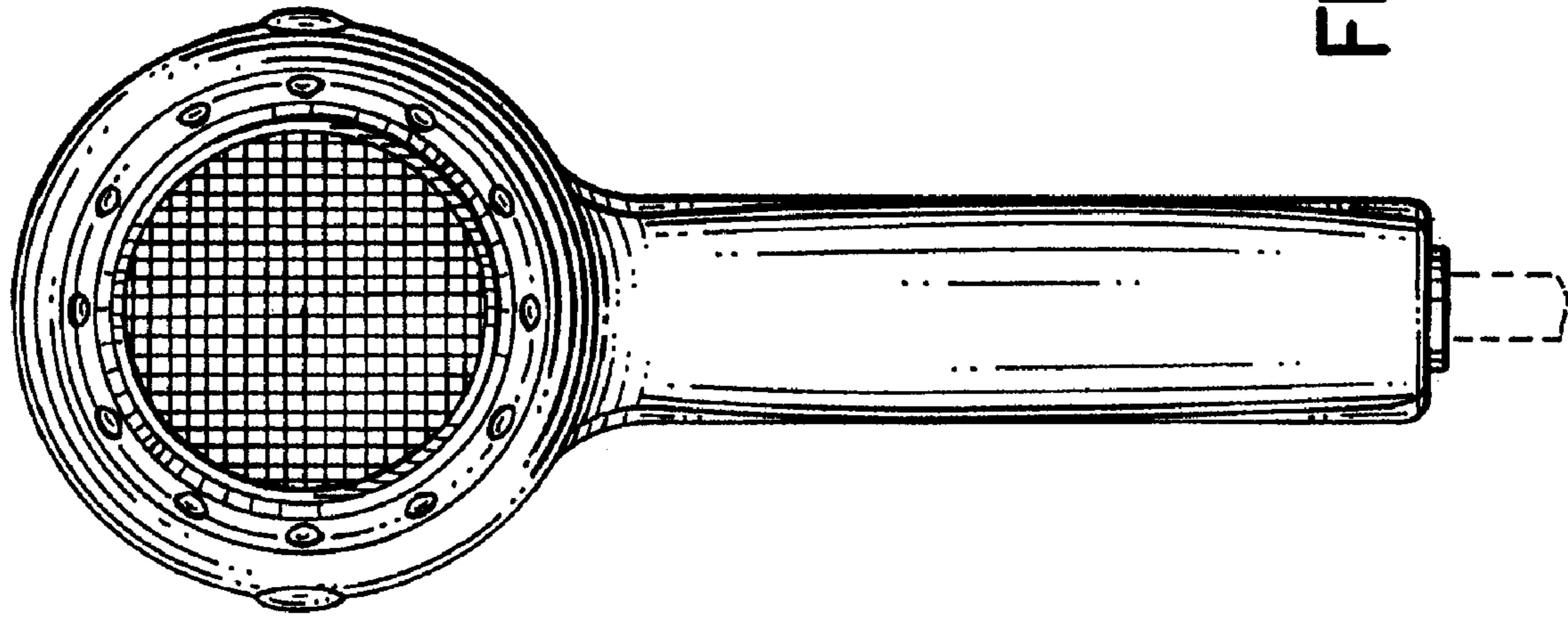

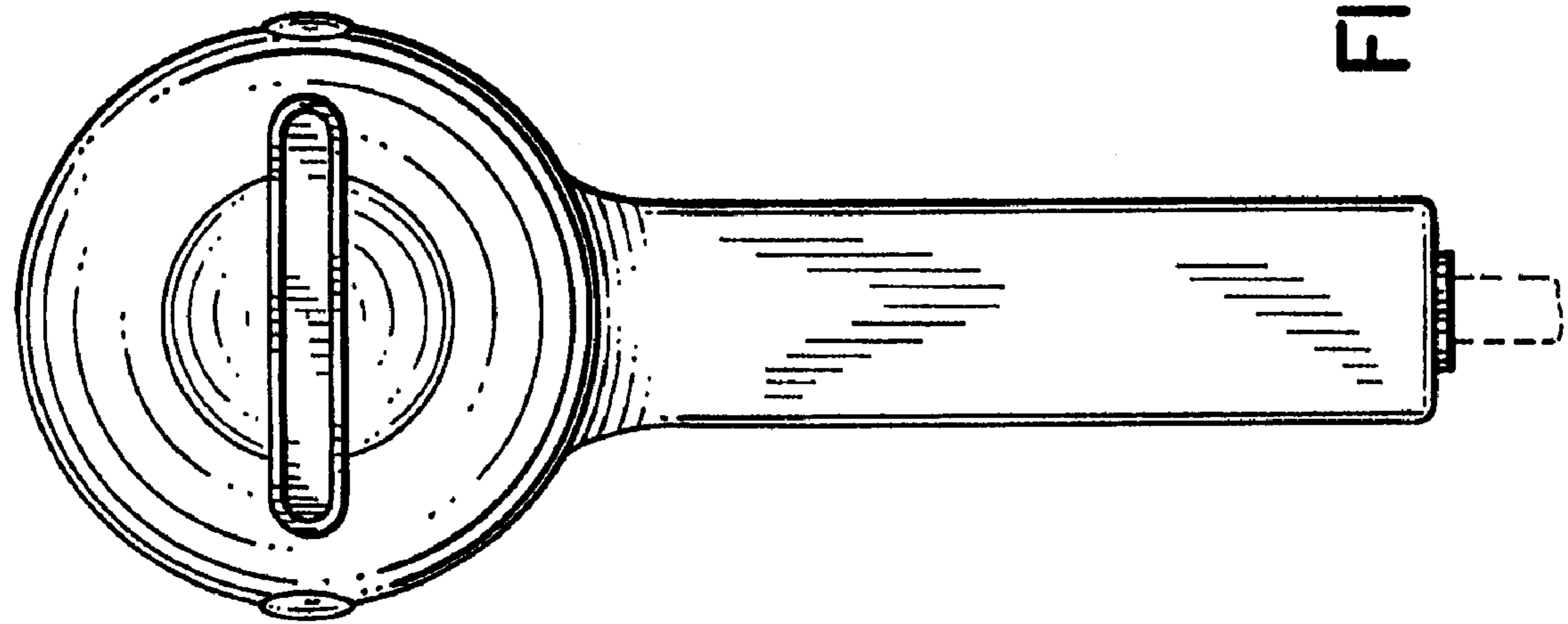
