DESCRIPTION

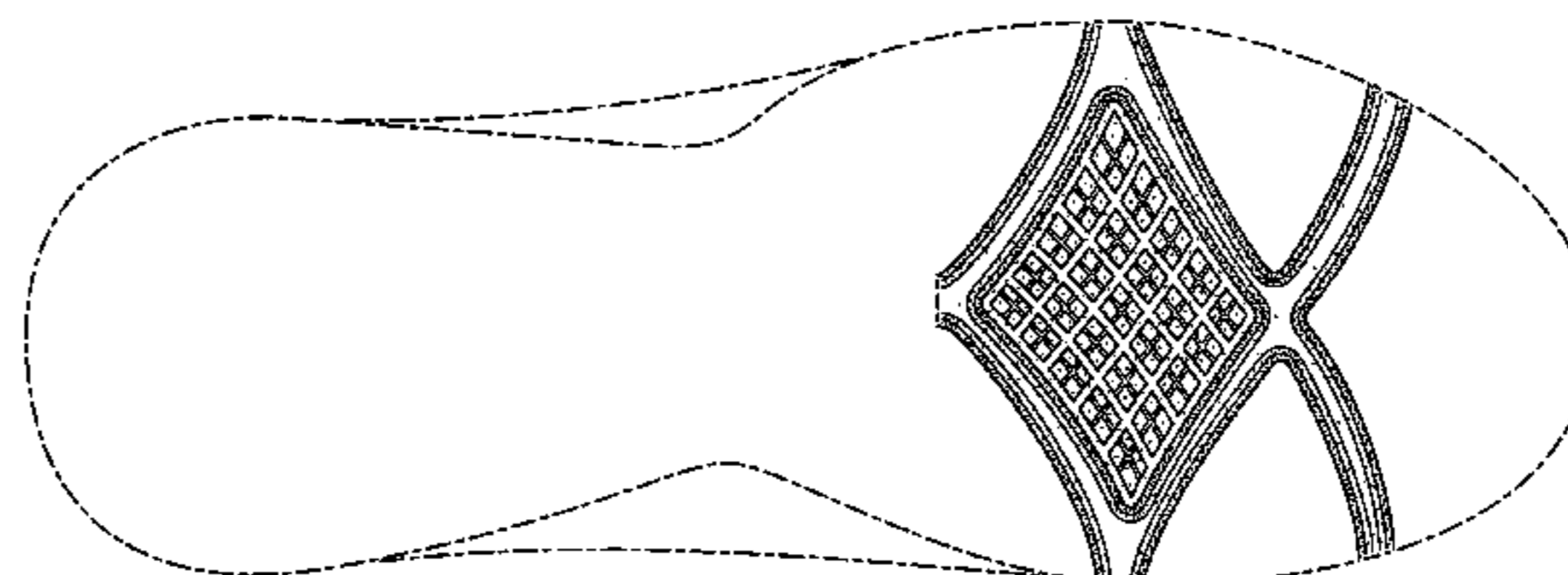
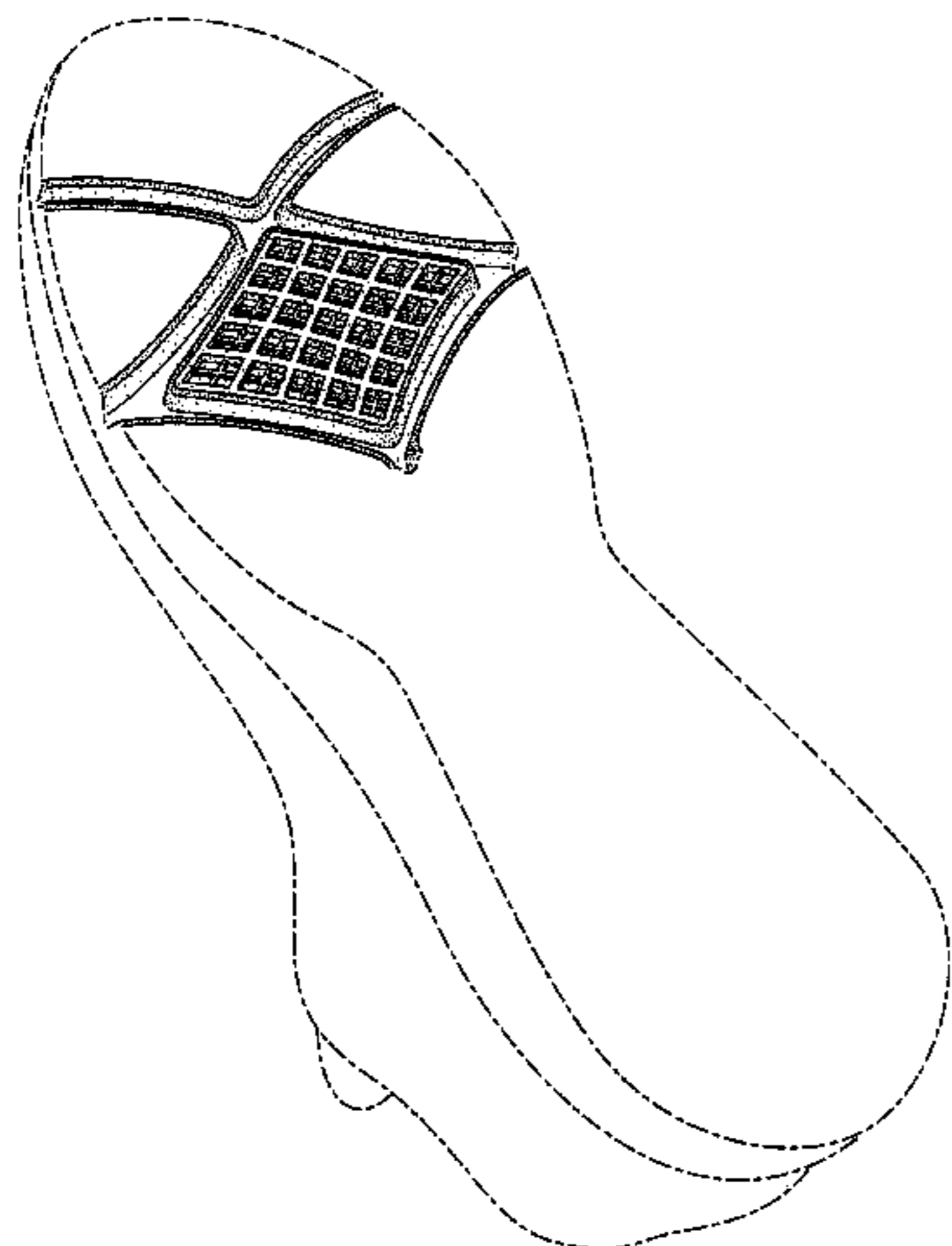
FIG. 1 is a perspective view of a shoe outsole showing my new design;

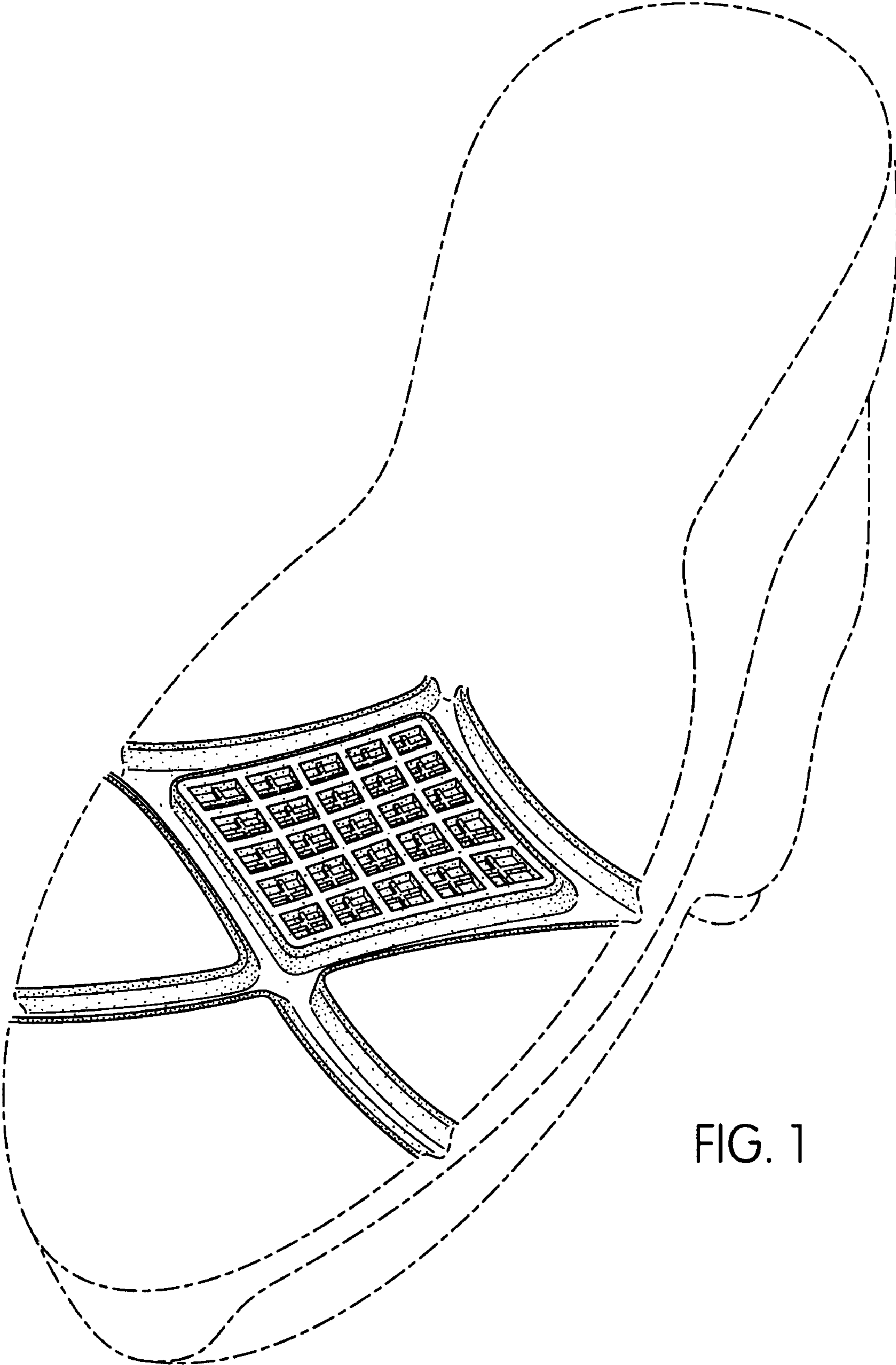

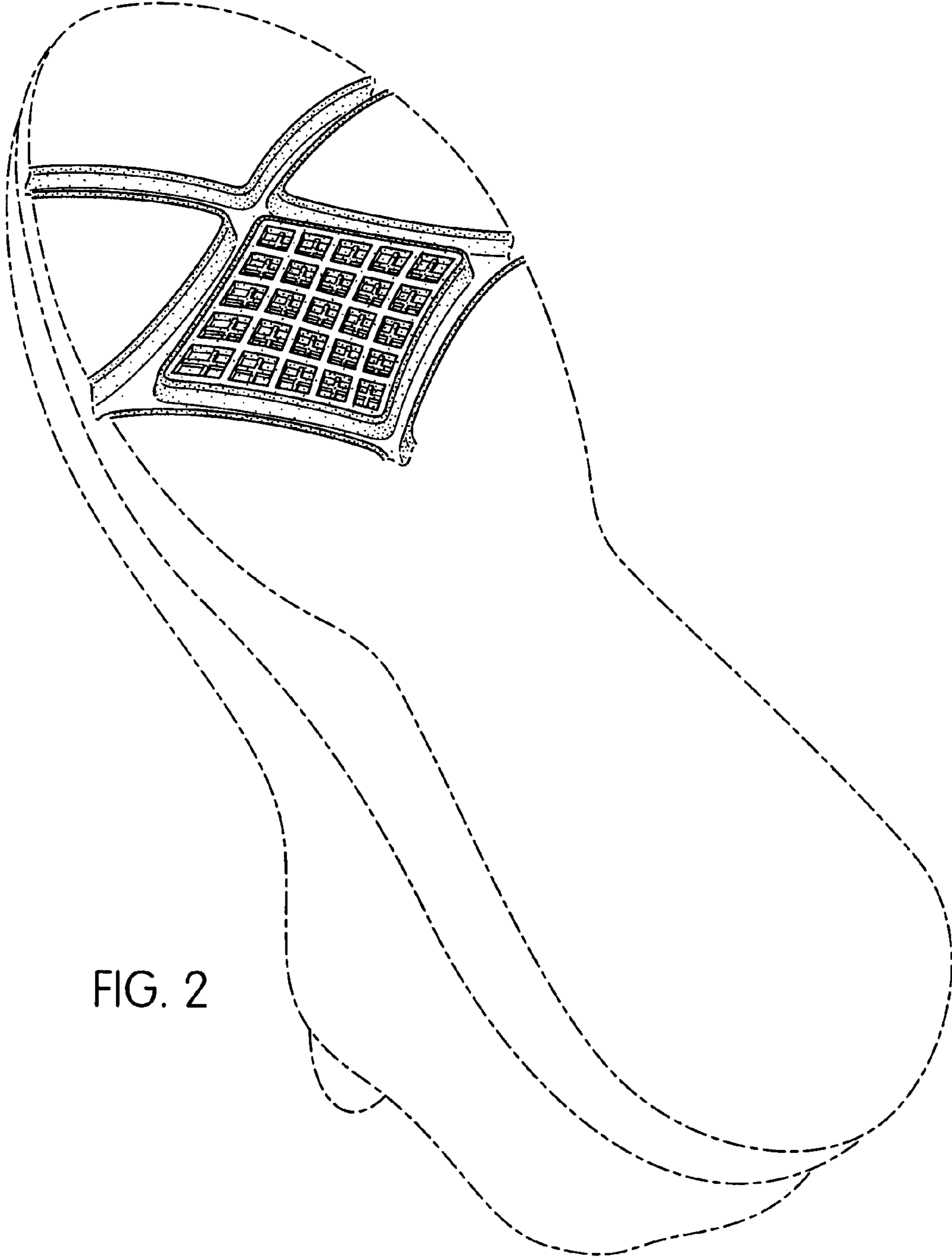

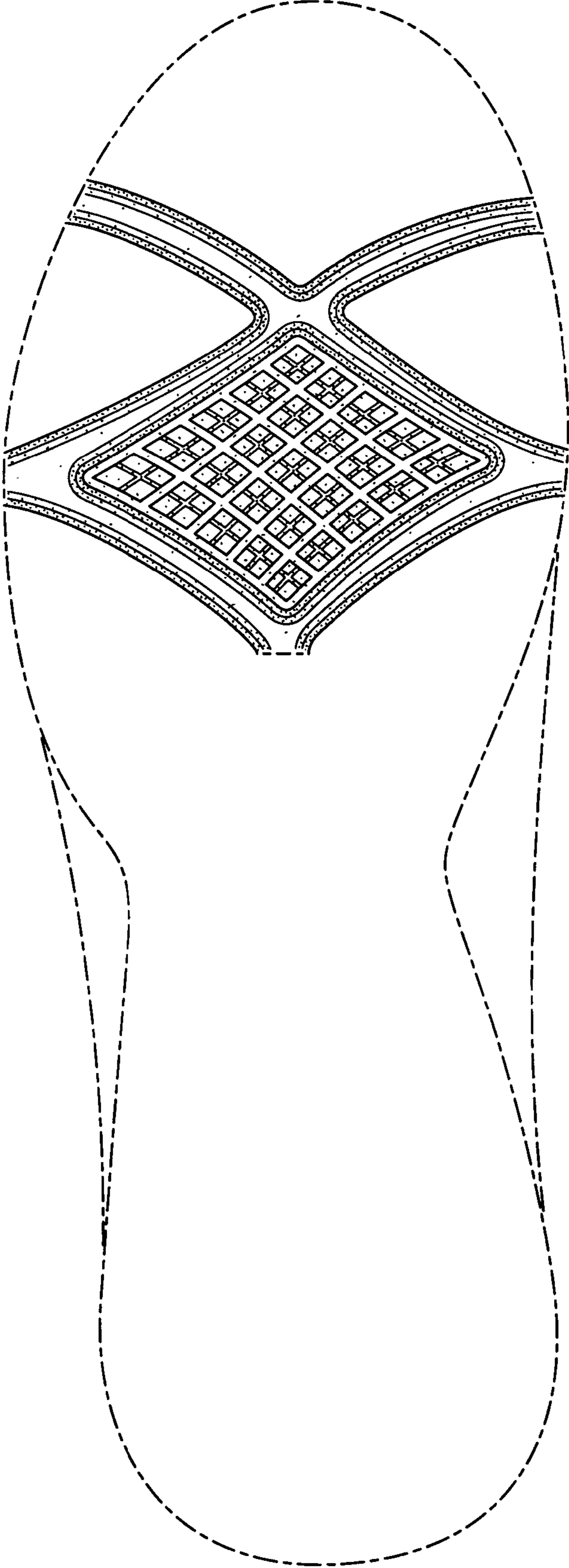
