FIG. 4 is an enlarged front view of the ornamental design of FIG. 1;

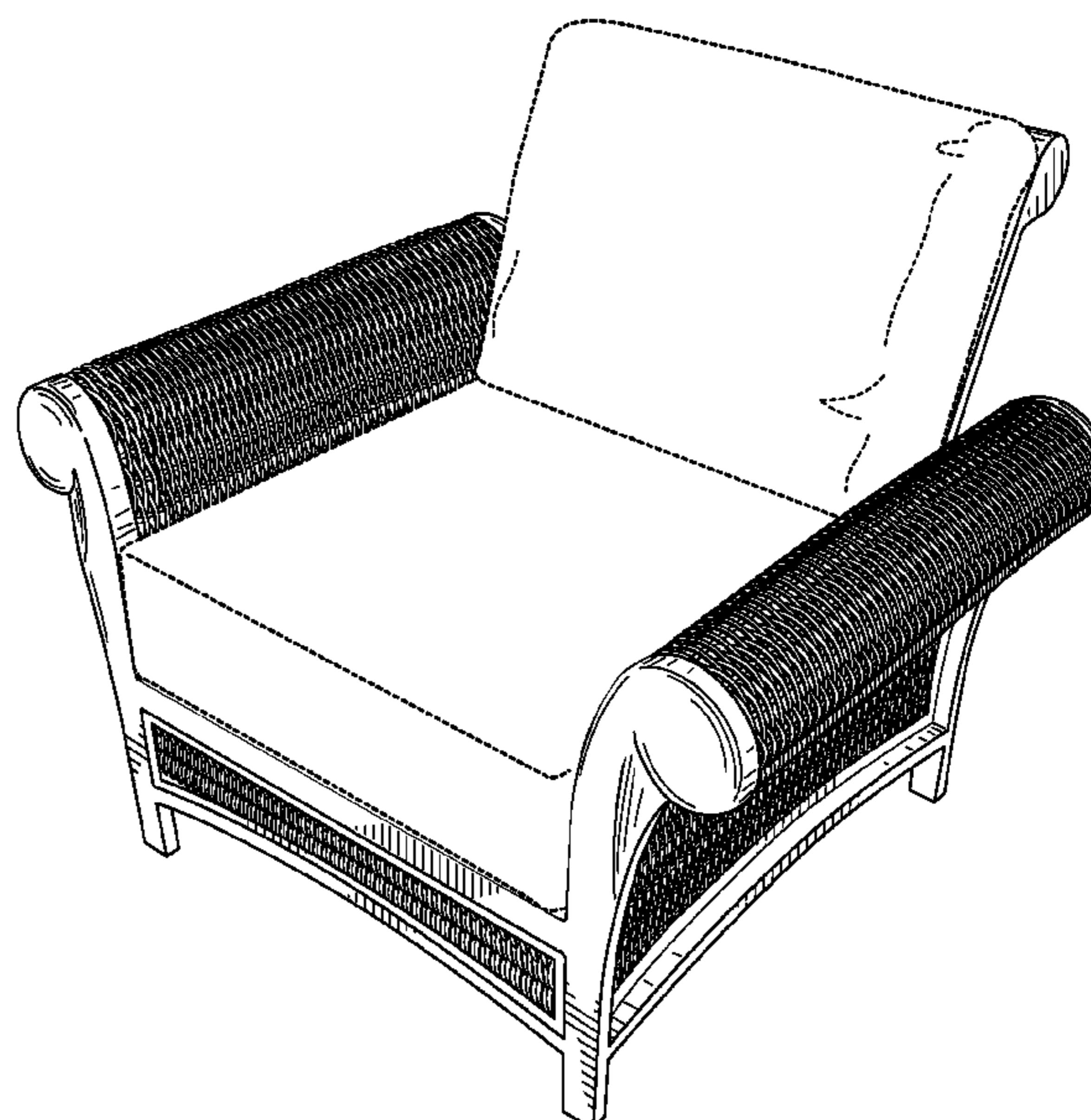
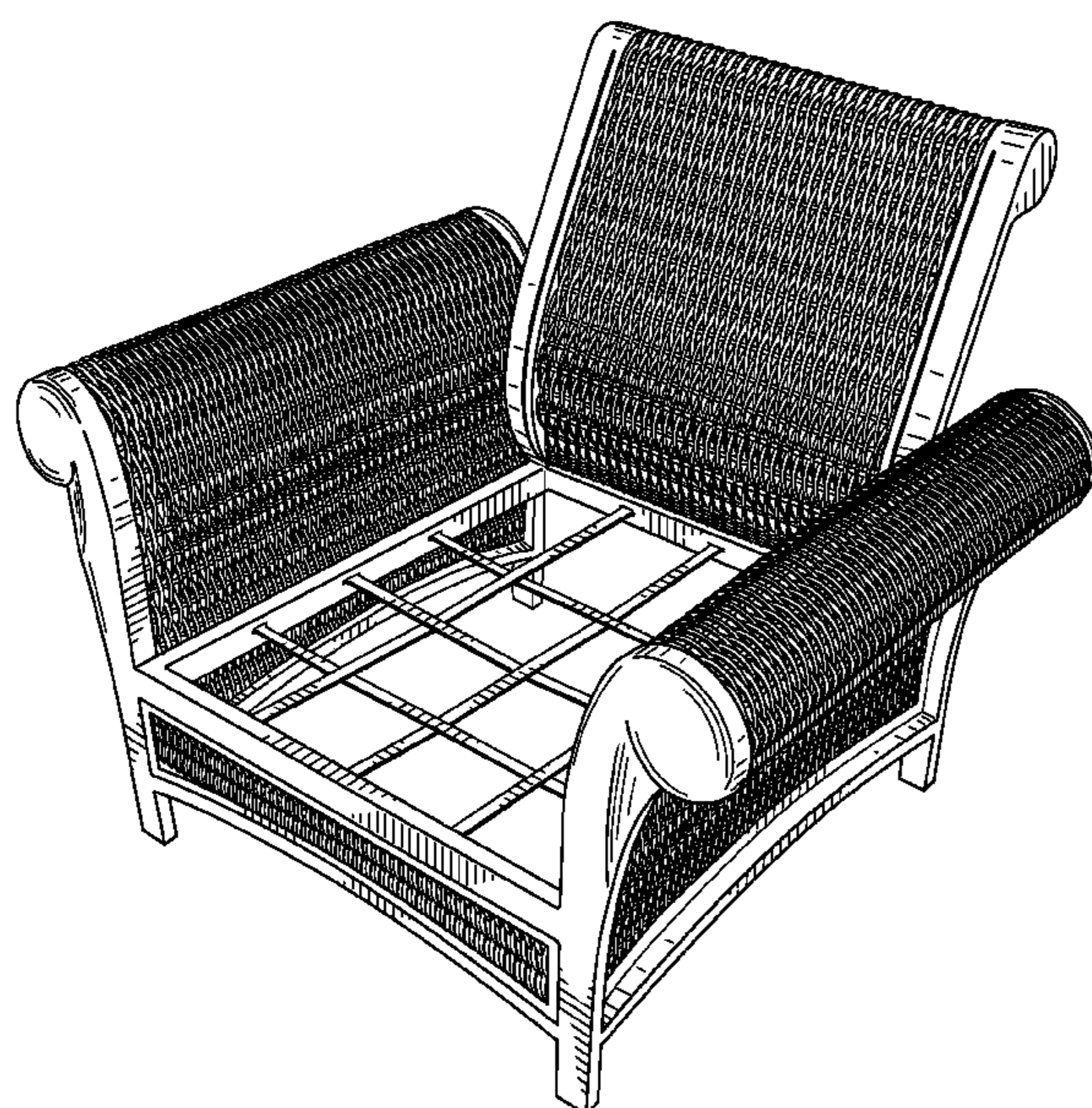
FIG. 5 is an enlarged rear view of the ornamental design of FIG. 1;

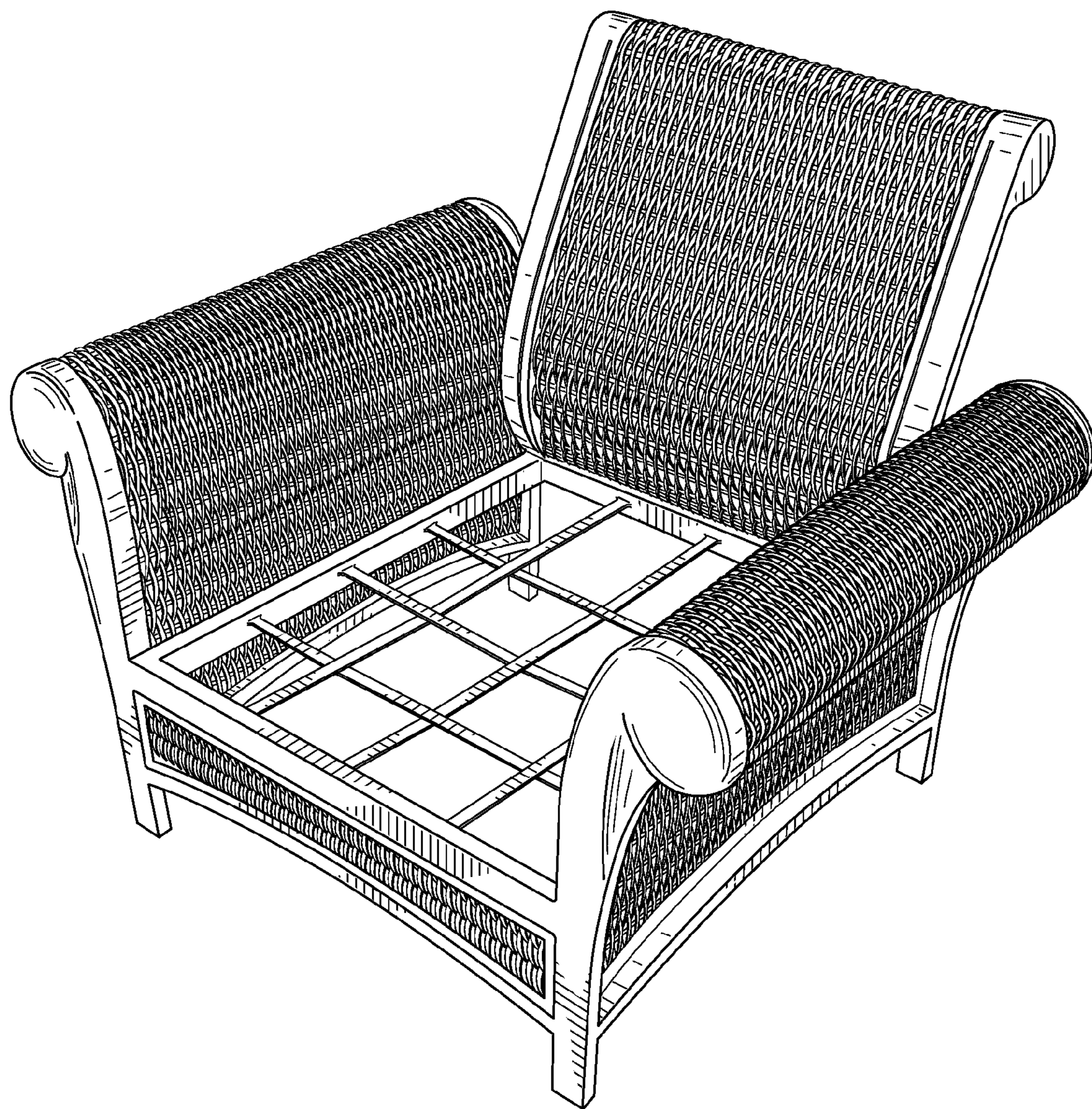

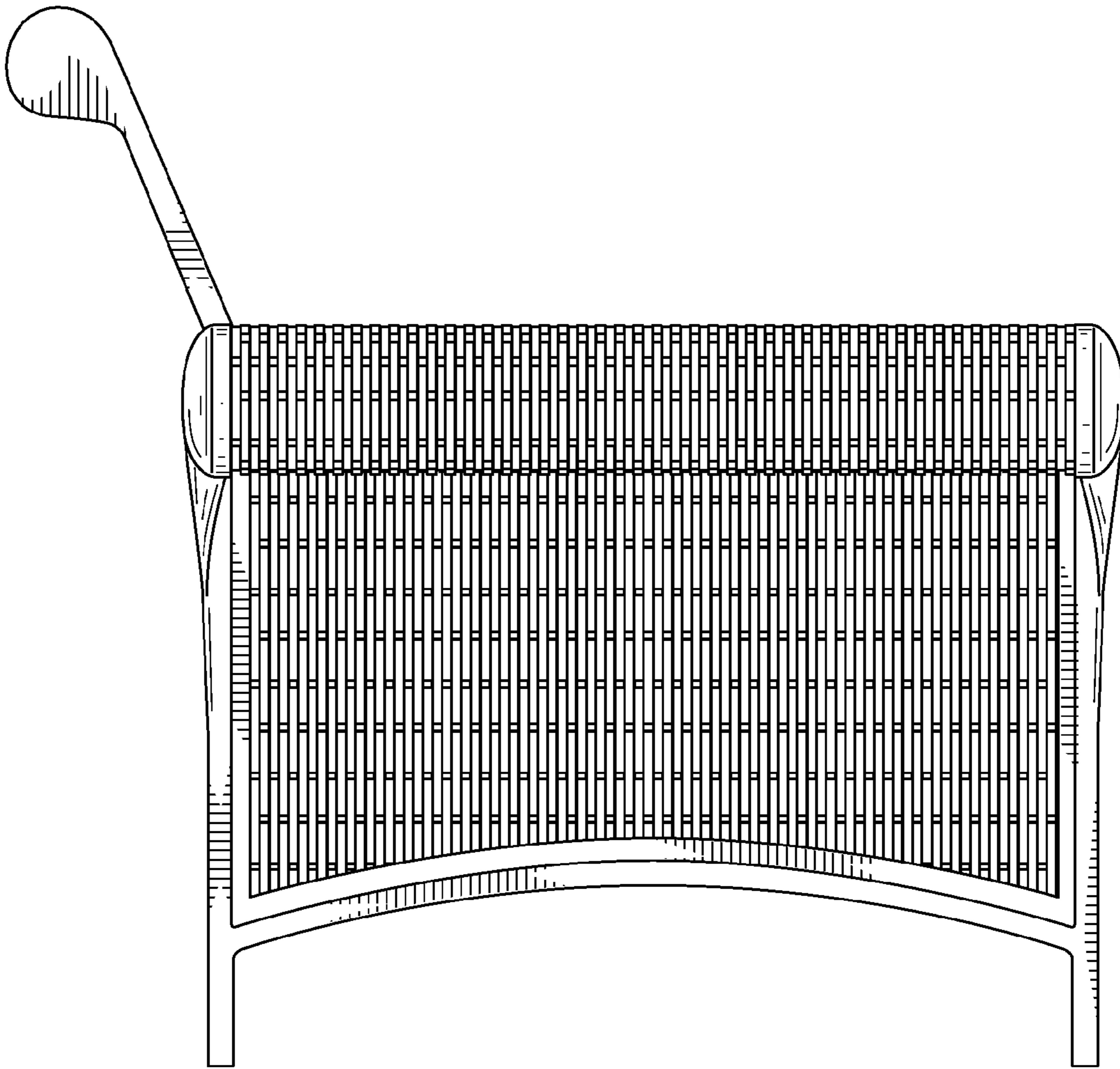

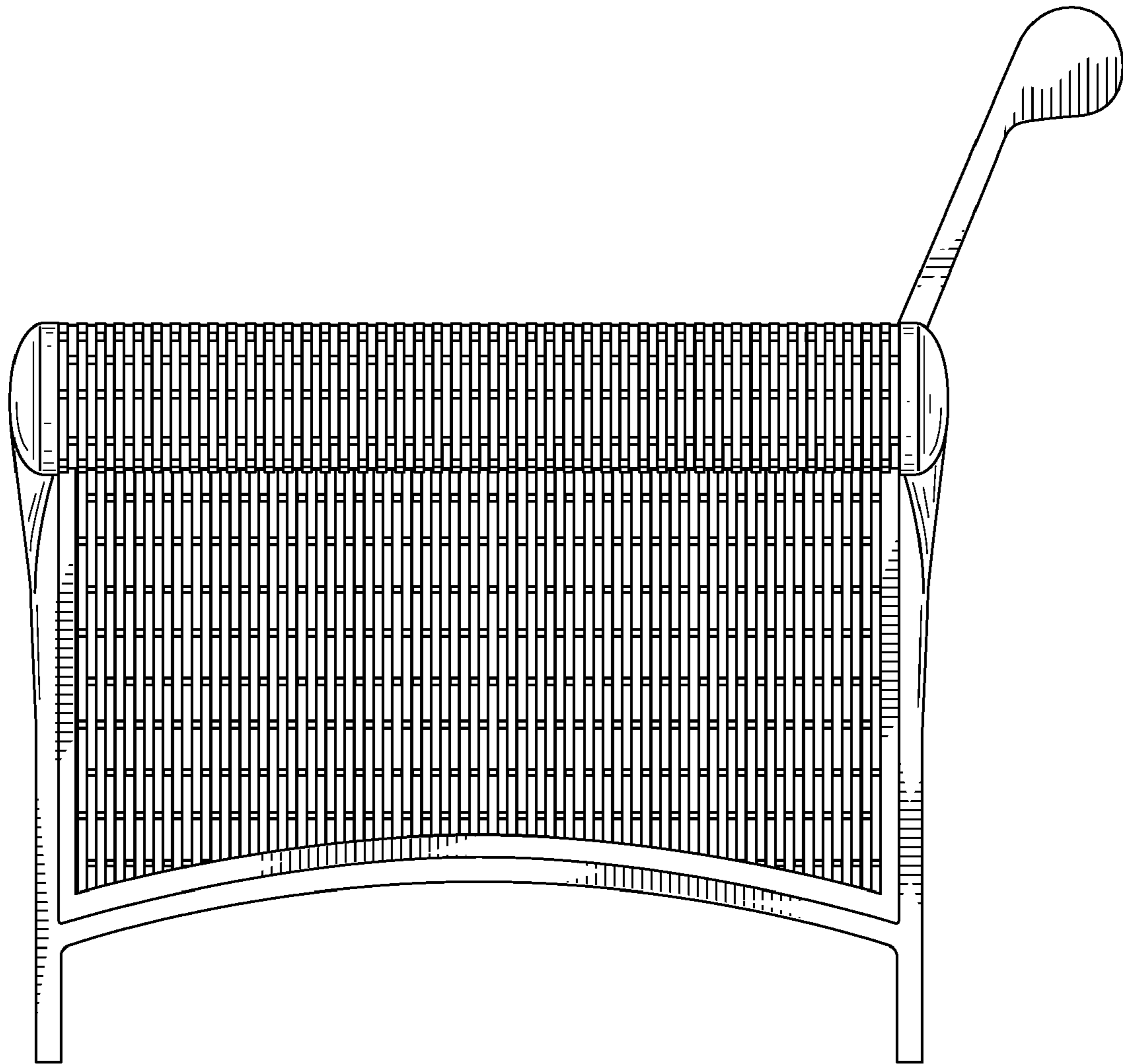

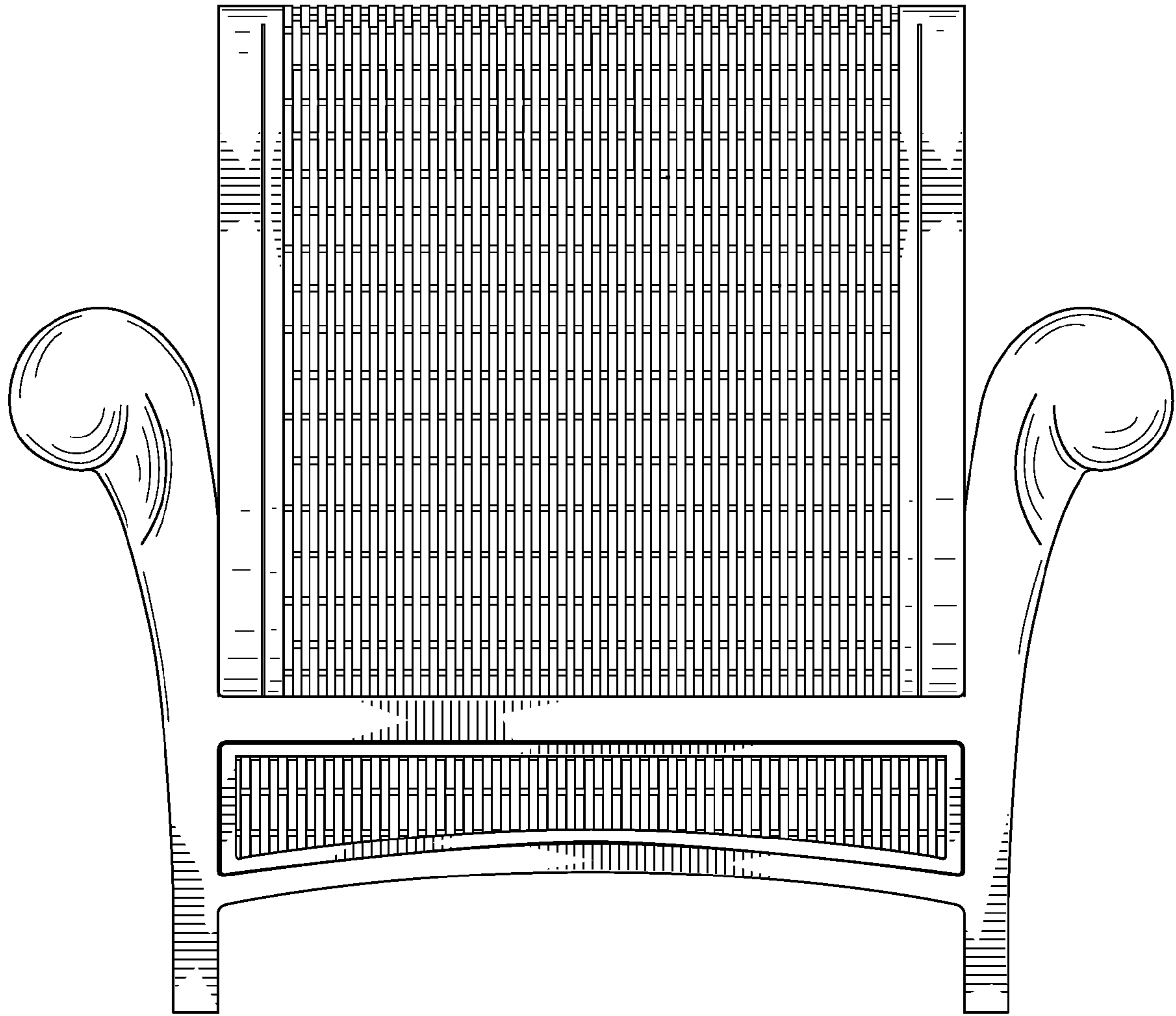

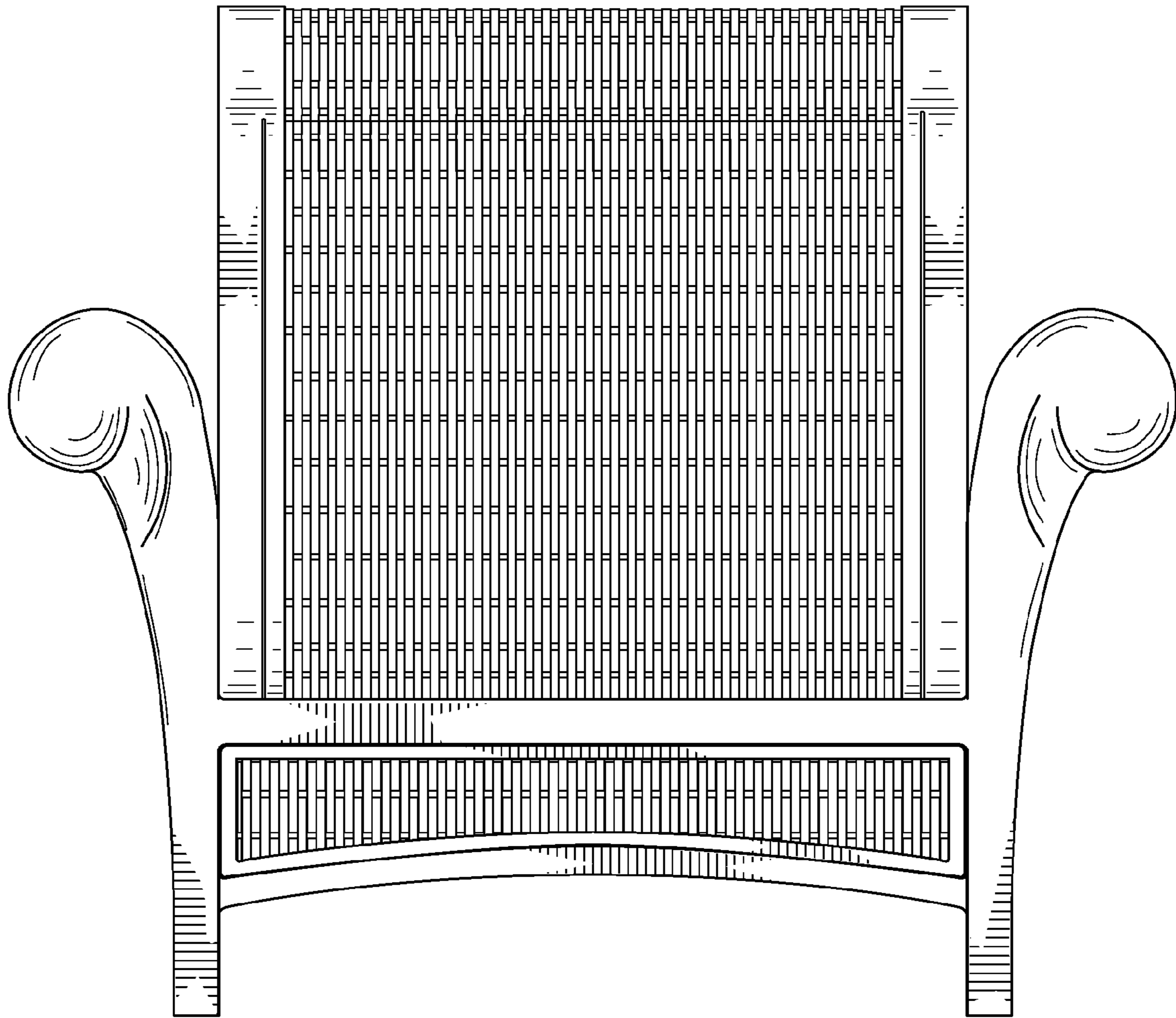

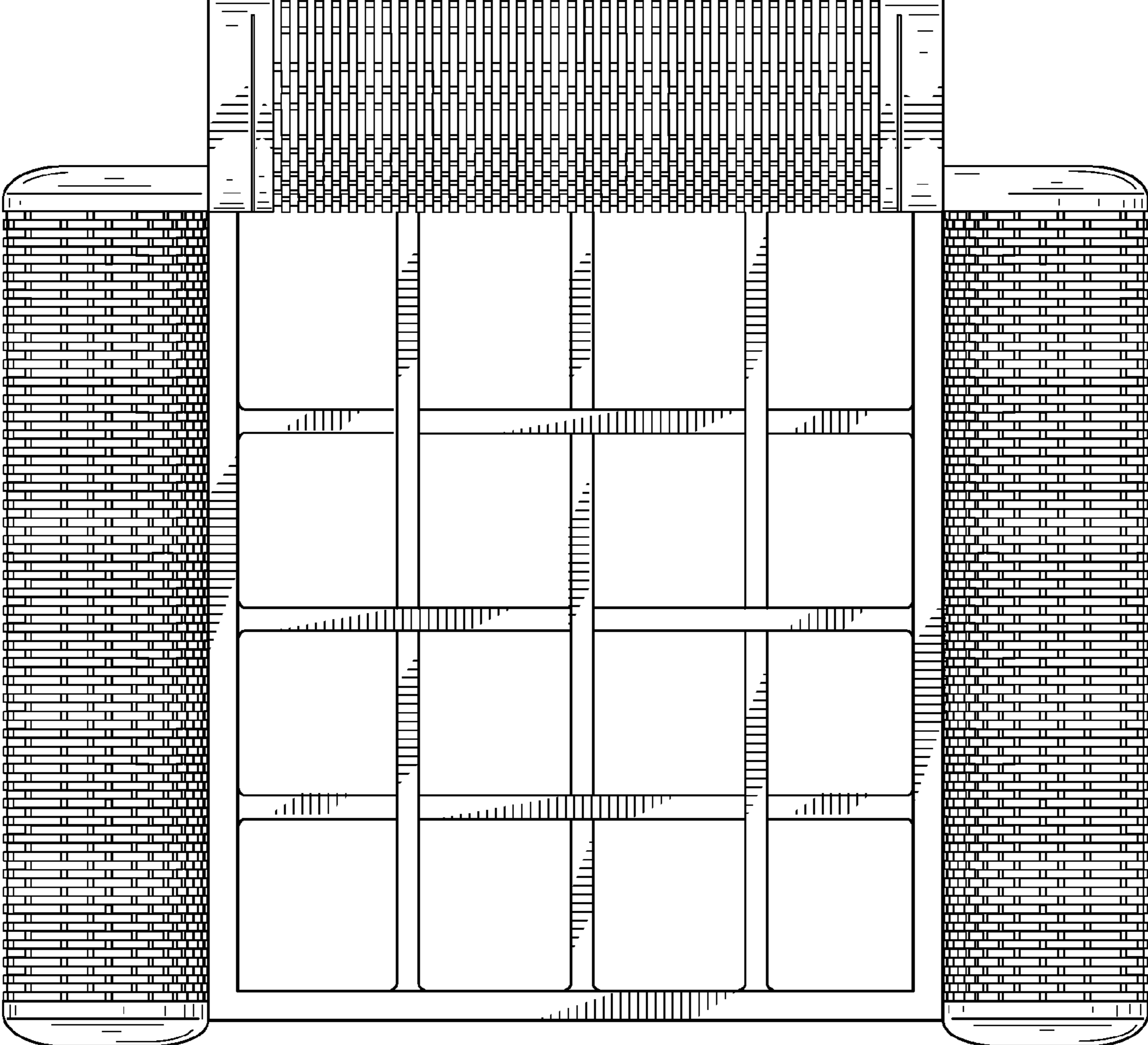

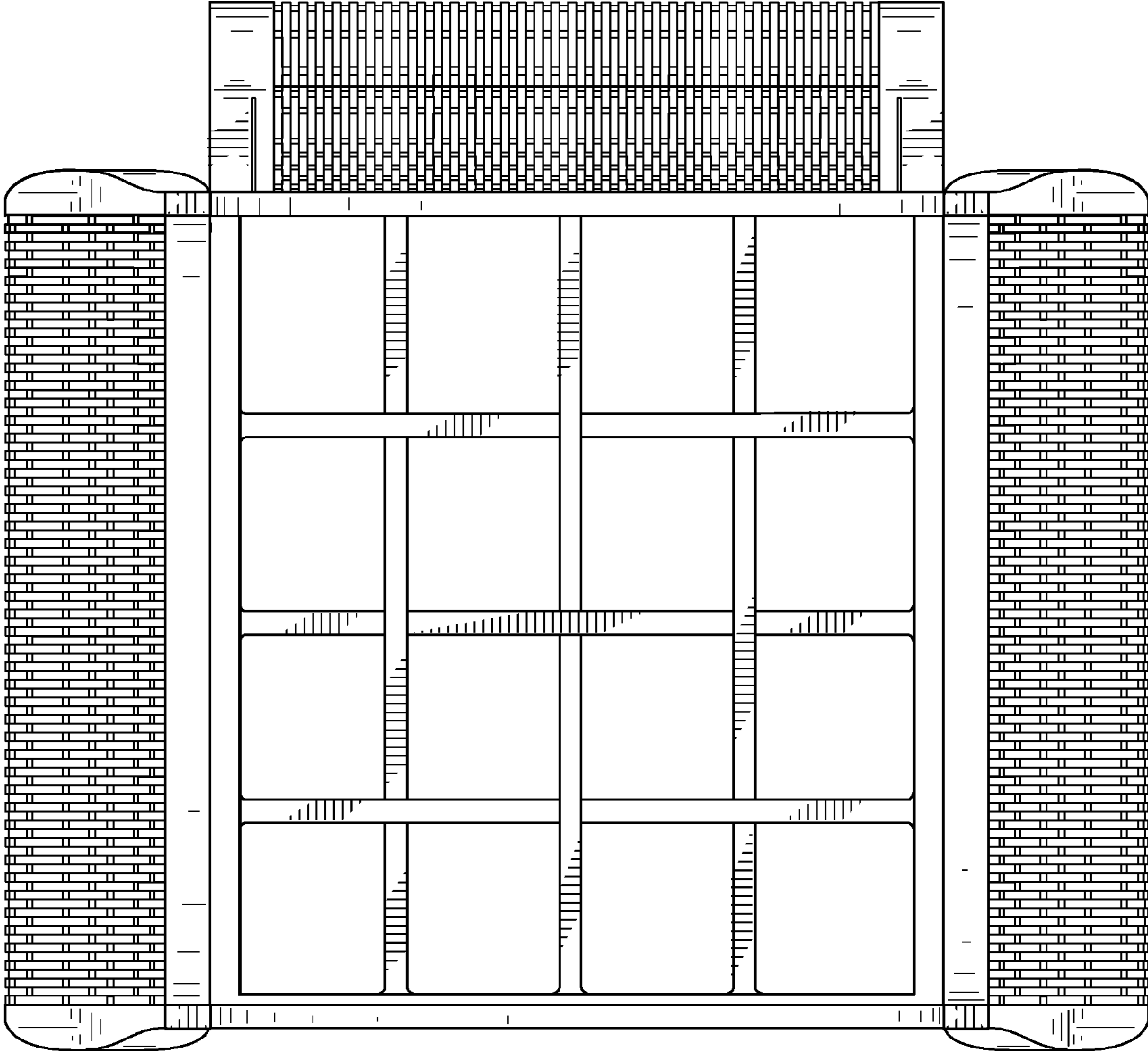

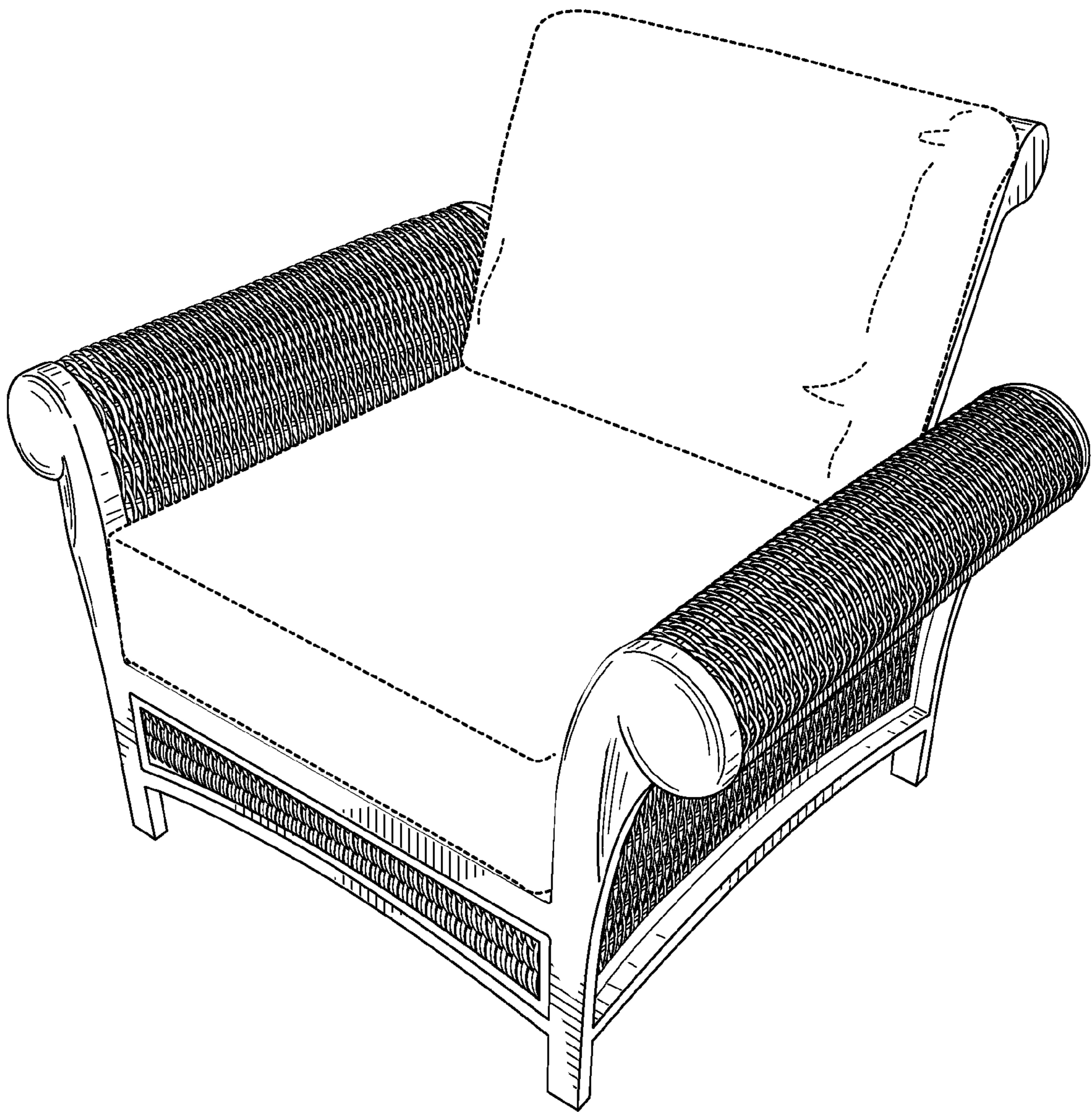
