(57) **CLAIM**

The ornamental design for a barbecue implement with wood laminate handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a barbecue implement with wood laminate handle showing my new design, the rear elevational view being a mirror image thereof;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a front elevational view of a first alternate embodiment, the rear elevational view being a mirror image thereof;

FIG. 7 is a top plan view of the first alternate embodiment;

FIG. 8 is a bottom view of the first alternate embodiment;

FIG. 9 is a right side view of the first alternate embodiment;

FIG. 10 is a left side view of the first alternate embodiment;

FIG. 11 is a front elevational view of a second alternate embodiment;

FIG. 12 is a right side view of the second alternate embodiment;

FIG. 13 is a left side view of the second alternate embodiment;

FIG. 14 is a top plan view of the second alternate embodiment; and,

FIG. 15 is a bottom view of the second alternate embodiment.

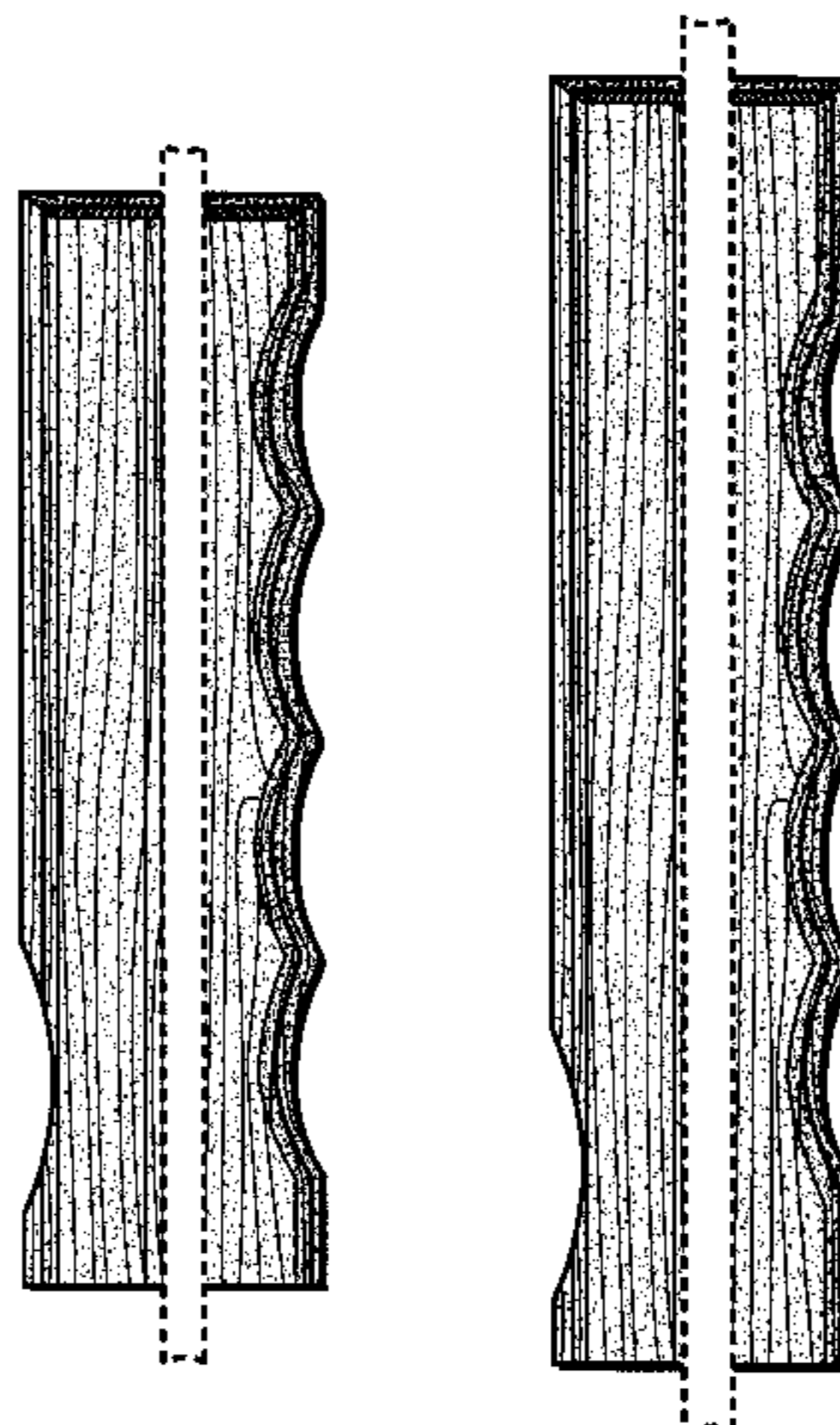

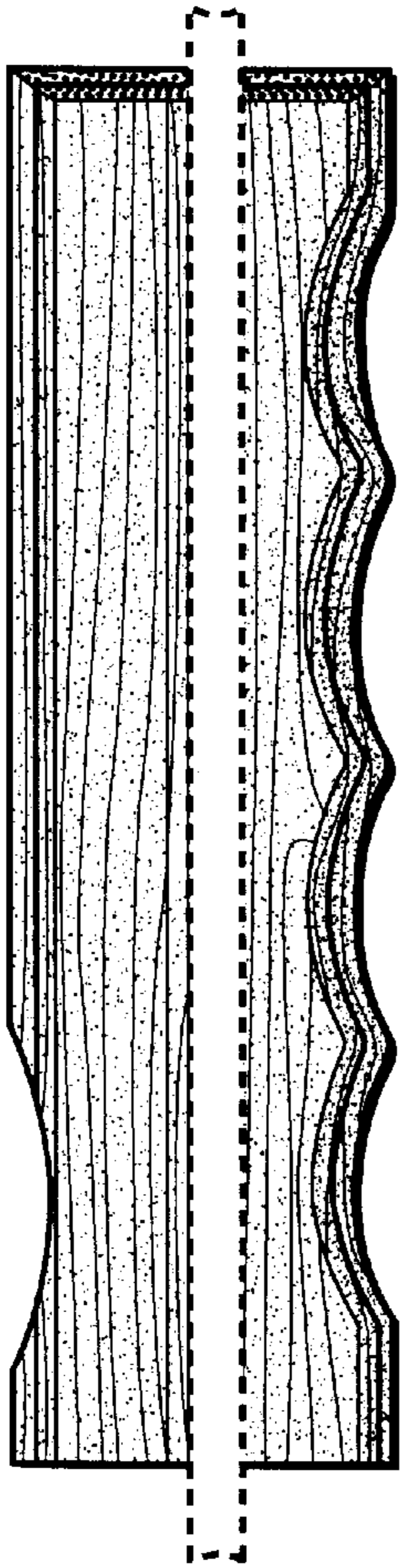

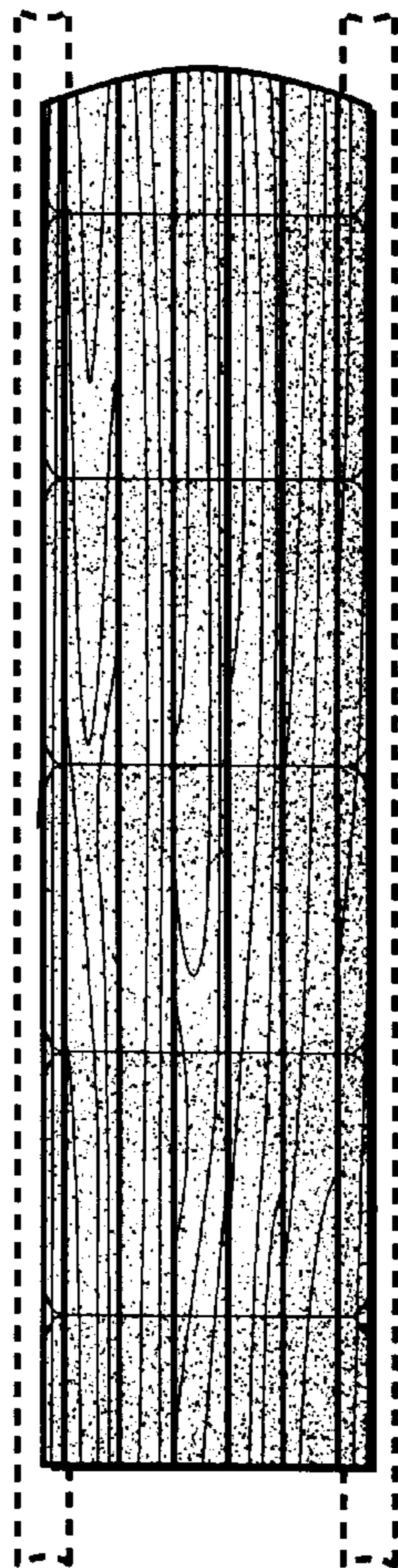

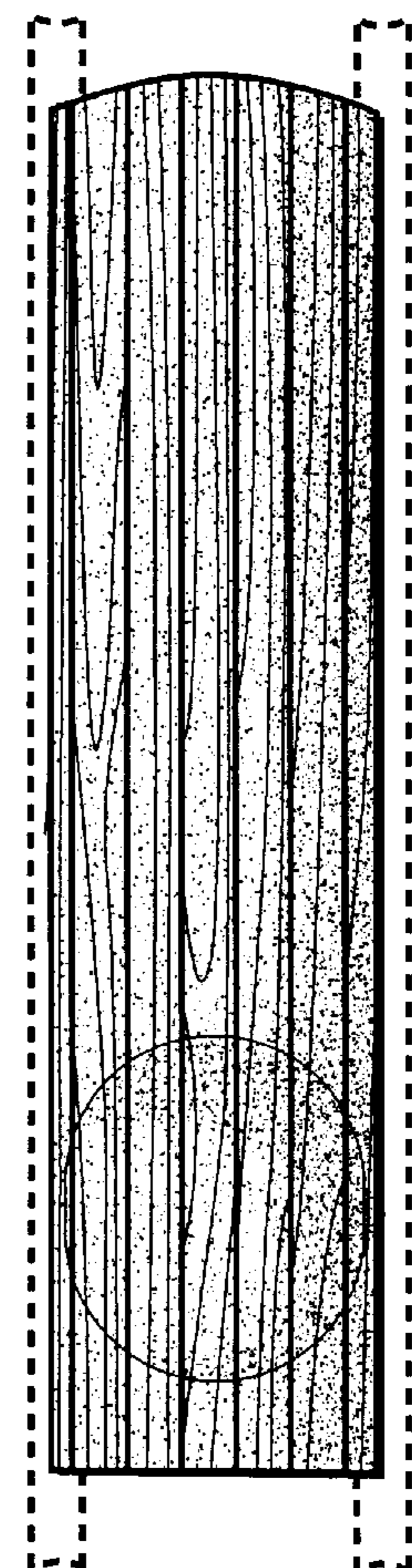

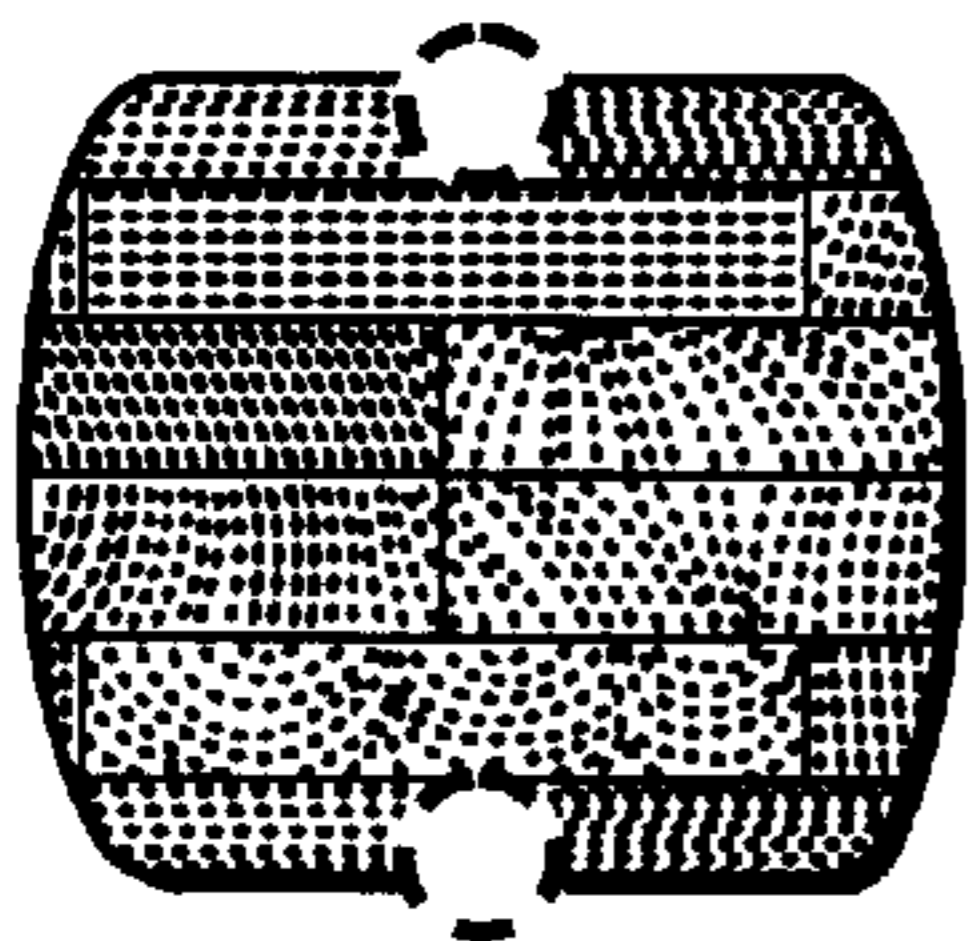

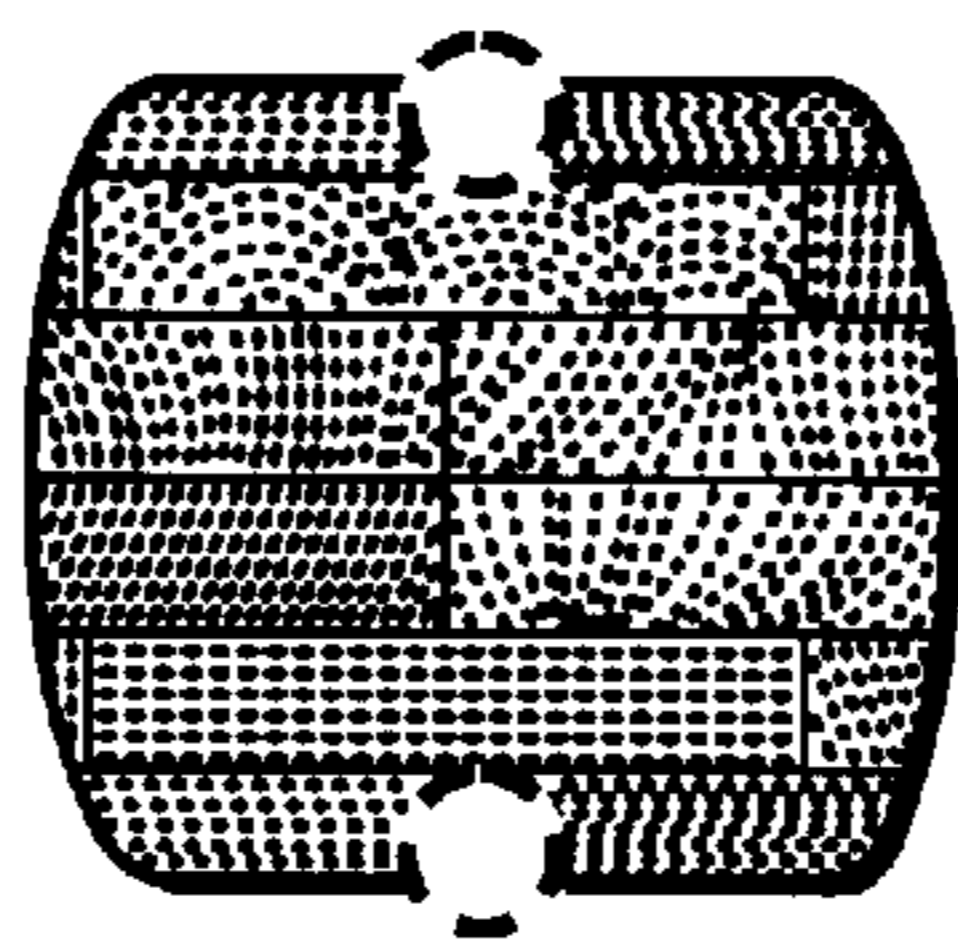

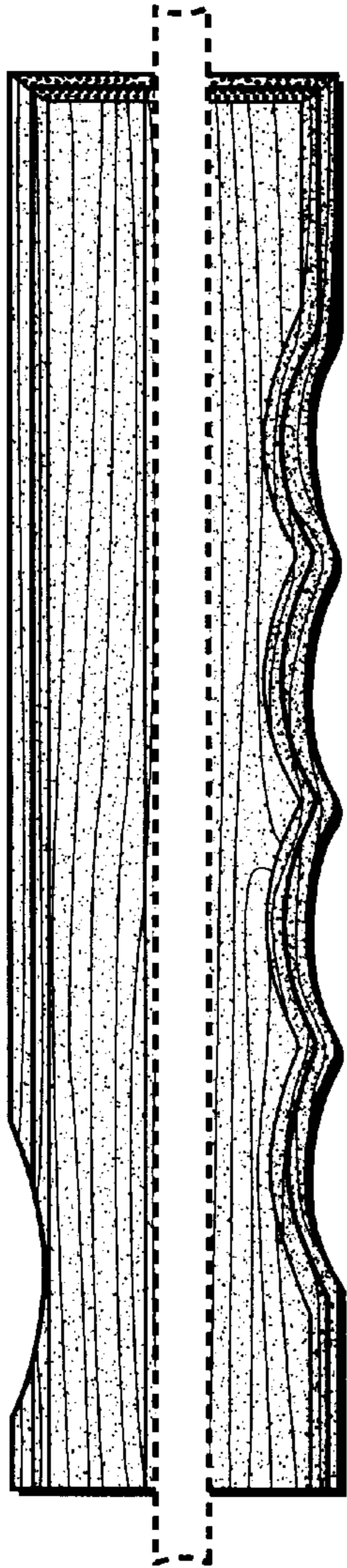

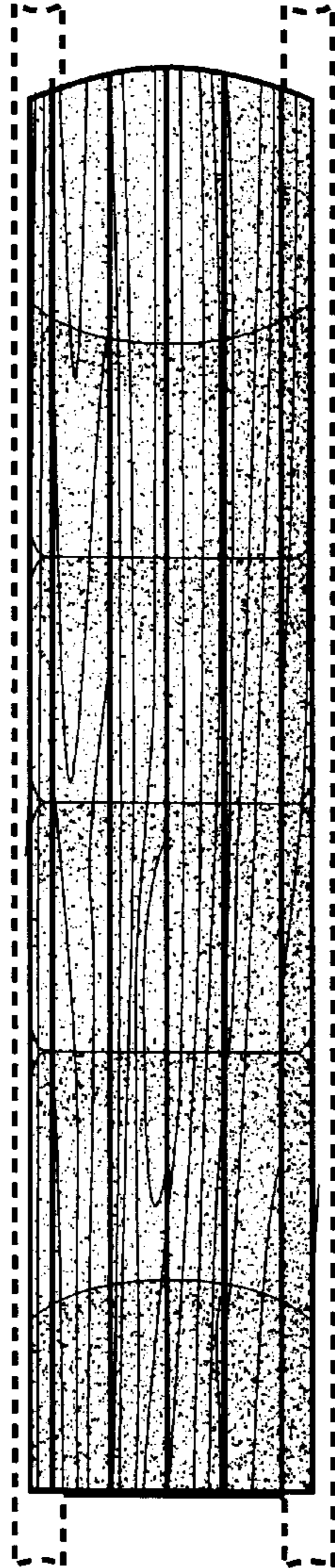

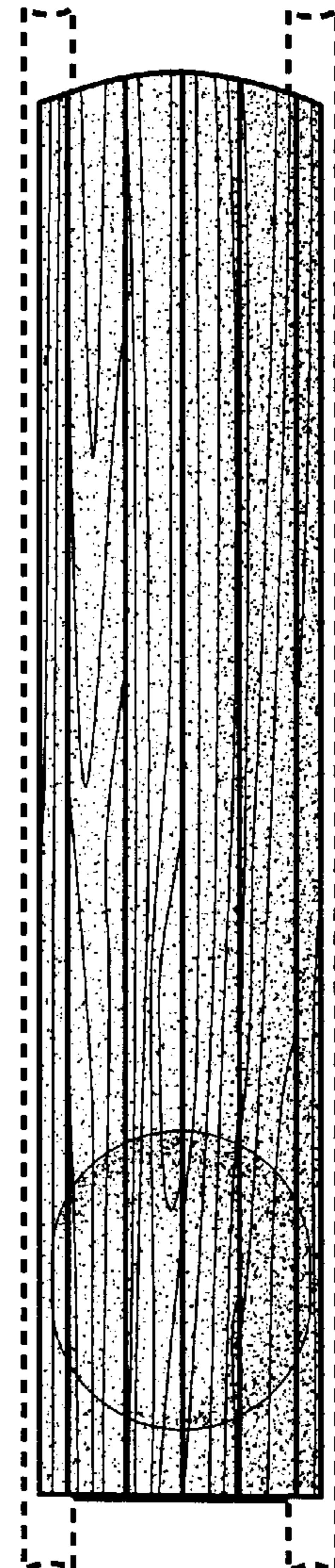

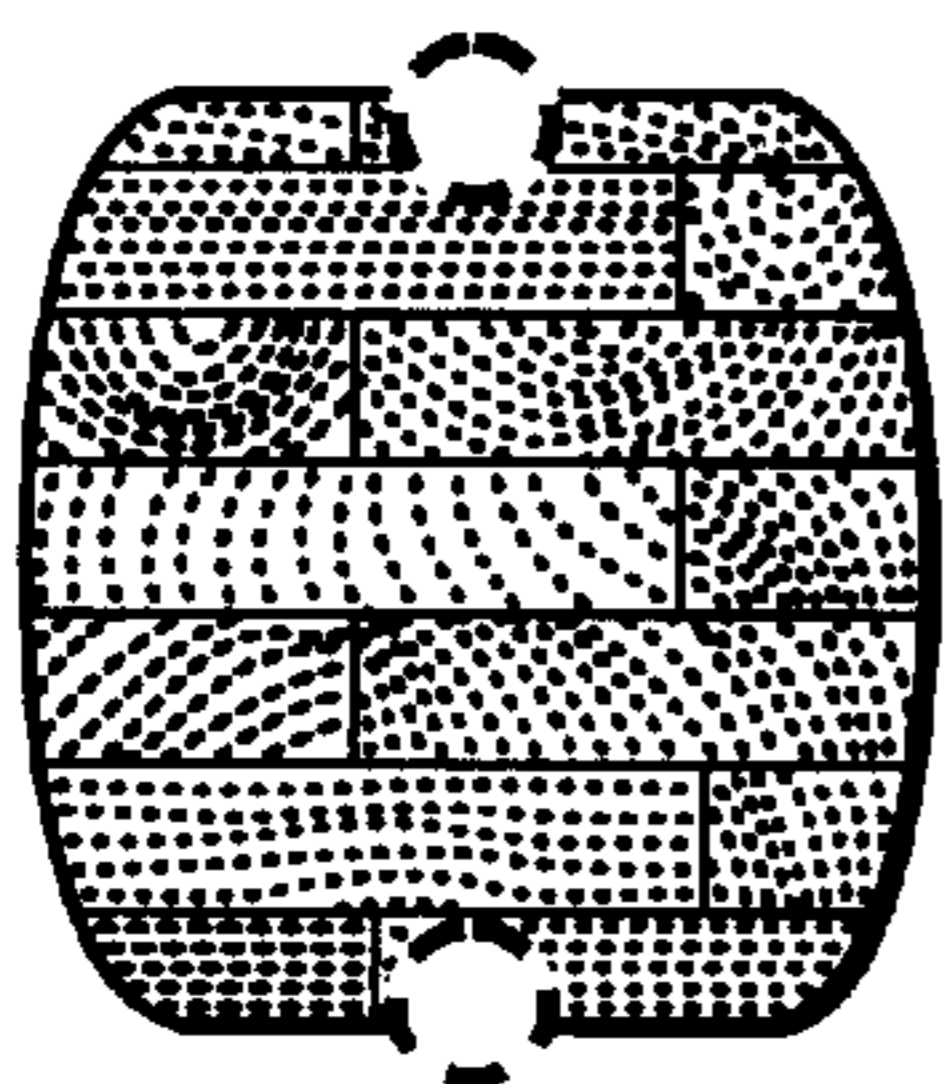

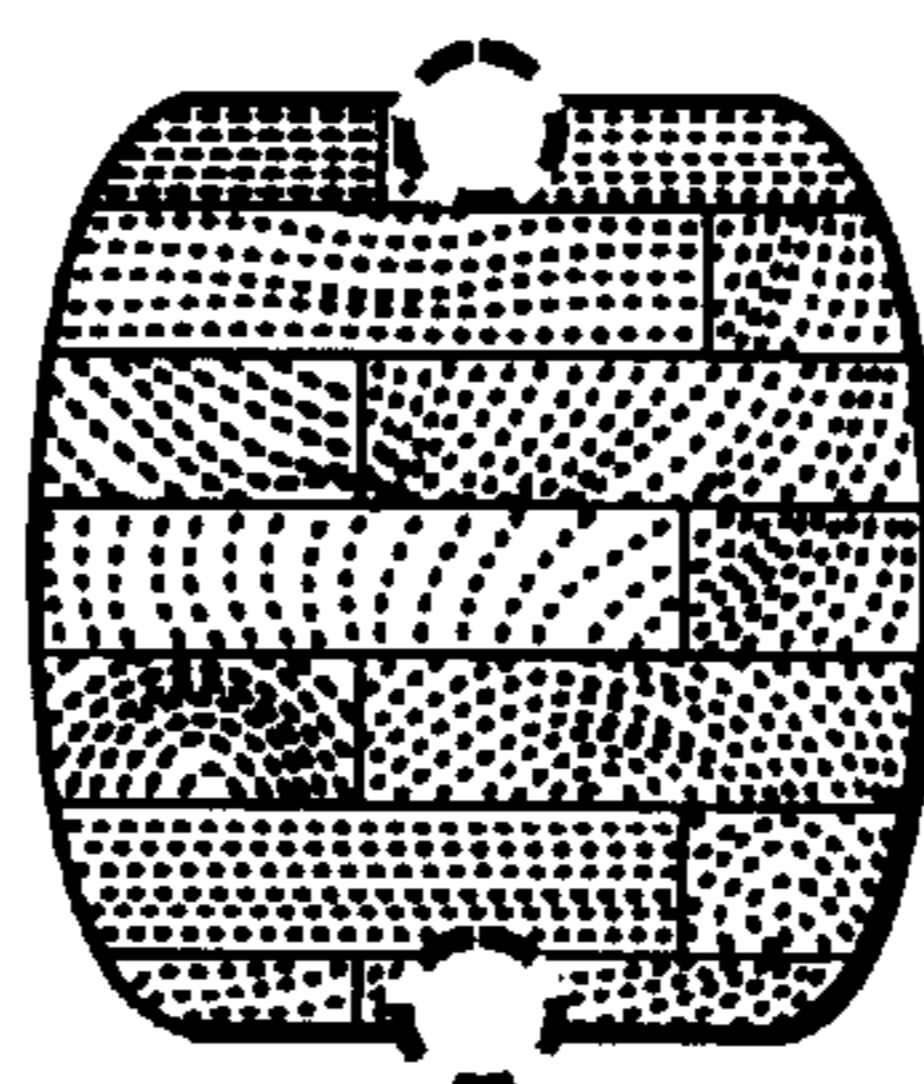

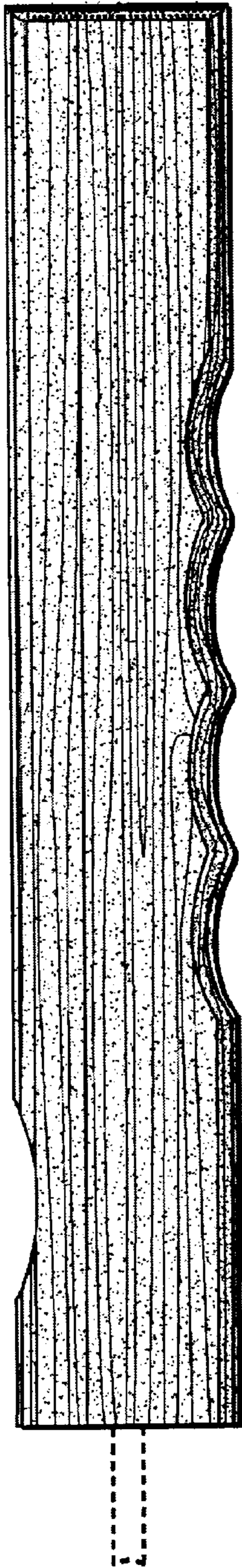

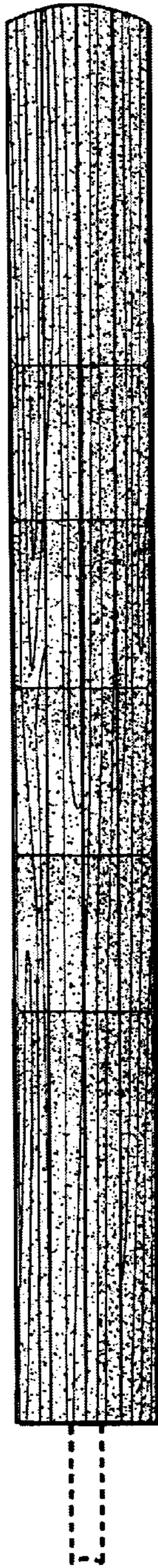

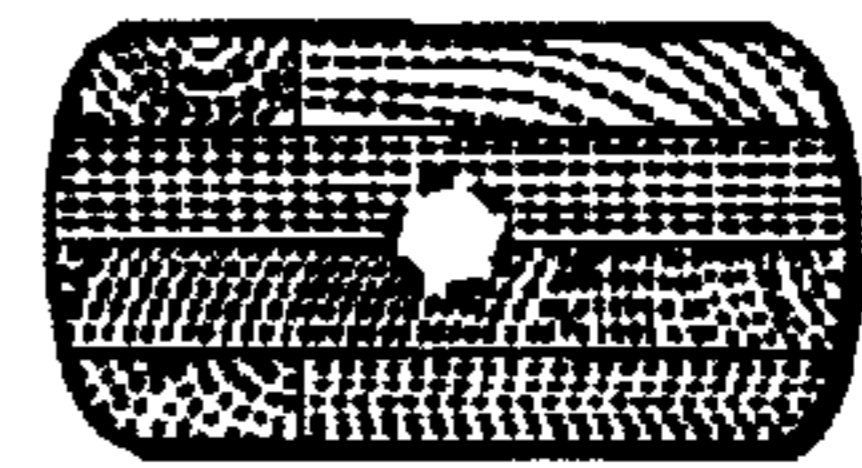
