FIG. 2 is a top perspective view of the tumbler.

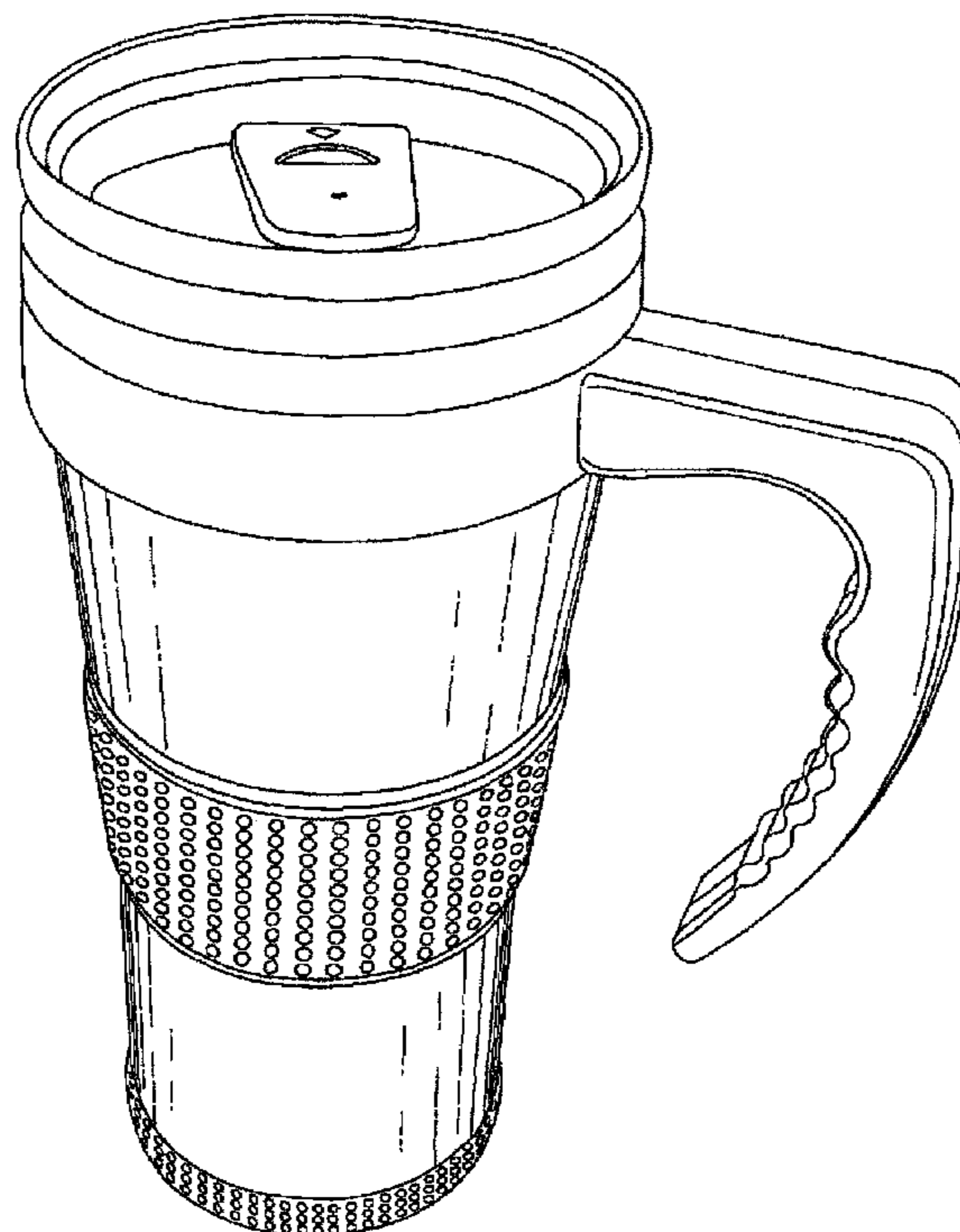
FIG. 3 is a bottom perspective view of the tumbler.

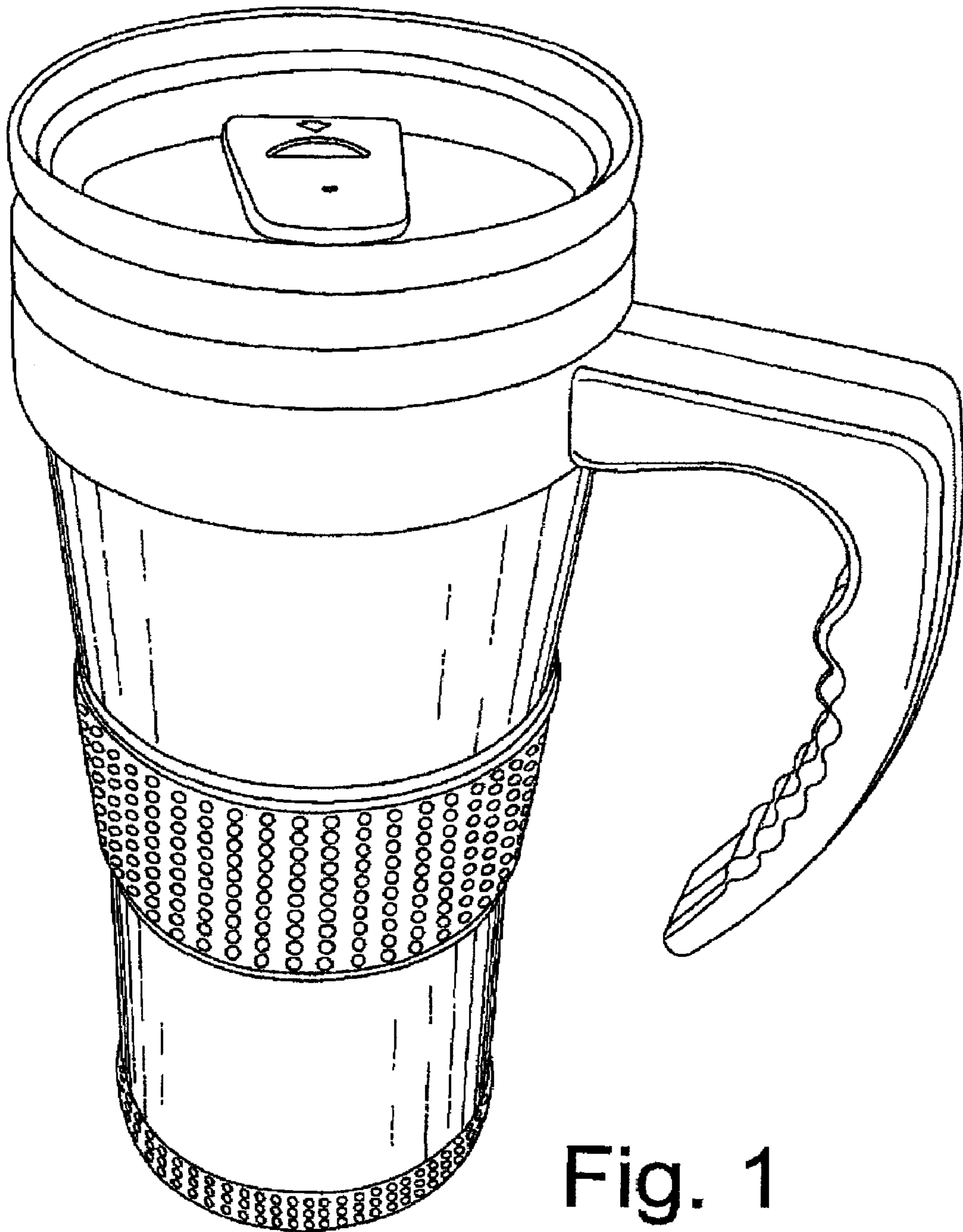

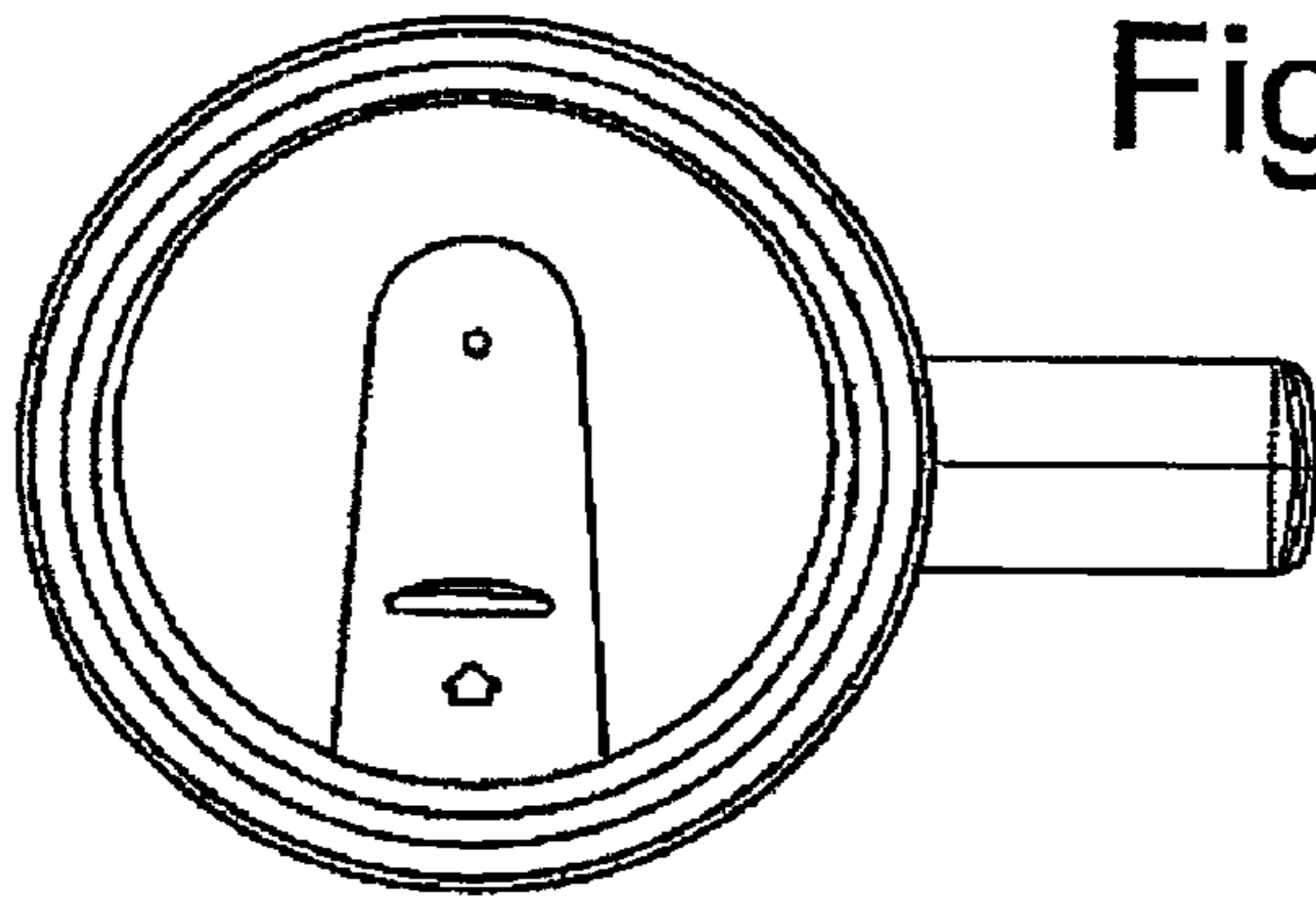

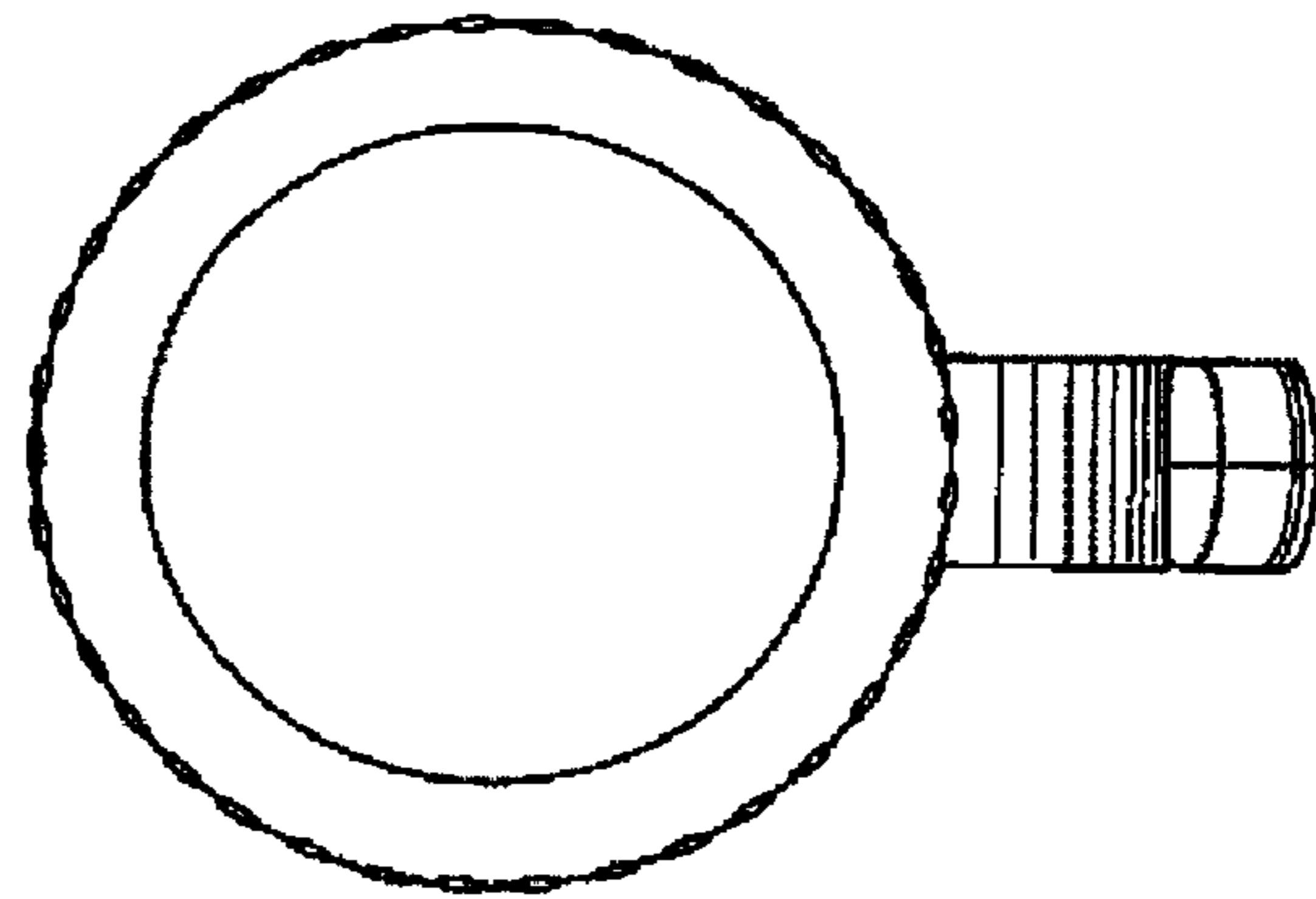

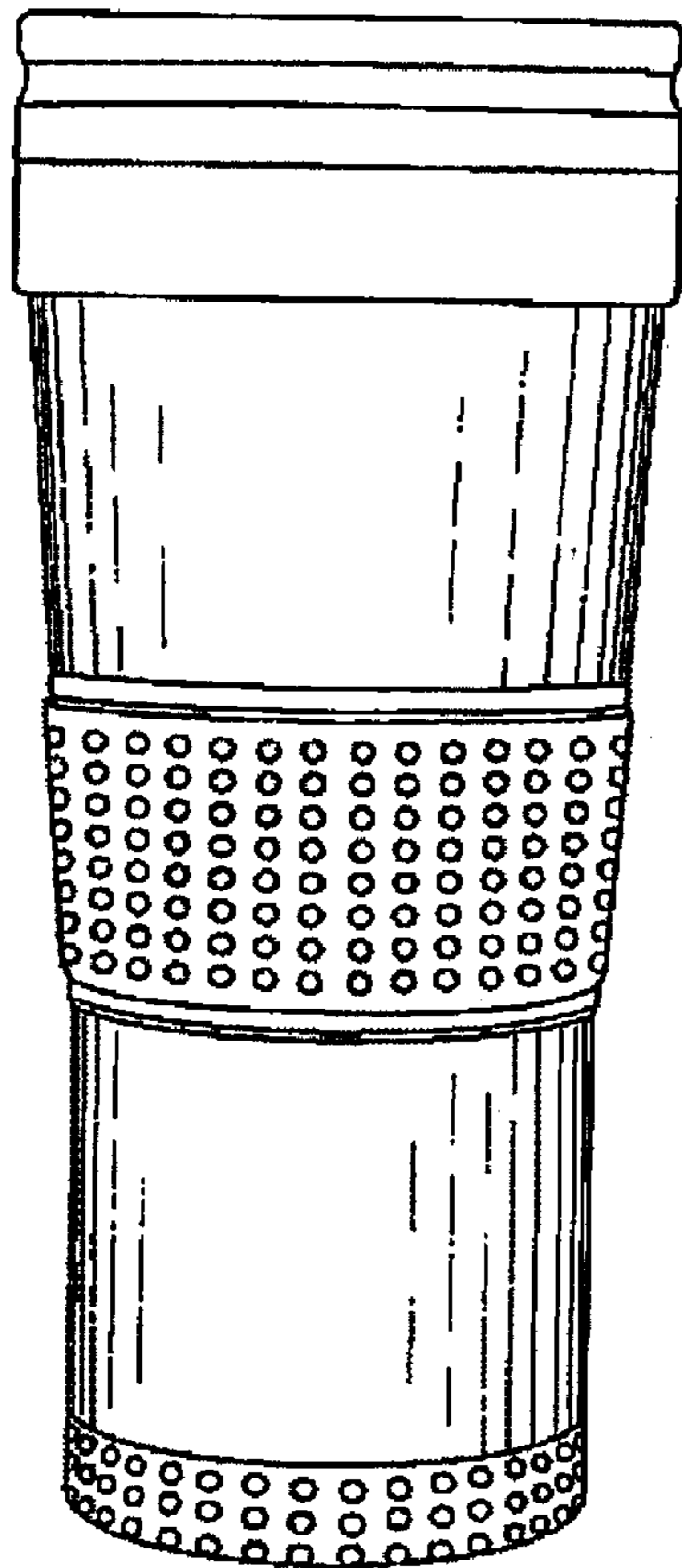

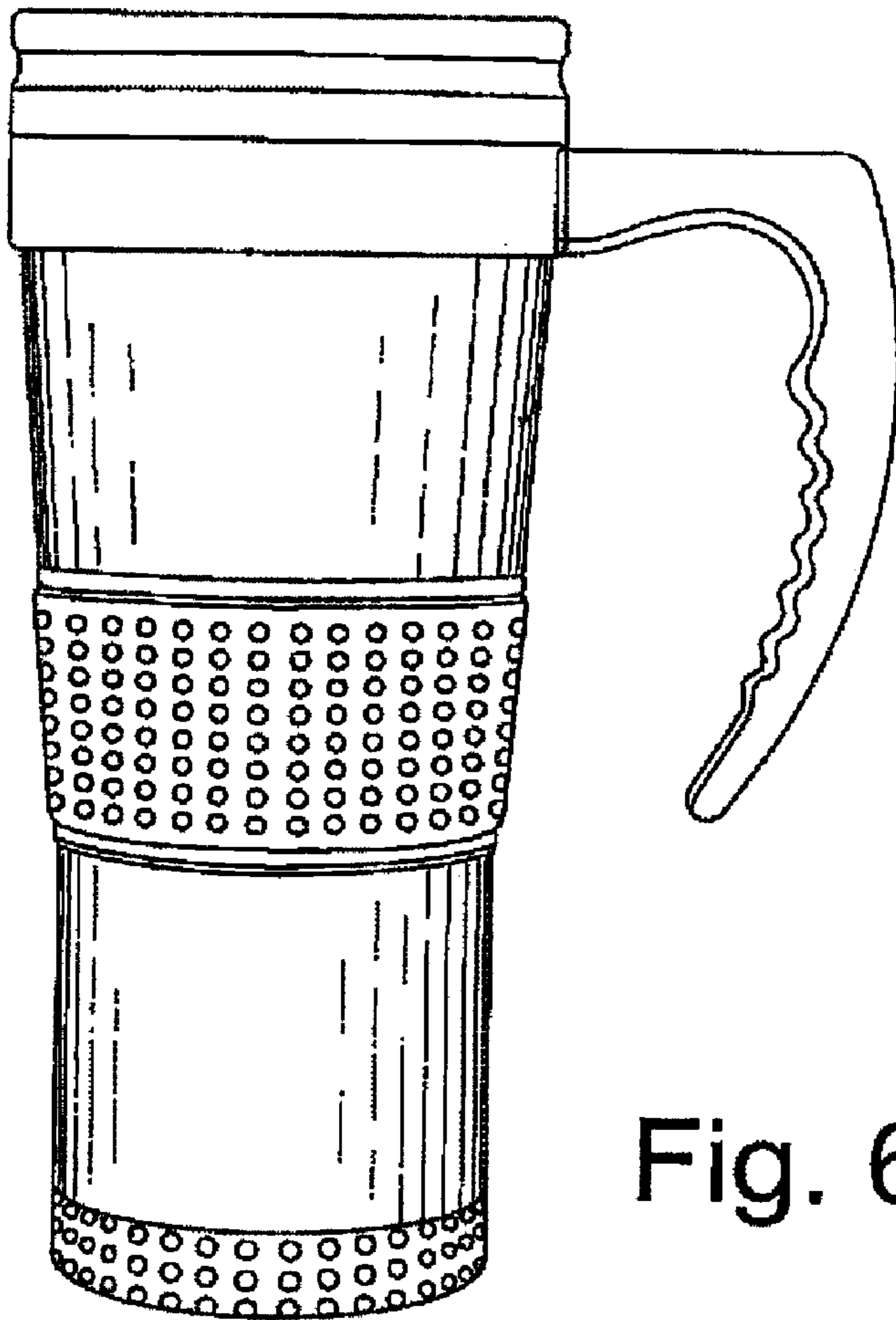
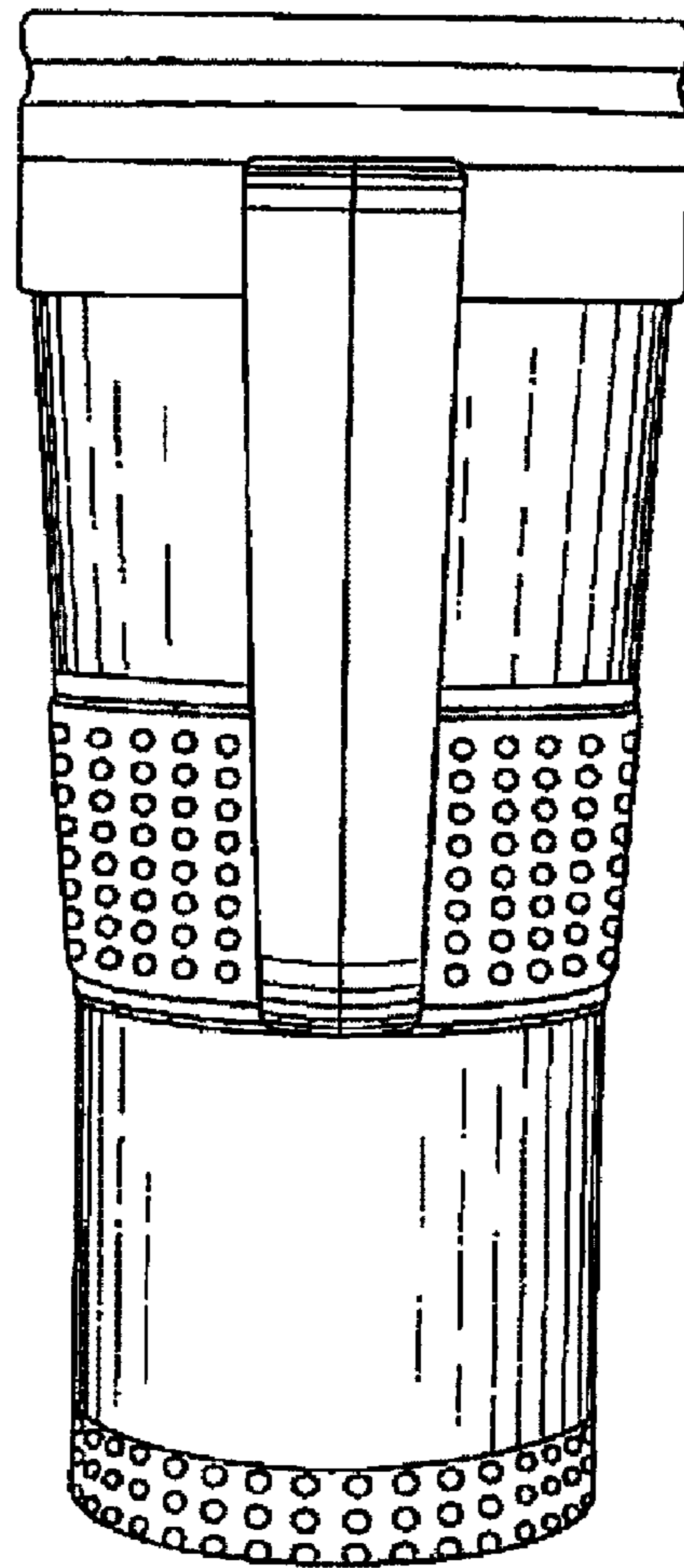
