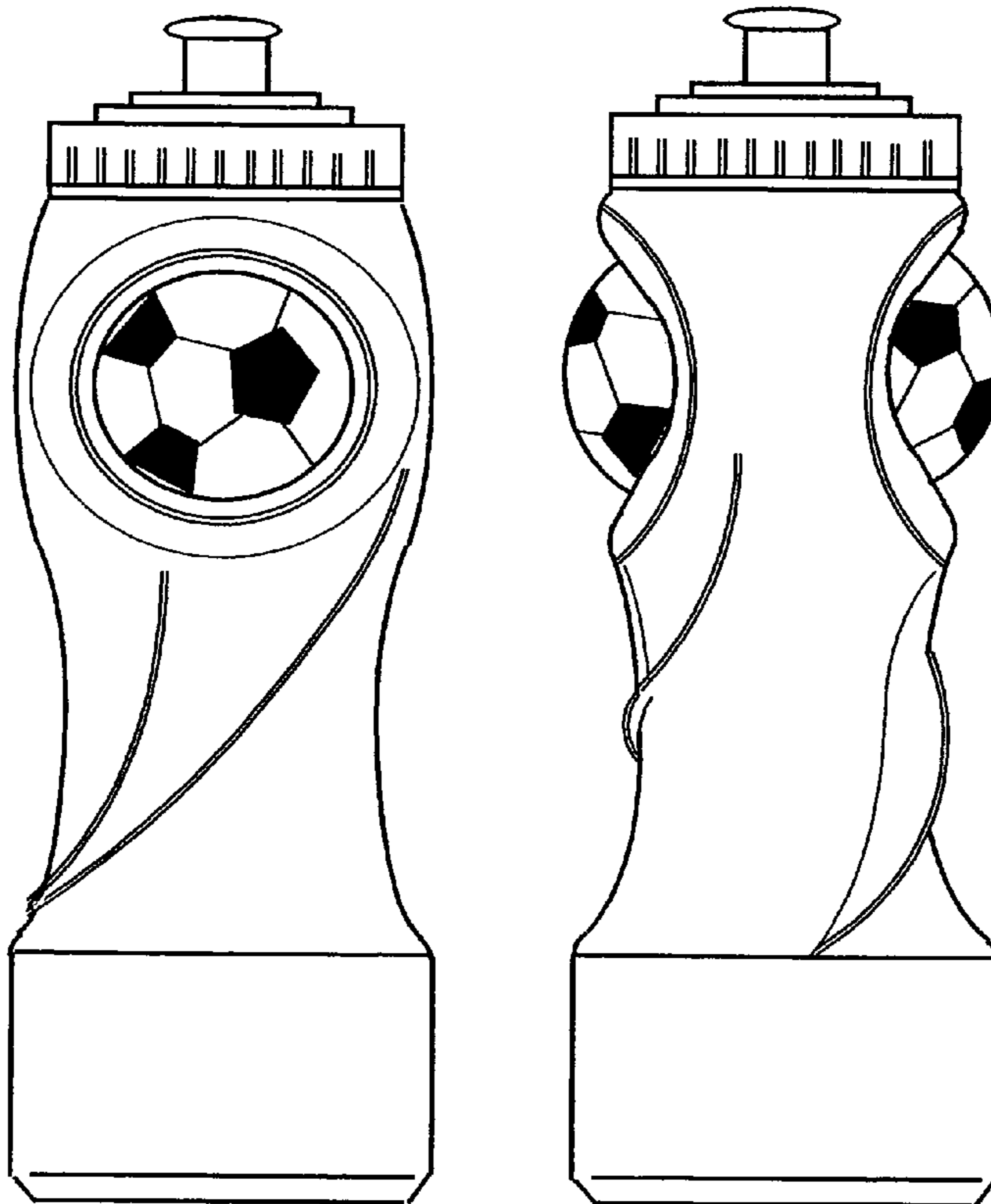

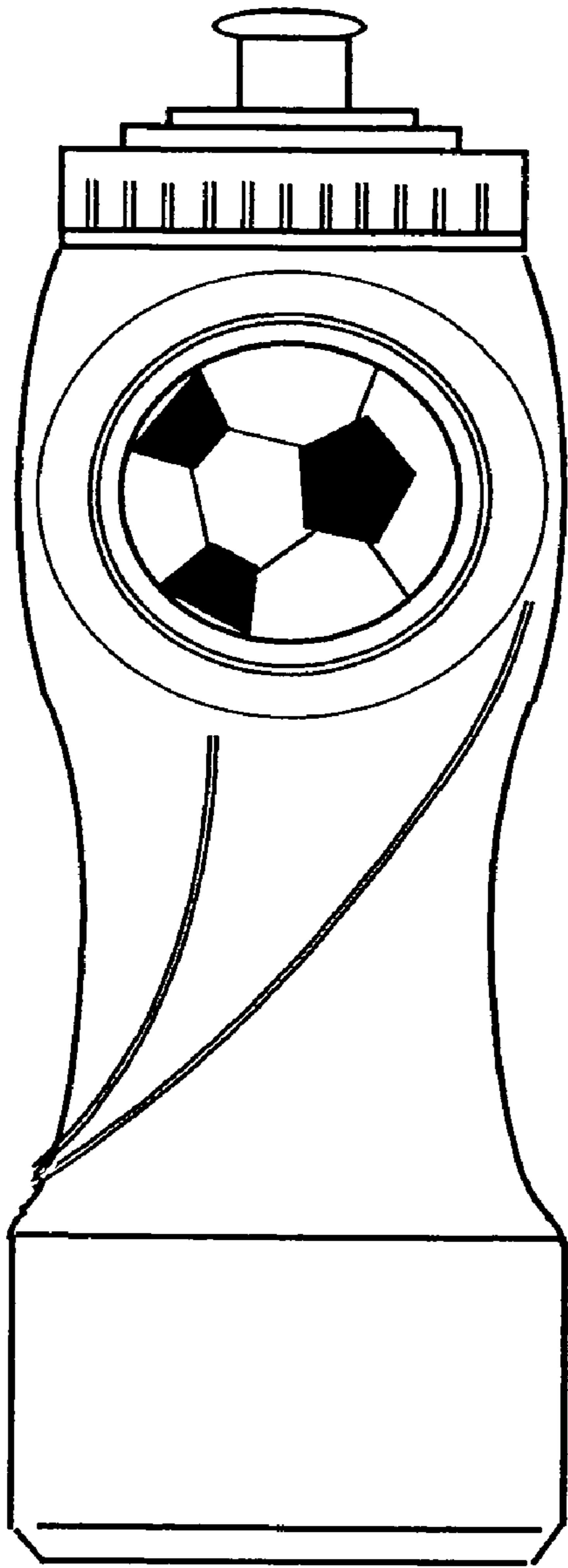
The ornamental design for a drinking bottle, as shown and described.

**DESCRIPTION**

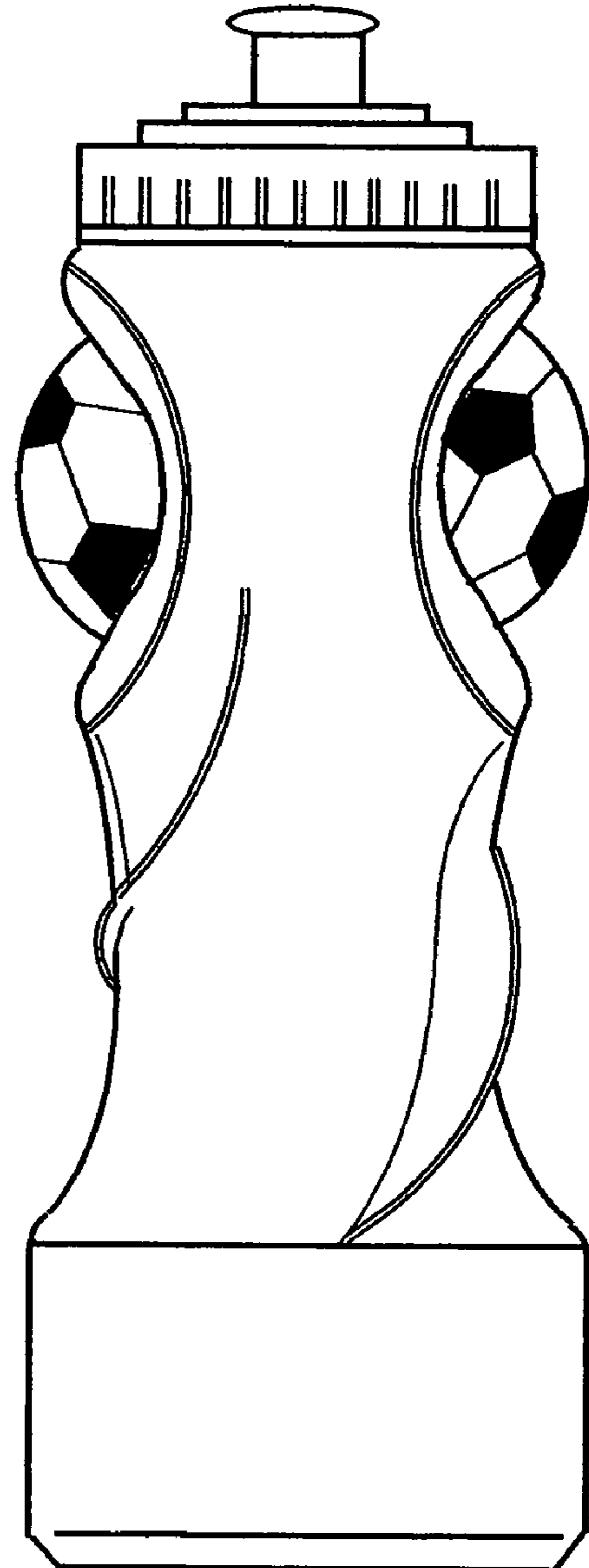
FIG. 1 is a view of a front or back of the drinking bottle; and, FIG. 2 is a view from the left or right side of the drinking bottle.
