DESCRIPTION

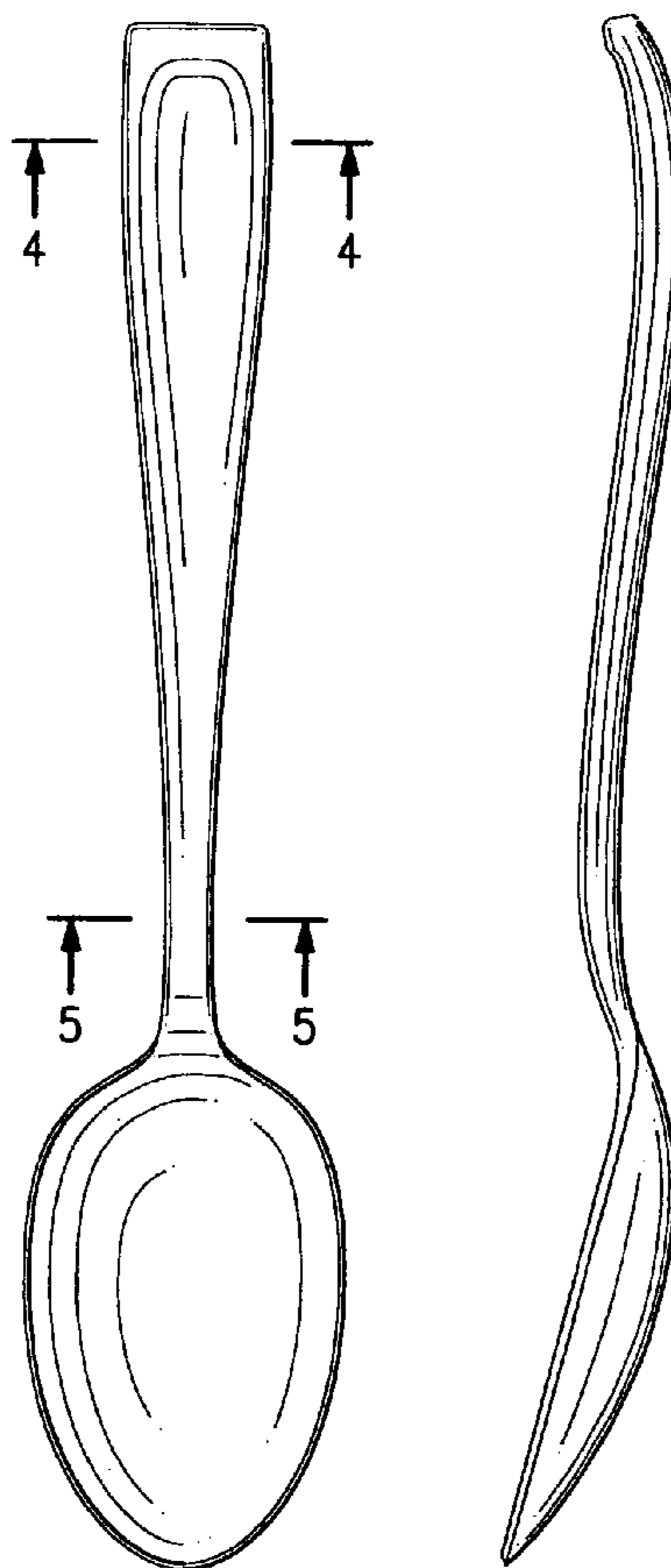
FIG. 1 is a top plan view of a spoon, illustrating my new Design;

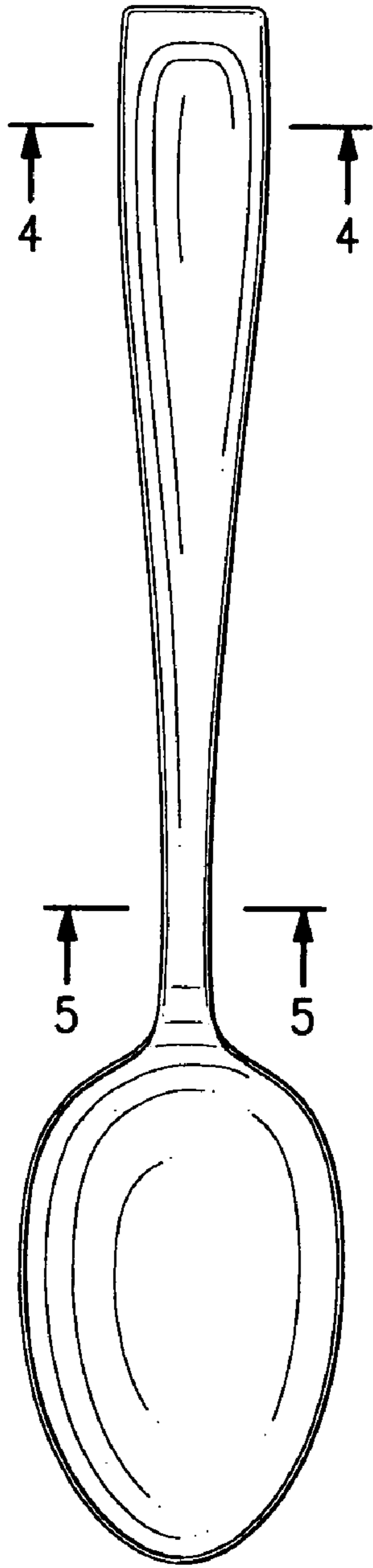

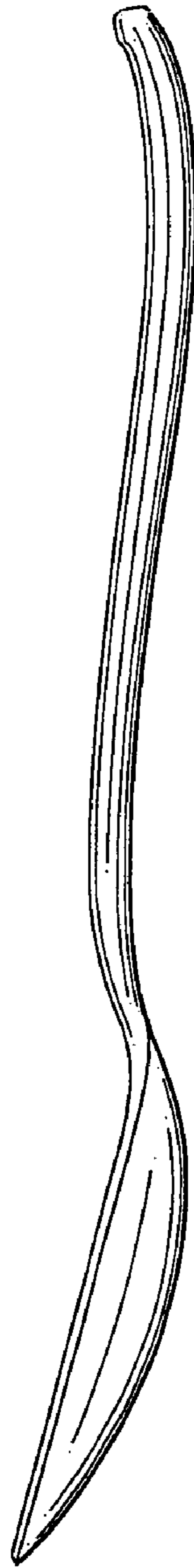

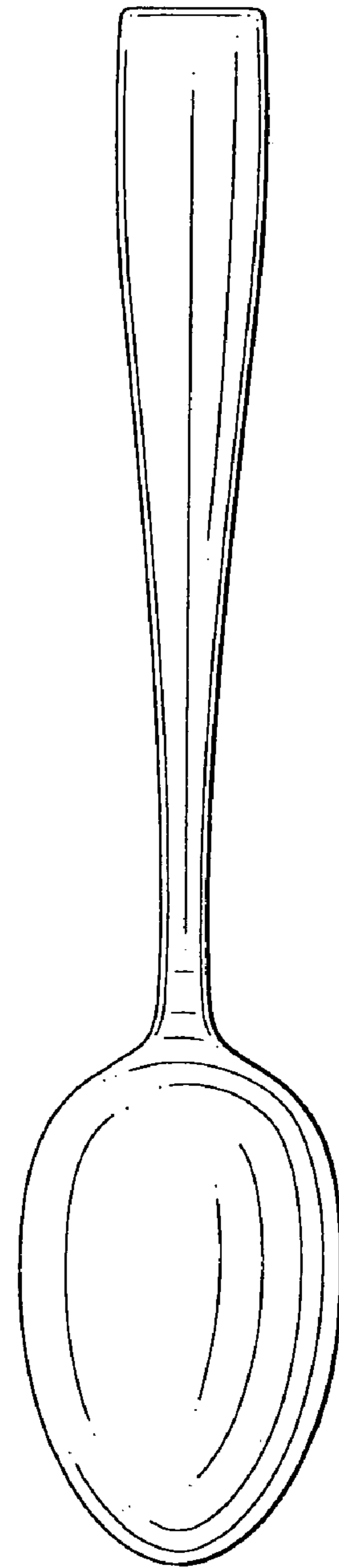
