FIG. 1 is a perspective view of a container, showing our new design, in a closed condition;

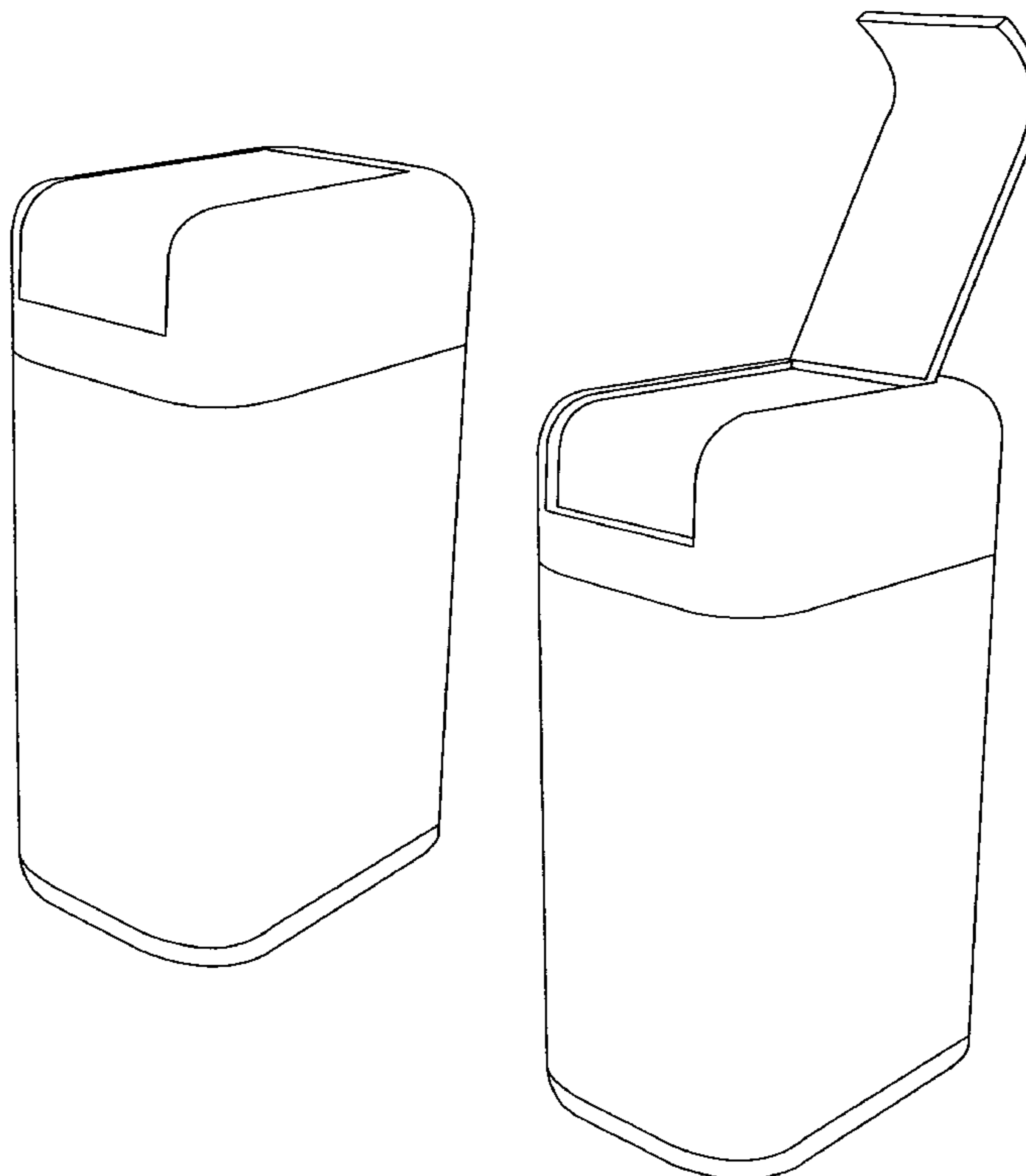
FIG. 2 is a perspective view thereof, in an opened condition;

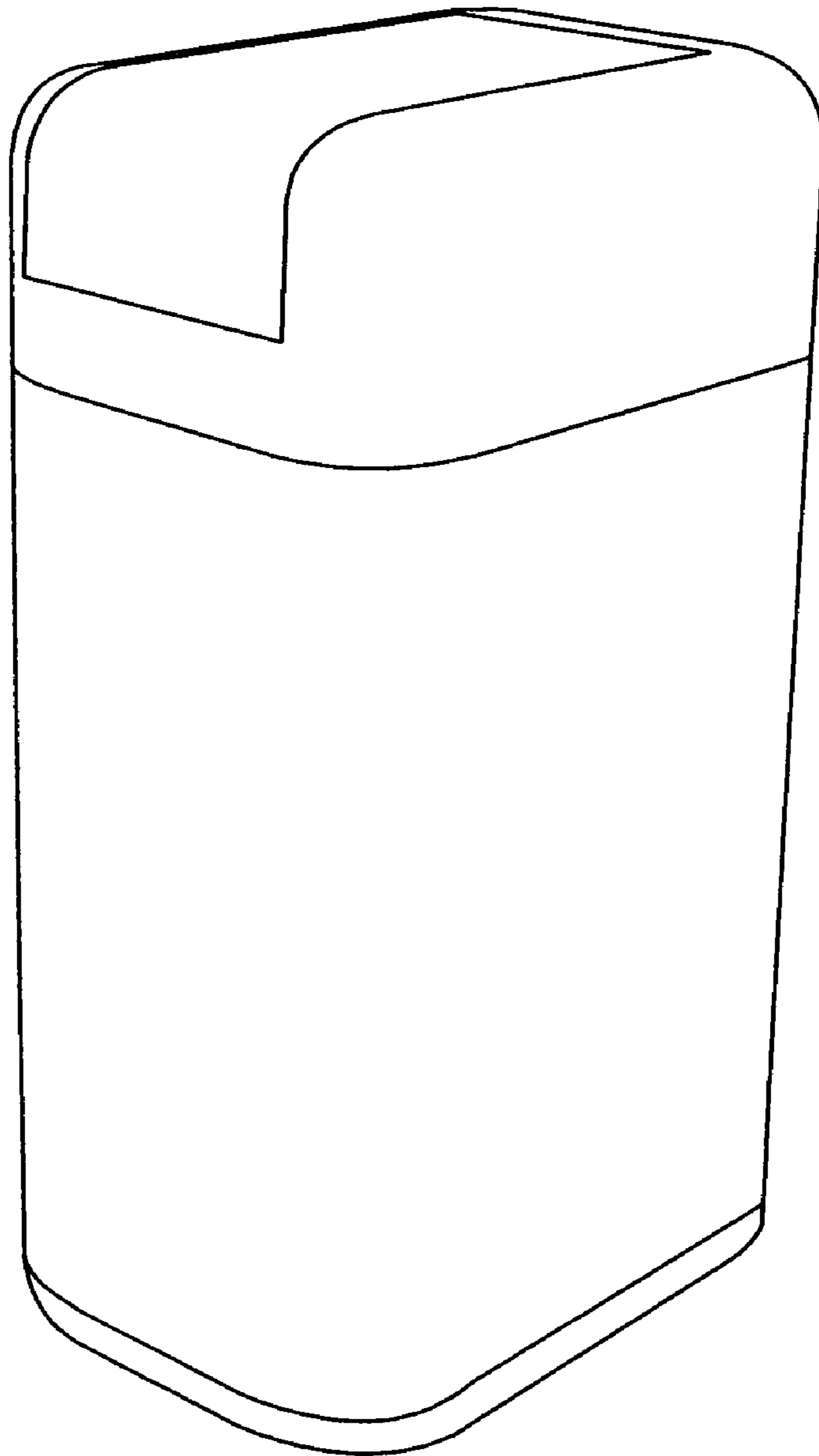

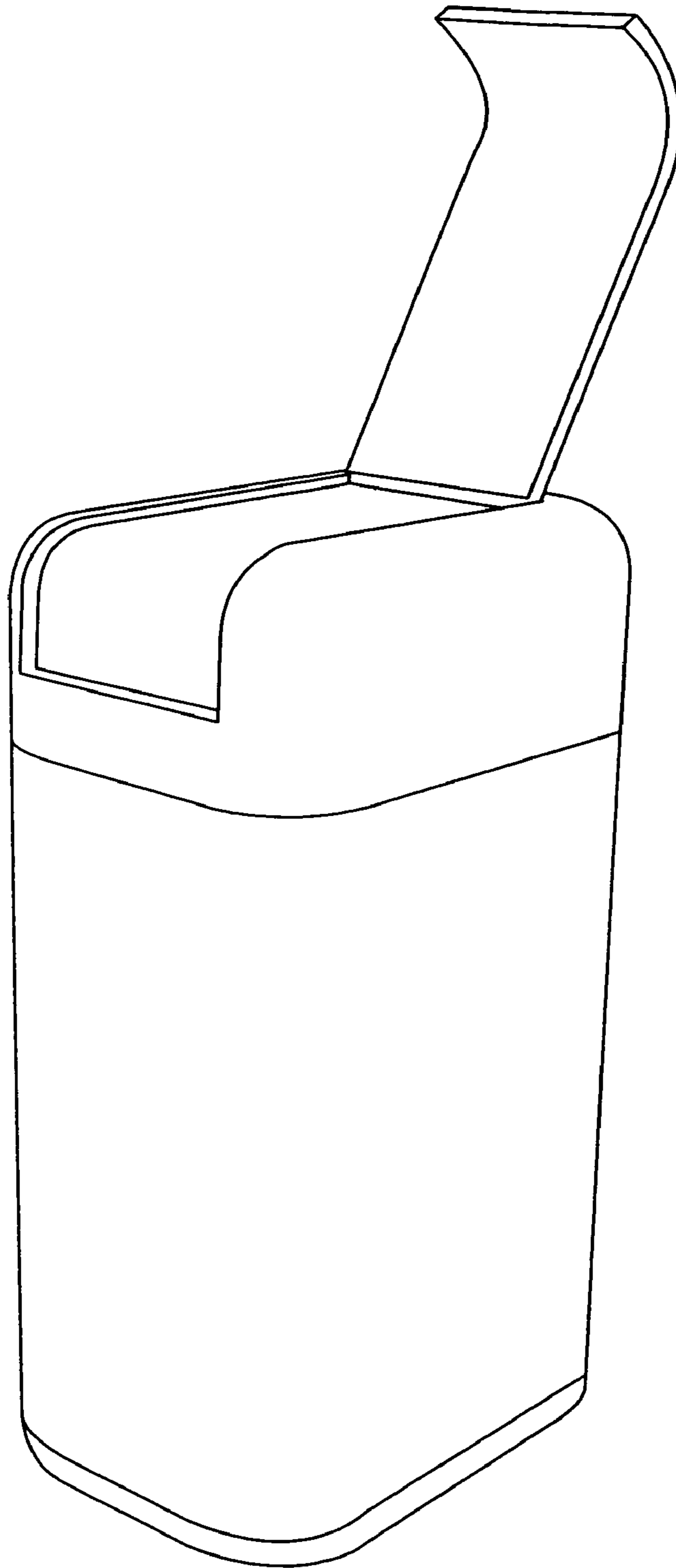

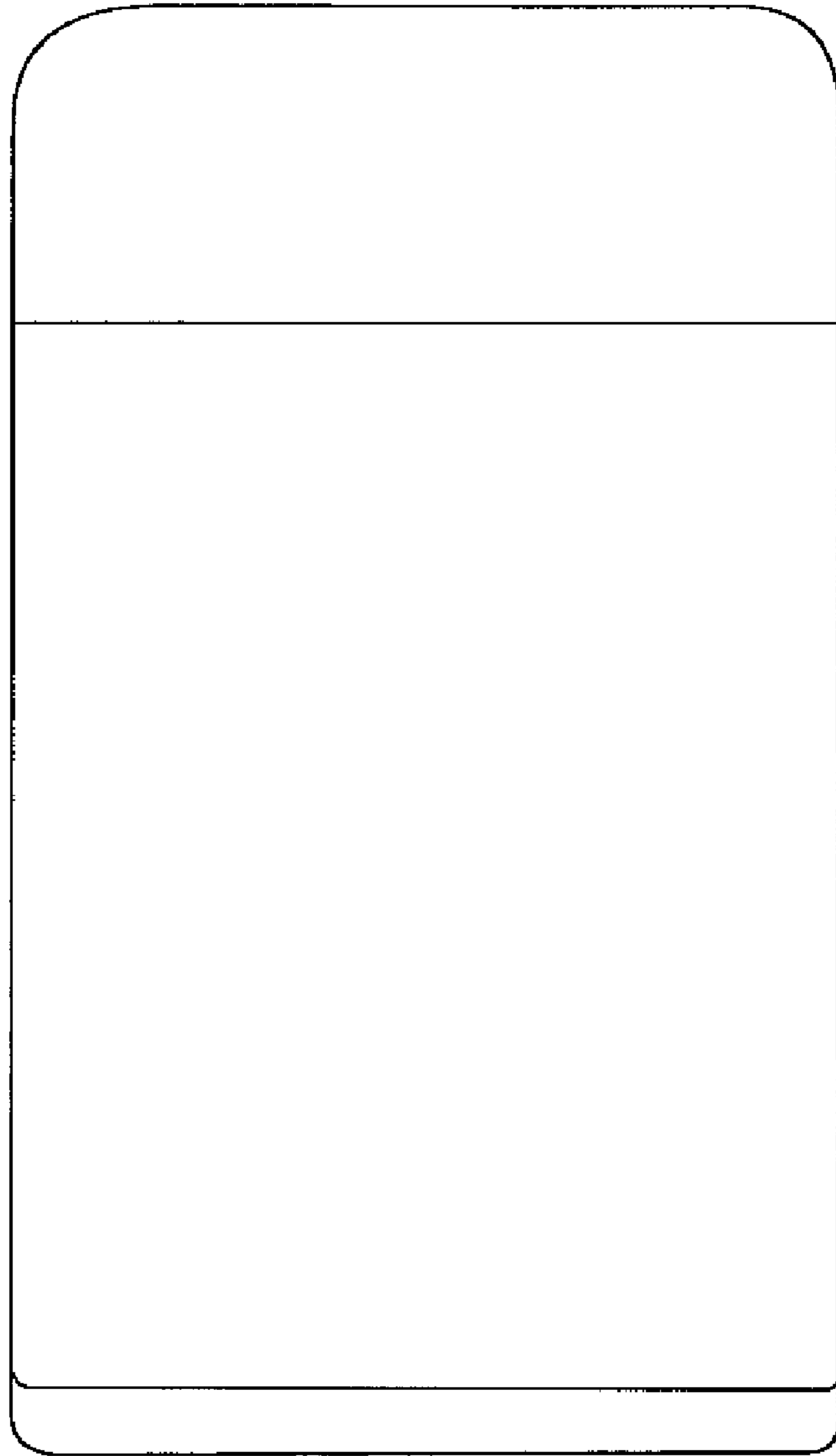

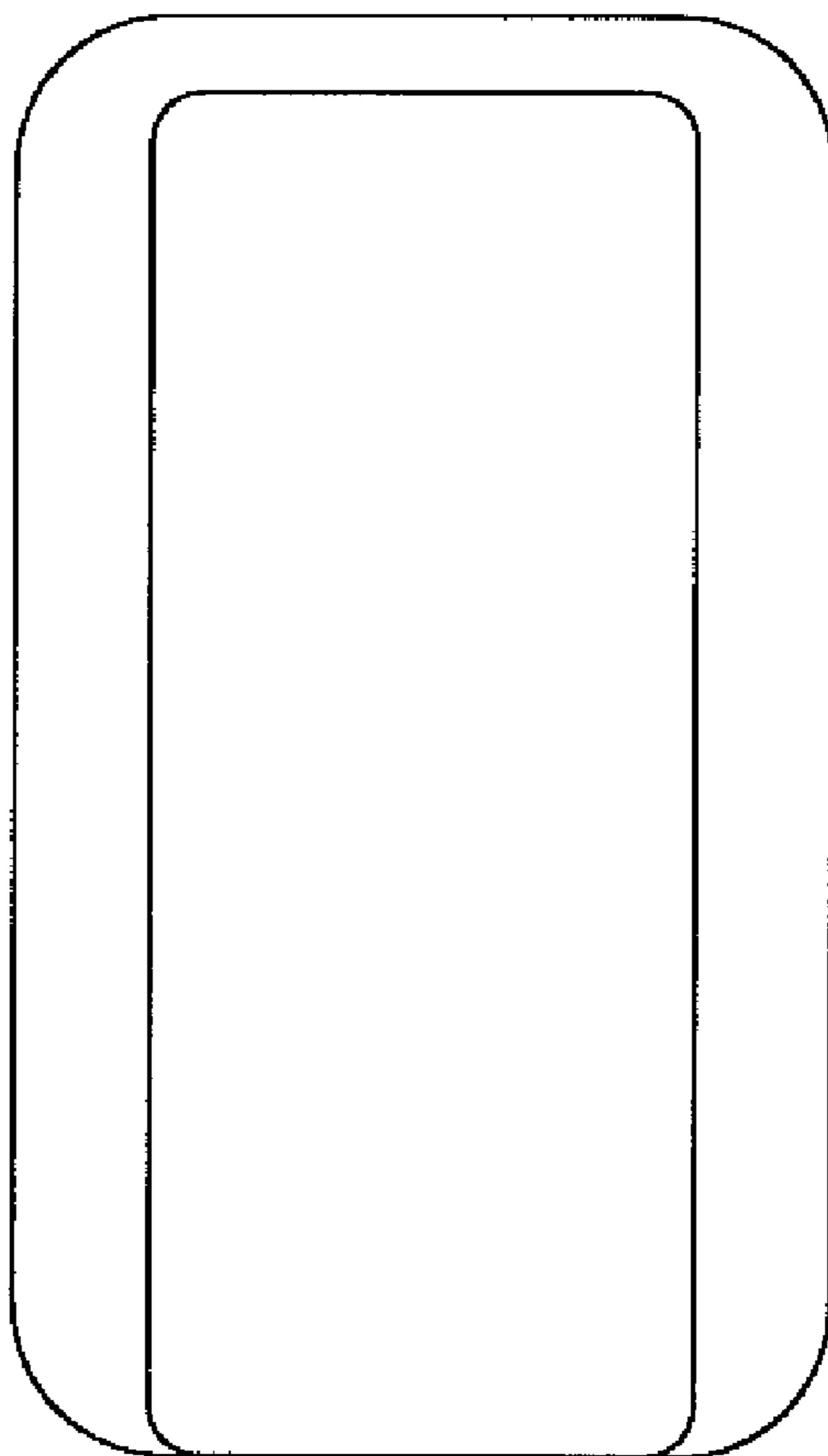

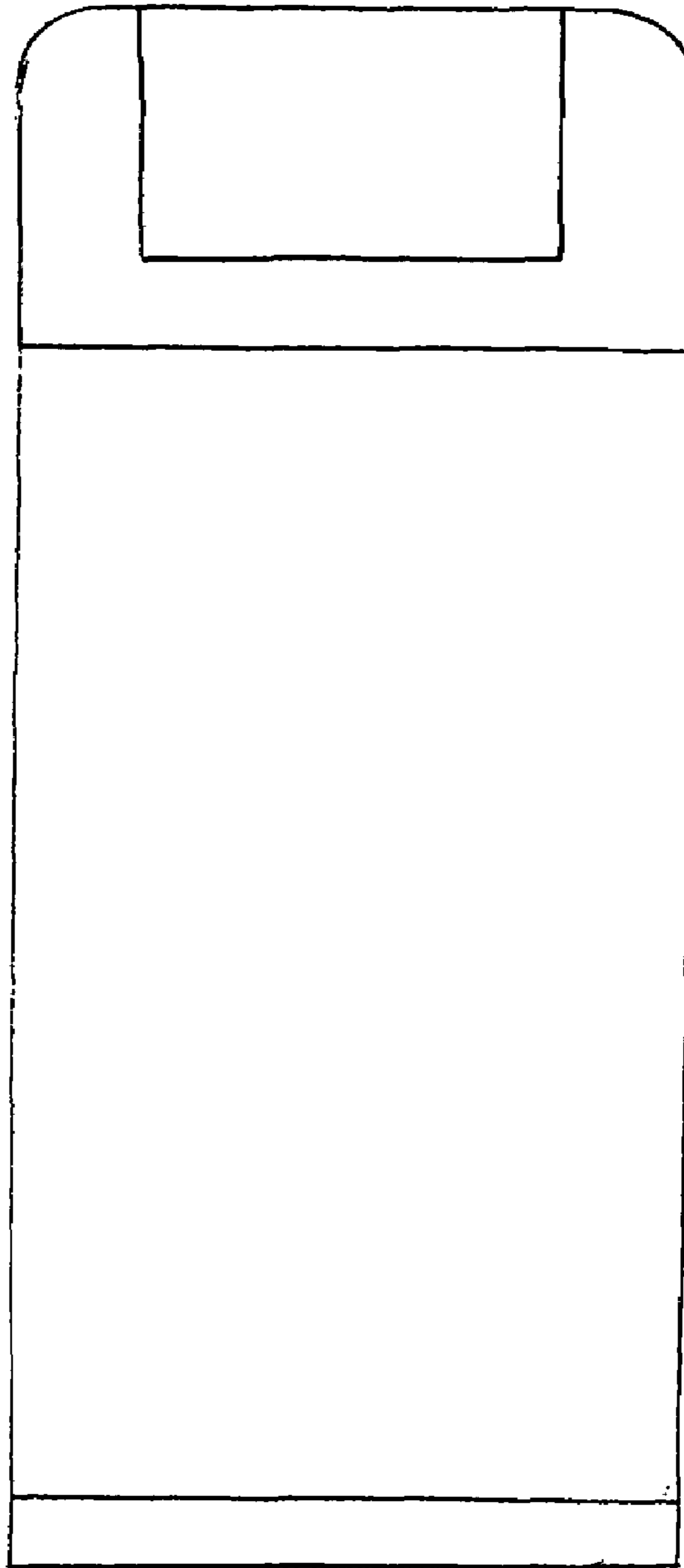
