DESCRIPTION

FIG. 11 is an elevation view showing one side of the second embodiment of my invention;

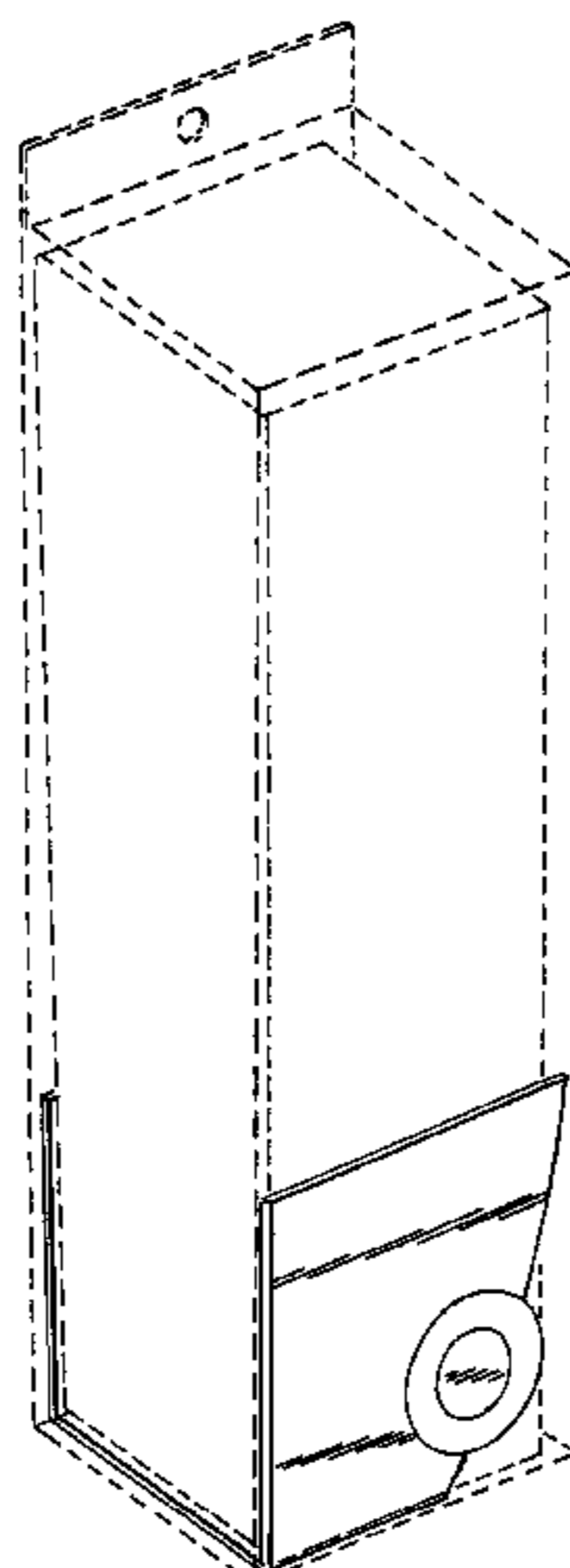
FIG. 12 is an elevation view showing the other side of the second embodiment of my invention;

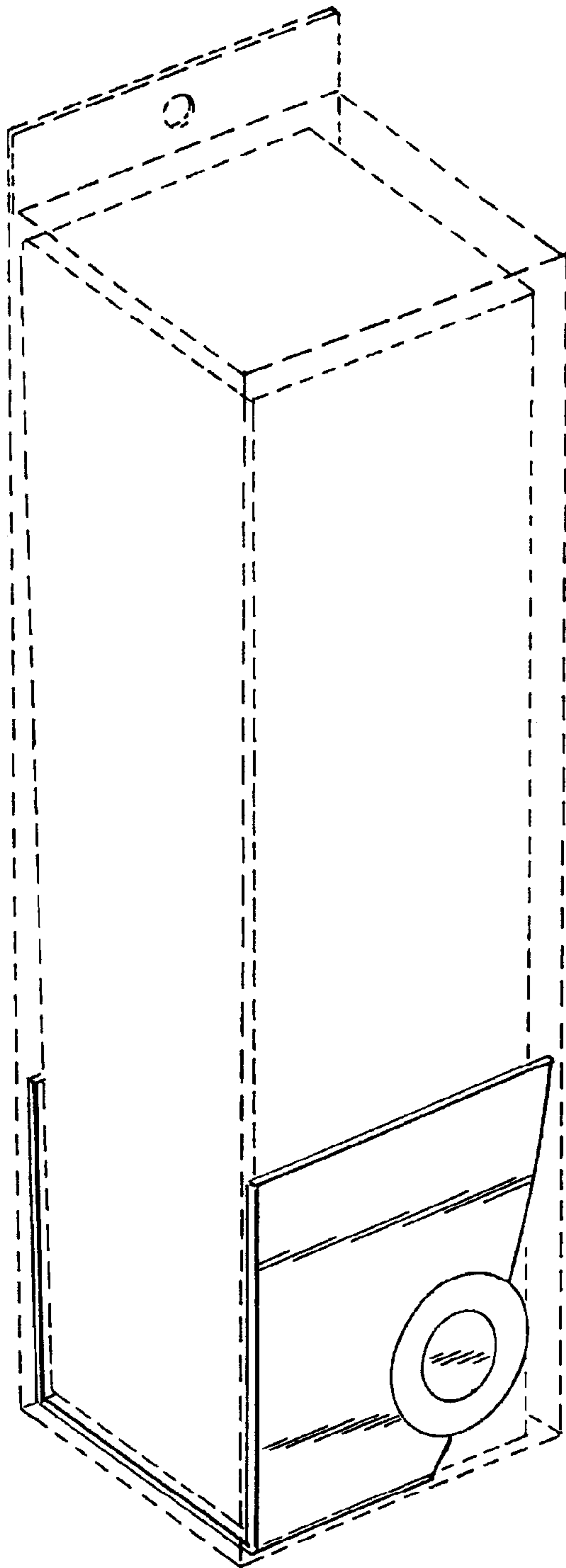

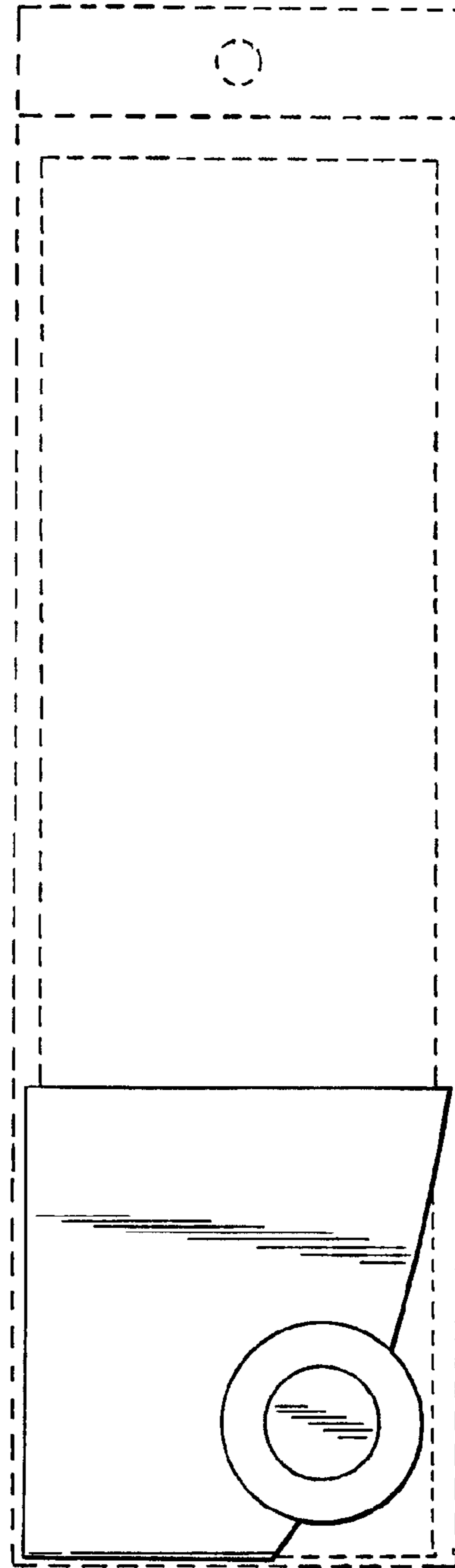

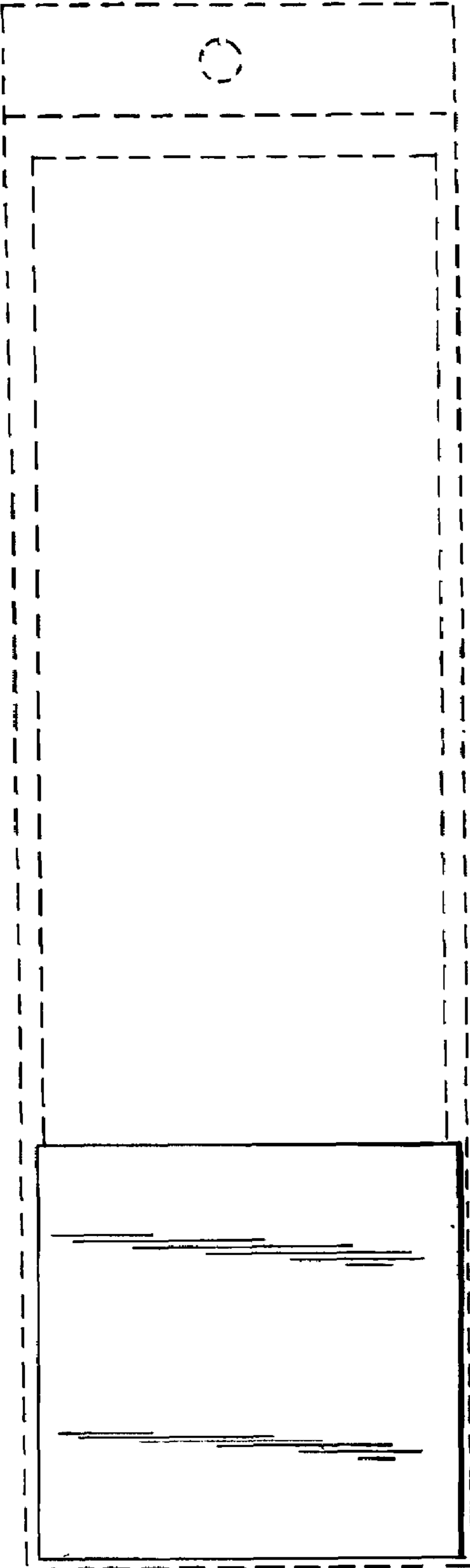

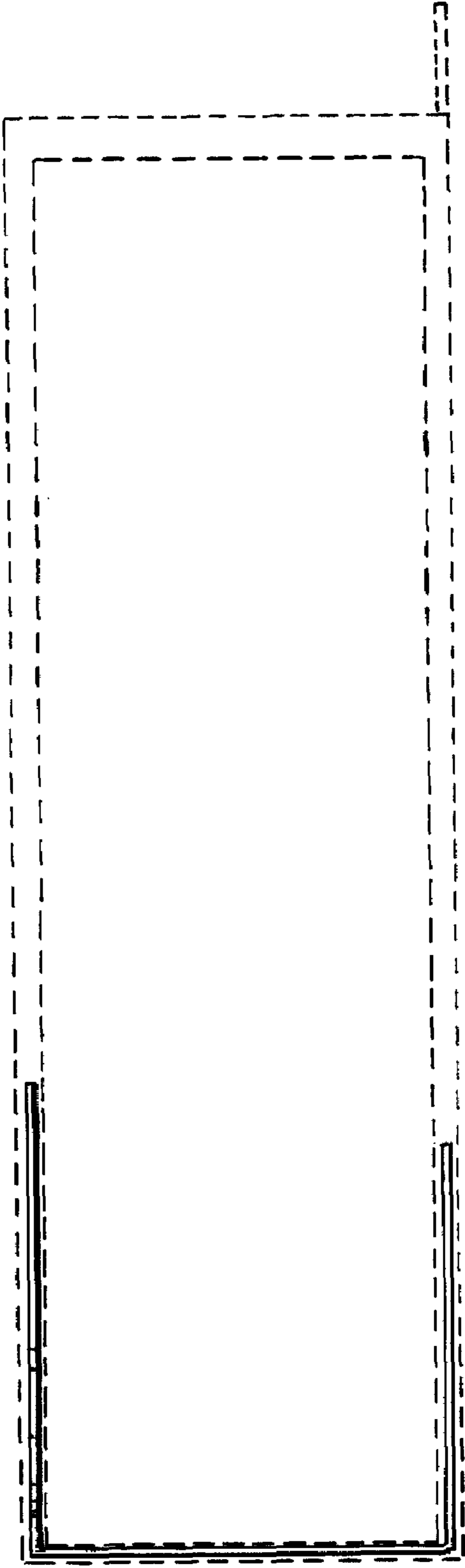

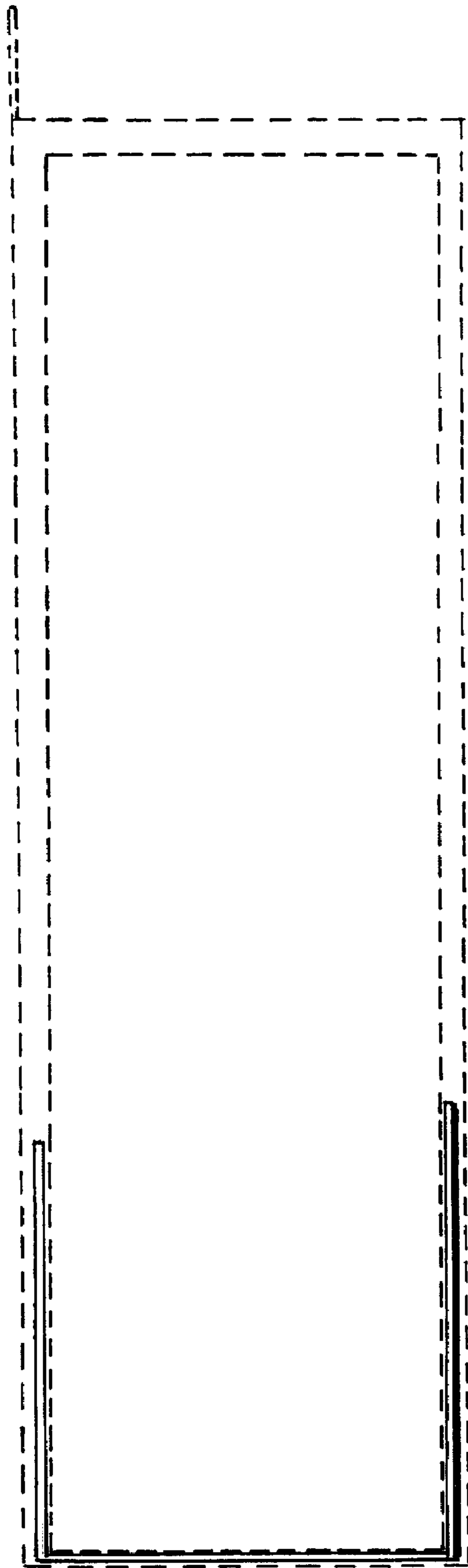

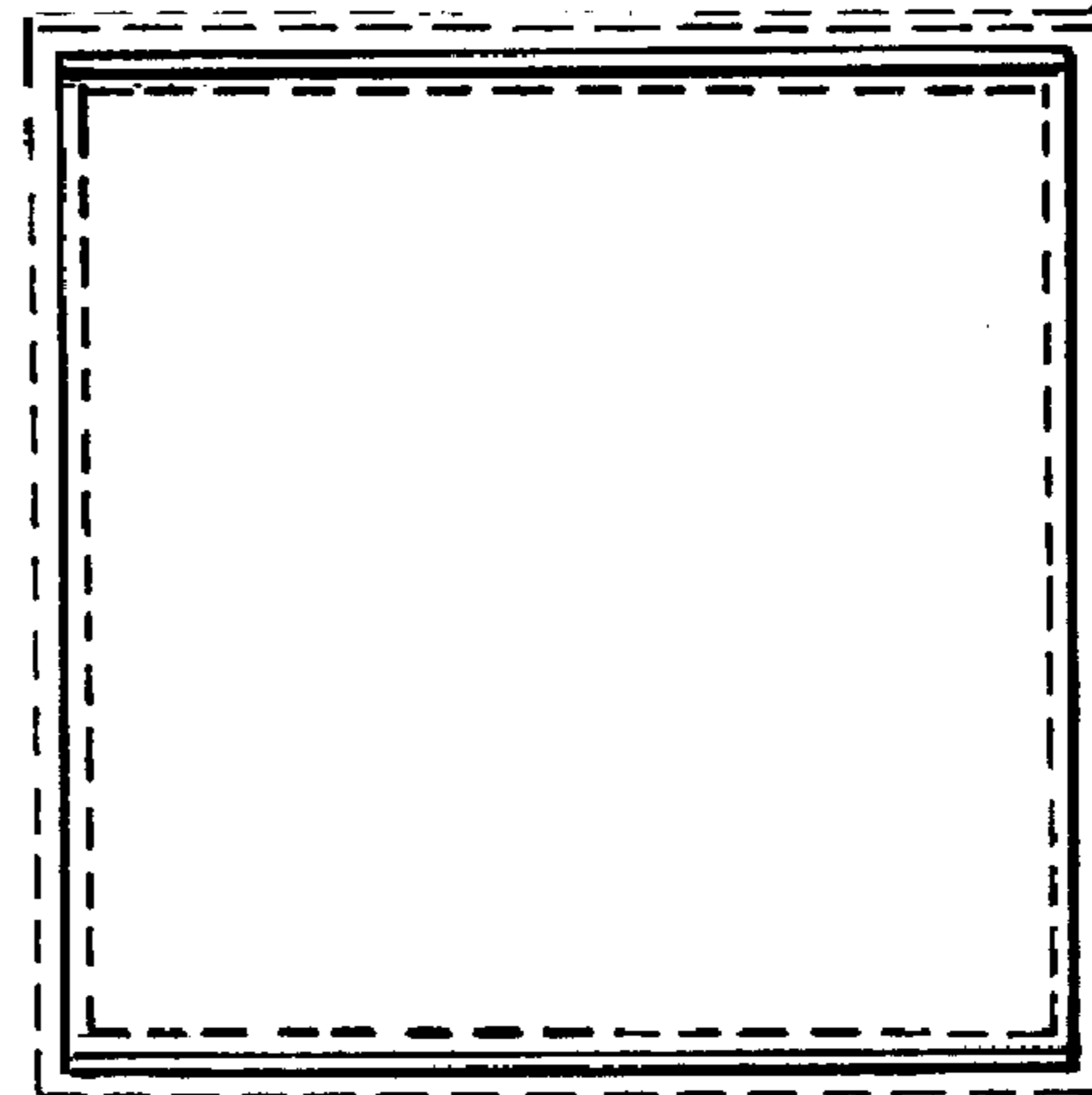

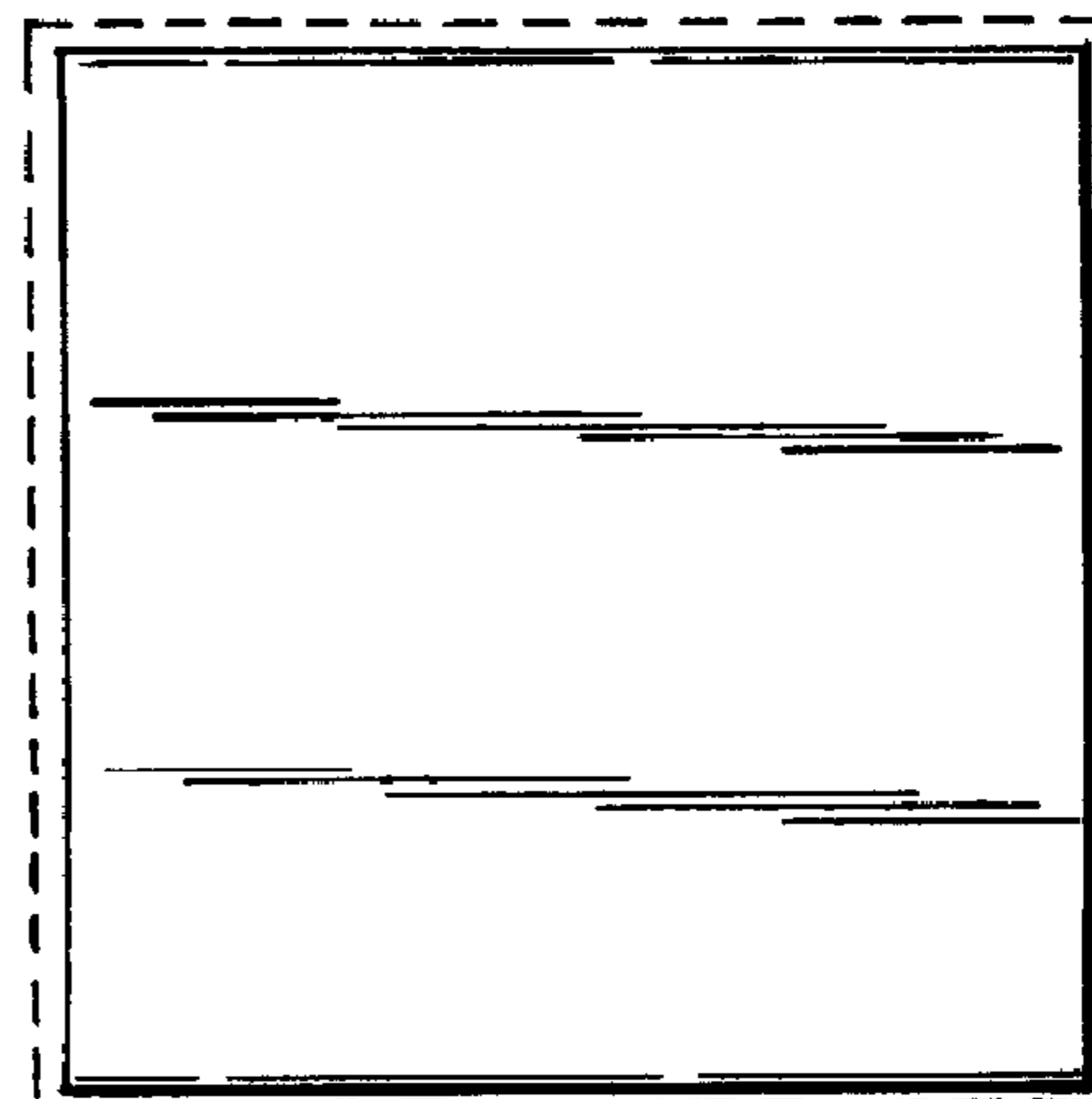

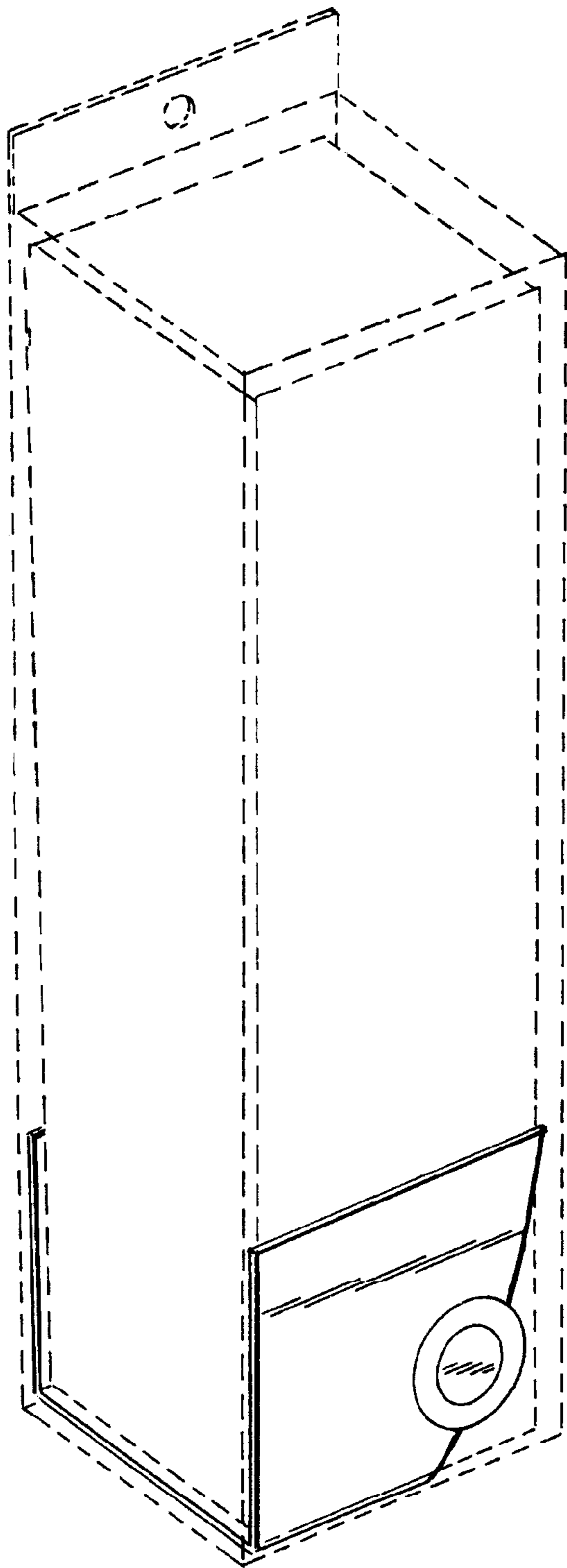

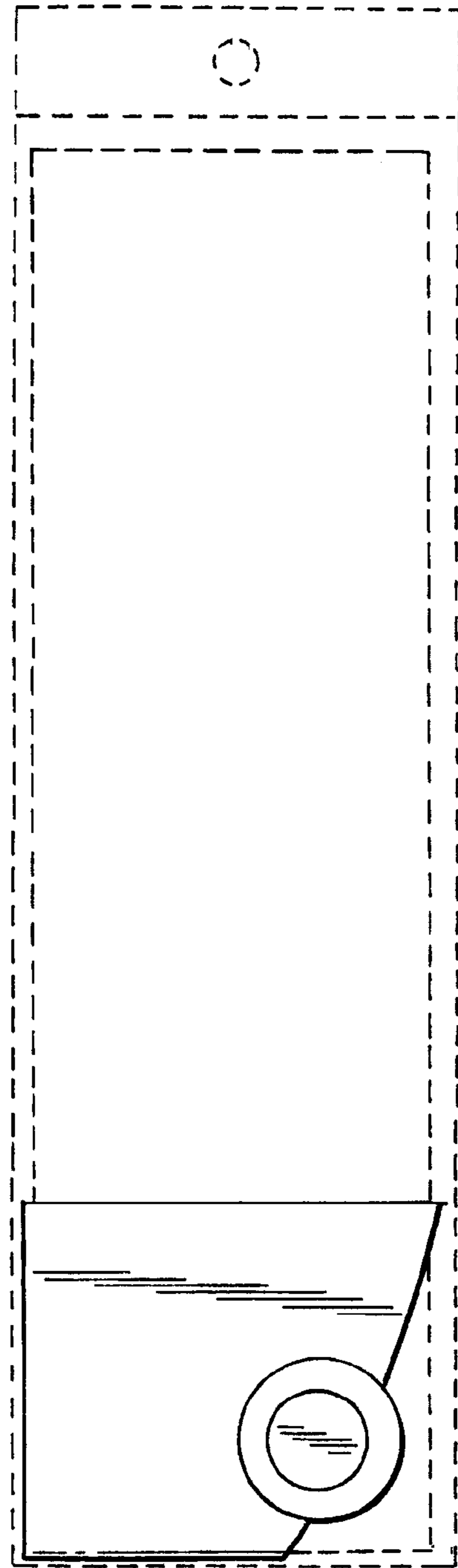

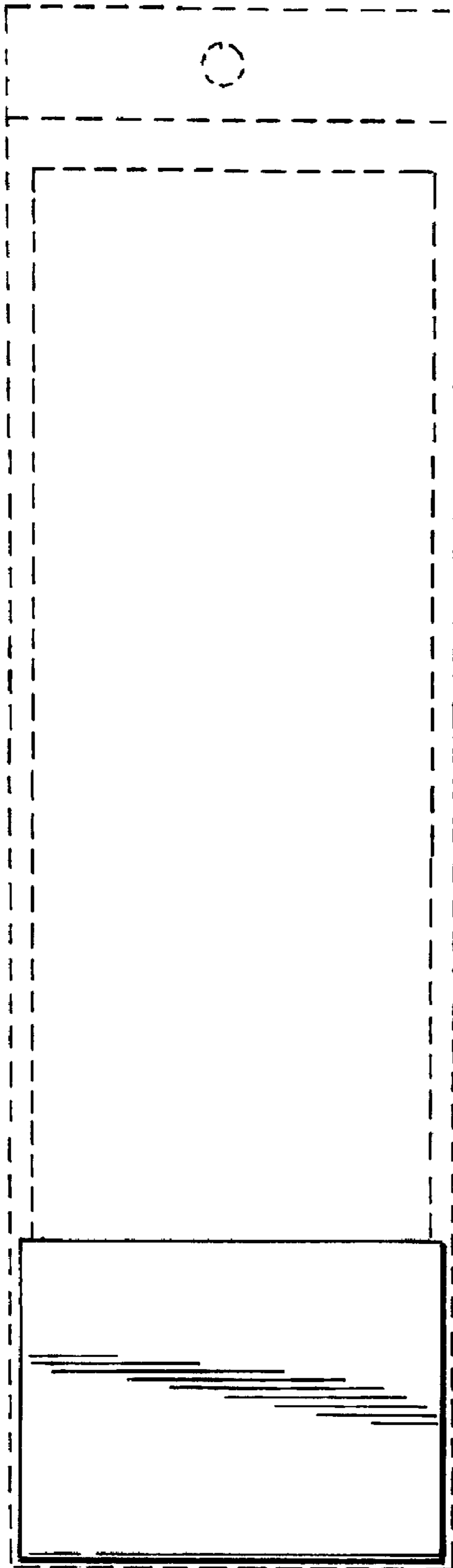

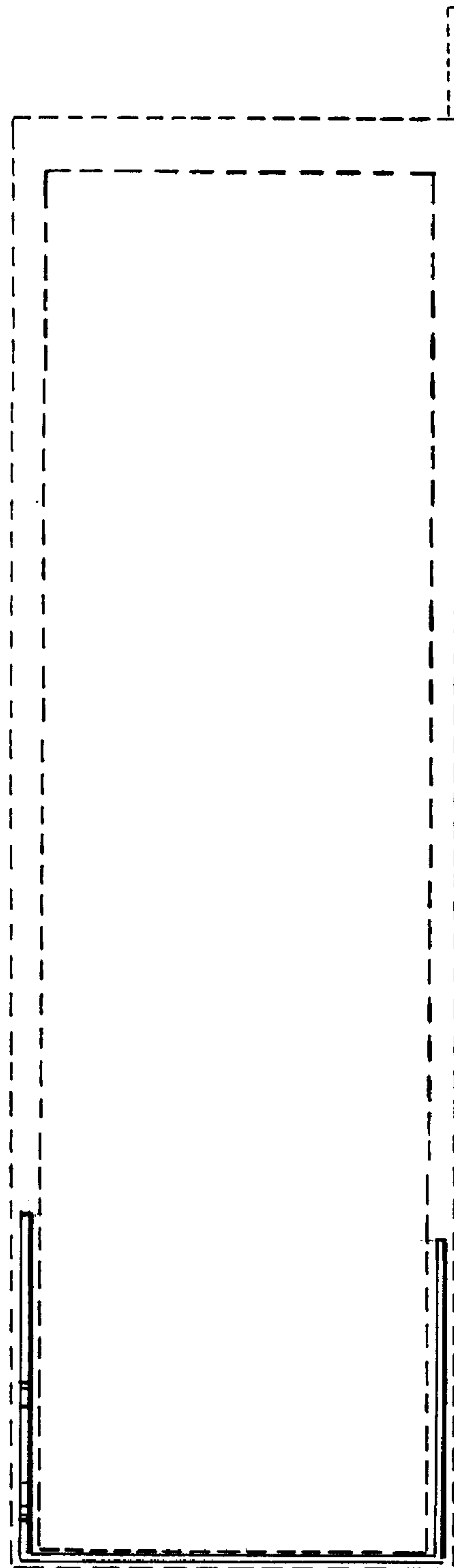

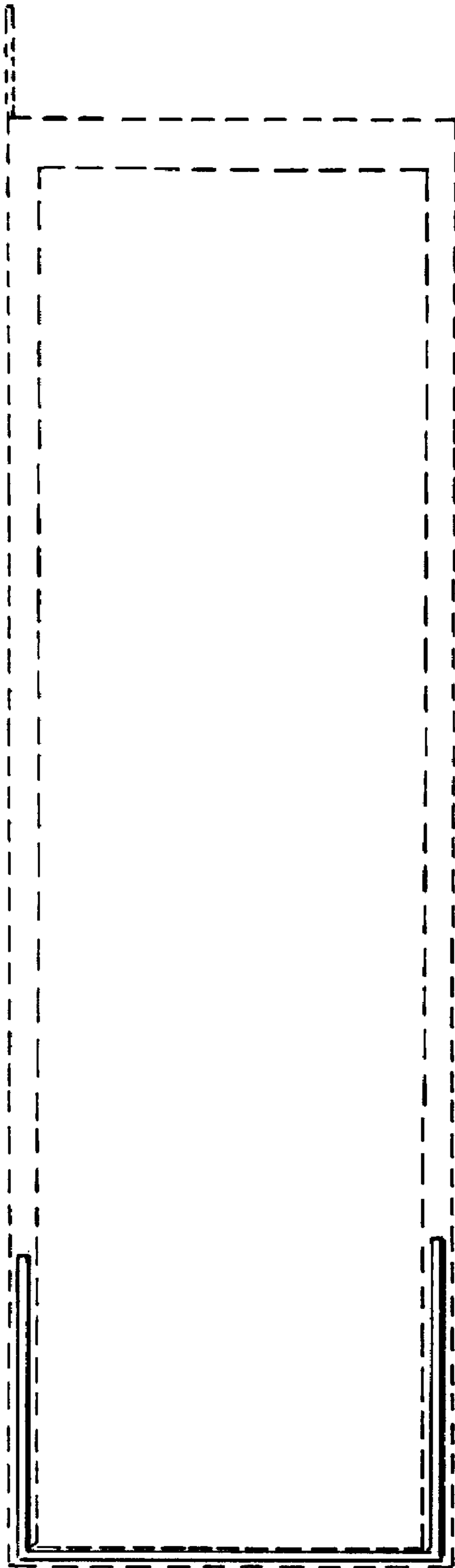

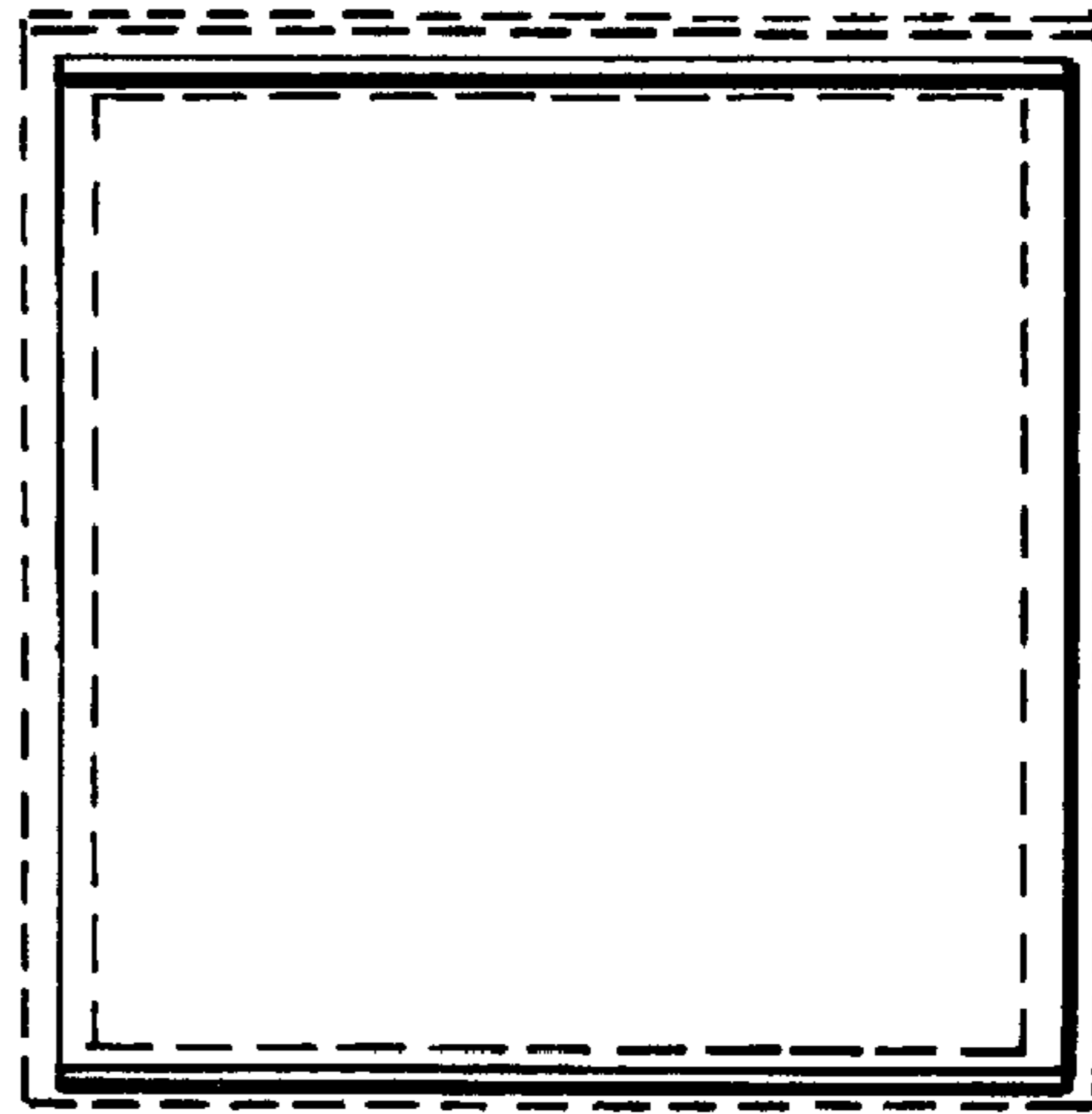

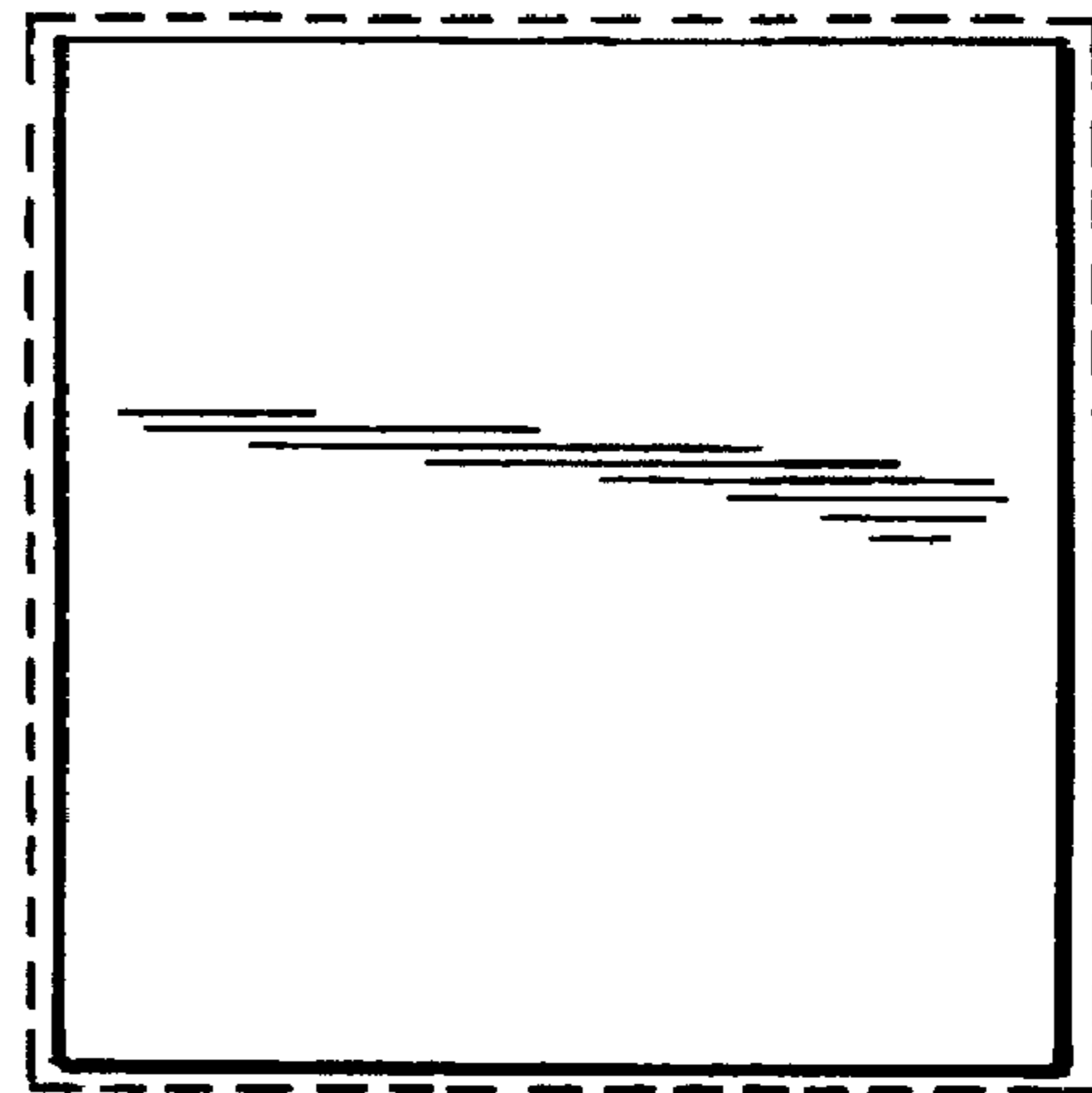
