FIG. 1 is a front elevational view of the compartment bottle with label;

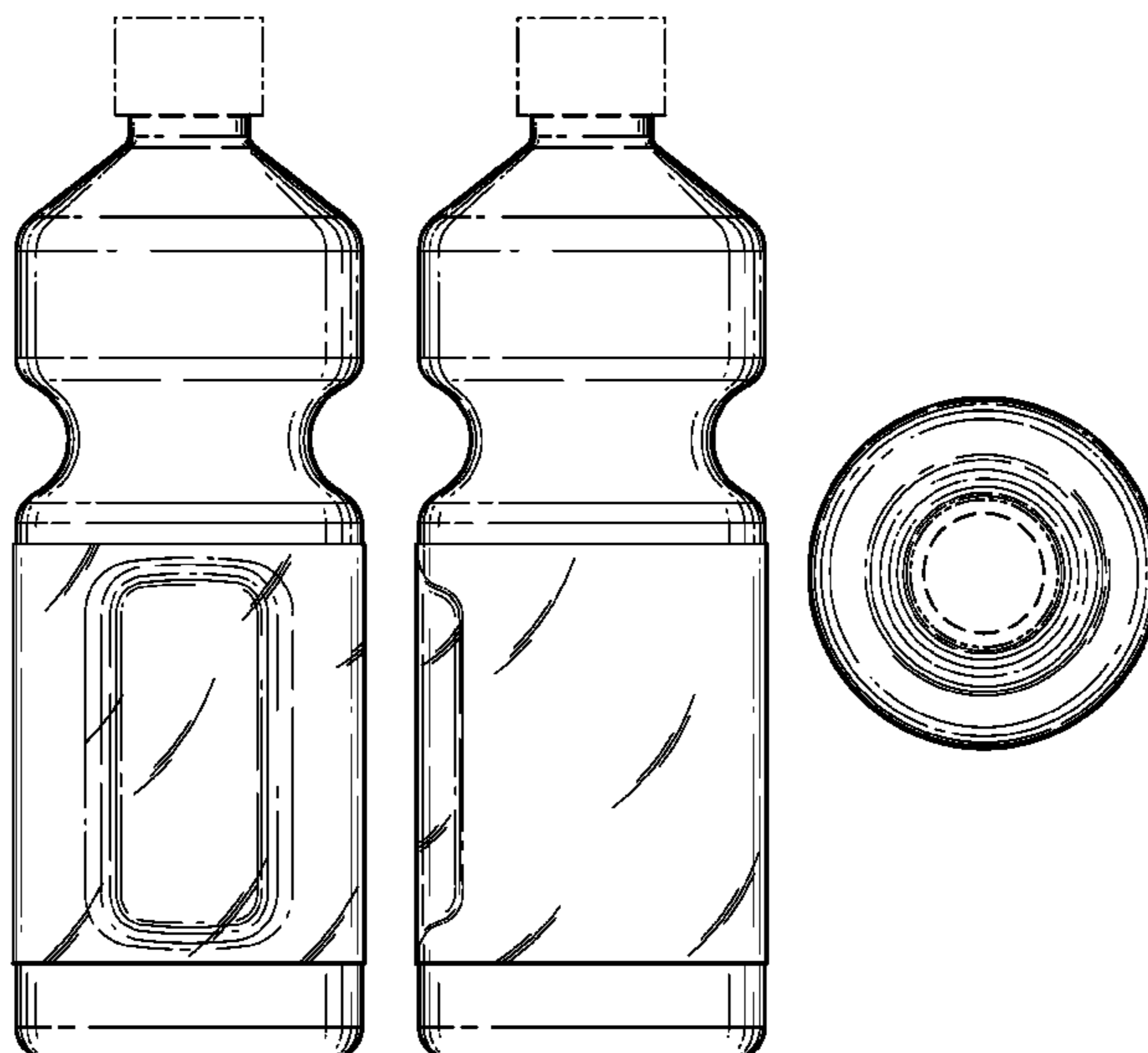
FIG. 2 is a left side elevation view thereof, the right side elevation view being a mirror image;

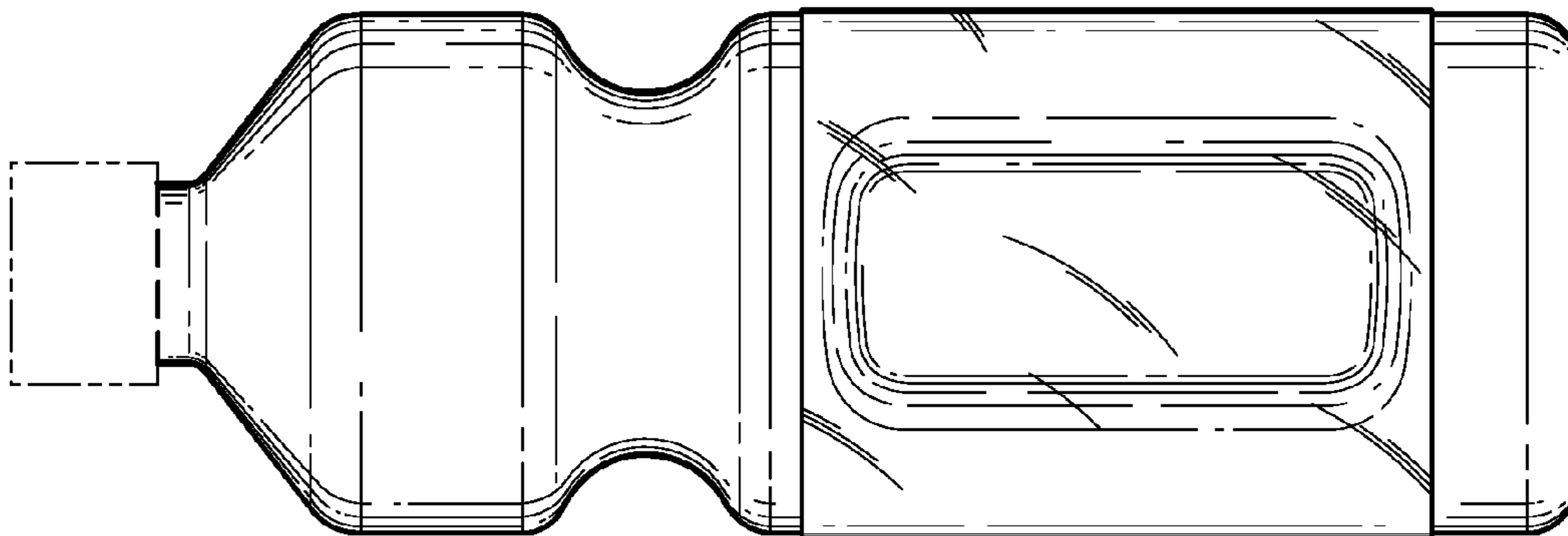

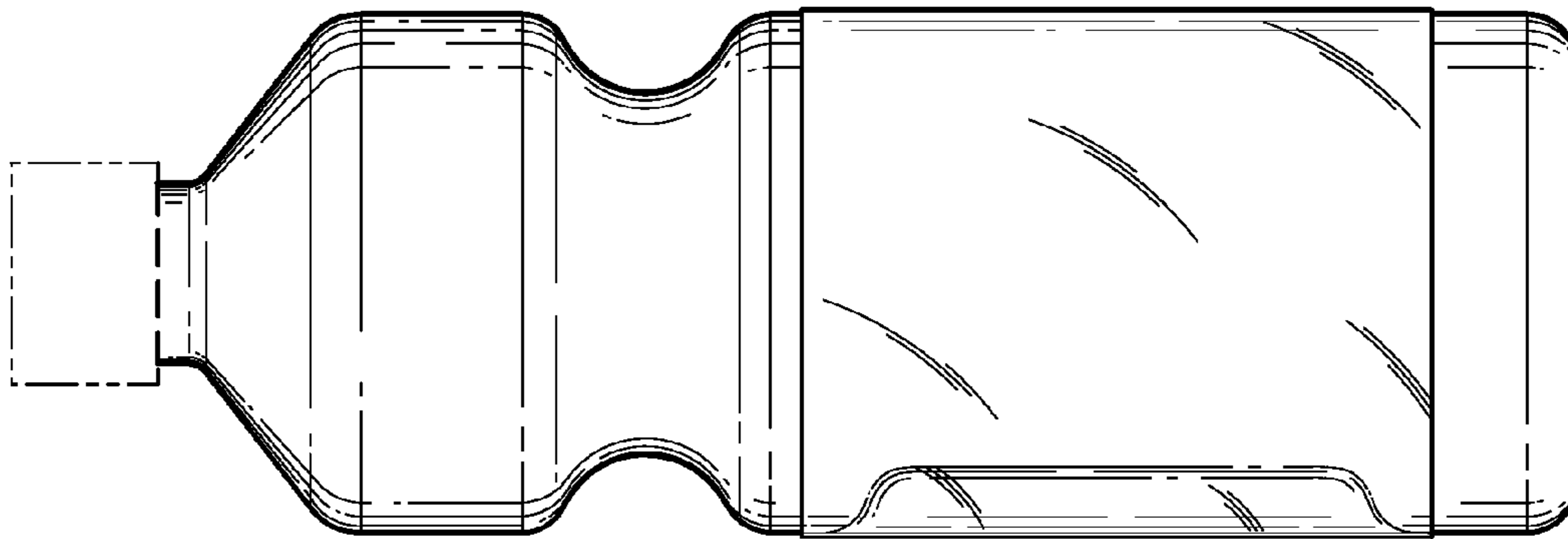

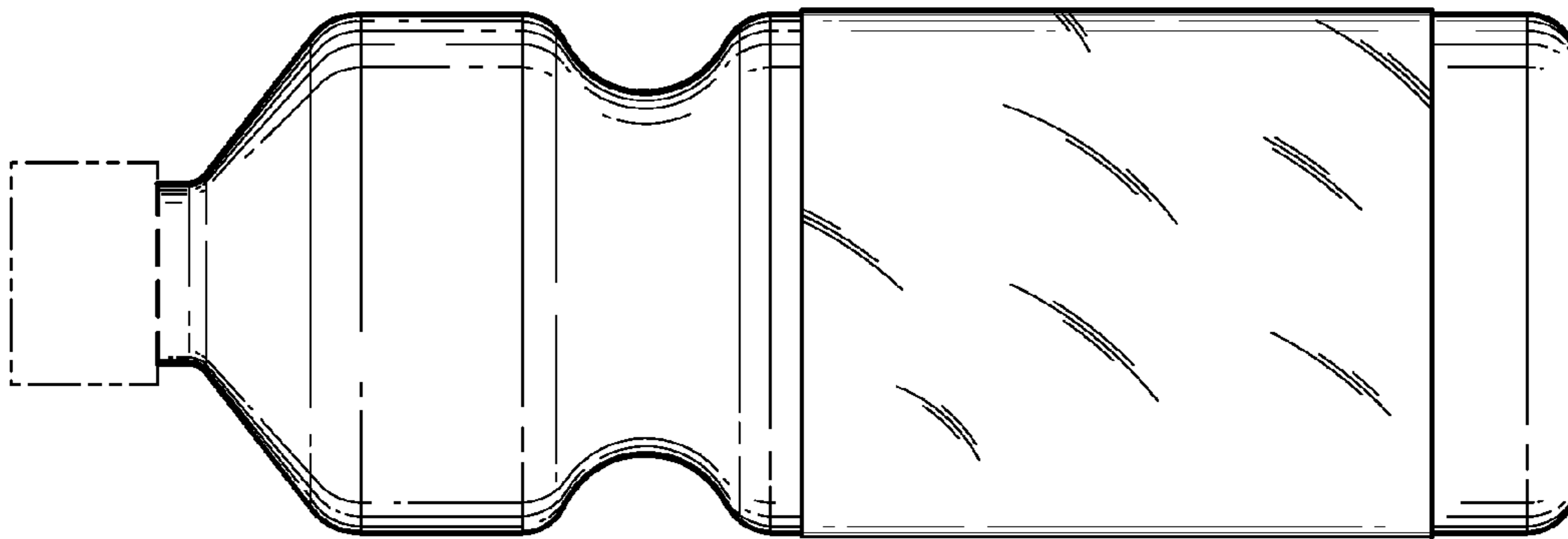

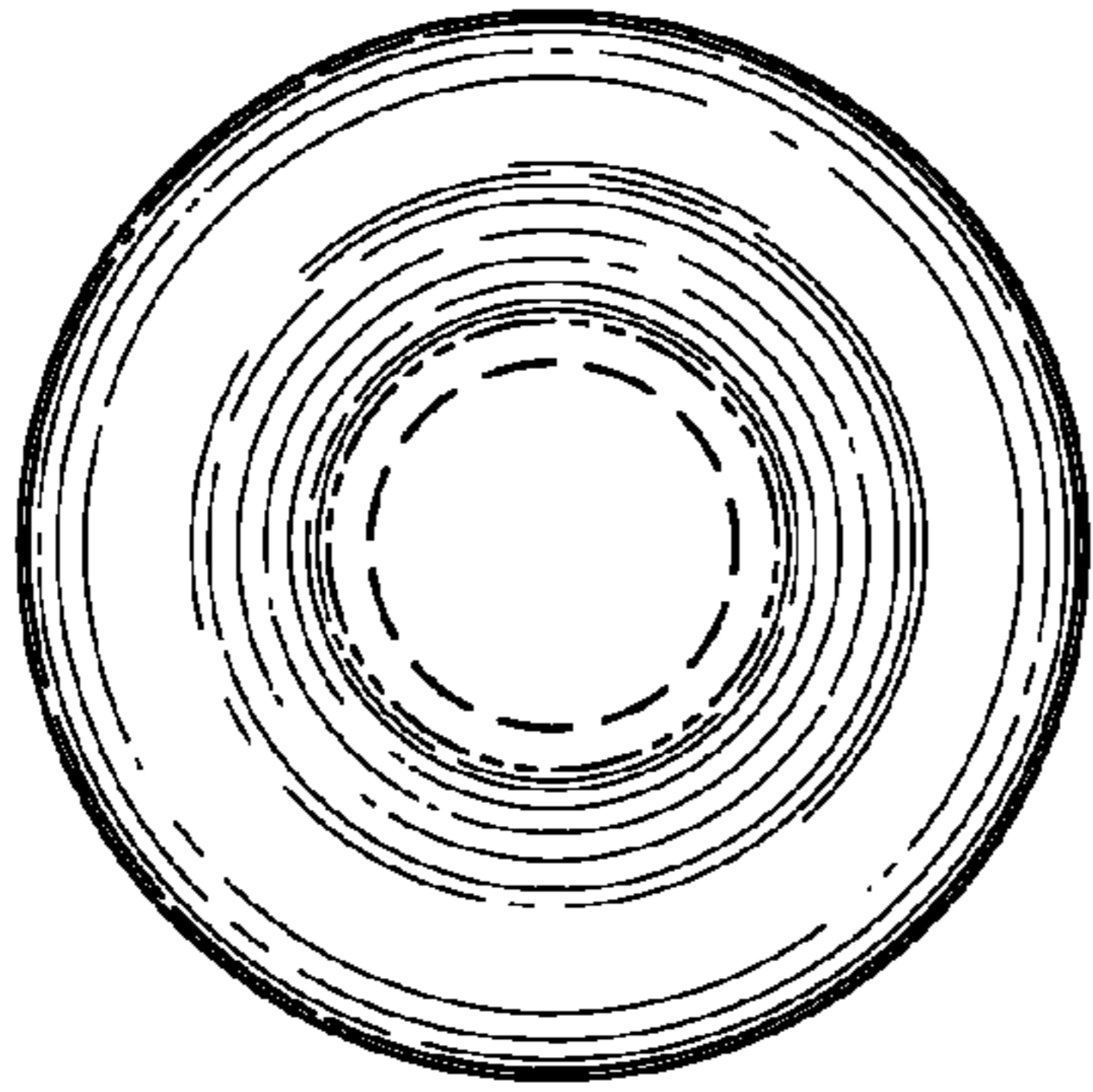
