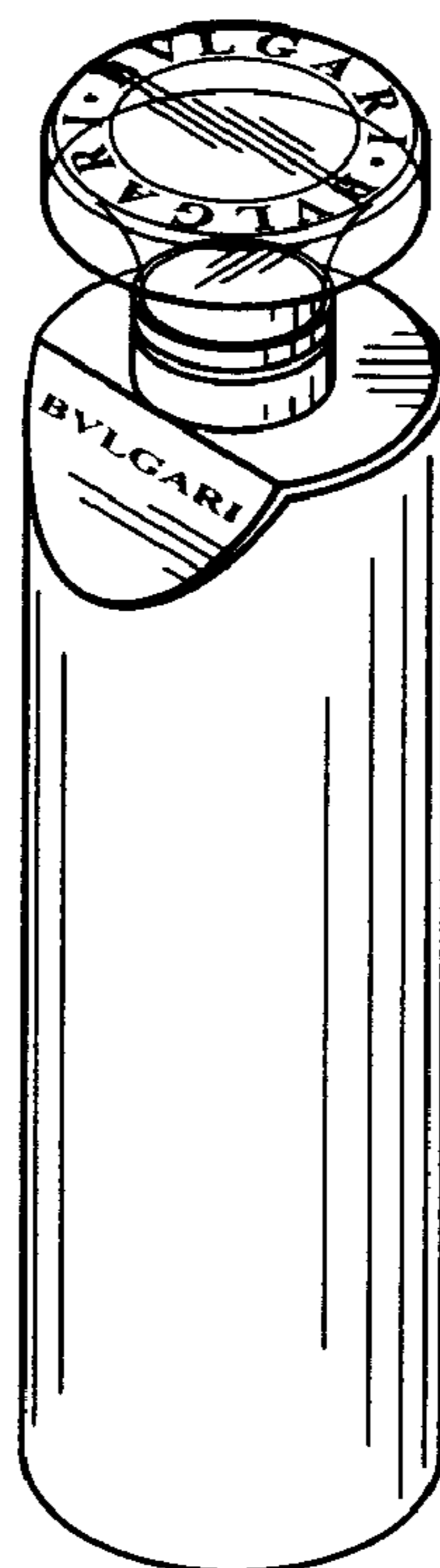
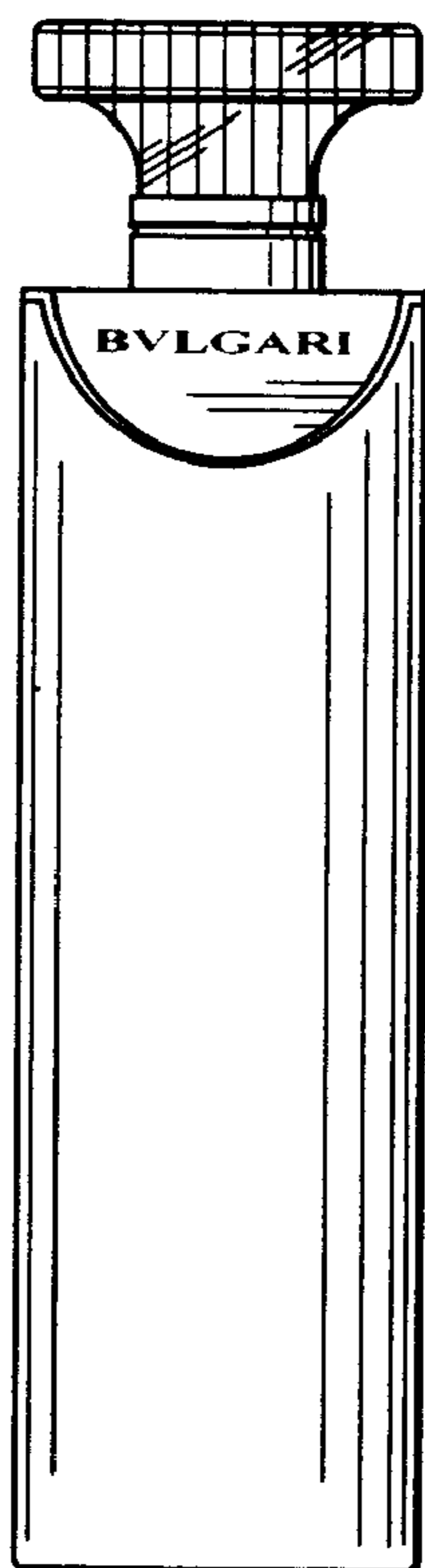
The ornamental design for a perfume container, as shown and described.

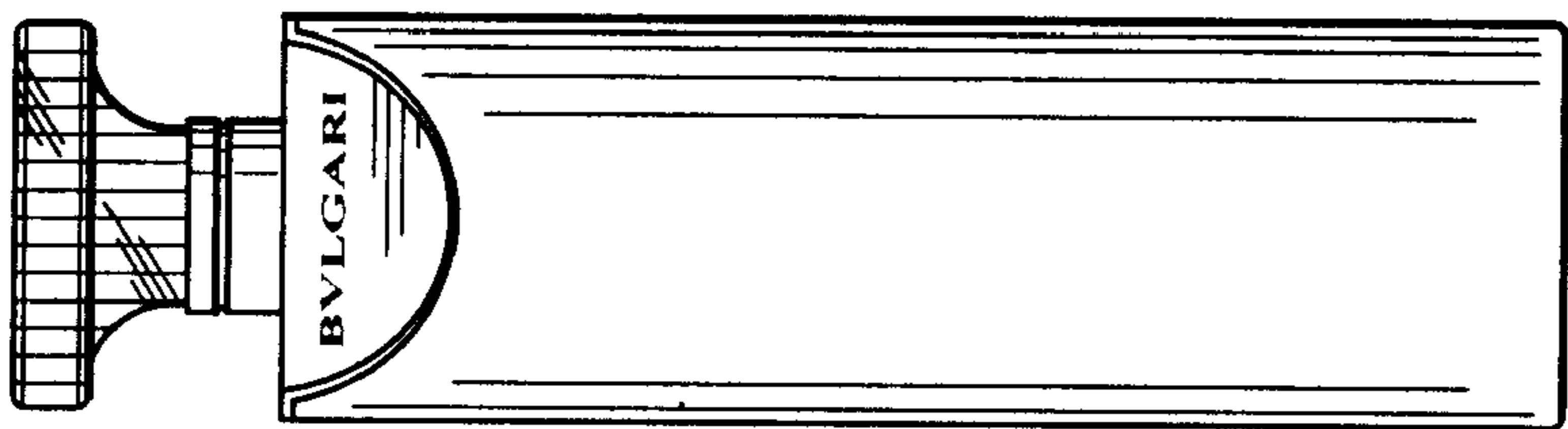
**DESCRIPTION**

FIG. 1 is a front elevational view of the perfume container; FIG. 2 is a left-side elevational view thereof; FIG. 3 is a back elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top, front, right side view thereof.

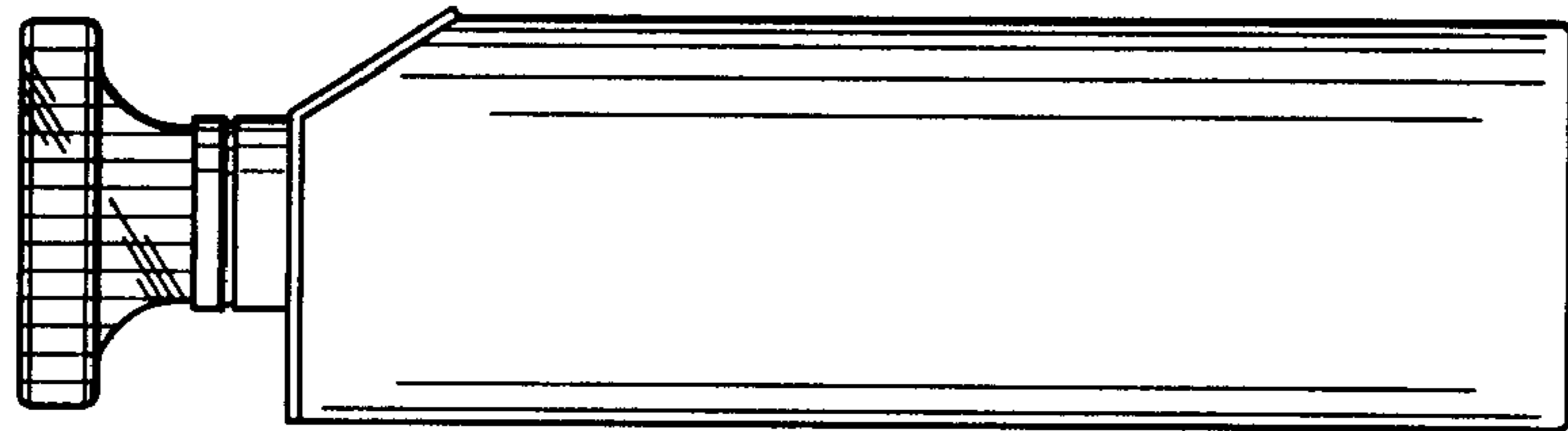
The vertical line pattern shown on the cap and bottom surfaces of the perfume container in FIGS. 1-7 represents the color red.

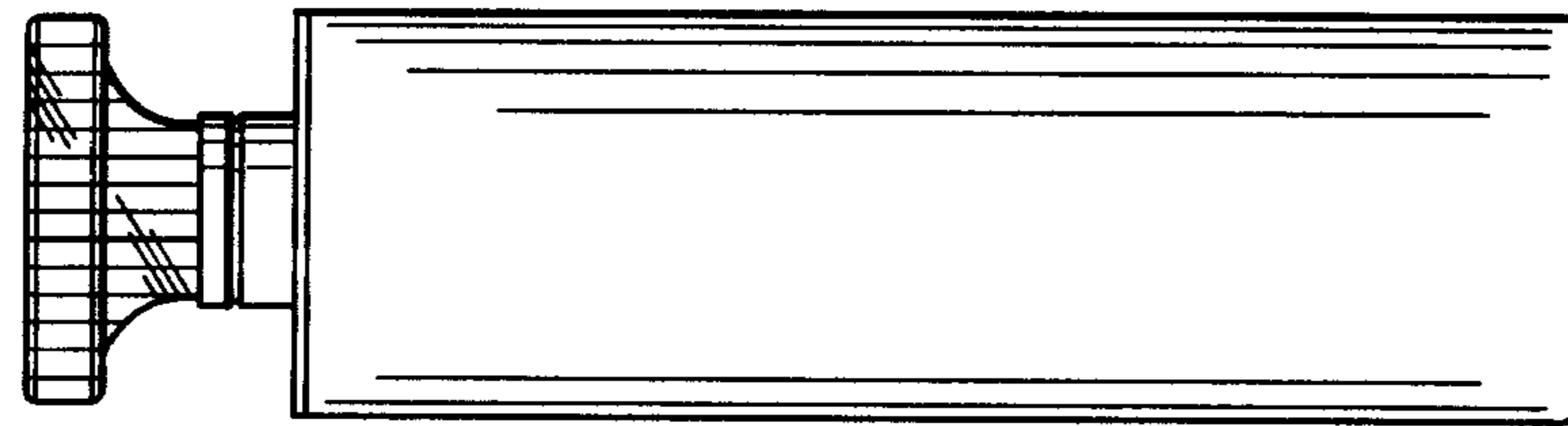




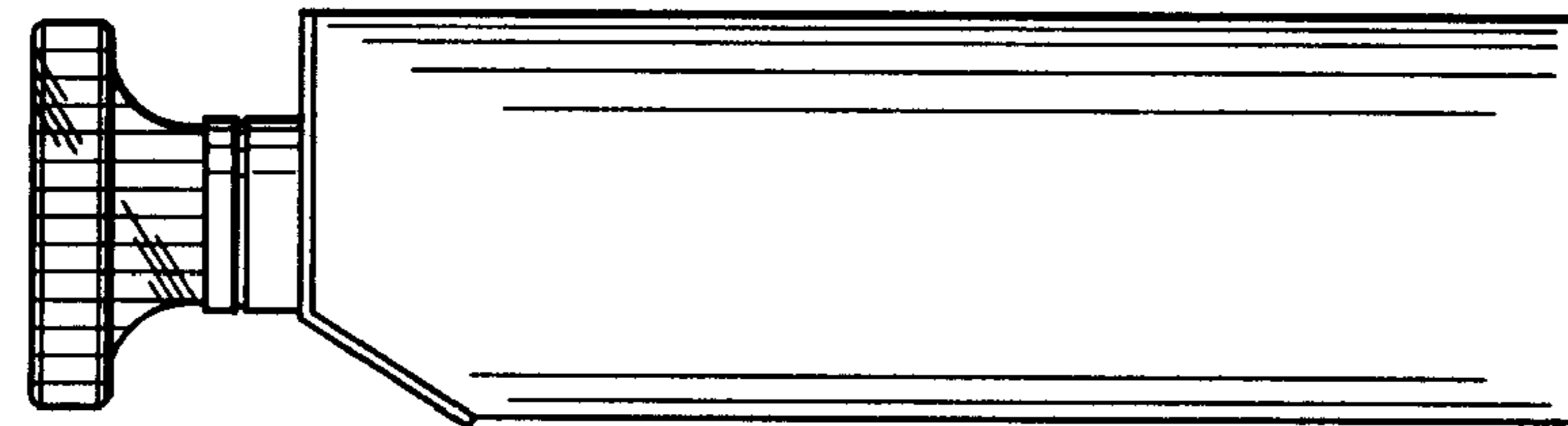

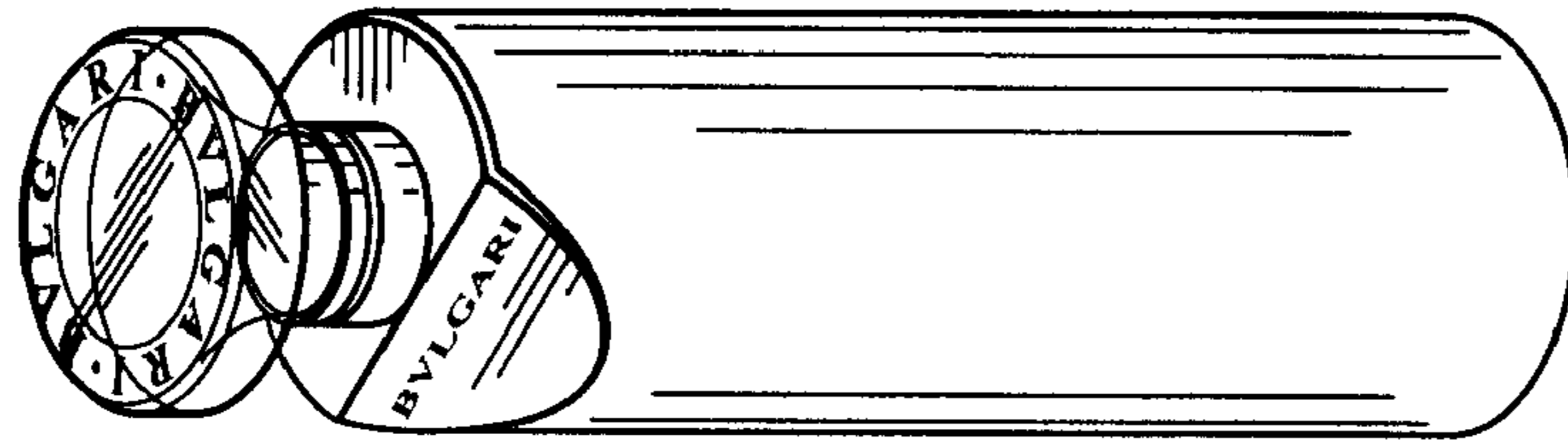

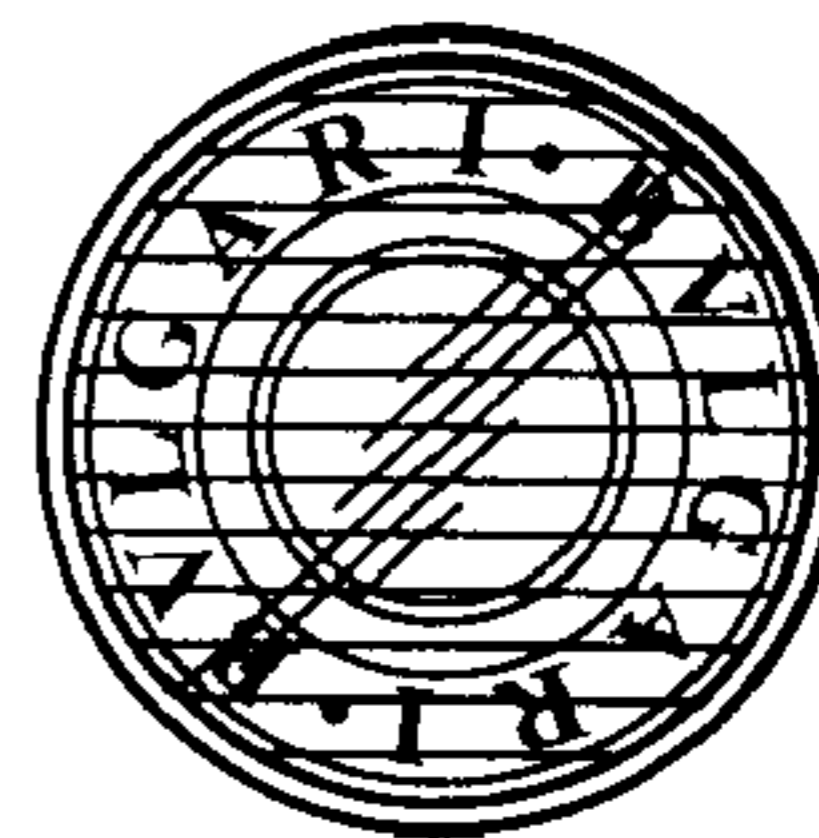

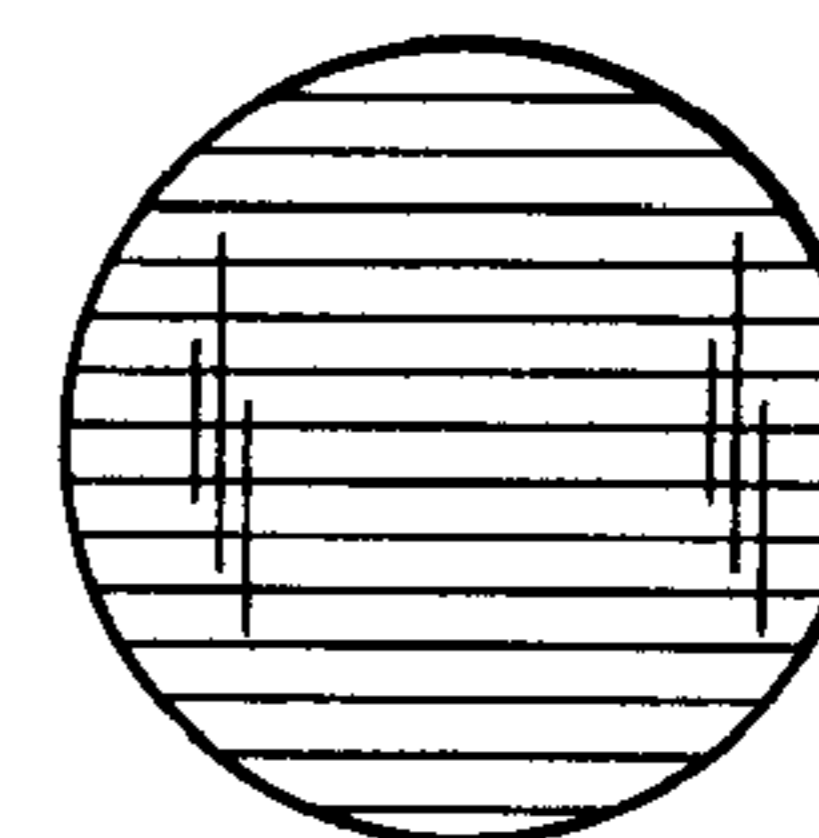
