The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a white opaque bottle incorporating my new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being identical;

FIG. 3 is a side elevational view thereof, the opposite side elevational view being identical;

FIG. 4 is a top plan view thereof;

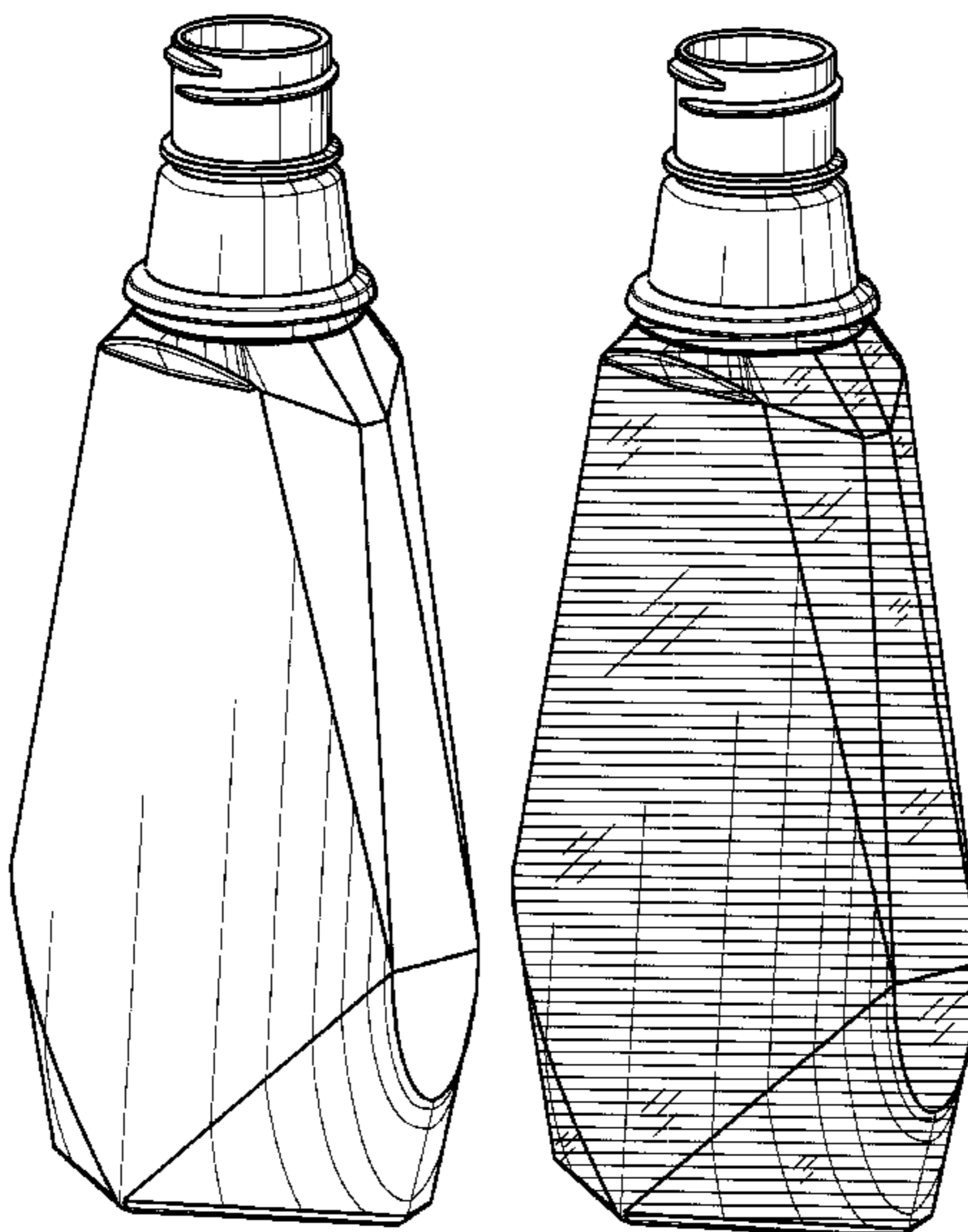
FIG. 5 is a front perspective view of a second embodiment showing a blue translucent bottle, color being represented by the solid horizontal lines;

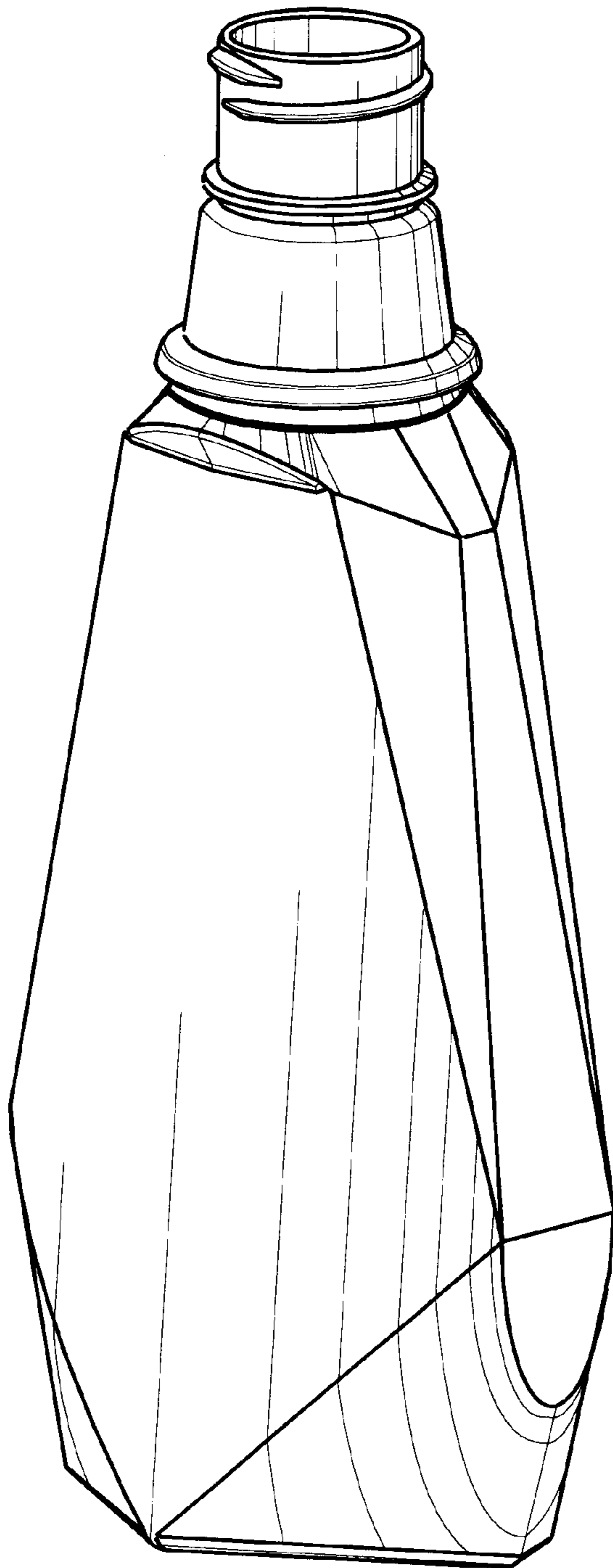
FIG. 6 is a front elevational view thereof, the rear elevational view being identical;

FIG. 7 is a side elevational view thereof, the opposite side elevational view being identical; and,

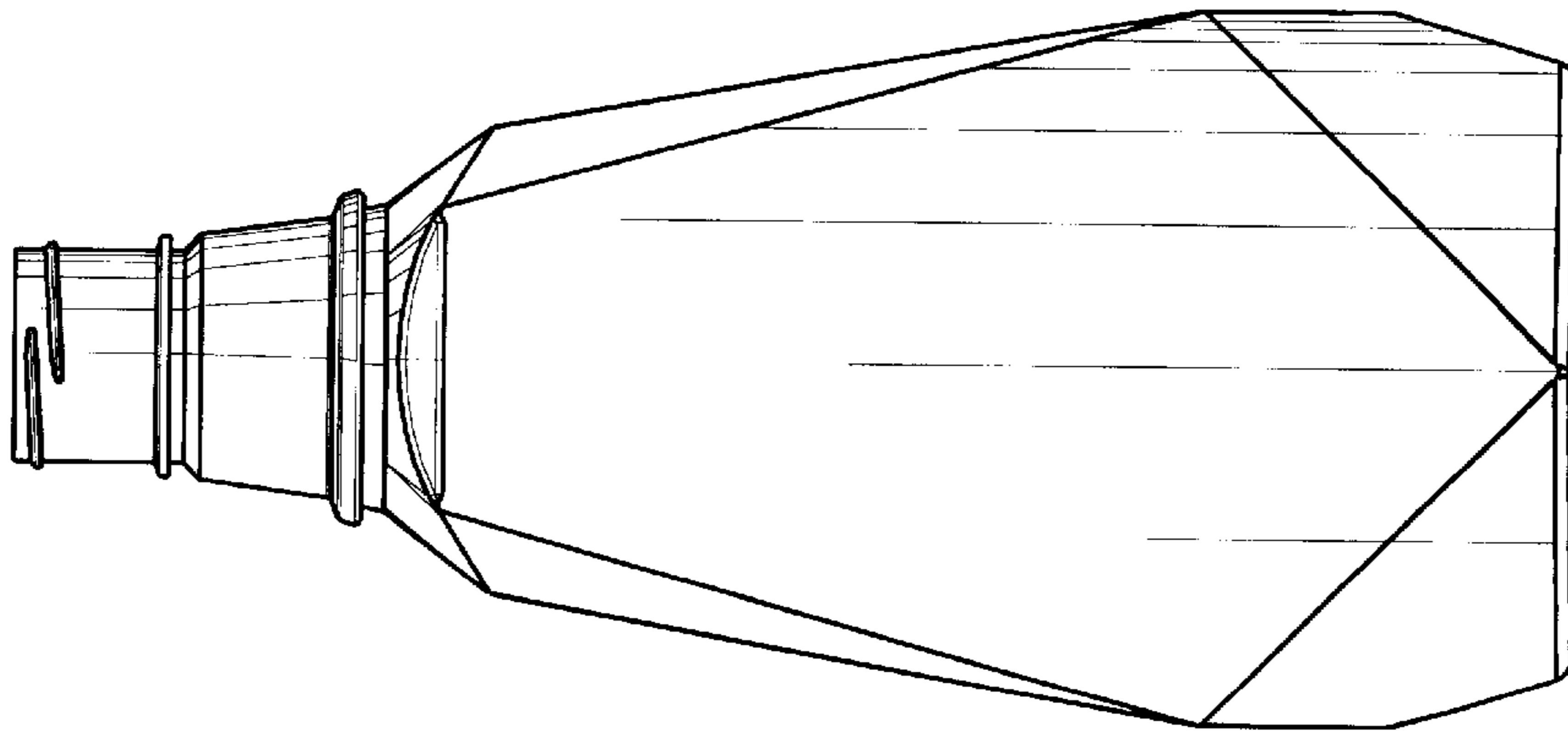
FIG. 8 is a top plan view thereof.

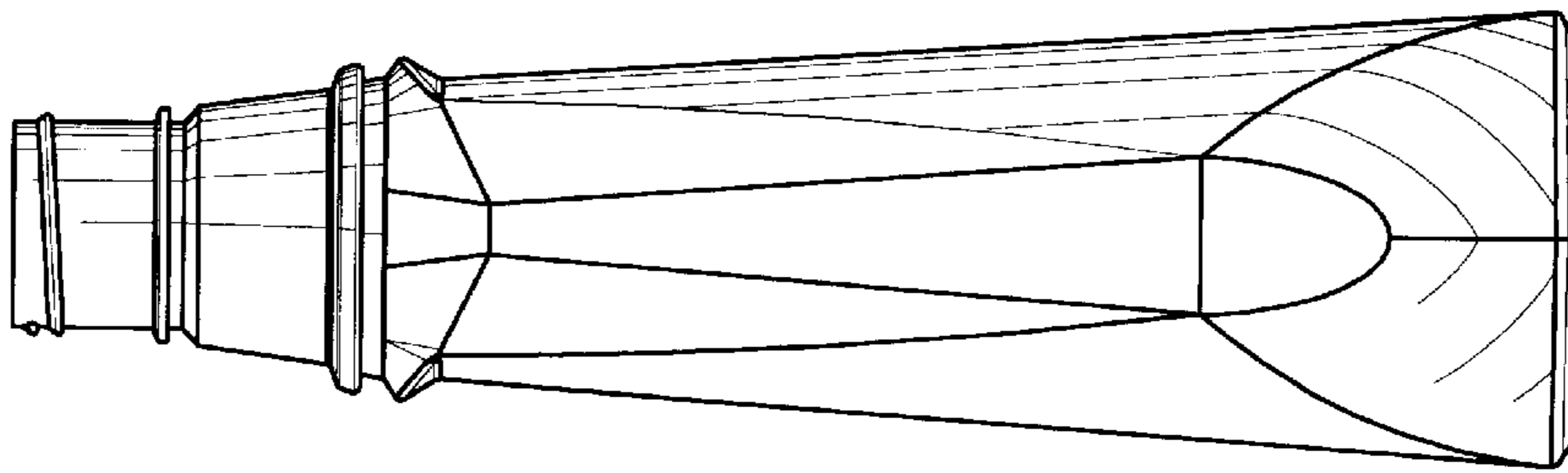




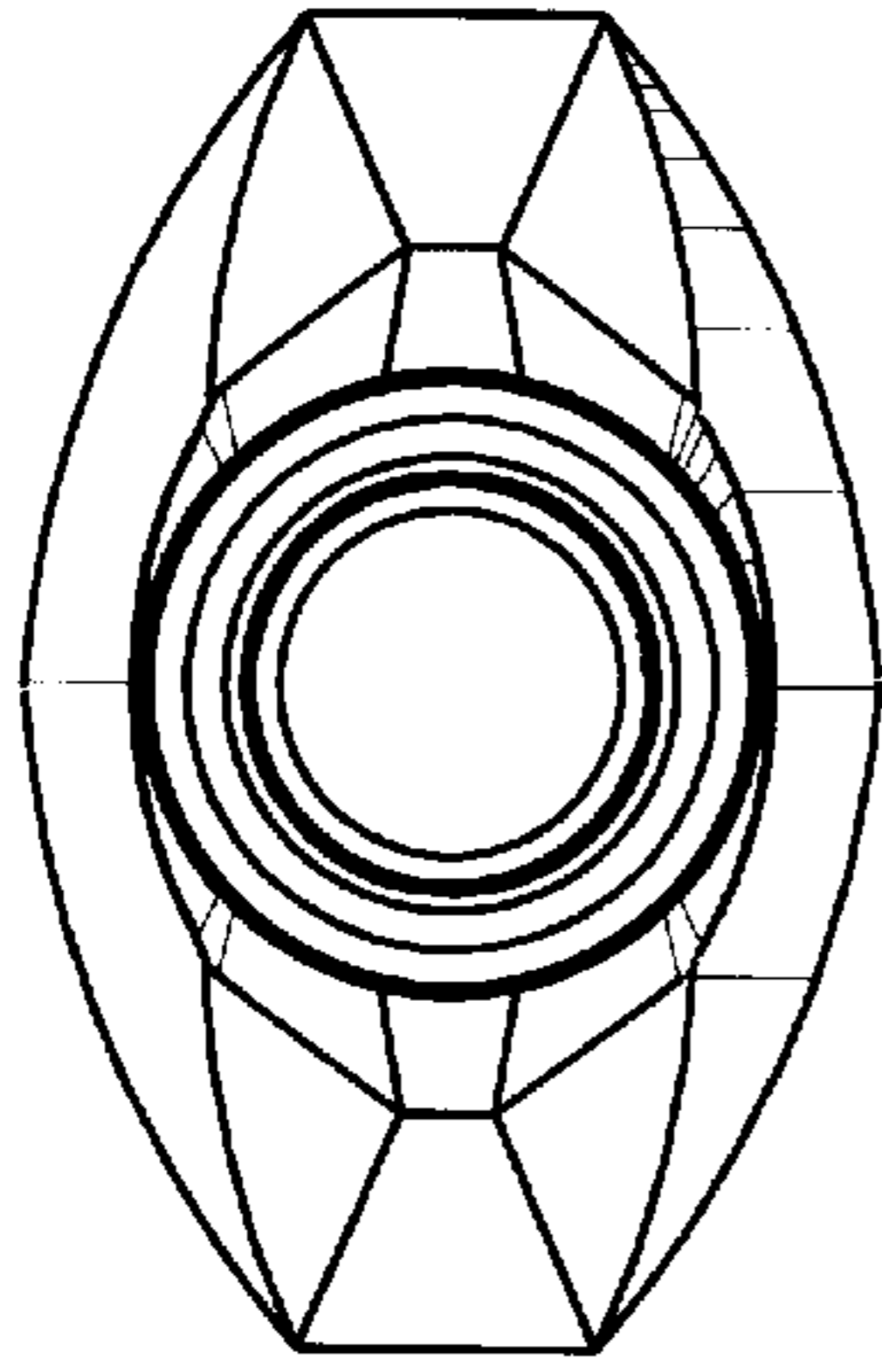

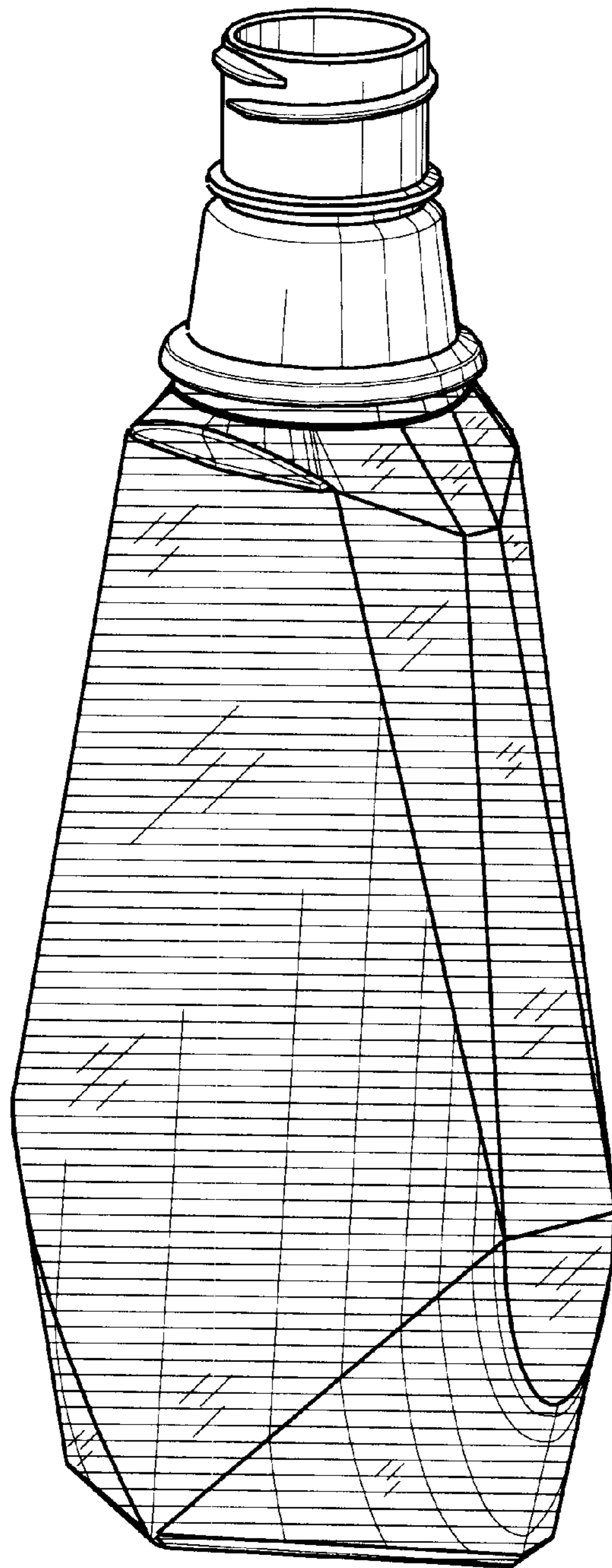

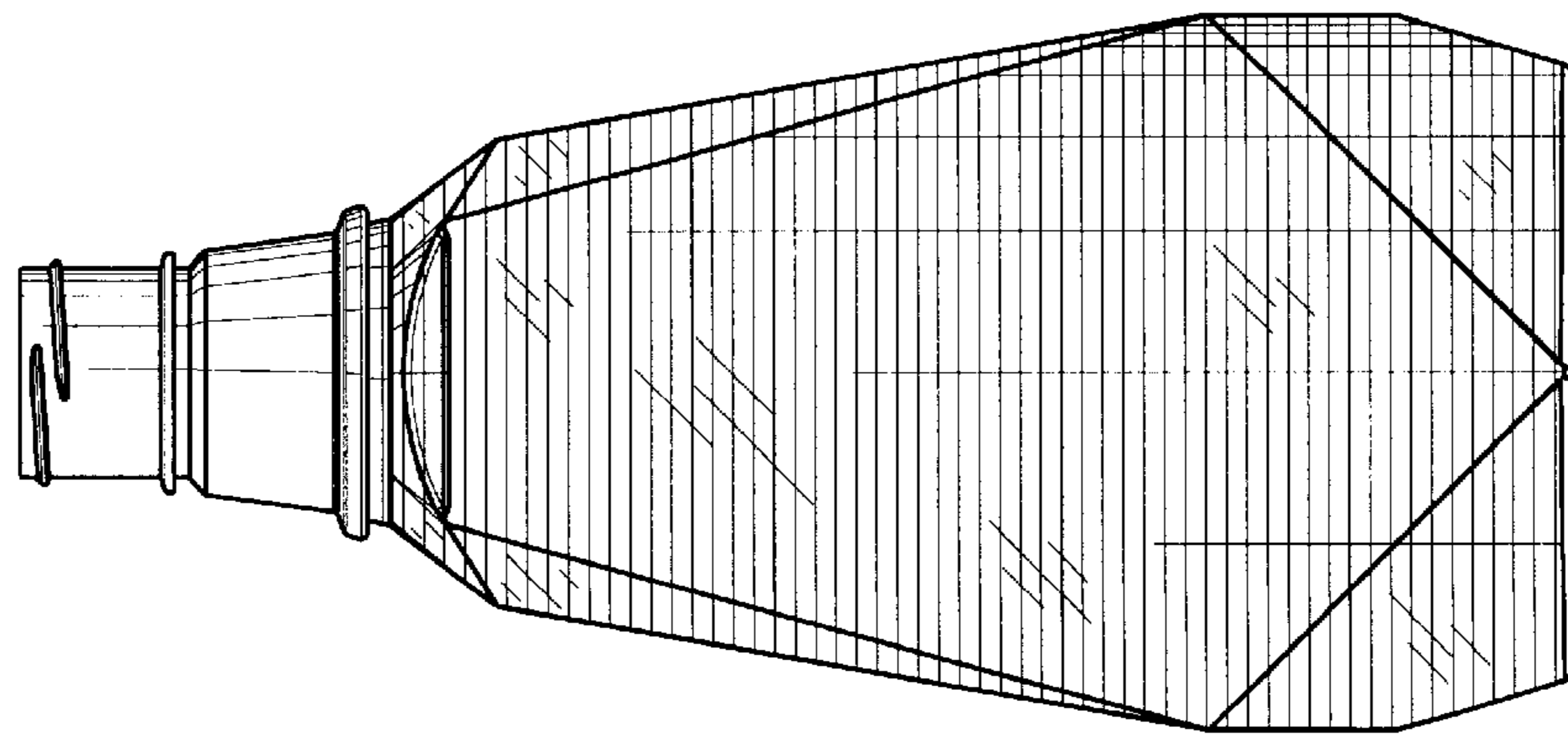

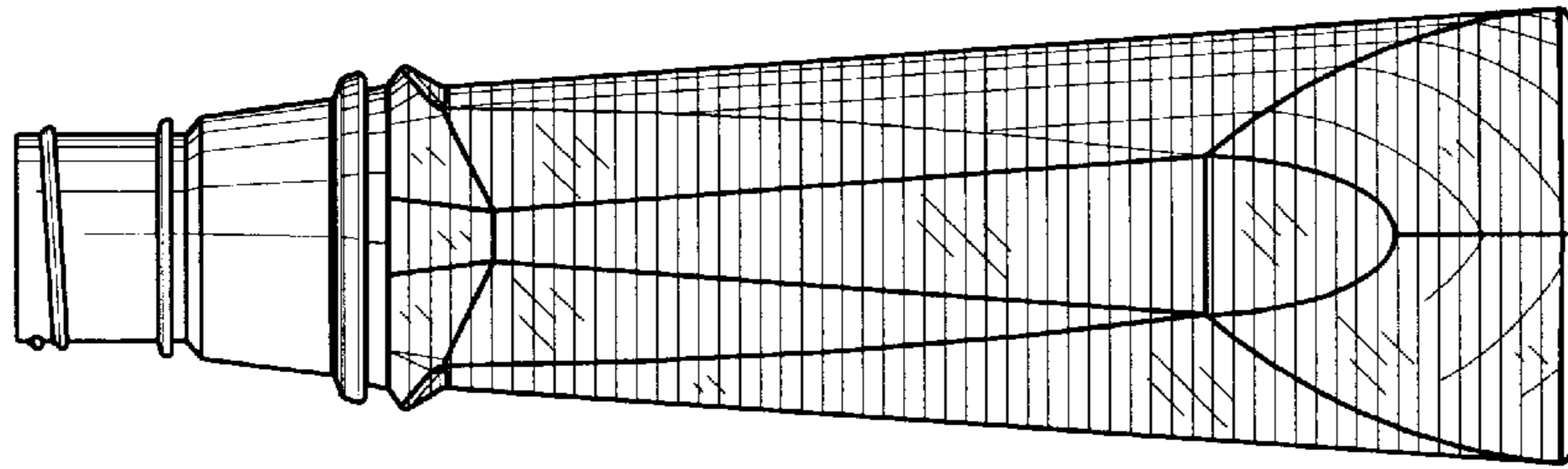

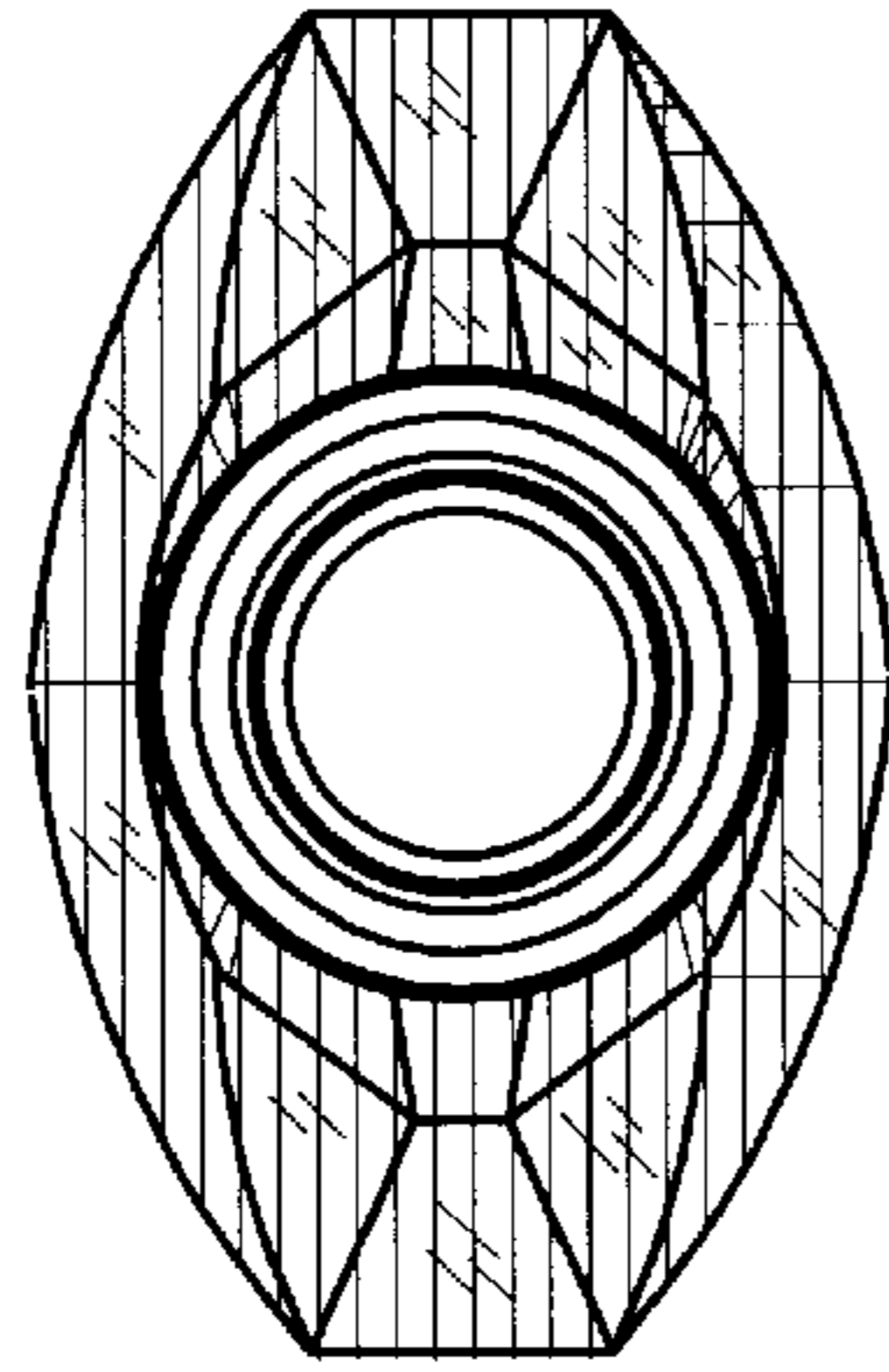
