(57) **CLAIM**

The ornamental design for a disposable bag for hygienic disposal of a feminine hygiene product, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a disposable bag for hygienic disposal of a feminine hygiene product, showing our new design;

FIG. 2 is a back elevational view thereof;

FIG. 3 is a front elevational view thereof when in open condition ready to receive said product;

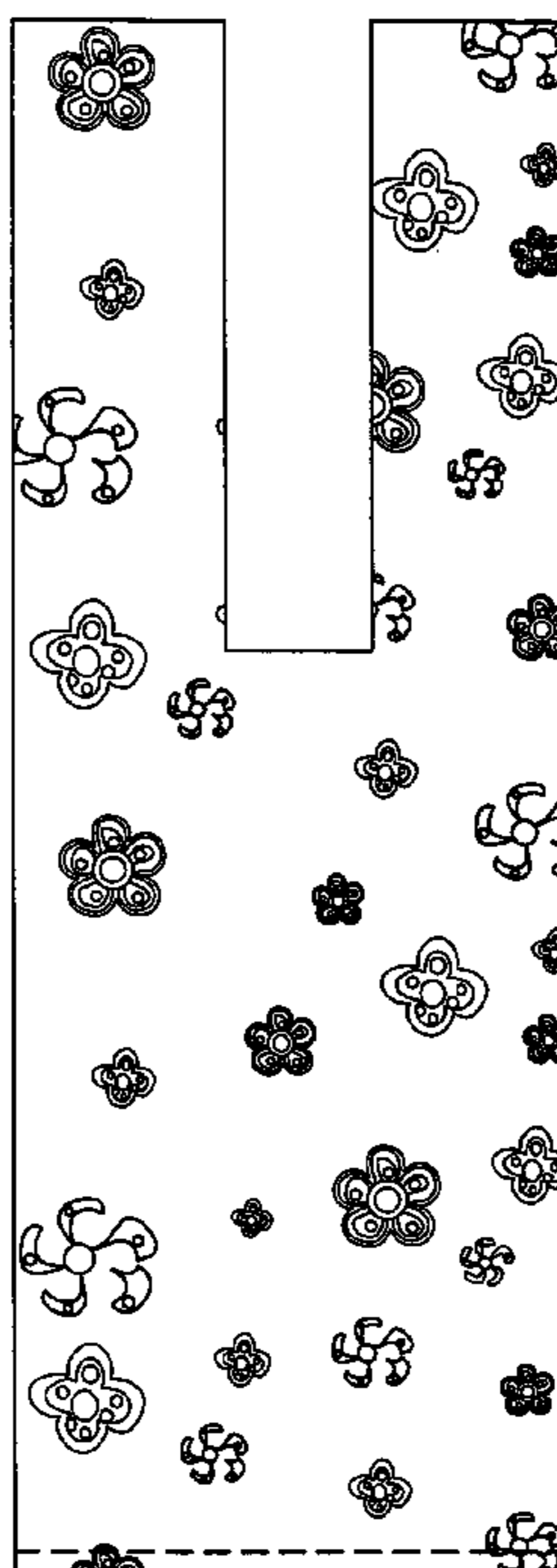
FIG. 4 is a back elevational view thereof when in said open condition as shown in FIG. 3;

FIGS. 5 and 6 are side elevational views thereof when in said open condition, from the left and right sides, respectively;

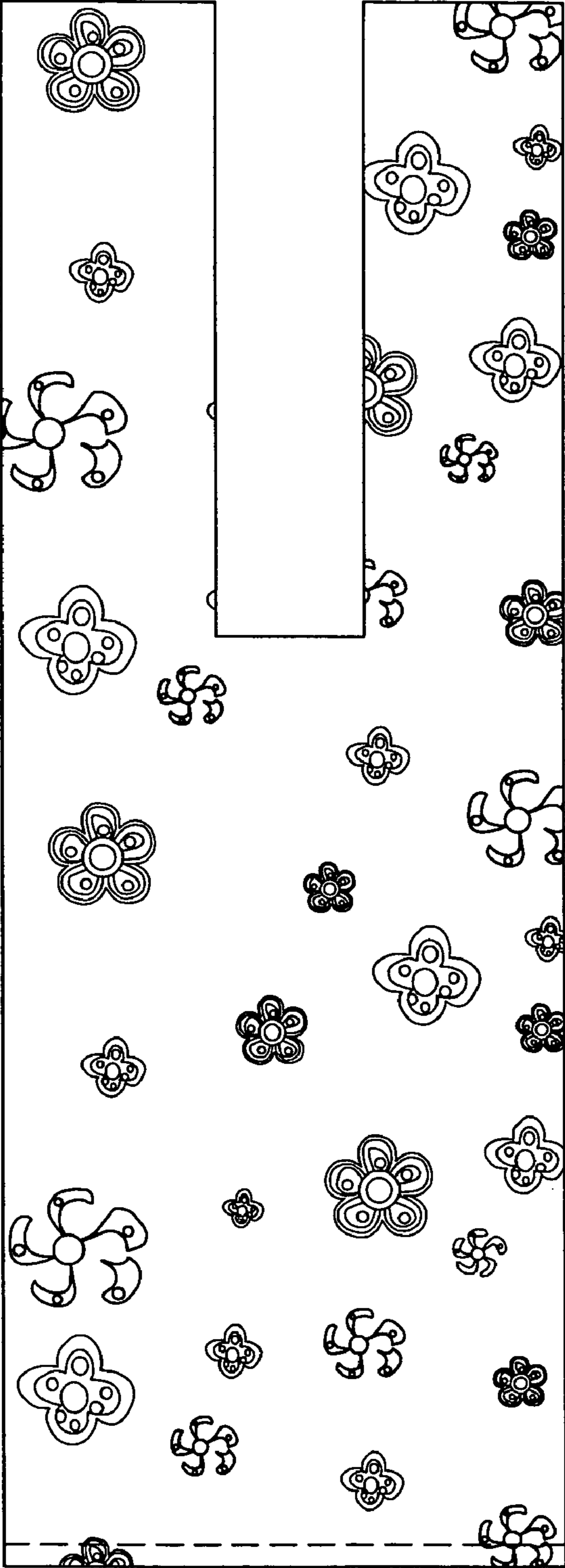

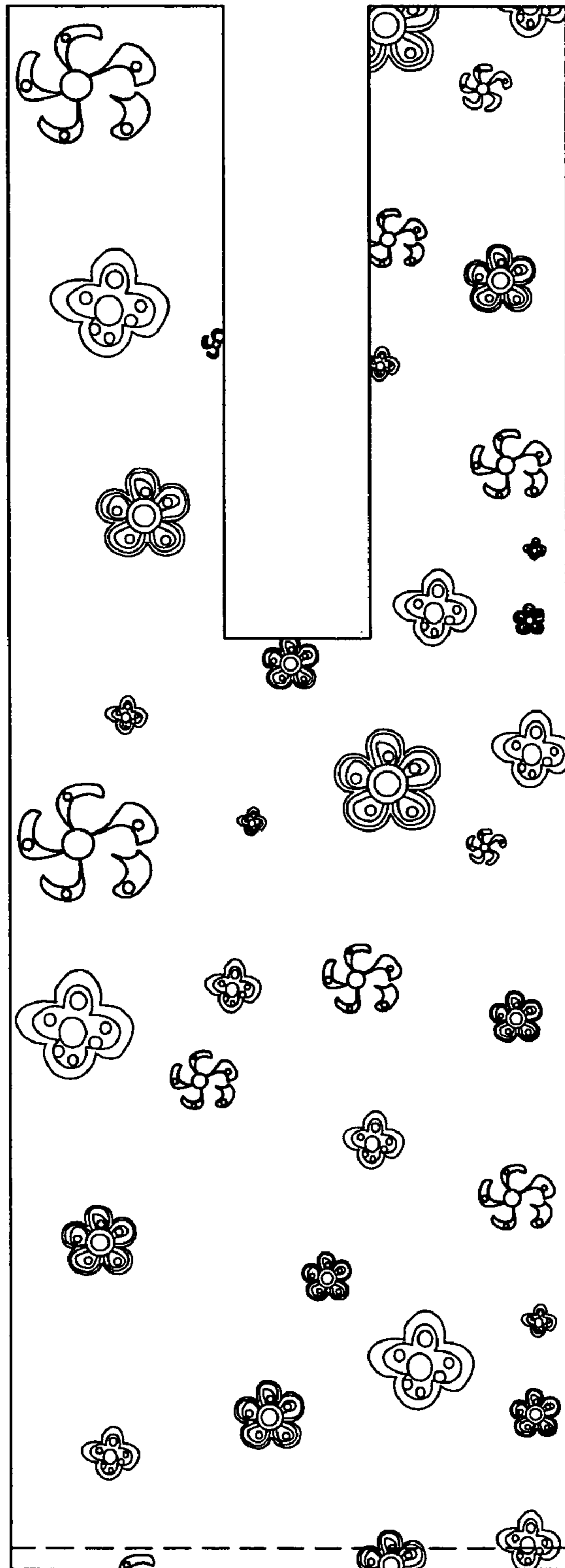

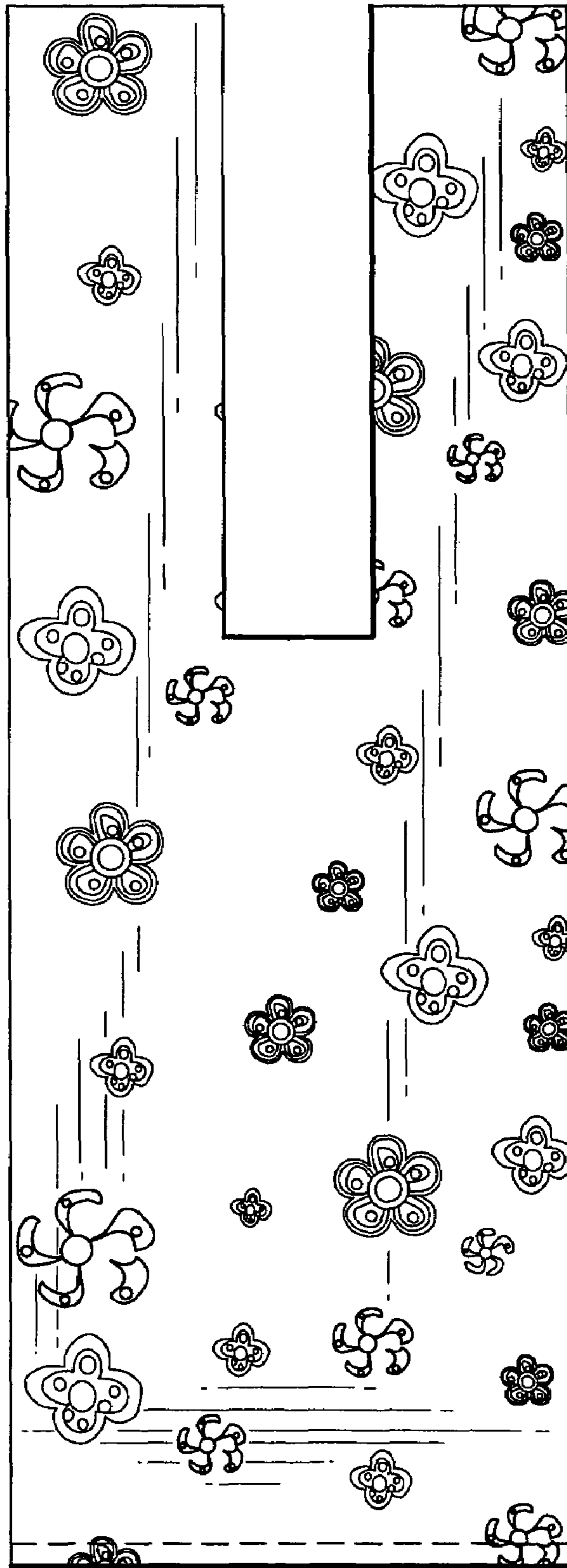

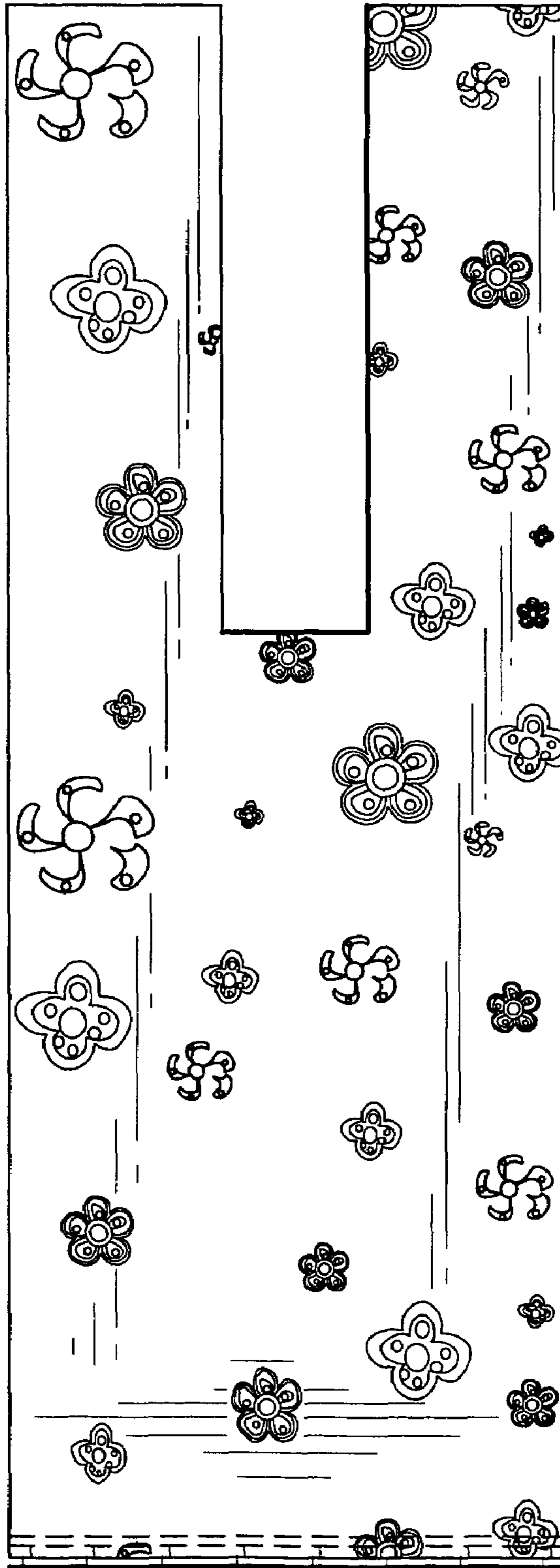

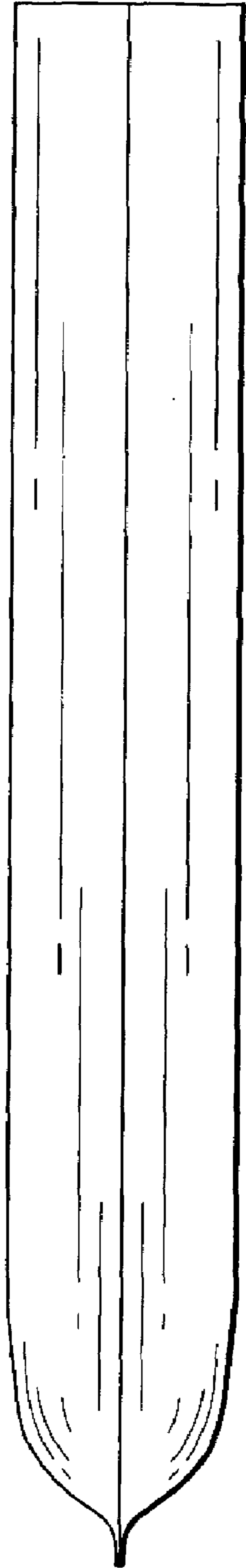

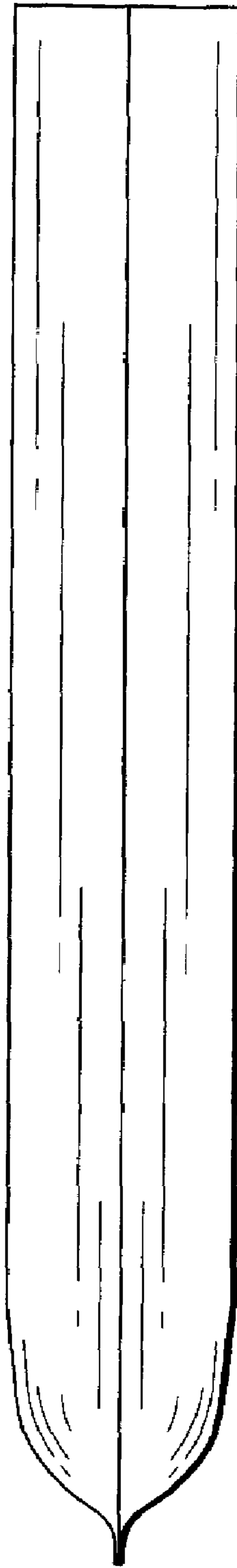

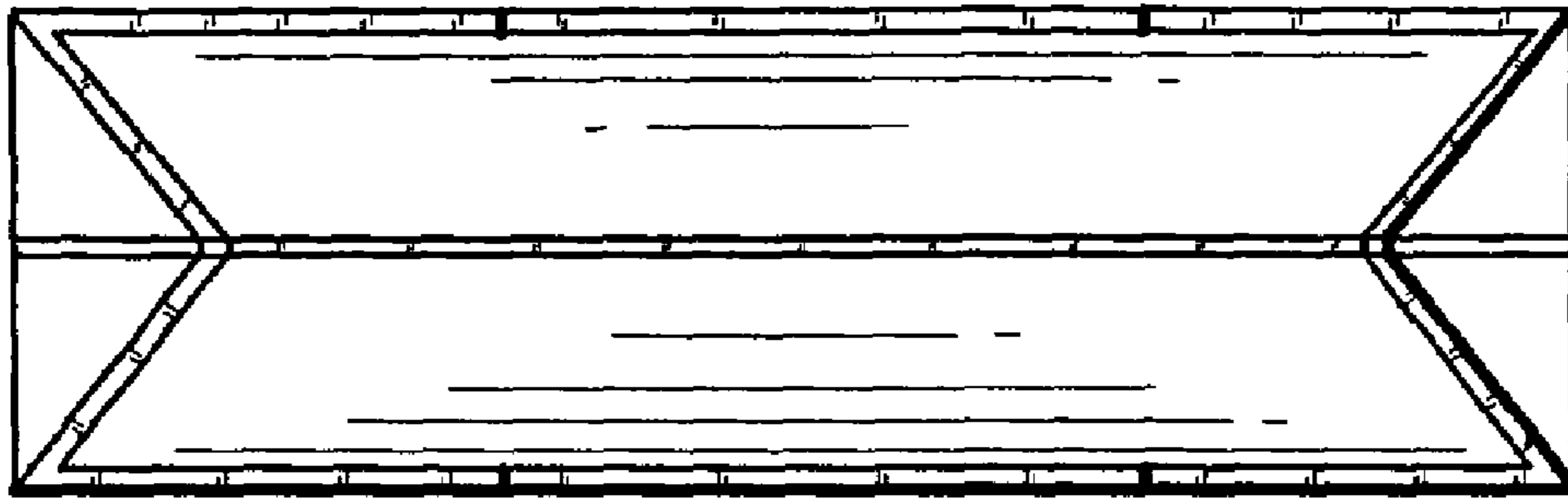

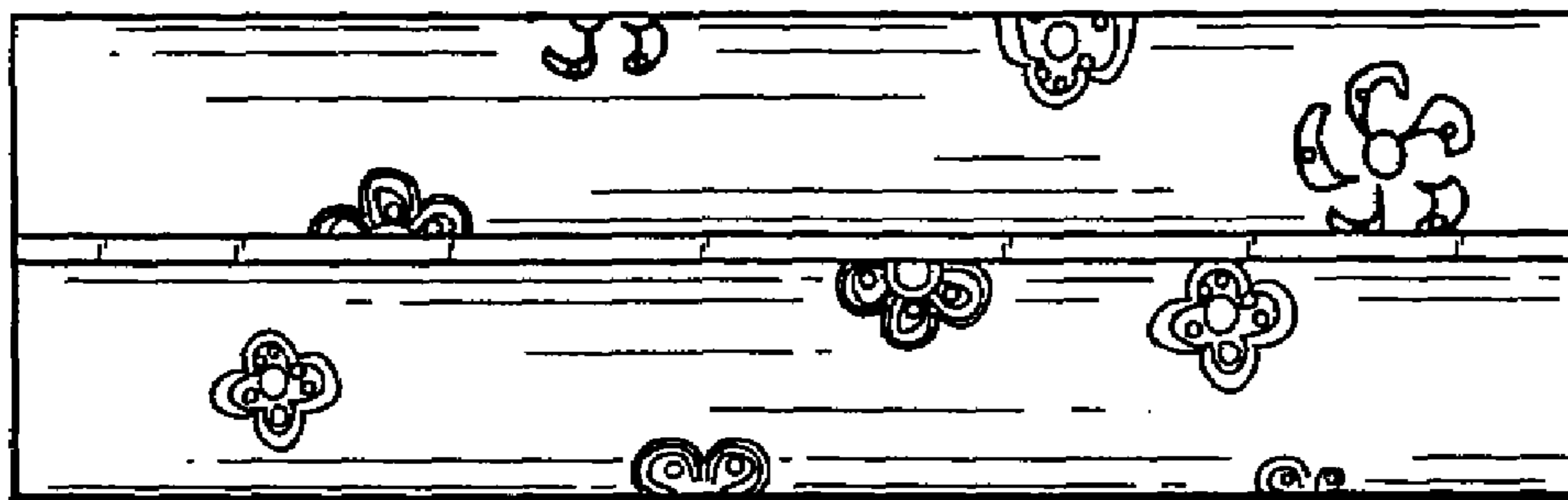
