The ornamental design for a combined watch with USB plug, as shown and described.

DESCRIPTION

The claimed combined watch with USB plug is a small portable timepiece with the function of storing data.

FIG. 1 is a front elevational view of a combined watch with USB plug showing my new design;

FIG. 3 is a right side view thereof;

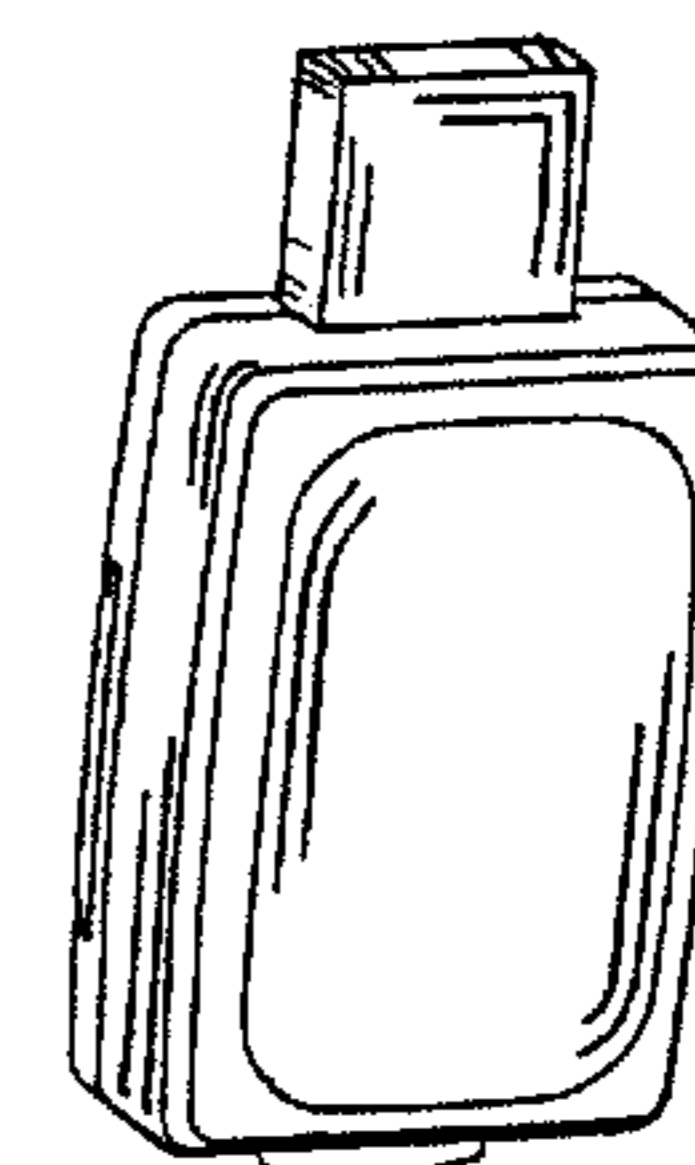
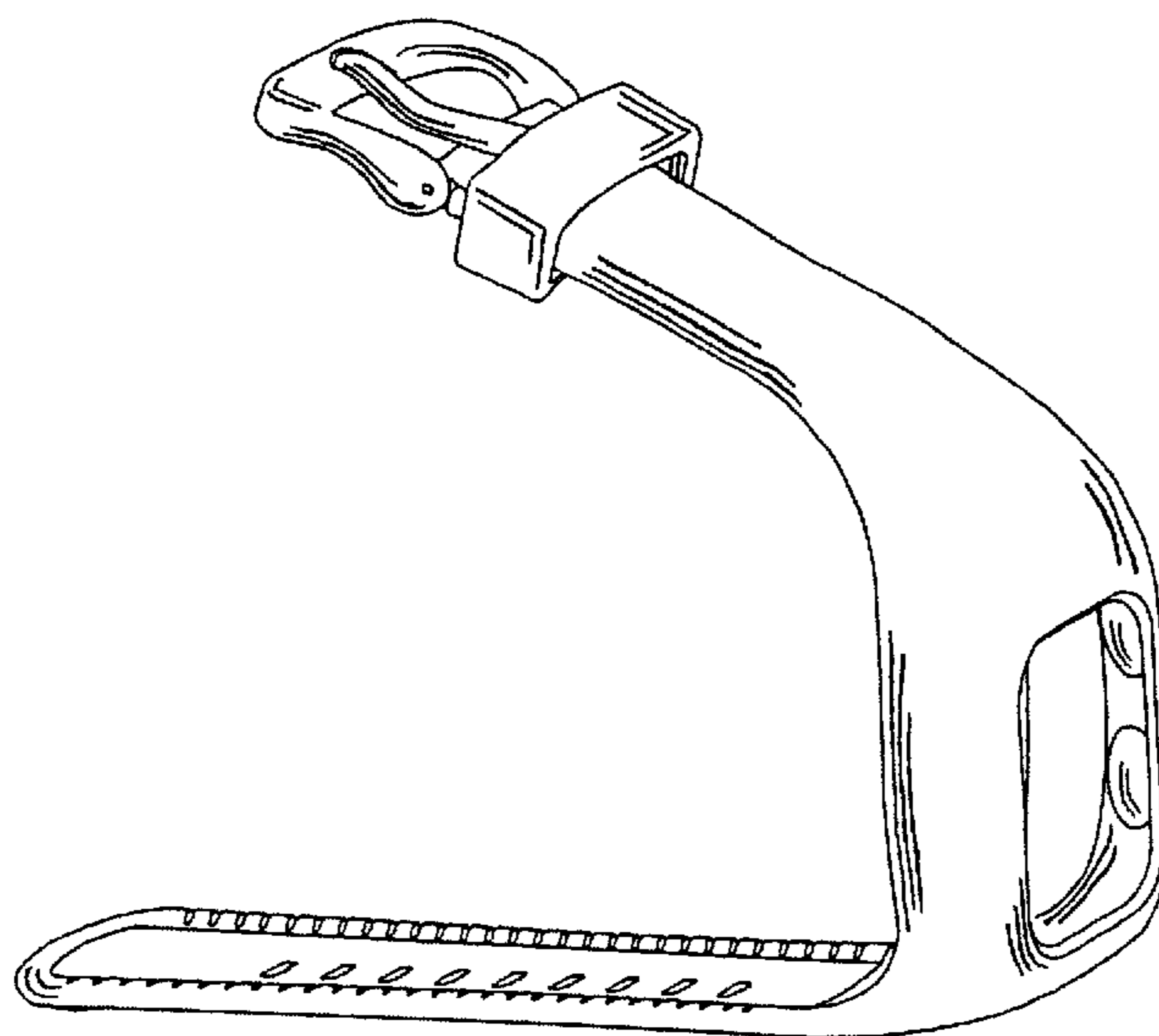
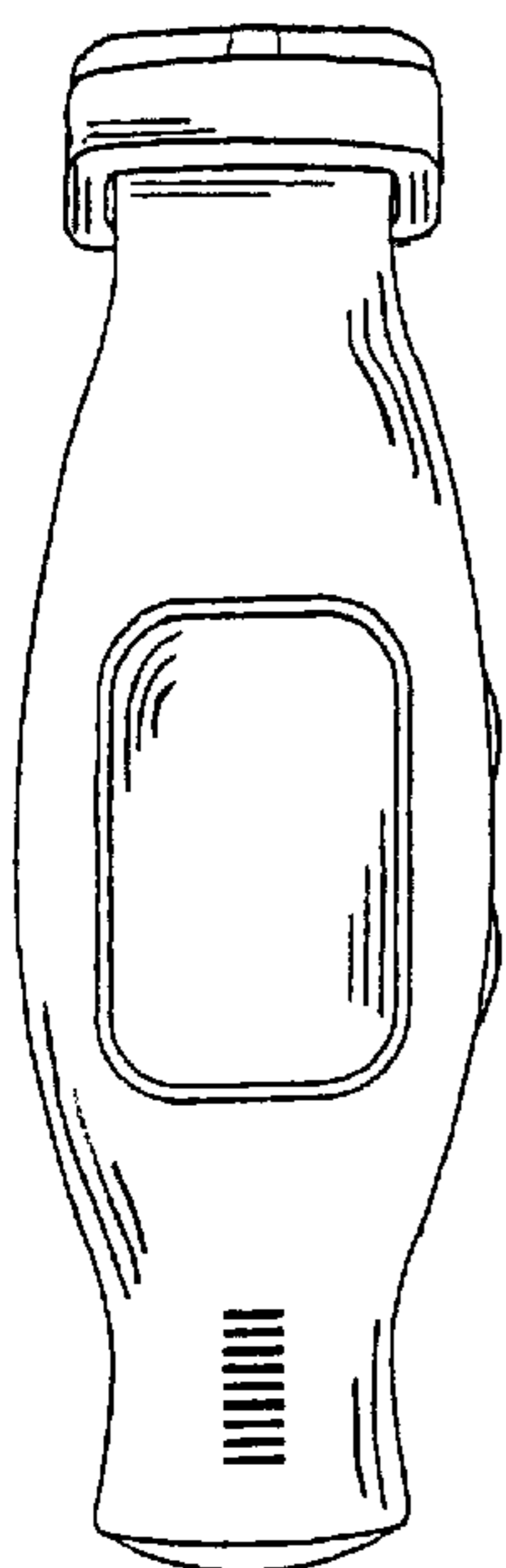
FIG. 4 is a left side view thereof;

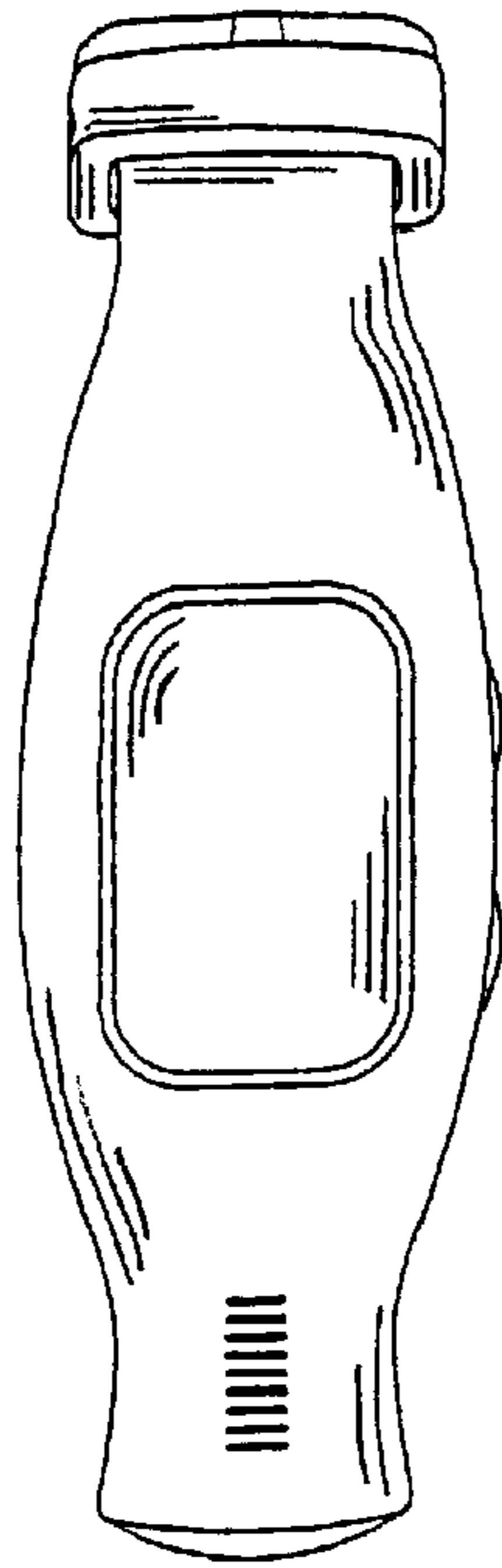

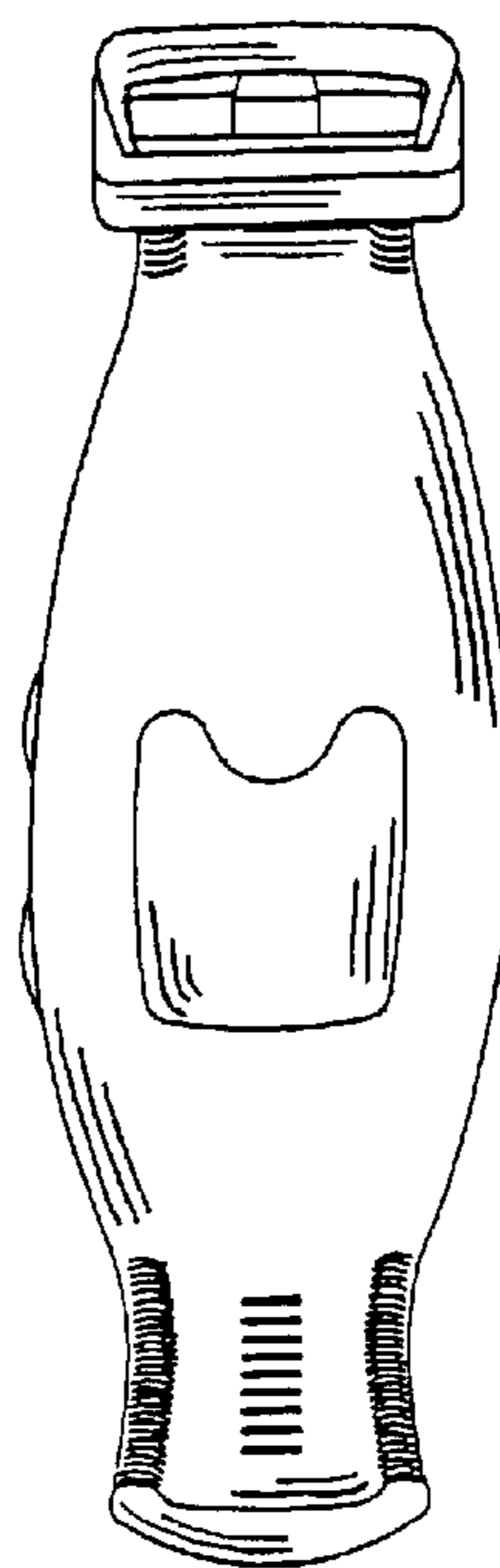

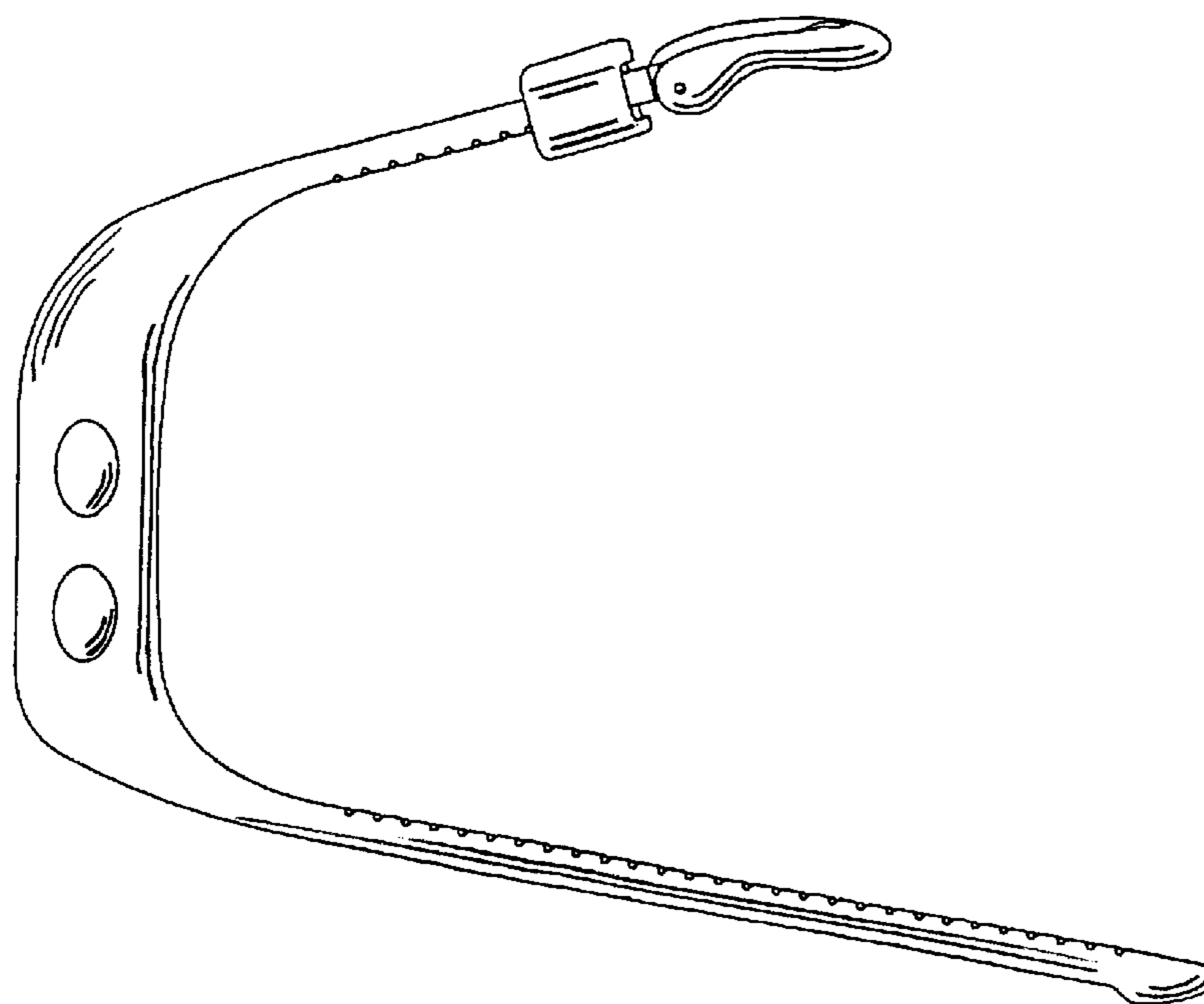

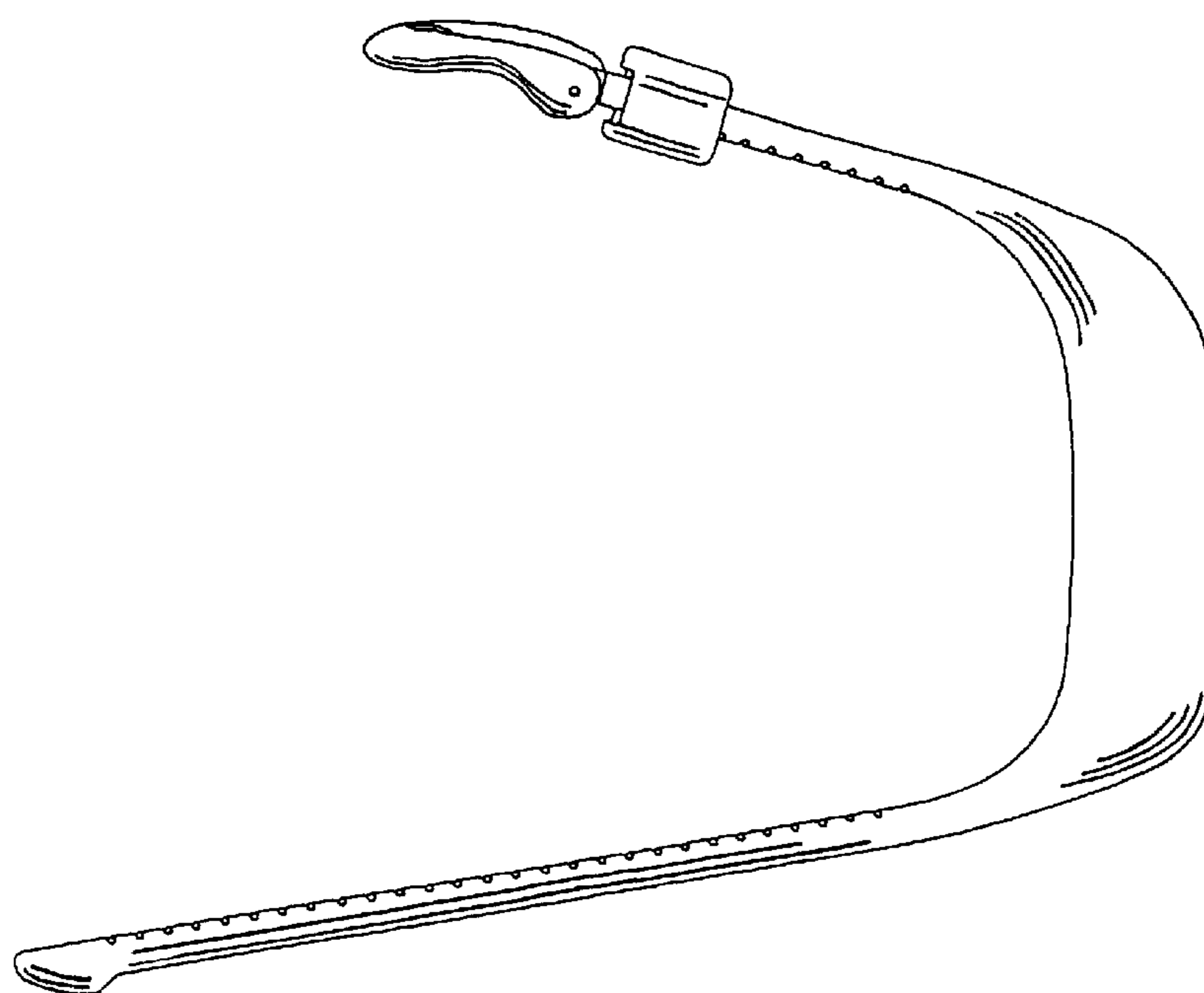

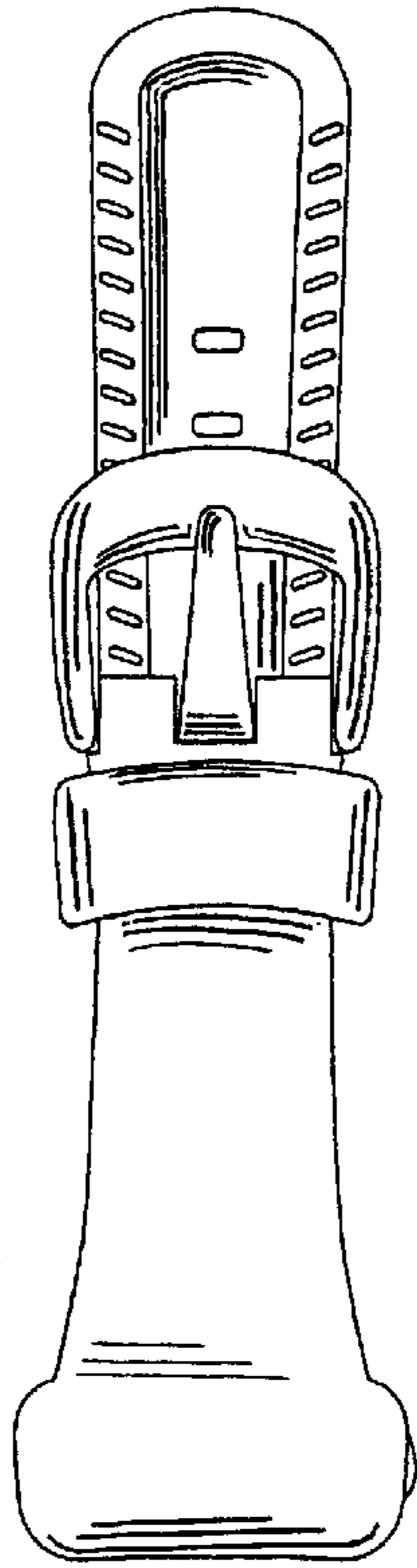

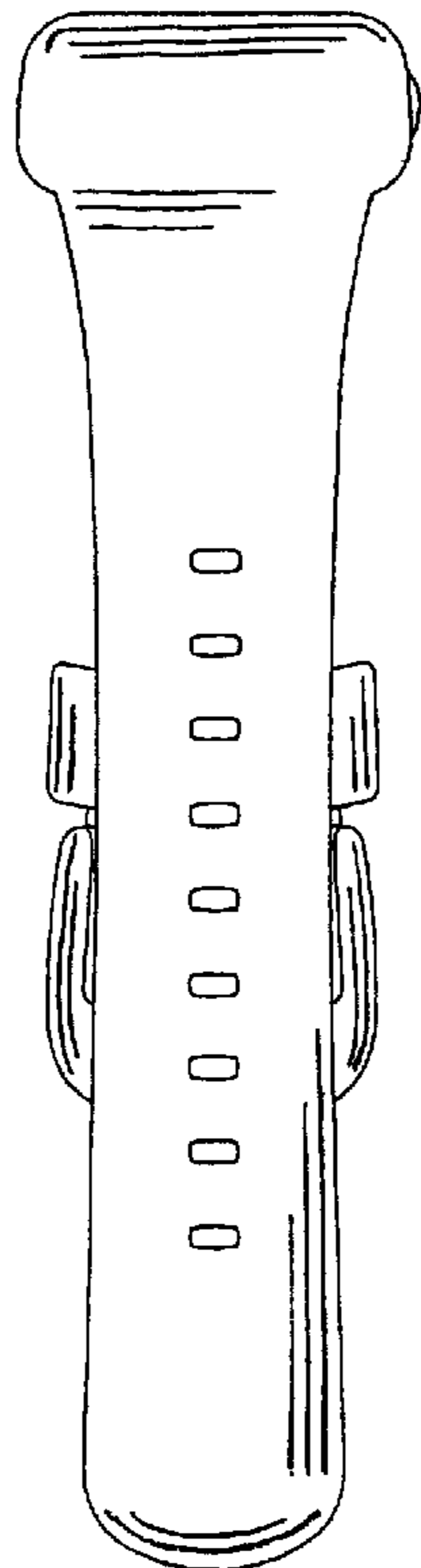

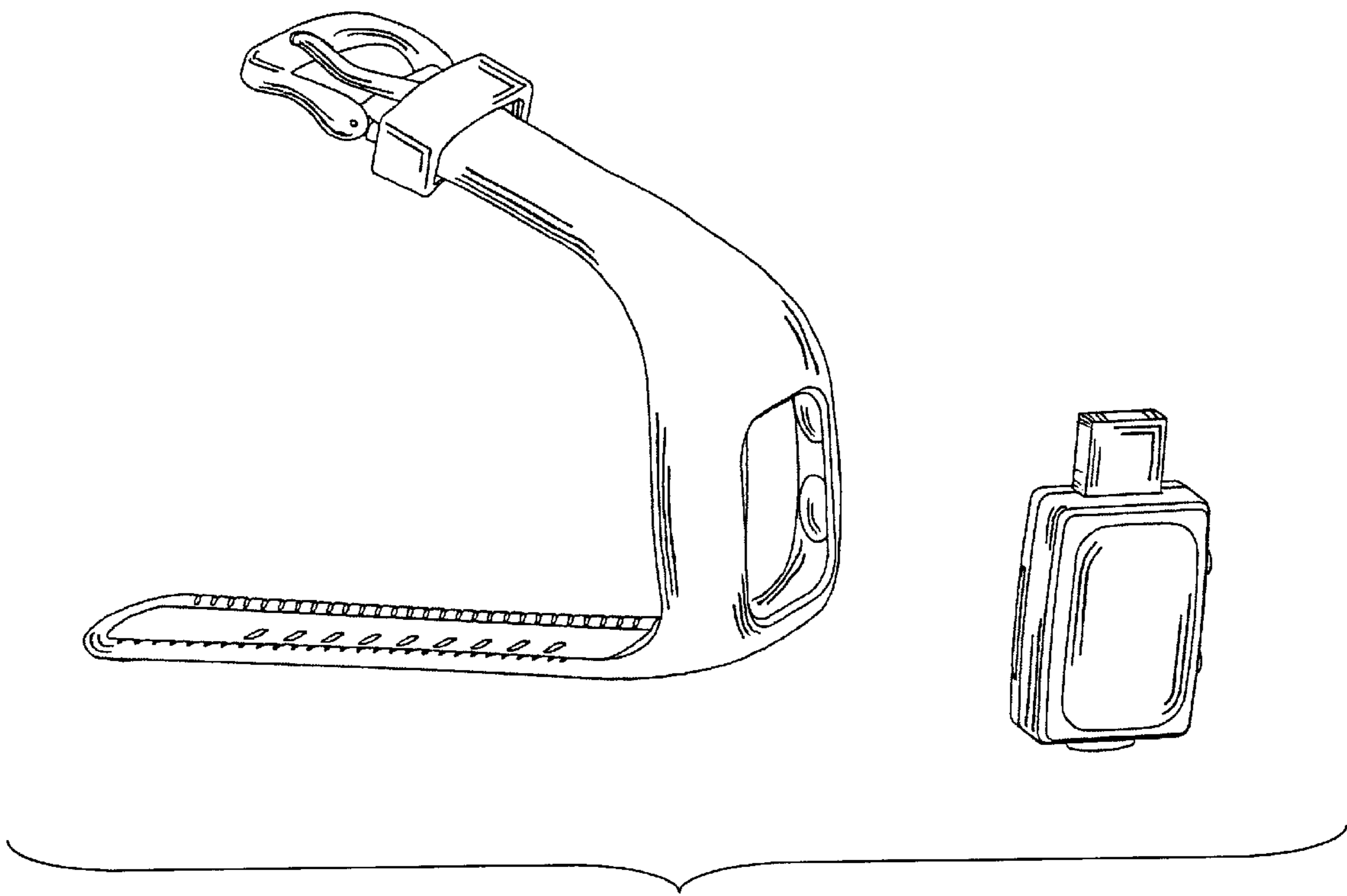
