(57) **CLAIM**

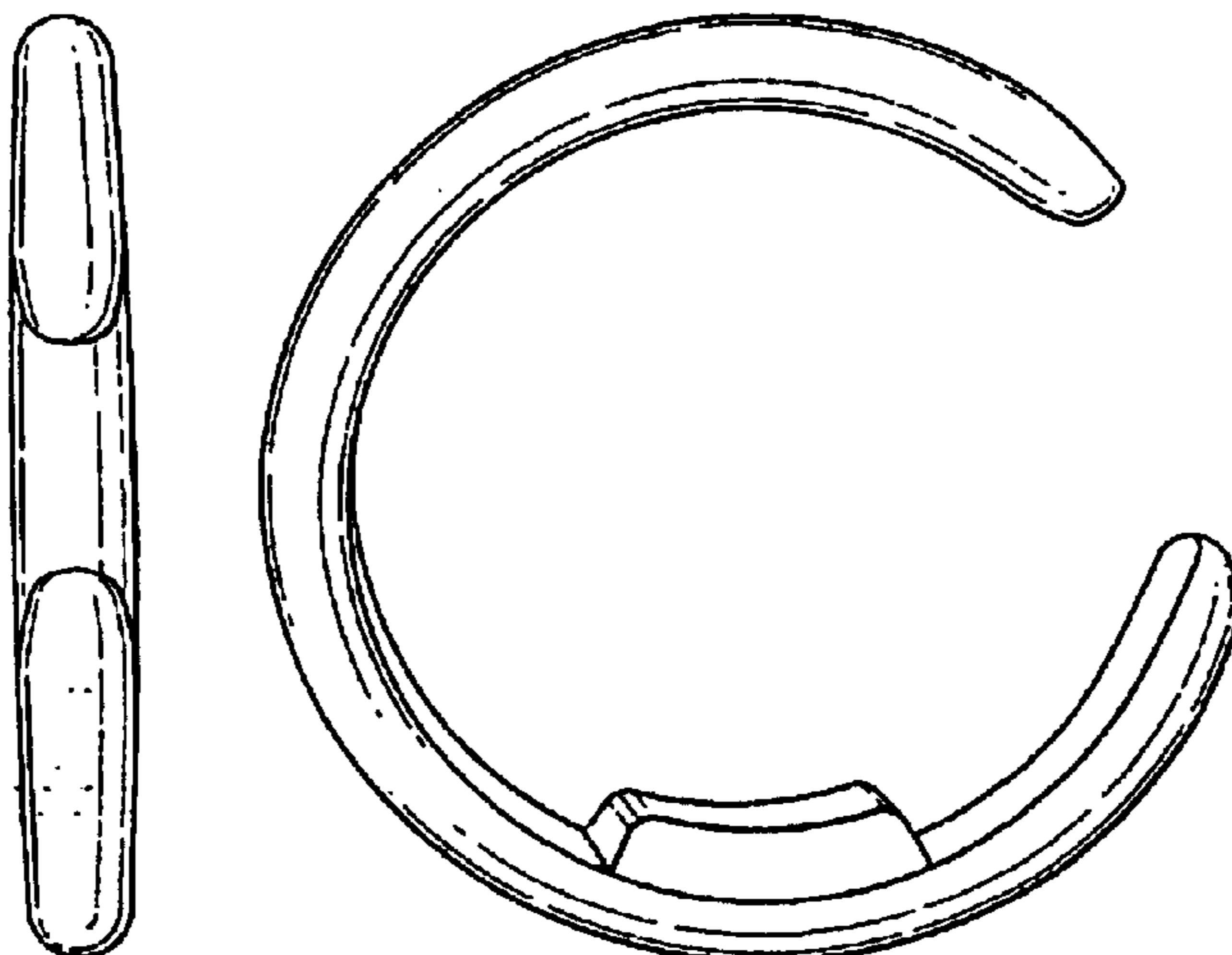
We claim the ornamental design for a ring, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the ring;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a perspective view thereof; and,  
FIG. 7 is a cross sectional view taken on line 7—7 on FIG. 1.

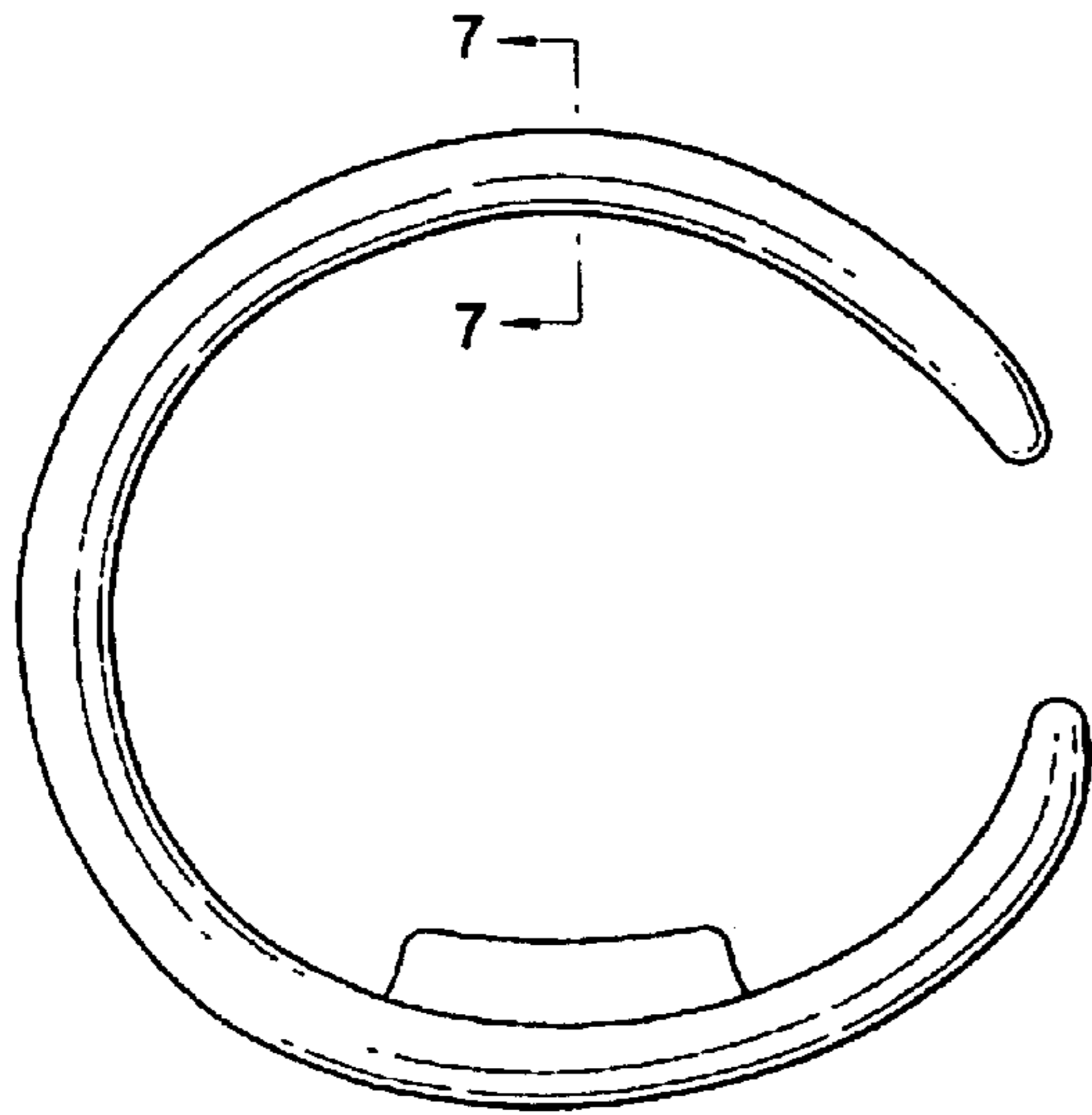

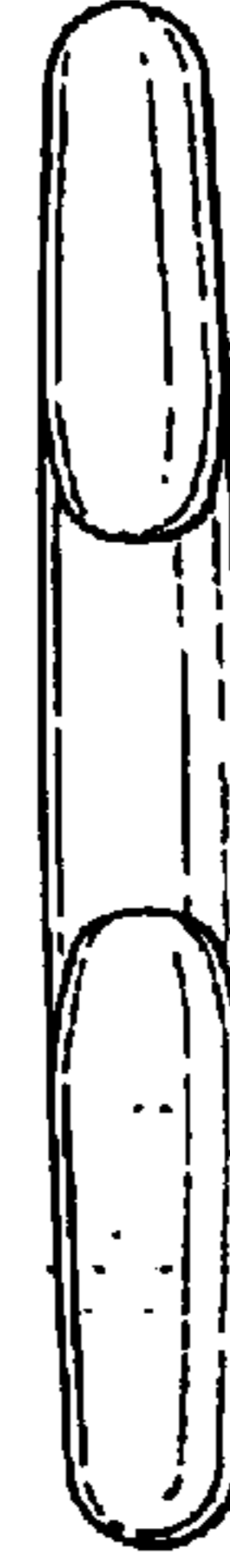

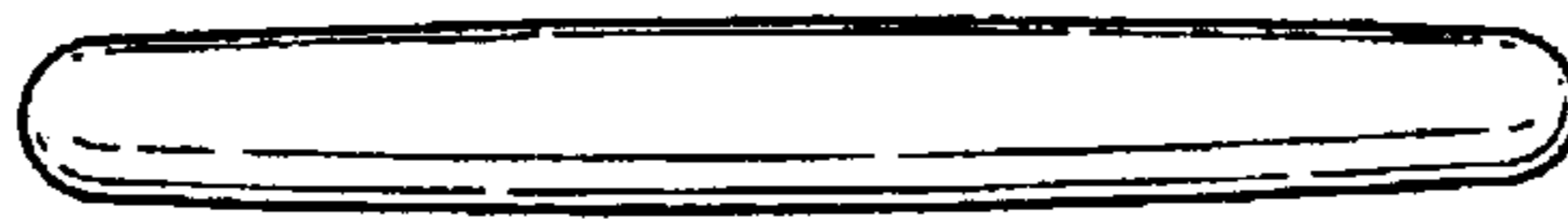

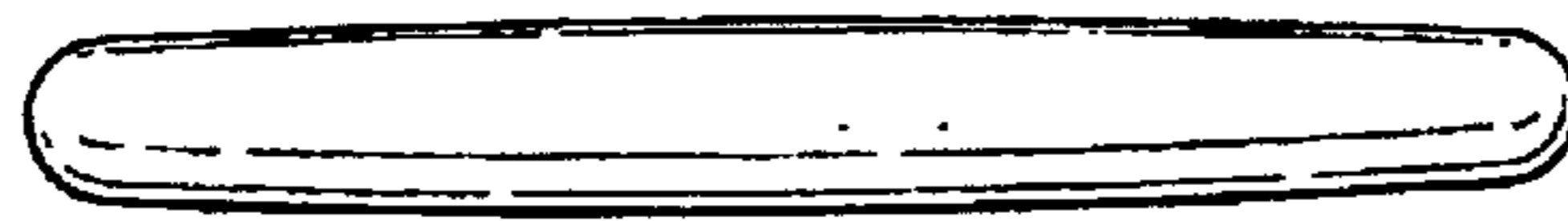

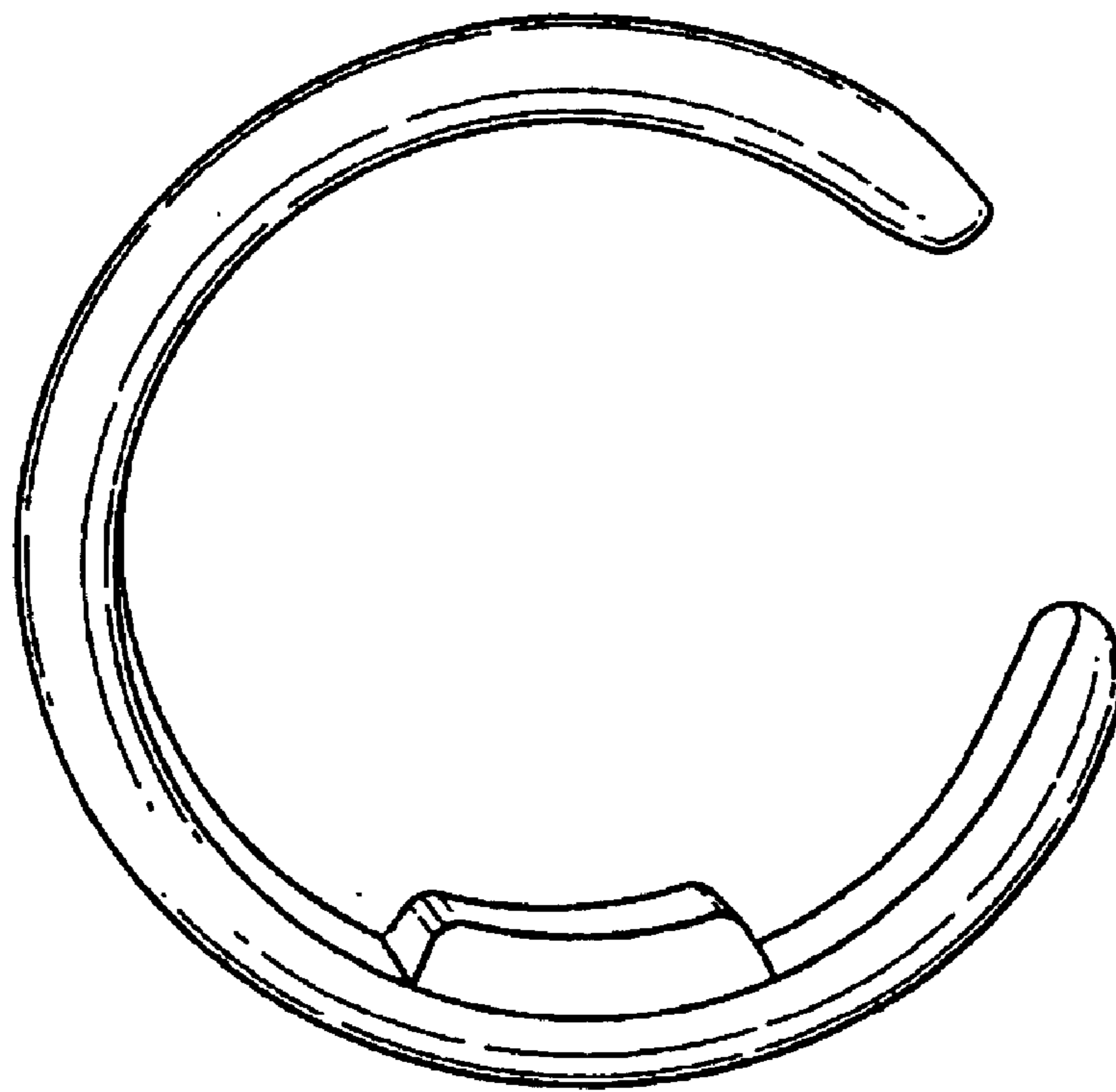
